

CITY SLOW TO ENFORCE NUISANCE ORDINANCE Some action taken; neighbors question if more will come



Property located at 707 Mitchell St. in Columbia has continued to be a topic of conversation in the community and within the city government. With years of violation notices being sent regularly to the property owner, neighbors continue to voice their displeasure in the system and question the help of city officials.

Tracey Corbin has attended several city council meetings to address the nuisance property, where city officials agreed that something needs to be done.

"We're two years later and last week was the first step that anybody had done anything to clean up the brush," said Corbin.

City of Columbia Mayor Pam Hoots said she has continued to be

in contact with Anthony Jones, who oversees the estate that owns the property on 707 Mitchell St.

said the Hoots response has been "favorable" with not only Jones but two other property owners within the city limits that have violated the city's nuisance ordinance. Jones received a letter on March 14 notifying him of a hearing set for May 8 and stating he had 30 days to respond with proposed actions to clean up the property. Jones responded to the mayor in the allotted time, foregoing a hearing.

"Mr. Jones, who lives out of state, did approximately \$2,000 worth of work," said Hoots. City Clerk Woody Sharpe and

Magistrates include road miles as they consider redistricting

Every 10 years, a census of U.S. residents is developed and released by the U.S. government. When that happens, local counties must adopt new boundaries for magisterial districts based on population.

Each district must be drawn so that it is contiguous and each district is as equal as possible in population.

On Tuesday, Adair

When it comes to determining how to spend road money, magistrates have debated for years over whether it should be split evenly between the districts or if it should be determined by road miles within the district. There's no right answer, and magistrates tend to argue for what is best for their own district.

As an example, District 2, represented by Daryl Flatt, includes Lindsey Wilson College, a highly concentrated population area within the city limits with no county roads. The district overall includes 56.1 county road miles. District 7, represented by Terry Hadley, covers the northern portion of the city limits and includes 43.72 county road miles. District 3, represented by Sammy Baker, includes some highly rural areas and his district includes 107.22 county road miles. District 6, represented by Mark Humphress,

covers the Knifley and lake areas and includes 106.21 road miles.

District 4, represented by Chris Reeder, includes 100.39 road miles. District 1, represented by Tony Denton, includes 97.47 road miles. District 5, represented by Billy Coffey, includes 68.54 miles.

While magistrates with a lot of road miles worry about getting the needed money to keep roads in good condition, there are other issues, too, according to Baker. Baker said the disparity can have an impact on residents when there are storms such as recent ones that took down trees and limbs and caused road closures. "We have a lot more miles to drive," he said. "It takes a lot longer to get all that cleaned up. It takes a lot of driving... It's just not fair to my constituents that they have to wait because I have more road mileage



County's seven magistrates received a copy of a proposed reapportionment. The proposed boundaries were developed by three appointed commissioners with the assistance of the Lake Cumberland Area Development District.

While the proposal meets the state guidelines based on population, magistrates hope to take the proposal one step further and address a disparity in the county road miles within the seven districts.

For years, county road miles per district have been a contentious topic.

North Dakota man arrested on drug charges

On Saturday, July 8, Columbia Police Officer Jimmy Luttrell observed a male subject in the Burkesville Street FiveStar who had suspected narcotics in plain view.

Police report that he refused to comply with verbal commands and attempted to flee from police.

Jamie Wolf, 48, of Center, N.D., was arrested and charged with resisting arrest; fleeing and evading; possession of drug paraphernalia; possession of marijuana; and possession of methamphetamine, along with numerous traffic violations.

Luttrell was the arresting officer and was assisted on scene by Trooper Kenny Brown.

Inmate charged after jail overdoses

The Columbia Police Department responded with Adair County EMS last Thursday to the Adair County Regional Jail for suspected overdoses.

Jail staff told responders that they had administered Narcan on two female inmates. Three inmates were transported to TJ Health Columbia by Adair County EMS for treatment and observation.

After subsequent investigation, Crystal Ashcraft, 43, was charged with two counts of wanton endangerment; possession of a controlled substance, heroin; and promoting contraband.

Ashcraft was previously booked into the jail as a Cumberland County inmate on drug charges.

Officer Elliot Smith is the investigating officer. He was assisted by Sgt. Drew Conn, the Adair County Sheriff's Office, Adair County Regional Jail staff and Adair County EMS.

Arrest made in Cookout drive-thru

A Columbia woman was arrested after she apparently passed out in the Cookout drive-thru in Columbia.

Once officers made contact with the subject she failed field sobriety tests. Officers also located suspected marijuana and methamphetamine inside the vehicle.

Samantha West, 30, of Columbia, was charged with DUI, 2nd offense; possession of marijuana; and possession of methamphetamine.

Officer Justin Cross was the arresting officer and was assisted on scene by Sgt. Drew Conn and Deputy Brandon Hitch.

Guilty plea entered in Taylor County fatality

On May 08, Donald Slusher, 50, of Knox County, entered a guilty plea stemming from a Kentucky State Police Post 15 investigation of a fatal collision.

The collision occurred in Taylor County on March 25, 2021 and was investigated by Senior Trooper Weston Sullivan.

Slusher was operating a commercial vehicle under the influence of drugs, above the posted speed limit, when his tractor and trailer overturned.

His vehicle then crossed the centerline of KY 210 approximately nine miles west of Campbellsville. Slusher's vehicle struck four other vehicles head-on, taking the life of Michael Brandon Heath.

The case was presented to the Taylor County Grand Jury in March 2022 and they subsequently returned an indictment on Slusher.

On July 7, Slusher was sentenced to 15 years in prison by the Taylor County Circuit Court. His charges were manslaughter 2nd degree; two counts of assault 2nd degree; operating a commercial vehicle while under the influence; and other traffic offenses.



Thanks for being positive

The most difficult part of my job is when I find myself writing about things that make me sad or discouraged. They are the same things that make readers feel the same way.

A lot of us have recently made comments that certain things going on in our community are downright embarrassing. They certainly for the most part make us sad.

I was thinking about that a couple of nights ago and at the spur of the moment I decided to reach out to the community for something positive. I shared on a Community Voice social media page that I would like for people to share positive experiences they have had with local businesses or offices. We all see the complaints when a food order isn't correct or a customer service person is rude, but we rarely see a post about a job well done. So, I asked for those posts.

Instantly comments started popping up. People were bragging on everything from dentists to the perfect cup of coffee. Business owners and employees got a shout out for providing someone with a positive experience.

Within 12 hours the post reached more than 7,000 people, had received 180 responses (smiles, hearts, and thumbs up) and almost 200 positive comments. This all happened from 7 p.m. until 7 a.m., definitely not peak hours for social media. It was so refreshing, and other people felt the same way. Some took the time to thank the Community Voice for the post. It was my pleasure, and it put some pep in my step the following morning.

heart disease who also had a positive outlook were one-third less likely to have a heart attack.

Yanek measured "positive" versus "negative" by assessing a person's cheerfulness, energy level, anxiety levels and satisfaction with health and overall life.

Other studies have also found links between positivity and health. An article by Johns Hopkins goes on to say that a positive personality is something you are born with, but I am not sure I believe that.

I think we decide, often without even realizing it, whether we will have a positive personality or a negative personality. Life gives us no option but to experience good and bad, but we can decide how we respond. Some people seem like they will never by happy, and a lot of those people have found their way to social media in search of kindred spirits. My post on social media asking for positive comments reminded me that there are plenty of positive thinkers out there, too, and sometimes they just need a

little encouragement to share that positive energy with others.

Still, there are plenty of people who obviously focus more on the negative, and it really should be no surprise. We have experienced a pandemic and we have instant access to hate, bad news and reports of tragedy; there are plenty of reasons to be negative.

But focusing on the negative never solved a problem. The problem solvers are the people who see a problem, believe they can be part of change, and respond with positive steps to be world changers. Positive people consider where they are in their life journey and begin working toward the future they want.

So, if you are discouraged, I urge you to start rewiring your brain. It can be done. Researchers from Kings College have found that high levels of negative thinking reduce the brain's capacity to think, reason and form memories. This information was taken from an article by Bill Howatt of Howatt HR Consulting.

A person can see a difference in their mood, however, by consciously making a decision to be more positive. Howatt recommends a 30-day challenge, which includes writing down negative thoughts during that time and analyzing why you are having those thoughts.

You can "train your brain," but it takes an intentional process.







you are. I almost saw one of my staff get hit ... We just really have to be really cautious."

When asked if any specific road was the problem, Loy said Jamestown St. is the worst but traffic coming off the square onto Burkesville St. is also dangerous. Linda

Waggener, owner of Columbia Magazine, was one of several people who talked about Burkesville St. and the two lanes as traffic approaches the square.

"People really zoom in there," Waggener said, noting that there was once a light at the intersection of Burkesville St. and East Guardian St. and that encouraged drivers to slow down.

Waggener asked about a yellow turn arrow for the corner of Reed St. and Campbellsville St. but was told that regulations require a dedicated turn lane for the arrow to be used.

State officials and Mayor Hoots talked about the potential to reduce Burkesville St. to a single lane with hopes for a solution before blacktopping takes place downtown in a few weeks.

There was also discussion of trucks using compression release engine brakes in town and trucks traveling through town when they could use the bypass.

Della Hare brought up the intersection of Burkesville St. and the bypass, where several wrecks have occurred. She noted that some intersections have a larger light higher up on a pole that is more visible than other lights as travelers near an intersection.

Officials noted that improvements have been made at that intersection and they have not had any complaints since. They agreed to review

crash data and review the intersection to see if more improvements need to be made.

City Police Chief Jr. Murphy said that they have seen improvements at that intersection and there have not been any fatalities since the state made changes.

"But we are seeing some crashes," he noted. "What we are seeing is that the visibility of the light itself, certain times of the morning, certain times of the evening, when the reflection is on there, you can't see the light."

Jackie Montgomery asked if there are ways to make the intersection at Hurt St. and Jamestown St. safer for pedestrians.

"There are folks who actually walk around town; it's not easy to do," she said. "They are trying to do their shopping and nobody stops. It's really difficult for them to cross in either direction."

There was conversation about the need for education about pedestrian right-of-way and officials said they would participate in an educational campaign.

The meeting lasted about an hour and several suggestions were made concerning signage and paint on the roadways. Transportation officials talked about several changes that could be made that fall within traffic safety regulations.

Mayor Hoots said she was pleased with the attendance of the meeting and the reception they received from state officials.

"I think this meeting went extremely well. We discussed a lot of things that people are concerned with in the community, and I think there are some solutions coming," she said.

County Clerk Lisa Greer, who serves as a non-voting member of the board that developed the proposed reapportionment, said she agreed with Baker, but the commissioners must base their map on population. From there, they consider the number of registered voters. Road mileage is not part of the consideration.

The lines can be altered, however, and as long as the districts are contiguous and population numbers are close, magistrates can adjust the proposed map to help solve the road milemiles, said he has shared his road money with the larger districts when they needed it more than he did.

Magistrates discussed the proposal during a regular fiscal court meeting Tuesday morning. They have 60 days after receiving the proposal to approve a plan so they voted to acknowledge that they received the recommendation and will continue working on the proposal.

Magistrates continued to review details of the map after the meeting adjourned and made plans to continue trying improve the road mileage issue.

Also during Tuesday's regular meeting, second readings were approved for a speed limit change to 25 mph for Ralph Hadley Rd. and 30 mph for Rooks Denton Rd, and a school bus turnaround for O Flatt Rd.

Judge Executive Larry Russell Bryant told magistrates they had 45 days to pass property tax rates to meet the deadline for this year's tax bill. No discussion followed and no action was taken.

All magistrates attended the meeting.





Sundowner Syndrome

If you care for someone with dementia or Alzheimer's disease you may notice that they get increasingly agitated, anxious, more confused or aggressive as the sun begins to set. These symptoms may be associated with sundowner syndrome. Sundowner syndrome causes people to be confused at the end of the day and into the night. It is common for individuals who are sundowning to pace, wander, ignore directions and not sleep well.

While the cause of sundowner syndrome is not fully understood by scientists, theories to its cause include changes in a person's internal biological clock, which is controlled by circadian rhythms; changes in body temperature; sleeping disorder; inadequate exposure to light and a side effect to some medication. The shorter and sometimes grayer days of winter can sometimes exacerbate these symptoms.

As a caregiver, vari-

ous environmental or behavioral changes can help alleviate some of the symptoms associated with sundowning.

For example, morning light therapy may help alleviate restlessness, sleeplessness and agitation. Researchers suggest trying to shine a full-spectrum fluorescent lamp on the individual while they are participating in morning activities such as eating breakfast or watching television. Pulling the blinds and turning regular lights on earlier in the evening may also help alleviate stress associated with the sun setting.

When possible, it can be helpful to organize daily events and activities, including doctor's appointments, visits and outings early in the day.

Exercise during the day can even increase evening tiredness and lead to a more restful night. A supplement of melatonin has also shown promise in helping individuals cope with sundowner syndrome.

City slow to enforce nuisance ordinance

Mayor Hoots both iterated that Jones decided to hire and pay for a private contractor to take care of the property, such as removal of some small-

er trees, large brush, mowing, and removing a number of weeds and shrubs from three sides

of an abandoned trailer. The property still holds a vacant, run-down trailer and overgrown trees, shrubs, weeds, and long grass on one side.

"Believe me, I know it's not sufficient. But I think he made a good faith effort," said Hoots.

The Corbins say what has been done is not enough, and Mathew Corbin said they were told not to expect anything else to be done to the property.

Sharpe said Jones continues to be in contact with the city.

"There's only been one day of cleanup. Nobody from the city said it was up to code," Sharpe said.

In a social media post, Mathew Corbin stated that the family's property had been torn up while

the work took place next door, as the contractor used their property as an entry point. Sharpe and Tracey Corbin both said the contractor has agreed to help repair the damage that had been done to the Corbin property.

"We're trying to find out what the next step is. We're working on it, the city is working on it, and we are in contact with Mr. Jones about it. That's where it is right now, as of yesterday," Hoots said Tuesday. "We're working on it to see what we can and can't do - with the legality of it."

Tracey Corbin said her family still can't sit outside at all due to the number of mosquitoes that the nuisance property produces. They actively see animals around their property such as opossums, snakes, and stray cats, which she believes are coming from the property next door.

While Tracey Corbin continues to reach out to local officials, Mayor Hoots, the city attorney, and the city council continue to reach out to property owners and say they are planning to advance to the next steps in the process according to city ordinance.

With efforts being made with the city officials and with property owners, Corbin says she is hopeful with a new city attorney in office and with the efforts being made next door, but still believes there is work to be done. By Jaidyn Lee
