Vision for Russell building starts to unfold

When David and Tina Thomas offered the final bid that took ownership of the Russell building on the square, they had not been able to inspect the historic building, which sat empty and disregarded for several years.

They didn't know a lot about its most recent past, but they knew they loved the idea of its place in Columbia's history.

Tina, who made the hand wave that bought the structure at a master commissioner's sale last October, had dreams of a building that blends treasured memories of the past with opportunities to create new experiences and adventures for years to come.

Her excitement was met with a crashing wave of real-

ity when they first entered the building only to find that it had been vandalized, and trash and debris were scattered throughout the vast structure. Cherished glass windows that had probably been part of the original building were broken. Dry-wall had been ripped from a wall. Brick had deteriorated from water damage due to poor gutters.

For every challenge they have faced, however, the Thomases have been met with promising news – a beautiful brick wall hiding behind dry-wall, gorgeous wood floors just waiting for new life, and news that the building's structure is secure.

"It was a bit of a shell shocker; the garbage that was in it," Tina said. "But, overall, it was

also quite shocking how well the bones of the building are."

After getting the largest dumpster they could find and working for an entire week-end cleaning up the mess, they saw the beauty.

"We filled that thing up in one weekend, and when we looked at those hardwood floors after getting that garbage up, it was amazing," Tina said.

There's plenty to be done, however. A new roof installation is scheduled to begin this week. Expensive windows are on the must-do list. Ceilings and walls need plenty of attention. Installation of an elevator will be required. There will be more, but for now they are taking care of

Stotts sees Malvina Farkle day from both sides

Columbia resident Kallie Stotts has experienced Lindsey Wilson College's Malvina Farkle day as a student the past four years. Last week she was able to witness the day of serving as a LWC faculty member.

In April of this year Stotts graduated from Lindsey Wilson College with a degree in interdisciplinary studies emphasis in elementary education and human services and counseling. She was ready to move out of her hometown of Columbia and head into the city of Bowling Green.

Last week LWC celebrated its annual Malvina Farkle day. This day is for students to put down the notebook and step out of the class into the Adair County community. Students join a host of service projects from cleaning fire trucks, sidewalks,

buildings and getting to know the community.

As a student, Stotts commuted to LWC, so she avoided the surprise wakeup call that is the ceremonial start of Farkle day for students. Still, she wanted to be involved as much as she could. For the first few Farkle events she spent helping with deep cleans of the wellness center at LWC. By her senior year she was

Court still lacks plan to administer new tax

Magistrates and County Judge Executive Larry Russell Bryant are still at odds about how to administer an approved occupational tax.

The court voted last month to establish an occupational tax of .5 percent for one year and .25 for a second year, with the tax starting on Jan. 1, 2024.

Before they can collect the new tax, they must have a plan in place, but they have disagreed since the adoption of the tax about how to staff a position for an administrator.

Judge Bryant first requested a full-time position for the judge's office, with the employee being a part-time occupational tax administrator and also performing other duties in his office as needed. He also said he planned to hire former county employee Benisha Johnson for the position.

Instead, magistrates voted two weeks ago to

approve a job description that creates a part-time position as a county employee. While a vote is not required to hire someone for a position considered an employee of the judge executive, magistrates must approve the hiring of a county employee.

At Tuesday night's meeting, Bryant asked for and received a motion and second to hire Johnson for the position. Instead of taking a vote, Bryant then went on to indicate the position was something he could appoint without magistrate approval. The confusion continued to grow.

"This is my appointment I'm making and I need you to accept this so we can move forward," Bryant said.

County Attorney Jennifer Hutchison-Corbin explained to Bryant that, because of the court's vote two weeks ago, the fiscal court must approve the person

Bryant recommended for the position. Bryant went on to continue to argue that it would be his appointment.

Magistrate Chris Reeder, who made the motion to hire Johnson, reminded Bryant that there was a motion on the floor. A vote was taken, with magistrates Tony Denton, Daryl Flatt, Sammy Baker, Billy Coffey and Mark Humphress voting no and Reeder, Terry Hadley and Judge Bryant voting yes. The motion failed.

"I'm not accepting the vote," Bryant said, adding that he talked to an attorney with the Kentucky Association of Counties who said he didn't have to.

Corbin, the county attorney, said she asked the attorney about the position and had asked for clarification before she presented her information.

No further action was

Police Chief Jr. Murphy to retire in October

In an announcement from the City of Columbia's Mayor's Office, Columbia Police Chief Jr. Murphy has announced his plan to retire. Murphy said it would take place next week around the first of October.

Murphy has been prepared to retire for some time. He plans to set aside more time to help care for his family. "I have been at my full term of service for my police duties police duties. Having to be away so much, I felt like I needed to let someone take over for the position," said Murphy.

Murphy has been happy to serve the city for so long, "a career in police services was something that I have always wanted to do since the time I was a small boy, and I achieved that goal, I was able to serve in my hometown and was able to fulfill my dream," said Murphy.

Murphy is a 1992 graduate of the Adair County High School; he later attended Lindsey Wilson College and Western Kentucky University.

He graduated from the Eastern Kentucky University Department of Criminal Justice Training in 2003 and began a twenty-year career in law

enforcement. He started at the City of Columbia under former Mayor Mark Harris. He was promoted to Sergeant in 2013; and, served in the capacity of Assistant Chief until he was promoted to Chief in 2021.

He attended the Academy of Police Supervision, received over one thousand hours of continued education in various fields of police training, a Certified Investigator through the Kentucky Law Enforcement, a member of the International Association of Chiefs of Police.

"I am very appreciative of everyone involved and I appreciate the mayor and city council that had confidence in me and appointed me to the position. We were able to make our city police thrive," said Murphy.

Mayor Pam Hoots gave appreciation for Murphy, "We appreciate the years of service that Chief Murphy has given to the City of Columbia."

At this time the position will remain unfilled until a new appointment is presented to take Murphy's place as Chief of police.

cosmetic improvements.

As the husband-and-wife team take the project one day at a time, Tina and her close friend, Andrea Feese, are also on a journey – creating a future for the Russell building that honors the history of the building and the downtown area where the 1909 structure dominates the corner of Jamestown Street and the Public Square.

“When I pitched the idea to (David) I threw in that my best friend Andrea would be a great one to work with us on ideas,” Tina said.

And the ideas have flowed. Through hours of conversation and creative thought, “Old Columbia” is destined to become a new term that instills a sense of shared identity and spotlights the survivability of small-town America in general, and Columbia in particular.

“So much attention has been focused on New Columbia, and that’s great,” Feese said. “We are not anti-growth at all.”

Even so, Feese said the term “New Columbia,” which is often used to reflect the commercial area on Burkesville Rd. near the parkway entrance, can send a message that it’s “new and shiny and better.” She disagrees.

“You can have something new without feeling like what you’re leaving behind is ‘being left behind’ and is old,” Feese said.

Tina has already created an LLC named “Old Columbia,” along with a logo. As they set on their adventure to join the downtown business community, they hope what they do will complement the neighboring shops and bring more shoppers downtown.

“I feel like our square is coming more alive. I love my neighbors, love the idea of everyone on all corners of us that offer business there. I would like for this – I would like for the Russell building to be something to fall in line for all of us business owners to help grow together,” Tina said.

Tina and Andrea are keeping some of their plans to themselves for now, but they will say they hope to offer a venue for weddings and other events as well as a farm-to-table restaurant that focuses on Kentucky Proud products. The upper floor could possibly be used for overnight stays for wedding participants or as an Airbnb.

Tina and Andrea have rented a smaller space next door to help get the venture off the ground. It will soon be a small retail shop for local, Kentucky-based products, and Feese will have a photography studio in the back. Tina and David will use the space as the center of operations while the larger project of getting the Russell building open is underway.

Tina said they have received a tremendous amount of support from the community, and a number of people have

thanked them for taking on the project to restore an Adair County landmark.

“Everybody keeps asking, what are we doing?” Tina said. “My answer is, we’re doing a lot and it’s going to take time.”

Tina and Andrea laugh as they talk about the ideas they have floated around, giving David credit for helping them think realistically and consider their options. David and Tina operate Hilltop Auto Mart, and that business experience is coming in handy.

“Because he is a businessman, he has been the one who has said, ‘girls, who are you robbing to make this happen?’” Andrea laughed.

David may be the voice of caution, but it’s obvious he is all in as the work gets done and the planning moves forward. It was his idea to put stone on the front of the building, and Tina and Andrea admit they weren’t sure at first, but everyone agrees it looks amazing.

“We don’t have a lot of resources, but we are very resourceful,” David said.

Tina said she would like to bring the building back to life for the entire community and for it to bring something of value to downtown Columbia.

“When you look at the history of it, it’s kind of sad to see the state it’s in now. So, we’d like to bring it back to its glory days and let this generation and next generation get to experience the building,” she said.

Court Plans to Sell Property

The court took initial steps to offer property on Reed Street for sale at auction. The county owns the property that was used by the health department years ago and is currently rented as an adult day care facility.

The property has an assessed value of \$150,000 at the PVA’s office, but a recent appraisal on the property came back at \$90,000.

The court voted to accept bids from real estate agencies to sell the property at auction with a reserve of \$150,000.

Court discusses Blair

Center rentals

The court discussed problems with people not cleaning up after renting the Jim Blair Center. Deputy Judge Bridget Compton said they may have several rentals over the weekend and not know which one left a mess. The contract states that anyone who does not clean up will be billed for cleanup but it does not require a deposit.

After discussion the court voted and approved to update the rental policy to include a \$100 dollar deposit for building rentals prior to use. If the building is left in a poor condition, the deposit would be kept and not returned to the renter. They also restated the \$25 charge if a renter did not return the

building key after use.

Also during the meeting, the court voted to purchase a Dodge Durango for the sheriff’s department. The vehicle and outfitting will cost just over \$62,800.

In closing the meeting, Bryant said there will be more information available soon about a project at the Green River Commerce Park.

“It’s a great step forward our county. It’s a lot of jobs and a lot of spinoff of jobs and products and services,” he said.

Gov. Andy Beshear is expected to be in Columbia next week to make an announcement, he added.

Republicans were different then

Fifty years ago the Republican Party was caught in the middle of what became the biggest political scandal in the history of the American Presidency.

Richard Milhous Nixon, the 37th president, was the subject of multiple congressional investigations that led to his resignation in 1974.

Two years prior, on June 17, 1972, five individuals hired by the Nixon campaign broke into the office complex of the Democratic National Committee in the Watergate Hotel in Washington, D.C. Frank Wills, a security guard, immediately called police when he noticed the damaged locks. The police quickly arrived and arrested the five intruders.

Over the next two years, investigations unraveled a tangled web of financial corruption in the Nixon campaign, lies, cover-up, and more lies that reached all the way to the Oval Office. Sixty-nine indictments followed, spreading from the Nixon campaign to corporate America. American Airlines, Goodyear Tire, Gulf Oil, and George Steinbrenner, owner of the New York Yankees, were indicted for various illegal activities related to the campaign.

Fifty years later, the Republican Party is again in the middle of what will in due time become a political scandal that will make Watergate look like child's play. There are common parallels between then and now. During the 1960s, social and political protests became common across the nation. The counter-culture, all those "long-haired hippies," that protested with civil rights marchers and anti-Vietnam War protesters, threatened conservative voters, most of whom were Republicans. To counter this, the Nixon Campaign fell back on the time-tested campaign strategy of using anger and fear about crime in the cities and all those "radicals."

Today, the GOP still uses the same tactics to trigger its base. Yes, both parties use emotion and exaggeration in campaigns, but the Republicans are masters at it.

The Nixon Administration clearly tried to subvert democracy and the rule of law in the cover-up of numerous crimes. However, Republicans did something that is completely alien to the party today. As more corruption and lies became public, Republican leaders in increasing numbers supported the investigation of the

Nixon White House.

They did NOT spew nonsense about the "weaponization" of the FBI, the Justice Department, or the courts. Nixon, as corrupt and paranoid as he was, did not name call, intimidate, or threaten those who investigated him. He did not try to turn Americans against the Constitution and the rule of law. Senator Barry Goldwater of Arizona, a staunch conservative, along with several Republican leaders told Nixon he must resign or he would face impeachment. Rather than attempt an insurrection, Nixon resigned the Office of the Presidency. Republicans in those days had a moral compass, believed in the rule of law, and placed the good of the nation over their party.

Contrast then with now. On Aug. 23, 2023, during the Republican Presidential Debate, the eight candidates on stage were asked, "If the Republican nominee for the presidency is a convicted felon, would you support that person?" Six said yes. Numerous polls of registered Republicans have consistently shown that about one-third will vote Republican even if the nominee is a convicted felon. The most alarming aspect of this is the fact that very few Republican office holders at any level, national, state, or local, seem alarmed at any of this. Is it lack of integrity or cowardice? The Republican

candidate for governor in Kentucky stated that he is "pro Trump" as did several of the Republican primary candidates in the 2022 legislative races. Really, what attributes do they find redeeming? Are Republican voters so partisan that they support party over country, lawlessness over the rule of law, or autocratic leaders over democratically elected leaders? A representative democracy will not survive under these conditions.

The Republican Party through much of its history was known as the "Party of Lincoln," and it demonstrated Lincoln's moderation for many years in its political and social policies. Unfortunately, Mr. Lincoln would not recognize the party today. Why has it changed from a party that always emphasized the sanctity of the Constitution, the rule of law, and political norms such as the peaceful transfer of power following elections? Why do so many Republican officials disparage governmental institutions, including the military? In 1994, Republican Newt Gingrich became Speaker of the House, and he made compromise with Democrats a "no-no" for Republicans. About this same time, Rush Limbaugh became popular with his daily attacks on anyone who was not Republican and conservative. His popularity spread from radio to television where FOX News continued the same propaganda. However, one of the lies by FOX finally caught up with them this past April to the tune of a \$787.5 million defamation judgment awarded to Dominion Voting Systems. Evidence presented during the civil trial clearly showed that FOX commentators knew President Biden won the election, the voting machines were accurate, and the "Big Lie" was just that.

Much of my early political teaching came from my father who was a "Rock-Ribbed" Republican to the core. I can say confidently that he voted Republican in every partisan election from the late 1940s until 2016. In poor health and unable to drive, I offered to take him to vote. He refused. When I asked him why, he replied in very colorful terms regarding the lack of character of the Republican nominee for president. Even at this stage of life, his political radar was laser sharp. Sadly, the party has continued down this path since 2016.

pets and spending time with her family and friends.


