Page, Bardin recognized as state presidents

For the first time in the history of Adair County, there are two high school state presidents: Trenton Page, Kentucky FFA president; and Natalie Bardin, Kentucky FBLA president. A reception was held on Friday to honor them and recognize their accomplishments. Mayor Pamela Hoots kicked off the reception by thanking Page and Bardin for the honor they brought to our community. Superintendent Jason Faulkner told everyone, "There are 193 school districts in the state of Ken-

tucky. Think of the shear odds of two students in consecutive years being named presidents of two large organizations and both of those students coming from Adair County. Even just saying that gives me chills." FFA Advisor Brittany Smith told the audience that the organization began in Adair County schools in 1940. There is a plaque in the high school that has accumulated only nine names in

Todd Davenport has been named by Gov. Andy Beshear as District 2 magistrate to fill the vacancy after Daryl Flatt's resignation in March. Davenport was officially sworn in last Thursday.

"The older I get the more I want to be a servant of the county," said Davenport. "I retired from the state in

December, so this felt like a perfect opportunity."

He graduated from Adair County High School in 1995 and Lindsey Wilson College in 2001 with a bachelor's degree. Davenport began working as a youth worker in 2000

Storm that left deadly trail passed over Adair

"We were very fortunate and blessed compared to the injuries, fatalities and damages in other areas," said Emergency Management Director Grant Loy. "We had some trees fall into homes and vehicles but no one was injured."

Grant said every emergency department was out and assisting with removing debris, cutting trees, and responding to calls.

During Friday night's storm, there were 10-12 weather spotters out in the county. Rotation was spotted in the Breeding area by four or five spotters who saw what appeared to be funnel clouds or lowering clouds. They were able to visualize them crossing the county for five to six minutes. The same storm moved to Russell County where a funnel cloud touched down a few minutes.

Brandon Harvey, cap-

tain of Breeding Fire Department, said that during the storm his department worked with Daniel Wilson to verify in person what Wilson was seeing on radar.

Wilson noted that, "Thanks to the weather spotters and their work, we were able to notify the citizens of Russell County about the funnel cloud. The training they have taken paid off."

After taking care of problems in Adair, Breeding's technical rescue team and Loy responded to Russell County and assisted over there throughout the night and on Saturdav.

As the storm moved east, a tornado touched down from Russell to Laurel counties, killing at least 19 people. The National Weather Service has ranked the tornado an EF-4, reaching 170 miles per hour and stretching almost a mile

wide. It spanned for 55.6 miles.

Adair County does have outdoor tornado sirens that are activated when a tornado warning is issued. These sirens are meant to alert people to take cover and in many areas cannot be heard if you are indoors. Code Red is also available and will send alerts to your phone if you are in an affected area.







The Indians added five more runs in the fifth with Bryce Russell and Jackson Sinclair scoring a total of three runs. Smith's homerun to left field gained two more runs.


