CONTENT POLICY

- Press Releases will be published based on space availability. Press Releases must be reporting on a person(s) or situation and not contain any type of "ask."
- Information on upcoming events with or without cost will only be accepted as an advertisement or included in the Community Calendar.
- Contributed Content is defined as regular content submissions by organizations of information that is of interest to the Caroline Review readers, as determined by the Editor, while also promoting the organizations' missions. Contributed Content is in the form of "reporting" or "storytelling," not acutely promoting or advocating for an organization's event or fundraising. Contributed Content must be supported by advertising spend for each month that the content is requested to be included. Typical advertising space is determined on a 1:1 ratio of content space.
- Caroline Creative submissions are accepted at the discretion of the Editor and must follow the Code of Conduct guidelines. Content must be original and not created or generated through AI. Preference is given to artists and creators who have a nexus to Caroline County. Written submissions must not exceed 1000 words. Written submissions must be fictional; no reporting, press releases, opinion pieces, or letters to the editor will be accepted as Caroline Creative submissions. Portrait or staged personal photographs are not accepted. Photographs containing persons are accepted only with a copy of the photographic release provided by the photographer. Selling and promoting of creative content will be permitted only through online display advertising (cube ads).
- Political public communications are accepted when following FEC rules and guidelines https://www.fec.gov/help-candidates-and-committees/advertising-and-disclaimers/.

CODE OF CONDUCT

Caroline Review website and social media purposes are to disseminate information. The following is not permitted on the Caroline Review website or social media:

- Content not related to the original topic, including content that is random or unintelligible;
- Profane, obscene, violent, or pornographic content and/ or language;
- Content that promotes, fosters, or perpetuates discrimination on the basis of race, creed, color, age, religion, gender, sexual orientation, disability, national origin, or any protected status;
- Defamatory or personal attacks;
- Threats to any person or organization;
- Content in violation of any federal, state, or local law;
- Encouragement of illegal activity;
- Information that may tend to compromise the safety or security of the public or public systems; or;
- Content that violates a legal ownership interest, such as a copyright, or any party.

Caroline Review will delete comments, ban or block users from its page(s) for violations of this Code of Conduct, and report such conduct to web and social platforms and to law enforcement when necessary.
