State fires 2,000 prison guards who refused to return to work after wildcat strike

New York fired more than 2,000 prison guards Monday for failing to return to work after a weekslong wildcat strike that crippled the state's correctional system, but said enough officers had come back on the job to declare the illegal work stoppage over.

"After 22 days of an illegal strike, the governor and I are happy to report it is now ended," Commissioner Daniel Martuscello said during a virtual press briefing.

The state and the guards' union struck a new deal to end the strike this weekend, but it was contingent on at least 85 percent of staff returning to work by Monday morning. Although the number returning fell short of that percentage, Martuscello said the state would honor the deal's overtime and some other provisions.

He said the National Guard would remain in place at prisons in a support position while the department undertakes an aggressive recruiting campaign to attract additional employees. About 10,000 security staff are available to work in prisons across the state, he said, down from about 13,500 before the wildcat strike.

"Termination letters have been sent to over 2,000 officers who remained on strike. Officers and sergeants who did not have preapproved medical leave and didn't return by this morning, 6:45 a.m. deadline, have been terminated effective immediately," Martuscello

An email seeking comment was sent to the guards' union, the New York State Correctional Officers & Police Benevolent Association.

Officer again implicated in death

Guards upset over working conditions began illegally walking off the job Feb. 17 at many state prisons, forcing Governor Kathy Hochul to send National Guard troops in to maintain operations. Inmates have complained about deteriorating conditions behind bars since the walkout. And the

death of a 22-year-old man this month at a prison near Utica is being investigated by a special pros-

The walkout violates a state law barring strikes by most public employees and was not sanctioned by the guards' union. Two previous deals aimed at ending the strike failed to coax enough guards back to end the crisis.

Like the other deals, this one addresses a key complaint of the striking guards with a 90-day suspension of a provision of a state law that limits the use of solitary confinement. Guards will work 12-hour shifts and the state Department of Corrections and Community Supervision will not discipline officers who participated in the strike if they returned by the Monday deadline.

Multiple inmate deaths

Multiple inmates have died since the walkouts began, though it was unclear if strike-related prison conditions played a role in the deaths.

Onondaga County District Attorney William Fitzpatrick is investigating the death of Messiah Nantwi at Mid-State Correctional Facility on March 1 as a special prosecutor. Authorities have declined to provide details, but a court filing by the attorney general's office said there is "probable cause to believe" that as many as nine correctional officers either caused or could be implicated in his death.

Fifteen prison staffers were placed on leave following Nantwi's death.

It is the second criminal investigation into a state prison inmate death in recent months. Six guards were charged with murder last month in the December death of Robert Brooks, who was incarcerated at the Marcy Correctional Facility, across the street from the Mid-State prison.

Workers behind 'Sesame Street' learn of layoffs one hour after announcing union's formation

The dozens of Sesame Workshop employees who gathered in a small park near Lincoln Center the morning of March 4 could hardly contain their excitement. Moments before the 10:30 gathering, 60 workers at the nonprofit behind "Sesame Street" had delivered a letter to management asking them to recognize their nascent union.

The delivery to CEO Sherrie Westin was the culmination of 18 months of organizing more than 210 workers into a bargaining unit within Local 153 of the Office and Professional Employees International Union. Afterwards, employees jovially headed to the park to listen to speeches from coworkers, sing classic "Sesame Street" songs and dance to celebrate their first major step as a union.

But when they returned at 11:30, the entire staff was called into a meeting where employees would learn from Westin that the workshop, facing funding headwinds, would lay off more than 20 percent of the members of their burgeoning union. The next day, around 50 workers, including several members of the union's bargaining committee, received notifications that they would be laid off, workers told The Chief.

"We were celebrating yesterday," Julianna Lopez, a senior manager on the brand marketing team, said

March 5. "Today we're coming together to support each other and to be with each other.'

According to Phoebe Gilpin, Sesame Workshop's senior director of formal learning and a member of the union's organizing committee, six of the seven workers who spoke at the "heartening" rally — including Gilpin herself — have received termination notices.

"We didn't have any actual confirmation that this would be happening beforehand," she added. Gilpin said that some of the workers set to be laid off have been working at Sesame Workshop for decades.

Financial headwinds

In a letter to employees following the meeting at which the layoffs were announced, Westin said a variety of factors had left the nonprofit with a "significant budget gap" that must be solved.

'Given that our largest single expense is people and benefits, we must downsize significantly and make what we hope will be temporary changes to our benefits and bonus program," she wrote. "These changes are necessary to ensure that the Workshop is poised to continue to deliver on its mission for years to come, but that does not make the human impact of these reductions any less painful.'

Westin also told the employees spected workers' right to organize, and strong. The workers are holdrecognize the union.

One of the largest threats affecting Sesame Workshop's bottom line is that its distribution deal with Warner Bros. Discovery's contract to air "Sesame Street" on its streaming service Max is not being renewed. The children's show, aired solely on public television from 1969 to 2015, moved to Max in 2016, but Warner Bros. announced in December that it would not continue to dis-

tribute the program. Sesame Workshop had \$187 million revenue, \$192 million in expenses and \$559 million in assets according to 2023 tax filings, but it's unclear how much funding the nonprofit receives from its TV deal.

'Disappointing and discouraging'

Workers and Sesame Workshop leadership are also concerned about losing out on federal funding as President Donald Trump has taken aim at the nonprofit.

In a speech last week during which he discussed a "long list of crap this administration is cutting," Trump said that one item cut was "\$20 million for the Arab 'Sesame Street' in the Middle East," referring to a partnership between Sesame Workshop and the U.S Agency for International Development for program tailored for young people in Iraq.

Nick Galipeau, the secretary-trea-

surer of OPEIU Local 153, said that Trump's comments about Sesame Street are an "attack on American culture?

But Galipeau said he wasn't shocked by the widespread layoffs. He also said that he doesn't think the timing of the layoffs was related to workers' unionization announcement. "While it wasn't official until yesterday, I don't think it was a huge surprise," he said last week. "It's incredibly disappointing and discouraging, but not a huge surprise really.

He added the union has been pushing Sesame Workshop management to find a way to mitigate the layoffs, offer workers substantial severance packages, give workers the ability to get their jobs back in the future, and meet with the union at the bargaining table.

"Sesame Workshop respects its employees' right to form a union and seek representation," a spokesperson for the nonprofit said in a statement. The layoffs and cuts were "planned and fully decided upon well before both the union's recognition demand and our knowledge of the employees' intent to organize. We have been in contact with the union regarding its demand, which Sesame Workshop is currently reviewing."

Laid off workers who spoke with The Chief said that even if Sesame Workshop follows through on the during the meeting that she re- layoffs, the union will remain visible but didn't say if she'd voluntarily ing out hope that management will recognize their union and quickly come to the bargaining table to negotiate a first union contract.

"This is not the end — we have a union," said Lopez, also a member of the union's organizing committee. "Those that are remaining staff are going to carry forward and keep the union going."

Workers who received layoff notices have been given various dates for their termination. Lopez's last day is later this month while Gilpin's is June 30, the end of the fiscal


"Unions stand the test of time," Gilpin said. "We needed a union a year ago even before these [financial] headwinds, we need a union five years from now after these headwinds have changed and shifted into something else.'

Reynaldi Lindner Lolong, the director of individual giving at Sesame Workshop, was told that March 7 would be his last day. Lolong, who pointed out that his job brings money into nonprofit, said that he was disappointed with management's lack of transparency, but was proud that workers had built their union.

"There is a sentiment that even for those of us who've been let go," he said, "if what we have done in starting this movement to organize can make a difference for everyone who is remaining, that is absolutely a victory."
