# Blight study rejected by City Council

A standing-room-only crowd of about 60 residents at Monday's City Council meeting stayed just long enough to get the good news they were looking for.

On a 7-0 vote (Councilman Jason Bowman was absent), the Council approved Mayor Rod Koch's rejection of a blight study that would have allowed a local trash hauling business to use TIF funding to build a new facility near Ninth Avenue and Golf Road to park its 52-truck fleet near a neighborhood.

Residents in the neighborhood didn't receive notice of the plans for the new facility until about an hour before.a July 15 Public Works Committee meeting and quickly made their opinions about the proposed facility known.

The blight study covered about 15 acres, and if approved, would have allowed Gill Hauling to use TIF funding that would have been put toward noise and odor reduction efforts, including the building of a fence and planting of trees around the facility.

There had been significant discussion of the proposal in subsequent meetings leading up to Monday's decision, and Mayor Rod Koch opened the continuation of the public hearing hoping to have a final decision reached quickly.

"We have had a lot of input on both sides of the issue, and I don't believe more input is needed and would ask that (the blight study) not be approved," he said.

Before the Council voted, Koch asked those in the audience to raise their hands if they were not in favor of the blight study. Almost every hand among the reporter-estimated 60 people went up.

After the vote, Gill Hauling district manager Mike Keeran thanked those in attendance and assured them that it was not the company's intention to rush something in without the neighbors knowing about it.





# Two down, one to go

Casino in South Sioux City tenatively set for 2026 opening

For those who have been wondering when South Sioux City would get a new casino, we have an answer for you.

That answer is — soon.

With the recent opening of the Warhorse Casinos in Omaha and Lincoln, it won't be long before the dirt starts moving on more than 40 acres of land south of Highway 20 as construction of a race track and casino is expected to be completed in the next 18 months.

"We got permission from the Nebraska Racing and Gaming Commission to move the old Atokad track over to the east side of G Street, south of Highway 20," Lance Morgan, CEO of Ho-Chunk, Inc., told the Dakota County Star earlier this week. "We intend to build the track starting in the spring of 2025, and we will start doing design work on the casino soon."

Morgan said that Ho-Chunk, which also owns the Omaha and Lincoln casinos will have invested close to \$500 million by the time the South Sioux City casino opens sometime in 2026. Omaha and Lincoln

at Monday's meeting, "the use of a cell phone by a student can result in a lack of focus, not following directions, and lack of engagement in academic activities."

The school is prohibiting cell phone use during class time, in all restrooms and locker rooms and during school assemblies. Students may use their cell phone before school, during passing periods, at lunch when in the commons, and after school. If a student is using a cell phone in the hallway during instructional time, it will be considered a handbook violation.

Before class starts, students will shut off or silence their phones and will be able to place their phones in a holder in the classroom, and the phone will remain there until the end of class. Exceptions can be made by the teacher if the phones are being used for academic-related activities.

If a violation is noted, the student's cell phone will be confiscated and checked in to the assistant principal or Dean of Students office. Parents will be contacted and will have to pick up the phone at the school.

"The property had been zoned commercial a number of years ago, and Andy Lux had bought some property and proposed it to us," Keeran said. "The price was right and the street had been repaved so we decided on it, but it wasn't our intention to upset so many people."

While it was not a legal requirement to let their neighbors know what was being planned, Keeran said a new spot for the site."

were first on the to-do list and more than \$450 million has gone into opening the two facilities, both of which include hotels, casino gaming, sports betting and live horse racing facilities

Morgan said the decision to build those casinos first came down to the casino market in each of the three cities

"The Lincoln and Omaha markets are larger metro markets that aren't as competitive as the one in the Sioux City area," he said. "Lincoln has no casinos in a town of 350,000 people, where you have the machines in North Sioux City, the Hard Rock in Sioux City and two tribal casinos in an area with 150,000 people. That's why we put our focus on Omaha and Lincoln first.'

Both Warhorse casinos have done very well since opening their doors. Lincoln's facility is going to double its present size and will include 1,400 gaming positions, while the Omaha

casino has taken off since it opened its doors to the public last week.

"Omaha is doing very well, and when we add more amenities there next April we expect it to be an absolute home run," Morgan said.

While final plans for the casino in South Sioux City are still in the works, Morgan promised that the proposed \$50 million facility which will include a 5/8-mile circle track for horse racing - will be worth the wait.

"We have to invest another \$100 million to finish (Omaha and Lincoln), but we're going to start from scratch in South Sioux and might as well go all the way with it," he said. "We'll have slot machines, table games, a restaurant, a sportsbook and the horse racing, and we'll have options to expand and include a hotel and convention center as well.'

Plans are for the race track to be ready by late summer or early fall of 2025, which will allow for a probable five-day card of racing, with the casino set to be open early in 2026.

## **Special session full of ideas**

Special session continued this past week. The Revenue Committee worked Aug. 5-6 to go over the 68 bills we heard in public hearings to put together a package to bring to the floor. Many ideas have been presented and a lot of work has been done. Everyone has their own ideas and it is hard to get 49 senators on board. This is still a work in progress, but it is a start. This is a spending issue, not a valuation issue.

There are three main goals behind the plan:

Educate our children Encourage grandparents and

families to stay in Nebraska Help businesses thrive

Since I have been in the legislature, property taxes have been discussed and addressed. Previous forms of property tax relief that have passed in past legislative sessions were the Property Tax Incentive Credit Act in 2020 with \$395 million in relief; also introduced in 2020, LB1107 Income Tax Credit for property taxes paid with \$560.7 million in relief; and in 2023 the Community College Future Fund Expenses with \$246.5 million in relief. In total \$1.202 billion was devoted to property tax relief before

this special session. On Thursday, Aug. 8, senators and their staff were invited to attend a briefing over the package being put together. The Revenue Committee decided to use Sen. Jana Hughes's and more (like GoFundMe or Kick-LB9 as the main vehicle. LB9 utilizes additional state aid to public schools to lower the maximum levy cap in order to provide property tax relief for Nebraska property tax owners. Under LB9, the state will fund schools, county jails, district court clerks, and NRDs. Changes to LB9 are the levy lid taken down from \$1.05 to \$0.25 for fiscal year 2025-26 and following years and add language similar to LB1107 which allows for any excess revenue about 103 percent from the raise additional funds to help cover prior years' collection to be put into the Education Future Fund for property tax relief. Ón Thursday, Aug. 8, Governor Pillen said "I deeply appreciate the extremely hard work being done by the majority of the Legislature to deliver transformative property tax reform to Nebraskans. These senators, who represent all political stripes and all corners of our state, are doing right by their constituents by engaging in tough negotiations, good faith exchanges of ideas, and collabora-



tion with their colleagues to forge a compromise that will work for Nebraska. Their dedication is even more impressive given that it is moving forward under intense pressure by lobbyists fighting to protect special interest loopholes at the expense of hardworking Nebraska homeowners. I know that any plan passed by the Legislature will be a hard-fought compromise and that it will not include every provision I believe in and am fighting for. Nevertheless, I have profound respect for the work of the Legislature and look forward to signing that work into law.'

## No rocket scientists in this special session

By no means could I be confused with a rocket scientist, but it appears to me that the only qualifications one needs to be a "representative" in state or federal government is that you have to be a real space cadet.

The special session of the governing body formerly known as the Nebraska Legislature has been a non-stop boondoggle of a circus that makes one wonder why we elected these individuals to "represent" us in state government. Evidently, The Three Stooges were on a cruise to Argentina and couldn't make it back in time.

Governor Pig Pen, sounding more like Mussolini than a governor, ordered the troops back to Lincoln under the guise that he had a plan to knock our property taxes down to a more palatable level, a level that wouldn't require us to get a second job, join the World Poker Tour or prostitute pictures of our feet on OnlyFans to make up for the doubledigit percent increases in our property taxes.

Personally, when I bought this newspaper two months ago, my original plan was to commute between here and my home in Wayne so that I could watch my niece compete as a high school golfer. That was the plan — until I got my statement from the tax lords at the county courthouse that informed me that, for the third year in a row, I would be paying at or near a 10 percent increase on my property assessment.

Governors going back to Dave Heineman have been promising to do something about our sky-high property taxes, and I guess they delivered on that promise - that is, assuming that doing NOTHING is still doing SOME-

So when Pillen brought everybody together a couple of weeks back and then said (and I THINK I'm paraphrasing, although this may be a direct quote) — ummm, I've got nothin' — it was at that point that I think we are starting to see that this governor couldn't think his way out of a wet paper sack. Granted, he's got a lot of ideas about what should be done — but to not have a real plan ready to go for that first day of a special session was infuriating, particularly to the "representatives" who had to drop whatever it was they were doing back home to head back to their Lincoln office.

Nothing really intelligent, meaningful or thought-provoking has come during the first few days of this special session. Two Omaha senators suggested legalizing marijuana (don't even get me started on the stupidity of that idea), others are suggesting legalizing online sports gambling (the only suggestion to come

anywhere close to making sense, considering the millions that can be collected) and the idea of the state paying for public schools and driving the levy down to 25 cents (an idea that takes local control away from schools, which is NEVER a good idea).

One of the best ideas that I've seen only because it creates a grand inconvenience to those in power is selling the governor's airplane. While a plane would be very useful in situations like needing to fly from Lincoln to Scottsbluff to oversee the aftermath of a natural disaster, Governor Pig Pen has made far too many trips by air to places like Beatrice, Grand Island or Columbus that cost many times more than a drive to those cities. Beatrice, for example, is roughly the same distance to Lincoln as the drive I make from this office to my home. In my college days, I made the drive from Beatrice to Lincoln imagine the possibilities.

so often that I have all the notable things on Highway 77 memorized (although, back in those days, that highway was a two-lane road, not the four-lane expressway it is today, so that pyramid of empty Old Milwaukee cans we left behind in a ditch outside of Pickrell coming home from a beer party out in the country might be gone . . . but I digress).

The only thing this Legislature seems to know how to do is pass anything but meaningful legislation. Blame, dissent, frustration, temper tantrums — they can sling those better than any bunch of "representa-tives" around — but when it comes time to put together something that makes sense and actually helps the vast majority of property owners in this state (rather than those with money and influence like Governor Pig Pen, Loo-Loo Ann Linehan and others), the only thing they seem willing to get done is - well nothing.

At this stage of the game, it might make more sense to just pull up the tent stakes and let this circus leave town. By the time anything meaningful gets done, most (if not all) of the school, city and county government entities will have set their budgets for the 2024-25 fiscal year, so anything that is done at this point isn't going to make any kind of impact until the 2025-26 fiscal year. The Legislature — if they still have their wits about them — will have the next Legislative session in January to FINALLY figure this out. There will be a number of new "representatives" who, we can only hope, have some fresh ideas and a willingness to actually take on this state's screwed-up tax system and come up with something that works for everybody.

The wastewater is produced by activities such as washing animals, cleaning meat and animal products, sanitizing equipment and scrubbing work areas within the facility. 





This would allow for the required parking of the commercial property and the exit lane. Another option was presented to put in a U-shape road that circles around the Post Office on the east side. Both scenarios will be presented to the commercial owner for consideration.

The location of the new scoreboard for the baseball field was discussed. After reviewing the location and the bids at the June meeting, Hayes moved to have the scoreboard located in center field of the baseball park. Petersen second the move. A roll call vote was taken with all board members voting in favor. The bid providers will be contacted and asked to update their bids to accommodate the new location.

The board discussed the care and maintenance of South Thomas Street on the southside of the bridge. Gill Construction was contacted to provide a bid to gravel and grade that road.
