County decides to forego LEC letter By MICHAEL CARNES

At Monday's Dakota County Board of Commissioners meeting, the future of the county's involvement with the City-County Law Enforcement Center was the main topic of discussion.

At issue was whether or not the county would submit a notice of termination letter to the City of South Sioux City, effective Aug. 31, 2025, as part of a 30-year-old agreement between the two parties that came with the construction of the law enforcement facility in South Sioux City.

When it was first constructed, the two law enforcement entities shared space with a single dispatch that communicated with both parties on situations that were called in via the city/county 911 system. Both parties had their own office space, but current Sheriff Chris Kleinberg moved the Dakota County Sheriff's Department to its present location at the Dakota County Jail after taking office in 2011 to save on transportation costs.

At issue is whether or not the county

should continue to pay the \$50,011.25 it pays monthly for the facility, or if they should pay a lesser amount since their use of the facility is primarily just for dispatch services.

The two sides can renegotiate those terms, and were expected to do so in the coming year with the original agreement set to expire in 2025.

Board chair Martin Hohenstein said he has had discussions with South Sioux City Mayor Rod Koch and Hohenstein City Administrator Lance Hedquist about renegotiating

the deal. "I have talked to a number of people at the city, and they say they are willing to sit down and take a look at the contract," he said. "It hasn't been looked at since it was written in 1996, and both sides want to sit down and look all the way through the contract."

Hohenstein said that both parties were looking at meeting after the city and county finish their work on their respective 2024-25

fiscal year budgets, adding that he didn't feel a termination notice letter needed to be sent.

"That is to terminate the contract and I'm not looking at terminating anything," he said. "I don't think the county needs to start that up and then have to go and duplicate those (dispatch) services.'

Board member Bob Giese felt that a letter should be sent so that the city is aware that the county wishes to renegotiate the terms.

"I think we need to send a letter that we are serious about renegotiating the contract," he said. "Neither side is going to walk away from it.'

Hohenstein disagreed.

"They said they'd work with us in good faith and I'm comfortable with that," he said. 'If things fall flat during negotiations, then you would do that."

Board member Scott Love said that the county would be foolish to disconnect from the agreement altogether.

'There's no way you could set up a communication center (for the county) for the money that would be involved," he said,

pointing to the equipment and salary costs the county would take on.

Giese said the county should put together a specific list of what their obligations to the LEC center would include.

"If I'm South Sioux City and I say 'What do you want us to reduce or cut from the county's obligation, budget-wise,' I think we need to have a specific list of what we need to cut."

At the end of discussion, Love moved to not send the letter to the city, saying he felt South Sioux City officials "are good enough people that they'll work with us on it." The motion was approved on a 3-2 vote, with Love, Hohenstein and Brian VanBerkum voting in favor. Giese and Troy Launsby voted against the motion.

There was also discussion on the process for finding a replacement for outgoing Dakota County Treasurer Dawn Bousquet, who announced her retirement earlier this month and will be leaving the position in early Oc-

No quorum at **Public Works** meeting

A quorum was not present at Monday's Public Works Committee meeting.

City Administrator Lance Hedquist went over some of the items that were on Monday's agenda, including information about expansion of the city's wastewater treatment plant and a request to drain standing water away from the Northeast Nebraska Senior Center.

Ethan Joy of JEO Consulting Group updated the plans for an expansion of the city's wastewater treatment plant that will allow it to begin accepting residential and commercial wastewater. A north-to-south pipe is in the works for the addition, and Joy said that design work is almost completed and final plans should be ready for presentation in the next 1-2 weeks. A small pool of water that sits in the north corner by the senior center can be moved away with installation of an underground pipe that would carry the water south into the ditch near Great West Casualty. Two bids on the project were noted at Monday's meeting, with Hedquist recommending the low bidder of Hans Excavating in the amount of \$14 875 The committee also received information about regulating the speed limit on Old Highway 20 to the west end of town, noting that there are different speed limits along the route. The current speed limit of 35 miles per hour going west could be increased to 40 miles per hour, based on recent surveys taken by local law enforcement. Hedguist said the topic will be pushed back to the next Public Works Committee hearing, as Police Chief Ed Mahon was on vacation this week. The committee also took a look at possible extension of Siouxland Drive that would run from 29th Street north to 25th Street behind the Hy-Vee convenience store. Negotiations are ongoing between the city and owners of property that the road would be constructed on, and Hedquist said more information would be available at the committee's next meeting.





DHHS faces cuts despite demands

The Nebraska Department of Health and Human Services has seen a \$15 million cut to its Behavioral Health Division this year and more cuts are being proposed, despite soaring demand for mental health and addiction reatment programs.

DHHS now faces a \$25 million cut to help fund property tax relief.

Behavioral Health Specialists in Norfolk provides short-term residential treatment for substance use disorders

Neil Broders, executive director, said the COVID pandemic may have contributed to the mistaken assumption any unspent funding must not be needed.

"Really, why a lot of places weren't able to pull down their funding and use it, it wasn't because the demand wasn't there," Broders pointed out. "It's because trying to find staff the last four to five years -- it was a difficult period.

Some Nebraska agencies have spent years rebuilding heir staff following COVID. Broders explained they have had to compete with national companies who can pay more and allow people to work remotely. He pointed out employers, especially in smaller communities, have had to increase wages and work harder to recruit and retain staff.

Broders added their residential program only recently became fully staffed for the first time in four years.

"We now have the staff to be at 58 beds and are full." Broders reported. "We receive over 100 referrals a month for those 58 beds. So, we have the staffing now to serve the clients, and the clients are there.

The multi-program CenterPointe, based in Lincoln, has seen a similar increase in demand in the past year.

Topher Hansen, JD, president and CEO of the nonprofit, said their primary care clinic served 500 more people, and they provided over 2,000 additional hours of outpatient clinic care, at least partly because they were able to fill some open positions.

"But the more staff we get, the more availability we have, the more people that come in the door," Hansen observed.

More than half the people CenterPointe served in the last fiscal year reported annual incomes of less than \$1,000

Hansen acknowledged funding for mental health and addiction recovery is not always politically popular, but he stressed it is often a fiscally sound move. He pointed to their "Alternative Response" program, which works with the Lincoln Police Department to send a Center-Pointe team, rather than a uniformed officer, for nonviolent welfare checks.

"We have done over a thousand of those in the last year and saved officer time every single time," Hansen emphasized. "We've cut the emergency protective custody incidents in half. We've housed a dozen people, and decriminalized being unsheltered."

NDOT announces transportation funding

The Nebraska Department of Transportation (NDOT) has announced funds are now available to private non-profit organizations and governmental entities for transportation needs of elderly persons and persons with disabilities for whom mass transportation services are unavailable, insufficient or inappropriate.

Eligible applicants include private non-profit organizations incorporated within Nebraska and governmental entities. Governmental entities must certify that there are no nonprofit agencies in the service area readily able to provide the service.

Applications will only be accepted for the rural and small urban areas and Lincoln. Applicants in the Omaha area should contact MAPA for information about applications. The Federal Transit Administra-

tion's Section 5310 program is a Federal Grant program managed by NDOT. The purpose of the program is to enhance the mobility of seniors and individuals with disabilities.

Applications are restricted to the acquisition of transportation vehicles. Applications are due by Oct. 31, 2024.







Special session on tax relief continues

Last week, the special session continued as we worked to hammer out what the property tax relief package would look like. There is a lot of disagreement on what is the right way to address this very important issue in the state of Nebraska

What I shared in my last newsletter has developed into something different. I do believe now is the time to address the property tax crisis. We have all been called back to the State Legislature by Governor Pillen and we need to address this now.

Our state and our taxing authorities have a spending problem. Our state has reduced its state spending by \$140 million which is a 2.5 percent reduction in spending. ALL taxing authorities MUST take a hard look at their budgets. This is not a valuation issue, but a levy problem as well as a spending problem. Just as we have to adjust our own personal budgets in order to make sure we are spending our income properly, the taxing authorities and state government must look at their budgets and tighten their belts to make sure they are spending correctly. It is in Nebraska state law that when valuations go up, levies shall reduce accordingly.

We need to broaden the base or we won't get relief. There are \$7 billion in sales tax exemptions and no one wants to give up their exemptions Strength comes when everyone comes to the table and is willing to negotiate in good faith. Nebraska will begin looking at ALL taxing authorities to see how taxes are being used. The lobby has done a good job of bringing division to our body. It seems to be okay for some to keep their tax exemption, but not for others. Everyone needs to give a little to get a little. Everyone needs to come to the sandbox to play. We pivoted to funding schools as it was never the intention of the state to fund public schools using property taxes. Currently, taxes paid to school



of most individuals' tax bills. School districts levy nearly 60 percent of the total property taxes collected. Recent increases in agricultural land valuation have greatly impacted state aid to schools through TEEOSA (Tax Equity and Educational Opportunities Support Act). School districts are eligible to receive state aid through TEEOSA to supplement property tax revenue. Part of TEEOSA's funding formula is based upon the property tax resources available in the district. Over the past few years, an increasing number of schools have become non-equalized and do not receive any state funds. These school districts, largely in rural areas, must then rely solely on property taxes. The formula is obsolete and MUST be revamped. Large schools will soon not be able to capitalize on the formula.

On Tuesday, Aug. 20, (day 17 of Special Session) we will either move forward with LB34 and Sine Die or if LB34 doesn't pass, we could be there longer with other ideas presented Stay tuned.

Nebraska GOP: Too chicken to debate?

The Republican Party got its start back in 1854.

Six years after its formation, it won its first Presidential race when Abraham Lincoln — a man who lost ELEVEL political races in a row before winning this one — became the leader of the free world.

Thomas Nast, known in historical circles as "the father of the modern political cartoon," first tied the GOP to the elephant in a cartoon for Harper's Weekly in 1874. Titled "Third-Term Panic," the drawing mocked the New York Herald's criticism of President Ulysses Grant's rumored chase of a third term in office, portraying a variety of interest groups as animals. The elephant was depicted as "the Republican vote," and Nast would go on to tie the GOP to the animal in future columns with other cartoonists following suit.

Well here we are, about 170 years from its debut, and I think it's time for Republicans — at least the Nebraska wing of the Grand Old Party — to undergo a rebrand.

You see, we are in the age where political discourse is, to put it in kind terms, hot. The two sides are at verbal war with one another, and both sides seem content with firing accusations — some true, the majority of them baseless or spun wildly in one direction or the other — and painting the other side as the "death of America" or "bad for business" or . . . just pick a phrase.

In the 2022 race for governor, Nebraska's candidates for governor and U.S. Senate both decided they had ANYTHING better to do than to actually engage the candidate of the group loosely known as the Nebraska Democratic Party in any kind of preelection public discussion. And, to be honest, who could blame them — the NDP is such a train wreck of a political organization that their candidates facing Republican would have been the political equivalent of bringing a feather duster to a gun fight.

That being said, it is VITAL to our form of government that an exchange of ideas and a vigorous challenge of those beliefs be done in a public setting. The debate has long been the place where both sides present their viewpoints and challenge the other side in defending theirs. It's from this conversation that we, as voters who will be paying for the winner's to-do list with our tax dollars, are able to see and hear who the best choices are for the major offices, including the White House, the governor's mansion, and the seats where they will serve as our "representatives" in Congress.

Fast forward two years later, and it would seem the Nebraska GOP doesn't think it NEEDS to exchange ideas with their opponents, refusing — as of this writing — every overture and offer for a debate by their challengers for the U.S. Senate seats that are up for election this November Thanks to Ben Sasse stepping down as a Senator to become the president of the University of Florida a couple of years ago, we have a unique situation where both Senate seats are up for grabs. Sasse's seat was decided in 2020 and, normally, wouldn't be up again until 2026. When he left, new Governor Jim Pillen (in a move that, OBVIOUSLY, was a coincidence and please note the sarcasm) named then-outgoing Governor Pete Rick-etts as Sasse's successor. Under the state rules, Ricketts would face a special election in 2024 to serve the final two years of the term before the seat's next cycle comes up in 2026. Ricketts is facing Preston Love Jr., an Omaha resident who, believe it or not, is a Democrat with some actual ideas that are worthy of being discussed before voters. Love has called out Ricketts and offered dates for the hail from thinking that we don't need have.

According to the state GOP's leadership, Love has "failed to meet even the most minimum threshold for

electoral viability." So what ARE those minimum thresholds? I mean, BESIDES the fact that he's not a Republican? Not Nebraskan enough? Doesn't have enough money in the campaign cof-fers? I mean, it CAN'T be because he's . . . (thinking whether or not this card should be played or not - nahhhh, it's probably already assumed so why play it? Let's move on . . .).

Also on the agenda for the Nov. 5 general election is the other Senate seat, currently held by Deb Fischer, who DOES have a legitimate candidate running against her who is NOT a member of that woebegone Nebraska Democratic Party that used to challenge these races back before Ben Nelson sold us out on Obamacare.

Dan Osborn, a former union leader, has put together a real race for the Senate as an independent, and he is challenging the two-term Fischer to four debates, including one during the Nebraska State Fair in Grand Island later this month. "Debates in this country are as American as baseball and apple pie,' Osborn told the Omaha World-Herald in a recent story. "Nebraskans deserve better access tot he people who serve them. I wholeheartedly agree with Osborn' view on this — the Nebraska GOP, not so much. Fischer has declined Osborn's challenge to debate on the issues and give Nebraskans an option when they go to the ballot box $2 \frac{1}{2}$ months from now, saying that debates are nothing more than "short sound bites" and adding "we don't have conversations at debates.' What??? conversation between two opposing candidates that lays out what we want (and NEED) to know about who we're going to select at the bal-lot box? What planet does Fischer

herself and her lone challenger?

Which brings us back to the elephant being the designated mascot of the GOP. In my mind, an elephant is a majestic creature, one to be respected for its size and power. An elephant isn't afraid to defend itself against attacks from other animals and will stampeded against those who try to harm them.

Nebraska's GOP — CLEARLY - doesn't have that same mindset when it comes to facing scrutiny and be subject to questioning on why we should vote for them over an opposing candidate. They don't WANT to put their agenda up for debate against the other side — regardless of who that side might be — and don't want to have to compete for our vote. Just blacken the circle with the (R) next to it and move on . . . nothing more to see here.

So with that idea in mind, I took it upon myself to freshen up the Nebraska GOP's logo (see above) to better illustrate its desire to not face their challengers. Quite frankly, the frightened chicken is a much better mascot that describes the state's Republican leadership and its unwillingness to face a challenger in a public setting (The scared chicken is also an appropriate alternate to the donkey that has long been the Democrats' mascot, as that party has been full of jackasses for as long as I can recall, but that's another column). Sadly, we'll probably not be given a chance to hear either Ricketts and Love, nor Fischer and Osborn, trade ideas in a public setting. Money rules the game in politics and the Republicans are far and away the leader in that department, which means they'll just waste their financial resources on TV and Internet ads that will be of zero value to those who want to compare and contrast the two sides.
