Fifteen years ago, Cardinal Christmas Baskets stepped in to continue the tradition started more than 60 years earlier by Pete's Feeders, an effort to help those in need have an enjoyable holiday dinner.

That tradition continues here in South Sioux City this year, and the group of local volunteers is looking for support in an effort to help more than 250 local families with a holiday meal this season.

The effort has a long history in South Sioux City and Dakota County, starting out as the Pete's Feeders effort, which ran for more than 60 years before Cardinal Christmas Baskets began its work.

Working with the schools and local churches, the group collects donated canned goods and brings them to the Memorial Hall across the street from the South Sioux City Fire Department. Prior to delivery, the canned goods are combined with donations from Hy-Vee and delivered to area residents in need. Eriksen said the group hopes to raise about \$35,000 to help feed 250-300 people in this year's effort.



Railroad seeking closure of F Avenue

The proposed addition of a parallel track near F Avenue that would help eliminate the blocking of traffic on Highway 77 was met with some concerns by local residents during Monday's Dakota County Board of Commissioners meeting.

Meeting in a rare morning meeting due to the Thanksgiving holiday, the board heard from Burlington Northern Santa Fe officials who are planning on installing a parallel track that would assist in moving grain commodity and cut down on blocking Highway 77 traffic.

Nathan Smith of Ameritrack Rail, an Indiana-based railroad contractor, said the second track would run to the west, and while closing F Avenue is preferred, he said it is not required

would minimize issues if it could be closed, but it's not required," he said.

Board chair Martin Hohenstein said a concern he would have is that by closing the road, it would eliminate an entry and exit for any emergency vehicles that might be required in that area.

"If something happened to that road, that would leave one way in and one way out," he said. "There is a residence out there, so I don't now if I would want to close it.'

Gene Mari, a local landowner, said he would not be in favor of shutting down the road.

"Myself, I wouldn't be in favor of closing that road for the simple fact that there would only be one access for everybody," he said. "If it needs to be shut down for construction "We're expecting a 15 percent increase of (of the second track), then that's the way it is.

When South Sioux City Councilwoman Carol Schuldt was asked why she was stepping down after serving the past 10 years on the City Council, she showed her sense of humor.

"I'm old," she deadpanned.

The 81-year-old lone woman on the eight-member board saw her last meeting Monday evening as the City Council held its second meeting of the month, ending a 10-year, 2 1/2-term run with

the city that she said she has thoroughly enjoyed.

"It seems like yesterday that I was appointed,' she said, reflecting back to then-Mayor Bill McClarty's 2014 appointment (she was elected to full terms in 2016 and 2020). "I felt that I had an opportunity to give back to a city that's given me so

much over the years, and I've enjoyed working with the people on the Council who have become friends and serve an important role in how the city operates."

Schuldt moved to South Sioux City when she was in seventh grade and has stayed in the community ever since. She initially ran for the City Council in 2012, and when a death left a seat open, McClarty called on her to fill the seat.

When she ran, she asked me if she should and I told her if that's where you're at, then go for it," her husband, Richard, said. "There was a lot of excitement when she got appointed and she's been really excited to have been on the Council these last 10 years.

Mavor Rod Koch said that he's had a front-row seat in watching Schuldt serve the city.

"Just watching her grow in her position. she has done such an excellent job and has an interest in the aesthetics of the community and it's been a pleasure to have had her on the Council," he said.

Schuldt has been a part of the city's design commission for a number of years and takes a keen interest in the look the city has, particularly in its downtown area.

Golf carts get second read, approval

Vehicles would not be allowed on major roads, including Dakota Ave.

Golf cart owners in South Sioux City are one meeting away from being allowed to drive their carts on certain city streets.

At Monday's City Council meeting, the board approved the second reading of an ordinance that will allow golf carts to be operated on city streets, with a number of restrictions.

Police Chief Ed Mahon said he was skeptical about allowing golf carts to be operated on city streets, but other cities who allow golf carts have not had any serious problems. Mahon said

Mahon he would like to see them limited to resi-

dential neighborhoods and kept off of major thoroughfares like Dakota Avenue

The city already allows ATV's and UTV's to be operated on city streets, according to City Attorney Mike Schmiedt. Those vehicles must be licensed and have proper signaling, including direction blinkers, headlights and taillights, and the operators must be licensed as well. Mayor Rod Koch agreed with

Mahon in limiting the vehicles to certain streets, keeping them off of major roads where traffic operates at higher speeds. Most golf carts have a maximum speed of 15-20 miles per hour, and they would pose a traffic hazard if allowed on the city's busier streets.

The ordinance received a second reading and passed on a 7-0 vote, with Councilman Jason Bowman absent from Monday's meeting. In other action, the Council:

- approved an updated insurance

package for city employees for the coming year. — approved Mahon's request to purchase three new vehicles for the

Police Department. Two old vehicles will be replaced, while a third that was involved in an accident earlier this year would also be replaced, with insurance taking care of most of that cost. ARPA funds will be used for the purchase.

approved the Fire Department's request for a Department of Homeland Security grant application to replace PPE devices used by the firemen.

- approved a 50-cent per cart in-- approved an agreement for de-

sign services for the Westside con-

necting trail.

- approved conditional use permits on two properties to convert into single-unit housing at 2219 Dakota Avenue and 1225 East 19th Street, both of which were at one time locations for the city library.

- approved a liquor license for Taqueria and Bar Mallis L Casa Del Taco Mexican Food.

- recognized Officer Dave Gerkin for 30 years of service with the Monday, Dec. 9 at 5 p.m. in Council South Sioux City Police Department. chambers at City Hall.

The Council also recognized outgoing members Carol Schuldt and Rick Bousquet, whose terms on the City Council ended with Monday's meeting. Bousquet will begin serving on the Dakota County Board of Commissioners in January, while Schuldt ended 10 years of service on the City Council.







We were about a dozen rows off the stage as they came out - without makeup - to do a 30-minute soundcheck where they played a few oldies that weren't part of the regular set.

If you've ever been to a KISS concert, you know all about the stage antics, from Gene Simmons breathing fire and spitting "blood" before being lifted to the top of the stage (this time, however, he rode a platform about two-thirds of the way up, which was still fun but not part of the usual routine) to Paul Stanley being carried out over the fans to a platform near the back of the arena (from where I was sitting, he was about 20 feet away, so I had a great view of him out there).

The drive home was even more entertaining, as we encountered a blizzard just outside of Moline, Ill. about a couple of hours into the drive home. We white-knuckled our way through the snow, made up time once we got to Des Moines, and made it back in 12 1/2 hours.






Pastor Hill asked the blessing before the noon meal. A lunch of spaghetti pie, Ceasar salad and desserts was enjoyed.



Resources offer crop insurance guidance

Across the United States, producers are facing un- crop insurance policies cover each type of loss. predictable or extreme weather events which can cause financial difficulties. Risk management, in the form of crop insurance, can offer financial protection.

To aid producers new to crop insurance, whether they are commodity corn and soybean growers or raising organic and specialty crops, the Center for Rural Affairs has created the "Crop Insurance 101" series that addresses frequently asked questions.

"Signing up for crop insurance, especially for the first time, can be daunting," said Kelsey Willardson, policy associate with the Center. "With shifts in weather patterns and extreme events like flooding and drought, it is important that all producers have access to crop insurance, and sometimes this access depends on understanding the basics.

Federal crop insurance is administered by the U.S. Department of Agriculture's Risk Management Agency and provides financial protection for producers who face yield or revenue losses caused by natural causes or market fluctuations.

The first of the series, "Weathering the Unpredictable: The Protection Crop Insurance Provides," describes common perils that result in these losses, as well as which

The series continues with resources outlining important dates to remember and instructions for filing a claim. This includes dates that producers must follow to maintain eligibility for crop insurance coverage, such as the sales closing date, premium billing date, and final planting date. In addition, the guide contains details producers need when filing a claim to ensure they receive full coverage

"The process may seem complicated to newcomers, but there's no need to navigate the process alone," said Willardson. "These guides are meant to serve as a starting point for a conversation with your crop insurance agent.'

Another resource in the series includes an overview of Prevented Plant Coverage. Many producers are familian with crop insurance policies that offer financial protection for damaged or destroyed crops; Prevented Plant Coverage, however, offers protection from the loss of crops that could not be planted in the first place.

"Farmers face many risks in their profession, and all farmers should have access to the safety net that crop insurance provides," said Willardson.

Windbreaks bring host of benefits for area farmers

Windbreaks are fantastic allies in farming! They bring a host of benefits, like preventing soil erosion, providing homes for wildlife, and helping to capture carbon. One of the most valuable things they do is protect crops, which can really boost production.

Wind can be tough on both soil and crops. It can lower soil temperature, increase water loss, and lead to erosion, not to mention the direct damage it can cause to plants. Issues like desiccation, abrasion, bruising, and breakage can all reduce both the yield and quality of your crops. By slowing winds down, windbreaks lend crops a helping hand, creating a more favorable environment for growth.

They also create microclimates that encourage pollinators to visit, which is great for improving crop production. However, it's wise to keep in mind the balance between the space taken up by windbreaks and the ben-efits they provide. For the best results, it's usually suggested that less than 5 percent of a field be dedicated to these natural barriers. Many effective windbreaks consist of a single row of tall trees. This setup minimizes the space used while still providing excellent Broadway in Dakota City.

protection downwind and reducing the need for multiple barriers.

Windbreaks can significantly boost crop yields in the areas that are 3 to 10 times their height downwind, with some benefits even reaching out to 15 times their height! With climate change bringing about more frequent droughts, heatwaves, and unpredictable weather, windbreaks can be crucial in helping farmers manage risks and keep their crop production steady while also enhancing quality. They can easily fit into other practices for improving soil health and adapting to changes in our climate, like cover cropping.

When planning a windbreak, it's beneficial for farmers to think about factors like density, area, height, the direction of the prevailing winds, and which specific crops need the most protection. Teaming up with natural resource department can make sure your windbreak is designed and placed just right to cater to your unique farming needs.
