Cardinal Vision price tag: \$127 million Most popular option will cost taxpayer \$40 per year

It has been more than a quarter-century since South Sioux City Community Schools last complet-ed a major multi-million dollar facilities upgrade.

With that thought in mind, the 130 local residents attending the final Cardinal Vision workshop decided that now is the time to play catch-up on addressing the school's building needs for the future.

Given the choice of four options, those in attendance overwhelming favored the priciest one, totaling \$127 million that will address three aging buildings and help address an ever-growing enrollment base far into the future.

Three new buildings would replace the district's three oldest elementary school buildings — Cov-ington, E.N. Swett and Lewis & Clark — and move sixth-grade students from the current Middle School to one of the new buildings, where they would join fifth-grade students. A new K-4 building would be built, with a third building designated for preschool students.

Tuesday's workshop was the last in a series of five that the school has hosted during the past several months. Previous workshops showcased the age and condition of the district's seven school buildings, and data regarding current and future enrollment numbers indicated that the district was facing an overcrowding issue in the coming years.

The plan that was under consideration consisted of a base concept with four options that would deal with a variety of issues at some or all of the district's seven school buildings, including five elementary schools, the middle school and the high school.

The base plan called for the replacement of the district's three oldest school buildings — Coving-ton Elementary (100 years old), Lewis & Clark Elementary and E.N. Swett Elementary (both 64 years) - and shifting of certain grades into new buildings, with a total price tag of \$109 million.

The first of the three new buildings would be a new intermediate school for grades 5-6 that would hold up to 660 students. A potential site on the northeast part of town would be where this building would be erected and would include new safety and security features and complete accessibility.



SSC teachers to see pay increase

Teachers in the South Sioux City Community Schools District will see a little something extra in their paychecks next school year.

At Monday's meeting, the district's Board of Education approved the negotiated teacher agreement for 2025-26 that calls for a number of financial enhancements for teachers.

Highlighting the changes is an \$1,800 increase to the base salary to \$42,425, with a \$1,000 bonus for teachers with MA+45 at Step 16. Language from existing memorandums of understanding were included to address years of experience and pay calculations for covering unfilled positions.

insurance contributions, an increase in lost plan time compensation from \$35 to \$0 an hour, and an additional sick leave day and personal leave day for teachers with 15 or more consecutive years of service. The buy-back rte for unused sick days at retirement was raised to \$160 per day (30 day) limit) and increases the rate for unused personal days.

Airport rezoning request still on the runway

The future of Martin Airfield has yet to take off as the City Council of South Sioux City postponed the second reading of a rezoning request during Monday's meeting.

The request to rezone the old privately-run airport west of town, which was recently purchased by Chase Bracht, is up in the air as discussion of whether or not cattle can be allowed on the 140-acre property.

City Administrator Lance Hedguist said the property does not have a permit to house cattle, and there is also a question as to whether it will be a commercial zone or an agriculture xone.

Bracht has stated in previous meetings that the hangars presently on the property were going to be used for storage, with plans to sell some heavier equipment also expressed.

"There are rules in place that we're not following, so we need to sit down with a plan," Mayor Rod Koch said. "If we allow one person to come in and ask for forgiveness rather than have cattle on property that is zoned permission, we're going to get this all the time. We need to talk about

OSHA looking into fatality at Tyson Foods

An investigation by the Occupational Safety and Health Administration (OSHA) is under way after a workplace fatality was reported earlier this week at the Tyson Foods plant on Dakota City.

U.S. Department of Labor officials confirmed last Wednesday that the incident happened in the warehouse material handling area on Monday, Jan. 6. Specific details of the incident were not available.

OSHA will have six months to finish its investigation. Further details are not expected until that work is finished.

The second buildings would be for grades K-4 and would replace both Covington and Lewis & Clark. The new building, with a potential site in the north or northeast part of the district, would also hold 660 students and include the same safety, security and accessibility additions as the first building.

A third building that would replace the Swett school, which would be built near the present building, would handle about 300 preschool students and also include safety, security and accessibility options.

With the base plan came four options that were considered by those in attendance, and the majority of positive responses added another \$18 million to the package, bringing the plan's total to \$127 million.

That package includes a full update of all infrastructure and classroom updates in the district, additional space to handle growing capacity at Dakota City Elementary, accessibility updates at Harney and Cardinal Elementary, and provide for more program space at the high school.

Discussing the pros and cons of such a project, those in attendance had some concerns, most notably the location of the new construction.

With the closing of Lewis & Clark Elementary coming as a result of the new construction, the district would be left without a building on the west side of town. Several of those who expressed this concern noted that all of the new building would be on the expansion in the city.

Redrawing the boundaries of the elementary schools was another concerned voiced several times, again pointing back to the issue of no school buildings on the west side of town.

Other concerns that were raised included traffic congestion problems, particularly at Cardinal and Harney Elementary, busing issues for students currently attending Covington Elementary, and the additional cost - which amounts to \$1.31 per day per \$1,000 of valuation on a property in the district.

After Tuesday's final two-hour workshop, Superintendent Dr. Rony Ortega said he was surprised those in attendance chose the priciest option of the four.

"I was surprised in a good way that our community selected the most expensive option, but I think what it shows is that the community recognizes they are getting more value,' he told the Star. "It's six dollars a month between the first and last (of the four options), and the thinking seems to be that we'll get a lot more addressed for the long haul.

The nine-digit price tag will no doubt be a concern for those who will be voting on the package, assuming the SSC Board of Education goes ahead with the proposal at a scheduled Feb. 24 meeting, but Ortega said that when recent cuts in the district's tag might not be as hefty as it first apperas.

One thing Ortega stressed after the workshop is that it is going to cost more the longer the district delays on addressing the building and enrollment issues it now faces.

"There was an attempt in 2016 before I was here, and what we've learned from that is that everything costs more," he said. "They were pitching a preschool in 2016 that would have cost \$10 million. Today, that same preschool is more than \$15 million, so the longer we wait, the more things will cost.'

Ortega said the five workshops have helped the school district educate the community on where the district's infrastructure issues are and have relied on the community to provide suggestions as how the school should address those issues.

Ortega said the community will have an opportunity to complete a survey that will be released online this Friday, and from that data the school board will make a final decision on whether or not to proceed with the proposed project in the form of a bond issue that will be decided by residents within the South Sioux City school district.

After Tuesday's meeting, Ortega feels optimistic that a bond issue, even a pricy one, will be approved.

Farmers optimistic about farm policy

Some farm advocates in rural America, including Nebraska, are calling on the Trump administration to continue investing in small communities.

They propose that new federal investments in agriculture wind up in the hands of farmers in rural communities.

Nebraska Farmers Union President John Hansen said he is cautiously optimistic about how rural policy will look in the new administration, but said it will start with fair competition in the agriculture markets.

"The markets are not competitive now," said Hansen. "So, if they're not competitive, they're not functional. They don't perform as they should. And we want more competition. So, in order to get there, we need some appropriate regulation in order to create competition. And in the absence of competition, there's collusion."

Hansen and other rural farm advocates are calling for increased competition in the supply chain and food processing sectors of the agriculture economy, and for more federal investments at the local level - where he said farmers are facing unprecedented financial stress.

Hansen added that markets are far more consolidated today than they were when lawmakers created the Packers and Stockyards Act in 1921, especially in beef and pork.



Legislative Round-Up: Week of Jan. 8

The 109th Nebraska Legislature convened last week for the first days of the 2025 session to swear in newly elected state senators, elect committee chairmen and begin bill introductions.

The Legislature began the first day of its 90-day session on Wednesday, Jan. 8, and swore in 25 senators, including six re-elected members and 19 new members.

Senators re-elected Sen. John Arch of La Vista, who ran unopposed, as speaker of the Legislature. The Legislature also elected senators as leaders of its 14 standing committees.

The first resolution of the session, LR1, honored and commemorated the service of former President Jimmy Carter, who died on Dec. 29, 2024, at the age of 100.

Senators began bill introductions on Thursday and Friday, introducing a total of 132 measures in the first two days

LB3, introduced by Sen. Loren Lippincott of Central City, proposes changing Nebraska's electoral vote system. Currently, Nebraska and Maine follow a split-vote system, where each congressional district casts one electoral vote for the winner of their district, and the state casts two overall votes for the winner

of the state. The bill would change the system back to winner-take-all, which would award the state's five electoral votes to the winner of the state. Senators proposed a similar measure before the 2024 presidential election but refused to consider it last fall, citing political pressures. LB 12 introduced by Sen. George Dungan of Lincoln, would remove the statute of limitations and allow for more extensive legal punishment in child sexual assault cases. Currently, charges cannot be brought against those who aided in child sexual assault beyond 12 years after the victim's 21st birthday. This measure would also allow those not found criminally guilty of child sexual assault to still be liable to civil

charges and fines.

LB 49, introduced by Sen. Terrell McKinney of Omaha, would change rules for public schools to ban individuals and students from school property.

The measure would require each district to create a specific ban policy. Each policy must state that bans cannot be applied as a form of discrimination. Policies cannot ban students Holdcroft of Bellevue, would elimiunless they are an immediate danger to the student body and must allow any individual who is banned to appeal against their ban.

LB 53, introduced by Sen. Machaela Cavanaugh of Omaha, would prohibit any criminal or civil prosecution of a pregnant person for any pregnancy outcome that does not result in live birth, such as stillbirth, miscarriage or abortion.

The bill is intended to provide legal protection to pregnant persons after Nebraskans voted to pass Initiative 434 in November, which ceban into the state constitution.

LB 63, introduced by Sen. Tom based on the court's discretion.

becca Allick spoke at a press conference on Jan. 10, introducing the bill and advocating that the move provided protection for women's rights in sports and private spaces. Transgender rights activists cited the act as another discriminatory move in Nebraska's recent string of anti-trans legislation.

LB 122, introduced by Sen. Glen Meyer of Pender, would require all public schools to display the national motto, "In God We Trust," and the Nebraska state motto, "Equality Under the Law," in English in every classroom

LB 127, introduced by Sen. Dan McKeon of Amherst, would require courts to award damages to defendants who are found not guilty or whose cases are dismissed or overmented Nebraska's 12-week abortion turned. Damages would cover legal fees, lost wages and other losses







New Year — New Me! January is the start of making new year's resolutions and setting goals that align with your physical and emotional health.

But as you navigate setting these goals, are you confused by constantly changing and often contradictory information in the area of nutrition? New information in the areas of Keto, Carnivore, Mediterranean plant-based diets, Fasting, Intermittent Fasting, and gut health, can often be overwhelming and confusing. When people are asked where they get their information from, the internet is one of their main sources. While the internet is a vast source of information, navigating accurate and trusted information is key.

The best place to get trusted information is through research articles and scholarly journals. Articles that have been "peer reviewed" (reviewed by other experts in the field, to ensure the research aligns with standards of study and quality). However, reading journal articles can be time consuming and difficult, trying to decipher medical jargon and research terms. As, research article information becomes available to the media, it is often reported as news, but then interpretation of information is subject to the person telling the news story.

Be your own advocate to obtain the best information. Avoid simple internet or Google searches, which brings a wealth of information, but is not always reliable. Instead search through credible sources, narrowing your search, by naming your nutrition topic followed by .edu (education) or .gov. (government). For example: keto.edu or carnivore.gov., (Specific, Measurable, Achievable,



these searches will load your topic Relevant and Time based). Two, make your goals forward focused. Focus on what you choose to add to your health, not focused on what you're trying to take away. If your goal is to reduce soda or coffee intake, make your goals about replacing them with better behaviors like drinking 6-8 glasses of water, or replacing your evening soda with green tea. When your focus is on adding positive behaviors, you are focused on what you can do, and not focused on "what you can't have". Lastly make your goals visible, hang them on your bathroom mirror, put them in your billfold, or on your desk at work. Making them visible helps you make intentional decisions throughout the day that align with your goals. But most importantly, whatever plan you intend to follow or goals you choose to pursue, the road to good health is a marathon, not a sprint. Make good choices through the long haul, and when you have small detours in your plans, give yourself permission to make mistakes, refocus and get back in the race.
