Former Warren Lumberjack and Arkansas Razorback Treylon Burks, was drafted last Thursday into the National Football League to play for the Tennessee Titans, which the team is based in Nashville, Tenn. He was selected 18th overall in round one of the NFL Draft. He was the highest selected Razorback to be drafted in the first round since running back former Razorback Darren McFadden, who was drafted fourth in 2008.

In his junior year as an Arkansas Razorback, he had 66 catches for 1,104 yards and 11 touchdowns that earned him First-Team All-SEC honors. He became the fourth Razorback pass catcher in Arkansas history to post a 1,000 receiving yard season and the first since 2012.

According to NFL.com, Burks' combine results were 4.55 at the 40-yard dash, 33 vertical jump, 122 broad jump, and 7.28 threecone drill.

It is projected that the Tenfour-year contract for \$14.3 milis also projected he'll receive a \$7.5 million signing bonus, a \$2.6 million 2022 cap hit, and a fifth-year option for 2026.

### **BCMC** Board meets with engineers about building

The Bradley County Medical Center board heard from engineers from Bernhard Engineering. Jose Bea, electrical engineer, Paul Gregory, from Polk Stanley Wilcox, and John Dale, from Bernhard Engineering spoke to the board members about the master plan for the Bradley County Medical Center.

The engineering team previously met with hospital managers and were able to tour the

Board members brought up some of the issues they had with the building and what the upgrades should be.

Interim CEO Leslie Huitt told the board cybersecurity was a big issue for the hospital. They would be looking into cybersecurity protection and having backup programs.

Huitt said they were looking into applying for a Blue and You grant from Blue Cross Blue Shield. The grant would be used for obstetrics, labor, and delivery

In the bid, they stated they preferred using a chemical to deter the regrowth of black stains on the brick. The hospital accepted the bid from

Softwash for \$5,000. Johnson reported that the community wide planning committee to expand South Ark's presence in Bradley County beyond healthcare classes was postponed due to the fire at Warren High School. She said South Ark requested a lounge area for the nurses to retreat to after tests. The hospital would set up a lounge area in the foyer for them.

Johnson reported the USDA grant was submitted to go to the next step in the application process. The hospital received another American Rescue Plan Act grant for retention and recruitment. This grant was specifically for employees of Home

lyn Johnson gave her report to Health who meet the definition of Direct Service Provider in connection with a Medicaid patient. Johnson stated they were researching other grant opportunities as well.

Chief Nursing Officer Jamie Wolfe reported that the hospital treated 237 positive COVID cases in January, 24 cases in February, three in March, and one in April. He also stated that flu cases increased to 18 in the area.

The board discussed the policy approvals for the administrative and compliance manual. Huitt admitted she had not had time to review the new policies for approval. Board president Freddie Mobley said he wanted to make sure Huitt had a chance to review the policies, so the board voted to table the policy until the next board meeting.

The board approved to contract with Protos Security to have a uniformed guard at the hospital. Huitt said there would only be one guard on duty at a time.

The next board meeting will be Tuesday, May 24 at 12:30 p.m.

### **BCEDC** learns about AHF Products at regular meeting

Steve Mahanes, from Armstrong Hardwood Flooring Products, was the guest speaker at the monthly Bradley County Economic Development Corporation Board last Monday. EHS and quality manager for AHF Products Ricky Rodriguez was also present at the meeting to represent AHF Products.

Mahanes said AHF Products have been in operation for over 40 years. The plant in Warren produces wood products for different brands that are part of AHF Products. They are Bruce, Robbins, and Timberland. They produce over 300 varieties. Mahanes said their major customers are Home Depot, Lowes, Floor Décor, and Lumber Liquidators.

The company employs 260 people at the mill located outside of Warren. The annual payroll for the company is \$10 million. Starting wages at the company is \$15.86 and about \$33,000 annually. Employees also receive a full benefits package for fulltime employees that include den-

tal, vision, and life insurance. boree program. They also provide holiday and vacation pay for employees.

Some of the challenges the company faces include staffing and the rise of lumber pricing. Mahanes said they were currently 30 positions short.

Warren Mayor Denisa Pennington updated the board on the shooting range expansion. She hoped the expansion project would be completed by the end of June. Students from SEACBEC built the tables that will be used at the shooting

Board Director Dr. Bob Smalling said he had met with an industrial prospect that was very promising.

Dr. Smalling reported that a surveyor had surveyed the chip mill for leases with Sorrell and Scott Richardson.

The board members approved to purchase courthouse square signs for the Pink Tomato Festival for \$200. They also approved to spend \$100 to sponsor the Warren Lions Club Gospel Jam-

"But seek first the kingdom of God and His righteousness, and all these things will be added unto you." (Matthew 6:33).







#### A word from Governor Asa Hutchinson

The freedom of speech is one of the bedrock principles upon which our country was founded. The purchase of Twitter by the world's richest man this week has reignited the discussion surrounding free speech, and I'd like to share my thoughts on the importance of this freedom.

Social media censorship has been a concern of many Americans for years. While platforms like Facebook and Twitter are privately owned companies that set their own rules for the service they provide, the concern over the spread of misinformation and disinformation on these sites is one shared by millions of Americans.

There is equal concern over how these private companies censor or ban certain speech, and the argument is that the platforms are, in essence, the public square where speech should not be limited. These worries have led some elected leaders to call for increased censorship, while others have called for a hands-off approach.

Throughout our nation's history, especially in times of war and turmoil, Americans have spilled a lot of ink about what speech, if any, should be limited by the government. The government plays a necessary role in ensuring public safety and protecting its citizens from violence. In other words, no one should be allowed to shout "fire" in a crowded theater.

Since the advent of the internet and social media, bad actors, such as violent terrorists who wish to harm us, have used these platforms to stir up unrest and recruit others to join their causes to harm others. This has been seen throughout the world, especially since the September 11th attack on the United States. In the wake of these horrific events, organizations like al-Qaeda, ISIS, and the Taliban have used the internet and recruited and radicalized citizens around the world to commit acts of terrorism in their home countries or join their fight

overseas

These are legitimate threats that can interfere with the government's commitment to ensure domestic tranquility and to provide for the common defense. It is important for these social media platforms to assure they do not cross the line into advocating violence.

In his dissent in the 1929 case of U.S. v. Schwimmer, Justice Oliver Wendell Holmes noted, "If there is any principle of the Constitution that more imperatively calls for attachment than any other it is the principle of free thought — not free thought for those who agree with us but freedom for the thought that we hate."

The American Ideal calls for us to live in a nation where we can agree to disagree with our neighbors, have robust debate, and still live peaceably. The Bill of Rights identifies rights that the government may not infringe; it pro-

hibits government from interfering with these rights that are essential to our freedoms, the rule of law, and our democracy.

I often see negative and hateful comments on social media. But despite this negativity, I am grateful to live in a nation where the rights of those who disagree can voice their opinions freely and without persecution. Whenever I check my Twitter account, I'll be appreciative of the protection of freedoms we're blessed to experience in this country.







"In many rural communities in Arkansas, families rely on discount stores like Family Dollar for essential products such as food, medicine or pet food," said Attorney General Rutledge. "Family Dollar has had knowledge of this dangerous and massive rodent infestation for over two years, yet they continued to sell and profit from potentially contaminated goods. Consumers lost money and could have lost their lives."

**Attorney General Rutledge files** 

Reports from state and federal health inspectors show that Family Dollar had knowledge of its rodent infestation since at least January 2020. In March 2021, the Arkansas Department of Health inspected the West Memphis Distribution Center where inspectors reported seeing "significant rodent activity where human food and pet food were stored" and management stated that they were aware of the rodent issues. In April 2021, state health inspectors reported that effective measures were not

expenses for murder victims, help with medical expenses for women abused by their husbands and help with medical expenses for people injured in car wrecks caused by drunk drivers.

Help paying funeral expenses is the largest category of claims paid out by the board. Almost half of the payouts last year for were for funeral expenses. The board can award up to \$7,500 for funeral expenses.

Legislators questioned the second largest category, for forensic exams, which made up almost 36 percent of payouts. While agreeing that victims should not have to pay for forensic exams.

The exams are part of the evidence kit that has to be presented at criminal trials, and legislators questioned whether the payouts should be considered reparations to victims.

If other law enforcement agencies paid for the forensic exams, the board would have more funds to make true reparations to crime victims.

Other questions from lawmakers concerned mental health. The board pays up to \$2,500 each for in-patient and out-patient counseling, but according to crime victims who spoke to the committee, the typical six-month delay in awarding claims can be too late for victims who need immediate mental health services. The board also makes payments to victims who lose income because they cannot work. In homicide cases the board can help pay for cleaning up the crime scene. Also in homicide cases, the board can make payouts to dependents of murder victims for being taken to stop the rodent infestation. Following notices from the Arkansas Department of Health and consumer complaints, the U.S. Food and Drug Administration (FDA) began an investigation in January 2022 of the West Memphis Distribution

In March 2022 the FDA issued a safety alert regarding the Distribution center, which stated in

"Conditions observed during the inspection included live rodents, dead rodents in various states of decay, rodent feces and urine, evidence of gnawing, nesting and rodent odors throughout the facility, dead birds and bird droppings, and products stored in conditions that did not protect against contamination. More than 1,100 dead rodents were recovered from the facility following a fumigation at the facility in January 2022. Additionally, a review of the company's internal records also indicated the collection of more than 2,300 rodents between Mar. 29, 2021 and Sep.

vices, and over-the-counter medications for both adults and children. Following the FDA's investigation announcement, Family Dollar issued a "voluntary recall" and was forced to temporarily close 404 stores, including 85 Arkansas stores, so that hazardous and contaminated products could be removed from its shelves. Restitution usually brings in from \$85,000 to \$90,000 a year, and revenue from court costs have declined over the past several years.

The board gets federal grants, and the governor and the attorney general have allocated money from special funds.

A Perspective on Inflation

If you asked ten people for their opinion on what causes inflation you can be assured of at least eleven opinions. Either the analysis is so deep as to be understood or it is too simplistic to really explain what is happening. This, on the other hand, is an overview of observations in times of inflation that may make it a little easier to understand. Don't discount the points being made if one of them is not as technically explained as it could In the 1970s, the stock market

suffered significant losses and fell about 50 percent in value. With people pulling out of stocks the economy began to slow down and unemployment began to rise. Social programs began that had no relation to the revenues coming into the treasury and as a result the dollar became weaker. OPEC stepped in with an oil embargo on those that would support Israel during the Yom Kippur War. I still remember the unending lines at the gas stations. All these things went together to form the perfect storm with the final blow coming in the tight money policies of the Federal Reserve. While inflation climbed to 14 percent, the interest rate on loans climbed to 21 percent. In Arkansas, anything over 10 percent was considered usury by state law and prohibited. It took a federal law allowing banks to go higher on interest rates that kept the housing market and commercial lending from dying in this state.

It wasn't until new leadership revised money policies, the embargo ended, the stock market began to improve, and yes, social programs began to be reigned in that inflation began to ease and interest rates began to fall. Don't get me wrong on social programs. There is nothing wrong with spending money to help people improve their lives unless you are printing money to do it. Today everything seems different even as it seems the same. Today, the stock market is healthier and going up. On the other hand, the economy is slowing down due to Covid related lock downs. Social programs,

including the direct payment of cash to millions of taxpayers, explosive increases in child credits, and an expansion of the earned income credit far exceed the revenues coming into the treasury. Now we have imposed our own embargo on oil that is likely to cause a world-wide slowing of economies aided by a war that seems to only be wanted by one

Inflation seems to be a fact but how bad is it? It's hard to tell because there are so many moving parts. Is it inflation or the shortage of labor from truck drivers to factory workers? There are shortages and delays in the marketplace that cannot be evaluated at this point in time. The Covid related lock downs and the advancement of working and shopping online caused probably the largest occurrence of job migration in history. Why live near the jobs when you can work for the same employer anywhere?

With all the volatility in business today you need to spend some time with your CPA before you make a move into something you had no idea was coming. Consider carefully, but timing the market, either the stock market or the one in brick and mortar, has always been an impossible task.
