Thrilling showdown: Lumberjacks tame the Lions in 42-28 victory

SPECIAL TO THE EAGLE

In a gridiron clash that will be remembered for its twists and turns, the Warren Lumberjacks secured an undefeated regular season with a resounding 42-28 victory over the Hamburg Lions. The game, played under the cool Thursday night lights in Hamburg, showcased high-stakes football with both teams giving their all.

Warren entered the game with an impressive 9-0 record, having already clinched the conference championship, while Hamburg, with a 3-6 record, aimed to play spoiler on their home turf.

The Lions set the tone early, opting for an onside kick on the opening kickoff. Successfully recovering at the Warren 44-yard line, Hamburg was met with an immediate setback as Antonio Jordan made a pivotal tackle, pushing them back by 4 yards. Undeterred, Hamburg orchestrated a 44-yard drive culminating in QB Willis Robinson's 4-yard touchdown run at the 8:07 mark of the first quarter. The extra point was good, putting Hamburg ahead 7-0.

Undoubtedly, the first quarter was eventful. Hamburg attempted another onside kick,

but this time Warren recovered at their 48-yard line. The game continued its seesaw nature as Warren QB, Jackson Denton threw an ill-timed interception to Hamburg DB, Payton Sellers. Sellers returned the interception 50 yards for a touchdown, giving the Lions a 14-0 lead with 7:06 left in the first quarter.

Following another Hamburg onside kick attempt, the Lumberjacks recovered the ball near midfield and started what they hoped was a quick touchdown drive. Hamburg was immediately called for a pass interference penalty which put the Jacks in striking distance. With 6:01 left in the quarter, Denton was picked off in the end zone, stopping what was a hopeful drive for the Jacks.

The Lumberjack defense held strong, forcing the Lions to punt with 4:30 left in the quarter. Warren tailback, Jordyn Ingram got the ensuing drive off to a great start with an energizing 33 yard run with 3:35 remaining in the quarter.

Despite Hamburg's efforts, the Lumberjacks got on the board as Denton orchestrated a masterful drive, and found Antonio Jordan for a 29-yard touchdown

pass, making it 14-7 with 3:11 remaining in the first quarter. The intensity reached a new level as the Lions and Lumberjacks battled for control.

Hamburg took over on their 20 yard line. Things looked to be turning around for Warren as the defense made two big stops followed by an amazing interception by Cam Burkes. Burkes snatched Robinson's pass out of the air and returned it for what appeared to be a game tying touchdown. However, the score was taken off the board due to a Lumberjack penalty.

The second quarter opened with Denton connecting on a 12-yard pass, setting up Tremond Miller's untouched touchdown run, tying the game at 14.

The Lumberjack excitement continued with Cody Weatherspoon intercepting a Lion pass with 9:01 left in the half.

Following Weatherspoon's interception, the Jacks found themselves with excellent field position. With 7:24 left in the half, Ingram scampered inside the 5 yard line, setting up a first and goal for the Jacks. On the very next play, Ingram took the handoff and pounded his way into the end zone for the score.

After Jaurez's extra point the Lumberjacks had scored 21 unanswered points to take the lead.

The game would go back and forth for the rest of the second quarter. The Lumberjack defense, led by JD Tillman and Neeyo Hardting, held Hamburg on its next drive. Following a

Lion punt, Warren returner Antonio Jordan made an amazing return down to the Hamburg 5 yard line, but a blocking penalty negated the play. The Jacks then drove into Lion territory, but the Hamburg defense held and with 3:21 left in the half, the Lions took over on downs.

The next two drives saw both teams hopes end with fumbles. Hamburg fumbled a few plays into their drive with Cody Weatherspoon making the recovery for the Jacks. Soon after, with 1:54 remaining, Warren lost the ball and the Lions took over

Warren EAST students requesting help from public

Warren High School EAST needs your help! Students Demetriyan Crawley, Dominic Slaughter and James St. John are compiling a list of food pantries in the Bradley County Area.

The students met with Immanuel Baptist Church Youth Director, Shelton Moorman, to discuss the high need for food assistance in our community. After some research, the students and Moorman determined that most people are unaware of the available places in town to receive assistance. They called the Director of the Food Bank, David King, to see what it takes for an organization to receive food and the services they offer

to help food pantries succeed.

"We are currently using ArcGIS Survey123 to gather the information from organizations who provide food resources, then we will use the data to create a map of all the different locations and any information you may need such as: if any ID is needed, days of the week they operate and types of food they provide," Demetriyan Crawley said.

"This map should be available online and as a paper copy," Shelton Moorman stated. "I asked them, 'What made you want this project?' and the students responded, 'This feels like we are actually helping a huge

need and seems purposeful.' That is incredible to hear from 16/17 year olds. Excited about this!"

looking to tie the score as the clock winded down in the half.

On the first play following the Warren fumble, the young Hamburg QB connected with his receiver on a 57 yard bomb to tie the game. At the half, Warren and Hamburg were deadlocked at 21-21, setting the stage for a

thrilling second half.

Hamburg received the kickoff and returned it an impressive 89 yards, placing them in a 1st and goal situation. A rushing touchdown by Robinson put the Lions ahead 28-21 with 11:41 left in the third quarter.

However, Warren responded swiftly, tying the game at 28 with a long touchdown pass from Denton to Antonio Jordan at the 10:30 mark.

On the ensuing Lion drive, The Lumberjack defense, led by Harding, made crucial plays, including a key interception by Cam Burkes, his second pick off the night.

The third quarter concluded with Warren taking over the game. With 5:13 left in the quarter, Warren RB Trey Jackson got things started with an impressive 20 yard run putting Warren in striking distance. On third and six from the Hamburg 17, Antonio Jordan took the handoff and sprinted 17 yards for his fourth touchdown of the evening, giving the Jacks a 35-28 lead. The Lions would take over and their next drive saw the Lumberjack defense showcase its dominance with a sack by Harding, setting up a fourth and 22 for Hamburg.

The fourth quarter unfolded with Hamburg pinning Warren

deep in their own territory. Despite challenges, Warren's offense made crucial first downs, and Treyton Jackson's long run virtually sealed the victory with 2:44 left. On the next play, Antonio Jordan scored his fifth touchdown, securing a 42-28 lead with 2:37 remaining.

The Lumberjack offense was led by Ingram's 115 rushing yards on 18 carries; Antonio Jordan's 5 rushes for 56 yards and 3 Touchdowns, Denton's 117 passing yards with 2 Touchdowns. Antonio Jordan led the receiving core with 5 catches, 109 yards, and 2 touchdowns. Jordan's performance reminded fans of Lumberjack standout Treyton Burkes as he dominated the game as a running back, a receiver, and kick returner.

In the end, the Lumberjack defense proved resilient when

it mattered most, and Antonio Jordan's remarkable performance propelled Warren to an undefeated season. The Lumberjacks will now embark on their playoff journey, starting with a first-round home game against

Truman next Friday at Jim Hurlley Stadium. The road to War Memorial Stadium beckons, and Warren is poised for postseason glory after a spectacular regular season.

Arkansas House Report

As November rolls around, we are reminded of a day that holds a special place in the hearts of countless Americans – Veterans Day. On this occasion, we pause to reflect on the sacrifices, courage, and unwavering commitment of those who have served in the U.S. Armed Forces.

Honoring our veterans is about recognizing the sacrifices they've made. It's the sleepless nights and missed birthdays, anniversaries, and family gatherings. It's the physical and emotional scars, the injuries, and the post-traumatic stress that some bear for the rest of their lives. It's the time away from home and the loved ones left behind. It's the uncertainty and the courage to face danger head-on.

More than 186,000 veterans call Arkansas home. That equals close to six percent of our state's population.

The Arkansas General Assembly continually reviews ways to ensure our veterans and their families are well cared for and that our policies make life a little easier for those living here.

In the last Regular Session, we passed Act 395 defines "homestead" for purposes of the property tax exemption for disabled veterans, surviving spouses, and minor dependent children of disabled veterans.

The General Assembly also passed Act 201 and Act 137.

Act 201 seeks to have veteran disability benefits excluded as income for eligibility for the Supplemental Nutrition Assistance Program (SNAP) by directing DHS to seek a federal waiver.

Act 137 allows a licensing agency to consider national certifications toward occupational licensure requirements for uniformed service members and veterans. It also extends the application for initial licensure to the spouse of a uniformed service member or a uniformed service veteran and removes the one-year limit for veterans to apply for service education, training, or certifications toward occupational licensure.

We will continue to review proposals to improve the lives of veterans in Arkansas. We encourage Arkansans to consider ways they can support our veterans this Veterans Day and throughout the year.

Veterans Day is not just a day on the calendar; it's a time for us to pause, reflect, and appreciate the sacrifices and bravery of our veterans. It is a reminder that the debt we owe them is immeasurable, but we can still strive to repay it with gratitude, respect, and support.

Arkansas History Minute

It was an incredible career in baseball, and it all started in Arkansas. Starting from modest roots in Little Rock, Brooks Robinson, Jr., would build one of the most successful careers in baseball history.

Born in 1937 to a firefighter and semi-professional baseball player, Brooks Robinson showed a lot of athletic promise from an early age. In high school, he ran track and played basketball for a time, but his real passion always lay with baseball. Immediately after his graduation from high school in 1955, he signed a contract to play for the Baltimore Orioles.

The Orioles sent him to their minor league farm team in York, Pennsylvania, and was called up to Baltimore late in the 1955 season. Robinson would play 23 seasons with the Orioles, mostly as third baseman. He became almost unstoppable defensively, getting the nickname "the human vacuum cleaner" for his fielding ability. In 1960, he won the first of 16 consecutive Gold Glove Awards for his defensive play, the most for any third baseman in baseball history. That year, he was also elected to play in the All-Star Game, his first of 15 consecutive appearances. He would lead the American League in fielding percentage 11 times and had a career .971 fielding average, the most for any third baseman ever.

He would have an impressive career .267 batting average with 268 home runs. He would be named the Most Valuable Player for the American League in 1964 and led the American League in runs batted in that year. He named the Most Valuable Player for the 1966 All-Star Game. The Orioles would go on to win the 1966 and 1970 World Series, with the key home runs and catches by Robinson seen as essential to the Oriole wins. In 1970, he would bat .429 in the World Series and would be named the Most Valuable Player for the World Series. By 1971, he was one of the highest-played players in the game, one of only five players making more than \$100,000 per season (more than \$770,000 in 2023 dollars).

The Orioles would lose the 1971 World Series, and though his career was starting to decline, he was still widely respected for his sportsmanship and abilities as a player, winning the Commissioner's Award (later named the Roberto Clemente Award) in 1972 for his play. He was named a Major League All-Star eighteen times in his career.

In 1977, Robinson retired from baseball and his jersey number, 5, was retired by the Orioles the following year. He would become a commentator for televised Orioles games on WMAR. Robinson co-founded the Major League Baseball Players Alumni Association in 1982, a group of retired ballplayers that raised money for various charities and helped secure benefits for retired players. He was inducted into the Baseball Hall of Fame in 1983 and remained a popular figure among players and throughout the Baltimore area.

He retired from broadcasting in 1993. Even as the years passed, Robinson remained a beloved figure in Baltimore. He faced a number of health issues as he reached his 70s, beating a bout with prostate cancer in 2009. He continued to invest in a number of businesses and worked with local charities. Three statues were erected to him across the Baltimore area, and one road in the Baltimore suburb of Pikesville was named for him. He died in September 2023 at age 86.



Senate Week in Review from Ben Gilmore Senator

The Arkansas Economic Development Commission broke records for job creation and investment last year.

Thirty companies invested close to \$6 billion and announced the creation of 5,359 jobs. The average salary of those new jobs is \$29 an hour.

Last year got off to a good start, with the announcement of the largest single project in Arkansas history, an expansion of the U.S. Steel plant in northeast Arkansas.

Private companies aren't the sole focus of economic developers. The United States Air Force and the State Department located the F-35 Foreign Military Sales Pilot Training Center at the Ebbing Air National Guard base in Fort Smith. Pilots will

also be trained to fly F-16 fighter aircraft.

Other military investment by the federal government creates jobs at the Pine Bluff Arsenal and the Little Rock Air Force Base in Jacksonville.

South Arkansas is home to some of the nation's largest defense industries. Northeast and Central Arkansas also have hangar space, extensive runways and a skilled work force. They make aerospace and defense part of the state's economic foundation. Their importance is reflected in the fact that 15 state universities and 22 two-year colleges in Arkansas offer courses in aerospace and military technology, as well as computer engineering.

More than 14,000 people work in Arkansas aerospace and defense industries.

Southern Arkansas University in Magnolia was the first institution in the state to be certified by the Federal Aviation Administration as an aviation maintenance training facility. Graduates can work anywhere in the world where aircraft maintenance is in demand.

Producing firearms and ammunition is another industry that is strong in Arkansas. Companies of varied sizes are throughout the state, employing more than 3,000 people.

A team at the commission has the important duty of working to retain existing industry and to encourage their expansion. Last year they helped retain 3,058 jobs and generate \$46 million in new investment.

Arkansas is home to 6,800 transportation, logistics and distribution companies that employ 55,000 people. An advantage is our location in the geographic center of the country. In addition, Arkansas is a producer of transportation equipment.

Statewide, 12.7 percent of the jobs in Arkansas are in manufacturing. The AEDC promotes industry with tax incentives, job training, infrastructure and financing.

Protecting Poultry More than 1,800 people from 81 countries attended a summit hosted by the Arkansas Agricultural Experiment Station and

the Center of Excellence for Poultry Science.

They discussed methods of controlling highly pathogenic avian influenza, a serious disease that requires rapid response measures to avoid the spread of massive losses of birds. In the United States, the disease has cost producers 59 million birds in 47 states since 2021.

In addition to the economic impact on growers, the loss of so many birds affected consumers because it factored into the recent price increases for eggs, chicken and turkey.

Cases of the disease have been confirmed in Oklahoma, Colorado, Montana, Utah, Idaho, South Dakota, North Dakota, and Minnesota.

Experts from Chile, Scotland, Mexico and the United States made presentations at the summit. They discussed how to extensively sample domestic flocks and wildfowl, the challenges of vaccination and other measures to control the spread of the disease.



The men and women who wore our nation's uniform are a courageous group of individuals who followed the path of a higher calling. They elected to employ their talents for the greater good. It is these same men and women who epitomize what it means to serve.

Veterans Day is a special time to remember and honor the sacrifice of these patriotic Americans who came from all walks of life but had the same sense of purpose – to protect and defend our country and our freedoms. We can never fully repay them for their commitment and service, but we can ensure we fulfill the promises we made to them.

As the son of a World War II veteran who served more than 20 years in the U.S. Air Force, it is my honor to serve on the Senate Veterans' Affairs Committee (SVAC). Members of this committee set aside party politics to do what is best for veterans and support the needs of their families. Working in a bipartisan manner, we've successfully expanded health

care benefits and eliminated barriers to care and services for women veterans at Department of Veterans Affairs (VA) medical facilities. Additionally, we modernized the VA breast cancer screening policies and strengthened VA suicide prevention programs.

This year I teamed up with SVAC Chairman Jon Tester (D-MT) to introduce the Not Just a Number Act. This bipartisan legislation would modernize how we reach and serve veterans who struggle to get the mental health support they need. It's clear the VA needs to update and expand its data collection to examine the relationship between VA benefits and suicide outcomes which includes analyzing benefits that have the greatest impact on preventing suicide.

Every veteran matters and we are committed to improving policies and programs that help them and their families thrive.

The VA has an important mission, and it's essential it has the workforce to meet its responsibilities. Last year

Congress passed the PACT Act, historic legislation that delivered toxic-exposed veterans their VA health care and benefits. In anticipation of an increase in claims, we also included a number of measures to expand hiring and retention at the VA, especially in rural areas.

These modest changes laid the foundation to attract new employees, and to take it a step further, we introduced the VA CAREERS Act to help bolster VA recruitment. This legislation incentivizes employment at the VA and ensures it can retain and recruit physicians, nurses and other professionals to deliver the high-quality care veterans deserve.

The committee advanced this legislation to the full Senate for consideration, so we are one step closer to our goal.

In recent days, the Senate, with my support, approved funding to strengthen veterans' programs and benefits. We invested in health services for women, telehealth measures and suicide-prevention initiatives.

I'm proud to fight for the heroes who bravely fought for us. While Veterans Day is celebrated on November, 11, let us demonstrate our appreciation for the service and sacrifice of veterans and their families every day of the year.





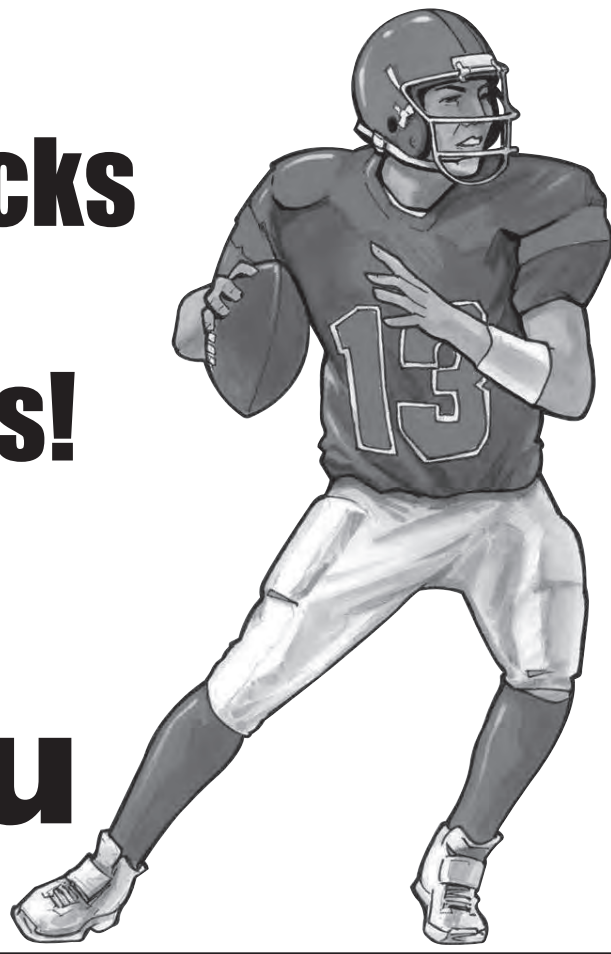
