Elkins dominates turnover-plagued Warren, 49-14

In a highly anticipated matchup between two of the top-ranked teams in the state, the No. 1 Elkins capitalized on a flurry of turnovers to dominate the No. 2 Warren Lumberjacks 49-14, advancing their unbeaten record and solidifying their spot at the top of Arkansas high school football.

On Warren's first possession, quarterback Cam Burks completed a 35-yard pass, setting up the 'Jacks for an early score. Moments later, Tremon Miller broke free on a 53-yard sweep for a touchdown, putting Warren ahead 7-0 just 49 seconds into the game.

Elkins then took possession and was forced to punt after a crucial sack from Lumberjack standout Antonio Jordan. The momentum would be short lived. On the ensuing play, Burks' pass was tipped and picked off by an Elkins defender for a pick-six, cutting the Warren lead to 7-6.

The turnovers kept coming. After Warren regained possession following a defensive stand by the 'Jacks, Burks fumbled the ball,

and Elkins once again capitalized with a scoop-and-score, putting the Elks up 13-7 midway through the first quarter.

Despite flashes of promise, Warren's offense struggled to maintain momentum, falling short on multiple key downs and turning the ball over on downs deep in Elkins territory. Elkins, meanwhile, began to roll offensively. Jaquae Walden found seams in the Warren defense, setting up Elkins for a field goal and expanding their lead to 16-7 with 3:20 left in the first quarter.

Elkins never let up, adding a 26-yard touchdown pass early in the second quarter to extend their lead to 23-7. Warren attempted to respond, moving the ball into Elkins territory before being intercepted in the red zone. Elkins then took advantage of another Warren turnover, with Walden breaking loose for a 60-yard run to set up a field goal that gave the Elks a 26-7 halftime lead.

The second half was no different, as Elkins came out firing. Walden continued to gash the

Warren defense, helping Elkins march downfield for another touchdown. After a successful two-point conversion, Elkins led 34-7 with 7:22 left in the third quarter.

Warren's struggles worsened when Burks threw another pick-six on the next possession, putting Elkins up 42-7. While Warren found the end zone late in the third quarter on a 1-yard run by Brayden Smith, it was too little, too late. Elkins capped off their dominant night with a final touchdown in the fourth quarter, sealing the 49-14 victory.

In the end, Warren's offense was undone by a series of costly turnovers and Elkins' opportunistic defense. The Lumberjacks never found their rhythm and could not recover after a devastating first half.

Warren will look to recover during their upcoming off week. They'll take a break next week and get back to their quest for another State Title by traveling to DeWitt for a big Conference 8-AAAA match up on September 27.

door. No matter the task she works her hardest and works with her team to get the job done. Her patients and colleagues can always trust her to do her best. She never does her job with a "look at me" attitude. Additionally, she volunteers with M*A*S*H Camp, is involved with other hospital committees, and is out in the community.

Morrison has proven her love for patients on numerous occasions. Her love for patients and her selflessness are unmatched as she gives her all to the profession and to Bradley County Medical Center.

In honor of winning the award, she received a certificate commending her for being an "Extraordinary Nurse." The certificate reads: "In deep appreciation of all you do, who you are, and the incredibly meaningful difference you make in the lives of so many people." Additionally, she was given a beautiful and meaningful sculpture called "A Healer's Touch," hand-carved by artists of the Shona Tribe in Africa.

The other finalist recognized was Rebecca Chambers of BCMC's Senior Care Department. Both Chambers and Morrison received a certificate and honorary DAISY pin. The award ceremony featured both candidates being honored with cinnamon rolls, fruit, and punch served to all who attended the event, including family members of both candidates.

The DAISY Foundation is a not-for-profit organization, established in memory of J. Patrick Barnes, by members of his family. Patrick died at the age of 33 in late 1999 from complications of Idiopathic Thrombocytopenic Purpura (ITP), a little known but not uncommon autoimmune disease. (DAISY is an

acronym for Diseases Attacking the Immune System.) The care Patrick and his family received from nurses while he was ill inspired this unique means of thanking nurses for making a profound difference in the lives of their patients and patient families.

Nurses were nominated by patients, families, and colleagues. The nominations were blinded and voted on by the DAISY Committee. The nominations were graded based on set criteria, a numeric value was assigned based on these criteria, and awards were determined based on score. The committee members voted. The process was overseen by the DAISY coordinator.

The Award at Bradley County Medical Center is co-sponsored by generous donations. Initial funding was provided by the facility. The program is maintained through generous support from donors, including anonymous donors, committee members, the BCMC Employee Appreciation Council, and other fundraisers.

This is one initiative of The DAISY Foundation to express gratitude to the nursing profession. Additionally, DAISY offers J. Patrick Barnes Grants for Nursing Research and Evidence-Based Practice Projects, The DAISY Faculty Award to honor inspiring faculty members in schools and colleges of nursing, and The DAISY in Training Award for nursing students. 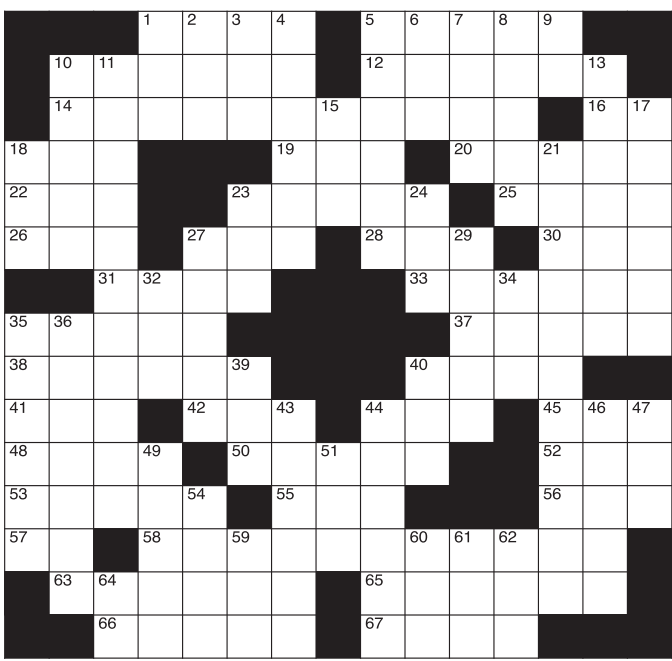

Arkansas History Minute

Elias Nelson Conway was the fifth governor of Arkansas. He presided over a prosperous two terms in office and was part of the dominance of the Conway family in the state in the decades after joining the Union.

Conway was born in eastern Tennessee near the North Carolina border in 1812. His father, Thomas Conway, was a successful planter. With his wife, the former Ann Rector, they had ten children, including seven sons. His father arranged for tutors for his children to give them the best education possible for a frontier family. In 1818, the whole family moved west to Missouri.

Many of his older brothers, excited by new opportunities in Arkansas, left for the new territory in the 1820s. His eldest brother, Henry Conway, was a popular territorial delegate to Congress before he was killed in a duel with political rival Robert Crittenden in 1827. After his death, the distraught brothers and cousins and their allies banded together to destroy Crittenden's political career and influence. In the process, the Conways and their cousins, the Ashleys, Rectors, and Johnsons came to dominate the most important political positions in Arkansas.

Elias Conway arrived in Arkansas in 1833 and soon became U. S. Deputy Surveyor. In 1835, he was appointed territorial auditor. By the next year, his older brother, James S. Conway, was elected governor. Shortly afterward, the state legislature appointed the younger Conway as state auditor.

In 1843, he was briefly considered as a candidate for governor to succeed Archibald Yell, but controversies over the nomination and questions about his own lack of experience ended his election bid. Conway stepped down as state auditor in 1849 and spent the next few years as an attorney and working in real estate.

In 1852, Conway won the Democratic nomination for governor. Gen. Bryan Smithson, a Democrat upset with the Conway family's domination of the party, broke away and ran as the Whig Party candidate.

The campaign centered on how to best build the state. Conway especially was interested in developing the internal infrastructure of the state. While some were pushing for the aggressive construction of railroads, Conway was uncertain about their future. Instead, he insisted that the state should concentrate on wagon roads for farmers and merchants. Because of his insistence on these dusty trails, he began to be called the "dirt road candidate." Conway won the election that fall with 55 percent of the vote.

Nevertheless, railroads dominated the first legislative session of Conway's term. The state approved corporate charters for five railroads. Conway worked diligently to erase the state's debt from the collapse of the Real Estate Bank in 1837, cutting the debt in half without a tax increase. He also committed the state to reclaiming swampland to make it available for settlers. He initiated the first geological survey of the state and the state takeover the Arkansas School for the Blind. He won re-election in 1856 with an even wider margin than 1852, with a 13,000-vote margin and 65 percent of the vote.

By most historical accounts, Conway was a very successful governor. The economy thrived under his administration, and the standard of living for most Arkansans rose steadily. The population rose as well. At eight years in office, he was the longest-serving governor of Arkansas in the nineteenth century and is the fourth-longest serving governor in the entire history of the state, behind Governors Orval Faubus, Bill Clinton, and Mike Huckabee.

Once Conway retired in 1860, he largely stayed out of the public eye for the remainder of his years. He died at his home in Little Rock in 1892.



Senate Week in Review from Ben Gilmore Senator

Legislators and state officials continue to work on methods of improving maternal health care in Arkansas.

A special committee created by the governor last week issued its recommendations in a report called "Healthy Moms, Healthy Babies." It calls for making access to health care more clear and convenient for expectant mothers.

It also listed ways for medical providers to recognize when pregnant women are at risk of losing their health coverage. It recommends steps to make sure that women have some type of health insurance and are aware of the services available.

The lack of obstetricians in rural Arkansas is a challenge,

so the committee recommended creating a loan forgiveness program for maternal care providers. One method is to increase the number of residencies in obstetrics and gynecology. Another would be to establish a school of midwifery.

Another recommendation was to create a process by which doulas and community health workers can get certified and receive Medicaid reimbursements. A doula is a woman who provides guidance and help during labor, and after delivery. Doulas provide physical and emotional support, with expertise in breathing techniques and breastfeeding.

Medicaid, a government health program for low-income families, pays for more than half the deliveries in Arkansas. Adding doulas and community health workers to the list of approved Medicaid providers could significantly increase the availability of maternal care in isolated parts of the state.

The report also recommends evaluating reimbursement rates

for all aspects of maternal care, including family planning and contraception.

The state Health Department operates local clinics throughout Arkansas, and the department is assessing whether each one needs to enhance maternal health care.

A report by the March of Dimes points to the urgency of expanding maternal care options. According to the organization, 38 of the 75 counties in Arkansas lack a hospital or birthing clinic with obstetric care providers.

Nationwide, about a third of all counties lack obstetrics services, according to the March of Dimes report.

Last December another special committee created by the legislature in 2019 issued a lengthy report that identified specific illnesses that are most prevalent in pregnant women in Arkansas, and recommended strategies for improving treatment.

The leading cause of death among those 38 was cardiomyopathy, a disease of the heart

muscles. The second leading cause was cardiovascular conditions caused by high blood pressure, diabetes, smoking, obesity and age.

In last year's legislative session lawmakers approved Act 562 requiring Medicaid to reimburse providers when they screen pregnant women for depression. An early diagnosis can dramatically help prevent the negative effects of postpartum depression.

Legislators also approved Act 553 to mandate that the state Medical Examiner conduct a postmortem examination of any woman who dies within 365 days of being pregnant, if the death is possibly related to the pregnancy. By identifying the serious medical conditions that harm a pregnant woman's health, physicians can better treat and prevent them.

Act 581 of 2023 requires Medicaid to reimburse physicians and clinics for providing reversible contraception immediately and during postpartum.



The March of Dimes released a report in early September detailing maternity care access nationwide and found 35 percent of counties are maternity care deserts. This means there is limited or no access to services such as birthing hospitals and obstetric providers. According to the data, Arkansas is one of the states with the highest percentage of maternity care deserts with more than half of our counties lacking access to these critical resources. Maternal health care is truly a crisis in our state and across the country.

The good news is we can change this troubling statistic. Among medical providers, non-profit organizations and elected leaders, there is a shared urgency to elevate maternal care in Arkansas.

In recent days, the Strategic Committee for Maternal Health, established by Governor Sarah Huckabee Sanders to craft a statewide plan aimed at improving outcomes for mothers and babies, released its report recommending policies and program enhancements. These include improving access to care

through telehealth and mobile units, establishing a school of midwifery and expanding prenatal services in local health units.

I am grateful for the governor's leadership to improve outcomes for vulnerable moms and babies.

We have built momentum this year to make positive changes, starting with bringing experts together to discuss opportunities to better serve the prenatal and postpartum needs in our state.

In February, I hosted the first in a series of maternal health roundtables. It featured meaningful discussions about the state of maternal health from a clinical perspective with medical professionals. In order to address outstanding health care disparities and work toward tangible solutions in the state, we must continue having these productive conversations.

That's why we followed that up with a roundtable in Bentonville in August with a panel of experts discussing ongoing initiatives and potential solutions for improving maternal health outcomes by bolstering

the workforce caring for these patients.

This dialogue is essential to moving us in the right direction. In Northwest Arkansas we discussed creating a pathway for doula and community health worker reimbursement in Medicaid. The Strategic Committee for Maternal Health recommended that very course of action, which is a welcome development.

The committee also proposed applying for the Transforming Maternal Health federal grant. I'm pleased to lead the Arkansas Congressional Delegation in supporting this request in writing to the Centers for Medicare and Medicaid Administrator so expecting moms can benefit from better care and newborns have a healthy start in life.


I'm also championing federal investments to address maternal and infant health workforce

shortages and enhance access to prenatal services in underserved areas of our state.

A comprehensive approach consisting of public-private partnerships that collaborate and contribute different areas of experience and expertise in pursuit of improving maternal health is underway.


There is a broad spectrum of medical providers in the maternal health space. Emphasizing the strengths of each and fostering coordination throughout the different stages of pregnancy and postpartum care is essential to improving the health and wellness of Natural State mothers and infants.

We have a long way to go, but we are on the right path. I look forward to continue working with my colleagues at the state and federal levels to support policies that can help save lives in Arkansas.

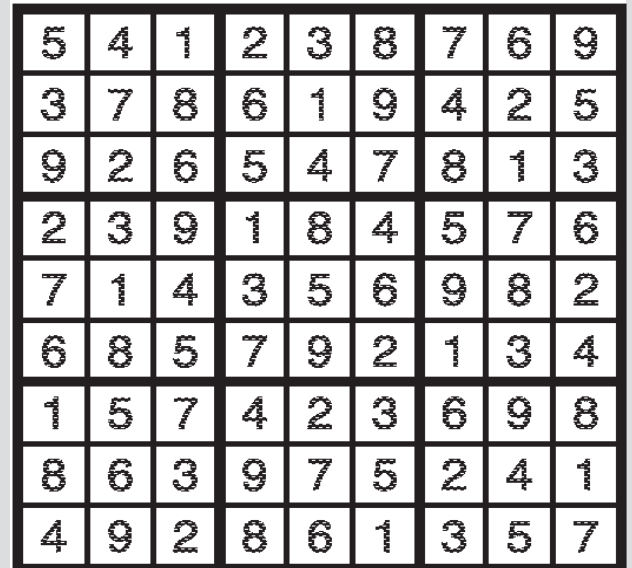
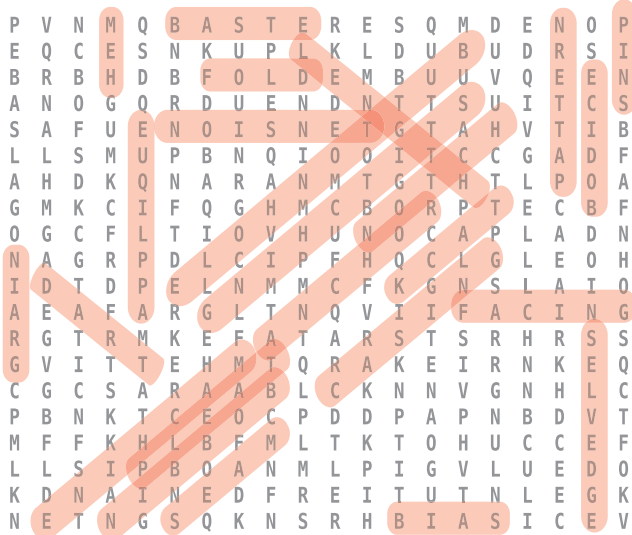

STOP Program accepting school applications until Sept. 27

SPECIAL TO THE EAGLE

The Arkansas Department of Agriculture's Forestry Division (Forestry Division) is accepting applications for the 2024 Shade Trees on Playgrounds (STOP) program through September 27, 2024. Arkansas schools needing additional shade on playgrounds can find the STOP program application and guidelines at agriculture.arkansas.gov.

Selected schools receive up to five Arkansas native shade trees, mulch, watering supplies, and planting guidelines. Forestry Division staff will help plant the trees during a ceremony with students this fall.

The STOP program started 22 years ago to help lower

adult skin cancer risk by reducing childhood exposure to direct sunlight on school playgrounds and outdoor learning areas. Since then, approximately 175 Arkansas schools have received trees. The STOP program also provides teachers with curriculum resources about the environmental benefits of trees, how shade reduces skin cancer risks, and tips for keeping trees healthy.

"From the hands-on experience of planting their own tree to engaging classroom lessons, the STOP program provides an excellent opportunity for students to learn about the benefits of shade trees," said Kristine Kimbro, Urban & Community Forestry Coordinator. "Our hope is that this

program will not only benefit students' health but also foster a lasting appreciation for our natural resources to carry with them as they grow into homeowners and community leaders."

Trees native to Arkansas are chosen by Forestry Division staff to fit the region and conditions of each playground. Sycamores, oaks, tulip poplars, and black gum trees are common species for the program.

To participate in the STOP program, a school must meet the criteria below:

- Have a lack of shade on a school playground or outdoor learning area.
- Participate in a STOP workshop to be held virtually

on October 10, 2024.

• Use provided curriculum resource materials to emphasize the importance of trees during the week(s) leading up to the tree-planting event.

• Involve students in tree-related projects that culminate with a school-wide tree-planting ceremony.

• Hold a tree-planting ceremony prior to December 20, 2024.

• Have a plan for maintaining the trees after planting.

Applicants may be any public or private Arkansas school serving grades pre-K through 12, or a non-traditional educational facility such as a juvenile detention center, residential childcare institution, or long-term care facility.



EMERGENCY ORDINANCE NO. 2024-5

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF BRADLEY, STATE OF ARKANSAS; AN ORDINANCE TO BE ENTITLED: AN EMERGENCY ORDINANCE TO DEFINE "DOMESTIC ANIMAL" AS USED IN ORDINANCE NO. 712 AND FOR RELATED PURPOSES
BE IT ORDAINED BY THE QUORUM COURT OF BRADLEY COUNTY PURSUANT TO SECTION I(A) OF AMENDMENT 55 TO THE ARKANSAS CONSTITUTION AS HEREINAFTER SET FORTH:

"Domestic Animal" is hereby defined to include, without limitation, domesticated dogs, cats, birds, poultry, horses, and cattle.
EMERGENCY CLAUSE (Ark. Code Ann. S 14-14-908). An emergency is hereby declared to exist, that emergency being an immediate and necessary need for the protection of the health, safety, and welfare of the people of Bradley County, and their livestock and other property, from harm and damage from dangerous/vicious dogs, this ordinance shall be in full force and effect from an after its passage by the Bradley County Quorum Court and approval by the Bradley County Judge

- 1. Definitions
a. "Control Officer" means the Bradley County Sheriff, a Bradley County Deputy Sheriff, or any person designated by the County Judge or the Quorum Court of Bradley County, Arkansas, to enforce the provisions of this Ordinance.
b. "Dangerous dog" means any dog which, without provocation, has:
i. Bitten or attempted to bite a human, ii. Inflicted physical injury upon a domestic animal when the dog is not on its owner's real property, or
iii. Exhibited such aggressive behavior toward a human as would put a reasonable person in fear of being attacked by the dog.
Any of the above behaviors may be referred to herein as a "dangerous dog behavior".
c. "District Court" means the District Court established under the laws of the state of Arkansas whose jurisdiction includes Bradley County, Arkansas.
d. "Muzzle" means a muzzle constructed of adequate material and of sufficient strength to prevent the dog from biting any person or domestic animal while not interfering with the vision or respiration of the dog.
e. "Owner" means every person or entity owning, keeping, harboring, or having custody, permanently or temporarily, of a dog.
f. "Secure Pen" means a pen with sound sides and sound bottom and top, if necessary, as sufficient to prevent an animal from escaping by climbing, jumping, or digging. When a dangerous dog or vicious dog is present inside the pen, the pen must be locked to prevent the entry of young children. The pen must be within a reasonable distance of a sign conspicuously warning of the presence of a dangerous dog in the pen.
g. "Vicious Dog" means any dog which, without provocation, has:
i. Killed or inflicted severe physical injury on a human,
ii. Killed or inflicted severe physical injury on another domestic animal,
iii. Has already been declared a dangerous dog pursuant to the provisions of this Ordinance and is determined to have committed a subsequent dangerous dog behavior. or
iv. any dog owned or harbored primarily or in part for the purpose of dogfighting or which has been trained for dogfighting.
h. "Vicious Dog Ordinance" - This ordinance may be referred to as the Vicious Dog Ordinance.

- 2. Exemptions
a. The provisions of this Ordinance do not apply to the following:
I. A dog being used by a Law enforcement officer to carry out the Law enforcement officer's official duties;
ii. A dog being used in a lawful hunt unless the dog has previously engaged in dangerous dog behavior;
iii. A dog where the injury or damage inflicted by the dog was sustained by a domestic animal while the dog was working as a hunting dog, herding dog, or predator control dog on the property of, or under the control of, its owner or keeper, and the damage or injury was to a species or type of domestic animal appropriate to the work of the dog;
iv. A dog protecting or defending a person within the immediate vicinity of the dog from an unjustified attack, assault, or other wrongful behavior;
v. A dog where the injury inflicted by the dog was sustained by a person who, at the time of the injury, was committing a willful trespass or other tort, was tormenting, abusing, or assaulting the dog, had tormented, abused, or assaulted the dog, or was committing or attempting to commit a crime;
vi. A dog where the injury inflicted by the dog was not severe and was sustained by a person who, at the time of the injury, had disturbed the dog while the dog was eating or sleeping; or
vii. Excessive barking or vocalization, if the dog is not exhibiting dangerous or vicious behaviors as defined in this Ordinance.
3. Unlawful to Keep a Vicious Dog
a. It shall be unlawful for any person to own, possess, keep, or harbor, permanently or temporarily, a vicious dog.
b. In addition to being subject to any other enforcement action prescribed by this Ordinance or other law, any person who violates this section of this Ordinance shall be subject to a fine not exceeding the amount of One Thousand Dollars (\$1,000.00).
4. Additional Fines
a. Any person who violates a provision of this Ordinance shall be subject to a fine not exceeding the amount of One Thousand Dollars (\$1,000.00).
5. Enforcement. Citing, and Adjudication
a. Enforcement of the provisions of this Ordinance shall be by a Control Officer. In addition, a private citizen may file a complaint alleging violation of the provisions of this Ordinance with the clerk of the District Court.
b. When investigating a possible violation of this Ordinance, a Control Officer is authorized to enter private property to obtain evidence and to seize any dog which the officer has probable cause to believe is a dangerous dog or a vicious dog subject to warrant and other requirements of the 4th Amendment to the US Constitution and other applicable federal and state law.
c. If probable cause exists to believe that a dog is dangerous or vicious, a Control Officer may issue to the owner of such dog a citation for violation of this Ordinance. The Control Officer may also seize and impound the dog. Any citation issued shall be for a mandatory appearance before the District Court.
d. The District Court shall adjudicate the guilt of the owner and, if the owner is found guilty of violation of the provisions of this Ordinance, shall:
i. Impose any range of punishment provided for by this Ordinance;
ii. Determine, based on the evidence presented, whether any dog which is the subject of a prosecution under this Ordinance is a dangerous dog or a vicious dog, as defined in this Ordinance, and, if the determination is in the affirmative, the Court shall so declare in the court records of the case;
iii. In the discretion of the court, order that any dog declared to be a vicious dog be euthanized;
iv. Establish the liability of the owner of any dog declared to be dangerous or vicious for boarding costs as described in the Impoundment section of this Ordinance; and
v. Impose any reasonable conditions upon the owner of the dog to protect the public against possible attack by the dog.
e. If a dog is declared to be a vicious dog but not ordered to be euthanized and that dog is thereafter the subject of a prosecution based upon subsequent dangerous dog behavior, all the enforcement actions described in the preceding paragraph shall be available to the District Court in the subsequent prosecution.
6. Requirements for Owners of Dangerous or Vicious Dogs
a. The owner of any dog declared to be a dangerous dog or a vicious dog, but not ordered to be euthanized, shall perform the following:
i. Keep the dog securely confined indoors or in a secure pen;
ii. When not on the property of its owner, the dog shall wear a muzzle and be restrained on a leash, of adequate material and sufficient strength to effectively restrain the dog and no longer than six (6) feet in length, and under the control of a responsible person at least 18 years of age;
iii. The dog shall at all times wear a substantial collar or halter and shall have attached to the collar or halter a metal tag bearing the owner's name and current telephone number;
iv. Within three (3) days of declaration by the District Court that the dog is dangerous or vicious, post in a conspicuous location, so as to be noticed by the public, on the owner's property a sign which says "Warning - Dangerous Dog on Property", the lettering of which shall be clearly legible and of sufficient size to be easily read from 25 feet. Such a sign must be posted on each side of the owner's property which abuts a public street;
v. If the dog escapes from the owner's property, immediately notify the office of the Bradley County Sheriff of such escape, and:
(1) Advise such office that the dog has been declared to be dangerous or vicious;
(2) give an accurate description of the dog; and
(3) give the timeframe of when the dog escaped.
vi. Implement any reasonable conditions imposed by the District Court upon the owner of the dog to protect the public against possible attacks by the dog.
b. The owner of any dog declared to be a vicious dog, but not ordered to be euthanized, shall also perform the following:
i. Immediately notify the office of the Bradley County Sheriff that the dog has been declared to be a vicious dog by the District Court;

- ii. Have the dog sterilized within 14 days after expiration of the time for the owner of the dog to perfect the appeal of the order of the District Court declaring the dog to be a vicious dog;
iii. No person under 18 years of age shall control or be made responsible for the care or supervision, even temporarily, of the dog;
iv. Upon transfer of ownership or possession of the dog to another person, the owner shall provide written notice to:
(1) the office of the Bradley County Sheriff, stating the name and address of the new owner or possessor of the dog; and
(2) the person taking ownership or possession of the dog, specifying that the dog has been declared to be vicious by the District Court and the approximate date of such declaration, and
v. If the owner changes place of residence while maintaining possession of the dog, the owner shall provide written notice to the office of the Bradley County Sheriff stating the owner's new address and advising that the owner is in possession of a dog which has been declared to be vicious by the District Court and the approximate date of such declaration
c. The violation of any of the provisions of this section by an owner shall subject the owner to the fine set forth in the Additional Fines section of this Ordinance.
d. So long as the owner complies with the provisions of this section and any directives issued by the District Court concerning the dog, the owner shall not be subject to the fine set forth in the Unlawful to Keep a Vicious Dog section of this Ordinance.
7. Impoundment
a. If a Control Officer issues a citation for violation of this Ordinance, the Control Officer may seize a dog which is the subject of such citation and impound the dog at an animal shelter operated by the County or by a legitimate humane organization or with a veterinarian. The reasonable costs of the boarding of an impounded animal shall be borne by the owner if the owner is convicted of violation of this Ordinance or the dog is declared to be dangerous or vicious by the District Court.
b. The District Court may order the release of the animal to the owner pending trial of any alleged violation of this Ordinance and may impose conditions for the keeping of the animal upon the owner.
8. Identification of Dogs
a. In carrying out duties to enforce the provisions of this Ordinance, a Control Officer may photograph any dog when there exists probable cause to believe that the dog is dangerous or vicious.
b. If a dog is declared by the District Court to be dangerous or vicious, the court may:
i. order photographing of the dog by a Control Officer or Other person designated by the court for that purpose; and
ii. if the dog has no remarkable identifying features, order that the owner of such dog have a microchip, for the purpose of identifying the dog, implanted in such dog by a veterinarian, and the expense of such implementation shall be borne by the owner.
9. Euthanasia
a. Any euthanasia ordered by the District Court shall be carried out in a humane manner by a licensed veterinarian or by a person eligible under the laws of the state of Arkansas to perform euthanasia upon a dog, and the cost of same shall be borne by Bradley County.
b. No euthanasia ordered shall be performed before expiration of the time for the owner of the dog to perfect an appeal of the order of the District Court authorizing the euthanasia.
c. The owner of the dog may be present when euthanasia is performed.
d. It shall be unlawful for the owner of a dog ordered euthanized under the provisions of this Ordinance to interfere with, attempt to prevent, or prevent such euthanasia.
10. Territorial Limitations of This Ordinance
a. The provision of this Ordinance apply only to a dog:
i. which is housed, temporarily or permanently, in Bradley County, Arkansas, but outside the city limits of Warren, Arkansas; or
ii. which has committed an act which would cause that dog to be defined as a dangerous dog or a vicious dog and such act was committed in Bradley County, Arkansas, but outside the city limits of Warren, Arkansas.
11. Miscellaneous
a. In the event of a conflict between a provision of this Ordinance and a law of the state of Arkansas, the Arkansas state law shall control and the conflict in provision of this Ordinance shall be severed from this Ordinance with all remaining provisions to remain in full force and effect
b. In the event of a conflict between the provisions of this Ordinance and the provisions of any previously enacted Ordinance, the provisions of this Ordinance shall control.
c. Nothing in this Ordinance shall limit or abrogate any claim or cause of action which any person may have under common law or statute relating to recovery of damages for injuries or property damage or other legal relief resulting from a dog attack.
d. The headings of sections in this Ordinance are for convenience only and shall not control the working of the body of the section
