# **Undefeated UAM Esports team to compete** for Divisional Championship Title

University of Arkansas at Monticello (UAM) E-sports League of Legends team will take on Ferris State University in the National Association of Collegiate Esports (NACE) Varsity Plus Divisional Championship on Tuesday, April 8, at 6 p.m.

As the top seed in the playoffs, the team earned a first-round bye

and then defeated Talladega College in the semi-final round of the playoffs on April 1, securing UAM a spot in Tuesday's divisional championship match. The team remains undefeated throughout both the regular season and playoffs — a significant milestone as it marks the first time in program history that a UAM Esports team has achieved a perfect regular

season record.

The publishers of The Eagle Democrat have chosen to publish articles from the past Oldtimer's Notebook in memory of Robert L. Newton. This article was first published March 25,

It was interesting to drive down the rebuilt Highway 15, (thanks to John Lipton) and visit the tiny, restored Harding Cemetery, now approaching 130 years in age. The woods around Warren are filed with what now appear to be abandoned cemeteries, including one to the west of town on the old Camden Road that was supposed to belong to Judge Josiah Gould's family, or certainly the one behind the V.C. Ford Family home, across from Union Bank on Pine Street.

Warren's main cemetery, Oakland Cemetery, is an ever-growing and well-maintained one to which more land, to the north, has been recently-added. Oakland'll be around, and in use, for a long time, it would appear.

People bullish on Warren's growth should enjoy travel down south Main these days, what with the big additions to the Bradley sawmill, the Highway 8 extension (world's oldest highway project . . . not the fault of Deon Construction of Warren, which has one of the pacts for the building). Then on down a little way, one sees the big expansion coming at the Witt Plant of Triangle Pacific and, to the west, the new water tank in the industrial park. Things are movin' around here. Sometimes we just neglect to look. By the way, Dr. Stacey

Toole, longtime dentist here, was the first person laid to rest in that new portion of Oakland Cemetery.


Our News Editor Caroline Selby authored the article about Steve Sera in last week's paper. It was our longest article since an excellent one penned by Robert W. Glasgow, onetime editor of this newspaper, about the "Bradley Strike" of 1935, published in our historical edition of 1985. 

then, those people knew how to make it happen.

We alluded recently to a practice of the late C. W. Hankins, Warren merchant, of writing peculiar March and April weather facts on the back of a closet door. Here are some of C.W.

Hankins' entries:

March 13, 1924 - Snow All Day.

March 14, 1926 – Ice one half inch thick.

March 26, 1926 - Snow flur-

March 18, 1928 - Heavy

white frost.

April 14, 1928 - Snow flurries.

Mr. Hankins resided on Hankins Street (where else?). He came to Warren from Monticello 14 years after the Civil War to establish his own business.

One of the young women who are at work here brought in a picture of a "Miss Pink Tomato" of 30 years ago and more. She thought it was a certain nurse at the hospital here. I told her it was Paula LaSue Campbell of Gould in Lincoln County. Miss Campbell was tall, dark, and striking like that LPN. Her youngest son is a distinguished member of the Bar. Now figure out who it is. The LPN, we mean: not Miss. Campbell, who has dropped out of sight and space.

We should all appreciate the weather around here. We were in Salt Lake City once on May 1. A terrific snow fell. It didn't keep us from attending the Sunday morning program from the Mormon Tabernacle. It'd be impossible to tell you how inspiring that was, and how gracious the folk were. One of the hosts was a fellow who gave the modest impression of great riches he'd made in the ice cream business. His onetime partner had branched out and gone into the hotel business. His name was J. Willard Marriott.

We were perusing a history of the First Baptist Church the other day and came across the part about the Rev. Dr. James T. Draper. Dr. Draper collapsed from a sudden heart attack and died perhaps 30 years ago. He rests at Oakland Cemetery. First Baptist has had some fine folks as pasto. Just two of the others are Rev. Dr. Bailey Smith and the Rev. James A. Walker, Jr. Dr. Draper lived in Warren as a kid. He held a job in Marshal, Texas.

We get amused at the ink job on the head of one of Little Rock's weathermen people.

His hair gets darker nightly, like Grecian formula X darker.



# Arkansas House Report

This week, the Arkansas House of Representatives passed several significant pieces of legislation focused on maternal health, breast cancer treatment, and state employee compensation.

HB1004 aims to extend Medicaid coverage to postpartum mothers for one year after childbirth, while HB1826 ensures that insurance covers births at licensed birthing centers, helping to expand access to care in rural areas. Additionally, HB1333 requires insurance to cover breastfeeding and lactation consultant services.

In another important development, SB392 adjusts the classification and compensation of state employees to bring their salaries in line with labor market rates, ensuring fairness in pay.

The House also passed SB83, a health-related bill that mandates health benefit plans in the state to provide coverage for all types of breast reconstruction surgery starting January 1, 2026. This legislation guarantees that any surgery considered the best treatment by a healthcare professional and in consultation with the patient will be covered, whether following trauma, the loss of breast tissue due to disease, or a mastectomy. Moreover, HB1859 was approved to amend current laws on mastectomies by requiring health plans to cover the use of artificial or biological mesh and nerve grafts in reconstruction surgeries.

The Arkansas House Revenue and Taxation Committee moved forward with HB1685, which proposes eliminating the state's 0.125% sales tax on groceries starting January 1, 2026. In addition, HB1631, which seeks to phase out the state's soft drink tax, also advanced through the committee.

Furthermore, the House State Agencies and Governmental Affairs Committee advanced HJR1018, a proposed Constitutional Amendment known as the Citizens Only Voting Amendment, which is expected to be considered on the House floor next week.

The House will reconvene on Monday, with plans to complete its business for the 2025 Regular Session by April 16. You can watch all House meetings at arkansashouse.org.

# Safety remains first as **Entergy Arkansas crews** work to restore power

Entergy Arkansas remains storm ready year-around. This week, crews have been working around the clock to restore power interruptions caused by multiple rounds of severe weather than 27,000 customers across the state at its peak, Entergy Arkansas crews have promptly restored power to many more customer interruptions caused by this week's cycle of severe weather, including two confirmed EF3 tornadoes. As the weather forecast calls for more weather impacts including high winds, lightning, heavy rain and flooding through Saturday evening, the company will remain ready to respond as conditions allow.

Entergy Arkansas has mobilized hundreds of line workers, tree trimmers and support personnel from across the state and region to assist in the restoration efforts. Crews are working tirelessly to assess damage, clear debris and rebuild the electric infrastructure impacted by the storms by using thicker, stronger poles. In some cases, concrete poles are being used to improve system infrastruc-

Senate Week in Review from Ben Gilmore Senator

The Senate voted to create a new and sustainable property insurance plan to help school districts meet the rising cost of property insurance.

Senate Bill 481 is the result of two years of work by legislators, school administrators and state officials. Two years ago the governor and legislators agreed to help schools pay for about 30 percent of the cost of increased premiums, noting that on average the cost of property insurance for schools was rising at an average of 130 percent a year.

The sponsor of SB 481, when presenting the bill before a Senate committee, said that some schools had experienced "staggering" increases of 180 to 200 percent in the cost of insurance premiums.

SB481 will create a captive insurance plan, administered by the state, which will combine the participants in three current plans. The larger risk pool will allow more efficient management of costs and risks. The goal is to have the plan in operation by July 1, and savings could be as much as \$15 million in the first

The legislature will consider a separate funding bill that will capitalize the new insurance program with about \$136 million.

In other news, the House of Representatives approved a bill to extend coverage from 60 days to a year for women on Medicaid who have a baby. In nationwide studies of maternal health care, Arkansas ranks near the bottom.

According to state Medicaid officials, during a three-month

period last year 39 percent of women on Medicaid lost their coverage after 60 days.

Public health experts say that providing coverage for 12 months will improve the health of both the baby and the mother. One reason is that it eliminates concerns the mother may have about paying for visits to the

In other news the Senate approved legislation intended to preserve order and dignity in women's restrooms, changing rooms and sleeping quarters where they have traditionally enjoyed privacy and safety. It is SB 486. If a woman enters a restroom and encounters someone of the opposite sex, she would be able to sue the shelter or facility.

The bill would not apply if the person of the opposite sex was cleaning or doing maintenance, responding to a medical emergency or a natural disaster or performing law enforcement

The Senate also approved SB 426 to enhance criminal penalties against illegal aliens who commit a violent offense. The enhancement depends on the severity of the felony. An illegal alien convicted of a Class A, Class B or Class C felony would receive an additional 10 years to their prison sentence. The enhanced sentence for a Class D felony would be four years.

Two years ago lawmakers passed Act 689 to require social media companies to verify the age of users, and to impose fines when social media companies fail to do so. It was blocked by lawsuits, however.

This year, SB 611 has been filed to give parents greater control over their children's Internet usage. Also, SB 612 would allow lawsuits against social media companies that encourages use of drugs, self harm, suicidal behavior or eating disorders.
