GATESVILLE CITY COUNCIL Council members file for reelection

Two of the three Gatesville City Council members eligible for reelection have filed to run again.

Council member Claude Williams filed to run for his Ward 1, Place 1 seat on Aug. 11. Williams was elected in Nov. 2020, finishing an unexpired term.

Mayor Pro-Tem Meredith Rainer filed to run for her Ward 1, Place 3 seat on Aug. 12. Rainer has served on the council since Nov. 2015.

Council Member Greg Casey had not formally filed by press time on Friday, however, he told the Messenger at the Aug. 12 council meeting he would likely file to run again by the Aug. 16 deadline.

The election will take place on Nov. 2 with early voting beginning on Oct. 18.

Modernizing county-owned facilities is group's mission

County facility advisory committee meets for first time

The Coryell County Facility Advisory Committee — formed to provide guidance to the Coryell County Commissioners Court on how to modernize county-owned and operated facilities, including future jail space — met for the first time Aug. 12.

"Honestly, we have been struggling as a county for years," Commissioner Daren Moore said at the Aug. 12 Commissioners Court meeting introducing the committee members. "It's always been a factor of resources, money and the ability to pay for it."

Moore, who has served on the court since 2007, said in the past when the county would run out of space it would purchase a building at a \$100,000 price tag and then pay an additional \$50,000 to remodel it.

"It fixes our problem for a year or two, but when we run out of room again, we move somewhere else," Moore said. "That's evident of our footprint in the whole downtown area, to include Copperas Cove."

The county footprint includes

22 buildings, 19 of which are in Gatesville, and two additional in Copperas Cove that the county is renting, according to a spreadsheet provided by Coryell County Judge Rodger Miller. The county owns six additional properties totaling 38 acres.

"The footprint has bunions all over it. We need to fix it," Nancy Botkin, a member of the advisory committee said during the Aug. 12 Commissioners Court meeting. Botkin is a retired senior warden for the Texas Department of Crim-

Fabulous Finds to close Oct. 1

or nearly 15 years Lynda Sue Wooten has sifted through storage units, rummaged through estate sales and bartered with customers to fill her downtown shop.

Open since 2007 Fabulous Finds has rows of books, stacks of games, hangers of clothes and a hodgepodge of household knickknacks.

But come Oct. 1 Wooten, 76, will be closing her doors for good, ending her second career to focus on traveling. "You do wake up one day and realize, I'm not running the store, the store is running me," Wooten said. "I guess I've given up the fight. I'll miss my customers."

Wooten said the forced closures during the pandemic and a lack of foot traffic from jury trials had a significant impact on her business. Even as restrictions have lifted this summer business has been touch and go with the constant stress of simply keeping the lights on.

"It kind of took the fun out of doing it," Wooten said.

Wooten opened the store after retiring from civil service in 2005 and wanting something to do. Her brother Keith Sears had owned the

Wally Ellisor, a manager at Bare Bones, said that they had a really good turnout for the benefit.

"It's really good to see how the community comes together on an event like this," Ellisor said. He also said many donated a

Shields, recently posted an update on her husband's condition. She reported that he is still in ICU, but that he's making good progress.

"We have heard from several nurses and doctors that he has quickly become the favorite patient on this floor with his positive attitude and easygoing personality even when he's in extreme pain," Birgit said.

She also said that he will need to go to a long-term care facility after leaving Seton Medical Center to finish his wound treatments and rehab.

"Please keep your prayers coming, they are very much appreciated," Birgit added.

ty Development Rene Ochoa said. "It takes another vacant property, another vacant building and puts it back on the tax rolls."

The name of the developer or potential buyer was not



disclosed at the meeting.

The Gatesville Planning and Zoning Commission heard the zoning change request at their July 12 meeting, approving the changes.

The adopted Future Land Use Map from the 2020 Comprehensive Plan designated the area as appropriate for commercial use.

No letters were returned for or against the change, according to Ochoa. The zoning change was unanimously approved by the council on Tuesday.

space to house his comics, coins and sports collectables shop. When Sears decided to move to South Carolina in 2007 he sold Wooten the building.

When she started, Wooten primarily did estate sales and buy/ trade/sell with customers to build up her inventory. Later she purchased storage units and added consignment.

While most of her customers are

local to the Killeen/Temple/Waco region, Wooten has seen people from as far away as New York and Oklahoma patronize her store. She has regular customers who include her store on their antiquing circuit of the area.

Collectors of all kinds have shopped at Fabulous Finds. She regularly sells collectible lighters. People are always looking for random collectible figurines, including a recent inquiry about dachshund figurines (which she had). And she even gets odd requests like a customer looking for old canes (she

had those too).

When she was able to open up again last year Wooten noticed an uptick in requests for games and craft items to entertain kids at home. But for Wooten it's less about finding the perfect item and more about connecting with people.

"A shop owner is a lot like a bartender. People will tell you the doggondest things. And they don't mind asking you questions, really personal questions," Wooten said. "You learn to be discrete about your own business and listen to what they have to say about theirs."

Wooten still hopes to connect with people, but more as a traveler than a shop owner. After she closes and sells her store she plans to travel the U.S. with a friend. She hopes to see her brother in South Carolina more often.

Fabulous Finds will close on Oct. 1. All items are currently on sale and Wooten said she's willing to negotiate. Anything not sold will be donated to several local charities. She will sell the building and let someone else usher in a new era at 107 South Seventh Street. "I really do appreciate all the cus-

tomers who have patronized my business," Wooten said.



DPS urges drivers to be aware as school year begins

USTIN - With the school year beginning in person for many districts across the state, the Texas Department of Public Safety is reminding the public of steps they can take to keep students and staff members safe. This includes slowing down in school zones, staying off cell phones and being aware at all times while around school buses.

"Going back to school is an exciting time for students, parents and staff, but it is paramount that drivers are more alert when around buses and schools," said DPS Director Steven McCraw. "I urge everyone on the road to be proactive and help ensure children arrive to and from school safely each and every day.'

DPS offers the following tips for school safety:

Give students extra room and don't assume they are paying attention to traffic. Students are frequently distracted by mobile devices or listening on electronic devices and may not be paying attention to their surroundings.

a school bus and know children may unexpectedly step into the road without checking for oncoming traffic.

front or rear, drivers MUST stop before reaching the bus. Drivers can only proceed if the flashing lights are no longer activated, the

this offense cannot be dismissed through defensive driving. Criminal charges are possible if a driver causes someone serious bodily

 Don't block a crosswalk when stopped at a red light or stop sign. Follow the directions of school crossing guards.

 Watch for children on bicycles traveling to and from schools.

Reduce speed when you spot

 Be careful around railroad crossings. School buses are legally required to stop at them.

Know laws regarding school buses. According to Texas law, if a bus has alternating flashing red signals visible from the

driver signals you to proceed or the bus has resumed driving. Approaching drivers do NOT have to stop for a school bus that is operating a visual signal if the road is separated by a physical barrier or an intervening space. If a high-

 Drivers who illegally pass a school bus face fines up to \$1,250 for the first offense. For people convicted of the offense more than once, the law allows for the person's driver license to be suspended for up to six months. A ticket for injury.

 Always obey speed limits and traffic laws in school zones.

Remember, texting while driving is illegal in Texas.




Taking care of preschool triplets is a great summer job.

Predictability is key here, characters, setting, and all, but it's exactly what you want in a romance.

Be aware that there's a touch of minor profanity here but it's realistically used and nothing you can't handle, so go ahead. Immerse yourself in a little escapism with a kiss. For you, "If the Shoe Fits" is sized just right.

hen some Cub Scouts toured Chuck Conrad's radio station in Kilgore, Chuck showed them some equipment that dated back to the days when telephones were rare.

One youngster asked a question: "If they didn't have phones, how did they get on the internet?" Chuck realized that these kids needed to learn about the early days of broadcasting and how it works today. Soon after that visit by the Cub Scouts, Chuck opened The Texas Museum of Broadcasting and Communications.

"We have a working TV news set," says Chuck. "We have a working radio studio so you can cue up a record or play a tape cartridge if you like. There's a lot of interactive things and our equipment works."

Chuck knows about equipment. Before he branched out into broadcasting fulltime he had a huge sound equipment company that provided public address systems for large gatherings. One popular item in the museum is a TV news bus.

"As far as I know it is the oldest fully restored television

visitors are impressed with what's in it.

"I don't think we've ever had a negative comment about it. Everybody is pretty well blown away by it. The usual comment is 'I didn't know it was this big.' More than once I've heard visitors tell me 'you know I didn't think I was going to like this but I had a really good time."

One item that history buffs find fascinating is a World War II Hitler radio.

"If you were living in one of Hitler's territories and you had a radio that was capable of picking up the BBC or Voice of America you stood a real good chance of getting shot. You were supposed to buy one of these special radios that would only pick up Hitler's radio stations."

Broadcasters are always donating equipment so a second building with 8,000 square feet has opened. Some equipment is from a long time ago. Once an old broadcaster went to see the museum. He told Chuck, "I'm actually in a place where I know how to run some of this stuff." A lot of broadcasters who are familiar with the old consoles and turntables go to the museum to reminisce.

he GISD School Board held a special meeting on Monday, Aug. 9. Several topics were discussed during the meeting which include:

HANDBOOKS

Executive Director of Testing and Federal Programs, Yancey Sanderson, addressed the board about the 2021-2022 school year additions and updates to the campus student and DAEP handbooks. Sanderson asked the board to review the handbooks for what was described as "subtle changes." The handbook was described by Sanderson as being a "good guiding document for our campuses and adminis-

trators to use."

STUDENT ATTENDANCE Gatesville ISD superintendent, Dr. Barrett Pollard, spoke to the board concerning daily attendance snapshot times. Pollard said that each school day the GISD teachers take student attendance at the designated campus snapshot times. He explained that the snapshot time does not have to be the same time across campuses. "Taking daily attendance is a very important task because it relates directly to funding," said Pollard. Each campus principal has been asked to work with their attendance secretaries to determine the ideal time to take attendance and capture the most students present. The campus snapshot times are as follows:

Primary 9:30 a.m., Elementary 9:00 a.m., Intermediate 9:30 a.m., Junior High and High School 9:40 a.m.

Dr. Pollard asked the board to approve the daily campus attendance snapshot times as presented. A motion was made and the motion was carried.

ELEMENTARY MOLD ABATEMENT Dr. Pollard informed the abatement at the Gatesville Elementary campus. After the completion of summer school, the elementary campus had a period of two to three weeks with little or no activity. During that particularly rainy time, the air conditioning system failed to remove enough humidity and moisture from many of the classrooms. GISD hired a professional mold abatement company to develop a protocol to give the school direction on what areas to clean. Fortunately, the front office, cafeteria library and some of the other classrooms were not impacted by the mold. The classrooms that were impacted by the mold were depressurized, hepa vac the vents and ducts

board about the recent mold

and then deep cleaned the entire area. After the cleaning, each room was tested to ensure it met the air quality standards. Following the testing, it was found that five rooms did not pass the air quality test and they were going to be cleaned again prior to the beginning of school.

The estimated cost to abate the elementary of all mold was in excess of \$75,000. Pollard said that "damages are still being tallied." He recommended that the board allow the district to spend over \$50,000 to pay for the abatement of the Elementary school in order to make the building safe for students to return. A motion was made and the motion was carried. 2021-2022 OPERATING BUDGET

GISD Chief Financial Officer, Darrell Frazier, reported to the board about the preliminary 2021-2022 operating budget. Frazier presented to the board the District's first draft of the preliminary operating budget. Appropriations are estimated at \$30,351,355 which is a 4% increase from the previous year. Frazier reported that the revenue estimates are still a work in progress. He recommended that the board consent to the overall framework of the preliminary budget, reminding the board that an updated proposed budget would be presented to the board later in the month for adoption.

A letter about 'the cow hunters' in the house

This is an article about a letter sent to Miss Zelma Scott who wrote A History of Coryell County. This letter is found in our collections, on very brown paper, unlined and written in pencil by Dave Grubb, son of Wiley P. Grubb and Georgia Hester in 1945.

The letter is as follows:

Dear Miss Zelma, The cow hunters all got together at our house, they would have pack horses or mules, the provisions and bedding were tied on them hard and fast with ropes, then each cow hunter would take along two extra horses to ride. Then they would have fresh horses to ride the ranges after the cattle. They would leave our house with all these horses, driving them and as they aathered cattle these horses went along with the cattle. The cattle that had drifted away from the cold northers (winter) were brought back. Father would put his cattle as he gathered them in a herd and they were penned at night. Jim Taylor, C.T. *Boling and Henry Lee were* hired by the month and in this way lots of the cattle were located. *The long horned beef* steers on the range were *large and fat and were from* four to eight years old. We

had buyers to come from the north, such as Kansas, Missouri, Illinois and Iowa. I remember they had wallets or saddle riders (money bags). They carried their money in to buy these cattle and stay with us in our home. The saddle riders would be throwed (thrown) over the joist (in the ceiling). No one paid any attention to it. iust knew the money was in them. Each man received the money for his cattle from those saddle bags. Then when they finished buying the herd of long horned steers would start overland across the country and hear the cowboys popping their whips and singing as they left, probably a thousand or more in the herd. It was a pretty sight, those large, aged steers and they sold for \$14 or \$15 each now and worth over \$100 (at the end of the trail).
