Remembering a Gatesville-born legend



Eddie Locke Jr.

Gatesville native Eddie Locke Jr. was a twoway star in the minor leagues of baseball, winning 20 games or more four times in the minors, known primarily as an outfielder in the American Negro League between 1943

Locke's humble beginnings started in Gatesville. He was the only child of Edward Locke, Sr., and Ida Manning Locke. His mother, Ida Margaret Manning, was 16 years old when she wed Eddie Locke who was then 32 years old. Despite their age difference, they

were married on Feb. 13, 1922. Eddie had a criminal background when he married Ida and had been in and out of jail prior to their marriage and that pattern would continue throughout their short-lived marriage.

Their only child, Edward (Eddie) Locke Jr., was born on Jan. 13, 1923. The couple had a very rocky relationship and Eddie Sr. would often end up in jail. In September 1924, he pleaded guilty to the offense of passing a forged instrument and was sentenced to two years in the state penitentiary at Huntsville. In July the following year, Ida filed for divorce and was granted full custody of Eddie Junior who was then 2 years old and father-

Very little is known about Eddie Junior's early life. In 1926, when Eddie was 3 years old, his mother married once again to a much older Gatesville man named Lee Adams who was 30 years her senior. The marriage would only last a few years. By 1930, Ida and Eddie Junior were living in Dallas with her sister, Serlater Bolden, and her family. The entire Bolden family, including Ida and Eddie Jr., were employed by a wealthy Dallas family. Serlater's husband, Ed, served as the chauffeur, Serlater was the maid, Ida served as the

This was the sixth time the Gatesville Police Department won the chili cookoff, and the second consecutive victory. Previously, GPD took top honors in 2013, 2016, 2018, 2019 and 2020. The chili cookoff was cancelled in 2021 because of COVID-19.

Lee said the police department's recipe "has pretty much stayed the same, but we'll make minor adjustments here and there. We had some good competition. I do want to thank the Gatesville Independent School District's Culinary Arts Department for letting us use their

kitchen."

Staff Sgt. Sheneka Love of Chicago prepared the entry from North Fort Hood. Lt. Col. Steven Hady said Love won three different contests to advance to the competition in Gatesville. The North Fort Hood entry was widely recognized as the spiciest entry in the contest.

"We brought the heat," Love

said. Several local restaurants and also local bakers participated in the Taste of Gatesville, allowing local residents to sample items ranging from pulled pork, nachos, pizza and chicken nuggets to meringue pies, cookies and doughnuts.

County confirms COVID-19 policy

COVID-19 numbers in Coryell County continue to decline, although two new deaths attributed to the disease have been reported

County Judge Roger Miller noted that 48.7% of county residents have received at least one dose of the CO-VID-19 vaccine. That number rises to 84.5% for people age 65 plus and 75% of seniors are reported as being fully vaccinated.

Miller said a new version of the omicron variant of COVID-19 has been reported, and so far, it is considered to be highly transmissible "but not nearly as deadly" as the nrevious variants

The Coryell County Commissioners Court recently addressed the county's policy on employee absences due to COVID.

Burn ban continues

The Coryell County Commissioners Court has reaffirmed a burn ban that had been enacted previously, and also voted against allowing the sale of fireworks in advance of the Texas Independence Day holiday.

Based on a conversation with Mr. (Billy) Vaden (the Gatesville fire chief) I would recommend against lifting the burn ban," said County Judge Roger Miller. Other members of the commissioners court, including Ray Ashby Jr., Ryan Basham and Kyle Matthews, also voiced their support for continuing the burn ban based on dry conditions.

Although fireworks sales are primarily associated with the period near the Fourth of July and New Year's Eve, sales are also possible between Feb. 25 and March 2. Texas Independence Day is March 2. Because of conditions, commissioners did not approve the sale of fireworks in the time period associated with that holiday.

cook and Eddie Junior, who was 7 years old, was also listed as a maid.

Two years passed and apparently Ida and Eddie Junior were living back in Gatesville. Suddenly, Ida died of amoebic dysentery at age 28, leaving her 9-year-old son, Eddie, an orphan. Eddie was left to be raised by aunts and uncles - some of whom were living in Kansas City.

Very little information is known about Eddie's early life or exactly how he became acquainted with baseball. It can be assumed that he was influenced by the American Negro Leagues in Kansas City while living with his mother's family. Records indicate that he made his debut in 1943 with the Cincinnati Clowns and the Kansas City Monarchs. The Negro Leagues were professional baseball leagues made up of teams of African Americans and Latin Americans.

In 1944, a Kansas City Star newspaper mentioned "a young Eddie Locke" who was pitching for the Kansas City Monarchs at age 21. In 1949, Locke was mentioned in The Brooklyn Daily Eagle in Brooklyn, New York as being a part of the Black Yankee Travelers. He was described as a "heavy hitter who is used in the infield and on the mound." A few years later, he was back playing for the Kansas City Monarchs and often described in newspaper articles as being an "outstanding ballplayer."

Locke returned to Texas to play for the Amarillo Gold Sox. An Amarillo newspaper wrote: "There are

one-man gangs, then there is Eddie Locke. He'll beat you either pitching or hitting - or both. And his flair for the dramatic has baseball fans in the Texas Panhandle agog."

Amarillo was proud of their new ballplayer, and he became known as "Amarillo's Iron Man Hurler." At age 24, Locke was reported to be pitching right-handed and batting left. In a 1953 interview, Locke said, "I'm batting about eleven hundred." Considered to be a valuable player, baseball scouts were attracted by his pitching and his fielding. "Amarillo never before saw anybody like him in baseball, either as an all-around player or as a gate attraction," reported the Amarillo Globe-Times.

Locke would later play for another Texas team, the Victoria Eagles, in addition to playing in the Mon-

terrey Club of the Class AA Mexican League - his contract had been sold in May 1956 to Monterrey for \$2,000 cash. In that same year, he was reported to be "going strong" in the Veracruz League.

In an article appearing in a Mexico newspaper described him as a "sturdy righthander who observed his 30th birthday on January 13." The article also stated that he was in the process of sewing up his third "winningest pitcher" designation in less than a year and a half.

In his later years, Locke would make a comeback in 1967 after returning to the Monterrey, Mexico league. He continued to be a big gate attraction in the American Negro League. Locke continued to play baseball until the late 1960s.

Locke died in Corpus Christi on March 2, 1992, at the age of 69.

His death was recorded in local newspapers with no more than three or four sentences - nothing mentioned about his illustrious baseball career or the baseball legends he had once played with - no fanfare for an all-time great.

Eddie Locke's connections to Gatesville were summarized by his cousin, Joe Manning, who said, "He would always come back [home] about once a year to Gatesville." Locke would make the journey back to Gatesville to reconnect with his roots and to visit with all of his childhood friends and his relatives. Manning described Locke as being "a beautiful Black man with a beautiful smile and a soft voice." When asked if the Gatesville community was proud of Locke, Manning replied, "Yes, most of the community was. ... I know our family was."



timelines, her family's goal is to keep her as comfortable as possible and to let her know how much she is loved.





mbivalence, the holding of two contrary attitudes or feelings, is built into us. We are spiritual creatures who seek God while living in a material world. That there is much to love and savor about our physical existence makes the ambivalence all the more unsettling. We know that we should seek God's kingdom first, but we hold tightly to the things of this world. How many of us could give everything away and completely trust in the Lord to provide for our needs? Ambivalence can be unsettling in many ways. Being attracted to something while simultaneously being repelled by it—think of the cheesecake that threatens to sabotage your successful diet—literally creates a mixture of positive and negative feelings that, for lack of a better word, just feels "yucky." Psychologists tell us that positive and negative feelings tend to be processed by different sides of the brain, and those uncomfortable feelings of ambivalence are literally caused by our simultaneously experiencing opposing emotions. It would perhaps be better if the right hand did not know what the left hand was doing, but alas, we cannot ignore or hide from ambivalence. It is everywhere, in our significant relationships, in our passions and values, and in our very being. But where possible, we should minimize it. We can't love our enemies as much as our friends and we shouldn't love the world as much as we love God. - Christopher Simon







Historic church in need of donations for repairs

The Historic Eagle Springs Baptist Church Association is seeking funding and donations to help with the repair and maintenance of the century-old church. The cypress siding on the building has begun to deteriorate, and mold is beginning to form on the outside of the structure. In addition, the building needs to be leveled and painted.

Originally known as Onion Creek Baptist Church, it was formed in 1858 in a log building. When the log church burned a year later, the congregations built a new one. In the 1870s, the church congregation divided, and a new church was created, The Eagle Springs Baptist Church, which was constructed in 1878. Cypress wood was hauled in wagons from Galveston for the siding of the structure.

The building has two front doors - men entered through the right door and sat on the right side of the church, while women and children entered through the left door and sat on the left side.

Rev. John McClain was the first pastor, and among the pastors who followed was the Rev. Raleigh R. White, father of one of the founders of Scott and White Hospital. This is also the church that

the Neff family attended. Governor Pat M. Neff attended Eagle Springs Baptist Church as a child and as a young adult. He always considered it his "church home."

Despite the decrease in population in the Eagle Springs community, the church continued to operate until 1948 when the congregation voted to disband.

Over the next 50 years, the church was used sparingly for occasional weddings, funerals, and the annual homecoming.

A tornado damaged the historic structure, and for a time, it appeared that it would be torn down. A group of area citizens rallied to the cause and was able to move the building a short distance away from its original site and begin restoration.

Since being restored approximately 15 years ago, the church came to life once again with weddings, family reunions, birthday celebrations, and the annual homecoming event — which has recently been put on hold due to COVID concerns.

Despite the restoration over a decade ago, the structure is still in need of repairs. The Historic Eagle Springs Church Association would greatly appreciate any donations that could be made to help repair this historic structure located in southeastern Coryell

County.

Scholarships available for African American students




