# City to consider rates for water

Although a decision will be made during an upcoming Gatesville City Council meeting, Council members were given a sneak peek at a water and sewer rate study which could result in increased fees for customers.

City Manager Bill Parry said the study, which will be presented in greater detail during an upcoming Council meeting, considers a price increase which the city will have to pay to the Brazos River Authority for water rights, as well as expenses for staffing, chemicals used for water treatment and maintenance.

In addition to the base rate, changes may be recommended in the volumetric rate – based on the amount of water used by customers.

"Everybody pays the same base rate," Parry explained, "and we try to balance the base rate and volumetric rate."

In 2018, the Council voted to keep the base rate the same regardless of the size of the water meter customers have. A consultant studying the best and most efficient way for the city's water department to operate has recommended that customers with larger water meters be charged a higher base rate than those with smaller ones. A larger meter allows more use.

Based on the current policy, Parry noted, "Wal-Mart pays the same amount for the first 1,000 gallons as other customers." One possible change is that the water rates would be based on a tiered structure, and those who use more water or who require larger meters might be charged a higher rate.

## Therapy dog making big impact on local campuses

Dogs just have a way of connecting with people emotionally that can make an incredible positive impact for those coping with emotional distress, and one new canine on the scene for the Gatesville Independent School District is Bishop.

"He was a godsend," said GISD social worker Joyce Cole, who has had Bishop for about six months. She said she has seen a noticeable difference in children's behavior when they interact with him.

"I started bringing him to school last year, and I figured out pretty quickly he was a natural," Cole said. "He has a keen sense of awareness and can tell when someone is upset or unhappy. His only job is to give love.

"Kids may be crying and he'll go sit in their lap and comfort them. He'll go to every student, but he gravitates toward those who are upset. With our emphasis on SEL (social emo*He's done wonders. Even test scores have improved when Bishop is there. People become calm and loving.*"

tional learning) and wanting to lower stress levels, he's done wonders. Even test scores have improved when Bishop is there. People become calm and loving."

Bishop is patient with people and doesn't try to approach those who aren't comfortable with him, Cole said.

"He doesn't demand affection or attention, and normally he won't go up to anyone who doesn't want to pet him. He can sense that, and that's OK. Not everyone loves dogs.

"A couple of kids moved in and they became my Bishop trainers. They felt happy that there was something they could contribute."

According to information provided to the

Gatesville ISD Board of Trustees, "when traumatic events happen at schools, counselors and a trauma team from the Service Center can converge on the campus to support the grieving students and staff. Therapy animals can also be deployed to help soothe pain and help people open up and start healing. Therapy animals are not reserved for traumatic events. Schools are beginning to use therapy animals in their everyday routines."

Bishop has become a celebrity and attracts attention wherever he goes, Cole said.

"He's already very well-known and I'm so excited about having him," she said. "It's

# Working for the future

Whether helping Coryell County find sources of grant money, identify top concerns among low-water crossings or put important information and maps into an electronic database, Natural Resource Solutions of Austin has been busy assisting county officials and departments for several months.

During the most recent meeting of the Coryell County Commissioners Court, a scope of work was approved between the county and NRS to help plan out future efforts.

"This is a continuation of what we've accomplished (working with NRS) - including three grant applications - and gives the court more latitude to continue with data collection independent of specific grants," said Coryell County Judge Roger Miller.

A next step is to obtain software so it can be utilized for county

operations including the road and bridge department, emergency services, school districts, "a whole host of uses," Miller said.

Once the Geographic Information System (GIS) software is being used by the county, "it can provide another level of information that will be readily available to the public," Miller said. Two examples of beneficial uses he mentioned were to alert people and show areas being evacuated because of fires, as well as road closures during an emergency.

"This (agreement) will allow us to work with NRS to continue to collect data and analyze it," Miller said.

Steve Manning, president of NRS, said there are a trio of specific areas to focus on.

"There are about three things that are especially relevant right now," Manning said. "This is a pathway for the court that doesn't cost a whole lot of money to get you into the 21st century (with data collection and accessibility)." When NRS began working with the county earlier this year, much of the information needed to compile databases – including key maps – was only available on paper and not in electronic form. Not only is having an updated electronic database important for local accessibility, it is often required in order to apply for certain grant funding for county projects.

Manning said there is a program the county can use through Esri – an international supplier of geographic information and software – that would cost \$600 a year (or \$50 per month). It would allow the county to tap into an electronic database and also use that as a way to communicate with vendors, the city of Gatesville, Copperas Cove, and other entities through that system.

"That would get you up and running and better able to communicate and identify areas on the map if concerns arise," Manning said. "We recommend you do this pretty quickly so y'all can actually see the product."

Manning said while the county has worked with NRS primarily on road and bridge information, "it has come to my attention that the county is also interested in grants for water infrastructure. There are grants specifically tied to smaller communities and counties and we should talk about those opportunities more in the near future."

There are U.S. Economic Development Administration (EDA) grants available that would benefit the county, Manning said.

"The (Central Texas) Council of Governments has done a great job helping the city of Belton obtain about \$2 million (through the EDA) for the city of Belton. We believe another grant opportunity for water infrastructure is available. Counties can apply. This would not necessarily be for roads, but for water infrastructure."

Maddie Todd, an NRS policy analyst and project manager, gave county leaders an update on grant applications. One which would help upgrade local bridges has already been submitted, and others are in the process of being compiled.

One of those grants would provide funding to help eliminate snags in rivers and streams that have caused significant flood damage in Coryell County.

Commissioner Ryan Basham said he has already reached out to area landowners affected by these snags and hopes to obtain funding to help them.

"If no action is taken, they will lose more land," he said, adding that the problem "is massive."

Manning said the county initially identified 20 areas of concern – lowwater crossings – impacted by flooding, but he has learned there are more.

"There are a number of crossings identified by (local) school districts that were not on the list of top 20 projects," he said. "I need guidance from the court on how you want to prioritize those."

Judge Miller said the county and the NRS should work together to identify the next steps in a comprehensive plan to make improvements throughout Coryell County.

"We need to start to put together a master plan rather than just taking little bites as opportunities come up," he said. "We can shape the environment instead of just reacting to it."

Capital improvement projects to make improvements in the city's water and wastewater infrastructure cannot all be funded out of the pool of money the city receives for water service without raising rates substantially, so in order to keep rates lower for customers, one recommendation will be that the city

### fund some of those improvements through debt services.

"We will have to talk to a financial adviser to determine how much we can afford," Parry said. "It wouldn't be rate funded, it would be debt funded to avoid a high cost for customers."

Raw water rights which are purchased from the Brazos River Authority have gone \$5 per acre foot of water to \$88 per acre foot, and Parry said the expectation is that rates will continue to rise an average of \$4 to \$5 per year.

Two likely recommendations for the Council to consider will be to "tie the base rate to the meter size" and to have the "volumetric rate based on a formula in which those who use the most water pay a higher rate," Parry said.

To maintain the current level of service and also pay for equipment maintenance or improvements, "we will need to increase rates slightly over the next three years," Parry said. He anticipated a recommended increase of about \$3.50 per month.

Despite the proposed increases, Parry noted that "the water and sewer rates in Gatesville are some of the most affordable you'll find."

He said that even those using 5,000 gallons in Gatesville have rates "half of what they are in Mc-Gregor, Marble Falls or somewhere else."

Based on consultants' recommendations, the Council will likely be asked to increase water rates for the 2023, 2024 and 2025 fiscal years, with no increases expected for 2026 or 2027.

More discussion – and a possible vote – on water and wastewater fees for Gatesville is expected at the Aug. 16 Council meeting.

great having him work with students and staff. We hope to make a difference together and visit each campus."

Christa Hitt, a case manager for GISD's School-Community Guidance Center, will also be bringing a therapy dog to campus through the Bella's Buddies program. Bella's Buddies is a nonprofit which loans therapy dogs to school district's for extended periods.

Classroom teachers can choose to participate in the program. The cost is caring for the dogs.

A packet provided to GISD trustees noted: "Some research from Bella's Buddies indicates a decline in (disciplinary problems) and a rise in attendance for students who routinely interact with therapy dogs. Students look forward to seeing the dogs in class. GISD continues to do what's best for kids, trying to employ various strategies to connect students to their school."

Hitt was scheduled to receive a therapy dog to work at GISD earlier, but the need for therapy dogs in Uvalde, the location of the tragic school shooting in May, led her to allow that district to go ahead of her because of their needs.

"Some districts have a therapy dog on every campus," Hitt said. In one case, there was a student who had received more than 50 referrals to the office because of poor behavior, and his interaction with a therapy dog resulted in dramatic improvement in his behavior, she said.

"Behavior improves and test scores go up because of these dogs," Hitt said. "Kids will request to take a test with the dog in the room. It's not just for the students, though. There's also a boost in staff morale. We want to see how therapy dogs can improve morale at GISD."

Cole said Bishop loves his job, and his tail starts wagging when he sees her get the bandana that he wears to school.

"I had a special gift given to me (Bishop) and I had to utilize it," Cole said.

Hitt said in one case a student was having a severe panic attack and a therapy dog was sent to calm her, crawling in her lap to provide love and affection.

"You could see her de-escalating," Hitt said. "That is one example that worked rather quickly."



Her book, "Untangling Alzheimer's," is designed to allow the first-time caregiver and the longtime professional to gain the understanding and skills they will need to work effectively with persons with dementia. Her dementia staging tool, the DBAT, is adapted from the Global Deterioration Scale. Updated with the behaviors easily recognized in each stage of sementia, the DBAT allows families to track the disease process, prepare for the future and recognize how the behaviors of their loved ones are directly related to damage in the brain's lobes.

## Coryell County eligible for disaster relief

Producers in Coryell County are eligible to apply for 2022 Livestock Forage Disaster Program (LFP) benefits on short and long season small grains, native pasture, improved pasture, and annual ryegrass.

LFP provides compensa-

tion if you suffer grazing losses for covered livestock due to drought on privately owned or cash leased land or fire on federally managed land.

County committees can only accept LFP applications after notification is

received by the National Office of qualifying drought or if a federal agency prohibits producers from grazing normal permitted livestock on federally managed lands due to qualifying fire. You must complete a CCC-853 and the required supporting documentation no later than Jan. 31, 2023, for 2022 losses.

# **Volleyball team primed & ready**

The Gatesville Hornets volleyball team has a tradition of excellence that few programs in the state share - 19 straight trips to the playoffs.

This year, as GHS looks to claim its 20th straight playoff berth, coach Janey Weber will rely on the leadership of six seniors as the Hornets compete in a new district.

Gatesville will no longer face road trips to Brownwood, Stephenville, Lampasas and Glen Rose for district competition. Instead, the Hornets will join a Waco-centric district that features China Spring, La Vega, Connally and Robinson, along with Bell County opponent Salado.

"Last year, we were traveling an hour and a half to play district games, so this will definitely be better as far as travel goes," Weber said. "The teams in our district are ones that we always try to keep on our schedule. They are strong programs.'

Closer proximity to Gatesville is an added bonus for both the athletes and fans.

Of the Hornets returning players, two earned All District honors. Kaleigh Haywood earned first team recognition and will bolster Gatesville on the outside, while junior Barrett Boyd, who earned second team all-district honors last year as a sophomore, was middle blocker but will also be relied on to play outside, Weber said.

Weber is entering her third season as the team's head coach and her fifth year with GHS and is continuing the winning tradition that former coach Rickey Phillips' - now GISD's athletic director - enjoyed from 2001-2019. Assistant coaches are Ashley Drozd-Hubik and Andrea Holdbrook.

The Hornets were 29-10 last season, and lost a close match in the first round of the playoffs last season against Graham.

"We fought hard and played well, but we lost in four sets," Weber said. "It was a good match."

One of the players the Hornets will miss this year is Tasha Thoms, the team's setter who earned a college scholarship to play beach volleyball at Missouri State.

While Thoms was a dominant force for the Hornets, the example she set and level of excellence she achieved will no doubt inspire those following her in footsteps as a new group of contenders step up and look to make their own positive mark on GHS volleyball.

Weber said one of those stepping up into more of a leadership role is Lola Barron.

"Seeing the kids step up and take on new roles is always exciting. Tasha was a great leader for us, and Lola is doing a great job stepping into that role."

Despite a strong slate of district foes, Weber said she is confident her team will step up to the challenge.

"I feel like this team is very motivated and enthusiastic, and we are really close - like a family," she said. "They feed off each other.'

The season-opener for GHS will be Monday, Aug. 8 at University High School in Waco. The home-opener will be Aug. 9 against Fairfield, with the varsity scheduled to take the court at 6 p.m.

"It's been fun watching the players develop and work hard during the spring and summer," Weber said. "We are ready to get going."

Weber said the Hornets will give their best shot in every contest, and she hopes the community will back the team with a good turnout.

"Come out and support us," she said. "We love having a loud and rowdy crowd behind us - the more the merrier. We hope to see you at the games.'
