# Jail expansion nearly halfway complete

County commissioners provided an update on the progress of the Coryell County Jail during a regular meeting of commissioners' court on Tuesday.

The construction of the jail is about 40% complete, Commissioner Ryan Basham said.

"I go over there about three times a week, and everything is moving along," Basham said.

He adds that the masonry work is about 90% complete, which includes the cinder block walls for the holding cells. Plumbers are also completing their work on the sewer vents.

As of Tuesday, they are hanging the steel and adding metal decking to the roof, as well as finalizing the installation of the interior door frames and window frames for the facility.

Following a meeting with the construction firm on Wednesday, Basham said the firm believed the roof would be completed within the next week to 10 days.

"They said they are a little ahead of schedule," Basham said.

# *Meals on Wheels is more than "just a meal"*

As the Meals on Wheels program continues to grow, so does the need for volunteers.

Meals on Wheels is a federally funded program that provides seniors in the community with support that allows them to remain living in their own homes. This typically involves delivering a nutritious meal, a friendly visit, or a quick safety check. The Senior Center encompasses a full nutrition program and does accept donations.

Senior Center Director Pam Rudolph said, "Volunteering for Meals on Wheels is very important because the purpose is to deliver meals to seniors who are shut in, cannot drive or leave their home, as well as giving our clients a sense of purpose." According to mealsonwheelsamerica.org, the program has had positive impacts on social isolation and loneliness for all clients.

"It is good for the client's mental health, because most of the time the Meals on Wheels volunteers are the only people they see for that day," Camilla Edge, Nutrition Supervisor said.

When there are not enough volunteers available, Rudolph or Edge will take a route.

"There's certain people that every time I see them, they are so happy, and it makes you feel so good," Edge said.

The volunteers are expected to deliver a meal while generally checking in with the clients to make sure they are doing well through a friendly greeting or small talk.

"Sometimes, you'll learn more about the client in those few minutes because they try to give a weeks' worth of information about what has happened with them," Edge said. "It doesn't matter that I have five more meals to deliver, I will make time for that person to listen because it is important to them."

A normal day of Meals on Wheels involves picking up the meals at the Senior Center, then delivering them along a pre-determined route directly to the homes of seniors in the area.

Meals on Wheels is done five days a week, Monday through Friday, and takes around 30 minutes to an hour to complete depending on the route taken. There is

the walk, each step representing the stride toward restoration and unity beyond incarceration.

"The peace walk was mainly to demonstrate the power of redemption, forgiveness, and understanding," said Chanel Jones, the Waco Regional Director for the organization. "Also, to unite what divided us from the community."

The walk included a healing circle to release any bad experiences associated with incarceration and move forward on a new path.

"A lot of people, when they think about Gatesville, it is trauma-based due to being incarcerated there and certain things they experience while being incarcerated," Jones said. "The peace walk was basically to get individuals together who have been incarcerated and have trauma associated with Gatesville and bring the community together in unity to start something different, because we don't want to associate bad things with Gatesville.

Lioness member April Towery, who was incarcerated in Texas women's prisons from 2020 to 2022, said the event offered a chance to heal and build community with Gatesville residents and faith leaders.

"It was incredibly powerful to walk alongside my sisters and see the strength and grace they exhibit in the face of trauma," she said. "It takes a lot of courage to admit your mistakes, make amends to those you harmed, and show up for others who are still suffering behind the walls. I'm proud of us for taking the worst experience of our lives and turning it into something positive."

The Lioness Justice Impacted Women's Alliance aims to end the devaluation and mistreatment of incarcerated women and girls. As a regional director for Lioness, Jones said she helps formerly incarcerated individuals in the Waco, Killeen, Temple, and Gatesville area who are re-entering society by connecting them with resources such as housing and employment.

"I'm trying to get more involved with the community and find resources for ladies that get out that live in the area," she said.

He adds that he does not foresee any road closures as they head into the final phases of construction over the next few months. The expanded facility will add 47 beds to the current 92 beds. It has been under construction since the spring and is scheduled to be completed in March 2024.

# Two candidates file for Gatesville City Council seat

The Gatesville City Council will have one seat up for grabs during the Nov. 7 election. Two incumbents, Meredith Rainer and Greg Casey, filed for re-election before the deadline on Aug. 21.

The third seat up for re-election was held by Claude Williams, who did not file for Ward 1, Place 1 seat. The two candidates that did file for that seat were Leo Corona and Lewis Aaron Smith. Corona filed on Aug. 16 and Smith on Aug. 17.

Leo Corona stated, "I decided to run for city council after attending

the city council meetings since last November and got a feel for what they're doing, and one thing that I noticed that I would like to bring change to the city council is in regards to ward representation." Corona continued, "At the end of the day, I'm running for city council, because our town deserves what is best for the people and representation that they can count on.'

Lewis Aaron Smith announced his candidacy by saying, "I am running for city council Ward 1, Place 1 to help preserve the integrity of Gatesville as a small town, while ensuring it can still grow and pros-

not a set schedule to volunteer.

"It is really based on the volunteer's availability," Rudolph said. "We need at least four drivers per day, but we do not require a certain amount of time."

There are four different routes in Gatesville, and each Wednesday a route to Hamilton is taken. Anywhere from 10 to 14 clients are seen each day per route. "If you are over 55 years

old, we have a free liabil-

ity policy," Rudolph said. "While delivering meals, if a volunteer trips and falls, has a wreck, or experiences an event of injury, it will kick in to help pay the deductibles."

At the end of last year, the Meals on Wheels program stopped reimbursing volunteers for their mileage driven. Vehicles need to be provided by the volunteers as well.

"Pam is trying to get enough volunteers where a few people come on a certain day, and if a person can't make it, then the volunteers will entwine and know each other enough to take each other's places," Edge said.

Volunteering does not only consist of delivering meals, but also includes coming in early to help put the coolers together and aiding with preparatory work.

"We all sit and chit-chat about everybody's week, we are just like a family," Rudolph said.

Edge prepares around 250 to 300 meals each week for her clients.

"When I first started, we were putting out 25 to 30 meals, and now our highest is 87 meals," Edge said. "We are still growing, and I project that next year we are going to be making over 100 meals."

Edge will have served at the Senior Center as the Nutrition Supervisor for one year this November.

Meals on Wheels is more than personal to Edge since her father took part in the program for years.

"My dad was getting meals delivered by Meals on Wheels in Temple, and I didn't even know," Edge said. "If it wasn't for that program, my dad would have been very lonely, and I am thankful that he had that."

To qualify to receive meals from the Meals on Wheels program, visit the Senior Center to get an application or have a family member pick one up. Seniors interested in applying must be 60 years or older and homebound.

The Senior Center also provides hot meals daily at its facility for those who can drive. There are daily activities, lunch, and companionship. For those 60 years and older, it will cost three dollars for a meal and any age below that will cost

seven dollars.

"If we could just get people to take that initial step and come through that door, they would have a good time," Rudolph said.

"I love my job, and I feel that what Pam and I do is important for our community," Edge said. "We are helping people in a good way."

The Gatesville Senior and Multi-Service Center is located at 208 N. Lutterloh Ave.

# *A historic bed and breakfast offers a place for new beginnings, memories, and the community*

> or Debra and Danny Kilgore, the slogan "a place of new beginnings and peace" set the foundation for the opening of Pennoli Bed and Breakfast.

Following a string of events in 2020 that included family tragedies and the outbreak of COVID-19, the Kilgores decided to leave their home in Washington state to join their daughter and granddaughter in Texas. After officially moving in 2021, they settled in Killeen for about one year before they began their search for a retirement home and investment property.

"When we came here, we loved the weather, our granddaughter is here, our daughter is here and we thought this would be a good place to retire and have income property," Debra Kilgore said. "We didn't know it was going to be a bed and breakfast though."

Settled along Gatesville's Main Street, it's difficult to miss the two-story colonial white house only a few blocks from the downtown square. Most recently known as the Widow Lambeth Inn, the Kilgores first noticed the historical home when driving through Gatesville for a DPS appointment.

"I was driving down here, and I noticed this house," Danny Kilgore said. "Now, that would be a house I would like to own."

When the house became available for sale on a real estate website, they decided to take the chance and reopen it as a bed and breakfast in 2022.

While owning a bed and breakfast was not part of their original plan, it has always been Debra Kilgore's dream to open one. With her background in hospitality, plus Danny Kilgore's desire to be a small busi'Pennoli' combines the names of Danny and Debra Kilgore's two dogs, Penny and Olive, and it also represents the meaning behind the business's slogan.

"We want it to be a place of new beginnings and peace," Debra Kilgore said. "Penny's name means 'new beginning' and Olive's name means 'peace.' That's what we want people to feel, and that's what we want our community (to feel) when they're driving by here – we want them to feel that ambience."

#### History and restoration

Although the deed dates its construction to 1955, the Kilgores believe the home is decades older, and that a fire might have destroyed its original deed.

According to the "Coryell County Scrapbook" by Mildred Watkins Mears, a fire at the courthouse square destroyed many early city records in the late 1800s. Due to the lack of re-

Due to the lack of records, the Kilgores have taken it upon themselves to track down its history through local research and old maps of Gatesville. One map provides evidence it could have been built as early as the 1880s.

"It would have been nice to know exactly when this was built, but we know it could be one of the first or built not very long after it (the town) was founded," Danny Kilgore said.

The Kilgores lived in historic homes during their years in the Pacific Northwest, allowing them to appreciate the architecture, but also recognize the hard work of restoration. Throughout the renovation process, the Kilgores have gone to great lengths to

Kilgores tried to match it to the original wood.

"We tried to stay as close to the color of the original wood to keep the character of the home," Debra Kilgore said. "If you look at the trim, you can see that it's an original trim that came with the house when we bought it, so that's how we matched it."

The décor of Pennoli nods to the home's historic ambience, with a mix of antique and modern furniture and art. It offers three guest rooms known as the Bluebonnet Suite, Longhorn Suite, and Magnolia Suite, plus a "glamping" camper that provides access to an outdoor seating area.

Guests can also gather in the downstairs dining room, lounge/bar area, and living room, or the upstairs parlor for a quieter environment. "When people come in, I want them to feel like they're at home," said Debra Kilgore. **Cherished memories**  Interviews with long-time residents of Gatesville have also helped the Kilgores discover the history of the house.

Although a variety of businesses and residents have lodged in the house over the years, it became a childhood home for the Ament siblings in the late 1930s and early 1940s.

Emily Young, Laverne Harris, and Bill Ament fondly remember their youngest sister, Kay Herring, taking her first steps in the house.

"I think that would have been a great place to grow up," Herring said. "It was the center of town, and all the activities were going on there."

Photographs shared by siblings show an image of a four-year-old Bill Ament sitting on the original front Despite their short tenure in the house, they agree it became a place of fond memories.

"It brings back memories to us," Laverne Harris said. "We were only there two or three years, but it seems like I can remember more things that happened there than anywhere else."

Decades later, the siblings have had a chance to revisit the home and appreciate the Kilgores keeping the home's memory alive.

"I just love being here and seeing it again, and that it's fixed up so nice and cute," Emily Young said.

A space for the community As a bed and breakfast, Pennoli welcomes visitors from out of town and locals needing a staycation. However, the Kilgores have also also advertise locally-owned businesses to guests, encouraging them to shop and dine in the Gatesville area.

"We're really trying hard to incorporate new businesses that are just starting up," Danny Kilgore said.

To give back to their community, Debra Kilgore adds that they also partner with local organizations for various charity and community events. On Oct. 28 - Nov. 30, Pennoli is partnering with Righteous Roots for their annual coat drive.

"I want it to be something that Gatesville's proud of. And that's why I want to be very involved with the community," Debra Kilgore said.

In this community, D.W. and Elizabeth reared her two children and children of their own, including Daniel Lee Edwards, who, in 1920, donated the graveyard to the Ireland Cemetery Association. 

magine planning a dinner party with an open invitation. You don't know who is coming, how many will attend, when they are arriving, or when they are leaving. How do you make sure you have enough food, but not too much? How much seating do you need? Did I mention that this is the first time you've had a dinner party?

This is the situation we find ourselves in as we plan for the April 8, 2024 eclipse. One of the first questions I'm asked when talking about the City of Gatesville's plans for the eclipse is "How many people are we expecting?" My answer is a solid "We don't know." We can, however, use information from experts on eclipse planning to try to estimate. Factors to consider include:

**Location along the path -**People traveling to experience the eclipse will want to be in a prime location. Gatesville will experience 4 minutes, 23.9 seconds of totality - one of the longest durations.

The accessibility of the area - U.S. Hwy. 84 and State Hwy 36 are expected to be popular routes, especially for those trying to avoid IH 35.

The population of the **area** - Areas with larger populations are more likely to attract more eclipse viewers because they have more lodging options. We also need to take into account that many residents will have visitors in their homes. In our area, the number of weekend homes and hunting cabins may affect the number of people who are in our area for the weekend leading up to the eclipse on Monday.

The weather forecast for the day of the eclipse - Clear skies are ideal for viewing the eclipse, so areas with a good weather forecast are more likely to attract more eclipse viewers. Eclipse chasers will check the weather the day before the eclipse then drive to a prime location that is also expecting clear skies.

The amount of publicity and promotion the eclipse receives - The 2017 total eclipse set the stage for a surge in interest in this eclipse. The October 14th annular eclipse has also brought more attention to the April 8th event. Based on these factors

and what areas like ours experienced in 2017, we've been told to expect two to three times our regular population. We think we could see anywhere from 10,000 to 20,000 visitors. We are working to prepare for that by planning for traffic and public safety, encouraging businesses to stock up and staff up, and planning activities to make sure residents and visitors have a great experience. Will 10,000 to 20,000 people really come to Gatesville?



# Reaching the century mark

> ccording to his daughter, James Dixon was greatly anticipating his 100th birthday. He woke up a little after midnight on the day of his birthday and thought to himself, "I made it."

> > James Dixon, the son of Alvis and Vida Tippit Dixon, was born at home on Oct. 3, 1923, in the Hubbard community of Coryell County. Hubbard was located in southeastern Coryell County, and in its heyday, had a grocery store, a gas station, a blacksmith shop, and a two-teacher school. At the time of his birth, Warren Harding was president of the United States.

> > "I was born at home. No hospital. No record of my birth. So, later I had a hard time getting a birth certificate, because everyone that knew of my birth was gone."

Dixon, who was raised on Owl Creek, attended the Longview School located in Cold Springs. "It went up to the 8th grade, and after that I went to Flat High School," he said.

"I dropped out in 10th grade when my Daddy got sick, and I went to Temple and got a job to help feed the family. I was the oldest of six children. A year after working in Temple, in 1942, they drafted me, Uncle Sam got me, and I was in the service for three years. I spent two of those years fighting Hitler," Dixon said.

"I received \$21 per month in the army and was able to send money home to help out," Dixon recalled.

During World War II, Dixon said, "I was over there during the Battle of the Bulge. The guns were going off like something you would hear at Fort Hood. All I can say is that our Heavenly Father is what saved me and that's what's given me a hundred years on this earth."

Considering the fact that his forefathers were German immigrants, when asked about fighting the Germans during the war, Dixon called upon his patriotism to the United States. "I told everybody, my job is that I'm killing my kinfolks. This is the way it had to be."

Eventually, the Germans were defeated, and Dixon was sent back to England to a school on fuses and bombs in preparation for the battle taking place in Japan.

"I got to the door of the college, and they told us to go back to the dorms, the United States had just dropped the atomic bomb. I felt God had saved me again," Dixon said.

After the war, Dixon returned to Coryell County and, soon afterwards, married his sweetheart, Allene Fischer. "We were married within two weeks," he said. "She raised me three outstanding children."

After returning home, Dixon went into the meat (sausage) business and later had a lumber yard and a construction business. To name just a few, Dixon built the Gatesville Masonic Lodge, Our Lady of Lourdes Catholic Church, Grant's Drive In, not to mention between 200 and 300 homes in Gatesville.

"To be just an old country boy without much education, I've had a lot of training alright," he said. "I tell my children that I came up in the best of times and learned a great deal."

In speaking of his wife, Dixon said "I've been married to the same woman for 77 years. We were married on the 28th day of December 1945. She is now 98 years old." When asked what the secret was to a long and happy marriage, he replied "It's the way you live. Christianity in marriage is a big thing. If you believe in God, like my wife and me, we were raised to believe in the Master."

On celebrating his 100th birthday, Dixon said "My family got a room here and they had a big birthday celebration for me, and you've never seen anything like it. We had pizza and cake, and I can't count how many people were there."

On reaching this memorable birthday, Dixon said "God, you've done it again." Dixon realizes that his life was spared during World War II, he has had a successful life and family, and has lived a century - which is a remarkable testimony to share with others.





Thanks to win over La Vega, the Gatesville volleyball team controls it's own destiny in their hunt for a 21st consecutive playoff berth.

The Lady Hornets dropped the Lady Pirates in three sets (25-10, 25-15, 26-24) on Oct. 6 then fell to Robinson in four (25-13, 25-15, 12-25, 25-17) to open the second round of district play.

With a record of 2-4 through six league games, the Hornets currently sit fourth in District 23-4A.

No. 15 Salado is 6-0 in district and has played in just twenty sets in district - winning 18. China Spring is at 5-1 with their only loss coming against Salado.

Robinson sits third and holds the tiebreaker over Gatesville with a district record of 4-2. They have the tiebreaker by virtue of two head-to-head wins against the Lady Hornets in district play.

If the Lady Hornets hold serve in the second half of district and beat Connally and La Vega in those rematches, then they will

clinch another playoff berth. They still hold an outside shot at moving up in the final standings, and the most likely result would be moving up to the No. 3 spot by winning three of their final four games and Robinson losing their remaining four games.

In 2022, Gatesville won their final five district games to finish third behind Salado and China Spring.

The win over La Vega featured a third-set comeback after a dominating performance in the first

two sets. The Lady Hornets faced deficits as large as six points at 18-12 and 19-13 before clawing back.

Down 18-12, a block from Addison Taylor cut the lead to 18-13, but La Vega took the next point to up the lead back to six at 19-13. From there it was all Gatesville.

A kill from Barrett Boyd made it 19-14, and then Anna McPherson drilled a winner to make it 19-15. Boyd followed with another kill to cut the lead to 19-16 before La Vega picked up a point to make it 20-16.

McPherson dropped in a winner to make it 20-17. Then Boyd picked up another to make it 20-18. Emma Pollard took over from there as she picked up four straight points at the net. First, she took an assist from Taylor Sanderson and drove home a point to make it 21-19. Then she scored again to cut the lead to 21-20.

The sophomore drilled an errant La Vega pass for a point to tie the game at 21-21. Then she combined with Sanderson for a block to give Gatesville their first lead at 22-21.

The Lady Hornets led 23-21 and had match point at 24-22 before La Vega scored twice to make it a 24-24 game. A pair of errors from La Vega gave Gatesville the final two points and the win.

Gatesville was at China Spring on Oct. 13 then returns home to face Connally on Oct. 17. They will host Salado on Oct. 20. Then they will make their last regular season road trip on Oct. 20 to La Vega.

# Gatesville falls just short in epic battle with Connally

A miracle-finish from Connally capped a disappointing 35-29 loss for Gatesville in the district opener for both teams on Oct. 6.

Kiefer Sibley raced 52 yards as time expired to score the winning touchdown after the Hornets had taken the lead 29-28 with less than a minute to play in the game.

Sibley – a highly-recruited, three-star running back was Connally's only hope offensively throughout the night. He accounted for 357 of Connally's 415 total yards in the game. In addition to 286 yards rushing, he added 71 yards receiving and scored four total touchdowns.

While the loss was disappointing for the Hornets,

they did more than their part in making the game and finish - one of the best in recent memory. That was due in large part to the performance by Rayshon Smith and the Hornets offensiveline, as well as a go-ahead fourth quarter drive packed with big plays.

Smith nearly matched Sibley's output on the night as he totaled 213 yards rushing on 29 carries and scored a pair of touchdowns. Smith's longest run of the night was a 40-yarder, and he averaged 7.3 yards per carry. Through seven games, he has 824 yards rushing and ten rushing touchdowns.

After the Cadets took a 28-21 lead with 3:44 to go, the Hornets took over and mounted their go-ahead drive.

First, Smith gained 11 yards to get the ball out to the Hornets 38-yard line. Two plays later, Sean Aguilar picked up another first down with a ten-yard run that featured an escape from five would-be tacklers.

Two straight plays for no gain set up a 3rd-and-10. That's when Jacob Newkirk connected with Amos Phillips on a 19-yard completion that gave Gatesville a first down from the Cadets 32-yard line.

Two more runs from Smith set the Hornets up with a 1st down from the Cadets 19-yard line. That's when Newkirk hit Phillips again for the biggest catch of the sophomore Phillips brief varsity career.

Newkirk dropped, looked left, then turned back right and fired to the sideline

where Phillips made a juggling catch over a Connally defender, set his feet to stay in bounds, then dove three yards for a touchdown to make it 28-27 Cadet lead.

Gatesville opted to go for two instead of kicking the PAT and converted when Tookie Jones -a tackle who had lined up eligible - peeled to his left, caught a perfect strike from Newkirk, and waltzed into the end zone for a 29-28 Gatesville lead.

The score by the beloved and charismatic Jones sent the Hornets side of the stadium into hysterics, so much so that their celebration knocked over the cameras providing the feed for the Hornet Radio broadcast. Unfortunately for the Hor-

nets, there was just enough

time left for Sibley - who took a screen pass at the Connally 46-yard line and outraced everyone to the corner pylon for the score and the win as time expired.

The game was tied 14-14 at the half and tied at 21-21 after three quarters, highlighting the evenly matched contest. Connally outgained Gatesville 415 to 335 in the game. Sibley averaged 11.6 yards per touchdown in the game while the rest of the Cadets totaled just 65 yards on their other 20 offensive plays - a 3.25 yard average.

LJ Hall picked up 49 yards rushing in the game, and Brayden Saunders carried five times for 17 yards and a touchdown.

Defensively, the Hornets were led by Lawson Mooney and Sean Aguilar who each had 13 tackles apiece. Each

had eight solo tackles and five assisted tackles.

Phillips had 12, tackles including one for a loss while Dutch Nielsen broke up a pass and had four tackles. Corey Burns had seven tackles and had another sack and is tied for the team lead with Tommy Aaron (seven tackles against Connally) with four sacks on the season. Gatesville has 17.5 sacks so far this season.

The Hornets looked to bounce back on Oct. 13 at home against Salado. Last season, they defeated the Eagles 49-35 in Salado. The Eagles dropped their district opener to Robinson 28-16.

# **Oglesby ISD introduces new mentoring program**

glesby Independent School District is beginning its first year with a new mentoring program, called the Tiger Cub Club. Megan Nichols, school counselor, and Jeb Dixon, athletic director decided it was important for Oglesby ISD to establish a mentoring program for students.

The Tiger Cub Club is a school-wide mentoring program that allows students of all ages to connect in meaningful ways and support student success while building rapport.

Last year, a handful of Oglesby ISD educators collaborated on what it truly

To date, the club has 32 students total including 16 varsity players who are paired with 16 elementary students. "We collaborated with teachers and staff to gather names of students who would be good candidates for this program," Nichols said.

The first meeting was held during the first week of October, where each

mentor and mentee introduced themselves and took some time to get to know each other. The students were put into pairs and given a list of conversation starters to keep the momentum going. "Everyone did great, and the kids were excited to learn about each other," Nichols said.

Being involved with the program comes with many responsibilities for the mentors and mentees. The responsibilities include honesty and integrity, active listening and participation, attendance compliance, maintaining passing grades each grading period, accepting constructive feedback and guidance, sharing knowledge and expertise,

and communicating and learning from others.

"Our older kids get to interact with the little guys and provide a positive role model in the school setting," Nichols said. "We want to enhance self-esteem and self-confidence while improving behavior, both at home and at school."

Nichols and Dixon find ways to incorporate mentors and mentees to hold each other accountable, as it is important in the Tiger Cub Club.

This week a short meeting was held to have each student write a goal for the week. "If they are able to meet those goals, the elementary students will be able to accompany the run-

through with their Tiger at Friday's pep rally," Nichols said. "We were able to see excitement, camaraderie, and unity with our goalsetting this week.'

"Stronger relationships with parents, teachers, and peers are what we are striving towards," Nichols said. "We also hope to improve interpersonal skills all around."

With the number of inquiries, the club hopes to expand as the year continues. "We would love to develop and grow this program to be able to reach all of our Tigers," Nichols said. "We are very excited for this program and where it will go.'

The Oglesby Junior High football team remained undefeated, defeating the Rising Star Wildcats, 31-20. A shout out to the linemen for opening holes for the running backs. Center Logan Ewing and ends Ranger Dalton, Jayce Aarron, and Holdyn Goff continued to be the workhorse for the Tigers. Goff had two carries for touchdown runs of 45 and 55 yards, one PAT, and threw a 35-yard touchdown pass to Evan Williamson and a 15-yard pass to Blayze Fisher. Goff had 141 total yards for the night. Goff had two kick offs, putting one ball in the end zone, and one on the 10-yard line.

Mason Marquez had three carries for a total of 85 yards rushing, including a 50-yard crushing touchdown run, where he carried half the Wildcat players into the end zone. Quarterback Blayze Fisher finished the night hitting two of three passes, including a 15-yard touchdown pass to Evan Williamson. Fisher had a catch for six yards, but twisted and broke several tackles to get his hard-fought yardage. He had several onside kicks, two that the Tigers covered. Evan Williams had two receptions of 35 and 15 yards and two touchdowns, for a total of 50 yards receiving.

# Women's Golf wins Texan Match Play Championship

GLEN ROSE — Tarleton State Women's Golf won the title at Texan Match Play after a narrow 3-1-1 victory in the title bout against Stephen F. Austin after 5-0 sweep of Texas Southern in the first round at the Lakes Course of Squaw Valley Golf Course in Glen Rose, Texas on Monday, Oct. 9.

The match play event featured a Ryder Cup style scoring method with the pairing competing on a per hole basis and the first to win more holes than the other with less holes remaining to play was crowned the victor.

The Texans swept Texas Southern in the first round to advance to the Championship Match against Stephen F. Austin, who was victorious in the first round against Prairie View A&M winning four of the five matches.

For the Purple and White, Mathilde Brogens won her match after just 11 holes leading her opponent by eight with just seven holes left clinching the match in favor of Brogens. Lou Deltombe was the next into the clubhouse playing in the third slot and defeating Shawnise Gregory after 12 holes, carrying a seven-hole lead with just six holes to play. Elle Fox clinched the victory for the

Rodriguez closed out the title also on the 16th hole to give the Texans the third win of the bout and clinch the title. Fox was narrowly defeated on the final hole and Fernandez tied after completing all 18 for the second time on the day. After the conclusion of the final round, Jimenez's Texans were awarded the trophy in a mini presentation. Jimenez thanked Texan Nation for attending the match and announced that Tarleton State was victorious in the first Texan Match Play.

Tarleton State will be back in action in two weeks for the second of three October events starting on Sunday, Oct. 22 at the Little Rock Women's Classic.

STEPHENVILLE — After a strong first half, Tarleton State wasn't able to keep the momentum going and Southern Utah mounted a late comeback to take the United Athletic Conference matchup.

The Texans (4-2, 1-1 UAC) fell 27-26 on Saturday night at Memorial Stadium in Stephenville to the Thunderbirds (2-4, 1-1 UAC). Tarleton led 20-0 at halftime and 26-14 in the fourth quarter, but Southern Utah scored two touchdowns over the final three minutes to steal the win.

SUU QB Justin Miller found an open Targhee Lambson for a 12-yard score with 2:55 left, then safety Trevon Gola-Callard forced a Kayvon Britten fumble, which Josh Lopez returned 23 yards for the go-ahead, and eventual

game-winning, touchdown with 2:29 remaining. Texan QB Victor Gabalis finished 13-of-31 for 152 yards and a touchdown, tossing his score to Jaden Smith from 14 yards out in the first quarter. Britten rushed for 93 yards on 17 carries (5.5 yards per carry) and a touchdown, scoring on an 11-yard scamper to make it 20-0 in the second quarter. Running back Caleb Lewis carried the ball 13 times for 82 yards (6.3 YPG) and his first Texan touchdown, an 8-yard run in the fourth quarter to make it 26-14. Benjamin Omayebu led the receiving group with 44 yards on six catches. Darius Cooper played his first game since the season opener. finishing with three catches and 38 yards.

Defensively, Kasyus Kurns picked off Miller on Southern Utah's first drive of the game that set up Smith's touchdown for the Texans. Kurns also added eight tackles. Patrick Jones and Devin Sterling each led the team with 10 tackles apiece. Kyle Taylor had nine tackles and a sack.

On special teams, Adrian Guzman shined, going 4-for-4 on kicks, 2-of-2 on field goals from 40 and 35 yards out. He also averaged 42.6 yards across five punts, including a 58-yard boot that pinned the Thunderbirds inside the 5-yard line. Deangelo Rosemond had three kickoff returns cover 107 yards, peaking at 51 yards long.

Southern Utah was led by Miller's 34-of-45 passing for 314 yards, three touchdowns and an interception. Aubrey Nellems had a game-high 14 tackles, and the Thunderbirds had three sacks.

This was the third all-time meeting between Tarleton and Southern Utah, all within the last two years. All games have had chaotic endings, with each ending in a onepossession game.

Saturday marked Tarleton's Legends Game as the Texans hosted the 2002-03 men's basketball team to honor them with a special presentation in the second quarter. The coaches from that team performed the coin toss just ahead of kickoff. Also pregame, Tarleton State President Dr. James Hurley and Vice President for Intercollegiate Athletics Lonn Reisman gave a team-autographed ball to head coach Todd Whitten for earning his 100th win with the program last week.

The Texans will play at Eastern Kentucky next, returning to Richmond, Kentucky, where they played two years ago. They'll match up with the Colonels on Saturday, Oct. 14, at 2 p.m. at Roy Kidd Stadium, Eastern Kentucky.

# JoAnn Sugg of CRSP explains **Proposition 9 on ballot**

JoAnn Sugg of CRSP (Culturally Responsive and Sustaining Pedagogy) explains Proposition 9 on the November Ballot.

Proposition 9 on the November ballot will provide a pension increase for retired teachers. JoAnn Sugg, Immediate Past-President of the Coryell Retired School Personnel Chapter, and current President of District 12 Retired Teachers, recently took time to explain the need for passing this proposition.

"First, since the vast majority of school districts in Texas

do not participate in the federal social security system, most retired teachers are not eligible to receive social security."

The annuity they receive from TRS (Teacher's Retirement System) is the only retirement benefit most retired teachers receive.

"Second, no public-school retiree has ever received a COLA (cost of living adjustment) in almost twenty years, so teachers have lost considerable purchasing power due to high inflation, and cost increases. A COLA would provide retired teachers muchneeded relief," Suggs said.


She continued, "Voters need to know that this proposition will NOT create a tax increase. The Texas Legislature had already set aside funds from the state's surplus revenue to make this COLA happen, contingent on voter approval of this amendment."

Proposition A is another proposal that will help education across the state. In an article in the Oct. 7 edition of The Gatesville Messenger, GISD Superintendent, Dr. Barrett Pollard, provided an excellent explanation concerning the proposition.
