

# **Ranger: Man confesses to hit-and-run fatality**

A Weatherford man has confessed to killing a Granbury woman almost seven months after the fatal crash, officials said.

Law authorities tracked down Leonard Clyde Harkness, 57, in Fred, Texas, north of Beaumont. Harkness said he was driving



Rose. Turrey was found dead on the side of Tin Top Highway northwest of Granbury.

Harkness is charged with failure to stop and render aid in accident involving death.

The former local hairdresser was the mother of several grown children, according to her family.

"Investigators have worked hard on this 'who-done-it case' and have put in countless hours investigating multiple leads in the last six months," Rose said.

According to the complaint affidavit prepared by Texas Ranger Danny Briley, investigators collected broken vehicle parts from the area where Turrey was found. Evidence suggested the passenger side headlight was broken during the collision.

"Evidence showed the suspect returned to the scene of the collision after striking Turrey and never rendered aid," Briley

stated.

The pieces belonged to a Dodge 1500 green truck, allowing investigators to narrow their search, he said.

"Harkness also admitted he hid his pickup from authorities in Weatherford, Texas because he believed investigators were

looking for it," Briley stated. The truck, with its headlight already repaired, will be seized for evidence, according to Briley.

"I'm glad to see all the investigators' hard work pay off and hope this helps the victim's family heal from this terrible tragedy," said Sheriff Roger Deeds.

Turrey's sister Bridget King said the family is praying for justice in the courts, but are still saddened by Turrey's absence.

# No love lost Councilwoman's lawsuit threat draws citizens, angry debate

The color scheme for Tuesday night's regular meeting of the Granbury City Council was black, white - and red.

The black and white was clothing worn by family members and supporters of council member Rose Myers in a show of solidarity.

As for the red, well, they were seeing a lot of it – so much so that Mayor Nin Hulett at times admonished the crowd in an effort to maintain decorum.

At one point, when Hulett ordered supporters not to applaud ("Folks, this is not a show," he said), one person loudly clapped again, seemingly in defiance.

Some in the audience were angry at council member Tony Mobly, who had asked that a public discussion take place about Myers' recent threat to sue the city over her daughter's wedding, originally scheduled for the Granbury Resort Confer-





taxpayers," Mobly said Tuesday night in his remarks opening the discussion.


Although the wedding took place more than a month ago, Mobly asked for an agenda item calling for the council to "ratify" the settlement agreement.

That meant that others on the council - Mayor Pro Tem Mickey Parson, Tony Allen and Gary Couch - would have to publicly take a stand either for or against Myers' actions.

Mayor Nin Hulett does not have a vote. In the end, the stand taken by

Parson, Allen and Couch was in support of Myers.

"There's nothing for me to ratify here," Couch said. Then, speaking to Coffman, he said: "You did the right thing. I have no issue with it. None." The journey getting to the vote involved an hour-long discussion peppered with angry outbursts, accusations of playing politics, a possible skewing of facts and a demand by Allen to "call the question," shutting down discussion. In making his case, Mobly elicited information from Coffman and GRCC employee Kristi Kreiling by posing questions to them.

It marks the date nearly 3,000 people died during terrorist attacks in 2001.

"This evening will be set aside as a time of unity and to seek God's continued grace and favor over our community," said Fred Orcutt of the Prayer Task Force. Bagpipes, group singing, scriptures and prayer are planned.

# **MYERS:** *Myers blames dirty politics, says no harm meant*

and indoor reception were not the only events scheduled for the GRCC that day in July.

He said he believes that Myers used the alleged over-booking as justification for cancelling the contract because she was angry that Coffman had accepted the resignation, sent amid of flurry of text messages after hours, of former GRCC Operations Manager Cleo Brown, who is her friend.

The resignation occurred about eight weeks before the wedding.

(Brown confirmed the friendship to the HCN but said that she is friends with other city officials as well.)

Text messages during that time between Myers and Coffman, obtained by the HCN, indicated that Myers was frustrated over that situation.

Mobly said he believes that, by contriving a reason to cancel the contract, Myers not only succeeded in getting a refund of her daughter's deposit, but a settlement that involved \$3,000 paid to another venue, free labor from city employees and items loaned from the GRCC, even though such loans are against policies that Myers helped create and adopt.

Regarding the refunded deposit, Mobly said it violated policy in two aspects.

First, he said, deposits are supposed to be 50 percent of the total rental cost. The deposit paid by Myers' daughter was less than that.

Also, full refunds are not given within a certain time frame prior to the event. Under the scenario with Myers and her daughter, a full deposit refund should not have been given, Mobly said.

In addition, both Mobly and Coffman said that the contract stated that the family would be renting the Lake Granbury Ballroom. If a certain number of hotel rooms are booked as part of the deal, the cost to rent the room is \$1,500.

Myers and her daughter were receiving the room for just \$900, with ancillary items such as chairs, dishes, candles and alcohol included.

Myers and Brown said that only areas five and six of the ballroom were going to be utilized.

Both women have denied any wrongdoing or any intention of Myers or her daughter receiving free goods and services.

One group ended up moving to the Hilton Garden Inn next door. The other group, a family reunion, was to meet upstairs.

The reunion was scheduled to conclude an hour and a half before the wedding, which was to take place under a tree by the lake, just outside the conference center.

According to city officials, it is not uncommon for separate events to take place at the GRCC simultaneously.

In fact, that is desired, since the city's goal is to lease out as much of the conference center's space as possible.

#### WHY GO PUBLIC?

During the discussion in front of a full council chamber, Couch said. "When we choose to debate our differences on the front page of the Hood County News, this is the price we pay.

Several times during the meeting, Allen made angry, derogatory remarks about the newspaper, at least once eliciting applause.

Council members have expressed anger at times about Mobly's communications with the HCN.

Mobly explained on Thursday why he made the decision to go public with Myers' lawsuit threat.

He said that, when the council became aware that there was an issue involving Myers and the conference center, he asked Coffman to inform the council in advance if he intended to approve any concessions.

That didn't happen.

Mobly is angry, but not at Coffman.

He said he feels that Coffman was placed under great pressure to grant the concessions, and that Coffman would have risked Myers' wrath if he had told the council about it.

Mobly also said that, even if the council had agreed during closed session to approve the settlement, a public vote would have been required.

At Tuesday night's meeting, Coffman told the council why he spoke to the HCN about the situation last month.

"As the city manager, I felt it was my job to share the truth with the newspaper," he said. "Some people didn't believe it was the truth. I can't help that. Some people disagree with me. I can't help that.

council meeting, Coffman at one point became emotional. "If we can all at least respect

each other and move down the road, I think we'll be on the right path," he said.

Parson then told Coffman: "This is the story that you told me ... the exact story ... about the heartfelt conviction, about the pain and anguish that people have been caused because of our lack of ability to manage the conference center."

Parson then stated that he wanted "to make sure that people understand" that in conversations between the two of them, Coffman had said "nothing" about a lawsuit "or pressure, or anything like that."

He continued: "There wasn't any threat, any indication, in what you talked about tonight, that you were under some undue pressure because of some potential lawsuit."

Coffman did not respond. Myers, however, spoke next and, in doing so, seemed to confirm the lawsuit threat.

In fact, she never denied it to the HCN when the newspaper first broke the story two weeks ago.

"My effort to protect my daughter was the only time I ever brought up the fact that I would hire an attorney to protect her," she said, referring to her daughter as "this poor little girl."

Mobly said he was "confused" by claims that there had been no lawsuit threat.

"Chris, please tell me you didn't make up that part," Mobly said.

Coffman replied: "No, I did not make that up."

Mobly then said, "Because, most of the times we've talked, you've said that was part of the (settlement) decision process." Coffman responded: "It was a

risk management decision." "And yet the council person

involved just stated that she did make those (threats) to protect her family," Mobly said. "Is that correct?"

"That is correct," Coffman replied.

Apparently referring to Parson, Mobly then commented that statements that had been made on Coffman's "behalf" were "diametrically opposed" to what he had actually said.

#### HUH? PART II

In a phone conversation with the HCN on Thursday, Parson asked whether the newspaper would be amending its reporting as to when Myers made the lawsuit threat.

that there was no indication that the city manager had been put "under duress" and that the lawsuit threat had to do with Open Records requests filed about the wedding.

However, that is not what Coffman said in an interview with the HCN on Tuesday, Aug. 22, nor is it what Mobly claims Coffman told him.

It also contradicts Coffman's statement at the council meeting that his agreement to grant Myers' demands was a "risk management" decision. By definition, anything re-

leased through Open Records is public information.

Mobly said that he requested the documentation from Coffman and that Coffman provided it.

The HCN received documents related to the wedding through an Open Records request.

#### **SMOKING GUN?**

Myers said her family had intended all along to pay for ancillary items such as dishes, cutlery, candles, chairs with sashes, etc., even though Coffman said there were no such details in the GRCC's folder.

With the settlement agreement, they got it all free.

Myers said that she was "just a mother that's just trying to protect her daughter" and that, with the release of "all this dirty information to the Hood County News... you start smelling dirty politics."

Myers is up for re-election in November and has an opponent.

"Our family meant no harm," she said.

Among city documents related to the wedding is an email from Myers' daughter to GRCC employee Kreiling at 10:22 p.m. on Sunday, June 4 – just days after Brown resigned and three days before the HCN published details of Myers' communications with Coffman regarding Brown's departure.

In the email, Myers' daughter listed the details that had been agreed upon "when we worked with Cleo.'

She listed: 100 chairs for the outdoor ceremony; convention center space for the reception: flowers; bar servers and alcohol (red and white wine, Coors Light, Shiner Bock); decor (tables, linens, flower vases, draping, DJ stage, dance floor, two chandeliers, serving ware, Chiavari chairs with sashes, uplighting, Gobo, flicker candles, glass rounds for centerpieces; and a closed boat ramp for privacy during the wedding. In bolded lettering, Myers' daughter stated that the price for those items and services was to be \$900. She also sent the email to her

"Maybe this will give them a little bit of hope to keep going on and not to give up. Maybe it will bring smiles and some joy to those that need it," Barefoot said.


Teaching the students to use their English skills to comfort others has been priceless, Ditto said.



According to Coffman, neither the city manager nor the city attorney has any role in enforcing governance policy or maintaining meeting decorum.

Hulett, who Coffman said Wednesday had left town on vacation, did not respond to a voice mail by press time.

During the council meeting, Mobly stated: "The folks out here and the folks that are watching TV have seen a theme tonight. And that is (that) when I start talking, we call for the question because we want to get this over with.

"I wanted to do a timeline of what's happened here and the incredible pressure that our city manager's been under."

Parson, who holds a different view from Mobly as to when Myers' lawsuit threat occurred, said Thursday that perhaps he and Allen "shouldn't have called for the question" so that

Mobly could have detailed his understanding of the timeline.

On Thursday morning, Allen told the Hood County News that he would answer the newspaper's questions only if the HCN would agree to pose specific questions to Mobly that he said he had not thought to ask during the council meeting and then publish those responses.

When the HCN refused, Allen then failed to answer questions and threatened to sue the newspaper. Despite the HCN informing

Allen that he had possibly violated rules of order during the council meeting, Allen texted this message to a reporter minutes after their phone conversation:

"You can't say that I refuse to answer the question, because I don't know the question."

# Hood County steps up to battle Harvey's devastation with chain saws, generosity

As the first waves of volunteers and relief workers return to Hood County from areas hit hard when Hurricane Harvey made landfall Aug. 25, stories of hardship and personal triumph are coming back with them.

Granbury apartment maintenance manager Brent Merriman traveled to Rockport on Aug. 30 armed with chainsaws, bug spray, food Merriman and water sup-

plies. Close on his heels, Revolver Brewing and the Granbury Chamber of Commerce transported loads of donated water and supplies collected during a marathon day of giving.

"The overall experience is very humbling," Merriman said. "Each and every person I was able to help, and those I also got to meet that didn't need help, I will never forget them."

He spent three days in Rockport assisting in any way he could, he said, and not sleeping as his mind buzzed over everything he had seen.

"My first day I was there, I saw a state trooper on the side of the road. I pulled over and asked if he needed water. He said he needed a chain saw, and I told him I had two," Merriman said.

He and the trooper spent the morning clearing the piles of trees blocking the only two roads in and out of a neighborhood, he said.

The next day, he and six border patrol agents cleared huge, gnarled trunks from 31 driveways, he said. Some the driveways had as many as 30 trees preventing the residents from leaving their homes.

He then volunteered for work crews organized by Operation Blessing, he said.

Carter weights about 175 pounds, and Collier said she is worried she may not be able to do it for much longer.

"It is just getting harder and harder to lift him up," she said and had been looking for a vehicle equipped to mechanically load Carter into the seat.

On Sept. 1, she got a call from Jerry Durant Toyota in Granbury that they had a used vehicle with the right equipment, Collier said.

the finances, it was a crushing blow, Collier said.

A full-time hospice aide raising Carter and his 7-year-old sister on her own, she can't trade in her current vehicle because she owes more on it than it is worth, she said. And the financing agencies will not allow her to take on another vehicle payment even though her credit is good, she explained.

"I was in tears Friday (Aug. 31) when I got turned down," she said. "The van would help me transport Carter more properly. He is only going to get heavier, and my back can only take so much.'

But she is not giving up hope. A friend has started a GoFund-Me account to raise the \$21,000 to buy the van outright, Collier said.

By Thursday, the fund had raised more than \$2,000.





# Palms cast tropical spell

While it may not be the Gulf Coast, this area of Texas has its fair share of waterside living - lakes, rivers, canals, streams and ponds. This prox-

imity to water prompts many homeowners to install tropical-inspired landscapes. Perhaps

no plant sets the mood for waterside living better

than a palm tree. Everything about their appearance, from fronds, which sway and rustle in the wind, to their prominent trunks, casts a tropical spell, especially when combined with complementary landscape and architectural elements.

Fortunately, some palms will endure freezing winters, but buyers beware. Less hardy palms dominate the available selections in many garden centers.

Purchase well-labeled plants from reputable nurseries to ensure hardiness. When planting a palm in fall, be sure to purchase a larger plant with well-developed roots. Late spring/summer is the ideal time to plant new palms. Unlike other plant species, they establish best when the weather is warm.

Know a palm's expected mature size before purchase. It's difficult to trim and prune a very large palm, so choose one that grows no larger than the available space.

Always select a palm that is reliably winter hardy, which sometimes means the trunk survives and the foliage dies. Dead and winter-damaged fronds are unsightly and should be removed. New fronds will emerge from the top of the

trunks. Palms grow best in loose, well-drained soil. They require full sun for symmetrical vertical growth.

In North Central Texas, select a planting site on the south or east side of a structure to best protect the tree from winter winds.

For additional protection, site the palm close to fences, alcoves, walls or other hardscape elements that reflect and hold heat.

Palms like the same high nitrogen fertilizer that is used on lawns, provided it is free of weed-killing additives.

Keep the plant roots moist, especially during winter. You will need to water the tree root area with a hand-held hose for several weeks to get it established.

Also, to protect a palm from harsh winter weather, water its root zone a few days in advance of a hard freeze. Dry plants always suffer more than hydrated plants. In winter, wrap palm trunks in several burlap layers secured with duct tape. Do not use plastic.

The hardiest palm trees for North Texas landscapes include Sabal palm (Sabal palmetto), Texas sabal (Sabal texana or Sabal mexicana), windmill palm (Trachycarpus fortnei) and California fan palm (Washingtonia filifera).







# Texas Edge baseball's new edge is a former MLB pitcher

Granbury's Texas Edge baseball program has had, by any measure, a wildly successful summer.

Three teams - the 8-and-under, 9-and-under and 10-andunder boys - won World Series titles. Another, the 11-and-unders, took second place.

The trophy cases in program director and co-founder Steve Mitchum's office are now nearly to the point of overflowing.

In just six years since its inception in 2011, Edge has morphed into an elite-level training facility that produces consistently high-quality competitive teams.

But Mitchum and the stable of coaches at Edge stress that the

have come off the field.

#### **MAJOR LEAGUE TALENT**

Brian Holman, a former major-league pitcher who spent time with the Montreal Expos and Seattle Mariners, became the newest member of the Edge coaching and training staff on June 1.

Holman was the 16th overall pick in the 1983 draft. After rising through the Expos' organization and a trade to the Mariners, he threw 14 complete games in two and a half seasons with Seattle before an arm injury prematurely ended his playing career at the age of 26.

Since then, he's been coaching and giving lessons, building up 25 years of experience that he'll take to Granbury and to Edge.

He comes from a baseball

But it's not Holman's major league resume that has Mit-

chum excited - or, at least, it's not the most important thing. "We were ready to grow, but we needed someone to guide

us," Mitchum said. "This was a once-in-a-lifetime opportunity. "Brian is just like us. He's not in this for the money ... if he

wanted to, he could be using his name to sell cars or something. "It's not about the money. It's about the kids."

Holman feels the same way, he says. He started looking to move to Texas from Colorado earlier this year to move closer to his daughter, who works at Cook's Children's Hospital in Fort Worth.

His wife came to check out the Edge facilities and was immediately impressed with what sne saw. Sne met with Steve s son Matt, a coach at Edge, and told her husband that the program was exactly what they

were looking for.

"It was very apparent right away that this was a cool place," Holman said. "They care about kids - they want the kids to be good people first and good ballplayers second."

#### **A PERFECT FIT**

It's easy, when talking to both Holman and Mitchum, to see why the former major leaguer fits in well at Edge

Holman, an affable man, talked effusively about his calling to coach and train the next generation of kids. He, Mitchum and the rest of the Edge staff all share the view that their program is unique because it focuses on players before they reach the high school level.

"We're as serious about the 6-13 age group as most are about college prep," Mitchum said. "We focus on the youth probably more than most of all of (other training programs)."

"If we can get kids to the point where they're prepared for high school, they'll stick with the game longer," Holman said. "The emphasis is on fundamentals and life skills."

Holman knows plenty about that. During a rough upbringing in Colorado, he said he turned to baseball as his "safety net" and relied on his high school coaches for guidance.

Once he reached the major leagues, he had several coaches that influenced him, perhaps none more so than former Montreal farm system coach Joe Kerrigan. In addition to Holman, Kerrigan coached Hallof-Famer Randy Johnson in his formative years; Johnson was part of the same trade that sent Holman to the Mariners.

"His philosophy was 'if they do well, that means I make the big leagues too,'" Holman said. That meant taking his pitchers out to dinners, talking to them more about life and personal situations than baseball and forming a real relationship outside of the baseball diamond.

It's these experiences that led Holman to seek a career in coaching and training after his playing career ended.

"It's such a calling to get involved," Holman said. "I want to pass on the knowledge I've learned, and it's a blast to coach kids.'

He'll join a staff of coaches that focus on development first and on-field results second. Having fun, Holman says, is the number one goal.

Still, there's no denying that trophies are a nice motivator to work hard. And at Edge, those trophies can come in bunches.

"What I love about development is that it's not about win-

PUBLIC NOTICE **Brief Explanatory Statements of Proposed Constitutional Amendments Special Election**, November 7, 2017

## Proposition Number 1 (HJR 21)

HJR 21 proposes a constitutional amendment that would permit the Texas legislature to expand the circumstances under which a partially disabled veteran or their spouse may qualify for an exemption from ad valorem taxation of part of the market value of the veteran's residence homestead. Currently, the Texas legislature may provide that a partially disabled veteran or their spouse is entitled to an exemption from ad valorem taxation of a percentage of the market value of the disabled veteran's residence homestead only if the residence homestead was donated to the disabled veteran by a charitable organization at no cost to the veteran. The amendment would allow the Texas legislature to provide that the exemption also may be taken when the residence homestead was donated, sold, or transferred to the disabled veteran by a charitable organization for less than the market value of the residence homestead. The amendment also harmonizes certain related provisions of the Texas Constitution.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of part of the market value of the residence homestead of a partially disabled veteran or the surviving spouse of a partially disabled veteran if the residence homestead was donated to the disabled veteran by a charitable organization for less than the market value of the residence homestead and harmonizing certain related provisions of the Texas Constitution."

#### **Proposition Number 2** (SJR 60)

SJR 60 proposes a constitutional amendment to require that certain conditions be met for the refinancing of a home equity loan to be secured by a voluntary lien on a homestead. The amendment also would: redefine what is excluded in the calculation of the cap on fees associated with a home equity loan, lower the cap from 3% to 2% of the original principal amount of the extension of credit, and specify that such fees are in addition to any bona fide discount points used to buy down the interest rate. The amendment would further specify the list of authorized lenders to make home equity loans, change the threshold for an advance of a home equity line of credit, allow agricultural property owners to acquire home equity loans, and update technical terminology in the Texas Constitution. The amendment would be effective on January 1, 2018, and applicable only to a home equity loan made or refinanced on or after that date.

The proposed amendment would appear on the ballot as follows: The constitutional amendment to establish a lower amount for expenses that can be charged to a borrower and removing certain financing expense limitations for a home equity loan, establishing certain authorized lenders to make a home equity loan, changing certain options for the refinancing of home equity loans, changing the threshold for an advance of a home equity line of credit, and allowing home equity loans on agricultural homesteads."

## Proposition Number 3 (SJR 34)

SJR 34 proposes a constitutional amendment that would prevent certain office holders from serving indefinitely beyond the expiration of their term. Office holders who are appointed by the Governor and confirmed by the Senate and receive no salary would only be able to serve until the last day of the first regular session of the Texas legislature that begins after their term expires.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment limiting the service of certain officeholders appointed by the governor and confirmed by the senate after the expiration of the per-son's term of office."

#### **Proposition Number 4** (SJR 6)

SJR 6 proposes a constitutional amendment that would allow the Texas legislature to require any court that is hearing a challenge to the constitutionality of a state statute to notify the attorney general of that challenge, if the party raising the challenge notifies the court that the party is challenging the constitutionality of such statute. Additionally, the amendment would allow the Texas legislature to set a period of not more than 45 days following the notification to the attorney general that the court must wait before rendering a judgment that a state statute is unconstitutional.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to require a court to provide notice to the attorney general of a challenge to the constitutionality of a state statute and authorizing the legislature to prescribe a waiting period before the court may enter a judgment holding the statute unconstitutional."

## Proposition Number 5 (HJR 100)

HJR 100 proposes a constitutional amendment to provide a more detailed definition of "professional sports team" for purposes of their charitable foundations, which the Texas legislature may permit to hold charitable raffles. The amendment also deletes a requirement that an eligible professional sports team charitable foundation permitted by the Texas legislature to hold charitable raffles had to be in existence on January 1, 2016.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment on professional sports team charitable foundations conducting charitable raffles.'

#### **Proposition Number 6** (SJR 1)

SJR 1 proposes a constitutional amendment that would allow the Texas legislature by general law to provide that a surviving spouse of a first responder who is killed or fatally injured in the line of duty is entitled to receive an exemption from ad valorem taxation from all or part of the market value on the surviving spouse's residence homestead, as long as the surviving spouse has not remarried since the death of the first responder. It would also allow the Texas legislature to provide that the surviving spouse, who qualifies

and receives the exemption and then qualifies a different property as the surviving spouse's residence homestead, receive an exemption from ad valorem taxation of the different homestead in an amount equal to the dollar amount of the exemption of the first homestead for which the exemption was received in the last year in which the surviving spouse received the exemption for that first homestead. Like the initial exemption, this benefit will only remain available if the surviving spouse has not remarried since the death of the first responder. The proposed amendment would apply only to ad valorem taxes imposed for a tax year beginning on or after January 1, 2018.

The proposed amendment would appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of all or part of the market value of the residence homestead of the surviving spouse of a first responder who is killed or fatally injured in the line of duty."

#### **Proposition Number 7** (HJR 37)

HJR 37 proposes a constitutional amendment that would allow the Texas legislature to make an exception to the law regarding the award of certain prizes. Currently, the Tex-as Constitution requires the Texas legislature to pass laws prohibiting lotteries, raffles, and other programs where the award of gifts is based on luck or chance. The proposed amendment would make an exception to this general rule to allow the Texas legislature to authorize credit unions and other financial institutions to institute programs which, in order to encourage savings, would award prizes based on luck or chance to the credit union's or financial institution's customers.

The proposed amendment would appear on the ballot as follows: 'The constitutional amendment relating to legislative authority to permit credit unions and other financial institutions to award prizes by lot to promote savings."

# **Cooling water means** fall turnover

his is a timely topic I usually discuss every year. It just seems to be happening a little early this year. Lake turnover, as most of us know it, is the mixing of the lower layer of the lake with the upper layer of water. In summer, the water is typically separated/stratified, with warmer water above the thermocline and cooler water with depleted oxygen levels that typically cannot sustain life below the thermocline.

As the water surface cools in the fall, the heavier cooler water sinks and the warmer water below rises, which is what we call "lake turnover."

Most folks recognize the initial turnover process due to the rotting debris coming to the surface, so the lake actually "stinks." Eventually, after this initial turnover, the temperature and oxygen levels are essentially the same from the surface to the bottom of the lake.

This gives the fish more room to roam and is probably one of the reasons behind folks saving that fishing is tough during turnover.

Initial turnover in some areas of the lake may actually lower oxygen levels due to rotting debris rising to the surface.

Not all bodies of water have turnover. Small reservoirs and reservoirs subject to lots of wind may not turn over.

The wind may mix the lake all the time, which means the body of water may never get a chance to stratify in the summer.

Our Lake Granbury does stratify, and the initial cooling has started the lake turnover. Turnover continues to occur as long as the surface is cooling.

Fall turnover is a necessary evil, but eventually this leads to better conditions for the fish (cooler water), which signals the change in season. If you head

pending on the day. Water temperatures are still in the low-tomid 80s and will continue to fall with passing cool fronts. Black bass to 6 pounds are

good on soft plastics on main lake points, and some are moving into the back of sloughs early and late. The shad, sunfish are thick in the creeks bringing in the predators.


Keeper stripers were slow to fair on the lower ends this weekend. Crappie fishing reports are getting better. Slabbing for small stripers

and sand bass are good on the lower end, by Indian Harbor and near the shores in 12 to 18 feet of water. Look for schooling fish early and late.

Squaw Creek black bass continue to be best on the north end of the reservoir on soft plastics near structure. Tilapia are in these same areas and are good on worms fished under a cork.

On other reservoirs, Whitney stripers to 15 pounds are possible on live bait and slabs near the Whitney/Towash Creek area and the flats upstream from the Katy Bridge.

# Volleyball roundup: more tough competition for Granbury, CCA wins big

Hood County volleyball teams were in action Tuesday night, and all of them were on the road.

Here's a look at how each one fared.

# When Somervill's not cooking, he's writing

harles Somervill likes to cook ribs. And he always makes extra.

"We buy the ribs when they are on sale," Charles said. "We get the pork back or baby back ribs. They have different names at different stores."

But after awhile, the freezer gets full. There's not room for any more ribs.

And the cooking process begins.

Guests who join the Somervills at their Granbury home for ribs often leave with a bag of leftover ribs for their next meal.

"He first got the rib recipe from the cookbook that came with the grill," recalls his wife, Linda.

But he's changed it up. And still changes the seasoning concoction nearly every time he cooks.

For starters, he doesn't marinate for an hour. "If you do it overnight, the ribs are much more tender," Charles said.

Linda explained they often try fresh herbs from their garden, like oregano and thyme, when changing up the seasonings. "But no mint," she said. "That

just wouldn't be good on ribs." Charles made another discovery when he recently greased

the grill grates with olive oil. It makes a lot of smoke. A whole lot of really black smoke.

"I'm surprised the neighbors didn't call the fire department," he said with a laugh.

Charles retired in 2013 after 53 years as a Presbyterian pastor. In addition to First Presbyterian in Granbury, he ministered in Illinois, Louisiana, New Mexico and in West Texas.

He's written four non-fiction books, including a book about struggles and solutions for

1 to 3 racks of pork baby back ribs, bottled garlic and herb marinade + 2 tablespoons olive oil (1 bottle per rib rack)

Salt, pepper and extra minced garlic to taste Juice of 2 limes Dash of Worcestershire sauce

2. Place ribs in a large pan, season and marinate overnight with the marinade. Turn the meat occasionally.


3. Heat grill to medium, then turn down to indirect medium.

4. Place ribs on grill with curved sides up and cook 1 to 1 ½ hours with the grill closed.

5. Turn ribs over. Cook for 40 minutes to 1 hour with the grill closed.

6. When ribs are nearly done, baste with the barbecue sauce. The sugar in the sauce may burn, so watch closely.

7. Remove ribs from grill and let rest at least 5 minutes before cutting into individual servings.



2 plum tomatoes, chopped 1 cucumber, finely chopped 1 stalk celery, finely chopped 1 jalapeno pepper, seeded and finely chopped

2 teaspoons salt

2 teaspoons ground black pepper 1 ½ cups chilled tomato and clam juice cocktail 1 cup chilled ketchup 1 bunch fresh cilantro – stems discarded and leaves chopped 2 tablespoons hot pepper sauce 2 avocados – peeled, pitted and chopped

#### DIRECTIONS

1. Mix onion with lime juice and tomatoes in a small bowl and let stand for 10 minutes.

2. Meanwhile, toss shrimp, cucumber, celery, jalapeno, salt and black pepper in a bowl to thoroughly combine. 3. Whisk tomato/clam juice cocktail, ketchup, cilantro and hot pepper sauce in a separate bowl.

4. Stir dressing into shrimp mixture along with lime juice and onions.

5. Gently fold in avocados. Alternatively, place avocados in bottom of bowl and spoon cocktail over them just prior to serving.
6. Cover and chill thoroughly, at least one hour.

7. Serve with saltines and a wedge of lime.




