# Mobly seeks ethics code

#### **BY KATHY CRUZ** HOOD COUNTY NEWS

Granbury City Council member Tony Mobly this week emailed the San Antonio attorney drafting guidelines pertaining to official misconduct allegations, requesting that he include language about ethics.

The attorney, Charles Zech, is expected to be back in town for the City Council's regular meeting on Tuesday.

The council tabled his proposed ordinance two weeks ago so that he could incorporate a few changes, but will consider it again Tuesday.

The statute that Zech origi-

nally presented dealt only with unlawful conduct and made no mention of ethical violations.

He indicated, however, that the council has significant leeway in how it handles such matters and that he could adjust the ordinance according to the council's wishes.

In his email to Zech on Tuesday, Mobly asked the lawyer to include language about "legitimate ethics violations.'

Ethical concerns have recently arisen regarding council member Tony Allen. He denies having been the person who phoned Ovilla City Hall claiming to be a Hood County News reporter and threatening to write a negative story about that town's mayor pro tem.

The phone number that Ovilla city officials said appeared on Caller ID matches Allen's.

Another incident involved bed and breakfast owner Tom Baker's claim that Allen had threatened to have city staff inspect his business. Baker said the threat occurred at a break in the Oct. 2 council meeting, where Baker had encouraged the council to take action in the

That realization is what led to Zech's hiring and to a review of the entire city charter.

The Hood County News found that the city of Wylie has a code of ethics and a board to hear complaints.

Mobly forwarded to Zech a policy that the Ovilla City Council adopted in 2012 for handling ethics complaints.

He said that Mayor Nin Hulett and City Manager Chris Coffman support adding ethical violations to the ordinance.

Mobly said he feels that public censure should be the first course of action for ethics violations.

However, should unethical behavior persist, he feels that the council should have the power to remove that person from office, rather than expecting citizens to collect petition signatures for a recall election.

"A recall election can take forever and, meanwhile, the behavior continues," he said.

# Hope takes flight Event to help grieving parents

The death of an infant child doesn't ease with time, Karen Sue Blaize said.

"She is with me daily in my thoughts," she said. "The pain is not something that goes away. You get used to it and functioning with it."

Blaize's daughter Ruby Grace was stillborn at 20 weeks on Nov. 10, 2014. She already had four sons, two biological and two adopted, when she found out she was pregnant.

"Both her conception and her stillbirth were a shock. I had just settled into the idea of being pregnant, and then she was lost," Blaize said.

To help parents like Blaize through their grief, Lake Granbury Medical Center is holding an Angel Baby Butterfly Release from 10 to 11 a.m. today at the hospital.

The event is part of October's Pregnancy and Infant Loss Awareness Month, said Rebekah Butler, director of women's services at the center. Families will

son could you have than the curator and historian at the Alamo?" said Walton, board member of The Bridge Street History Center. "I think it's a real coup to get a guy like that here."

The Alamo resonates with Hood Countians because the widow of its famous hero, Davy Crockett, is buried in Acton Cemetery southeast of Granbury. Elizabeth Crockett moved here after being awarded a land grant following her husband's death. That land. now called Crockett's Bounty, is located in northeast Hood County and will be the site of a private reception Sunday afternoon for the Friends of The Bridge Street History Center.

The Alamo was a fort in San Antonio where a group of Americans made a heroic stand against a much larger Mexican force in 1836. The Mexicans, under General Santa Anna, besieged the Alamo and eventually killed all of the defenders.

A recognized authority on the conflicts involving the U.S., Mexico and Texas, Winders has

# Democrats bringing in lt. gov.'s 2018 opponent

Not to be outdone by Republicans showcasing Lt. Gov. Dan Patrick at their "Make America Great Again" fundraiser next month, Hood County Democrats are bringing in his 2018 opponent.

Democrat Mike Collier will be the guest speaker at the Hood County Democratic Club's monthly meeting Thursday night.

The group typically meets in the meeting room at county Annex I, but this gathering will take place at the DeCordova Bend Country Club.

The meeting will begin at 7 p.m., and will be free and open to the public.

drinks will be provided. Collier, a CPA and former chief financial officer for a Texas oil company, is a Collier former top aide

to the chairman of PricewaterhouseCoopers. He will speak about property taxes and school funding.

"When the local Republicans present Dan Goeb Patrick at a \$150 a plate fundraiser in De-Cordova in a few weeks, they will avoid talking about your property tax bill," Democratic Party chair Robert Vick said. "They will talk about their misguided agenda on vouchers, bathrooms and sanctuary cities.

"They won't tell you how their actions forced your property

taxes to increase, but we will if you join us on the 19th."

Patrick's appearance is scheduled for Thursday, Nov. 2, also at the DeCordova Country Club.

"Rather than fund 60 percent of the cost of public education, as Texas once did, Republicans led by Dan Patrick have reduced support to less than 40 percent," Vick said.

"This unwise effort has not resulted in better schools. It has resulted in higher property taxes as school districts struggle to keep up. This is a discussion we must have.'

Vick added that the Republican-controlled "Legislature has "deliberately shifted the burden of funding public education onto the backs of homeowners.

# Walton to seek one more term as district judge

355th District Judge Ralph Walton will be running for one more term before he retires.

The district judge position will be on the November 2018 ballot.

The filing period for the March 6, 2018 primary will be from Nov. 11 through Dec. 11.

Walton, a Republican, has served on the bench for more than 20 years.

He and his wife Patsy have lived in Hood County since 1974.

Walton is a graduate of Baylor University and the Baylor School of Law. He is board

certified in criminal law by the Texas Board of Legal Specialization and is a 2007 graduate of the Texas College for Judicial Studies.

"It has been my pleasure to live and work in Hood County for over 40 years, and I have especially enjoyed my years of service to the people of Hood County as district judge," Walton said in announcing his reelection bid.

Walton's announcement came shortly after county Court-at-Law Judge Vincent Messina announced that he, too, will be seeking another term.



**ON STAGE: Granbury Theatre Com**pany will perform "Arsenic and Old Lace" Oct. 20 - Nov. 5.

Leading Granbury Theatre Company's coming show has been a bit of déjà vu for director Luke Hunt.

His first memories of "Arsenic and Old Lace" are 40 years old, back when his mother checked out a radio play cassette from the San Bernardino public library.

"I distinctly remember my third-grade self loving the show and all of its quirks," Hunt said.

He even used stuffed animals from his grandparents' house to stage the play, providing all of the voices on his own.

"So, in a way, 'Arsenic and Old Lace' was the first show I ever directed," he said.

He went on to become a theater arts teacher at Alvarado High School and had directed previous GTC performances.

Now, he has returned to his early love and is directing the Granbury Theatre Company's presentation of "Arsenic and Old Lace" that will run Oct. 20 - Nov. 5 at the Granbury Opera House as part of the Broadway on the Brazos season.

Directing real actors is much more satisfying than the stuffed ones of years gone by, Hall said, because of the passion and creativity the actors bring to their roles.

"I would like to take this opportunity to thank the cast for bringing a vision to the stage that has existed since I was 8," he said. "And I would like to thank the production team at Granbury Theatre Company for allowing my directing journey

to come full circle." "Arsenic and Old Lace" is a

comedy by Joseph Kesselring. The story follows Mortimer Brewster's struggle to remain sane when he discovers the delusional diggings of his brother are nothing compared to the murderous actions of his aunts and second brother.

Cast members include Matt Beutner as Mortimer Brewster with Tonya Laree and Drenda Lewis featured as his aunts, Abby and Margaret Brewster.

A member of the original company operating the Opera House in the 1970s, Lewis returns to the stage after primarily working in the costume shop.



or far too long, city officials throughout Texas have operated under no official ethical guidelines.

It is high time that changed. Not everyone, after all, has a personal moral code of conduct.

Although a few Texas cities have adopted ethics policies in recent years, most, including Granbury, have nothing on the books.

This is disturbing, especially considering that most professions have ethical standards and employees who violate them are shown the door.

The way it is now, no elected official - no matter how outrageously unethical his or her behavior - will ever be held accountable.

There are challenges associated with creating ethical policies for elected officials, and there could be political consequences for those who take a stand against another.

But doing so when it is warranted might result in the public having more faith in its city leaders. It is unfortunate that, the way it

stands now, a citizen would have to head up a cumbersome recall effort, collecting the required number of petition signatures and possibly subjecting themselves to threats or bullying from the person they are attempting to remove from office.

How likely is it that a citizen will be willing to do that? With no policy in place to give power to the City Council, the guilty official is free to continue the unseemly behavior.

Most cases of ethical violations wouldn't result in a recall election, but rather a public hearing and possible public censure.

Censure is a slap on the hand, but most people who undergo such a process likely would not be eager to repeat it. Hopefully, therefore, their behavior would change.

If the behavior didn't change and more public hearings were held, maybe the official would resign due to pressure from a fed-up public. This would spare the community an expensive and time-consuming recall election.

The City Council is paying thousands in legal fees to an expert to help them create an ordinance pertaining to official misconduct. Right now, it makes no mention of unethical behavior.

In order for the attorney to create ethical guidelines, he must been given that instruction from the collective council.

In light of embarrassing allegations that have recently come to light against one council member, it is clear that measures are in order.

But any policy pertaining to ethics should be clearly detailed and should serve as an umbrella covering any and all types of unbecoming behavior that goes against the best interests of the city.

Maybe the City Council can bring some good from the recent embarrassments by creating an ethical code and public hearing procedure that could serve as an example to other Texas cities.

Wouldn't we much rather be known for that than for having a council member whose behavior is an embarrassment?








# **Christopher Aaron Young**



# **Deaver, Morgan lead** a fired-up Tolar team

Tolar began this season with a new head coach in Jeremy Mullins, a new offensive scheme and a new starting guarterback that hadn't played the position since junior high.

Not that it mattered, of course.

The Rattlers' offense has been clicking just fine this season, led by senior quarterback Bryan Morgan and his favorite target, wide receiver Clayton Deaver.

Tolar is averaging 29.2 points per game through the non-district schedule. In their wins, the Rattlers score at a rate of 42.6 points per game.

That's not bad for a roster full of players who have had to learn a whole new offensive language and system.

"We were like, 'What is happening?'" Deaver said about the first few practices in the offseason.

Because everyone was back to square one with this offense, Morgan suddenly found himself on equal footing with the rest of the potential quarterbacks. Even though he had played wide receiver the season before, he had "the same starting point as everyone else" coming into this season.

"He's been huge," Mullins said of his quarterback. "He's not where he wants to be, but he's certainly done better with managing the game and understanding his role."

Having one of the best receivers in the district to throw to in Deaver hasn't hurt, either.

"He's one of those kids that's a good athlete, and then he just has a good knack for the game,' Mullins said. "He does it on every phase."

"It doesn't matter if he can beat his man or not," Morgan

said. "When all else fails, I can throw it to him."

Morgan and Deaver have played together since they were in the third grade. The two have the type of connection on the field that allows Deaver to sense where his QB is scrambling to and come back to make a catch. In fact, they were lighting up defenses in middle school, too.

Deaver said they were a "dynamic duo" even back then. "We kind of knew what was

coming this season," he said. The two have connected on 36 passes for 596 yards and nine touchdowns. That's an average of 119 yards per game and 18.6

yards per completion. Still, Deaver swears they don't worry about stats.

"As long as we score, that's what matters," he said.

#### **PROVING THEM WRONG**

Coach Mullins has often talked this season about how his players show up every day ready to work, with a determination that almost took him by surprise.

Even the players recognize that there's a very positive spirit around this team.

"It's different than anything we've ever had here," Morgan said. "More motivation, more drive to do better."

According to Morgan and Deaver, that stems from a desire to show some doubters that the Rattlers are the real deal.

"There was a lot of speculation, and I feel like we've done a lot better than people thought,' Morgan said.

"I want to prove people wrong," Deaver said. "People have been telling me even before the season, 'Oh yeah, y'all aren't gonna have line, y'all aren't gonna have a passing game or a run game.'

"That kind of motivates me to

When the fish really get going, you can catch two at a time. If the fish are feeding on smaller baits, then the crappie jig may catch more fish.



species with a slab, especially now.

A slab is piece of solid-painted lead or heavy metal shaped typically in an oval or willow leaf form to mimic the look of a baitfish.

When the water falls into the 60s and 70s and the fish congregate on the bottom on feeding flats and humps, the slab is deadly.

Look for bait and fish positioned on or near the bottom on your sonar graph. It may appear as a "ball" of bait with fish arches around and above it.

There are a variety of jigging methods. Some will drop the bait, reel it up through the fish and let it fall again to let the fish hit it on the fall.

My favorite jigging routine is to bounce the bait off the bottom. but don't be fixated with one method. Try different jig-

strike.

Other times dead sticking the slab (no movement) while drifting through the fish is deadly. The slight flutter of the slab may be enough to draw the strike.

Sometimes it is prudent to jig the bait several times and then hold it steady for a few seconds. The predator watching your bait may decide to take it when it pauses.
