## Ribbon-cutting held for newly renovated county courthouse

A ribbon-cutting ceremony was held for the newly renovated county courthouse in downtown Kirksville on Saturday, July 15. Presiding Commissioner Mark Shahan welcomed the audience to the venue followed by a presentation on the history of the building by Blytha Ellis, president of the Adair County Historical Society.

Visitors to the courthouse were allowed to tour the building with some of the offices open and providing information about the building to them. After the ribbon cutting, cakes decorated with a picture of the courthouse in the center were served to guests.

Features of the courthouse renovation include new slate composite roof tiles that replaced five layers of asphalt shingles; historically accurate windows, doors and mortar that replaced the old models; modern plumbing, fixtures and floors installed as well as woodwork and lighting restored throughout the building. Commissioners also had the 124-year-old flooring restored.

According to a flier promoting the day's events, the Adair County Courthouse is a historic structure that was experiencing interior and exterior damage/deterioration issues that included plaster cracking, floor damage,





cracked stones, missing mortar, discolored stones, inadequate patching and bat infestation, issues that needed immediate attention when county voters approved a 1/4-cent sales tax to fund the upgrades in 2021.

Building repairs included tuck pointing, cleaning, sealing and caulking around the windows; a new HVAC system that replaced window AC units that were inadequate and damaging the building with leaking condensation; a new









roof, new premium ice and water shield, gutter apron, ridge caps and flashing. Damaged boards were also replaced and extensive plumbing upgrades were made to include sensor faucets and high efficiency toilets. Plaster and ceiling repairs were made throughout the courthouse and modern resilient flooring was included with the extensive repair of the the historic floors.

The courthouse is located at 100 W. Washington Street in Kirksville.

## Cornerstone rededication ceremony held by Freemasons at county courthouse







#### NEMO Drug-Free Communities Taskforce takes steps to raise awareness about underage drinking

The NEMO Drug-Free Communities Taskforce is working to raise awareness about the dangers of underage alcohol consumption and what people can do to help reduce it. The Taskforce is taking advantage of the number of teens and adults who attend the NEMO Fair in Kirksville to spread the word about how to "Summer Responsibly."

"We hope to raise awareness about underage drinking in our community by reminding teens in this area that we care about them and want the best future possible for them," said April Dobrinske, NEMO Drug-Free Communities program director.

The Taskforce works to reduce youth alcohol, marijuana, and prescription drug use in Adair and surrounding counties. This week, members of the Taskforce will be getting the word out using banners and signs placed throughout the NEMO Fairgrounds, including at the gates, show barns and campground.

Dobrinske cites compelling data gathered by the Missouri Student Survey, collected during even-numbered years by the Missouri Department of **Elementary and Secondary Education** (DESE) and the Missouri Department of Mental Health. The data point to high incidence rates of underage drinking in Adair, Schuyler, Knox, Sullivan, and Macon counties.

According to the survey, 50.8 percent of students say it is "easy" or "sort of easy" to obtain alcohol. Moreover, 57.6 percent say they have obtained alcohol from a friend or family member. Research shows the earlier the more likely they are to become addicted. The goal of "Summer Responsibly" is to encourage community members and parents to do their part by not providing alcohol or other substances to minors.

Dobrinske said Taskforce efforts will continue into the fall with an "alcohol sticker shock campaign" when students return to area schools.

These projects are funded by the Missouri Department of Mental Health and Preferred Family Healthcare. The BUILD grant project, while separate, is dependent on the schedule and timeline of the reservoir project.



As part of the BUILD grant, transportation improvements are also planned in the next two years at the intersection of Sullivan County Routes N



#### Mozeliak says change is coming for Cardinals

ST. LOUIS — Change is coming to the St. Louis Cardinals, according to President of Baseball Operations John Mozeliak, a sign the underperforming team may deal veterans for prospects ahead of the Aug. 1 trade deadline.

St. Louis started Monday last in the NL Central at 40-53, on track for its first losing record since 2007.

"Usually when you're having a year like this, it's more than one thing that went wrong," Mozeliak said. before a game against Miami. "I feel like where this club's at right now, we just know it's not working intact. We do know we have to make some changes.

"If we can find talent that we think can help emerge in 2024, that'd be great," Mozeliak added. "2025? I wouldn't rule that out either. But 2026 seems a long way away."

"I don't think this is going to happen overnight," Mozeliak added. "Change is good if it helps you. We're not so stubborn or arrogant to say we're going to keep doing our system and hoping for a better outcome. We understand there's been a shift and we're going to try to adjust to it. We're going to take a hard look at ourselves."

Among starting pitchers. Miles Mikolas is under contract for 2024. Jack Flaherty and Jordan Montgomery are eligible to become free agents and Adam Wainwright plans to retire after this season,

"Pitching, pitching and pitching" is the theme of the deadline and during free agency for the Cardinals, Mozeliak said.

"We do like the collection of hitters we have," Moze-

liak said. Paul Goldschmidt and Nolan Arenado, who have notrade provisions, are likely

"I don't have any intentions of trading anybody like them," Mozeliak said.

St. Louis wants to obtain pitchers that cause "swing and miss.

"I think the process we have in place can be tweaked," Mozeliak said. "I don't think we need to re-do it. You are who you are. We've been really good defensively and we understood how to shift. Having pitchers put the ball on the ground was something we benefited from."

St. Louis signed 35-yearold right-hander Ryan Tepera. The 11-year veteran has a 19-20 record and a 3.59 ERA in 371 major league games, all but one in relief.

Tepera was 2-2 with a 7.27 ERA in 10 relief appearances this season for the Los Angeles Angels, then was released in May. He made nine minor league appearances for Texas, then was released Friday.
