## Kirksville police make arrest after suspect attempts to flee traffic stop

A 48-year-old Glenwood man is in custody after attempting to flee from a traffic stop. At approximately 1:52 a.m. on Wednesday, May 29, a Kirksville police officer initiated a traffic stop on a vehicle driven by Kevin Anders near North Centennial and West Cottonwood streets.

This attempted stop was for multiple traffic violations. The vehicle

didn't stop and fled northwest out of the city. The officer continued to follow the vehicle until it came to a stop near Missouri Route B and Stokes Road. The occupants then fled on foot but were apprehended by the Kirksville police officer and an Adair County Sheriff's deputy.

The driver, Anders, has been charged in Adair County court with one count of resisting/interfering with an arrest for a felony and two counts of possession of

a controlled substance related to this event. K9 Erno was deployed on the vehicle at the scene and suspected narcotics were located in the vehicle. Anders also had active arrest warrants from Adair County and Schuyler County for forgery and possession of a controlled substance.

The other occupant has not been charged at this time. The Kirksville Police Department was assisted by the Adair County Sheriff's Department.

She is in the marching band at Schuyler R1 as a percussionist. Hannah plays the drums and does an awesome job with them."

O'Dell said, "Hannah does well in educating her peers about the deaf community, cochlear implants, and other assistive technology related to her disability needs. She is quick to ask for assistance, reminds others when to use assistive technology, and overall goes above and beyond in her day-to-day life. She takes a strong leadership role in group activities, but

also takes the time to help others. Her school-based supports are always impressed with her strong work ethic and accomplishments. Hannah hopes to apply for an excelled program educationally. Overall, I'm excited to see what the future holds for Hannah."

Raven Weaver with the Schuyler R-1 School District added, "Hannah started receiving services

from Schuyler R-1 School district when she turned three years of age. She has had the same team working for her as well as working with her team of doctors from Columbia. Hannah has been such a joy to watch grow over the years. I think most teachers would say they learned as much from Hannah as Hannah learned from them. She has had an amazing support team along the way including her mother Carrie, therapist, teachers, and her friends."

## Harden appointed as parks and recreation director, Callaghan as assistant director

The city of Kirksville announced that Robin Harden has been appointed as the city's parks and recreation director, and Luke Callaghan as the assistant parks and recreation director.

## 2023 Missouri Beef Queen's platform raises awareness of the mental health of farmers

Those engaged in agriculture are united by a common love of the land, animals and lifestyle. Yet, something unique sets each youth in agriculture apart from their peers. What makes Emma Harvey unique is her patriotic spirit that established her passion as an advocate for farmers' mental health. Harvey is committed to using each platform she earns as an opportunity to raise awareness for agriculture's most vulnerable.

Harvey was born at Camp LeJune while her father was serving as a Marine officer. At a young age she came "home" to northeast Missouri to grow up on the family farm. Her firsthand perspective on mental health has developed from watching her veteran dad experience the effects of PTSD (Post-Traumatic Stress Disorder).

"I have a personal connection to the importance of farmers' mental health," Harvey shared. "Farmers

go through tons of stress. Since farming is a male dominated occupation, it often gets overlooked because many people don't recognize it or may view the stress as weakness. There has been a lack of communication in agriculture that has caused farmer suicide to be overlooked. It really hits home for me."

Harvey translates her sympathy and patriotism into service. As a proficient trumpet player, Harvey plays "Taps" for Memorial Day and Veteran's Day celebrations and is frequently invited by the local VFW to present "Taps" at military funerals.

It is hard to tell, but Harvey was a shy freshman when she joined Missouri FFA. "I attended FFA camp that first summer and my FFA advisor made me participate in a speech contest," Harvey said. "It was the gateway to all I have accomplished. I thank my advisor, Waltedda Blessing, for making me put my foot in the 'public speaking door.'"

Harvey has utilized platforms with confidence throughout her high school career to share her meaningful message about farmer suicide awareness.

"Today I am so outgoing it is almost embarrassing," she said with a laugh.

Harvey enjoys helping her father and grandparents on the family farm with their South Devon and Simmental beef cattle, so it wasn't unreasonable when her best friend Elsie encouraged her to apply to become the 2023 Missouri Beef Queen. Harvey was intimidated as the young-

est competitor in the contest against experienced peers. She was excited to communicate her willingness to learn through her interview and she shared her heart for addressing farmer suicide and mental health during her speech. During her 2023 reign, Harvey worked alongside the Missouri Cattlemen's Association, met Governor Mike Parson, Lt. Governor Mike Kehoe, numerous legislators, and traveled across the state meeting people of all ages.

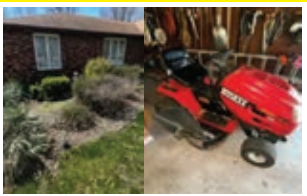

Simple playground game remembered

In second grade, my school playground was a blacktopped rectangle behind the building. We had swing sets and see saws and horizontal bars. There was a metal slide whose surface heat on sunny days seared our bare legs on the way down.

But the best fun at recess was along the edges of the slightly sticky, blacktopped surface of the playground. A slight ditch ran along the perimeter; it was generally a dry, craggy area that grew little more than scrubby saplings.

If you were among the first to get to the playground, you headed for the ditch and plopped down onto the clumpy dirt. You staked your claim to just the right place and waited for your friends.

Sneakers slapped their way to you; soon you had your group of three or four. It was always the same girls in each group, and to be included was a sign of social acceptance as important as being saved a seat on the bus.

It was time to play jacks. We sat with our dresses folded under our legs, bodies swiveled toward the edge of the blacktop, and propped our elbows on the natural shelf that was just the right height for the game. Every girl I knew had a set of jacks. We stowed them away in

our lunchboxes, and there they were, convenient for play, right after lunch. They were easy to carry in their thin cotton pouch with its drawstring top. Ten metal stars jangled inside the pouch, crowded together by the gummy, red, rubber ball that was included.

Slender, nail-bitten fingers tugged the drawstring top apart, and the jacks tumbled from the pouch. If yours were new, they could be red or gold or blue. But most of the time, the paint had been played off our sets, and the metal was a dull silver that matched the chains on the creaky swings across the playground.

Then, the ball bounced out. If you had the “good” set of jacks, your ball was a solid sphere of dark, tomato-y red. It was super bouncy and felt just right in your palm. Unfortunately, if a mom bought a set of jacks without counsel, the ball included had a high, raised line around the circumference from its molding at the factory.

These cheap balls were never used, because every girl knew you couldn’t get a precise bounce from them. Nothing ruined a game of jacks more than having a ball land on its little line and career across the playground.

The rules were simple: scatter the jacks along the ground, throw the ball upward, pick up a

jack, watch the ball bounce, and catch the ball...all in the same hand. We started with onesies. Then, twosies. By the end of the first round, we needed to pick all ten jacks in one sweeping swoop and grab that ball.

The rounds had varied themes with whimsical names. Double Bounce, Pigs in the Pen, Eggs in the Basket...even Over the Fence. Your turn ended if you missed the ball or picked up the wrong number of jacks or moved the remaining jacks on the ground during your pick up.

Our hands swept along the pavement and our fingers scraped patterns against the rough surface. The edges of our palms grew tough and slightly discolored from rubbing across the blacktop as we grabbed those jacks, and we carried our rough skin there like status scars.

When the recess bell rang, we gathered up the scattered jacks, scrambled up from the ditch, and dusted off our skirts. There was seldom a winner, because the game never seemed to end.

We’d start fresh tomorrow, at recess, playing jacks and growing memories.

Two years later, when it was our middle son Jack’s turn, we were so thrilled for a normal school year and a traditional graduation that we didn’t have time for tears. When he moved all the way to Michigan for college three months later, I cried my head off. But on the long drive back home, I took comfort in knowing we’d have Kate at home for two more years.

Then I blinked — once, maybe twice. And suddenly there we were, standing in a parking lot helping her and an 80-pound Goldendoodle get zipped up in their graduation gowns. They disappeared into a royal blue sea of classmates, and Tom and I joined the throngs of other parents lining up to get seats.

This third time around, when Pomp & Circumstance played over the arena’s speakers, the full emotional force of three different high school graduations washed over me. It’s so strange to feel these strong, conflicting emotions at the same time. I’m elated to ride this wave of joy and pride for our kids’ growth and accomplishments, yet I feel the rip current of a new reality as it pulls them away from home.

This milestone is natural and good and everything we wished for, but it still leaves me standing on the shore feeling gut-punched by how much I’ll miss this part of our life.

The good news is that all three kids are home for the summer, working part-time jobs and raiding the fridge and pantry like old times. In the fall, they’ll all move out for college. Thankfully, Kate and her dog are moving to a university only 30 minutes away. I can already picture myself driving to campus for quick visits, hoping it’ll take the edge off the withdrawal symptoms of an empty nest.

And who knows? Maybe Tom and I will find new adventures while the grown-up kids are out enjoying their own. We’ll figure it out as we go along, like millions of parents before us. We’re so grateful for these graduates and stunned by how quickly they’ve gone from diapers to diplomas.

To all our fellow parents in the day-to-day trenches of raising good humans, enjoy the ride. Sometimes it’s hard, and sometimes it’s happy, but it’s always so very worth it.

This Week in Local History

100 Years Ago, June 1, 1924

S. M. Pickler, long time Kirksville resident, early graduate of the Normal School, and former member of the Missouri State Legislature, announced his donation \$25,000 to the Kirksville State Teachers College (KSTC, now Truman State University) to assist with the building of a new library on the college campus. In addition to being a graduate of the old Normal School, Pickler had been on the faculty there for many years. After the fire which destroyed Baldwin and Library halls in January 1924, Pickler decided to aid in the construction of a new fireproof library building. At a meeting of the Board of Regents of the college he formally tendered the donation for the library, and the board accepted. Although no stipulation was made as to Pickler's name being placed on the library, the Board of Regents decided that it should be called Pickler Memorial Library.

100 Years Ago, June 2, 1924

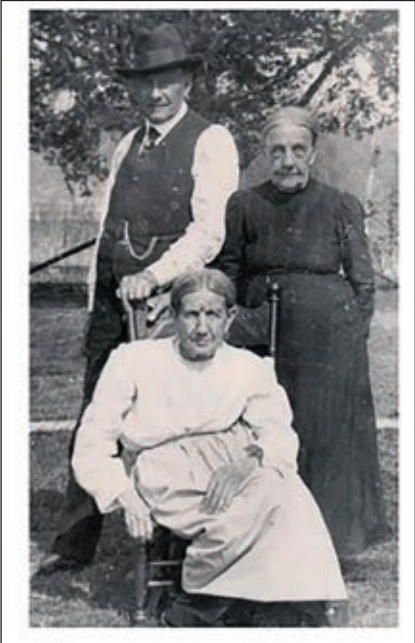
Kirksville's baggage handlers at the local railroad depots were exceptionally busy with the influx of summer school students arriving in the city by railcars. Local baggage men at the Wabash rail station handled over 400 trunks in one night. During the day the rush was more pronounced with rail cars filled with the belongings of students arriving by train. At the O. K. depot, the same situation was unfolding. The morning train brought in 74 trunks and with the afternoon train came 30 more. This was in addition to all the smaller pieces of baggage. More baggage cars were being added by the railroads to accommodate the additional loads of baggage.

100 Years Ago, June 3, 1924

A vagabond, James Houser, unknown to Kirksville residents, arrived in town and because of his appealing personality, manner, and conduct, soon made numerous acquaintances with people in town. One night he was invited by a Kirksville resident, Eddie Sloop of South Stanford Street, to spend the night at Sloop's home. Sloop, an employee of the Coffee Shop had to arise early to go to work. The following morning Sloop got up and found the man still sleeping. After attempting unsuccessfully to wake him, Sloop decided to let him sleep. Later that day Adair County Sheriff Waddill and Chief of Police Willis apprehended Houser in La Plata. He had been seen in Millard and recognized as the drifter who had befriended people in Kirksville. Houser was wearing three shirts and a suit and was carrying a bundle of clothes under his arm that he had stolen from Sloop, the unsuspecting good Samaritan.

100 Years Ago, June 6, 1924

John W. Tinsman, 69, artist, legislator, and resident of Adair County for 69 years died at his home six miles west of Kirksville. Tinsman was well known in this part of the state, and his art studio, Idylwild, had been visited by hundreds of people. Tinsman was born in Pennsylvania in 1842 and came to Adair County in 1855 with his mother and four siblings. He served two terms as mayor of Kirksville and one term as the county's representative in the state legislature. In his personal reflections of Adair County prior to 1860, Tinsman wrote the following; "The first work I done (sic) the summer of 1855 was to drive three yoke of oxen to brake (sic) 40 acres of groun (sic) which later consisted of the Wilson Addition of Kirksville. I was 13 years old and have lived to see it all built up." He recalled that when the family arrived in Kirksville, dog fennel was growing in the streets around the courthouse, and the mail was delivered by stagecoach. He wrote: "As far as the eye could reach (the county) was one vast sea of moving prairie grass with here and there a cabin." In the fall of the year prairie fires were

numerous and "there was scarcely an evening but the horison (sic) was iluminated (sic) by fires." Tinsman was engaged in milling on the Chariton River until the mid-1870s when he turned to his passion for art. He spent time in Paris studying art and toured the cities of Italy. He turned his talent into a business and began painting photographic scenes. Most of his art work was accomplished at his art studio, Idylwild, overlooking the Chariton River near Sloan's Point. He served in the Union Army during the Civil War and was honorably discharged in 1865. In 1866 he married Eudora Panabaker and their union produced four children.

85 Years Ago, June 8, 1939

Mose Jackson, 95, who spent the first sixteen years of his life in slavery, died at his home in Kirksville. He was born May 10, 1844, in Howard County, Missouri of parents who were slaves of Pryor Jackson of near Fayette. He remained a willing servant of his master after the slaves were emancipated. For many years Mose was a mortar mixer on construction projects in Kirksville and other locations throughout the state. He was survived by his wife, Lucy, and seven of his fourteen children. Jackson said that his slave days were "the happiest of my life."

80 Years Ago, June 5, 1944

Mrs. Karl Webb, executive secretary for the Red Cross in Adair County, made a special plea for blood donors and cars to go to Hannibal June 19 where a Red Cross Mobile Blood Donor unit would be located for collection of blood to be used in the war effort. Mrs. Webb said that she realized it was a sacrifice to give up a day of one's time and blood to make the donation, but she pointed out that this was but a puny sacrifice compared to what American boys were being asked to do. World War II was in its final phase, and the United States Armed Forces were preparing for what would be the largest tactical military movement in history, D-Day, with the invasion of Normandy, France and the liberation of Europe from Nazi control. Military commanders anticipated that casualties would be staggering and thus made the special appeal for blood by citizen donors.

50 Years Ago, June 4, 1974

The Missouri State Highway Commission gave approval for improving about eleven miles of U.S. Route 63 at Kirksville. The new improvement would involve relocation of the highway from the Baltimore Street location to just east of the city—a bypass around Kirksville. The plan called for development of a section of highway from about one mile north of Kirksville south to approximately one mile south of Route KK near Millard. Also included would be four interchanges, a railroad grade separation, and a grade separation for a county road. The highway commission's approval of the relocation of Highway 63 permitted the Highway Department to proceed with the development plan. Public hearings were to be held before final approval was given to allow residents to express their views regarding the design of the project. Numerous modifications to the plan were implemented before the project became a reality.

The Captain Harris Mansion — Chapter 10- The Murdock Family

By 1936, Dr. Bert Byrd Parrish was living alone in the Capt. Harris mansion. His parents and his wife were deceased. He had moved his Kirksville medical office to his home. Around this time, he hired a housekeeper who also assisted him in his medical practice. She was Everella (Childers) Murdock (1887-1975).

Everella was the daughter of a distinguished lawyer in Sullivan County, Mo., named William Hezekiah "Hez" Childers (1857-1928). He practiced law in Milan, Mo., for 40 years. For a time, he was in practice with his brother, Joseph W. Childers, in Milan. Hez was also interested in history and was instrumental in the compilation of the 1895 book, "History of Sullivan County."

Everella was Hez's only child, and her mother died when she was only 3 months old. In 1913, Everella married James Manford Murdock (1877- 1931), a farmer in Sullivan County. They had two children, James Manford Murdock, Jr. (1914-1981) and Mary Childers Murdock (1915-2003). In the spring of 1922, Everella filed for divorce. She moved to Kirksville in 1930 to attend Northeast Missouri State Teachers College and received her teaching certificate. She then taught in rural schools in Sullivan and Adair Counties. On December 5, 1931, Everella's ex-husband, James Manford Murdock, Sr., died at the age of 54.

When Everella Murdock went to work as a housekeeper and nurse/attendant for Dr. Bert Parrish in Kirksville, she and her two children also rented part of the Parrish house. At age 23, son, James, Jr., married Josephine Cook in Kirksville on November 5, 1937, and established his own home. They had a son born in 1939 also named James. Later, they would move to California for a time.

Everella's daughter, Mary, graduated from Kirksville High School in 1933 during the Great Depression. She became a telephone operator in Kirksville for Southwestern Bell when she was approximately 19 years old. After the U.S. became involved in World War II in December 1941, an urgent need developed for telephone operators in Washington, D.C. A temporary transfer of operators from other locations to Washington, D.C. was arranged by the telephone company. Two operators from Kirksville were chosen for transfer. They were Mrs. Alpha Smith, who had been with the telephone company for 15 years, and Miss Mary Murdock who had worked at Southwestern Bell for eight years. Their assignment was to be "for the duration of the war." A patri-

otic farewell luncheon and party was given for them by their local co-workers. They left Kirksville on March 22, 1942. Mary's entire life was about to change forever.

While working in the nation's capital, Mary met a young Navy lieutenant named George Edward Slone from Marion, Indiana. George was the son of restaurant owners George Emer Slone (1889-1958) and Gladys (Lee) Slone (1891-1962). After graduating from high school in Alexandria, Indiana, George went to Purdue University and was then appointed to attend the U.S. Naval Academy at Annapolis, Maryland. He graduated from there as a lieutenant with the Class of 1941.

With the onset of World War II, George was assigned to a U.S. destroyer in the Atlantic Ocean. Upon the completion of this 18-month tour of duty, George was transferred to the Naval Air Corps at his request and assigned to the Naval Air Base at Dallas, Texas.

When he left the destroyer, George used his furlough time to marry Miss Mary Murdock on January 30, 1944, in the chapel of the Naval Academy at Annapolis "with all the ritual which accompanies a Naval wedding" as stated in the publicity about the wedding in George's hometown. Mary's mother, Everella, came from Kirksville for the wedding. Mary accompanied George to his new assignment in Dallas and established a home near the base. The couple's second wedding anniversary on January 30, 1946, came with the news that there would be an addition to their family in June. But, George would never see his son.

On Monday, February 11, 1946, George and a mechanic left the Dallas air base on a routine training flight. Near Waco, Texas, at about 10 a.m., the plane's motor failed and went into a tailspin. George was able to right the plane, but it was too late. They were too near the ground. They crashed killing George and severely injuring his mechanic.

A military escort brought Lt. George Edward Slone's body to his hometown of Alexandria, Indiana, accompanied by Mary. A large military funeral was held on February 15, 1946, at the Gipe Funeral Home in Alexandria with burial in the Park View Cemetery where later George's parents would also be buried.

In deep sorrow, Mary returned to her mother's home in Kirksville. Four months to the day after George's death, on June 11, 1946, George and Mary's son was born and named George Edward Slone, Jr. He would grow up in the Capt. Harris mansion with his mother, his grandmother and for a short time with Dr. Bert Parrish.

With concern for his own mortality and the fact that he had no heirs, Dr. Parrish arranged in December 1942 to have Everella Murdock added to his deed for the Capt. Harris house. They became "joint tenants and not tenants in common ... the surviving party on the death of either to take the whole title to said real estate." It was reported elsewhere that Everella did pay Dr. Parrish for the home.

Dr. Bert Byrd Parrish died on December 20, 1951, at the age of 65, making Everella Murdock the sole owner of his property. Bert was buried in the Parrish plot (FA-23) at Forest-Llewellyn Cemetery in Kirksville, near his parents and beside his wife, Hermione. No one gave him a tombstone at that time.

Each year in honor of Kirksville's Founders Day on May 18, the Friends of Forest-Llewellyn Cemetery, in cooperation with the City of Kirksville who owns the cemetery, provides a tombstone for some person who does not have one. This year (2024), the recipient of this headstone is Dr. Bert Byrd Parrish.

This was the end of the Parrish era for the Capt. Harris Mansion, but our story continues on.

Harvey’s Beef Queen platform provided an additional opportunity for her to advocate for farmers’ mental health. She was interviewed by podcaster and beef advocate, Amanda Radke, at the 2023 Missouri Beef Days. She presented to local Lions and Rotary clubs and spoke at the banquet of the North American South Devon

Association. Her favorite experience was speaking with consumers about beef.

“I was waiting in line at the Beef House at the Missouri State Fair with a family that didn’t know anything about agriculture, and they were thrilled that I would share my beef story with them,” Harvey said. “There is too much misinformation about agriculture. My goal is to help correct it.”

Harvey developed an enthusiasm for policy through her Missouri Beef Queen

experience. As a long-term goal, Harvey wants to advocate for agriculture through politics; for now she is involved in local town hall meetings where she watches, listens, and learns about local government. 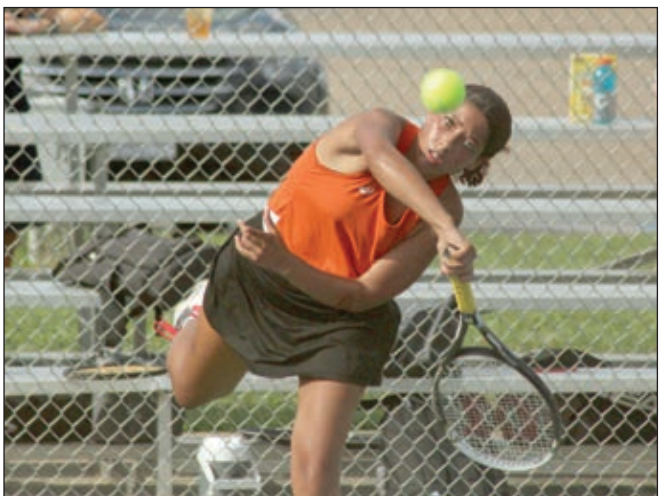

# 2024 MSHSAA Baseball State Tournaments Recap

As the calendar flipped from May to June, dozens of prep baseball teams from all over Missouri battled for state titles and only six were crowned Missouri State High School Activities Association champions.

CLASS 1: The Oran Eagles bulldozed their way through opponents to win the Class 1 MSHSAA Baseball State Tournament. The Eagles outscored their opponents by an average of 8.5 runs per game during the tournament. This was the Eagles' third trip to the state final game in the past four seasons, and their second state title during that period. The team was led by Coach Joe Bickings, who is approaching his 10th season at Oran High School. The Eagles won a nail-biter one-run-game against Norwood in the quarterfinal, but that was the only bump on their path. In the title game, Oran cruised past Sacred Heart and won 11-1. Sacred Heart grabbed the lead in the bottom of the first, but the Eagles erupted for a seven-run second inning and didn't look back. Junior pitcher Parker Bryant dazzled for the Eagles, going the complete game 5.0 innings, racking up 11 strikeouts and only allowing one run off two hits. Seniors Brenden Campbell and Gabriel Dirnberger combined for

four RBI. Oran finished the season with a 20-5 record.

CLASS 2: The Iberia Rangers completed an undefeated season to win the Class 2 MSHSAA Baseball State Tournament. The Rangers went an immaculate 30-0, which is poetic since their previous season ended at the hands of an undefeated Ash Grove team. This was Iberia's second state title all-time. The team was led by Coach Tim Vinson, who praised his team's pitching ability throughout the season. "Our pitching has been awesome... that's what's held us together," said Vinson in a May interview with KRCG-TV. Iberia didn't allow more than five runs in a game all year. Throughout the tournament, Iberia held opponents to just 1.5 runs per game. In the title game, Iberia took control early, grabbing a 4-0 lead in the second inning and beating Maysville 7-3. Junior pitcher Riemensnider went the distance, going the complete game 7.0 innings to earn his eighth victory of the season, and picked up an RBI at the plate. Senior Brady Blankenship and junior Isaac Duncan batted a combined 4-6, each 2-3. Iberia shut out their opponent in 10 of their 30 games.

CLASS 3: The Duchesne Pioneers out-slugged the competition to win the Class 3 MSHSAA Base-

ball State Tournament. The Pioneers scored a whopping 9.75 runs per game during the tournament. This was Duchesne's second state title all-time, but their first time winning it since 1984. The team was led by Coach Mike Hollander, who shared his excitement for his players. "I just love the guys so much, I'm happy they get to have this experience and everything that's going to come along with being state champions," said Hollander in a video posted to Duchesne's X/Twitter page. Over the season, the Pioneers were led offensively by sophomore Jackson Nikodym who batted over .400 and junior Sam Jost who reached base at a .513 clip. Sophomore TJ Griese and junior Gavin Moffit held down the pitching staff, with ERAs of 1.14 and 1.98 respectively. In the title game, Duchesne dominated, jumping out to a 6-0 lead after two innings and beating Mid-Buchanan 9-0. Sophomore Jaymson Forrest went 2-3 with an RBI. Duchesne ended the season with a 26-11 record.

CLASS 4: The Blair Oaks Falcons toughed it out and pulled off an upset to win the Class 4 MSHSAA Baseball State Tournament. The Falcons beat teams that had a better regular season record than them in three of their four state championship games. This was Blair Oaks' fifth state title all-time, and their first as a member of Class 4. The team made the jump from Class 3 following the 2019 season after they won the

Class 3 title. It was led by Coach Mike DeMilia, who recognized the importance of team chemistry. "What I'm going to remember is how many guys contributed to this team. We didn't rely on one lineup, we didn't rely on just a handful of pitchers," said DeMilia in an interview with the Jefferson City News Tribune. In the middle of the season in April, the Falcons played in the Columbia Baseball Tournament and suffered crushing losses including a 15-14 loss against Class 5 Willard, among others. But this mid-season tournament allowed the team to find itself and click in the second half and postseason. In the title game, Blair Oaks shocked Benton, who entered that day with a 32-3 record. Moreover, Blair Oaks held Benton, a team that scored almost 10 runs per game to just two thanks to pitching duo of freshman Wyatt Libbert and junior Zane Halford. Blair Oaks finished with a 26-13 record.

CLASS 5: The Willard Tigers' pitching and defense didn't flinch to win the Class 5 MSHSAA Baseball State Tournament which was low-scoring. Three of the first four games of the tournament were shutouts. This was Willard's second state title all-time, and their second under Coach Scott McGee, who appreciates the legacy left by his staff. "When you win it, you also think about all of the guys that came before and built our program into what it is today... our assistants are far and



away the best in the state," said McGee in a post on his X/Twitter page. It was a strategic father-son coaching moment that propelled the Tigers to victory in the end. In the title game, sophomore Jarrett McGee entered as a pinch-hitter in the sixth inning and knocked in a go-ahead, two RBI hit to give Willard the lead and beat Webster Groves 5-1. Senior pitcher Kaelin Adams led the way after coming in during the third inning and earning the victory. Willard closed with a 34-5 record.

CLASS 6: The Blue Springs Wildcats withstood a miraculous comeback effort to hold on to win the Class 6 MSHSAA Baseball State Tournament. This was Blue Springs' first state title in over 15 years and their second all-time, although this is their first as a member of Class 6. The team was led by Coach Tim McElligott, who had his guys ready for a multi-round fight. "Their kids play hard. It was like shooting a grizzly bear with a .22. They just kept coming and coming," said McElligott about

the opposing Lafayette Lancers in an interview with the St. Louis Post-Dispatch. Back in March, Blue Springs dropped an early-season game against those same Lancers that they beat almost three months later for the state trophy. The title game was complete with twists and turns, coming down to a Hollywood-esque bases-loaded, down by one run in the bottom of the last inning situation that Blue Springs just barely held on for. After the Wildcats took a commanding 9-2 lead, Lafayette chipped back right away in the bottom half of the inning to make it 9-8 and that's when the see-saw teetered but didn't totter. In the sixth inning, the Wildcats extended their lead to two runs before Lafayette cut it to one in the bottom half. The exact same scenario unfolded in the seventh, but Blue Springs kept the game-tying run at third base and the game-winning run at second base to escape with an 11-10 victory. Blue Springs concluded with a 28-11 record.

# City recognizes National Public Works Week

The city of Kirkville recognizes National Public Works Week from May 19 to May 25. The city's Public Works Department comprises six divisions: Wastewater Treatment, Water Treatment, Utility Maintenance, Central Garage, Street Maintenance, and Administration.

Public Works professionals ensure drinkable water comes out of your faucet, your toilet flushes waste away, there are streets for residents to commute on, and that city vehicles can continue being of service. They focus on infrastruc-

ture, facilities, and services vital to the well-being of the people of Kirkville.

Some numbers to think about when it comes to public works:

- More than 100 miles of city streets, 155 miles of water lines, and 100 miles of sewer mains are maintained by public works.
- Residents combine to use 2.4 million gallons of water each day, which is treated at the water treatment plant before making its way to homes.
- The wastewater treatment plant treats almost three million gallons of wastewater each day, sending clean water back into the environment.

# Resurfacing project to begin on Missouri Route 5 in Putnam County
