The Kirksville Police Department made an arrest regarding the stabbing death of Dakota J. McClelland, 16, of Kirksville reported on Tuesday, Oct. 8.

Shawn Michael Dukes, 21, of Kirksville, is in police custody in connection with the murder, pending the issuance of an arrest warrant from the Adair County Courts. At approximately 8:09 a.m. on

On arrival, officers took a potential suspect into custody and rendered aid to a female victim until personnel with the Kirksville Fire Department and Adair County Ambulance District took over care. The female victim died on the scene from her injuries. The

suspect was transported for treat-

ment of related injuries. There is no current threat to the public.

A criminal charge is merely an accusation and a defendant is presumed innocent until and unless proven guilty.

## Adair County SB40 holds annual Legislative Coffee Chat

#### By Adair County SB40

On Monday, Oct. 7, the Adair County SB40 Developmental Disability Board held its annual Legislative Coffee Chat at the SB40 Community Learning Center. The purpose of this annual meeting is to provide information and resources about issues impacting citizens with developmental disabilities to local, state and federal representatives.

Topics that were discussed during the presentation included information about services provided by Adair County SB40, financial challenges, challenges with systems of supports, the lack of transportation options and recommendations from the Public Administrator.

Attendees included SB40 staff and board members; several individuals and family members serviced by Adair SB40 and community leadership including Adair County Public Administrator Rhonda Noe; Adair County Commissioner candidate Gayla McHenry; Missouri Representatives Danny Busick (District 3) and Representative Greg Sharpe (District 4); Missouri Senator Cindy O'Laughlin's Legislative Aide, Lois Bragg (District 18); U.S. Senator Josh Hawley's Legislative Aide, Taylor Blackwell; and MACDDS Executive Director/CEO Nancy Pennington Incoming executive director for Adair County SB40, Sean Jacob, shared a great deal of information explaining Targeted Case Management Services. He said, "Targeted Case Management is a service offered by SB40's Service Coordinators that assesses the need of people with developmental disabilities and their families. Once the need is identified, a plan is put into place which includes securing eligibility and authorization for direct services and supports for those individuals. What makes Targeted Case Management different than typical case management services is that the service coordinators are responsible for monitoring the services provided by the chosen service providers to assure that they are meeting program requirements and, most importantly, continue to meet the needs of the individuals and their families. Adair County SB40 service coordinators are essentially the gatekeepers in place to make sure that those

taxpayer dollars are 'targeted' where the individuals most benefit from them."

Melissa Hocker, a parent and SB40 Board director, shared with the group that Service Coordination has assisted her in securing services and supports for her daughter since she was just over a year old.

"Our Service Coordinators have assisted us with securing special equipment such as wheelchairs and communications devices, they helped us make our home accessible, they connected us with services to provide after-school and summer care, because I wanted to keep my job," she said. "Now my daughter is graduating high school and turning 18, they are helping me plan what supports she will need as an adult in our community."

Crystal Aminirad, the current executive director of Adair County SB40 is retiring at the end of the year. She reported to the participants that her concerns are that with increasing pressures on funding for services for people with developmental disabilities, emphasis

## Adair County marks 20th anniversary of its worst air tragedy

October 19 of this year marks the twentieth anniversary of the worst air tragedy to occur in Adair County's history. Corporate Airlines Flight 5966, en route from St. Louis to Kirksville, crashed two miles south of Kirksville Airport as it made its final landing approach. Thirteen of the 15 persons on board were killed in the disaster. The consequences of the crash were devastating for the families of the deceased and the two survivors.

The community was stunned and particularly A.T. Still University's

#### **Details of the Crash**

On Tuesday evening Oct. 19, 2004, Corporate Airlines Flight 5966, a part of American Airlines Connection service, departed St. Louis's Lambert Airport at 6:42 p.m. on its regular evening commute to Kirksville. The airlines operated regularly scheduled flights to and from St. Louis and Kirksville each weekday. The airplane was a British Aerospace Jetstream 32, twin-engine turboprop with 19 seats.

At 7:45 p.m., one hour and three minutes after departing St. Louis, the plane crashed through the treetops south of the airport on its final approach to Kirksville airport. Skies were overcast, mist was in the air, and thunderstorms were in the area when the plane went down. The airport at Kirksville did not have an instrument landing system (ILS), a valuable tool for pilots trying to land in poor weather conditions. The crew consisted of the pilot, Kim Sasse, and co-pilot, Jonathan Palmer. Their last communication indicated the plane was on a normal approach to the airport with no mention of any problems



Kirksville College of Osteopathic Medicine (ATSU-KCOM). The two survivors and several of the deceased passengers were coming to the KCOM campus to participate in a conference on humanism in medicine. Some of the passengers were current and former faculty and staff at ATSU-KCOM. Amazingly, two passengers—Dr. John Krogh and Wendy Bonham, with ties to the University-survived. Thirteen people, including the two crew members, perished in the fiery crash.

according to a spokesperson for the Federal Aviation Administration (FAA) in Chicago. The contact came at 7:27 p.m., when the pilot reported that they were about 10 miles south of Kirksville airport getting ready to make their final approach to the runway. According to the FAA weather observation system, there was no distress signal and no sign that there were any problems aboard the aircraft. After the National Transportation Safety Board's (NTSB) lengthy and detailed investigation, the conclusion as to the causes of the crash revealed the details.

## First Responders at the Crash Scene

According to the NTSB's final report, the Kirksville airport operator on duty at the time of the crash stated that he received a telephone call from a local farmer who told him that an airplane had crashed south of the airport. After obtaining a more detailed description of the accident location at 7:53 p.m., the airport operator called Kirksville 911 dispatch to report the accident. According to the Kirksville 911 dispatch timeline, between 7:55 and 8:03 p.m., the dispatcher initiated emergency response regarding the accident.

will be placed on supporting systems rather than people.

"The biggest challenge our staff are going to face in the near future is to keep the supports we offer focused on the person we are supporting, rather than supporting the systems," she said. "That takes informed, educated professionals. It's become increasingly difficult to be competitive in recruiting those professionals because our TCM services have not been given an increase in funding since 2015."

Nancy Pennington, executive director/CEO of Missouri Association for County Developmental Disability Boards added, "Cost of living has increased over 30 percent since the last rate increase for Targeted Case Management services. Organizations that provide this service are facing increased expenses and struggling to continue to staff qualified professionals as they try to stay competitive with wages and benefits."

Pennington also addressed the importance of SB40 boards across the state that rely upon property tax income in order to meet the needs of people with developmental disabilities, which are unmet or unfunded through typical state and federal benefits.

## **This Week in Local History**

#### 90 Years Ago, October 13, 1934

The search for notorious criminal, Charles "Pretty Boy" Floyd (1904-1934), centered in north central Missouri, and local law enforcement officials went on special duty to be on the lookout for Floyd. On the run from the law, Floyd had traveled from Iowa to central Missouri where he attempted to cross the Missouri River, but all the bridges were blocked. He then turned back north and was thought to be headed back to Iowa by way of Highway 63. He had been in the Moberly area and had stopped at a farm house in the Cairo area to get medical supplies to treat his wounded accomplice who was traveling with him. C.M. Parker with the Kirksville area highway patrol was notified to be on the lookout for Floyd. He and Kirksville police officers Bowles, Hatfield, and Little, equipped with plenty of weapons and ammunition, left town to patrol highway 63 south of town with the expectation that Floyd would pass through on his way to Iowa. Floyd and his accomplice were never spotted, and it was assumed they passed through the area later that night in the cover of darkness. "Pretty Boy" Floyd, a bank robber and murderer, was designated by J. Edgar Hoover, head of the FBI, as "Public Enemy # 1." He was accused of killing four law enforcement officials in the 1933 "Kansas City Massacre." In the fall of 1934 Floyd was tracked down and killed by FBI agent Melvin Purvis near East Liverpool, Ohio.

#### 90 Years Ago, October 17, 1934

A large and enthusiastic audience was present at the Democratic rally held in the circuit courtroom of the Adair County courthouse. In attendance at the rally were the Democratic candidates for various state and local offices. Those speaking were Judge Harry S. Truman, candidate for United States Senator; and M. A. Romjue, nominee for Congress from the First District. Truman was elected to the U.S. Senate that year and again in 1940. He was elected Franklin D. Roosevelt's vice-president in 1944 and became President upon the death of Roosevelt on April 12, 1945.

#### 80 Years Ago, October 12, 1944

A deed was filed in the Adair



mer cottages was to begin soon. A beach was constructed on the lakeshore to provide a swimming area. The lake was stocked with 130,000 bass and other fish were to be added.

#### 75 Years Ago, October 18, 1949

An outright gift of 1,108 acres of land by the Dr. George M. Laughlin estate to the City of Kirksville, which was to become a part of the new city reservoir and state park located south and west of Kirksville, was announced by the Laughlin family and Kirksville Mayor I. E Markham. The land, a part of the Thousand Hills farm, was located east and north of the proposed large lake, to be built in the Big Creek watershed. Markham said that the gift by Mrs. Blanch (Still) Laughlin and her daughter, Mrs. Mary Jane Denslow and son Dr. George Andrew Laughlin, provided nearly half of the land the city needed for the proposed improvements. Markham indicated that without the Laughlin land gift it would not have been possible for the city to build the reservoir or to have acquired a state park near Kirksville. The project required about 2,600 acres, so the city needed to acquire an additional 1,500 acres to be able to complete the project. The mayor indicated that negotiations were ongoing with the other landowners in the area for the purchase of their property by the city. However, he said the owners were asking much more than the city could afford to pay. Consequently, he said unless an agreeable dollar amount could be worked out, the city would begin condemnation proceedings against those landowners. In making the gift, Mrs. Denslow said she knew it would be the wish of her father that the land be given to the city because he had said that someday Kirksville would need a large reservoir for its water supply and the logical location would be on the property where it was to be built.

#### 70 Years Ago, October 18, 1954

The new Novinger R-1 School, which replaced the previous building that was destroyed by fire in January 1953, was dedicated. Approximately 500 people were served dinner by the Novinger Parent Teacher Association (PTA). Dinner was served between 11 a.m. and 1 p.m. in the new building's cafeteria. At 2 p.m. the formal dedication services began with an invocation by the Rev. Jim Fox. This was followed by musical presentations by the R-1 school band decked out in colorful red and white uniforms and directed by Herschel Burris. Words of welcome were given by Robert Jones, president of the board of education. The guest speaker was H. Pat Wardlaw, assistant commissioner of education in Jefferson City. A girls sextette, composed of Marlys Guffey, Mary Ann Stidmon, Linda Powell, Georgia Ann Lee, Diantha Truitt and Francetta Hoerrmann, accompanied by Elizabeth Novinger, presented a selection, "Listen to the Lambs." Platform guests were introduced by M. S. Powell, superintendent, and included Chester Calvert, State Supervisor of Education; Walter H. Ryle, of the Kirksville Teachers College; Congressman Clarence Cannon; State Representative Wallace Pearson; Robert Schneider and Arthur Peterson, general contractor and plumbing supply contractor for the new building; and Mrs. Stella Hills, county superintendent of schools. The Novinger school principal, Donald Daniels, and members of the board of education were introduced. They were Edgar Paris, Bob Daniels, O. T. Huffman, Bennie Summers, Russell Linder, E. R. Adams, and Robert Jones. A musical selection by the band and the benediction by Rev. James Cole concluded the event.

## The Smith-Kellogg Mansion – Chapter 12 – The Subdivision

With the last two Kellogg brothers displaced from the property and the Kellogg estate sold to

a company which planned to develop it into a subdivision, all hope was then gone for the preservation of the historic Smith-Kellogg mansion. The last two Kellogg siblings, Fred and Charley, died in 1966 and 1969, respectively, and they joined the other members of their family at Forest-Llewellyn Cemetery. Out of seven children of Warren and Susan Kellogg, not a single descendant existed. There were never any grandchildren.

The McHenry and Gash Company, which purchased the Kellogg property, had it surveyed and divided into city lots and streets. The new subdivision would be called Kellwood Hills, a play on words to acknowledge the family who had owned this property the longest. Advertisements were published stating, "Lots will soon be ready for you to select your choice of the beautiful building sites in Kirksville's newest and most beautiful subdividion. A plot of Kellwood Hills will be on display in the very near future at McHenry-Gash Motor Co."

As an added incentive for residents to buy a building site in Kellwood Hills, McHenry and Gash offered a contest to win a new 1958 Pontiac Chieftan Catalina 4-door sedan. A drawing would be held to give it to one of the purchasers of the first 30 lots sold in Kellwood Hills. The winner would then be given the privilege of naming one of the streets in the subdivision.

The family who won the car let their teenage daughter name the street, and she chose Catalina, a part of the name of the car. There were five other streets in the subdivision with the names Overbrook, Kellwood, Vista, Broadview and Center Rd. The old Kellogg mansion sat on the site of what became 1 Center Road. For a time, there was a question as to whether or not the old house could be saved, remodeled and updated. During the 1960s, a brief but unsuccessful campaign was launched to try and save the house as a landmark. As the house sat empty in the early 1960s and work was going on all around it, kids in the community became aware of this big, spooky and ominous looking structure. Vandals had destroyed the doors and the 31 steps on the spiral staircase, so the house was open to curiosity seekers. Kids would dare one another to enter the house and snoop around. At least two board members from the Adair County Historical Society can tell tales of taking this dare when they were kids about 60 years ago. One brave soul remembers climbing the once beautiful spiral staircase using just the outside structure of the stairs, the stringers, to reach the 2nd and 3rd floors since the actual stair steps were gone. That person then remembers being in a panic when she had to come down. Looking down and descending was a lot scarier than going up. She was afraid someone was going to have to go and get her father, but then she would have been in bigger trouble, so she finally managed



to get down by herself.

Owners of the new subdivision ultimately decided to tear the Kellogg house down in approximately the early 1960s. In front of the old house, the street called Center Road was paved, and the new house which was built on the site of the old mansion was numbered 1 Center Road. The lovely one-story brick house which was built in its

place was at one time occupied, but for 13 years now, it has sat vacant, giving rise to the old idea of a curse haunting this location.

So ended the dream of the original builder, John Thompson Smith, his friend and second owner, George McGuire, and any aspirations that Warren Kellogg might have had for his posterity.

By this time, all of the siblings of Warren Kellogg who once prospered in Adair County had died or left the area. Eight of Warren's 12 siblings had lived in Kirksville at one time or the other. The other Kellogg mansion in Kirksville which had once been the Parcels mansion had also been sold. Something drew five of Warren Kellogg's siblings to Los Angeles where all five had died by 1935 and four were buried there. Only five of the 12 siblings had children, and only Johnathan Kellogg (1846-1922), who once lived near Bullion, Mo., ever had children to carry on the Kellogg name. Three of his sons became osteopathic physicians. After leaving Adair County, Mo., Johnathan maintained a ranch in Colorado. He moved to Los Angeles after retirement but was returned to Colorado for burial. Warren's brother, James Silas Kellogg (1841-1915), came to Kirksville in 1873 to manage the Parcels property that his father had purchased. Over the years, he hosted many of his other siblings as they filtered into Kirksville. His oldest sister, Mary Eliza Ann (Kellogg) Palmer (1838-1912) came here as a widow with three children in 1900. She later moved back to Pennsylvania. Another sister. Adeline Matilda Kellogg (1843-1919) came to Kirksville and married a local dentist who was a widower, Dr. Isaac D. Pearce, in 1874. She cared for Dr. Pearce's three children as well as the son they had together, Jirah Jacob Pearce (1880-1949), who became an osteopathic physician. Adeline and Isaac Pearce divorced. Adeline is buried in Highland Park Cemetery in Kirksville. A brother, Edward Headon Kellogg (1851-1935), joined James on the Parcels-Kellogg farm and together they raised and sold a large quantity of cattle and pedigreed horses for several years. They also took carloads of cattle by train back to Pennsylvania and sold them. At the age of 54 in 1895,

> James Silas Kellogg visited his home county in Pennsylvania where he reconnected with a childhood friend, Cynthia Spencer, and they were married. They came back to Kirksville where James built a new two-story house for them at the bottom of the hill from the Parcels-Kellogg mansion. This new home is now addressed at 1601 E. Illinois St. James and Cynthia were divorced by 1900. James was declared insane in 1914, and his brother, Edward, was appointed his guardian. (James probably had Alzheimer's disease or something similar, but this term was not widely known nor used at this early date.) James died the next year and is buried at Highland Park in Kirksville. He owned several pieces of real estate, and he left \$50,000 to his siblings, a large sum for that era.

Edward Kellogg's 1st wife, Malissa Atteberry, died in Kirksville and is buried in Highland Park. He then married a prominent widow in Brookfield, Mo., Lusetta (Cook) Lantz, in 1913. They retired to Los Angeles in 1917 and died there. They each have a tombstone at Highland Park without death dates. They are not buried there but in LA. Neither Edward nor James had any children. Two other Kellogg sisters came to Kirksville from Pennsylvania with their brother, James, and married Kirksville men. Sarah Caroline Kellogg (1855-1932) married Thomas Clarkson. She and her husband moved to LA by 1920. Dency Helen Kellogg (1858-1900), lived with her brother, James, until she married Ira Collins in Kirksville and moved to Iowa. She died there and was returned to Kirksville for burial at Highland Park. Ira then graduated from Dr. Still's American School of Osteopathy in Kirksville and became an infamous osteopathic physician in El Paso, Tex., where he earned disapproval from the osteopathic community, but that is another story. He and his 2nd wife also retired to LA. Four Kellogg siblings, Esther Julia, Azor Edgar, Deborah Caroline and Harriett Eva were never known to live in Kirksville but lived their lives elsewhere. However, both Esther and Azor retired to LA. Thus ends the saga of the Kellogg family and the Smith-Kellogg Mansion as we at the Historical Society know it.

County Recorder's office in which Dr. Charles E. Still, one of the sons of Dr. A. T. Still, conveyed to the Kirksville College of Osteopathy, his 24-room home on Osteopathy Street at the west end of Jefferson Street. The home was to be used for the purpose of establishing the Anna R. Still Osteopathic Convalescent Home. In making a gift of the home, Dr. Still stated that he was desirous of perpetuating the memory of Anna R. Still, his deceased wife, by dedicating the use of the home to further the teaching, principles, and precepts of the science of osteopathy founded by Dr. Andrew Taylor Still.

#### 75 Years Ago, October 14, 1949

Spring Lake Inc., a private corporation, invited the public to an inspection of the new recreational facility near Yarrow in southwest Adair County. The roads around the lake were recently completed and the corporation wanted to give the public a chance to see the new recreational place which was sponsored by citizens of Kirksville and the community. The 100-acre lake was nearly filled with water. Officials said the bright tree coloring of the fall season made for a place of exceptional beauty. The new high-type road around the lake was three and a half miles in length and served 90 percent of the lots. The Spring Lake association purchased 520 acres and leased 1,000 acres. A dam on Elm Creek was constructed at a cost of \$60,000. Practically all the 120 lots which border the lake were sold as well as several of the lots on the upper side of the road on the hillsides. The erection of sum-

#### TRAGEDY

The following emergency responders were notified; the Macon County 911 Center, La Plata Fire Department (LPFD), AirEvac, Southwest Rural Fire Department, Kirksville Police Department, Adair County Sheriff Department, and Adair County Ambulance Dispatch.

A Missouri State Highway Patrol trooper was at the Macon County 911 Center when the notification phone call was taken. He immediately responded to the accident site. The Kirksville 911 dispatch timeline indicated that La Plata Fire Department was the first emergency responder to arrive at the scene of the crash at 8:20 p.m., 35 minutes after the crash.

The La Plata responders reported that the downed airplane was located south of the airport in a wooded area between farm fields. Upon arrival at the crash scene, they found the plane's fuselage in flames, but largely intact, with its wings broken off and lying nearby. Other debris including the tail section was found scattered over a halfmile wide area. The plane clipped tree tops before crashing to the ground.

Upon arrival at the crash site, La Plata responders immediately split into teams to start searching for survivors. By the time other EMTs arrived at the scene the La Plata responders had located two survivors, Dr. John Krogh and Wendv Bonham. The two survivors were found outside the plane. Wendy Bonham was found walking around stunned from the trauma and her injuries when rescuers discovered her. Dr. Krogh was found in the brush about 25 feet from the fuselage. They were taken by an awaiting ambulance to Northeast Regional Medical Center (NRMC) in Kirksville. At the hospital Dr. Krogh was treated for a broken left hip and a broken bone in his lower back. He was not burned. Bonham suffered from a compound fracture of her right arm jurisdictions as well as other firefighting and emergency medical personnel, maintaining control of the site became a challenge. There was some difficulty in communication between the multiple agencies which had responded because of different radio frequencies. Traffic congestion near the accident site created a situation in which the Adair County ambulance could not immediately exit the area until response vehicles from multiple jurisdictions were moved. Initially, 100 rescuers were on the scene, but as the passengers and crew were accounted for the

number was scaled back. During the night of the crash the search for victims continued, and eight bodies which included the two crew members, were found in the burning fuselage. Some were still strapped in their seats. Although rescue workers remained on the scene throughout the night, they did not find additional bodies or survivors due to the darkness and heavy brush. Rescue personnel remained hopeful that when daylight arrived, they would find the remaining five alive.

On Wednesday morning as daylight approached, an intense search for more survivors resumed. As the day wore on their hopes were dashed as the bodies of the five remaining passengers were located.

#### The Survivor's Story

One of the survivors, Dr. John Krogh, 68, of Wallsburg, Utah, was a former member of the KCOM faculty. At the time of the crash, he was a part-time faculty member at Provo College in Utah. Krogh was interviewed by ABC's "Good Morning America." He told the interviewer. "There was just a crashing sound. I'm sure it was a wing hitting a tree. I just didn't believe that it was happening. As we bounced along through the trees, people started screaming badly. Terrible screams." He said the plane was on fire and he could hear Bonham, his 44-year-old assisover the main wing span and near the emergency exits of the aircraft. A post impact fire destroyed most of the aircraft. During a post-accident interview the survivors stated that they exited the aircraft through a break in the left side of the fuselage near the exit row and were able to move a safe distance from the aircraft before the fire engulfed the airplane and the surrounding trees.

Dr. Krogh and Bonham were seated across the aisle from each other near the middle of the aircraft. Regarding his seat selection Krogh said, "I didn't know we had assigned seats, and I walked in there and sat down in that seat, and that may have saved my life." Regarding his escape from the burning fuselage, Krogh said, "The wing was gone, and I knew there was no way that I could do anything but just pull myself out and let myself fall."

#### The NTSB's Investigation

The NTSB team of investigators began to arrive at the crash scene on Wednesday morning, the day after the crash. They recovered the two black boxes which were in good condition. The information they gathered from these devices helped them to eventually piece together the causes of the tragedy.

The team of 12 NTSB specialists began a detailed investigation into the cause of the crash. It covered everything including the crew, their workload, medical history, training, experience, and work environment. Also, the plane's equipment, engine, hydraulics, electrical system, and navigational system were examined. The weather conditions. rescue operations, crash site, and wreckage, including force of impact and angle of descent of the plane were thoroughly studied. Air traffic control was included in the examination. The full investigation was expected to take from 12 to 18 months to complete.

#### The Passengers and Crew

The 13 passengers on board Flight 5966 who lost their lives were: Mark Varidin D.O. of Florida, the Florida regional dean for KCOM's clinical education program; Clark Ator, D.O., 39, a graduate of KCOM, a husband and father of seven children who conducted a medical practice in Alpine, Utah; Dr. Judith Diffenderfer, a doctor in Saginaw, Michigan, with husband and a 16-year-old daughter; Kathleen Gebhard, administrator of a hospital of Englewood, Ohio, who had a husband and 18-year-old son; Dr. Stephen Z. Miller, who was

director of pediatric medicine at Columbia Universitv's College of Physicians and Surgeons; Dr. Richard Sarkin, 54, of Buffalo, New York, a pediatrician, who was affiliated with Women and Children's Hospital in Buffalo and director of pediatric education at University of Buffalo; Paul Talley, 44, of Mesquite, Texas, a Dallas area photographer; Dr. M. Bridget Wagner, the assistant dean of Universitv of Ohio's College of Osteopathic Medicine.

Other passengers killed in the crash included: Rada Bronson, Matthew Johnson, and Tony Sarantino. The two deceased crew members were pilot, Kim Sasse, who had been flying for Corporate Airlines for three years and co-pilot Jonathan Palmer, 29, of Cincinnati, Ohio.

#### **Response by the KCOM/** Kirksville Community

The Adair County Chapter of the American Red Cross immediately rallied to assist local rescue personnel, federal investigators, and family members of those lost in the crash. Local Red Cross workers immediately began their efforts to assist as soon as reports of the crash came in on Tuesday evening. Kirksville Salvation Army and volunteers helped at the crash site by distributing food and drink to the rescue workers, law enforcement officials, and others working at the scene. The people in the community reached out to assist. There were many phone calls from people offering to prepare food and local businesses donated food.

Specialized Red Cross personnel from St. Louis and Jefferson City began arriving in Kirksville at dawn the morning after the crash to provide mental health care services while logistics and family service personnel from as far away as Pennsylvania and Texas also arrived in Kirksville. Family members of the crash victims began arriving in Kirksville soon after they received word of the loss of their loved ones. The Red Cross and NTSB set up

ered to hear local leaders, 12 hours after it happened and representatives of both ATSU and Truman State University (TSU) offer their words of condolences to grieving families. Dennis Smith, chaplain at NRMC; Ron Gaber, dean of students at ATSU; and Barbara Dixon, president of TSU; delivered messages on behalf of their institutions.

Chaplain Smith led a candlelight service in which representatives of emergency responders lit 15 candles—one for each of the crash victims. Brad Ator, father of Dr. Clark Ator, who was killed in the crash, spoke on behalf of his family. He told of his son's love for Kirksville, the place he had received his medical education. Later, hundreds of people lined up to hug and offer condolences to Brad Ator and his family members and other victim's families who were in attendance.

#### **Removal and Identification of** the Bodies–DMORT Response

When natural or manmade disasters strike, there may be more fatalities than local facilities and resources can handle. This was the case with the crash of flight 5966 near Kirksville. The Disaster Mortuary Operation Response Team, known as DMORT supports local mortuary services on location working to quickly and accurately identify victims and reunite them with their loved ones in a dignified, respectful manner.

DMORT personnel focus on the recovery, decontamination, examination, identification and return of deceased victims to help families and communities find closure. Members of the DMORT team include coroners, funeral directors, medical examiners, forensic specialists, and a multitude of other specialists in related areas. They provide facilities and services as needed such as establishing temporary morgue facilities, identifying human remains and personal effects, performing postmortem examinations, determining the cause and manner of death,

and were ready to assist in every way they could. They didn't show up and try to run things, they were helpful. They let the local authorities take the lead, and they helped in every way they could. If some equipment or facility was needed, they immediately arranged for it to be available. They did an amazing job."

Noe said he got the call regarding the crash shortly after it occurred, and he immediately went to the scene where he spent the night assisting in whatever ways he could. As the extent of the air tragedy and the number of deaths was revealed, it became obvious to him that local facilities and resources could not handle the work to be done without lots of help.

When the NTSB team and DMORT personnel arrived at the crash site, they immediately took pictures of various aspects and angles of the crashed aircraft and its remaining contents. The photographs would assist them with their ongoing investigation. At this point the heat from the burning fuselage was too intense to begin removing the bodies.

Once the heat subsided, the next thing that had to be done was to remove the bodies and immediately get the remains placed in a refrigerated container. DMORT provided the metal containers for the bodies and arranged for a refrigerated tractor trailer unit to be brought in for storage of the bodies while the identification, post mortem examinations, and preparation of the bodies for final disposition took place. All the bodies were recovered and removed from the wreckage within 48 hours.

DMORT, with the assistance of the city of Kirksville, arranged for the use of the Standard Register facility as a temporary morgue. Here the refrigerated trailer was taken and the bodies removed one by one for examination and preparation for disposition. Trained forensic dental technicians, DNA experts, morticians, funeral directors, and other forensic professionals all provided by DMORT arrived at the morgue to conduct their respective examinations. Noe related that all the bodies were located in the burned-out fuselage of the plane, and the bodies were what he termed "non recognizable remains." Although family members or representatives of all the crash victims except one came to Kirksville after the crash, they did not view the remains.

family service centers at Kirksville's Days Inn and at the Adair County Ambulance District. They assisted families with the daunting task of interviewing victim's family members, identifying bodies, and making arrangements for disposition of the remains. As search and rescue

operations ended, the full impact of the tragedy began to sink in. Kirksville community came together in a candlelight vigil and prayer service at Rieger Armory. Hundreds of residents gathpreparing, processing and returning human remains and personal effects to appropriate recipients.

Brian Noe, Adair County coroner, had served in that position for 15 years at the time of the crash of flight 5966. Until that time the greatest number of deaths he had examined in one incident was a car wreck in which there were four fatalities. He explained the valuable role that the DMORT team played.

"They arrived on the scene of the crash within



## **City of Kirksville recognizes Fire Prevention Week**

Kirksville Mayor Zac Burden signed a proclamation on Oct. 7, recognizing Fire Prevention Week in Kirksville.

"The city of Kirksville and Kirksville Fire Department remain committed to ensuring the safety and security of all living in and visiting our city," city officials said in a press release. "Fire Prevention Week is an opportunity to share information that can help with survival and safety should a fire occur."

The theme for this year is "Smoke alarms: Make them work for you!" Roughly three out of

five fire deaths happen in homes with either no smoke alarms or no working smoke alarms. Working smoke alarms cut the risk of dying in reported home fires

almost in half. Smoke alarms sense smoke well before you can, alerting you to danger in the event of a fire, which you may have as little as two minutes to

escape safely.

Residents should install smoke alarms in every sleeping room, outside each separate sleeping area, and on every level of the home, testing at least once a month.

Smoke alarms with non-replaceable (long-life) batteries are designed to remain effective for up to 10 years. If the alarm chirps, warning the battery is low, replace the entire smoke alarm right away.

For smoke alarms that do not have non-replaceable (long-life) batteries, replace batteries at least once a year. If the alarm chirps, replace only the battery.

For the best protection, interconnect all smoke alarms. When one sounds, they all sound. It is important to have interconnected smoke alarms if you sleep with closed bedroom doors.

## Kirksville police attempt to locate stolen truck

The chief medical examiner, with the assistance of DMORT personnel performed autopsies and toxicology tests on the two fatally injured pilots and passengers. The blood specimens of the pilots tested negative for ethanol and a wide range of drugs including drugs of abuse. The report of the autopsies concluded that the cause of death of the two pilots and 11 passengers was "multiple blunt force injuries" resulting from the impact.

Almost immediately after the Corporate aircraft crashed and it was known that there were two survivors and 13 casualties,

was highly professional in every respect. They completed their investigation in a sensitive and sympathetic manner, respecting the wishes and needs of the surviving family members. At the same time, they displayed a high degree of decency and respect in the removal, identification and examination of the remains and in the preparation of the remains for their transfer to their final destinations."

#### **NTSB Finding as to Causes** of the Crash

On Jan. 26, 2006, 15 months after Corporate Air's flight 5966 crashed, the NTSB officially adopted its finding as to the cause of the tragedy. The causes are listed below:

Pilot Error. The NTSB determined that the probable cause of the crash was pilot error. The pilots failed to follow established procedures to effectively monitor the airplane's descent rate and height above terrain during the last stages of the approach. They relied too much on minimal external visual cues. Although descent rate and altitude information were readily available on the cockpit instruments, both the pilots were largely preoccupied with looking outside the airplane for the approach

lights. The pilots did not adhere to the division of duties between the flying and monitoring pilot. The cockpit voice recorder (CVR) indicated that both pilots were looking outside the cockpit for visual cues to the location of the airport and failed to realize how low (top of the trees) they had descended.

Pilot Fatigue. The pilots had been on duty for over 14 hours and were landing for the sixth time that day in challenging weather conditions. Pilot Kim Sasse had been on duty for 14 hours and 41 minutes that day. This length of time was within FAA guidelines at the time.

Weather conditions. Although the weather did not cause the accident,

Bond's office announced that Kirksville's airport was slated to get about \$975,000 for the purchase of an instrument landing system (ILS). The ILS is of valuable assistance for pilots trying to land in poor weather by providing them with both horizontal and vertical guidance in landing a plane. The ILS was something that both the Pilots Association and the Airport and Transportation Commission had advocated for Kirksville for some time. Unfortunately, the ILS was not in place before October 19, 2004.

notification of family members began. Several came to Kirksville as soon as they could. The Kirksville Days Inn on south Highway 63 was selected by DMORT as the headquarters for its operations. Arrangements were made with the hotel for family members to reside there while they were in Kirksville. The Red Cross and Salvation Army also set up temporary locations there to assist as needed. The Days Inn provided an environment for the survivors to share their grief and bond with each other. As sad as the bonding situation was, it helped family members work their way through the initial grieving process.

Having all the families together simplified the work of the DMORT team as they could readily confer with family members regarding the personal effects of the deceased and assist with identification of the remains. The DMORT team used various techniques in establishing positive identification of the bodies. These included DNA tests, examination of dental records, and positive identification of items found on the bodies, including jewelry, and other personal items on or near the bodies that were not destroyed by the fire and heat.

According to Noe, the DMORT team remained in Kirksville for several weeks until their work was completed. As coroner, he assisted with all aspects of the team's work. His 15 years of experience gave him local contacts for which the DMORT team members could connect for assistance in their work.

Noe concluded: "The work of the DMORT team

"This SB40 Board and organizations like them in Missouri are providing essential services, individualized grants, transportation and specialized equipment that have no other source of funding," she said.

Carla Mayer, a parent and SB40 Board director, discussed the significant impact that the Adair SB40 Community Learning Center has on her daughter's life.

"Not only does my daughter get education and information through the center. but she has formed friendships and relationships with so many people because of the time that she invests in the Learning Center program," Mayer said. "If it wasn't for the Learning Center, my daughter's life would largely be staying at home and maybe watching TV. I wasn't going to have that for her."

Susan Lassabe, incoming director of Service Coordination for SB40, also shared recent difficulties experienced by families when attempting to work with the Medicaid Reauthorization process.

"Communications in-person are difficult to schedule, and telephone calls are often placed on hold or disconnected after long periods of waiting," she said. "Applications and other documents have been lost and the application process has had to be restarted in some cases. Our service coordinators are experiencing the same challenges that families are experiencing. The system just isn't efficient."

Lassabe shared resources with legislators that will assist in 'trouble shooting' the reauthorization process and gave some suggestions about how the system can be improved. "It would be helpful to have well trained and knowledgeable staff available in person at local offices, not getting shuffled to phones when you walk in," she said.

Several individuals receiving services from Adair SB40 spoke to the value of the services that they receive through authorizations coordinated

by their SB40 staff. They shared that current staffing shortages by local service providers are causing some programs to not be able to fulfill their services.

"The lack of usage of all of the authorized services is not because the services are not needed," Aminirad stated. "In many cases, it is because the service provider cannot hire direct staff to provide the service due to the low rate of pay. The more rural the area a family lives, the greater the service desert for essential services" and the lack of transportation is recognized as one of the top, if not the number one, barrier to accessing services and community."

Dennis Miller, SB40 Board director, shared that he is not always able to get the transportation that he needs to get to his job or to essential medical appointments. He pointed out that there is a new program in Missouri, New Growth

LLC, that is rapidly expanding in the provision of a Volunteer Transportation Network.

"If we can begin working with a Volunteer Transportation Network in our community, find the funding to reimburse volunteers for the mileage they drive to provide point-to-point rides, more people could have jobs, get to their medical appointments and participate in the retail economy in their communities," he said. "Research has shown that investing in transportation boosts economic development while improving the quality of life for those using the service."

Legislators also discussed the status of a recent U.S. Department of Justice investigation into the state of Missouri's efforts to offer the least restrictive environment to people assigned public guardianship by Missouri Courts. Rhonda Noe, Adair County Public Administrator and a member of Missouri Association of Public Administrators, shared that communities do not have the resources or placement options needed to provide community living for many of the people that Public Administrators service.

"We recognize that there is a long list of very complicated approaches to solving this problem, and we just ask that when the DOJ and Mo-DMH begin meeting to plan solutions, that they include Missouri Public Administrators at the table.," she said. "We can offer support and solutions to help continually improve the services offered by the state."

## Bulldogs make short work of S&T

Truman advanced to .500 on Saturday evening with a commanding 48-17 victory over Missouri S&T at Stokes Stadium. The Bulldogs held a three-touchdown lead after one quarter, and at one point in the first half led 31-0.

The 'Dogs rode the back of workhorse junior Denim Cook again – he finished with 182 yards and a pair of touchdowns on 21 carries. He eclipsed his own personal best from last week of 157 yards versus Upper Iowa.

"Our guys have been opening these holes up front all season, I just got to take care of the ball and be the tougher guy when I'm jersey No. 7," Cook joked after the 'Dogs picked up their first win against Wayne State (Mich.) a few weeks ago. "It's only going to get better there."

Cook was right.

The Bulldogs improve to 3-3 (2-1 GLVC) while Science & Technology drops to 2-4 (1-2).

First-year signal caller Dylan Hair completed 12 of his 15 attempts for 267 yards and four touchdowns. Redshirt freshman Jackson Overton, a St. Dominic product, continued his explosive season going for 106 yards and a trio of touchdowns on just four receptions.

The Daily Express is researching when, if ever, a Bulldog in his first year of full eligibility scored three all-purpose touchdowns in multiple games – especially within his first six. Overton had two receiving touchdowns and recovered a fumble in the endzone against Indianapolis.

Truman first-year head coach Kellen Nesbitt said everything is just a matter of the pieces coming together.


"It was our most complete team game of the season. Everyone was kind of clicking all at once, and they were fun to watch," he said. "Once it started rolling, it really went fast for us.

# Bulldogs propel into conference intermission with first win

After weeks of agonizing near-misses, the Bulldogs' volleyball team collected its first victory by defeating Southwest Baptist on Saturday. The irony is that this is the one match that didn't take Truman to five sets.

The 'Dogs took the first set 25-17 before grinding out a 29-27 set. The Bearcats dominated the third, 25-13, before Truman sealed it 25-20. The Bulldogs are now 1-16 overall and 1-4 in GLVC play. Although it is now 8-12 overall, SBU is now behind the 'Dogs in GLVC standings. The Bearcats fall to 0-5 in conference meetings.

After five consecutive losses that went all five sets, and 11 of their 16 matches overall ending that way, the win is just a relief the Bulldogs knew would come.

Following a five-set home loss to Quincy on Oct. 5, Bulldog junior outside hitter Jessica Proszenyak said that their time was around the corner.

Truman played its first 13 matches at home, and the Great Lakes Valley slate is still young, she said. She said, basically, her girls do not care what the Bulldogs' season had looked like on paper.

"Going into GLVC play, we have nothing to lose and we've shown these teams that we can play," the Lake in the Hills, Ill. native said. "I know we'll learn how to finish as a team. We came into conference play in last. If we're happy with the way that we played and that ends up a negative result at the end, we're still playing the way we want to be playing.

"Our motto has been resilience. We want to just go and touch the ball, and get as many touches as we can."

The timing of the 'Dogs first win could not have been better. They play a tournament in Hammond, Ind. beginning Oct. 18 and don't resume conference play until hosting William Jewell on Oct. 25. Truman hosts Rockhurst the following evening, and will still have six GLVC matches remaining following that back-to-back. trict, Marshall Public School, and Mexico Public

Schools, have made the difficult decision to dissolve the conference, effective at the end of the 2025-2026 school year.

### Proposed Amendments to the Constitution of Missouri and Statutory Propositions

To be submitted to the qualified voters of the State of Missouri at the General Election to be held on Tuesday, the 5th day of November, 2024.

#### CONSTITUTIONAL AMENDMENT NO. 2

[Proposed by Initiative Petition]

#### OFFICIAL BALLOT TITLE:

Do you want to amend the Missouri Constitution to:

- allow the Missouri Gaming Commission to regulate licensed sports wagering including online sports betting, gambling boats, professional sports betting districts and mobile licenses to sports betting operators;
- restrict sports betting to individuals physically located in the state and over the age of 21;
- allow license fees prescribed by the Commission and a 10% wagering tax on revenues received to be appropriated for education after expenses incurred by the Commission and required funding of the Compulsive Gambling Prevention Fund; and
- allow for the general assembly to enact laws consistent with this amendment?

State governmental entities estimate onetime costs of \$660,000, ongoing annual costs of at least \$5.2 million, and initial license fee revenue of \$11.75 million. Because the proposal allows for deductions against sports gaming revenues, they estimate unknown tax revenue ranging from \$0 to \$28.9 million annually. Local governments estimate unknown revenue.

NOTICE: The proposed amendment revises Article III of the Constitution by adopting one new section to be known as Article III, Section 39(g).

Be it resolved by the people of the state of Missouri that the Constitution be amended as follows:

Section A. Article III of the Constitution is revised by adopting one new Section to be known as Article III, Section 39(g) to read as follows:

Section 39(g) 1. The people of the state of Missouri hereby find and declare that the interests of the public are best served by a wellregulated sports wagering industry that will provide substantial tax revenue to support educational institutions in Missouri.

 Notwithstanding any other provision of law to the contrary, any entity licensed by the Commission pursuant to Article III, Section 39(g) may offer sports wagering;

 a. through an online sports wagering platform to individuals physically located in this state;

b. at excursion gambling boats; and

c. at any location within each sports district, as approved by each applicable professional sports team that plays its home games in such sports district.

 A licensee shall not offer sports wagering to individuals who are under twenty-one years of age.

4. a. The Commission shall issue not more than one retail license to operate sports wagering in this state to each qualified applicant that is:

(1) an excursion gambling boat or a sports wagering operator operating on behalf of each such excursion gambling boat that has applied for a retail license to offer sports wagering at such excursion gambling boat; or

(2) a professional sports team or a sports wagering operator designated by each such professional sports team that has applied for a retail license to offer sports wagering within the applicable sports district in which such professional sports team plays its home games.

b. The Commission shall issue not more than one mobile license to operate sports wagering in this state to each qualified applicant that is:

(1) an owner of an excursion gambling boat located in this state or a sports wagering operator operating on behalf of each such owner, provided, however, that not more than one sports wagering operator shall be permitted to operate under such mobile license on behalf of any entity, or group of commonly owned or controlled however, that such licensee shall also be permitted, but not required, to use the brand of a professional team or excursion gambling boat pursuant to a partnership with such entity. Notwithstanding any other provision of law to the contrary and subject to approval by the Commission, a person or entity may hold and operate more than one license under distinct sports wagering operator brands, regardless of whether multiple brands are owned by the same parent entity.

c. Commercial agreements between an excursion gambling boat or a professional sports team and a sports wagering operator shall be submitted to the Commission as agreed to by the contracting parties. The Commission shall not prescribe any terms or conditions that are required to be included into such commercial agreements. A sports governing body or professional sports team may enter into commercial agreements with sports wagering operators or other entities in which such sports governing body or professional sports teammay share in the amount wagered on sporting events of such sports governing body or professional sports team. A professional sports team may grant any such rights provided under this paragraph to its affiliate. Neither a sports governing body nor a professional sports team, nor such team's affiliate, is required to obtain a license or any other approval from the Commission to lawfully accept such amounts.

 d. Each mobile licensee shall determine, set, and display applicable lines, point spreads, odds, or other information pertaining to online sports wagering.

c. Any submission to the Commission under this section, including all documents, reports, and data submitted therewith, that contain proprietary information, trade secrets, financial information, or personal information about any person or entity shall be treated in the same confidential manner as submissions by other licensees of the Commission and shall not be subject to disclosure pursuant to Chapter 610 RSMo.

 All sports wagering fees prescribed by the Commission and collected by the state shall be appropriated as follows;

a, to reimburse the reasonable expenses incurred by the Commission to regulate sports wagering; and

b. to the extent all reasonable expenses incurred by the Commission have been reimbursed, the remaining fees shall be deposited in the Compulsive Gaming Prevention Fund.

9. Subject to and consistent with the terms of this section, the Commission shall have the power to adopt and enforce commercially reasonable rules, including emergency rules, to implement the provisions of this section. No rule or portion of a rule promulgated under the authority of this section shall become effective unless it has been promulgated pursuant to the provisions of Chapter 536. The Commission shall examine the rules implemented in other states where sports wagering is conducted and shall, as far as practicable, adopt a similar regulatory framework, including, but not limited to:

a. Standards governing the security and integrity of sports wagering, including requiring the use of official league data on the terms and conditions set forth below from each applicable sports governing body headquartered in the United States solely for the purposes of determining the outcome of tier two sports wagers on a professional athlete or sporting event, but only if made available to licensees on commercially reasonable terms. Sports wagering operators may use any data source for determining the results of any and all tier one sports wagers on any and all sporting events, and the results of any and all tier two sports wagers on sporting events of an organization that is not headquartered in the United States.

(1) A sports governing body may notify the Commission that it desires sports wagering operators to use official league data to settle tier two sports wagers on sporting events of such sports governing body. Such notification shall be made in the form and manner the Commission may require. The Commission shall notify each sports wagering operator of a sports governing body's notification within five days of the Commission's receipt of such notification. If a sports governing body does not notify the Commission of its desire to supply official league data, a sports wagering operator may use any data source for determining the results of any and all tier two sports wagers on sporting events of such sports governing body.

(2) Within 60 days of the Commission notifying each sports wagering operator of a sports governing body's notification to the Commission, or such longer period as may be agreed between the sports governing body and the applicable sports wagering operator, sports wagering operators shall use only official league data to determine the results of tier two sports wagers on sporting events of that sports governing body, unless: (a) The sports governing body or its designee cannot provide a feed of official league data to determine the results of a particular type of tier two sports wager, in which case sports wagering operators may use any data source for determining the results of the applicable tier two sports wager until such time as such a data feed becomes available from the sports governing body on commercially reasonable terms and conditions; conducted by law enforcement agencies, regulatory bodies, and sports governing bodies;

f. Standards for licensees and sports wagering operators to report to the Commission and the sports governing bodies information related to: abnormal betting activity or patterns that may indicate a concern with the integrity of a sporting event or events; suspicious or illegal betting activities if known to the applicable licensee or sports wagering operator; and any other conduct that corrupts a betting outcome of a sporting event or events for purposes of financial gain, including match fixing;

g. Standards for any sports governing body to submit to the Commission a written request to restrict, limit, or exclude a certain type, form, or category of sports betting with respect to a sporting event of that sports governing body, if the applicable sports governing body believes that such type, form, or category of sports wagering with respect to the sporting event of the sports governing body may undermine the integrity or perceived integrity of the applicable sports governing body, or sporting events of the applicable sports governing body.

These standards shall also require the Commission to request comment from sports wagering operators on all requests made pursuant to this paragraph and after giving due consideration to all comments received, the Commission shall, upon a demonstration of good cause from the applicable sports governing body that such type, form, or category of sports betting is likely to undermine the integrity or perceived integrity of such body or sporting events of the applicable sports governing body, grant the request.

These standards shall require the Commission to respond to a request concerning a sporting event before the start of the event, or, if it is not feasible to respond before the start of the event, no later than 7 days after the request is made, and if the Commission determines that the applicable sports governing body is more likely than not to prevail in successfully demonstrating good cause for its request, the Commission may provisionally grant the request of the applicable sports governing body pending the Commission's final determination thereon. Unless the Commission provisionally grants the request, sports wagering operators may continue to offer sports betting and accept bets on the covered sporting event pending a final determination by the Commission;

h. Requiring licensees and sports wagering operators to use commercially and technologically reasonable means to ensure that marketing and advertisements do not purposefully target minors or individuals who have self-excluded from sports wagering, are not false, misleading or deceptive, and clearly disclose the material terms of any offer included in any promotion or advertisement;

 Standards for the regulation of suppliers of sports wagering goods, services, software, or any other components necessary for the creation of sports wagering markets and determination of wager outcomes;

j. Standards for the implementation of responsible gaming programs, including using commercially reasonable efforts to verify that a person placing a bet on a sporting event is of the legal minimum age for placing such bet, displaying a hyperlink on its online sports wagering platform to responsible gaming information, allowing individuals to voluntarily exclude themselves from placing bets with the operator through a process established by the Commission, and allowing persons to place limits on their time, deposit, or bet limits in a daily, weekly, or monthly manner;

k. Establishing fines, placing licensees on probation, and revoking licenses for violations of this section. The Commission may impose fines upon any person holding, or required to hold, a license or approval under this section or the rules subsequently adopted. Fines shall not exceed \$50,000 per violation or \$100,000 resulting from violation of the same occurrence of events. The Commission shall promulgate rules relating to procedures for disciplinary hearings, including that any such decision may be appealed to circuit court;

1. Establishing a start date for all sports wagering that is not later than December 1, 2025. No sports wagering, either retail or mobile, shall be offered in the state before such start date established by the Commission. No category of license shall be given an earlier launch date over any other category of license; and

 m. Prohibiting all sports wagering activity, including sports wagering promotional and advertising activity, within a sports

entities, which owns, directly or indirectly, more than one excursion gambling boat located in this state; or

(2) a professional sports team or a sports wagering operator designated by each such professional sports team.

c. The Commission shall issue not more than two mobile licenses to operate sports wagering in this state directly to qualified applicants that are sports wagering operators. Each sports wagering operator shall only be eligible for one mobile license per distinct sports wagering operator brand. For purposes of Article III. Section 39(g) brand shall refer to the name, trade name, licensed trademark, or assumed business name of the sports wagering operator. If there are more than two qualified applicants for a mobile license to be issued by the Commission directly to a sports wagering operator under this section, the Commission shall select the applicant for licensure based on the applicant's ability to satisfy the following criteria:

(1) Expertise in the business of online sports wagering;

(2) Integrity, sustainability, and safety of the applicant's online sports wagering platform;

(3) Past relevant experience of the applicant;

(4) Advertising and promotional plans to increase and sustain revenue;

(5) Ability to generate, maximize, and sustain revenues for the state;

(6) Demonstrated commitment to and plans for the promotion of responsible gaming; and

(7) Capacity to increase the number of bettors on the applicant's online sports wagering platform.

5. An applicant for a license to conduct sports wagering shall apply to the Commission on a form and in the manner prescribed by the Commission. The Commission shall conduct background checks of each applicant or key persons of such applicant and shall not award a license to any applicant if such applicant or key person of such applicant has been convicted of a felony or any gambling offense in any state or federal court of the United States. If a professional sports team designates a sports wagering operator to operate on its behalf, then that sports wagering operator, rather than the professional sports team, shall submit to the Commission for licensure and shall be considered the licensee for all aspects of Commission oversight and regulatory control. In the application, the Commission shall require applicants to disclose the identity of all of the following;

 a. The applicant's principal owners who directly own 10% or more of the applicant;

b. Each holding, intermediary, or parent company that directly owns 15% or more of the applicant; and

c. The applicant's board appointed chief executive officer and chief financial officer, or the equivalent individuals, as determined by the Commission.

Retail and mobile license applicants shall be required to pay a license fee as follows:

a. An applicant for a retail license shall be required to pay a license fee prescribed by the Commission, not to exceed \$250,000. Retail licensees shall be required to pay a license renewal fee every five years, as prescribed by the Commission, not to exceed \$250,000.

b. An applicant for a mobile license shall be required to pay a license fee prescribed by the Commission, not to exceed \$500,000. Mobile licensees shall be required to pay a license renewal fee every five years, as prescribed by the Commission, not to exceed \$500,000.

 a. A license for sports wagering shall not be assignable or transferable without approval of the Commission. Such approval shall not be unreasonably withheld.

 b. A license shall authorize a licensee to offer sports wagering under not more than one sports wagering operator brand, provided, (b) A sports wagering operator can demonstrate to the Commission that the sports governing body or its designee will not provide a feed of official league data to the sports wagering operator on commercially reasonable terms and conditions; or

(c) The sports governing body or its designee does not obtain the necessary supplier approvals to provide official league data to sports wagering operators to determine the results of tier two sports wagers, if and to the extent required by law.

(3) The following is a non-exclusive list of factors that the Commission may consider in evaluating official league data is being offered on commercially reasonable terms and conditions for the purposes of paragraphs (a) and (b) of subsection (2):

(a) The availability of a sports governing body's tier two official league data to a sports wagering operator from more than one authorized source;

(b) Market information, including, but not limited to, price and other terms and conditions, regarding the purchase by sports wagering operators of comparable data for the purpose of settling sports wagers in this state and other jurisdictions;

(c) The nature and quantity of data, including the quality and complexity of the process utilized for collecting such data; and

(d) The extent to which sports governing bodies or their designees have made data used to settle tier two bets or wagers available to operators and any terms and conditions relating to the use of that data.

(4) Notwithstanding anything set forth to the contrary herein, including without limitation subparagraph (3), during the pendency of the Commission's determination as to whether a sports governing body or its designee will provide a feed of official league data on commercially reasonable terms, a sports wagering operator may use any data source for determining the results of any and all tier two sports wagers. The Commission's determination shall be made within 120 days of the sports wagering operator notifying the Commission that it desires to demonstrate that the sports governing body or its designee will not provide a feed of official league data to the sports wagering operator on commercially reasonable terms.

b. Standards concerning a licensee's books and financial records relating to sports wagering, including auditing requirements, standards for the daily counting of a licensee's gross receipts from sports wagering, and standards to ensure that internal controls are followed;

c. Standards for the use and distribution of monies from the Compulsive Gaming Prevention Fund shall include, but not be limited to, research, detection, and prevention of compulsive gaming, the implementation of treatment and recovery programs, or services related to compulsive gaming in this state;

d. Standards concerning the detection and prevention of compulsive gaming including, but not limited to, requirements to prominently display information regarding compulsive gaming on all online sports wagering platforms and promotions;

e. Requiring licensees to cooperate with investigations

district, unless approved by the professional sports team that plays its home games within the district, except such rules shall not prohibit any licensee from offering sports wagering through an online sports wagering platform to persons physically located within a sports district.

10. a. Notwithstanding any other provision of law, including Article III Section 39(d), to the contrary, a wagering tax of 10% is imposed on the adjusted gross revenue received from sports wagering conducted by each licensee and each sports wagering operator acting on behalf of a licensee.

b. The annual revenues received from such tax shall be appropriated for institutions of elementary, secondary, and higher education in this state; provided, however, that an appropriation to such educational institutions shall be made only after such annual wagering tax revenues are appropriated as follows;

(1) to reimburse the reasonable expenses incurred by the Commission to regulate sports wagering in the state to the extent that the Commission has not been fully reimbursed for such expenses from the sports wagering fees collected by the state; and

(2) the greater of 10% of such annual tax revenues or \$5,000,000 to the Compulsive Gaming Fund.

c. Such revenues shall not be included within the definition of "total state revenues" in Section 17 of Article X of this Constitution.

d. The state auditor shall perform an annual audit of the revenues received and appropriated pursuant to this section to ensure they are being used only for authorized purposes. The state auditor shall make such audit available to the public, the governor, and the general assembly.

11. A mobile licensee shall maintain in this state, or any other location approved by the Commission and consistent with federal law, the computer server or servers used to receive transmissions of requests to place wagers and that transmit confirmation of acceptance of wagers on sports events placed by customers physically present in this state.

12. All wagers authorized under this section must be initiated, made, or otherwise placed by a bettor while physically present within this state. The intermediate routing of electronic data related to lawful intrastate wagers authorized under this section shall not determine the location or locations in which the bet is initiated, transmitted, received, or otherwise made. Each online sports wagering operator shall use commercially reasonable geolocation and geofencing technology to ensure that it accepts bets only from customers who, at the time of placing the bet, are physically present in this state.

 a. An individual wagering in this state shall establish an online sports wagering account with an online sports wagering operator;

(1) over the Internet;

(2) through an online sports wagering platform; or

(3) through other means approved by the Commission.

b. An individual wagering in this State shall not register more than one account with each online sports wagering platform. Mobile licensees shall use commercially reasonable means to ensure that each customer is limited to one account per platform.

c. Permissible methods of funding and withdrawal for accounts include, but are not limited to, credit cards, debit cards, gift cards, reloadable prepaid cards, free and promotional credit, automated clearing house transfers, online and mobile payment systems that support online money transfers, and wire transfers. The Commission may approve additional funding and withdrawal methods including, but not limited to, cash deposits at approved locations and secure cryptocurrencies.

14. a. A sports wagering operator shall use commercially and technologically reasonable means to ensure marketing and

#### OFFICIAL BALLOT TITLE:

- Do you want to amend Missouri law to:
- increase minimum wage January 1, 2025 to \$13.75 per hour, increasing \$1.25 per hour each year until 2026, when the minimum wage would be \$15.00 per hour;
- adjust minimum wage based on changes in the Consumer Price Index each January beginning in 2027;
- require all employers to provide one hour of paid sick leave for every thirty hours worked;
- allow the Department of Labor and Industrial Relations to provide oversight and enforcement; and
- exempt governmental entities, political subdivisions school districts and education institutions?

State governmental entities estimate one-time costs ranging from \$0 to \$53,000, and ongoing costs ranging from \$0 to at least \$256,000 per year by 2027. State and local government tax revenue could change by an unknown annual amount depending on business decisions.

#### Be it enacted by the people of the state of Missouri:

Chapter 290, RSMo, is amended by amending section 290.502 and enacting fifteen new sections to be known as sections 290.600, 290.603, 290.606, 290.609, 290.612, 290.615, 290.618, 290.621, 290.624, 290.627, 290.630, 290.633, 290.636, 290.639, and 290.642, to read as follows:

290.502. 1. Except as may be otherwise provided pursuant to sections 290.500 to 290.530, effective January 1, 2007, every employer shall pay to each employee wages at the rate of \$6.50 per hour, or wages at the same rate or rates set under the provisions of federal law as the previling federal minimum wage applicable to those covered jobs in interstate commerce, whichever rate per hour is higher.

2. The minimum wage shall be increased or decreased on January 1, 2008, and on January 1 of successive years, by the increase or decrease in the cost of living. On September 30, 2007, and on each September 30 of each successive year, the director shall measure the increase or decrease in the cost of living by the percentage increase or decrease as of the preceding July over the level as of July of the immediately preceding year of the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) or successor index as published by the U.S. Department of Labor or its successor agency, with the amount of the minimum wage increase or decrease rounded to the nearest five cents.

3. Except as may be otherwise provided pursuant to sections 290.500 to 290.530, and notwithstanding subsection 1 of this section, effective January 1, [2019] 2025, every employer shall pay to each employee wages at the rate of not less than [\$8.60] \$13.75 per hour, or wages at the same rate or rates set under the provisions of federal law as the prevailing federal minimum wage applicable to those covered jobs in interstate commerce, whichever rate per hour is higher. Thereafter, the minimum wage established by this subsection shall be increased [each year] by [\$.85] \$1.25 per hour, [effective January 1 of each of the next four years, until it reaches \$12.00 per hour] to \$15.00 per hour, effective January 1, [2023] 2026. Thereafter, the minimum wage established by this subsection shall be increased or decreased on January 1, [2024] 2027, and on January 1 of successive years, per the method set forth in subsection 2 of this section. If at any time the federal minimum wage rate is above or is thereafter increased above the minimum wage then in effect under this subsection, the minimum wage required by this subsection shall continue to be increased pursuant to this subsection 3, but the higher federal rate shall immediately become the minimum wage required by this subsection and shall be increased or decreased per the method set forth in subsection 2 for so long as it remains higher than the state minimum wage required and increased pursuant to this subsection. 4. For purposes of this section, the term "public employer" means an employer that is the state or a political subdivision of the state, including a department, agency, officer, bureau, division, board, commission, or instrumentality of the state, or a city, county, town, village, school district, or other political subdivision of the state. Subsection 3 of this section shall not apply to a public employer with respect to its employees. Any public employer that is subject to subsections 1 and 2 of this section shall continue to be subject to those subsections.

(J) Any individual employed by a retail or service business whose annual gross volume sales made or business done is less than five hundred thousand dollars;

(L) Any individual described by the provisions of section 29 U.S.C. 213(a)(8).

(6) "Employer", any person acting directly or indirectly in the interest of an employer in relation to an employee; provided, however, that for the purposes of sections 290.600 through 290.642 "employer" does not include the United States Government, the state, or a political subdivision of the state, including a department, agency, officer, bureau, division, board, commission, or instrumentality of the state, or a city, county, town, village, school district, public higher education institution, or other political subdivision of the state.

(7) "Family member", any of the following individuals:

(A) Regardless of age, a biological, adopted or foster child, stepchild or legal ward, a child of a domestic partner, a child to whom the employee stands in loco parentis, or an individual to whom the employee stood in loco parentis when the individual was a minor;

(B) A biological, foster, stepparent or adoptive parent or legal guardian of an employee or an employee's spouse or domestic partner or an individual who stood in loco parentis when the employee or employee's spouse or domestic partner was a minor child;

(C) An individual to whom the employee is legally married under the laws of any state, or a domestic partner who is registered as such under the laws of any state or political subdivision, or an individual with whom the employee is in a continuing social relationship of a romantic or intimate nature;

(D) A grandparent, grandchild, or sibling (whether of a biological, foster, adoptive or step relationship) of the employee or the employee's spouse or domestic partner; or

(E) A person for whom the employee is responsible for providing or arranging health or safety-related care, including but not limited to helping that individual obtain diagnostic, preventative, routine, or therapeutic health treatment or ensuring the person is safe following domestic violence, sexual assault, or stalking.

(8) "Health care professional," any individual licensed under federal or any state law to provide medical or emergency services, including but not limited to doctors, nurses, certified nurse midwives, mental health professionals, and emergency room personnel.

(9) "Person", any individual, partnership, association, corporation, business, business trust, legal representative, or any organized group of persons.

(10) "Retaliatory personnel action", denial of any right guaranteed under sections 290.600 through 290.642, or any threat, discharge, suspension, demotion, reduction of hours, or any other adverse action against an employee for the exercise of any right guaranteed herein. "Retaliatory personnel action" shall also include interference with or punishment for in any manner participating in or assisting an investigation, proceeding, or hearing under sections 290.600 through 290.642.

(11) "Same hourly rate", means the following:

(A) For employees paid on the basis of a single hourly rate, the same hourly rate shall be the employee's regular hourly rate.

(B) For employees who are paid multiple hourly rates of pay from the same employer, the same hourly rate shall be either:

(i) the wages the employee would have been paid for the hours absent during use of earned paid sick time if the employee had worked; or,

(ii) the weighted average of all hourly rates of pay during the previous pay period.

Whatever method the employer uses, the employer must use a consistent method for each employee throughout a year.

(C) For employees who are paid a salary, the same hourly rate shall be determined by dividing the wages the employee earns in the previous pay period by the total number of hours worked during the previous pay period. For determining total number of hours worked during the previous pay period, employees who are exempt from overtime requirements under 29 U.S.C. § 213(a)(1), the Fair Labor Standards Act, shall be assumed to work 40 hours in each work week unless their normal work week is less than 40 hours, in which case earned paid sick time shall accrue and the same hourly rate shall be calculated based on the employee's normal work week. Regardless of the basis used, the same hourly rate shall not be less than the effective minimum wage specified in section 290,502. (D) For employees paid on a piece rate or a fee-for-service basis. the same hourly rate shall be a reasonable calculation of the wages or fees the employee would have received for the piece work, service, or part thereof, if the employee had worked. Regardless of the basis used, the same hourly rate shall not be less than the effective minimum wage specified in section 290.502.

(4) The costs of free play or promotional credits provided to and redeemed by the applicable licensee's customers, provided that the aggregate amount of such costs of free play or promotional credits that may be deducted under this paragraph in any calendar month shall not exceed twenty-five percent of the total of all cash and cash equivalents received by the applicable licensee for such calendar month;

(5) Any sums paid as a result of any federal tax, including federal excise tax; and

(6) Uncollectible sports wagering receivables, not to exceed two percent of the total of all sums, less the amount paid out as winnings to sports wagering customers

(7) If the amount of adjusted gross receipts in a calendar month is a negative figure, the licensee shall remit no sports wagering tax for that calendar month. Any negative adjusted gross receipts shall be carried over and calculated as a deduction in the subsequent calendar months until the negative figure has been brought to a zero balance.

b. "Commission." means the Missouri Gaming Commission:

 c. "Excursion gambling boat," means an excursion gambling boat or floating facility as described in Article III, Section 39(e);

d. "License." means any retail license or mobile license.

Be it resolved by the people of the state of Missouri that the Constitution be amended:

Section A. Article I of the Constitution is revised by adopting one new Section to be known as Article I, Section 36 to read as follows:

Section 36. 1. This Section shall be known as "The Right to Reproductive Freedom Initiative."

2. The Government shall not deny or infringe upon a person's fundamental right to reproductive freedom, which is the right to make and carry out decisions about all matters relating to reproductive health care, including but not limited to prenatal care, childbirth, postpartum care, birth control, abortion care, miscarriage care, and respectful birthing conditions.

3. The right to reproductive freedom shall not be denied, interfered with, delayed, or otherwise restricted unless the Government demonstrates that such action is justified by a compelling governmental interest achieved by the least restrictive means. Any denial, interference, delay, or restriction of the right to reproductive freedom shall be presumed invalid. For purposes of this Section, a governmental interest is compelling only if it is for the limited purpose and has the limited effect of improving or maintaining the health of a person seeking care, is consistent with widely accepted clinical standards of practice and evidence-based medicine, and does not infringe on that person's autonomous decision-making.

4. Notwithstanding subsection 3 of this Section, the general assembly may enact laws that regulate the provision of abortion after Fetal Viability provided that under no circumstance shall the Government deny, interfere with, delay, or otherwise restrict an abortion that in the good faith judgment of a treating health care professional is needed to protect the life or physical or mental

Any license issued before or after the adoption date of this amendment for any excursion gambling boat or floating facility located in any such artificial space shall be deemed to be authorized by the General Assembly and to be in compliance with this Section.

2. Notwithstanding any other provision of law to the contrary, lotteries, gift enterprises, and games of chance may be conducted on excursion gambling boats and floating facilities licensed by the Missouri Gaming Commission upon the portion of the Osage River from the Missouri River to the Bagnell Dam, which shall include artificial spaces that contain water and that are within 500 feet of the 100-year base flood elevation as established by the Federal Emergency Management Agency.

3. Notwithstanding any other provision of law to the contrary, in addition to such licenses as have been authorized prior to January 1, 2024, the Missouri Gaming Commission shall issue one additional excursion gambling boat license. Such license shall only be issued to an excursion gambling boat that will operate upon the portion of the Osage River from the Missouri River to the Bagnell Dam.

4. Notwithstanding any other provision of law to the contrary, all state revenues derived from the issuance of excursion gambling boat licenses issued after January 1, 2024 shall only be appropriated to early-childhood literacy programs in public institutions of elementary education and shall not be included within the definition of "total state revenues" in section 17 of article X of this constitution.

5. The state auditor shall perform an annual audit of the revenues received and appropriated pursuant to this section to ensure they are being used only for authorized purposes. The state auditor shall make such audit available to the public, the governor, and the general assembly.

[Proposed by the 102nd General Assembly (Second Regular Session) SS SCS SJR 71]

#### OFFICIAL BALLOT TITLE:

Shall the Missouri Constitution be amended to provide that the administration of justice shall include the levying of costs and fees to support salaries and benefits for certain current and former law enforcement personnel?

State and local governmental entities estimate an unknown fiscal impact.

Submitting to the qualified voters of Missouri, an amendment repealing section 14 of article I of the Constitution of Missouri, and adopting one new section in lieu thereof relating to the administration of justice.

Be it resolved by the Senate, the House of Representatives concurring therein:

That at the next general election to be held in the state of Missouri, on Tuesday next following the first Monday in November, 2024, or at a special election to be called by the governor for that purpose, there is hereby submitted to the qualified voters of this state, for adoption or rejection, the following amendment to article I of the Constitution of the state of Missouri:

Section A. Section 14, article I, Constitution of Missouri, is repealed and one new section adopted in lieu thereof, to be known as section 14, to read as follows:

Section 14. 1. That the courts of justice shall be open to every person, and certain remedy afforded for every injury to person, property or character, and that right and justice shall be administered without sale, denial or delay.

2. In order to ensure that all Missourians have access to the courts of justice as guaranteed by this Constitution, the administration of justice shall include the levying of costs and

When there is a separation from employment and the employee is rehired within nine months of separation by the same employer, previously accrued earned paid sick time that had not been used shall be reinstated. Further, the employee shall be entitled to use accrued earned paid sick time and accrue additional earned paid sick time at the re-commencement of employment.

(E) When a different employer succeeds or takes the place of an existing employer, all employees of the original employer who remain employed by the successor employer are entitled to all earned paid sick time they accrued when employed by the original employer, and are entitled to use earned paid sick time previously accrued.

(F) At its discretion, an employer may loan earned paid sick time to an employee in advance of accrual by such employee.

5. Any employer with a paid leave policy, such as a paid time off policy, who makes available an amount of paid leave sufficient to meet the accrual requirements of this section that may be used for the same purposes and under the same conditions as earned paid sick time under sections 290.600 through 290.642 is not required to provide additional paid sick time under this section.

6. Except as specifically provided in this section, nothing in this section shall be construed as requiring financial or other reimbursement to an employee from an employer upon the employee's termination, resignation, retirement, or other separation from employment for accrued earned paid sick time that has not been used.

7. Employees shall not accrue earned paid sick time before May 1, 2025. Employees who are employed or who commence employment on or after May 1, 2025 shall accrue earned paid sick time and be entitled to use earned paid sick time as it is accrued in accordance with sections 290.600 through 290.642. The Department may develop model posters and notices, engage in rulemaking, initiate outreach programs, and engage in other activities for implementation of the provisions of sections 290.600 through 290.642 as authorized by those sections before May 1, 2025.

290.606. 1. Earned paid sick time shall be provided to an employee by an employer for:

(A) An employee's mental or physical illness, injury, or health condition; an employee's need for medical diagnosis, care, or treatment of a mental or physical illness, injury, or health condition; an employee's need for preventative medical care;

(C) An employer may not require that the documentation explain the nature of the illness, details of the underlying health needs, or the details of the domestic violence, sexual assault, or stalking, unless otherwise required by law,

290.609. 1. It shall be unlawful for an employer or any other person to interfere with, restrain, or deny the exercise of, or the attempt to exercise, any right protected under sections 290.600 through 290.642.

2. An employer shall not take retaliatory personnel action or discriminate against an employee or former employee because the individual has exercised rights protected under sections 290.600 through 290.642. Such rights include, but are not limited to, the right to request or use earned paid sick time pursuant to sections 290.600 through 290.642; the right to file a complaint or inform any person about any employer's alleged violation of sections 290.600 through 290.642; the right to participate in any investigation, hearing, or proceeding or cooperate with or assist the Department in any investigations of alleged violations of sections 290,600 through 290.642; and the right to inform any person of his or her potential rights under sections 290.600 through 290.642.

3. It shall be unlawful for an employer's absence control policy to count earned paid sick time taken under sections 290.600 through 290.642 as an absence that may lead to or result in discipline, discharge, demotion, suspension, or any other adverse action.

4. Protections of this section shall apply to any individual who mistakenly but in good faith alleges violations of sections 290.600 through 290,642.

290.612. 1. Employers shall give employees a written notice about earned paid sick time within fourteen calendar days of the commencement of employment or on April 15, 2025, whichever is later, which must include the following information: (1) beginning May 1, 2025, employees accrue and are entitled to earned paid sick time at the rate one hour of earned paid sick time for every 30 hours of work, and may use earned paid sick time, subject to the limits and terms under sections 290.600 through 290.642 of Missouri law, (2) it is prohibited for an employer to take retaliatory personnel action against employees who request or use earned paid sick time as allowed by law. When the use of earned paid sick time is foreseeable, the employee shall make a good faith effort to provide notice of the need for such time to the employer in advance of the use of the earned paid sick time and shall make a reasonable effort to schedule the use of earned paid sick time in a manner that does not unduly disrupt the operations of the employer. Where such need is not foreseeable, an employer may require an employee to provide notice of the need for the use of earned paid sick time as soon as practicable.

 An employer that requires notice of the need to use earned paid sick time where the need is not foreseeable shall provide a written policy that contains procedures for the employee to provide notice. An employer that has not provided to the employee a copy of its written policy for providing such notice shall not deny earned paid sick time to the employee based on non-compliance with such a policy.

5. An employer may not require, as a condition of an employee's taking earned paid sick time, that the employee search for or find a replacement worker to cover the hours during which the employee is using earned paid sick time.

6. Earned paid sick time may be used in the smaller of hourly increments or the smallest increment that the employer's payroll system uses to account for absences or use of other time.

7. For earned paid sick time of three or more consecutive work days, an employer may require reasonable documentation that the earned paid sick time has been used for a purpose covered by subsection (1) of this section.

(A) Documentation signed by a heath care professional indicating that earned paid sick time is necessary shall be considered reasonable documentation for purposes of this section.

(B) In cases of domestic violence, sexual assault, or stalking, if the employer requests, one of the following types of documentation selected by the employee shall be considered reasonable documentation: (i) a police report indicating that the employee or the employee's family member was a victim of domestic violence. sexual assault, or stalking, (ii) a written statement from an employee or agent of a victim service provider affirming that the employee or employee's family member is or was receiving services from a victim service provider; (iii) documentation signed by a health care professional from whom the employee or employee's family member sought assistance relating to domestic violence, sexual assault, or stalking or the effects thereof; (vi) a court document indicating that an employee or employee's family member is or was involved in a legal action related to domestic violence, sexual assault, or stalking; or (v) a written statement from the employee affirming that the employee or employee's family member is taking or took earned paid sick time for a qualifying purpose of subsection 290.618. 1. The Department may, in accordance with chapter

536, promulgate rules for the implementation, enforcement, and administration of sections 290.600 through 290.642. Any rule or portion of a rule, as that term is defined in section 536.010. that is created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with the general assembly pursuant to chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after November 5, 2024. shall be invalid and void.

2. Nothing in this section shall be interpreted or applied, either expressly or through practical necessity, to require the promulgation or adoption of rules if it requires the appropriation of funds to cover the costs of such acts.

290.621. 1. The Department may investigate and ascertain compliance with sections 290.600 through 290.642, establish and implement a system to receive complaints regarding non-compliance with sections 290.600 through 290.642 and to investigate and attempt to resolve complaints between the complainant and the subject of the complaint, and establish additional means of enforcement, including requiring by subpoena the testimony of witnesses and production of books, records, and other evidence relative to any matter under investigation or hearing, issuing notices of violation, holding hearings on notices of violation, making determinations, recovering unpaid earned sick time, and imposing fines for willful violations of up to \$500 per day of each day of a continuing violation. A final decision of the department is subject to review in accordance with the provisions of chapter 536.

2. The Department may develop and implement an outreach program to inform employees, parents, and persons who are under the care of a health care provider about the availability of earned paid sick time under sections 290.600 through 290.642. This program may include the distribution of notices and other written materials to child care and elder care providers, domestic violence shelters, schools, hospitals, community health centers and other health care providers in Missouri.

3. A municipality, county, city, town, or village may adopt ordinances, rules, and regulations to investigate and ascertain compliance with sections 290.600 through 290.642, establish and implement a system to receive complaints regarding non-compliance with sections 290.600 through 290.642 and to investigate and attempt to resolve complaints between the complainant and the subject of the complaint, and establish additional means of enforcement, with respect to employers within, or employees performing work while physically present in, the geographic boundaries of the municipality, county, city, town, or village. Any such ordinance, rule, or regulation shall be consistent with this law and any Department rules or regulations and system for compliance and enforcement. The municipality, county, city, town, or village may exercise such powers as allowed by any applicable charter or ordinance, including requiring by subpoena the testimony of witnesses and production of books, records, and other evidence relative to any matter under investigation or hearing, issuing notices of violation, holding hearings on notices of violation, making determinations, recovering unpaid earned sick time, and imposing fines for willful violations of up to the maximum allowed for an ordinance violation. Before investigating or seeking to resolve any complaint between the complainant and the subject of the complaint, the municipality, county, city, town, or village shall give notice to the Department with a copy of the complaint and, within 14 days of such notice, the Department may intervene as of right through 290.642 shall be deemed contrary to public policy and shall be void

290.636.1. Nothing in sections 290.600 through 290.642 shall be construed to discourage or prohibit an employer from the adoption or retention of an earned paid sick time policy more generous than the one required herein.

2. Nothing in sections 290.600 through 290.642 shall be construed as diminishing the obligation of an employer to comply with any contract, collective bargaining agreement, employment benefit plan, or other agreement providing more generous paid sick time to an employee than required herein. Nothing in sections 290.600 through 290.642 shall be construed as diminishing the rights of public employees regarding paid sick time or use of paid sick time as provided in the laws of Missouri and ordinances of political subdivisions pertaining to public employees.

290.639.1. Sections 290.600 through 290.642 provide minimum requirements pertaining to earned paid sick time and shall not be construed to preempt, limit, or otherwise affect the applicability of any other law, regulation, requirement, policy, or standard that provides for greater accrual or use by employees of earned paid sick time or that extends other protections to employees.

2. Nothing in sections 290.600 through 290.642 shall be interpreted or applied to create a power or obligation contrary to any federal law, rule, or regulation.

290.642. Except as detailed in section 290.618, all of the provisions of sections 290.600 through 290.642 are severable, and if any provision, including any section, subsection, subdivision, paragraph, sentence, or clause, or the application thereof to any person or circumstance, is found by a court of competent jurisdiction to be invalid, unconstitutional, or unconstitutionally enacted, such decision shall not affect other provisions or applications of sections 290.600 through 290.642 that can be given effect without the invalid, unconstitutional, or unconstitutionally enacted provision or application, and to this end the provisions of sections 290,600 through 290.642 are declared severable.




