## With ad hoc committee report complete, Supervisors to mull future of Pine Crest

MERRILL – The Lincoln County Board of Supervisors is expected to weigh numerous options regarding the future of Pine Crest Nursing Home in Merrill.

Pine Crest, which has operated in Merrill for about 70 years and is owned by Lincoln County, has experienced financial losses in recent years, prompting the board to form a committee to explore the nursing home's viability and the county's options moving forward.

During its meeting at the Lincoln County Service Center in Merrill on Tuesday, March 21, the board heard a summary of a report developed by the Pine Crest Ad Hoc Committee.

Formed in June 2022, the committee was tasked with reviewing the nursing home's current and potential future financial obligations, the use of the building and grounds and the agreement between Lincoln County and North Central Health Care (NCHC). Lincoln County transferred management responsibilities to NCHC in 2019.

The committee was also directed to prepare a report on its findings and provide the board with recommendations on areas for improvement regarding the county's overall position concerning Pine Crest.

The committee is made up of District 1 Supervisor William Bialecki, District 15 Supervisor Marty Lemke, District 18 Supervisor Ken Wickham, District 20 Supervisor Angela Cummings and District 22 Supervisor Greg Hartwig.

Wickham, who serves as chair of the committee, walked the board through a summary of the nearly 170-page report, released on Tuesday, March 21.

The first topic Wickham discussed was the past and present use of the Pine Crest building and grounds.

The original Pine Crest facility was constructed in

the mid-1950s. In several phases over the following decades, the nursing home gradually moved to its current location on E. 6th St. in Merrill.

Wickham said that according to records, Pine Crest originally had 180 bed licenses. The Pine Crest Board of Trustees scaled that number down to 160 in 2019. Two years later, another reduction brought the number of bed licenses down to 120, where it stands today.

The nursing home is currently occupied by an

average of 85 residents. Wickham said Pine Crest's occupancy has decreased in recent years, noting that the facility had as many as 150 to 160 residents prior to about six years ago.

Wickham also highlighted the county's financial obligations regarding Pine Crest.

Lincoln County is responsible for about \$1.5 million in recurring expenses that the county can plan and budget for each year. Among these costs are the roughly \$440,000.00 provid-

ed from the tax levy and the approximately \$300,000.00 in salaries and fringe benefits for maintenance staff as-

signed to Pine Crest.

Each year through 2038,
Lincoln County is also responsible for \$630,000.00
for debt service owed for existing bonding on loans on Pine Crest, Wickham said, adding that the current principal on Pine Crest is just over \$8 million, with about \$2 million interest.

When discussing non-recurring expenses, Wickham said Pine Crest is in need of "significant maintenance."

In 2019, Lincoln County contracted with a private consultant to conduct an assessment of the nursing home, which found that between \$8 million and \$11 million in maintenance will be necessary over the next ten years. The facility's windows, HVAC systems and parking lot are among the areas in need of work.

Another non-recurring expense Wickham made note of is the roughly \$1.2 million that NCHC requested from Lincoln County in February to cover losses at

Pine Crest.

A Wednesday, March 22 release from NCHC said the losses were due to "the State of Wisconsin's changes in how Supplemental Payments are distributed, additional reductions in the Certified Public Expenditure (CPE) payments, as well as a substantial reduction in Medicaid Supplemental Payment Program (SP)."

NCHC Executive Director Gary Olsen said in the release that Pine Crest would have ended 2022 with a gain had those revenue payments from the State not been altered or reduced.

In a letter to Governor Tony Evers dated Friday, March 17, Board Chair Don Friske asked the governor to "direct the Department of Health Services to reallocate the Supplemental Payment or in some other way make (Lincoln County) whole for the 2022 and 2023 annual county budget cycles."

GREEN BAY - Multi Media Channels (MMC), the publisher of the Tomahawk Leader, has purchased the Kewaunee County Star-News from Gannett Co., Inc.

Kewaunee is roughly 30 miles east of Green Bay.

MMC CEO Patrick Wood said that the company plans to invest heavily in local news there, covering school and municipal events.

"Local is the most important part of what we do," he said. "We believe strongly that consistent, honest reporting of everything local

in Kewaunee, Luxemburg, Casco and Algoma will enrich the vibrancy of our region, as well as making our governments even stronger through open and honest accountability."

The publication will also be transitioned to U.S. Mail delivery, with a 10,000-copy circulation.

MMC began its work in community newspaper publishing in Denmark, Wis., in 1953. Under the leadership of its founder, Frank Wood, the business expanded into other mar-

Today, the company remains in the Wood family, owned and operated by both family members and employees, publishing more than 30 print publications, including 22 weeklies and 17 digital channels that serve the central, northern and eastern regions of Wisconsin.

The sale closed on Monday, March 27.

## THS alum Kristin Ramassini recognized as Coast Guard Base National Capital Region Spouse of the Year

Challenges, alternative solutions

Wickham also pointed to several "challenges" Lincoln County faces regarding Pine Crest, as well as alternative solutions for the nursing home's future.

Among the challenges Wickham noted were costs for ongoing and needed maintenance at the 30-year old facility, a declining population at the nursing home and staffing shortages within the healthcare industry.

Wickham also walked the board through several potential actions the county could take moving forward.

Wickham noted that the committee does not endorse or recommend any of the

alternatives, and "none of them are mutually exclusive to themselves."

"It really boils down to two alternatives - either Lincoln County continues to operate Pine Crest as a countyowned nursing home, or we don't," he stated.

Wickham touched on an array of options that could be on the table if Lincoln County chooses to continue its ownership of the facility, including exploring ways to cut costs and generate additional revenues, pursuing a management arrangement with an entity other than NCHC and downsizing the facility.

In the event that Lincoln County were to cease its operation of Pine Crest, Wickham said the county could

consider finding alternative uses for the facility or selling the property.

Wickham also suggested the option of holding a referendum to allow Lincoln County voters to decide whether or not the county should continue to operate Pine Crest. A potential referendum could ask taxpayers for \$3 million to \$4 million per year to allow the county to continue its operation of the nursing home, Wickham estimated.

Readers are invited to submit questions about God, the Bible, and religion. I shall try to answer them for you, using the Bible as the authority for my answers.

Over the last few weeks I have suggested that we should read the Bible with the intent of learning who God is and what He says. A few weeks back we looked at the meaning of the words faith and believe. Today we shall continue looking at why people may not believe or have faith in God. We have looked at why religious and nonreligious people do not believe, this week we shall look at why people continue to not believe or have faith in God unless the Holy Spirit convicts them of their need for God. We shall look at Psalm 10.

The first verses begin with a question: Why do you stand afar off, O LORD? why do you hide yourself in times of trouble? The wicked in his pride persecutes the poor: let them be taken in the devices that they have imagined. The Psalmist asks God why He doesn't do something about those who treat others badly; he suggests that God should make sure they get caught in the traps they have set for others. He calls the people doing wrong, the wicked.

In the Bible, the idea of being wicked does not mean you are always doing bad things; it simply means that you don't care what God says about what you do. We can be wicked and still do good things; it is just that we do good things for our own personal reasons and not because God says it is right. But if we are wicked, it is more likely that we will do wrong. Psalm 10 focuses on why the wicked continue to behave wickedly.

In verses 4 and 5 we read, The wicked, through the pride of his countenance, will not seek after God: God is not in all his thoughts. ...your judgments are far above out of his sight. In other words, they are not thinking about God to begin with, and when they are confronted about what God says about their activities, they cannot understand.

In verse 11 we read, He has said in his heart, God has forgotten: he hides his face; he will never see it. The thought is, God has not judged me yet, it is probable that He isn't even looking.

In verse 13 we read, Why does the wicked contemn God? he has said in his heart, You will not require it. Why does the wicked despise or mock God (contemn)? He does not think God will ever hold him accountable for his actions. This goes back to the question in verse 1 where God is asked why He seem to be hiding from all the bad things going on? In other places the Bible tells us God does not judge us in this life, but after we die (Hebrews 9:27). Instead, this life is our opportunity to repent and find forgiveness so we will not have to face God's judgment (Romans 2:3-6). But the wicked, they will only see the absence of God's judgment upon them as proof that they can do whatever they want without being judged, because they do not want to think God will ever judge them (Psalm 92:6,7).

## Two facing drug-related charges following execution of search warrant at City of Tomahawk residence

TOMAHAWK - Two people are facing drug-related charges following the execution of a search warrant at a residence in the City of Tomahawk.

In a Thursday, March 23 post on the Tomahawk Police Department's Facebook page, Chief Al Elvins said a search warrant was executed at a residence on the 200 block of Hillcrest Dr. in Tomahawk as part of an investigation into the sale, distribution and possession of controlled substances.

As a result of the execution of the search warrant, David W. Fish, 41, and Crystal L. Dean, 34, were taken into custody and transported to the Lincoln County Jail. Each is charged with felony counts of maintaining a drug dwelling, possession of methamphetamine and manufacturing and/or delivery of tetrahydrocannabinols, according to the

Fish and Dean were also each charged with a misdemeanor count of possession of drug paraphernalia, and Fish was also wanted on a probation warrant, the post

"In addition to the marijuana and methamphet-

officers amine, located items used to inject, smoke and consume the illegal drugs," the post stated. "Multiple other items of evidentiary value were removed from the home."

More charges may be filed in the future, according to the post.

Referendum is confusing, deliberately misleading

Referendums are important, but only if they clearly represent their objective. The threequestion referendum on this April 4th's ballot is misleading, confusing and partisan politics at its

In Question 1, Republicans want to remove the current state standard that allows courts to impose reasonable conditions in order to release defendants, pre-trial, to protect the community from "serious bodily harm", to replace it with the language of "serious harm" to be later defined by the legislature. Open-ended definitions are questionable and could result in unintended

In Question 2, according to the state Constitution, cash bail exists only to assure that a person will re-appear in court. The current system guarantees that the wealthy can buy their way out, until trial, while the indigent cannot. The poor often land up waiting behind bars, some times for extended periods, before any trial or conviction. Remember, the accused have not yet been convicted of a crime. Risk assessment is a much better mechanism to determine pre-trial

Even the Wisconsin Council of Churches labels Question 3 as misleading. Welfare programs (Wisconsin Works, Food Share and Medicaid) exist to help people in poverty. Wisconsin Works and Food Share already have work requirements. Federal regulation prohibits work requirements as a condition of receiving Medicaid.

This referendum is confusing, deliberately misleading and deserves a "no" vote on all three questions.

"Last year, these scholarships helped students pursue degrees in fields such as business management, electric power distribution, information technology and natural gas utility construction," WPS stated.





# Hatchets to face familiar GNC opponents next year following football conference realignments

TOMAHAWK - The Tomahawk High School football team will face familiar Great Northern Conference (GNC) opponents next fall following the realignment of the state's football conferenc-

On Tuesday, March 7, the Wisconsin Interscholastic Athletic Association (WIAA) Board of Control approved most of the Conference Realignment Task Force recommendations for football and advanced five Constitutional amendments to the WIAA Annual Meeting, slated for Wednesday, April 26 in Stevens Point.

The portions of the plan approved by the board will be implemented in the fall of 2024.

In a release, WIAA said that after receiving and reviewing 10 appeals - representing 18 schools - on the football-only conference realignment plan recommended by the Conference Realignment Task Force, the Board approved the plan for all eight-player conferences and all but eight 11-player conferenc-

es, which were remanded back to the Task Force for further evaluation and consideration.

The conferences - and schools associated with those remanded - that will be re-evaluated by the Task Force include the Capitol, Dunn-St. Croix, Eastern Suburban, Heart O' North, Lakeland, Southwest, Southwest Athletic League and Trailways, according to WIAA.

The Task Force will review the remanded conference plan at its Tuesday, April 11 meeting with a final proposal for those conferences impacted to be presented to the Board for final consideration at its Tuesday, April 25 meeting.

As part of the realignment, Tomahawk and Wausau East will move to the Great Northern Conference (GNC), joining Antigo, Lakeland, Medford, Merrill, Mosinee and Rhinelander.

Tomahawk competed in the Northwoods Conference last year, along with Clintonville, Coleman, Crandon, Crivitz, Menomi-Indian, Northland Pines and Oconto Falls.

School District of Tomahawk Athletic, Recreation and Pool Director Scott Parsons said the district feels the move to the GNC is "good for many reasons."

"Geographically, it is much more favorable than the Northwoods Conference setup, where two or three trips per year could be two and a half hours away," he stated. "In that configuration, we were an outlier as the farthest western school in the grouping."

Parsons noted that playing in the GNC "makes each conference game more meaningful, as most of these are schools we compete against in every other sport."

"This isn't a slight on any of the Northwoods schools, as we've enjoyed our relationships with them, but a Friday game against someone in the GNC would have a little more excitement, as they are more traditional opponents," he said.

Parsons added that he anticipates the Hatchets' home games will have higher attendance due to fans from GNC schools having shorter distances to travel than those of Tomahawk's opponents in the

Northwoods Conference.

"We feel the trajectory we're on puts us in a spot where we can compete very favorably," Parsons stated, adding that Tomahawk will be able to face all of its conference opponents in JV games, and JV2 opportunities may also be in the cards.

#### Other area schools impacted

The conference realignments will also impact other schools throughout the area.

Among the impending changes is the dissolution of the Marawood Conference. Abbotsford, Auburndale, Edgar and Pittsville are slated to move into the Central Wisconsin Conference-Small Division, joining Assumption, Iola-Scandinavia, Pacelli and Rosholt. Colby and Marathon will join Amherst, Loyal/ Greenwood, Spencer/Columbus Catholic, Stratford, Weyauwega-Fremont and Wittenberg-Birnamwood in the Central Wisconsin Conference-Large Division.

Numerous area schools will compete in eight-player football next fall. Athens, Chequamegon Co-op, Hurley, Flambeau, Phillips,

Prentice and Rib Lake will make up the Northwoods-East Conference, while the Northwoods West Conference will be comprised of Bruce, Mellen, Northwood/ Solon Springs, Shell Lake, South Shore, Washburn, and Winter/Birchwood. A mandatory crossover for seventh conference game will be held, according to WIAA.

## Natural Connections: **More Bear Babies**

My feet were just starting to get numb from standing on the snow-packed trail when the activity over by the den changed. Students with University Wisconsin-Stevens Point's (UWSP) Wisconsin Black Bear Project, led by Dr. Cady Sartini, plus several other wildlife professionals, were working together around the mouth of the den.

A student broke away from the group and headed to where we non-researchers were stationed out of the way. Abby was cradling something small against her chest, and the adoring smile that lit up her face gave it away: she was carrying a bear cub.

Eager hands reached out to take the cub and nestle him into a puffy winter coat. Soon more students with more cubs headed our way. Four tiny cubs were distributed among the willing volunteers. Mama bear lay anesthetized in the den, and the cubs needed our warmth.

Back in January, Dr. Sartini allowed a group of Wisconsin Master Naturalists to join her team on a reconnaissance mission to find out if this den had cubs,

yearlings, or just the collared adult. As I wrote, we saw the mom's sleepy face, and heard the grunts of two cubs. Two cubs were all I'd been expecting when I lucked into joining Dr. Sartini and her students on this data collection visit to the same den.

One of the students held a cub out toward me, and I cradled him against my chest, trying to tuck him inside my puffy coat while his long claws tangled in nylon and wool. I'd forgotten to take my hood down, and soon the anxious cub

was climbing up my neck, needle-sharp claws poking and wet nose nuzzling. It was adorable, funny, and painful all at once. Climbing trees to safety is a lifesaving instinct in bear cubs, and although this was the first time outside their den, their long, sharp claws were ready to go!

Startled by the cub's climbing, and unable to untangle him alone, I enlisted Laura Schulte, a Milwaukee Journal Sentinel reporter also covering the

#### Notice of Referendum Election **APRIL 4, 2023**

NOTICE IS HEREBY GIVEN, that at an election to be held in the several towns, villages, wards, and election districts of the State of Wisconsin, on Tuesday, April 4, 2023, the following questions will be submitted to a vote of the people pursuant to law:

#### 2023 ENROLLED JOINT RESOLUTION 2

To amend section 8 (2) of article I of the constitution; relating to: conditions for release prior to conviction, including the imposition of bail (second consideration).

Whereas, the 2021 legislature in regular session considered a proposed amendment to the constitution in 2021 Assembly Joint Resolution 107, which became 2021 Enrolled Joint Resolution 6, and agreed to it by a majority of the members elected to each of the two houses, which proposed amendment reads as follows:

SECTION 1. Section 8 (2) of article I of the constitution is amended to read:

[Article I] Section 8 (2) All persons, before conviction, shall be eligible for release under reasonable conditions designed to assure their appearance in court, protect members of the community from serious bodily harm as defined by the legislature by law, or prevent the intimidation of witnesses. Monetary conditions of release may be imposed at or after the initial appearance only upon a finding that there is a reasonable basis to believe that the conditions are necessary to assure appearance in court, or if the person is accused of a violent crime as defined by the legislature by law, only upon a finding that there is a reasonable basis to believe that the conditions are necessary based on the totality of the circumstances, taking into account whether the accused has a previous conviction for a violent crime as defined by the legislature by law, the probability that the accused will fail to appear in court, the need to protect members of the community from serious harm as defined by the legislature by law, the need to prevent the intimidation of witnesses. and the potential affirmative defenses of the accused. The legislature may authorize, by law, courts to revoke a person's release for a violation of a condition of release.

Now, therefore, be it resolved by the senate, the assembly concurring, That the foregoing proposed amendment to the constitution is agreed to by the 2023 legislature; and, be it further

Resolved, That the foregoing proposed amendment to the constitution be submitted to a vote of the people at the election to be held on the first Tuesday of April, 2023; and, be it further

Resolved, That the question concerning ratification of the foregoing proposed amendment to the constitution be stated on the ballot as follows:

OUESTION 1: "Conditions of release before conviction. Shall section 8 (2) of article I of the constitution be amended to allow a court to impose on an accused person being released before conviction conditions that are designed to protect the community from serious harm?"

QUESTION 2: "Cash bail before conviction. Shall section 8 (2) of article I of the constitution be amended to allow a court to impose cash bail on a person accused of a violent crime based on the totality of the circumstances, including the accused's previous convictions for a violent crime, the probability that the accused will fail to appear, the need to protect the community from serious harm and prevent witness intimidation, and potential affinitive defenses?

#### **EXPLANATION**

1. Explanatory statement regarding Question 1:

Under the current Wisconsin Constitution, courts may impose reasonable conditions on the release of a criminal defendant before trial for three purposes: (1) to secure the defendant's appearance in court; (2) to protect the community from "serious bodily harm;" and (3) to prevent intimidation of witnesses. Wis. Const. art. I, § 8(2).

Question 1 would change the language of the second factor from "serious bodily harm" to "serious harm as defined by the legislature by law." The question would thus change the type of harm to the community that a court could seek to protect against. Because the term "serious harm" would be defined by the legislature by law, what it means could evolve over time

A "yes" vote on Question 1 would vote to amend Wis. Const. art. I, § 8(2) to allow a circuit court to impose release conditions based on the purpose of avoiding "serious harm as defined by the legislature" rather than "serious bodily harm."

A "no" vote on Question 1 would vote not to amend Wis. Const. art. I, § 8(2) to change the term "serious bodily harm" as a factor for determining the conditions of a defendant's pretrial release.

2. Explanatory statement regarding Question 2:

Question 2 would also change the language of Wis. Const. art. I, § 8(2), but in a different way from Question 1. Question 2 addresses the circuit court's ability to impose the specific condition of monetary bail.

Currently, the Wisconsin Constitution allows a court to impose a monetary bail requirement only if the court finds a reasonable basis to believe that bail is necessary in order to secure the defendant's appearance in court. Wis. Const. art. I, § 8(2).

Question 2 would expand the factors a circuit court may consider in imposing monetary bail. In cases where a defendant is accused of a "violent crime as defined by the legislature by law," Question 2 would allow a court to impose monetary bail based on circumstances in addition to securing the defendant's appearance in court, including accounting for a previous conviction for a violent crime, the need to protect the community from serious harm, preventing witness intimidation, and potential affirmative defenses the defendant might assert.

A "yes" vote on Question 2 would vote to amend Wis. Const. art. I, § 8(2) in cases where the defendant is accused of a violent crime to allow a court to utilize monetary bail for additional reasons in addition to securing the defendant's appearance in court, including accounting for a previous conviction for a violent crime, the need to protect the community from serious harm, preventing witness intimidation, and accounting for the defendant's affirmative defenses. Because the term "violent crime" would be defined by the legislature by law, what it means could evolve over time depending on legislative enactments.

A "no" vote on Question 2 would vote not to amend Wis. Const. art. I, § 8(2) to expand the factors a court considers in imposing monetary bail.

#### 2023 ENROLLED JOINT RESOLUTION

Relating to: providing for an advisory referendum on the question of requiring able-bodied, childless adults to look for work in order to receive taxpayer-funded welfare benefits.

Resolved by the senate, the assembly concurring, That the following question be submitted, for advisory purposes only, to the voters of this state at the spring election to be held in April 2023:

"Shall able-bodied, childless adults be required to look for work in order to receive taxpayer-funded welfare benefits?"

#### EXPLANATION

Explanatory statement regarding Question 3, the advisory question:

This is an advisory referendum and would not change Wisconsin law. Wisconsin and federal law currently define various programs available to those with financial need based on criteria such as age, familial status, and disability, among other criteria. Most of those programs are limited to children, families with children, pregnant women, disabled persons, or those 65 or older, who Wisconsin law does not consider "able-bodied" for public assistance purposes. See, e.g., Wis. Stat. § 49.79(1)(am) (defining age limits for "able-bodied" under food stamp program).

Two programs currently available to "able-bodied, childless adults" are Wisconsin's Badger Care Plus medical assistance program and the Food Share program, also known as SNAP or food stamps. However, those programs are subject to certain federal requirements and restrictions that either would be inconsistent with the requirement about which the referendum asks or, in some cases, already include such a requirement.

Badger Care Plus's medical assistance program is subject to federal Medicaid restrictions, and federal law does not allow for work-based requirements for such programs absent a federal waiver. See 42 U.S.C. §1396a(a)(10)(A). Currently, there is no federal waiver in force that would allow Wisconsin to impose work requirements on this program. Wisconsin's Food Share statute contains requirements that able-bodied, childless adults be employed or participate in an employment and training program, see Wis. Stat. § 49.79(9), but that requirement has been suspended by the federal government in response to the COVID-19 pandemic.

A "yes" vote on Question 3, the advisory referendum, would make no change to Wisconsin law.

A "no" vote on Question 3, the advisory referendum, also would make no change to Wisconsin law.



If a voter is not registered to vote, a voter may register to vote at the polling place serving his or her residence, if the voter presents proof of residence in a form specified by law. Where ballots are distributed to voters, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the voter shall retire alone to a voting booth and cast his or her ballot except that a voter who is a parent or guardian may be accompanied by the voter's minor child or minor ward. An election official may inform the voter of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

#### Where Paper Ballots are Used

The voter shall make a mark (X) in the square next to the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall write in the name of the person of his or her choice in the space provided for a write-in vote. On referendum questions, the voter shall make a mark (X) in the square next to "yes" if in favor of the question, or the voter shall make a mark (X) in the square next to "no" if opposed to the question.

When using a tactile ballot marking device (Vote-PAD) to mark a paper ballot, the voter shall obtain from the inspectors, the assistive device and any audio or dexterity aids if required. The voter shall fill in the oval or connect the arrow next to the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall write in the name of a person of his or her choice in the space provided for a write-in vote and fill in the oval or connect the arrow next to the write-in line. On referendum questions, the voter shall fill in the oval or connect the arrow next to "yes" if in favor of the question, or the voter shall fill in the oval or connect the arrow next to "no" if opposed to the question.

#### Where Optical Scan Voting is Used

The voter shall fill in the oval or connect the arrow next to the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall write in the name of the person of his or her choice in the space provided for a write-in vote and fill in the oval or connect the arrow next to the write-in line. On referendum questions, the voter shall fill in the oval or connect the arrow next to "yes" if in favor of the question, or the voter shall fill in the oval or connect the arrow next to "no" if opposed to the question.

When using an electronic ballot marking device ("Automark," "Express Vote," Clear Access or "ImageCast Evolution-ICE") to mark an optical scan ballot, the voter shall touch the screen at the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall type in the name of the person of his or her choice in the space provided for a write-in vote. On referendum questions, the voter shall touch the screen at "yes" if in favor of the question, or the voter shall touch the screen at "no" if opposed to the question.

#### Where Touch Screen Voting is Used

The voter shall touch the screen at the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall type in the name of the person of his or her choice in the space provided for a write-in vote. On referendum questions, the voter shall touch the screen at "yes" if in favor of the question, or the voter shall touch the screen at "no" if opposed to the question.

The vote should not be cast in any other manner. Not more than five minutes' time shall be allowed inside a voting booth. Sample ballots or other materials to assist the voter in casting his or her vote may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

## **Spoiled Ballot**

If the voter spoils a paper or optical scan ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one voter. If the ballot has not been initialed by two inspectors or is defective in any other way, the voter shall return it to the election official, who shall issue a proper ballot in its place.

The voter may spoil a touch screen ballot at the voting station before the ballot is cast.

#### After Voting the Ballot

After an official paper ballot is marked, it shall be folded so the inside marks do not show, but so the printed endorsements and inspectors' initials on the outside do show. The voter shall leave the booth, deposit the ballot in the ballot box, or deliver the ballot to an inspector for deposit, and shall leave the polling place promptly.

After an official optical scan ballot is marked, it shall be inserted in the security sleeve, so the marks do not show. After casting his or her vote, the voter shall leave the booth, insert the ballot in the voting device and discard the sleeve, or deliver the ballot to an inspector for deposit. If a central count system is used, the voter shall insert the ballot in the ballot box and discard the sleeve or deliver the ballot to an inspector for deposit. The voter shall leave the polling place promptly.

After an official touch screen ballot is cast, the voter shall leave the polling place promptly

A voter may select an individual to assist in casting his or her vote if the voter declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the voter's employer or an agent of that employer or an officer or agent of a labor organization which represents the voter.

event, to help. Together, we got the cub off my neck and swaddled against her chest so that he was comfortable enough to stay put-although the little guy whined the entire time. Later, we discovered he was the runt of the litter at only 3.4 pounds to his brothers' 4. They've likely quadrupled in size since birth just over a month ago.

A few minutes later, someone shared their cub with me. Paul Smith, a Milwaukee Journal Sentinel outdoor writer who has been covering this project for 30 years, helped me get the cub settled comfortably and remarked on just how perfect the little ones are. Paul will be writing about the 45-year history of this long-term research project.

Taking off a mitten, I reveled in the softness and warmth of this tiny wild creature, and soon he became so quiet that I'm pretty sure he was sleeping. I felt honored by his trust. Despite bears' excellent sense of smell, there's no evidence that a mama bear will abandon her cubs if she catches a whiff of human. And despite rumors of animal babies being scentless, this cub had plenty of his own odor.

Disrupting a den like this is undoubtedly stressful for both mother and cubs, which is why protocols and safety measures are in place. But in the 45 years that the Wisconsin Black Bear Project has been collecting data and handling cubs,

the impacts have been found to be minimal. And the data gathered has proven essential for learning about and managing black bears in Wisconsin, and training students in wildlife research.

After a few minutes, Abby and a volunteer weighed each of the cubs by placing them into a cozy stocking hat and attaching a spring scale through the knit. They were sexed (all boys) and students held a

ruler up to the hair between their earsa proxy for age. Then a wildlife biologist collected nasal and blood samples to screen for wildlife diseases.

Meanwhile, back at the den, students and professionals struggled to get the limp, heavy female out of the ground. The entrance, tucked under the roots of a spruce tree, proved too narrow. She couldn't be weighed or fully measured. With just her head out, they checked her collar, took vitals, and collected a tooth. Bear teeth record growth rings just like a tree. A cross section can tell researchers her age, and even record the years she gave birth and had less calcium to spare.

At the end of the day, the cubs were safely returned to the den with a drowsy mother, and the den entrance covered with balsam boughs. Researchers packed up samples and data for analyzing in the lab.

"It didn't go the way we thought it would go," said Dr. Sartini as we stuffed gear into vehicles, "but it went just fine. So many of the skills the students gain here will be transferable. Risk management, teamwork, and planning are useful for studying other wildlife and doing any kind of science." John Tracey, the wildlife vet in charge of anesthetizing the bear, agreed, "As much as you want an event you're running to go smoothly, it's also beneficial for the students to see curveballs and challenges come up and get dealt with calmly."

Researchers are always looking for new bears to add to the UWSP Wisconsin Black Bear Project, so if you know of a bear den in Ashland, Bayfield, Price, or Sawyer Counties, you can contact Dr. Sartini directly at csartini@uwsp.edu. Dens outside this area can be reported to your nearest DNR office for their statewide research project.


