Three 'Our Dream Park' donations push total raised past \$120,000.00

TOMAHAWK – Three recent donations towards Tomahawk Together's "Our Dream Park" efforts have pushed the total funds raised past a significant landmark.

A pair of contributions came from Tomahawk Middle School (TMS).

The TMS Student Council donated \$2,000.00 towards the revitalization of Washington Square Park on N. 4th St. with an all-inclusive playground.

Meanwhile, TMS Hatchet Pride made a contribution of its own, donating \$1,029.00. The funds came from an end-of-the-year fundraiser.

Joining TMS in making a donation towards Our Dream Park was Wealth Strategy Group LLC, which contributed \$500.00 earlier this year.

To date, more than \$120,000.00 has been raised for Our Dream Park via donations and grants.

The total cost of the park project is just over \$2 million.

Tomahawk Together is currently working towards completing the park by next summer.

City of Tomahawk awarded federal grant for 'Sidewalks to Schools' project

TOMAHAWK – A federal grant awarded to the City of Tomahawk will go towards improving the safety of students' walks to school.

In April, the City of Tomahawk Common Council approved a resolution allowing the city to apply for a Transportation Alternatives Program (TAP) grant, with the intention to receive funding for a project called "Sidewalks to Schools."

TAP is a legislative program authorized in the

Bipartisan Infrastructure Law, signed by President Joe Biden in Nov. 2021. With certain exceptions, projects that met the eligibility criteria for Wisconsin Department of Transportation (WisDOT) programs focused on improving the safety of routes to schools, enhancing transportation and making upgrades to bicycle and pedestrian facilities could be permitted to receive TAP funding.

In June, WisDOT informed the city that it had been awarded \$185,440.00 for the Sidewalks to Schools

oroject.

During the City of Tomahawk Finance Committee's meeting at City Hall on Tuesday, July 25, City Clerk/Treasurer Amanda Bartz explained that the grant amount is for 80% of the project cost. The city's portion will be \$46,360.00, plus an additional \$15,000.00 for a "State Design Review."

Under the program, projects must begin within four years of the notification of the grant award.

Although there are currently no specific design plans in place, the resolution

approved in April said students have been seen walking to school in the road on King Road, where no sidewalks exist, and improvements made through the Sidewalks to Schools project will "allow all kids in grades K-12 within the neighborhoods north and east of the Tomahawk School Complex to safely walk to school, instead of on King Road."

The acceptance of the grant will be reviewed by the City of Tomahawk Common Council.

Sidewalks to Schools is not the first City of Toma-

hawk project to receive funding under TAP.

In Oct. 2020, the city was awarded \$40,000.00 for its

Bicycle and Pedestrian Plan, which was approved by the Common Council in Sept. 2022.

Body of Town of Bradley man recovered from Lake Nokomis following Silver Alert

TOWN OF BRADLEY – The body of a Town of Bradley man was recovered from Lake Nokomis last week after a Silver Alert had been issued in an effort to locate him.

According to a release from the Lincoln County Sheriff's Office, a request for a welfare check on an elderly male at an address on County Rd. N in the Town of Bradley was received shortly after 9 p.m. on Monday, July 24.

The request was made after out-of-town family members had been unable to contact Leroy H. Rupnow, 83, for more than 24

After deputies responded to the address but were unable to make contact with Rupnow, a search of the

residence. surrounding wooded area and shoreline of Lake Nokomis was conducted. A K9 unit track indicated Rupnow may have potentially "walked up to and perhaps even into the lake, though Mr. Rupnow was unable to be located," the Sheriff's Office said.

In the early morning hours of Tuesday, July 25, after enough information had been developed to warrant an activation, the Lincoln County 911 Center requested a Silver Alert be sent out, asking for the public's assistance in locating Rupnow or providing information regarding his whereabouts.

"Shortly after that alert was broadcast, day shift deputies searching the area with the benefit of added daylight were able to spot

what appeared to be an abnormality approximately 30 yards offshore from Mr. Rupnow's residence," the Sheriff's Office stated. "Further observation. which included the assistance of the Oneida County Sheriff's Office's drone team, led to confirmation that it was, in fact, the body of Leroy H. Rupnow in the water."

Members of the Tomahawk Fire Department assisted in removing Rupnow's body from the water, and Rupnow was pronounced deceased by Lincoln County Coroner Valerie Caylor.

The Sheriff's Office said no foul play is suspected.

The incident remains under joint investigation by the Sheriff's Office and the Coroner's Office.


Search warrant executed at Town of Merrill property reveals evidence of unlicensed salvage yard, illegal drugs

TOWN OF MERRILL Multiple investigations into an individual operating as an unlicensed salvage dealer led to the execution of a search warrant and the individual's arrest on numerous charges.

According to a release from the Lincoln County Sheriff's Office, a search warrant executed on a large property in the Town of Merrill on Thursday, July 27 revealed an "immense quantity of vehicles, vehicle parts and other equipment."

"During the search, a stolen vehicle was recovered, along with stolen vehicle parts," the Sheriff's Office stated. "Indications of tampering with, and

removing, VIN tags was discovered in multiple vehicles."

The Sheriff's Office said the search of the property provided "significant evidence of a salvage yard being operated for many years."

Illegal drugs were also located, which included more than 140 grams of

WISCONSIN - Marshfield Clinic Health System and Essentia Health, on Thursday, July 27 announced that the two health systems entered into an agreement to form a new integrated regional health system serving rural and mid-urban communities across four

The integration agreement was preceded by the signing of a memorandum of understanding in Oct.

A release from the health systems said the agreement is the "latest step in the process that keeps the organizations on track to come together formally by the end of this year pending regulatory approval."

'We are both physicianled organizations with an unwavering commitment to the health of rural communities," said Essentia Health Chief Executive Officer Dr. David Herman, who will serve as CEO of a new parent company. "Our complementary capabilities will with one another to better achieve our collective mission."

"Discussions the past few months have made it clear

that this is an incredible opportunity to enhance both health systems, solidify our futures and take patient care and services to an even higher level," said Dr. Susan Turney, who previously announced plans to step down as Marshfield Clinic Health System CEO this fall. "By joining together, Essentia and Marshfield Clinic will combine the strengths of both organizations and advance the level of care in Wisconsin. Minnesota. Michigan's Upper Peninsula and North Dakota," the release stated.


shared their lives together for 67 years.

Aspirus: How to treat common summertime injuries

WISCONSIN - Summer is a time for fun and outdoor activities, but it also brings a higher risk of certain inju-

From sunburns to insect bites and heat-related issues, Aspirus Health is reminding the public that it's essential to know how to handle these common mishaps and provide prompt care.

Sunburn: One of the most common summer injuries is sunburn. To treat sunburn at home, start by taking cool baths or showers, as this can provide immediate relief to the painful skin. Afterward, apply aloe vera gel or a soothing moisturizer to the affected area to promote healing and reduce discomfort.

Insect bites and stings: Insects can be an annoying presence during summer, and their bites or stings can cause pain, itching and swelling. To address this issue, begin by taking overthe-counter painkillers like acetaminophen or ibuprofen to alleviate pain from bites, such as bee stings. Be sure to follow the recommended dosages on the label.

"For itchy insect bites, applying an ice pack or overthe-counter anti-itch cream like hydrocortisone can provide relief," Wateski stated. "Alternatively, taking an oral antihistamine can help with the itching as well. Avoid scratching the affected area to prevent infection, and be on the lookout for signs of an allergic reaction, such as difficulty breathing, nausea, hives or dizziness. If any severe allergic reactions occur. seek medical attention immediately."

Heat exhaustion and heatstroke: High temperatures during summer can lead to heat-related issues like heat exhaustion and heatstroke. If you or someone else experiences these symptoms, move to a shaded or air-conditioned area immediately. Remove unnecessary clothing, including shoes and socks, and cool off quickly by using cold wet cloths, an ice bath or splashing cool water on the skin.

"Staying well-hydrated is crucial to prevent heatrelated issues, so make sure to drink plenty of cool fluids, especially water," Aspirus stated. "If the symptoms persist or worsen, seek medical help promptly, as heatstroke

is a medical emergency." Minor cuts and scrapes: Engaging in outdoor activities increases the likelihood of minor cuts and scrapes. Start by handwashing the wound with mild soap and water to clean it thoroughly. Apply gentle pressure with a clean washcloth to stop any bleeding. Cover the injury with a sterile bandage and change it daily until the wound heals.

Mild rash from poison oak or ivy: Encounters with poison oak or ivy can lead to itchy rashes. Immediately rinse the skin with lukewarm, soapy water after contact. Taking short, lukewarm baths can also help relieve itching.

"To further alleviate the itch, apply calamine lotion or hydrocortisone cream to the affected area," Wateski said. "Cool compresses can provide additional relief. You may also consider taking antihistamine pills to reduce itching, but be cautious to avoid scratching the rash, as it may lead to further spread or infection."

Sprains and strains: Summer activities may result in sprains or strains due to sudden movements or overexertion. If this occurs, rest the injured area and avoid putting weight on it. Applying ice packs wrapped in a

thin cloth can help reduce swelling and pain.

"While these home remedies and over-the-counter medications can be effective for treating common summer injuries, it's essential to monitor the progress and seek professional medical attention if the condition worsens or does not improve," Aspirus stated. "Always follow the directions on the medication labels, and if you have any existing medical conditions or concerns, consult a healthcare professional before administering any new treatments. 

Over 900 signatures have been collected from citizens who are against the selling of Pine Crest. However, on June 28, the Administrative and Legislative (A&L) Committee (Julie DePasse motion/Jesse Boyd second) chose a Broker to sell Pine Crest. After watching the recorded meeting, Chairman Friske congratulated the Broker and announced that the information would be taken to the board.

I attended the July 18 County board meeting to voice frustration of how the Chairman and Supervisors are not listening to their constituents. I received the agenda which states: "All Public Comment is Limited to Current Agenda Items...

." Pine Crest was not on the agenda preventing me from voicing my concerns. Chairman Friske did allow me to speak but would not hear comments about Pine Crest.

According to the A&L meeting, Pine Crest should have been on the agenda and comments from the public should have been heard. By not adding it to the agenda resulted in the loss of my freedom of speech.

Pine Crest recently received a "Five Star" rating for its outstanding facility and staff. Residents are alarmed and confused about their future, we need to slow down and examine all the alternatives. One Supervisor indicated options to stable funding including grant writing and endowments. Why haven't we explored these options?

I urge you to watch the recorded A&L meeting (June 28) and call your Supervisor requesting due diligence before finalizing the sale of Pine Crest.

It can be done

Response to Jim Torgerson's letter on July

My husband and I did two separate signature collections, in Tomahawk, in opposition to the sale of Pine Crest Nursing Home. We knew almost all of the people who signed. Regardless of their political bent

conservative or liberal
 they all understood the consequences of taking a publicly-owned, highly-rated nursing home and selling it to a for-profit venture.

No one voiced support for the sale. Time limited us from obtaining more. Other Tomahawk people also gathered Tomahawk signatures and relayed similar results.

The supposed taxpayer backlash to keeping Pine Crest as a county-owned facility surfaced recently and suspiciously from that quarter promoting the sale.

The fact is that Pine Crest accepts the highest percentage of Medicaid recipients where other facilities will not.

It is an insult to the average citizen to state that no one should worry about the quality of operations because all homes are under state and federal statute. In spite of those statutes, non-partisan organizations still find enough differences in performance levels to issue ratings. Pine Crest has the highest.

The sale of Pine Crest has been a priority for some board members as they proceed to eliminate as many services as possible. At the May 2023 county board meeting, Supervisor and State Assemblyman, Calvin Callahan, moved to begin the process to find a broker for the sale of Pine Crest. Supervisor Ken Wickman then asked for an amendment to that motion to include the sale of the Social Services building.

The motion passed but without the amendment to sell the Social Services building. The minutes stated, "... this exploration could be determined at a later date and once the broker was retained."

At that same board meeting, Supervisor Elizabeth McCrank submitted a resolution asking for an advisory referendum to determine the course of action on Pine Crest. Supervisor Calvin Callahan motioned to table the referendum resolution indefinitely, which passed, 13-8.

At the June 28 Administrative and Legislative Committee meeting, Item 5 listed Review and Award RFP – Broker for Pine Crest Nursing Home. Supervisor Julie DePasse motioned to award the bid to Marcus & Millichap, which passed.

The July 18 county board meeting agenda listed no reference to the sale of Pine Crest. Those members of the public waiting to address the board were told by Chairman Don Friske that unless an item was specifically on the agenda, they could not address it. Fortunately, those waiting did address the board's agenda tactics, budgeting and questioned:

What will be done with the county's approximate \$1 million in remaining ARPA funds? Why wasn't the broker selection brought to the whole board when Friske said earlier that the broker selection was made and would be brought to the board? When pressed, Friske assumed that it might be at the August board meeting. Regardless, the 300 additional signatures were presented, bringing the current total to approximately 900 in opposition to the sale.

In its rush to dispose of Pine Crest, the board should instead explore a foundation to assist Lincoln County with finances and grants for Pine Crest. Marathon County faced the same situation with its Mount View Home and worked to keep it under county control. It can be done.

RHINELANDER What started out four years ago as a major effort to advance economic development in the Northwoods will take a major leap forward later this year.

Nicolet College in Rhinelander recently announced that The GRID, which was initiated and fostered at the college, will become a standalone entity under the Grow North Regional Economic Development Corpora-

Nicolet said the plan is to have The GRID's transfer from Nicolet to Grow North take place as of Jan. 1, 2024.

The GRID, which stands for "Guiding Rural Innovation and Development," was founded at Nicolet in 2019 with the guiding idea the college would incubate and grow the organization until it had the structure, processes and resources to function on its own, a release from Nicolet explained.

DNR: Hunting dog depredated by wolves in Lincoln County

LINCOLN COUNTY - A hunting dog was depredated by wolves in Lincoln

On Monday, July 24, the Wisconsin Department of Natural Resources (DNR) said the U.S. Department Agriculture (USDA) Wildlife Services verified that wolves killed a Redbone trailing hound in the Town of Merrill.

USDA Wildlife Services verified the depredation on Friday, July 21.

The incident marks the first confirmed depredation of a domesticated animal in Lincoln County this year, according to DNR

One hunting dog was depredated in Lincoln County last year. In 2021, a wolf depredation of an undisclosed species occurred "close to a residence," and DNR recorded the status of the incident as a "confirmed human health and safety complaint." One confirmed hunting dog depredation took place in Lincoln County 2018.

area established

Following the verification of the depredation in Lincoln County, DNR established a "wolf caution area.'

On its website, DNR explained that it creates wolf caution areas when wolves attack dogs in hunting or training situations in an effort to warn hunters of the attack.

"The purpose of these caution areas is to let hunters know that a specific pack has attacked a dog or group of dogs," DNR stated. "It is the department's experience that once a pack has attacked a dog in a hunting or training situation, there is a high probability another attack will occur again during the same year or within the following year."

DNR said these attacks will generally be on trailing hounds used to hunt bears, bobcats and coyotes, but such attacks rarely occur on dogs in bird-hunting situations.

"Caution areas are not intended to close areas to


rather to advise hunters to exercise greater caution when hunting within these areas," DNR stated. "Greater caution can include staying closer to dogs, avoiding releasing at bait sites recently visited by wolves and avoiding releasing dogs at or near the site of an attack.'

The caution area map is generally considerably larger than the actual pack territory because attempts are made to use highways or easily-recognized roads as the boundary of the caution area, according to DNR.

"Generally, wolf pack areas average about 40 to 60 square miles (five to 10 miles across)," DNR said. "Thus, portions of the caution area, especially the far corners, will be outside the actual pack area and represent no more risk than other locations across the landscape."

The actual attack site is shown in a red-orange circle about one mile in diameter.

DNR said wolf attacks

on hunting/training dogs most often occur at or near rendezvous sites.

"These sites vary from year to year, but when an attack occurs in July, August, or early September, the attack site should

be treated as a proxy for a rendezvous site and is the primary location that should be avoided," DNR stated. "The farther away you can stay from the rendezvous site/attack sites, the lesser your risk of attack on your dogs."

The future and success of America is not in this constitution, but in the laws of God upon which this constitution is founded.

John Adams, the 6th president of the United We have no government armed with power capable of contending with human passions unbridled by morality and religion. Our constitution was made only for a moral and religious people. It is wholly inadequate to govern any other.

Noah Webster, publisher of the first American dictionary in 1828 and the Blue Backed Speller, which was used for a century in public education, said, The religion which has introduced civil liberty is the religion of Christ and his apostles. ... to this we owe our free constitutions of government.

Thomas Jefferson, 3rd president of the United States and the writer of the Declaration of Independence, stated, The reason that Christianity is the best friend of government is because Christianity is the only religion that changes the heart.

George Washington gave a warning in his farewell speech of 1797 at the end of his second term as President. There he warned, ... of all the dispositions and habits which lead to political prosperity, religion and morality are indispensable supports. In vain would that man claim the tribute of patriotism who should labor to subvert these great pillars of human happiness, these firmest props of the duties of men and citizens. The mere politician, equally with the pious man, ought to respect and cherish them.

The Bible, the Law of Liberty, reminds us that peace and freedom is the fruit of righteous character (Isaiah 32:17; 52:21).





It was found that the subject had been previously released on three different court cases and had a requirement to maintain absolute sobriety. The subject was transported to the hospital for medical evaluation and then later transported to the Lincoln County Jail where he was booked on four counts of bail jumping.

There were seven car vs. deer crashes reported in the week, with one causing minor injuries.

I love how you Mary Oliver!" I chuckled—my brain's autocorrect had skipped right over the phone's autocorrect fail. So often, even when someone's words come out in a funny order, we still know exactly what they mean. But now I re-read the original typo and felt a little fizz of joy. Leaving out a single word had essentially turned Mary Oliver into a verb. I mulled this over. What would it mean "to mary oliver"?

If you've read any of her poetry, you know that she was an ecologist poet who wrote with joy and empathy about the natural world. She's shaped my views on death and beauty more than I can comprehend, and little phrases from her poems overlay my days like the script on artsy greeting cards.

Thinking of her while picking my way around the slippery rocks of the island, I stuck my nose into a patch of hot pink swamp milkweed flowers to inhale their heady scent. "Every day I walk out into the world / to be dazzled, then to be reflective," wrote Mary Oliver. That seems like a good start to the definition of our new verb.

Backpaddling out of the thicket, I became enamored with the bur-reed leaves. The cells in the dead leaves

had hollowed out to create long strips of stained glass. While photographing those held up to the Sun, I noticed some funny bumps on a live leaf, each with two long tails like the bunny ears on my first TV. When I picked up that leaf, I found that they each extended a long oval capsule into the water on the underside. Often, when you are mary-olivering, "if you notice anything, / it leads you to notice / more / and more." (If you know who these eggs belong to, please tell me!)

As I paddled on through the shallow bays of Lake Namakagon, the ghostly shapes of aquatic plants appeared and disappeared beneath me. To get a better look, I dipped my waterproof camera beneath the surface and blindly took photos in the water. I'd have to enjoy them later, after dark, on my computer screen. "I look; morning to night I am never done with looking." Wrote Mary Oliver, and although I'm pretty sure she wasn't talking about uploading photos, I think it counts. (Watch for the results on our social media feeds.)

Finally I made it to a patch of white water lilies just starting to bloom. In a scene straight from her poem "The Ponds," a muskrat swam past. I dipped my camera below the surface and snapped away, then brought it up and peered at

the screen. The lily was luminous. Light from above filtered through the white petals. Specks of algae surrounded it like fairy dust.

But the flower wasn't perfect. Algae and tiny eggs had clung to its surfaces and the odd detritus of a productive lake mucked up the water. Nearby, the water lily's leaves were full of holes chewed by beetles. It's not just art, it's habitat. Still, it was worthy of maryolivering. "I want to believe that the imperfections are nothing— / that the light is everything-that it is more than the sum / of each flawed blossom rising and falling. And I do."

I mary-olivered all evening. I plan to mary-oliver every day. "Tell me, what is it you plan to do / with your one wild and precious life?"

The Pastor's Corner

"My Yoke is Easy and My Burden is Light"

One year after I had just had surgery, I carried heavy Christmas totes into the house. I realized as I was doing this that it wasn't such a good idea. There are times when we all carry heavy burdens that are too much for us to carry.

If you've ever carried something very heavy, you can relate.
Maybe you handed it off to someone stronger, but not all burdens
are physical. Sometimes emotional or spiritual burdens feel heavier.

King David of the Old Testament, was weighed down with many things when he wrote in Psalm 55, "Oh, that I had wings like a dove! I would fly away and be at rest." How many times have we heard someone say, "I need a vacation!"

Sometimes we do wish we could just fly away or run from the burdens we carry. But David concluded this Psalm by reminding us that we should always, "Cast your burden on the Lord, and He will sustain you; He will never permit the righteous to be moved."

We must remember that every circumstance in life is lovingly sifted through our Father's fingers. Those things that seem too much for us, He allows as opportunities to teach us something important and to learn dependence on Him. God never intends for us to carry our burdens alone. He asks us to bring them to Him.

Jesus invites us to come to Him for rest. He uses the agricultural image of a 'yoke.' When animals are yoked together, they are twice as strong to pull or carry the load. In fact, the yoke of Christ is a symbol of discipleship, obedience, and submission. Jesus longs to draw us to himself.

In Matthew 11:28-30, Jesus tells his disciples and others, "Come to me, all who labor and are heavy laden, and I will give you rest. Take my yoke upon you, and learn from me, for I am gentle and lowly in heart, and you will find rest for your souls. For my yoke is easy and my burden is light."

Jesus is talking about more than heavy loads here. He wants us to take on being a disciple of Jesus Himself. He wants us to share our loads with Him.

Jesus never promises us a life without problems or effort. But He is inviting us to find rest. Yokes and burdens come in all sizes. Debts, relationship issues, job pressures, aggressive people, out of control desires, regrets, insufficient finances, or caring for elderly parents, to name a few. But if He shares our yoke with us, He walks at our side and we learn to trust him.

There is burden-bearing that is right and burden-bearing that is wrong. We ought never to bear the burden of sin. But there are burdens placed on us by God. If you are a parent, you have a responsibility to care for your children.

If you are a boss or leader in your community, you have responsibilities to other people. If you have been called by God, you have a duty to answer that call.

But we must never get out of touch with God in our work. If we do, it will be crushing. If you have taken on too much, learn from that experience, and choose your commitments wisely. If we roll back onto God that which he has put upon us, he takes away the sense of responsibility, and we can bear it.

What is your burden? What are you carrying that is unbearable? How can you lighten your load? Has God placed someone in your life who can help share your responsibilities? Have you asked Jesus to help you?

If you have been bearing it all, it is time to share your burden. Commit your cares to the Lord. Your burden will be lightened by your new sense of companionship with him.

helps communities across the Northwoods."

Nicolet said The GRID functions as a one-stop connection to a wide-ranging list of business resources for entrepreneurs and small businesses in Northern Wisconsin.

"We've always felt that it was important, even critical, that we go to them and meet with business owners where they are at," Van Doran stated. "Running a business is time-consuming and challenging, and we wanted to make it as efficient for them as possible to access the resources The GRID has available."

"The major emphasis is targeted toward working with small businesses, which are the backbone and heart and soul of the Northwoods economy," Nicolet stated. "Research shows that across the region, roughly 90% of business have 20 employees or less."

The service area for The GRID covers eight counties: Florence, Forest, Langlade, Lincoln, Marinette, Oconto, Oneida and Vilas. It also serves three tribal communities: the Forest County Potawatomi, Lac Du Flambeau Band of Lake Superior Chippewa and Mole Lake Band of Sokaogon Chippewa, as well as the Great Lakes Inter-Tribal Council.

Nicolet said it will continue to work with The GRID as an education and training partner after the anticipated organizational transfer.
