A Wednesday, March 20 release from the district said Ewart's esteemed recognition highlights her "outstanding dedication, innovation and leadership in education."



County board approves allocation of ARPA funds to targeted digital marketing services

LINCOLN COUNTY
– Lincoln County will allocate American Rescue
Plan Act (ARPA) funds to
targeted digital marketing
services.

During its meeting at the Lincoln County Service Center in Merrill on Tuesday, March 19, the Lincoln County Board of Supervisors gave the thumbs up to a resolution approving the use of \$120,000.00 in ARPA funds for marketing services offered by Midwest Communications, a Wausau-based multimedia company.

Cameo Almli of Midwest Communications provided the board with a presentation on the company's offerings.

Almli explained that through digital marketing, the company can promote the county's natural resources and recreation opportunities. The company is able to use data from cell phones, computers and other digital means to identify individuals who are interested in activities offered in Lincoln County

and distribute advertisements to those individuals based on their expressed interests.

As an example, Almli said a person in Chicago who is looking into canoeing may see an ad highlighting such opportunities in Lincoln County.

Almli said the company is able to conduct targeted advertising via "non-traditional cable services," such as Charter Communications, Roku and Hulu, as well as social media,

utilizing 15-second videos.

The company also has the ability to conduct tar-

geted advertising in specific areas for designated amounts of time. Almli explained that if there was a canoeing event in another community, Midwest Communications could promote Lincoln County canoeing opportunities to individuals in that area for 30 days.

Midwest Communications can provide reporting and analytics data showing the effectiveness of the advertisements.

Almli noted that Midwest Communications is a local company and that she is a resident of the area, which gives her and her team of roughly 80 people an advantage in understanding what the county is looking for in terms of promotion.

Midwest Communications currently works with the City of Merrill.

"It's just unbelievable what we can do," Almli stated. "It's pretty cool because of the fact that we can get so narrowed, and we can target exactly who you'd want. The sky's the limit to what we can do."

After brief discussion, the board approved the resolution.

The board originally gave its stamp of approval to use ARPA dollars for county promotion last year. In April 2023, the board gave the green light to a vision statement and branding with the goal of boosting tourism. The following month, the board voted to earmark \$500,000.00 in ARPA funds to be used for marketing the county.

ARPA dollars have also been used for improving campgrounds, parks and county roads.

LWVNOW holds voter registration drives at area high schools

NORTHERN WISCON-SIN – The League of Women Voters of the Northwoods (LWVNOW), earlier this month, re-launched its high school voter registration and education drive.

On Monday, March 4, members of LWVNOW visited Tomahawk, Rhinelander, Lakeland Union and Laona High Schools, where they spoke to 119 students and helped 58 18-year-olds register to vote.

A release from LWVNOW said the majority of students had a Wisconsin driver's license, allowing for quick registration via www. vote.wi.gov, while other students mailed a paper registration form to their town clerks to complete the registration process.

Students were also shown how to use the MyVote website to find their polling places, their local clerks and the date of the next election.

"They learned they

could also use that website to obtain an absentee ballot and know what issues and candidates will be on their ballot," LWVNOW stated. "Additionally, it was explained what to do if and when the student

"For students with cell phones, we suggested a reminder in their calendar app, 'Happy 18th Birthday! Register to vote today,'" LWVNOW said.

The League said it plans to visit high schools to assist students with voter registration at least once more before the school year ends. "The League's objective is to motivate high school students to register to vote, cast their first vote and begin a lifelong habit of voting in every election," LWVNOW stated. "For those eligible to register, that first vote could be as soon as the next election on Tuesday, April 2, 2024."

Nearly \$9,500.00 in County Forest Road Aids allocated to Lincoln County

WISCONSIN – Governor Tony Evers and the Wisconsin Department of Transportation (WisDOT), on Thursday, March 21, announced that \$320,600.00 in state funds will go towards improving more than 900 miles of county forest roads across 24 counties this year.

A release from Evers' office said WisDOT administers the state's County Forest Road Aids program, which was established to help defray county costs for the improvement and maintenance of public roads within county forests.

"To qualify for the state funding, roads must meet minimum design standards of a 16-foot surface width and a 20-foot roadway width; be located within county forests; be part of a comprehensive county forest land-use plan; and be open and used for travel," the release stated. "The road cannot be a state or county trunk highway or town road and cannot receive General Transporta-



tion Aids (GTA)."

County Forest Road Aids are separate from the larger GTA program, which distributes funding to local governments from state-collected transportation revenues, helping offset the cost of county and municipal road construction, maintenance, traffic and other transportation-related costs.

According to data from Evers' office, Lincoln County is slated to receive \$9,493.14 for its 27.25 miles of eligible roads.

A total of \$13,534.26 will be allocated to Oneida County, which has 38.85 miles of eligible roads.

Price County will receive \$2,713.82 for its 7.79 miles of eligible roads, while \$16,850.76 is earmarked for Vilas County's 48.37 miles of eligible roads.

"My administration has been working hard at all levels to keep improving our transportation infrastructure to drive economic development, increase safety and improve the quality of life in every corner of Wisconsin," Evers said. "Our county forest roads are an important part of how we make our abundant natural resources more accessible for outdoor recreation, business and tourism."

"Since Governor Evers took office, WisDOT has improved 7,424 miles of road and 1,780 bridges," said WisDOT Secretary Craig Thompson. "A good transportation network depends on investing in the first and last mile in every part of the state, and we appreciate working with local leaders to deliver infrastructure improvements."

LINCOLN COUNTY SHERIFF'S REPORT

On 03/14/2024 a 38 year old Merrill woman, 38, came to the Sheriff's Office to report a domestic disturbance that had taken place at a residence on Lone Pine Rd. in the Town of Merrill the night before. The woman reported that the disturbance was between her and her boyfriend, 45, also of Merrill. The disturbance started over a disagreement at a local bar. Once the couple got home it was reported that the male subject tackled the female and forcibly took her cell phone, demanded other items and then head butted her. It was also reported that he hit her in the face and kicked her feet out from under her. When talked to by deputies, the male subject denied any wrongdoing, and stated that the female was out of hand. The male subject advised that he had called the Sheriff's Office after the incident, but he advised that it wasn't out of hand and he didn't want the police. The female subject had injuries similar to those of someone being hit in the face. The male subject was arrested and transported to the Lincoln County Jail, where he was booked for disorderly conduct,

As reported by the Lincoln County

battery, and robbery with force. On 03/16/2024 deputies responded to Lincoln Hills School for a battery complaint, It was reported that a male student, 17, was making threats to staff and other students while being defiant, disruptive and resistive towards staff. While attempting to confine the student to his cell, he became combative and fought with the staff. During the ensuing altercation, three staff members were injured and sent to the hospital for treatment. The student was taken into custody

by the investigating deputy and transported to the Lincoln County Jail. The student was uninjured in the incident. The deputy is requesting two counts of battery by prisoner and one count of disorderly conduct. The subject was cooperative with the deputy and Lincoln County Corrections staff. On 03/17/2024 deputies were sent to the KFC/Taco Bell on CTH W in the Town of Pine River for a complaint of disorderly conduct. A female, 18, from Sheboygan, was reporting that her boyfriend a male, 30, from Merrill, was driving drunk and threatening to kick her out of the car. The male subject then reportedly exited the vehicle and left the scene on foot. Investigating deputies found that the subject was on bond through Marathon County and was in violation of the conditions of that bond. The male subject was found a short time later and was arrested and transported to the Lincoln County Jail. At the jail, he was booked in for a charge of disorderly conduct (domesticrelated) and bail jumping for the violation of his bond in Marathon County.

On 03/17/2024 the Sheriff's Office received a complaint of a suspicious person at the R-Store in Tomahawk. It was reported that the female party was acting strange. It was described like she was under the influence of something and she had been driving a car. Tomahawk PD was dispatched to the call and found the Michigan woman, 59, and found no signs of impairment, but told the woman that she could not drive as she didn't have a valid license. A short time later, a deputy pulled into the business and noticed the female party had moved her car. After

investigating, the deputy who has advanced specialty training and is a drug recognition expert, determined that the female was impaired and had been driving her car. The driver submitted to standard field sobriety testing, along with advanced drug impairment testing, and as a result of those tests, she was placed under arrest for OWI 1st offense. She was later released to a responsible party. On Sunday 03/17/2024 the Sheriff's Office took a complaint of a mailbox being struck and damaged. The reporting party advised they observed a vehicle heading S/B on CTH JJ with a male hanging out the window smashing mailboxes. The r/p reported there were several damaged mailboxes in the area. The r/p also reported that her husband had gone after the suspect vehicle and was last seen S/B on CTH JJ. During this call the r/p's husband also called the Sheriff's Office, reporting that he was following the suspect vehicle and continued to do so until law enforcement was able to locate and stop the vehicle. Once stopped, it was learned that the vehicle was being driven by a Merrill juvenile, 16, and the passenger who was hitting the mailboxes was a Merrill juvenile, 15. Upon subsequent searching of the area, as of this time there, were 35 mailboxes damaged by the two. Anyone who may have found their mailbox damaged that hasn't been contacted by the Sheriff's Office yet is asked to call to report their damage. The damage was found to be in the area of the Towns of Merrill and Rock Falls. The two juveniles were turned over to their parents; charges against the two are pending. The Sheriff's Office was assisted by the Wisconsin State

Deputies conducted 49 traffic stops and 25 security checks.



LCHD provides information on measles following recent national uptick in cases

LINCOLN COUNTY - The Lincoln County Health Department (LCHD) last week provided information on measles following a recent uptick in cases of the illness across the country.

According to a Wednesday, March 20 release from LCHD, as of Thursday, March 14, a total of 58 measles infections had been reported by 17 states: Arizona, California. Florida, Georgia, Illinois, Indiana, Louisiana, Maryland, Michigan, Minnesota, Missouri, New Jersey, New York, Ohio, Pennsylvania, Virginia and Washington.



Only 58 measles cases were reported in the United States for the entirety of 2023.

"Why is this important? Measles is one of the most contagious illnesses that we know of," LCHD stated. "It is so easily spread, that for every group of 100 unvaccinated people exposed to measles, 90 will become infected. The measles virus remains in the air for two hours after an infected person leaves that room, so just walking through a room an infected person was in two hours prior is enough to be exposed."

LCHD said measles, although once very common, has been on the decline since the introduction of the measles, mumps and rubella (MMR) vaccine in 1963. Before that time, nearly all children got measles by age 15.

In Lincoln County, 10% of students across all schools are not up-to-date with their MMR vaccine as of the 2023-2024 school year, according to

"Up-to-date is considered one dose of MMR vaccine for 3K and 4K students and two doses of MMR vaccine for those in kindergarten or

older," LCHD stated. "This is a significant number of students that are at risk of becoming infected if a child with measles comes to school."

LCHD said it is reminding community members that the best protection against measles is the MMR vaccine.

"One dose is 93% effective against preventing measles infection, and two doses are 97% effective against preventing infection," LCHD stated. "All children are recommended the first dose of MMR vaccine between the ages of 12-18 months and a second dose between the ages of four to six years old."

Currently, 83% of all Lincoln County two-year-olds have their first dose of the MMR vaccine, according to

"Measles is still very common in other parts of the world," LCHD noted, "In 2022, an estimated 136,000 people, mostly children, died of measles."

"Measles is really only a plane ride away," said Kristi Krombholz, Public Health Nurse. "This is something everyone should keep in mind during spring break and traveling with families."

Measles symptoms include high fever; runny nose; red, runny eyes; and a rash that starts from the head then moves down the body.

Complications of measles can include hospitalization, pneumonia. encephalitis (brain swelling), pregnancy complications and death.

"What does this all mean for Lincoln County? As we continue to see declining vaccine rates, there becomes larger numbers of people that are able to become ill and spread measles," LCHD stated. "So is measles back? It's too soon to say, but based on increasing number of measles illnesses and less children vaccinated, it is likely to become something that we will see in Lincoln County, and not just on the news."

Aspirus highlights trends in substance use among young people

WISCONSIN - Aspirus Health recently highlighted trends in substance abuse among young people.

"As society evolves, so do the patterns of substance use among young adults," a release from Aspirus said. "One notable trend observed by Saba Khan, DO, a Family Medicine Resident Physician at Aspirus Wausau Familv Medicine, is the rising prevalence of marijuana and nicotine vaping among young

According to the Wisconsin Department of Health Services (DHS), 11% of middle schoolers in Wisconsin have experimented with electronic tobacco products, and 4% are current users.

"These figures notably in-

crease by high school, with 32% of students having tried e-cigarettes, and 20% considering themselves current users," Aspirus stated. "In Michigan, the OK2SAY student safety program reports that half of high school students have tried vaping, and one out of five currently engages in vaping."

Aspirus said vaping gained popularity as an alternative to traditional tobacco smoking, maintaining its appeal among younger populations due to a variety of flavor options, accessibility and its discreet nature.

Khan expressed a "major concern," saying, "It can be done indoors and doesn't have a strong odor like cigarettes, making it easier to use these products in secret."

The act of vaping involves inhaling steam that comes from hot nicotine liquid.

"Despite claims of being a healthier alternative to smoking conventional cigarettes, research indicates that vaping still poses health risks, including exposure to harmful chemicals, nicotine addiction and respiratory issues," Aspirus stated.

Beyond the medical risks, substance use during adolescence can impede cognitive development, disrupt



MOVIES YOU GOTTA SEE

'Field of Dreams' and the magic of baseball

If Ray Kinsella, Kevin Costner's character in the stellar 1991 sports fantasy drama Field of Dreams, was even semi-normal, he would've been on a dead sprint back to his house the second he started hearing otherworldly whispers in his cornfield. Thank god he handled the situation in a weirdly chill manner, because if he'd have called a priest instead, the events of the movie probably never would've happened, and we'd be bereft of one of the most unique and touching sports movies ever made.

Field of Dreams focuses on Ray, a family man and diehard baseball fan grappling with his difficult relationship with his late, former-ballplayer dad, John. Baseball was the one thing the two could see eye-to-eye on, but Ray, a child of the '60s, resented his father for "getting old," left home after a falling out, and never got the chance to make amends before his father's death.

One night, Ray is walking in the cornfield on his Iowa farm when he hears a voice say "If you build it, he will come." Ray's understandably baffled, but after concluding that the voice is telling him to build a baseball field, he levels a por-

tion of his crop and, with the support of his wife, Annie, follows the instructions he was

Let me just go on record here and say that if I were moseying around in my crops and a voice said literally anything to me, let alone tried to coax me into constructing an athletic field, the only thing I'd be "building" would be the courage to tell my wife that we have to pack up and move immediately because our farm is haunted by the spirit of Tim "The Tool Man" Taylor.

Ok, back to the movie. In the months after the field is finished, Ray waits for the aforementioned "he" to arrive, but nothing happens, to his disappointment. Finally, on one summer night, his

daughter, Karen, spots a man outside. Ray, ever the optimist, doesn't call the police or grab some sort of weapon (you'd think the guy's got an old Louisville Slugger lying around somewhere) - he just heads out there to See What's Up. And What's Up is the legendary "Shoeless" Joe Jackson (played by the late, great Ray Liotta) poking around on the diamond. Oddly, the only person more shocked at this scenario than Ray is Joe. Joe doesn't understand where he is exactly, but he knows why he's there. After being part of the infamous Black Sox, the Chicago White Sox team accused of throwing the 1919 World Series, Joe and seven of his teammates were banned from pro ball for life. But now, he's back where he belongs the baseball field. Ray hits Joe some fly balls, throws him a little BP, and all is great. The next day, some of Joe's old teammates show up from out of Ray's cornfield, and eventually former players from other teams are playing as Ray, Annie, and Karen watch the

ist. Terrance once wrote a fictional character named John Kinsella – Ray's father's name - and he also once said during an interview that as a kid, he'd dreamed of one day playing for his beloved Brooklyn Dodgers. This convinces Ray to trust his instincts, which are telling him that he has to take Terrance, who lives in Boston, to a Red Sox game. Ray tracks Terrance down at his apartment, and in a fantastic scene, convinces Terrance to accompany him to Fenway

A quick tangent: This is a movie where the ghosts of baseballers past emerge from a cornfield to get some innings in; the filmmakers obviously took a few liberties with the laws of our objective reality. But the most unbelievable thing in this movie happens not on Ray's ballfield, but at Fenway, where Ray and Terrance buy two hot dogs and two beers for seven (7) dollars. I implore you to go to a professional sporting event and see what seven bucks gets you. If you're lucky, the concessions guy might toss you a handful of loose Cracker Jacks.

Anyway, the events that follow the Red Sox game are Pure Cinema Magic, folks. Sure, baseball is at the center of Field of Dreams but the film is really about life; how


everyone has hopes, triumphs and failures and how sometimes, you don't know that the most important moment of your life is happening until it brushes past you like a stranger in a crowd. Several characters, including Ray and Terrance, are struggling with past regrets - wrongs they wish they could right and days they wish they'd seized. Ray's field gives them a second chance. Does it matter how, or why? I don't think so. The great thing about Field of Dreams is that it doesn't stop to ponder these questions. It simply is what it is, and it asks the audience to buy in, just like the field itself does. Only those who have faith in the mysterious workings of the field can see the players, and those who hold some sort of belief in the notions of forgiveness and redemption - and the spiritual power of baseball - are able feel the film's full emotional impact.

There's a case to be made that the lessons at the heart of the film could've been conveyed through another medium - cribbage, water polo. interpretative dance, etc. But those things simply lack the magic that baseball possesses in abundance. There's something about the game - its simplicity, its timelessness, its mythical history and legacy - that stretches across generations and can help people overcome their individual differences. Baseball connects us to our past, and it will endure, which is a comforting idea. Maybe someday soon, you'll turn on the radio, and you'll hear Bob Uecker calling a Brewer game, just like you had countless times before. And years from now. you'll tune in again, and this time you'll say to your grandchild, "I remember when Bob Uecker called Brewer games." Sure, it's just an offhand observation, but your grandchild might remember it, and maybe someday they'll tell their own grandchild how you, so long ago, were lucky enough to listen to Mr. Baseball himself on so many summer afternoons. And your memory will live on, even if it's just in that small, passing moment, because of the game of baseball. There's a beautiful hopefulness in that.

It is wild that Field of Dreams worked. On paper, it's completely ludicrous - I felt insane just typing the summary. But what is truly preposterous is how moving the final 20-or-so minutes are. Some people might scoff at the sheer unabashed corniness of it all, and I will tell you, you do not need that kind of negativity in your life. Sometimes we need to be reminded that there are some forces for good in the world, and second chances are possible. I like to believe those things are true everywhere even in heaven, and Iowa.

Your vote matters

All elections are important and there is another one coming up on April 2nd. Presidential ballots, primary or general, always generate the largest turnouts, and justifiably so. We should not, however, ignore the asimportant state and local contests because they often have a more significant impact on our daily lives.

On this spring ballot all seats of the Lincoln County

Board are up for election. It is worth recalling what our elected officials have or have not accomplished while in office in order to aid us in our ballot choices for the next two-year term of county board supervisors. Some county services were aided by additional outside state and federal funding, but other services were discontinued.

The current county board of supervisors managed, in the past two years, to: substantially increase the individual powers of the county board chair; eliminate the important income-generating wheel tax that directly benefited the county highway department; eliminate most UW-Extension services; prevent a county-wide referendum on the question of selling the county-owned nursing home - multiple times; and ultimately sold Pine Crest Nursing Home despite intense public opposition. None of these decisions were unanimous, but a majority of the supervisors, many of whom were new to the county board, voted to do so.

Also critical to our electoral access are two questions on two proposed constitutional amendments. The first wants to prohibit any level of government in the state from applying for or accepting non-governmental funds, grants or equipment and supplies for the administration of elections, without providing alternative resources of funding to ensure that our elections are fully funded.

The second amendment, which Common Cause opposes, proposes that only election officials designated by law may perform tasks in the conduct of primaries, elections and referendums. Wisconsin statutes already provide comprehensive and rigorous requirements for election officials. It is unclear how this provision would enhance current laws, especially since the Legislature has not identified specific need for this constitutional amendment. If enacted, the potential exists to stifle current practices that enhance voter participation.

The ACLU of Wisconsin, All Voting is Local Action Wisconsin, The League of Women Voters of Wisconsin, Wisconsin Conservation Voters and Wisconsin Democracy Campaign oppose both amendments.





NOTICE IS HEREBY GIVEN, that at an election to be held in the several towns, villages, wards, and election districts of the State of Wisconsin, on Tuesday, April 2, 2024, the following questions will be submitted to a vote of the people pursuant to law:

2023 ENROLLED JOINT RESOLUTION 78

To create section 7 of article III of the constitution; relating to: prohibiting state and local governments from using privately sourced moneys or equipment in connection with the conduct of elections and specifying who may perform tasks related to the conduct of an election (second consideration).

Whereas, the 2021 legislature in regular session considered a proposed amendment to the constitution in 2021 Senate Joint Resolution 101, which became 2021 Enrolled Joint Resolution 17, and agreed to it by a majority of the members elected to each of the two houses, which proposed amendment reads as follows:

SECTION 1. Section 7 of article III of the constitution is created to read:

[Article III] Section 7 (1) No state agency or officer or employee in state government and no political subdivision of the state or officer or employee of a political subdivision may apply for, accept, expend, or use any moneys or equipment in connection with the conduct of any primary, election, or referendum if the moneys or equipment are donated or granted by an individual or nongovernmental entity.

(2) No individual other than an election official designated by law may perform any task in the conduct of any primary, election, or referendum.

SECTION 2. Numbering of new provision. If another constitutional amendment ratified by the people creates the number of any provision created in this joint resolution, the chief of the legislative reference bureau shall determine the sequencing and the numbering of the provisions whose numbers conflict.

Now, therefore, be it resolved by the senate, the assembly concurring, That the foregoing proposed amendment to the constitution is agreed to by the 2023 legislature; and, be it further

Resolved, That the foregoing proposed amendment to the constitution be submitted to a vote of the people at the election to be held on the first Tuesday of April 2024; and, be it further Resolved, That the questions concerning ratification of the foregoing proposed amendment to the constitution be

stated on the ballot as follows: QUESTION 1: "Use of private funds in election administration. Shall section 7 (1) of article III of the constitution be created to provide that private donations and grants may not be applied for, accepted, expended, or used in

connection with the conduct of any primary, election, or referendum?" QUESTION 2: "Election officials. Shall section 7 (2) of article III of the constitution be created to provide that only

election officials designated by law may perform tasks in the conduct of primaries, elections, and referendums?

EXPLANATORY STATEMENTS AS TO THE TWO QUESTIONS

1. Explanatory statement regarding Question 1:

The Wisconsin Constitution does not limit the ability of the state or local governments to receive non-governmental grants, funds, or equipment to assist in carrying out election-related responsibilities. Question 1 would add a new provision to the Constitution to prohibit the state or local governments from applying for, accepting, expending, or using such funds to assist with carrying out "any primary, election, or referendum." The question would appear to apply to any type of non-governmental grant or funding, no matter how general in scope.

A "yes" vote on Question 1 would vote to create a new provision of the Wisconsin Constitution—Wis. Const. art. III, § 7(1). That provision would prohibit a state agency or local government from applying for, accepting, expending, or using any non-governmental moneys or equipment in connection with the conduct of any election.

A "no" vote on Question 1 would vote not to add Wis. Const. art. III, § 7(1) to the Wisconsin Constitution.

2. Explanatory statement regarding Ouestion 2:


Wisconsin statutes define and regulate how clerks can designate individuals to serve as election officials and carry out various tasks relating to elections. The Wisconsin Constitution does not separately spell out which individuals can do

Question 2 would add a new provision to the Constitution to prohibit individuals from performing tasks related to an election unless they are an "election official designated by law." Under current statutes, clerks have the statutory power to designate individuals to carry out election-related tasks, and so such designated individuals could continue doing their work as an "election official designated by law." But that power is only statutory, and if the statutes changed, the new constitutional provision would bar clerks from designating individuals to assist with electionrelated tasks

A "yes" vote on Question 1 would vote to create a second new provision of the Wisconsin Constitution - Wis. Const. art. III, § 7(2), which would prohibit an individual from performing election-related tasks unless they are an "election official designated by law."

A "no" vote on Question 1 would vote not to add Wis. Const. art. III, § 7(2) to the Wisconsin Constitution.

Where Paper Ballots are Used

The elector shall make a mark (X) in the square next to the name of the candidate of his or her choice for each office for which he or she intends to vote. On referendum questions, the elector shall make a mark (X) in the square next to "yes" if in favor of the question, or the elector shall make a mark (X) in the square next to "no" if opposed to the question.

When using a tactile ballot marking device (Vote-PAD) to mark a paper ballot, the elector shall obtain from the inspectors the assistive device and any audio or dexterity aids if required. The elector shall fill in the oval or connect the arrow next to the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of a person of his or her choice in the space provided for a write-in vote and fill in the oval or connect the arrow next to the write-in line. Information to Voters

Upon entering the polling place and before being permitted to vote, a voter shall:

• state their name and address

- show an acceptable form of photo identification* sign the poll book**

*If a voter does not have acceptable photo identification, the voter may obtain a free photo ID for voting from the

**If the voter is unable to sign the poll book due to disability, a poll worker may write the word "exempt."

If a voter is not registered to vote, they may register to vote at the polling place serving their residence if the voter provides proof of residence.

Where ballots are distributed to voters, the initials of two inspectors must appear on the ballot.

Upon being permitted to vote, the voter shall enter a voting booth or go to a machine and cast their ballot. The vote should not be cast in any manner other than specified here. Sample ballots or other materials to assist the voter in marking their ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

A voter who is a parent or guardian may be accompanied by the voter's minor child or minor ward.

An election official may inform the voter of the proper manner for casting a vote but the official may not advise or indicate a particular voting choice.

A voter may select an individual to assist in casting their vote if the voter declares to the presiding official that they are unable to read, have difficulty reading, writing, or understanding English, or that due to disability are unable to cast their ballot. The selected individual rendering assistance may not be the voter's employer or an agent of that employer or an officer or agent of a labor organization which represents the voter.

Where Optical Scan Voting is Used
The voter shall fill in the oval or connect the arrow next to the name of the candidate of their choice for each office for which they intend to vote. To vote for a person whose name does not appear on the ballot, the voter shall write in the name of the person of their choice in the space provided for a write-in vote and fill in the oval or connect the arrow next to the write-in line. On referendum questions, the voter shall fill in the oval or connect the arrow next to "yes" if in favor of the question, or the voter shall fill in the oval or connect the arrow next to "no" if opposed to the question.

When using an electronic ballot marking device ("Automark") to mark an optical scan ballot, the voter shall touch the screen or use the tactile pad to select the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall type in the name of the person of his or her choice in the space provided for a write-in vote. On referendum questions, the voter shall touch the screen or use the tactile pad to select "yes" if in favor of the question, or the voter shall touch the screen or use the tactile pad to select "no" if opposed to the question.

After Voting the Ballot

After an official optical scan ballot is marked, it shall be inserted in the security sleeve, so the marks do not show. The voter may insert the ballot in the voting device and discard the sleeve or deliver the ballot to an inspector for deposit. If a central count system is used, the voter shall insert the ballot in the ballot box and discard the sleeve or deliver the ballot to an inspector for deposit. The voter shall leave the polling place promptly

Spoiling Ballots
If a voter spoils an optical scan ballot, they shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one voter. If the ballot has not been initialed by two inspectors or is defective in any other way, the voter shall return it to the election official who shall issue a proper ballot in its place.

Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth or machine and cast his or her ballot except that elector who is parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

At the school district election, the elector shall make a cross (X) in the square at the right of or depress the button or lever next to the candidate's name for each office for whom he or she intends to vote, or insert or write in the name of the candidate of his or her choice in the space provided.

On referenda questions, when voting by paper ballot, the elector shall make a cross (X) in the square at the right of "yes" if in favor of the question, or the elector shall make a cross (X) in the square at the right of "no" if opposed to the question. On referenda questions when voting by voting machines, the elector shall depress the button or lever next to "yes" if in favor of the question, or the elector shall depress the button or lever next to "no" if opposed to the question. On referendum questions when voting by marksense ballot, the elector shall complete the arrow at the right of "yes" if in favor of the question, or complete the arrow at the right of "no" if opposed to the question. On referenda questions when voting by accu-ballot, the elector shall darken the oval at the left of "yes" if in favor of the question, or darken the oval at the left of "no" if opposed to the question.

The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth or machine. Unofficial ballots or a memorandum to assist the elector in marking his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official paper ballot is marked, it shall be folded so the inside marks do not show but so the printed endorsements and inspectors' initials on the outside do show. After casting his or her vote, the elector shall leave the machine or booth, and where paper ballots are distributed to electors, deposit his or her folded ballots in the paper ballot boxes, or deliver the ballots to an inspector for deposit. The unused ballots should be deposited in the blank ballot box, and the elector shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.

Wisconsin statutes provide that school board members of a Unified School District are elected "at large" by all of the electors of the school district. All electors in the district, regardless of where they reside may vote for any candidates for election to the school board, regardless of which apportioned district the candidate is from.

NORTHERN WISCON-SIN – What a strange time to be putting together a fishing report. According to the calendar, we should be talking about the two-plus feet of ice on the lakes. Instead, we're talking about open water and chasing panfish in a boat.

We had quite a few people through the store this week who were headed out by boat, both on the Chain and other bodies of water that were mostly ice-free. We're also seeing people headed to the river and dams to fish from the shore.

We expect panfish to be in their "normal" spring patterns right now – well, at least what is normal for April rather than March. Fish them as if you were going out on open water for the first time in late April.

People usually think perch fishing right after

the ice goes out. Look for the warmest spots on the lake, which tend to be shallow bays that get good sun. They will stage in six to eight feet and move right into a foot or two of water when temps get right for spawning, often near wood.

On our smaller lakes, look for green weeds if you can find them. As the sun hits the treetops in the evening, the fish will be pretty shallow, feeding very actively. Minnows and/ or small flashy jigs should work well, but crawlers or worms under a bobber make for a nice evening on the dock, too.

Other than that, there's not a whole lot to say! Keep hoping for some rain, and if you haven't already, get your rods and reels out and ready for an interesting spring.


