

Biermann Foundation donation covers replacement of Sheriff's Office cameras

LINCOLN COUNTY -The Lincoln County Sheriff's Office will replace its aging camera systems after receiving a donation to cover the associated costs.

During its meeting at the Lincoln County Service Center in Merrill on Tuesday, Oct. 15, the Lincoln County Board of Supervisors unanimously approved a resolution accepting a donation of \$533,349.50 to purchase new squad cameras, body cameras and related data storage systems for the Lincoln County Sheriff's Office.

According to the resolution, drafted by Lincoln County Sheriff Ken Schneider, the cameras

currently being used in Sheriff's Office's patrol vehicles are nearing the end of their life cycles, and half of them no longer record audio.

The Sheriff's Office also sought to replace bodyworn cameras, citing the safety of Corrections staff and protection from liability when state inmates are housed at the Lincoln County Jail.

The Biermann Foundation has made financial contributions to the Sheriff's Office in the past, and after the Sheriff's Office presented the camera package to the Foundation, funding for the project was approved.

No timeline for when the Sheriff's Office would receive the new camera systems was provided during the meeting.

LINCOLN COUNTY SHERIFF'S REPORT

As reported by the Lincoln County Sheriff's Office Monday,

On 10-07-24 a deputy on patrol stopped a vehicle on USH 8 near Woodland Dr. for a speeding violation. While making contact with the driver, a man from Grand Rapids, Mich., 35, was discovered to be in possession of marijuana. A subsequent search turned up more illegal drugs and drug paraphernalia. The suspect was taken into custody and transported to the Lincoln County Jail, where he was booked for possession of marijuana and drug paraphernalia. He was also cited for speeding and operating after revocation.

On 10/11/2024 deputies were dispatched to the area of USH 51 and Lincoln Dr. for a reported car vs. box truck crash with injuries. Upon investigation and witness statements, it was learned that a box truck being operated by a man from Elgi, III., 35, was traveling W/B on Lincoln Dr. intending on crossing USH 51 and continuing on Lincoln Dr. The driver cleared the N/B lanes of USH 51 but failed to see a S/B vehicle being operated by a Wausau woman,

74. The box van continued into the S/B lanes and was struck by the S/B vehicle. The driver of the S/B vehicle was transported by Merrill Ambulance to Aspirus Wausau Hospital. The crash is still under investigation.

On 10/11/2024 deputies were dispatched to the area of the USH 51 Truck Stop on Brandenburg Ave. in the Town of Scott for disturbance in progress. The caller, a Merrill man, 30, was reporting that he has a no contact order with a Tomahawk woman, 44, and that she was at the time of the call following him. The man reported that they had been arguing, and that during the argument, the woman had hit the R/P with her with her car, but no injuries were reported. According to the investigation, the man and woman were involved in an argument. During the argument, the man reported that the woman who was sitting in a car struck him three times. The woman denied having struck the man. Both parties were found to be on probation; as a result of the incident, both parties were arrested on a probation hold. Additional domestic related charges are possible.

On 10/12/24 a deputy on patrol stopped a vehicle for a speeding violation on USH 51 near the 229 mm in the Township of Bradley. While making contact with the driver, a Merrill man, 43, the deputy noticed signs of impairment. The deputy requested the driver perform sobriety tests and a preliminary breath test, which the driver refused to do. The driver was then placed under arrest for a first offense of OWI. He was then transported to Aspirus Merrill Hospital for a blood draw, which the driver also refused to do. Following a search warrant, the subject's blood was obtained, and he was transported to the Lincoln County Jail, where he was later turned over to a responsible party.

On 10/12/2024 LISO received a call from the Marathon County Sheriff's Office of a hang up call they had received from a phone number that is located within Lincoln County. Deputies were dispatched to an address Bittersweet Ln. in the Town of Pine River. When the first deputy arrived on scene, she found a Merrill man, 49, passed out in a car. A short time later, the deputy advised that the female subject, 52, also from Merrill,

had returned to the scene. After talking with both parties, it was learned that the two were engaged to be married and the woman was suspecting the man of cheating on her. This led to a fight, where the man reportedly struck the woman. After talking with both parties, the man was arrested on numerous domesticrelated charges. An ambulance was requested at the scene for a possible head injury, but no one was transported. The male subject was transported to the Lincoln County Jail.

Deputies conducted 42 traffic stops five security checks.

Deputies responded to nine car vs. deer crashes.

Tempus Fugit – Memento Mori

Forty or more years ago, I was a member of a Fraternal organization that used those Latin words as their motto. It translates into English as "Time Flies – Remember you must die." Now, to some, that may seem rather sad, or frightening. However, do we not often ask ourselves, or perhaps others, "Where has all the time gone?" "How have I spent the time God has given me? "or "How much time do I have left?"

Many songs have been written about time, both secular and religious

For example, Frank Sinatra sang a song titled "September Song". Composer, Kurt Weill, Lyricist, Maxwell Anderson. The Last two lines of the second verse says, "And plentiful waste of time of day, a plentiful waste of time." Followed by the chorus,

"Oh, the days dwindle down to a precious few

September, November

And these few precious days I'll spend with you

These precious days I'll spend with you"
There's a real lesson to be gained from those words.

God has allotted each of us a certain number of days, some of us more, and others less. We just don't know. Would we want to know? And, if we did know how many days, or years, we have "been allotted," would we make one or more changes to how we are

Pete Seeger, Joe Hickerson and Bert Paige wrote "Where Have All the Flowers Gone? A song with which you may be familiar. Peter, Paul, and Mary produced a wonderful recording of the song. It too, reminds us of Tempus Fugit, Time Flies. Each verse begins with a question. The first is "Where have all the flowers gone?" followed by "Where have all the young girls gone?", "Where have all the husbands gone?", "Where have all the Soldiers gone?", Where have all the graveyards gone?", and then returning to "Where have all the flowers gone?" (This reminds me of the song, "The Circle of Life" in the animated movie "Lion King") Then each verse ends with the same questions. "Oh, when will they ever learn? When will they ever learn?" most importantly "When

Return now with me to consider some of our Sunday Morning worship hymns.

A praise song with which we often begin our service is titled "This Is the Day". Wonderful words of praise – "This is the day that the Lord has made, we will rejoice and be glad in it." A wonderful testimony of how we will spend our time in worship.

In the hymn "In His Time" we are reminded how beautiful is God's creation. The seasonal changes can bring stunning changes for our enjoyment. (I do realize, though, some of the weather changes do not rise to that level called enjoyment.)

And then we raise our voices singing "Take Time to Be Holy", a wonderful time to reflect on the awesomeness of God, how He has provided us with the tie to "Time to Be Holy".

There are several other praise songs and Hymns that speak of time such as "In Moment Like These" and "In Times Like These."

Do you have your own Hymnal at home? If not, perhaps you could borrow one, or purchase one at a book store for your own family worship time in your home. Great uplifting time well spent.

Consider the following abbreviated story titled "The Unmoved Rock", source unknown

Once upon a time, there was a man who was sleeping at night in his cabin when suddenly his room filled with light and the Savior appeared. The Lord told the man He had work for him to do and showed him a large rock in front of his cabin. The Lord explained that the man was to push against the rock with all his might. This the man did, day after day, for many years he toiled from sunup to sundown, his shudders set squarely against the cold, massive surface of the unmoving rock, pushing with all his might. He became discouraged that the rock would not move. He planned to quit until one day he decided to make it a matter of prayer and take his troubled thoughts to the Lord.

"Lord," he said "I have labored long and hard in your service, putting all my strength to do that which you have asked. Yet, after all this time, I have not even budged that rock a half a millimeter. 

Readers are invited to submit questions about God, the Bible, and religion. I shall try to answer them for you, using the Bible as my final authority.

A couple of weeks ago we looked at Proverbs 2:1-9 and its answer to the question: How do we get wisdom? There we saw the two conditions necessary to being wise and understanding: 1) knowing how to obey God defined authority and 2) a desire to learn. Last week we looked at this as it applies to the coming elections. Today, we shall look at what it is to not behave wisely as we choose the next set of leaders. God defines two types of people that are the opposite of the wise, who know no authority but their own thoughts, and listen to no one who may disagree with what they already think. God refers to them as the foolish and the scorner.

The nature of a foolish person (usually called a fool in the Bible) and a scorner is that they only want to hear what they already think (Proverbs 18:2), considering themselves to be wise enough to already know anything of importance (Proverbs 12:15). For this reason, they will not receive instruction from others (Proverbs 23:9), and if you try to correct their errors, they will not like you for it (Proverbs 15:12) and will not learn from what you say (Proverbs 17:10). They also are easily angered at any who would challenge what they think (Proverbs 12:16).

The foolish and the scorner are alike in these things, the main difference between them is that the foolish will leave you alone if you leave them alone, but the scorner will freely voice their opinions, because they are proud in their self-conceived wisdom and are quick to attack any who may disagree (Proverbs 21:24). The scorner, in their pride, is a source of contention (Proverbs 22:10).

Because the foolish and the scorner will not listen to anyone who may disagree with them, and therefore are unteachable, they will often bring upon themselves and those they influence, trouble (Proverbs 19:29 and 29:8). When it comes to elections, to vote foolishly or as a scorner, our choices will affect everyone for time to come. So, how does the foolish and scorner vote?

First, they will vote for the party they always have, without investigating what the candidates on both sides really believe. Second, when they do investigate the candidates, they limit their investigation to what their favored party says about the opposition. And third, they will believe the campaign slogans without investigating what past performance (what the candidates have already done – actions speak louder than words) actually tells us about their candidate's politics.

A final comment about the foolish and scorner is that they do not care about moral issues, only that they get their own way (Proverbs 10:23, 13:19 and 14:9).

May we be wise in our voting, our future and that of our children depends upon it.

OCHD highlights **Breast Cancer Awareness Month**

ONEIDA COUNTY - The Oneida County Health Department (OCHD) recently highlighted Breast Cancer Awareness Month.

"Breast Cancer Awareness Month happens every October to bring awareness to breast cancer and breast cancer screening," OCHD said in a release. "This disease is far-reaching. In fact, each year it affects one out of every eight women in the United States and around 2.3 million women worldwide."

OCHD is asking the public to be on the lookout for pink this month, because pink is the color for breast cancer awareness.

The department said it is working with its partners, including the Wisconsin Well Woman Program, to do the following:

· Help people who have breast cancer. Those already diagnosed with breast cancer, even when it may have spread to other parts of the body, can receive financial and other kinds of support.

· Teach people about what causes breast cancer. Education is very important when it comes to breast cancer, and some organizations create messages to share so women know what can cause or increase their chances of getting breast cancer.

· Tell everyone how important it is to get checked. Some groups also share critical information about breast cancer screening messages. This includes sharing that starting at age 40, or sometimes earlier if you have a higher risk, getting regular check-ups can find breast cancer early when it's easier to treat.



· Collect money to study breast cancer. The more we know about it, the better we can fight it. So, breast cancer fundraising organizations raise money to do important research.

"In 2023, statistically about 5,460 women in Wisconsin may have found out they had invasive breast cancer, and sadly, 720 of them might not survive it," OCHD stated. "However, if we can find breast cancer early, with regular checkups, women can live longer, healthier lives."

OCHD said Breast Cancer Awareness Month is a great time to set up screenings.

"If you are a woman aged 40 to 64 and you do not have good insurance, or maybe you do not have insurance at all, you may be able to get these important screenings through the Wisconsin Well Woman Program," OCHD said.

WPS crews began their work in northwest Tampa earlier this month, jumping in and helping restore power to a hospital affected by the storm. The crews were also working to make repairs to some of the main power lines in the city's neighborhoods.

"Each time, residents have been quick to share their thanks, offer crews something to eat or drink, or express their appreciation for coming all the way from Wisconsin to help," WPS stated.

"We had customer after customer coming up and thanking them," Joanis said. "One guy drove by and said he wanted to come and visit Wisconsin

because he heard of all the great supper clubs ... he actually threw some names out there that guys knew. Our northern guys were very appreciative of that and thought it was pretty funny."

The sister utility of WPS, We Energies, also has crews working to restore power in Tampa. WPS noted that crews aren't sure when their work in Florida will be finished, but they are "committed to helping as long as they are needed."

"We're here, doing good work and helping people out ... it's kind of what it is all about," Joanis said. "If we can come help, we're ready and willing to do so."

WPS and We Energies helped restore power in Puerto Rico following the devastation from Hurricane Maria in 2017. Both companies also assisted in restoring power in Georgia and Florida after Hurricane Irma, and last year they sent crews to help restore power after extreme weather in California.



School District of Tomahawk to see roughly 13.5% increase in state aid

FOR THE TOMAHAWK **LEADER**

WISCONSIN — The Wisconsin Department of Public Instruction (DPI) last week posted state general school aids that school districts will receive during the current school year.

DPI said the release of certified financial figures is based on data from the previous school year, including student counts and year-end financial data.

The information published includes certified general school aid amounts for each school district, as well as 2024-25 student enrollment numbers for independent charter schools and private schools participating in the Private School Choice Programs (PSCP) and the Special Needs Scholarship Program (SNSP).

Certain enrollment numbers for these programs are used to determine the dollar amounts to be withheld from school districts' aid payments to fund the programs as applicable, according to DPI.

"General school aids are the largest form of state support for PK-12 schools in Wisconsin and are based on prior-year data," DPI stated in a release. "The PSCP, SNSP, and independent charter school programs are funded based on current year data."

DPI is required by state law to release the certified aid figures by Oct. 15 of each

General school aid amounts for school districts are calculated using student counts and year-end financial data from the previous school year (2023-24). This certified data replaces preliminary aid estimates released in July.

"The 2023-2025 state biennial budget increased funding for general school aids for the 2024-25 school year by 4.2 % (\$224.9 million) to a total of \$5.58 billion," DPI said. "Statewide, a majority of general aid is equalization aid, which is distributed according to a formula designed to help Wisconsin communities provide public education despite local differences in property wealth."

The formula incorporates school district expenditures, property values and resident student counts (called "membership"). The other, smaller elements of general school aids are integration aid (or "Chapter 220" aid) and special adjustment aid. The latter, also known as 'hold harmless' aid, prevents districts from receiving more than a 15 percent reduction in aid from year to year and will go to 69 dis-

Aid varies widely by district based on the equalization formula, DPI noted, Of 421 districts, 276 (66%) will receive more aid for 2024-25 than in 2023-24; 137 (33%) will

receive less.

According to DPI data, the School District of Tomahawk will see a \$237,390.00 (13.46%) increase in state aid, representing one of the largest local boosts, percentage-wise. Tomahawk's \$2,001,350.00 allocation is among the lowest in the area.

Aid amounts for each school district can be found on the department's School Financial Services webpage (www.dpi.wi.gov/sfs/aid/ general/summary), both alphabetically and by percent change.

General school aids are paid in four installments during the school year.



Notice is hereby given of a general election to be held in Lincoln County, on November 5, 2024, at which the officers named below shall be chosen. The names of the candidates for each office to be voted for, whose nominations have been certified to or filed in this office, are listed under the title of the office and under the appropriate party or other designation, together with any referendum questions submitted to a vote, in the sample ballot below.

INFORMATION TO VOTERS

Upon entering the polling place and before being permitted to vote, a voter shall state their name and address, show an acceptable form of photo identification and sign the poll book. If a voter does not have acceptable photo identification, the voter may obtain a free photo ID for voting from the Division of Motor Vehicles. If the voter is unable to sign the poll book due to disability, a poll worker may write the word "exempt." If a voter is not registered to vote, they may register to vote at the polling place serving their residence if the voter provides proof of residence. Where ballots are distributed to voters, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the voter shall enter a voting booth or go to a machine and cast their ballot. The vote should not be cast in any manner other than specified here. Sample ballots or other materials to assist the voter in marking their ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked. A voter who is a parent or guardian may be accompanied by the voter's minor child or minor ward. An election official may inform the voter of the proper manner for casting a vote but the official may not advise or indicate a particular voting choice.

Assistance for Voting

A voter may select an individual to assist in casting their vote if the voter declares to the presiding official that they are unable to read, have difficulty reading, writing, or understanding English, or that due to disability are unable to cast their ballot. The selected individual rendering assistance may not be the voter's employer or an agent of that employer or an officer or agent of a labor organization which represents the voter. If a voter is unable to state their name and address, an assistant may also do so for the voter.

A vote for candidates for President and Vice President is a vote for the presidential electors of those candidates. A write-in vote for President and Vice President must designate the name of a presidential candidate. A write-in vote for a candidate for President only will be counted. A write-in vote for a candidate for Vice President only will not be counted

Where Optical Scan Voting is Used

The voter shall fill in the oval or connect the arrow next to the name of the candidate of their choice for each office for which they intend to vote. To vote for a person whose name does not appear on the ballot, the voter shall write in the name of the person of their choice in the space provided for a write-in vote and fill in the $\,$ oval or connect the arrow next to the write-in line. When voting for President and Vice President, the voter shall fill in the oval or connect the arrow next to the set of candidates (ticket) for president and vice president for whom they intend to vote. To vote for a Presidential ticket that does not appear on the ballot, the voter shall write in the names of persons of their choice in the spaces provided and fill in the oval or connect the arrow next the write-in lines. On referendum questions, the voter shall fill in the oval or connect the arrow next to "yes" if in favor of the question, or the voter shall fill in the oval or connect the arrow next to "no" if opposed to the question

When using an electronic ballot marking device (Express Vote) to mark an optical scan ballot, the voter shall touch the screen or use the tactile pad to select the name of the candidate of their choice for each office for which they intend to vote. To vote for a person whose name does not appear on the ballot, the voter shall touch the screen next to "write-in" and type in the name of the person of their choice. When voting for President and Vice President, the voter shall touch the screen at the set of candidates (ticket) for president and vice president for whom they intend to vote To vote for a Presidential ticket that does not appear on the ballot, the voter shall touch the screen next to "write-in" and type in the names of persons of their choice. On referendum questions, the voter shall touch the screen at "yes" if in favor of the question, or the voter shall touch the screen at "no" if opposed to the question.

Spoiling Ballots

If a voter spoils an **optical scan** ballot, they shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one voter. If the ballot has not been initialed by two inspectors or is defective in any other way, the voter shall return it to the election official who shall issue a proper ballot in its place.

After Voting the Ballot

After an official optical scan ballot is marked, it may be inserted in a security sleeve so the marks do not show. The voter shall then insert the ballot in the voting device. or deliver the ballot to an inspector for deposit. If a central count system is used, the voter shall insert the ballot in the ballot box or deliver the ballot to an inspector for deposit. The voter shall leave the polling place promptly

[Article III] Section 1 (2) Every Only a United States citizen age 18 or older who is a resident of an election district in this state is a qualified elector of that district who may vote in an election for national, state, or local office or at a statewide or local referendum.

SECTION 1. Section 1 of article III of the constitution is renumbered section 1 (2) of article III and amended to read:

SECTION 2. Section 1 (1) of article III of the constitution is created to read:

[Article III] Section 1 (1) In this section:

- (a) "Local office" means any elective office other than a state or national office.
- (b) "National office" means the offices of president and vice president of the United States, U.S. senator, and representative in
- (c) "Referendum" means an election at which an advisory, validating, or ratifying question is submitted to the electorate.
- (d) "State office" means the offices of governor, lieutenant governor, secretary of state, state treasurer, attorney general, state superintendent of public instruction, justice of the supreme court, court of appeals judge, circuit court judge, state senator, state representative to the assembly, and district attorney.

SECTION 3. Numbering of new provision. If another constitutional amendment ratified by the people creates the number of any provision created in this joint resolution, the chief of the legislative reference bureau shall determine the sequencing and the numbering of the provisions whose numbers conflict.

Now, therefore, be it resolved by the senate, the assembly concurring, That the foregoing proposed amendment to the constitution is agreed to by the 2023 legislature; and, be it further Resolved, That the foregoing proposed amendment to the constitution be submitted to a vote of the people at the election to be held on the first Tuesday of November, 2024; and, be it further Resolved, That the question concerning ratification of the foregoing proposed amendment to the constitution be stated on the ballot as follows:

"Eligibility to vote. Shall section 1 of article III of the constitution, which deals with suffrage, be amended to provide that only a United States citizen age 18 or older who resides in an election district may vote in an election for national, state, or local office or at a statewide or local referendum?"

EXPLANATORY STATEMENT AS TO THE QUESTION

The Wisconsin Constitution provides that "[e]very United States citizen age 18 or older who is a resident of an election district in this state is a qualified elector of that district." Wis. Const. art. III, § 1. That language is repeated in Wisconsin statute. Wis. Stat. § 6.02(1).

The referendum question would modify the language in Wis. Const. art. III, § 1 to provide that "only" a U.S. citizen 18 or older who resides in an election district may vote, and it would specify that only such individuals may vote in an election for "a national, state, or local office or at a statewide or local referendum." It also would add definitions of what "local office," "referendum," and "state office" mean. 2023 Wis. S.J. Res. 71.

A "yes" vote would vote to modify existing article III, section 1 of the Wisconsin Constitution to provide that "only" a U.S. citizen 18 or older who resides in an election district can vote "in a national, state, or local office or at a statewide or local referendum."

A "no" vote would vote not to change Wis. Const. art. III, § 1 of the Wisconsin Constitution.

Packers vs. Texans: The Good, the Bad, and the Ugly

So that was chill, huh?

Before we get to the Green Bay Packers' 24-22 Week 7 victory over the Houston Texans at Lambeau Field on Sunday, let's recap the Pack's last few games. Since my last column on Green Bay's win over the Tennessee Titans in Week 3, the Packers lost at home to the Minnesota Vikings in a blowout-turnednail biter marred by three interceptions from Packers quarterback Jordan Love and a pair of missed field goals by now-ex-Packers kicker Brayden Narveson; beat the Los Angeles Rams on their home turf to maintain Green Bay head coach Matt LaFleur's perfect winning streak against his



friend and mentor, Rams head coach Sean McVay; and flat-out walloped the Arizona Cardinals at home. The Packers now stand at 5-2, behind the Detroit Lions and the Vikings, each with 5-1 records, in the NFC North. The Chicago Bears, at 4-2, were on a Week 7 bye and are in fourth place in the division.

Alright, let's get into the Good, the Bad, and the Ugly from the Packers' anxietyinducing, ugly-at-times, lastsecond win over the Texans.

The Good

First and foremost, I want to send a sincere "atta boy Josh" and virtual high-five to Packers running back **Josh** Jacobs, who caught his first career touchdown reception on Sunday. Prior to his score, Jacobs, at 212 career receptions, held the NFL record for the most catches without a touchdown, LaFleur earlier this year said he intended on getting Jacobs a touchdown catch this season, and it was great to see Jacobs' Lambeau

Leap after finally ending the scoreless streak.

In my 2024 season preview published a few months ago (www.tinyurl.com/ht9wdeu), I predicted the Packers would beat the Texans in a shootout. While Green Bay did, indeed, get the W, it seems like only one quarterback brought his six shooter. While Jordan Love was slinging the pill around the yard (positive and negative connotations here), Texans quarterback C.J. Stroud was straight-up not having a good time. The Packers' pass rush had the usually-electric Stroud in the torture chamber all day, pressuring him on seemingly every down and sacking him four times while holding him to just 10 completions on 21

pass attempts for 86 yards and no touchdowns. You couldn't ask for more from defensive coordinator Jeff Hafley's guys.

Jaire Alexander talking trash is always great to see, and there was no shortage of it on Sunday. On-field drama between Alexander and Texans wideout Stefon Diggs broke out before the game, and Alexander kept up the smack talk all day. It might've been effective: Diggs left Lambeau with just five catches for 23 yards.

Have the Packers finally ended their kicking woes? Green Bay signed 33-year-old veteran kicker Brandon McManus last week, and he made his debut for Green Bay in glorious fashion

on Sunday. McManus hadn't been with a team since last summer, after he and his former team the Jaguars were sued by two women claiming McManus had sexually assaulted them while they were working as flight attendants when the Jaguars traveled to London last year. After an investigation, the NFL in September said it found insufficient evidence that McManus had violated the league's personal conduct policy, and the civil case has since been resolved. In his first game with Green Bay, McManus hit a 45-yard field goal as time expired, sealing the Packers' win. After enduring struggles

Fishing Report: Turnover is imminent

NORTHERN WISCON-SIN - We're getting some typical fall weather right now, albeit a bit warmer than we're used to for this time of the year. Water temperatures remain in the mid-50s - we're seeing both upper and lower 50s, depending on the body of water. Turnover is imminent, and we've heard of some smaller lakes where it's on.

Walleye fishing is generally good at this point, although just like the water temperatures, we're getting very different reports from different lakes. Fish are being caught on the deep flats and in the holes on many bodies of water. This makes them pretty easy to find, and these deep spots will be exactly where you'll want to be after turnover, too. If you find yourself in a spot with a good bite, don't be afraid to put some of those big ones back to help with next year's spawn. Jigs and minnows have been doing the trick, with walleye suckers or large fatheads working

well. On the bigger lakes, you may have luck looking off the breaks, at hard bottom areas in water from 20 to 35 feet or so. Again, larger minnows seem to be working the best.

Panfish action has been decent, with perch leading the bunch and being found surprisingly shallow by many anglers. Look for shallow weeds and use bigger minnows to catch those big guys, but crawlers are still working great, too. The bluegill seem a little confused by the last couple of weeks of weather, but crawlers are working. Crappies have been pretty deep, along weed edges or structure. They seem to be hanging at about 15 feet, and crappie minnows and the smallest jig you can manage have been working for these fish.

Bass action has remained steady. Not a lot of anglers fishing for largemouth, but the smallie bite has stayed excellent. These fish are being caught all over the map - deep flats and shallower weed edges. Bigger sucker

minnows or plastics that mimic are working great.

The northern have been hitting well, with a lot of musky anglers reporting catches of northerns on musky baits while fishing in or near weeds. As usual, the deeper the weeds the better for these fish.

Even with the warmerthan-usual weather, musky action has been good. We're glad to see a forecast with some colder weather, even if it is still a bit of a rollercoaster. The sucker bite has been getting strong now, and we've also seen some great action on bucktails and jerk baits, too. It's almost time for a super slow retrieve and giant plastics - almost. We're just waiting for turnover to come and go, hopefully before the snow flies, to see some of those giants!

Assuming we're in for a "normal" winter, we're going to see snow flying on some of these cold days

Packers punter **Daniel Whelan** earned a tip of the cap as well. While the Packers struggled to convert on third downs in the second half, Whelan was able to push

the Texans' starting field position far enough downfield to give the defense a chance to keep them off the scoreboard. Whelan averaged just about 57 yards per punt on five punts - a notable jump from his roughly 46-yard average heading into the game, and the second-best singlegame average in team history. Whelan's longest punt of the day went for 66 yards, and he also deftly handled a low snap that McManus sent through the uprights for the win.

Green Bay appears to have a Dawg in rookie safety Evan Williams. He's a tough, instinctual player, and he's made several key plays this season, including stuffing a run on a two-point conversion attempt by Houston. Williams' tackle arguably saved the game for the Packers. His nine tackles Sunday were the most on the team, and he joins his teammate Xavier McKinney as the league's two highest-graded safeties by Pro Football Focus. Keep an eye on this guy.
