# Suicide among farmers

Signs of stress, how to get help

IOLA – The Waupaca County Suicide Prevention Coalition held a presentation called "Grateful for Growers," on Jan. 23 at The Rustic Grill in Iola to shine a light on suicide among Wisconsin farmers.

The program focused on mental health, self-care and warning signs to look for in those who may be considering suicide.

Jeff Ditzenberger, the keynote speaker and founder of Talking Understanding Growing Supporting (TUGS), told his story and encouraged the crowd to check in on the people in their lives.

"My tagline on my website and all my paraphernalia is, 'It's okay to not be okay," said Ditzenberger. "Find the help. Find the resources for you [or] the one going through it or help someone do it. And then again, in a world where you can literally be anything you want ... be kind. Please be kind, but remember to be kind to that person in the mirror, too."

Ditzenberger joined in on a panel discussion with Brenda Statz from Farmer Angel Network, Dr. Lynae Schott, a veterinarian and a representative from Wisconsin Farm Center, and Vivian Flanagan and Vicki Rivera from the National Alliance of Mental Illness (NAMI).

Both Statz and Ditzenberger talked of the tremendous stress that farmer's take on every day.

Statz said her husband ended his life in 2018 due to a variety of contributing factors dealing with farming, something many of Wisconsin farmer's feel the weight of daily.

"If I fail, we all fail. This is the mentality that a farmer takes. Everything is

on them. No matter what happens, they relate it back to them that they caused it," Statz said. "If it rains, 'I should have cut hay two days ago.' You can't control the rain, but they're going to blame themselves. Or I should have maybe paid this bill here, instead of there. But, they always know how to turn it around that it's their fault."

Statz said the Farmer Angel Network is a support system for those farmers that need someone to listen and they can help navigate through these feelings and challenges that are faced.

Statz said being able to recognize symptoms of depression or suicide risk is very important and can be a wide variety of factors including: isolation from social life, a decline in appearance or in the maintenance of the farm, changed in eating or sleeping and lashing out are a few.

Statz also mentioned language used can also be a sign, including comments about worry, self-blame, lack of control, getting even and calling it quits.

Ditzenberger said the warning signs are not always obvious, if anything seems off just taking a moment to ask if someone is okay could be exactly what that person may need.

Another number that can be called is the Wisconsin Farmer Wellness Program, which has a 24-hour number that can be called at any time with experienced stress counselors.

The Farmer Wellness Program will also connect farmers to various resources including vouchers for ongoing counseling and assistance with financial consulting, transition planning, mediation, arbitration, farmer veteran programs and things like herd-based diagnostics.

## Deuman retires after 30 years

## Foundry partners in protection

WAUPACA – Chief Jerry Deuman is retiring from his role as fire chief this January after 30 years as a volunteer firefighter.

The Waupaca Area Fire District protects 147 square miles. Its coverage includes the City of Waupaca and the Townships of Waupaca, Farmington, Dayton, Lind, and portions of Lanark and Belmont in Portage County. This area is protected by 32 volunteer firefighters and one full-time chief.

The new full-time chief is Jake Waller who was hired by the City of Waupaca on August 5, 2024, replacing Jerry, who served as chief since 2016. Waller credits Jerry with building lasting community relationships and expanding the fire department's role. A major

challenge for the department was taking responsibility for fire protection at the Wisconsin Veterans Home at King, which required patience and teamwork with the state.

"Jerry has been a great mentor/teacher to everyone on this department, always willing to take time to teach and explain the reasoning behind it," Waller said. "Jerry always took a 10,000-foot view of the issue and saw the big picture. His knowledge and leadership will be greatly missed on the fire ground but also in the fire department."

## Hardhats to fire helmets

Deuman is a maintenance manager at Waupaca Foundry, where he started as an electrician. The Waupaca Foundry has an arrangement with the fire district: if an employee is also on the volunteer fire department and is called out during a work shift, they are still paid their full hourly rate while on the fire

"The safety of our team members and their families is our highest priority. Leaders like Jerry exemplify this through his commitment to serving and protecting others, which he did for our community for decades. We're proud of his service," said Executive Vice President of Administration & CFO Rob Johnson

The Waupaca Foundry currently has six employees who are volunteer firefighters for the Waupaca Fire Department and many other neighboring fire departments.

"I remember getting about three hours of sleep during the day, going to my kids' events at school, catching a quick nap before I went to work, and also being called out on fires," said Deuman. "Long story short, it's just about helping out communities, neighbors, friends, and whoever is in need. The state auditors can't believe we can leave our jobs [at Waupaca Foundry], put on our gear, get in the trucks and leave for a call in five minutes. It makes us feel really good because our response time is so quick," said Deuman.

## **Open house for new EAA chapter**

### Clintonville-Shawano airports join up

CLINTONVILLE – More than 40 people attended an open house at the Clintonville Municipal Airport Jan. 15 for the newly formed EAA Chapter 1710, encompassing the Clintonville and Shawano airports.

At the open house, EAA Chapter 1710 President Mathieu Labs unveiled the logo for the new chapter, which officially became a chapter in November of last year.

The vision for the chapter first began in 2020, when Clintonville City Administrator Caz Muske was hired as the deputy city administrator. One of her duties at that time was to oversee the city's public

works department, which included managing Clintonville Municipal Airport.

"I had a great mentor,

Mike McCord, he was very

knowledgeable and was with the city for decades," Muske told the Tribune-Gazette. "One of the things that he had said, was we really need to get more activity here (airport), and there's this thing called EAA. I

Rivera and Flanagan also talked of NAMI resources, including virtual support groups and educational classes, all of which is free.

NAMI was started in Wisconsin in 1979 when two mothers with sons living with schizophrenia decided they were not getting enough guidance or help.

"I think language matters," Flanagan said. "People are so much more than their illness ... they are a beautiful person inside that just happens to have the challenges."

The biggest take away from the program was the simple task of checking in on friends and family.

Ditzenberger said having the difficult conversations—asking people if they are suicidal, could help save that person. Instead of using phrases like, 'You're acting crazy,' show the person that you are a person that will listen and offer help.

If immediate assistance is needed the hotline number is 988, this number connects callers to a mental health professional for help.

Ditzenberger said one of the misconceptions about 988 is that they will call the authorities and you will be taken away, and that is not something that they commonly do.

"They are the most interesting, most compassionate group of people I've ever had the opportunity to work with," Ditzenberger said.

Mark Miller, the outreach coordinator for 988, said two percent of 988 calls end up with outside intervention, while in Wisconsin that number is even lower at only a half a percent.

knew nothing about it. I'm from Texas. I don't know much about aviation. That stuck with me, so working with him and trying to get some traction, it just never happened."

Muske said she began working with the EAA on creating a chapter in Clintonville around 2021, but not much progress was made until the end of 2023 when she connected with the manager of the Shawano Municipal Airport, who also expressed interested in helping form a local EAA chapter.

When Muske connected with Labs, it was full steam ahead for the creation of a new EAA chapter. In October of last year, Labs agreed to be the president of the

Labs, who was a member of a different EAA chapter when Muske reached out to him, said he was considering leaving that chapter.

"I started talking to Caz and Colin (manager of Shawano Municipal Airport), and they were still looking for a president after a month, and I just said, 'You know what. I'll do it," Labs said. "Somebody has to step up and take it over, and I already have the leadership experience, and so does my wife. I have a lot of good connections with the EAA. What we've done with this chapter, most chapters would take 5-10 years to do. We're already on the map."

### Chapter formation

Labs said it is a long process to be recognized as an official EAA chapter.

"Basically, you have to have an EAA number, you have to register with the state, you have to have a minimum of 10 members, all EAA members, you have to follow guidelines, and you have to create your own bylaws, which probably took us two months to do," Labs said. "It's a lot of things that EAA wants so you can be on their insurance. We have events where we are on EAA insurance. You can also apply for a 501(c)(3) (nonprofit), which is what we're doing so we can start to get donations. After that we can get a raffle license. To be on EAA's insurance, they have a lot of requirements. It's vigorous. If you have the people with the right mindset, you can get it done."

Because at least 10 committed members are reguired for the creation of a new EAA chapter, Muske said that was the reason it so long for the Clintonville and Shawano EAA chapter to become official.

"I think that was the hardest part, because, especially in small towns, everybody wears multiple hats," Muske said. "They're all serving for all the same organizations. So, the hardest part was getting leadership to step up and say, 'Ok, I will help lead this.'

The Clintonville and Shawano EAA Chapter 1710 has 20 members as of the date of the open house.

### Chapter benefits

Muske said having an official EAA chapter will showcase the value of the airport in the city of Clintonville.

"There's a lot of community members that don't even know we have an airport," Muske said. "For me, I was tasked by our elected officials to bring activity, to work with Mike McCord before he left and to find ways to bring more awareness, and to show the value of what this is.

"Historically speaking, the birthplace of an airline was here in Clintonville. So, Delta Airlines, a couple of mergers back, started North Central Airlines here in Clintonville. So, it's a huge historic monument of our community

that I feel like has been lost in translation. With my elected officials, they want to bring that back and show the value of aviation, and how our community specifically has a history in aviation, and making sure that we don't forget that awesome history that we have in the community."

Muske added that teaming up with the Shawano Municipal Airport makes sense because "there is power in resources coming together and partnering."

Having airports working together to form one EAA chapter is not a new concept. Labs said the EAA chapter in Rice Lake encompasses 10 airports, while an EAA chapter in Illinois has 20 airports as part of the chapter.

### Chapter activities

The monthly meetings for the chapter will be held in Clintonville and Shawano, alternating between the two airports each month. Over the course of the next year, different speakers will speak at the meetings on topics related to aviation.

'Mat has done a lot of ground work with soliciting different speakers that are in the world of aviation," Muske said. "He's reached out to a lot of different people around the state."

Members do not need to be a pilot or own an airplane to be a chapter member, all they need is an interest in aviation.

"I think it's a great industry," Muske said. "You can be with likeminded individuals. Pilot license or no pilot license, you're welcome here."

Members of the community can attend the EAA Chapter 1710 meetings to find out what the chapter is about, even if they are not members of the chapter.

"Goals right now are to grow membership, get people involved, just have a positive outlook out there,'

## **Historical Society gets grant**

STEVENS POINT – The Portage County Historical Society (PCHS) has been awarded a Visionary Grant from the Community Foundation of Central Wisconsin. As one of the inaugural recipients of this prestigious grant, PCHS will receive five years of support to enhance its impact in Portage County.

The funding enabled PCHS to create a new, full-time museum educator position. This role is designed to deepen the society's educational outreach and programming, ensuring alignment with Wisconsin's state social studies standards and fostering meaningful partnerships with local school districts and

community organizations. The museum educator will also plan and execute engaging public educational programs, as well as deliver interactive, hands-on experiences across PCHS's historic site museums.

Kimberly Kopplin is the new museum educator. Kopplin brings a wealth of expertise to the role, including over 15 years of experience as an elementary educator and a recent position with CAP Services. ## School board news round-up

STEVENS POINT – On Monday, Jan. 13, the Stevens Point Area school board discussed programming updates, open enrollment for the 2025-26 school year, student news and the results of the district's 2023-24 audit.

### Student affairs

Student Senate representative Kylie Haas announced a successful winter sports season thus far at SPASH. At the time of the meeting, the boys' hockey team and the boys' swimming team were undefeated.

Haas concluded her report with a promotion for SPASH students' upcoming one-act play, to be performed Friday, Jan. 31, and Saturday, Feb. 1, at 7 p.m. in the SPASH auditorium."[The students] hope to see many community faces there," she said.

The Student Art Show will be held on Jan. 30 from 4:30-6:30 p.m. at the Bliss Educational Services Center.

### New website

Communications Director Sarah O'Donnell announced that new district website, www.pointschools.net, launched successfully on the day before winter break. In addition, she reported an increase in traffic on both the website and on the district's social media accounts. The District will continue to address user feedback and to resolve support requests going forward. O'Donnell also mentioned that an episode of "Monday Mornings with Mike" featuring district updates was the series' top-viewed episode of the year.

### Honors

McKinley Elementary teacher Robert King was presented with the Mandana Bliss Award, which honors "unwavering commitment and outstanding efforts... for educational excellence." The award is named after Mandana Hale Bliss, Stevens Point's first schoolteacher.

In addition, cross country coaches Donn Behnke and Kevin Hopp were named Wisconsin Cross Country Coaches of the Year by the Wisconsin Cross Country Coaches Association.

### School finances

Superintendent Cory Hirsbrunner announced a series of donations to area schools, including a piano to the music department and \$30k to be used toward treadmills at SPASH. In addition, there is a potential offer "on the table" for a donation of up to \$50k to be used toward new playground equipment at McDill Elementary School.

The results of the 2023-24 financial audit of the district, conducted by an outside audit firm per state guidelines, "went smoothly," according to the team, who found "nothing out of the usual." The board unanimously passed a motion to accept the report.

The board reviewed the budget evaluation process. After reviewing 48 programs and 374 positions, the district filled three positions "as is," froze ten positions and eliminated 11. They are currently evaluating 14 programs with potential inefficiencies, which will be reviewed at the next meeting on Feb. 10 at 6 p.m.

Hirsbrunner put forward a motion to approve a \$39k proposal from urban planning company Consulting MDRoffers "to conduct community growth and enrollment projections, with funding sourced from budget savings due to unfilled positions." The study is estimated to take 4-5 months and will culminate in a detailed report with projections for every grade level at every school in the District through 2040. The motion passed, with all members present voting yay except for Dennis Raabe, who voted nay.

### School staff

The board approved the personnel recommendations put forth by HR, which noted the retirement of six personnel, the resignation of one and the acquisition of a school nurse.

Several district employees will attend the State Education Convention, which will be held in Milwaukee from Jan. 22-24.

### Election

Candidates for the upcoming spring school board election were announced in the order in which they will appear on the ballot: Jen Bushman (I), Miguel Campos, Jeremy Lebrick, Marne Mercer, Barb Portzen (I), Kristina Smith.

### Partnership

Boys and Girls Club (BGC) of Portage County

CEO Danielle Belsky gave a presentation on the ways in which the organization collaborates with the district, which includes providing kids with a safe space for kids to spend time after school, time to work on homework, snacks and enriching programs. BGC also provides mentors to struggling students and a workforce development program. The Berard Center location also offers dental care. BGC has been established in Portage County since

### Enrollment

The board discussed open enrollment projections for the 2025-26 school year as reviewed by the Educational Services Committee on Jan. 6. Based upon enrollment trend data, staff workloads, student needs and projections for the coming school year, the Board unanimously passed the motion to approve unlimited general education 4K and general education non-resident seats available under open enroll-

Due to a current limitation of available resources for the programs, which require specialized instructors who are able to provide for disabled students' individual needs, the board also passed the motion to restrict the number of seats available under open enrollment to zero multi-categorical students (all disability areas) for early childhood programming, K-6 inperson and grades 7-12 in-person.

There will be one multi-categorical (all disability areas) seat available for the disabled and three seats available for Project SEARCH.

### School policies

The board unanimously passed a resolution to revise the contents of Policies 8510 and 8511, the district's wellness and free and reduced-price meal policies, respectively. In addition, the district will be looking into the possibility of making participation in school sports count toward students' P.E. credits.

The board approved with amendments a series of resolutions proposed by the Wisconsin Association of School Boards that included report card standards, decoupling public and private school funding and pathways to licensure for prospective teachers.

## Board looks at district's facilities

### Creating a long-range plan

**BY BERT LEHMAN** STAFF REPORTER

CLINTONVILLE Clintonville Superintendent Troy Kuhn presented information about the district's facilities to the Clintonville Board of Education, as a starting point of creating a long-range plan to make sure its facilities are up-to-date and meet the needs of the district.

The discussion took place at the board's Jan. 13 meeting.

Kuhn told the board that the information being presented was gathered by himself, District Activities Director Shaun Liesch, Director of Buildings and Grounds Stephen Reinke, and some of the district's committees.

"Our baseball and softball locations for accessibility is not good, especially for handicapped," Kuhn said.

Kuhn said there is a "buzz" about the district creating a space for recreation. He said there are two reasons for that. First, pickle ball participants and others have been kicked out of the Rec Center gym because of wrestling.

"We have explored many options where wrestling can go, and at this point, the Rec Center gym is the best spot still to have it," Kuhn said.

Second, the district would like more storage. Kuhn acknowledged that not everyone is in favor of using trailers for storage.

"I know they're kind of an eye sore," Kuhn said. "They serve their purpose, they're waterproof, rodent proof, etc."

### District wants

According to Kuhn, stakeholders to the district have different things they want in the district. Outdoor learning spaces are is currently playable. included in those wants. Kuhn said a pavilion for

the elementary school would cost \$12,000-\$15,000, depending on how elaborate it would be.

The bus garage also needs to be fixed. Preliminary estimates for that is around \$100,000.

"And that I think is a necessity, at least from what I have heard," Kuhn said. "We need to fix the roof, and some other leaks," said Kuhn.

A new maintenance shed is also needed. Kuhn said to tear down the two existing maintenance sheds, and to construct one large maintenance shed and parking garage would cost around \$200,000.

Kuhn said a lot of people have been in contact with him about the idea of the district constructing a multi-purpose sports complex built on district property. He said it could go on the tennis courts or adjacent to the tennis courts.

It could also be an extension of the Rec Center. If that were to be the case, Fund 80 funds could be used to fund the project.

A multi-purpose sports complex could house summer gymnastics, pickle ball, indoor tennis, and a youth center.

"Depending on if we would choose to upgrade the baseball and softball field onsite, we would possibly have to move the varsity soccer field, meaning that we would probably have to put bathrooms in there for the new soccer field to be located," Kuhn

### **Facility** assessments

Kuhn told the board the district's onsite baseball field is not playable.

"It has been probably neglected for five years," Kuhn said. "They don't even practice there anymore. It's just sat there."

The onsite softball field

He said there is no parking available for either the onsite baseball or softball fields.

"That's always been a problem," Kuhn said.

Kuhn said the playing surface of the district's football field in crowned perfectly, but the running track that surrounds the football field is also crowned outward for drainage.

'That's not the way they do things anymore," Kuhn said. "They either build some type of a drainage tile, so that the water goes in and it goes underneath the track and out. It's recommended that that track should actually be sloped the other way."

The district could leave the football field as is, or it could create a turf playing surface, and then soccer could also be played on the football field.

Also, regarding track, Kuhn said the jumping pits need to be moved to a location where there is more space.

Kuhn said the varsity soccer field is in good condition, but can get very wet in the spring. There are also no lights and limited bleacher seating at the soccer field. He added that if the district would move the onsite softball field closer to the onsite baseball field, and create handicap parking, half of the varsity soccer field would become a parking lot.

"Then it is, do you turf the football field and allow soccer to play up there?" Kuhn asked. "Or do you move the whole soccer complex.'

He added, "Soccer is growing in Clintonville. We have middle school soccer that is booming, so we need space."

Kuhn said the current tennis courts need to be replaced, which is a big

"Right now, we're just leaving them as is until we figure out what we want to do," Kuhn said.

The current Fieldhouse seating and floor are in

great shape, Kuhn said.

"We get lots of compliments when people come here and play in our Fieldhouse," Kuhn said.

The middle school gym, which Kuhn said is brand new, is "really good."

The gym floor at the elementary school can no longer be resurfaced, as it has reached its limit as to the number of times it can be sanded, Kuhn said.

"We probably need to be looking at replacement in 10-15 years," Kuhn

### Funding options

Kuhn said referendum funds could probably be used for the bus garage repairs and building a new maintenance shed. These two projects would exhaust the referendum funds still available.

Kuhn had earlier told

that remain to be spent from the most recent referendum need to be spent by the district by Jan. 1, 2026.

Funds for repairs to the running track would be needed in the next 5-10 years, Kuhn said. Those funds would come from Fund 10 or possibly a future referendum.

If the district would decide to redo its onsite baseball and softball fields, funds would have to come from Fund 10 or a future referendum. The other option would be for the district to continue to use ballfields owned by the city of Clintonville.

Kuhn said if the district would decide to pursue constructing a multipurpose sports complex, it would need around \$3 million for the project, depending on the size of the building. Funds from

funds from a future referendum.

"We have to create a plan," Kuhn said. "And for some of them, sooner than later, because we need to spend roughly \$400,000 of the referendum money before January 1st."

Kuhn said whatever plan the district would decide on, would be the district's plan, and not his plan. He also acknowledged that any plan would also have to consider other expenses in the district, such as health insurance and staff wages.

"Everything I presented right now might get thrown out the door," Kuhn said. "I am hoping for the best and preparing for the worst, because if a referendum doesn't pass, it doesn't pass. It doesn't matter what we present. We need to have a back-

## District to buy three new buses

\$332,809 after trade-in

NEW LONDON – The School District of New London will be purchasing three new school buses for a total cost of \$332,809, after the trade-in allowance.

The New London Board of Education approved the purchase of three new buses when it met Jan. 8.

At the meeting, Joe Marquardt, SDNL business services director, told the board that at the December Facilities Committee meeting, the committee reviewed the bids the district had received for purchasing new buses. Bids were requested in October 2024.

"If you remember, it's almost an annual review, there have been years that we have skipped bus purchases as a specific decision of the board for reasons

that are in that budget, or just trying to be sustainable in transportation operations," Marquardt said.

Marquardt told the board that the district was looking for approval to purchase three school buses. He said district administration was recommending approval of the low bid from Ascendance Truck Centers for three International buses, at a cost of \$138,270 per bus. The Ascendance Truck Centers' bid also included a tradein allowance of \$82,000. With the trade-in allowance, the total cost of the three new buses would be \$332,809.

Only one other bid was received, which was from Nelson's Bus Service, Inc. for three Thomas buses. Its bid was for \$137,673 per bus, but included only a \$75,000 trade-in allowance. This would have

put the total purchase at

\$338,019.

Marquardt told the board that the bid from Nelson's Bus Service was disqualified because the bid was not received on time.

Even though the low bid included the district trading in four current buses it has, Marquardt said the district didn't have to trade in any buses. The district could sell current buses on its own.

The board was reminded by Marquardt that last year's school budget included the purchase of one new bus, but the district has not received that bus yet. He said he anticipated the district would receive that bus by the end of January.

Marquardt added that it was indicated in the bids, that if the district agreed to purchase new buses this year, the buses would be scheduled to arrive in 2026.

## Shoreline project moves ahead

MANAWA – The shoreline stabilization project is set to move forward, despite a slight push back from the Department of Natural Resources (DNR).

Ann Bonikowske, a firstward alderperson, said the DNR was concerned that the project would disrupt fish movement and spawning for sturgeon, walleye and panfish.

The shore stabilization is needed in order to stop the erosion at the Sturm Memorial Library and Kobussen shorelines, which was due to the historic flooding July 5 that caused the dam to breach.

The Manawa City Council pursued a grant through the United States Department of Agriculture (UŜDA) that would alleviate the bulk of the cost of stabilizing the shorelines at the Sturm Memorial Library and Kobussen.

Bonikowske said the time

spawning and movement for fish is between Oct 15 and May 15; however, waiting to stabilize the shore until after that timeframe could result in the loss of the grant from the USDA as it expires April 25.

Mayor Mike Frazier said at the Jan. 20 common council meeting that representatives from the DNR, USDA and Cedar Corporation met, along with Frazier and Josh Smith, head of the Department of Public Works, on Jan. 14 to discuss getting the permit and the project up and running as soon as they can.

During this meeting, Frazier said the representatives from the USDA and Cedar Corporation were able to get the DNR to budge on their time frames and allow the project to move forward

prior to the grant deadline. "I'll tell you what ... they didn't back down," Frazier said of the meeting. "They

frames most important to because all of us know that spring here, between snow and runoff and we get rain with that, you're going to have more damage to that river and the wildlife and then the fishing."

"Before the project starts there is a small amount of the river bottom that will need to be excavated," said Brandon Strehlow, a representative from Cedar Corporation, the city's engineering contractor.

The excavation is needed in order to create space for the rock riprap foundational pieces; these pieces will be used to stabilize the shore-

Strehlow said the excavation portion of the project will need to be completed by March 1, per the language in the DNR permit.

The rip rap will go about four feet below the water surface and 18 feet above. The contract is currently in the bidding process and construction is anticipated to start by late February.

Gaffney, SC - - Our beloved Mom left this earth on January 15, 2025, slipping peacefully away only a few weeks before her 100th birthday. It was almost like she had gotten out of bed and was silently cruising the halls of her house in her wheelchair, hoping we wouldn't hear or notice.

Mary was born on February 8, 1925, on the family dairy farm, Clover Dell, halfway

between Waupaca and Weyauwega, Wisconsin to John Jensen and Verna Mae Jensen. As a 'farm girl', Mom learned about chickens, cows, sheep, how to harvest and preserve the produce from Grandma's 2-acre garden, how to sew on Grandma's treadle sewing machine, and hundreds of other skills. Her love of the land engendered the same respect and love for growing things, especially crops, flowers and puppies. For several years after moving to Cherokee County, SC, she had a 2-story greenhouse on the south side of the house that Dad had built for her, where she could raise every kind of flower you could imagine. But after moving from the Midwest to the Southeast, her big frustration was not being able to grow apricot trees or sweet corn.

Mom and Dad (Arthur Morris Pedersen, MD) met at Dana College in Blair, Nebraska and were married on May 11, 1947. Coincidentally, Dad had also been born in Waupaca, but when Grandpa Pedersen went into the Public Health Service they moved away and lived in many towns in Iowa and Nebraska. Eventually, Dad's family settled in Blair. Dad went to the University of Nebraska, School of Medicine for his MD, while Mom earned her RN at Milwaukee General Hospital. They settled in Council Bluffs, Iowa, across the Missouri River from Omaha. Their children, Barbara Jean was born on November 25, 1948. William Allen (Bill) was born on May 18, 1951 and several years later, Nancy Lynn was born on April 25, 1958. It was easy to see the favorite in the family, but Nancy was such a sweetheart that neither Barb nor Bill was jealous in the least.

Dad was team doctor for the Thomas Jefferson HS football program, where he met Steve Field, Vice Principal. Steve raised and showed Rough Collies, which fascinated Dad. Soon our backyard was home to a pair of Collies, Prince and Muffy (who protected us by barking at butterflies). The neighbors were annoyed, prompting Dad to build outside city limits to pursue his hobby of Collie breeding. And that's how Mary learned to raise and show their dogs. Several years later, the kennel expanded to include Bouvier des Flandres. CH Bibarcy's Soldat de Plomb (Sarge) worked his way to becoming the #1 Bouvier in the nation. Quite an accomplishment, especially when one considers that petite Nancy could take Sarge into the ring on a Chihuahua lead.

Bill and Barbara spent every summer on Grandpa and Grandma Jensen's dairy farm to give Mary a break and allow her to heal from her fight with polio. While on the farm, Grandpa Jensen taught Barbara how to ride horseback while he farmed with his team of Belgians, Babe and Nelly. Bill decided he'd rather learn how to drive the tractor, though. Don, Mary's brother, helped Grandpa on the farm and rented horses during the summer for us kids to ride. Barb didn't really have a favorite, until Lightning came along one year and was bred to a Thoroughbred owned by one of Don's friends. The next year Lightning foaled a dappled Palomino colt, Sunny, on the very same day as Nancy's birthday.

Grandpa Jensen began Sunny's training and built a solid set of habits so that we kids could do almost anything with him without fear of being kicked. When he was moved to Iowa we kept him in our fenced backyard by day and stabled him in the garage by night. But then there was the problem of where to keep him when the family was out of own on weekends for dog shows. And that's how we came to move further out into the County, to the former State Orchard farm. And that's how Mary learned about horse shows. We didn't have a horse trailer, yet, so when Barb found a show close enough to our farm to ride Sunny to it, Mom would patiently follow in her Mercury station wagon, flashers blinking the whole way. Not too much later, Bill got interested in riding around our pasture, so Patsy, a buckskin Quarter Horse, came to be his ride and Sunny's

When Nancy turned 5, she wanted to ride too. So Mom and Dad took Patsy to George and Vivian Stock to be bred. The next year Gypsy was foaled, the cutest little sorrel filly you ever did see. From Gypsy and Nancy going to horse shows, they met Marsha Stacy and learned how to do competition barrel racing. By that time Dad had moved the family to Cherokee County, SC because he didn't want to shovel snow any more. And that's how Nancy got started in rodeo, and how Mary learned about rodeo competition and





Even though it would take that long to deliver the new buses, Marquardt said the price of the news buses would be guaranteed and the trade-in allowance would remain the same.

"They just take longer to build now," Marquardt

Board Vice President John Heideman said there was value in the price and trade-in allowance guarantee because there is a good chance the bus delivery will be delayed and costs continue to rise.

Board member Mandy Wilz asked for verification that the bus purchase is in the current budget, and that the district would not be borrowing money

to purchase the buses. She also asked what the district would do with the funds received if the district sold some of its buses instead of trading them in.

Marquardt said the district would not sell any buses until it received the new buses it ordered. He also said the bus purchases are in the 2025-26 budget.

He added that the district typically does trade-in a buswhen it purchases a new one, but this current year somebody approached the district about purchasing one bus. If the district is offered more money for a bus than what is offered as trade-in value, Marquardt said it would make fiscal sense for the district to sell a bus outright.


