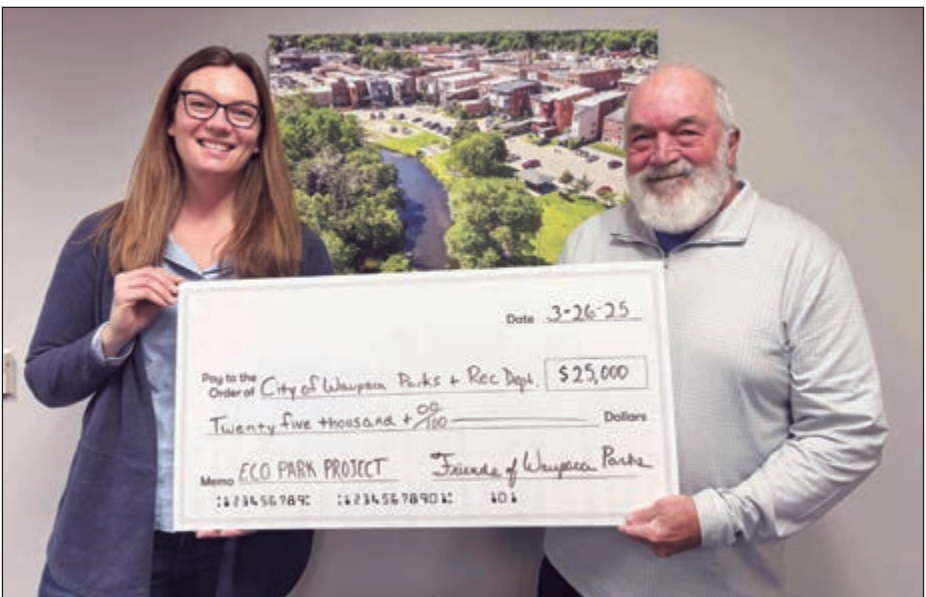

Repair work on Highways 45 and 22

CLINTONVILLE – The Clintonville Common Council approved a bid of \$49,469 for concrete repairs to U.S. Highway 45 and State Highway 22.

The \$49,469 bid from Sommers Construction Company located in Shiocton was approved by the council at its March 11 meeting. Broken down, the base bid is for \$38,970, plus \$6,900 to repair and adjust storm inlet castings and manhole castings and \$3,000 to remove and replace concrete curb and gutter.

The area where concrete will be repaired is by Klein Auto, Pumps Tire, and the Kwik Trip intersection. The project was originally planned for 2024, but was pushed back to this year. The funds will come from funds that the council had previously approved carrying over from 2024 in the city’s street maintenance account.

A total of four bids were received for the concrete repairs project. The other three bids were for \$49,800, \$56,830, and \$70,324.

Justin Mc Auly, director of public works, told the Clintonville Finance and Personnel Committee at its March 10 meeting that the common council had previously agreed to carry over funds to cover this project.

“We have a lot of areas that need concrete repair fixing,” said Mc Auly. “We also have some inlets and catch basins that need some repair.”

Kunkel Engineering was hired by the city for the engineering and construction services for the project, Mc Auly said.

Mc Auly said he was looking for an approval of the Sommers Construction bid, which Kunkel had recommended. He added that Sommers Construction is also doing the street reconstruction for 16th Street and Harriet Street in the city.

Skeleton identified, two arrested

WAUSHARA COUNTY – The Waushara County Sheriff’s Office identified the human skeletal remains found on March 13. The remains were located in the Township of Leon. This area is south of Pine River and west of Poy Sippi.

The person was identified as Tiffeny M. Schneider, 33 years old. This investigation led to a search warrant that was executed at a residence in the Township of Leon and two people were arrested: 57-yr-old Jerry L. Wendler and 48-yr-old Wade A. Mc Lees.

Jerry Wendler was charged with felon in possession of a firearm, possession of methamphetamine, possession of THC (second offense), receiving or concealing stolen property, possession of drug paraphernalia, and for an active warrant with the Wisconsin Department of Community Corrections.

Wade Mc Lees was charged with possession of methamphetamine, three counts of felony bail jumping, and possession of drug paraphernalia. Mc Lees has three open felony cases out of Adams County and two open cases in Waushara County.

Jerry Wendler was ordered to post a \$2,000 cash bond and Wade Mc Lees was ordered to post a \$1,000 cash bond. Sheriff Wally Zuehlke said this investigation remains open and active.

The future of Zenoff and Goerke Parks

New plans, historical preservation

STEVENS POINT – On March 27 the city hosted two public meetings to present plans and answer community questions regarding the future proposed renovations of Zenoff and Goerke Parks.

Dan Kremer, Director of Parks, Recreation, and Forestry, presented drafts to the community of possible renovations for the 16.5-acre Zenoff Park. Draft A would include a new 200’/215’/200’ synthetic turf softball field with lighting, 750 new seats of bleachers, 200 additional parking spots and more. Kremer said of Draft A: “To build a field of this magnitude, it would require acquisition of one acre, or a little more, of Moose Lodge. That’s ultimately their choice, and it may never happen. It comes down to if a deal can be worked out.” Kremer later stated the city has not yet been told what the Moose Lodge would like to do in regards to possible land acquisition.

Draft B examines the idea of, rather than adding a new field to Zenoff, enhancing and renovating one of the three existing fields. Draft B includes the renovation of synthetic turf of one field, 750 new bleacher seats, replacement of field lighting and more. Kremer said feedback received prior to the March 27 meetings has leaned towards support in building a fourth field in Zenoff Park.

Goerke Park currently sits at 29 acres. Several of the park’s features are original to its 1930s roots such as the Parker Building, the Rec Center, and the grass overflow parking that becomes the ice rink in winter, which Kremer explained is a feature to Goerke that been grandfathered in. Grass overflow parking is no longer permissible in the city of Stevens Point for businesses; therefore upgrades to businesses such as those proposed for Goerke would require paved parking lots.

The Goerke Park meeting began with a nearly filled room. Kremer began by showing previous drafts of possible renovations, explaining that there is not yet a final draft. “A project of this magnitude can take decades,” said Kremer. “Some of the biggest things—like an aquatic center—if you ask me today, I think something is going to happen with outdoor aquatic center. Our community has been pretty loud about doing something there. Other elements might never happen. There may be other improvements we haven’t even arrived at yet. There are going to be changes coming and those are based on the feedback we’re going to be receiving.”

The most recent draft from Feb. 2025 shows features added to Goerke such as an inflatable dome over a synthetic field, an aquatics area, new parking lots, and

Horse-and-buggy crash

MARION – A vehicle crashed into a horse-drawn buggy in the Town of Dupont on Thursday, March 27 at 7 p.m. The accident occurred on Country Trunk C near Sprenger Road.

A 49-year-old woman was at the reins and she was badly hurt. Theda Star medical helicopter flew her to ThedaCare in Neenah with life-threatening injuries. Two children were in the buggy with her: an 11-year-old and a 3-year-old, and they were taken to ThedaCare in Shawano with serious but non-life threatening injuries. The driver of the vehicle was a 34-year-old man and he walked away with minor injuries. The crash remains under investigation.

playground equipment. According to the Stevens Point Convention and Visitors Bureau the inflatable dome is the “number one facility needed inside Stevens Point from a tourism perspective.”

Community concern for historic aspects of Goerke Park have grown, with most its original 1930 structures no longer standing in the current draft. The Recreation Center, built in 1921, is on the eligibility list for historic preservation but would no longer exist in the current draft. Other historic aspects of the park include the 1933 Parker Building, community bleachers constructed in 1938, and PJ Jacob’s Middle School built in 1937, all of which are not on the eligibility list, historic preservation list, or historic registry.

Kremer shared preliminary options to preserve history in the case of demolition, such as saving exterior façade of historic Goerke structures to be incorporated into new building construction.

Trina Dorn of Stevens Point, and her neighbors have taken to knocking on community members doors in light of the city’s current draft for Goerke. Dorn said after knocking on 76 doors, only one home owner knew of the city’s current draft plans. Dorn is advocating for the preservation of over 70 years of Goerke Park history, but she also is concerned about the ability for Goerke Park and it’s neighborhood to accommodate larger events if the inflatable dome is built. The inflatable dome would attract more sports and recreation events to the area.

“No one who lives in

the area is excited for the dome, you can barely get down Minnesota Avenue and Prais Street when there are two events going on at Goerke. This area can’t handle more events,” said Dorn said.

Along with Dorn and her neighbors knocking on doors to discuss Goerke Park History, the Portage County Historical Society is hosting a virtual presentation on May 1 at 7 p.m. titled, “The History of Goerke Park” in an effort to educate the public about the historical park buildings. Dorn also posts on the Facebook Page “Save the Rinks/Warming House Stevens Point” to virtually share the information she spreads with her neighbors.

Draft plans for both Goerke and Zenoff Parks are available on the City of Stevens Point website in addition to surveys that are due April 11.

Residents speak out against rezoning

Council takes no action

NEW LONDON – Several residents spoke out against rezoning properties owned by Ingrid LLC to change the 20 existing family lots on the new section of Southland Drive to allow for single family and two-family dwellings.

The residents spoke during a public hearing regarding the rezoning at the March 18 New London Common Council meeting. When it came time for the council to act on the rezoning request, the motion did not receive a second, and the matter was referred back to the New London Plan Commission. The Plan Commission had previously recommended approval of the rezoning when it met Feb. 27.

of what was going on back there,” Graham said. “... I want this ceased. I want a full investigation.”

Graham asked what the rezoning entailed.

New London City Administrator Chad Hoerth said the rezoning, if approved, would change the city parcels in the rezoning area from R-1, which is singlefamily homes, to R-2, which would allow single-family or two-family units on the parcels.

“I hope you guys do the right thing and vote it down,” Graham said.

Patty Dyreson also spoke during the public hearing.

“I’m telling you that myself and several other people sitting back there, our families are not at all in favor of making this an R-2,” Dyreson said. “We already have all of those apartments back there. It has increased traffic.”

She said she didn’t think Oshkosh Street was built well enough to handle more traffic in and out of the area.

Dyreson agreed with Graham about not knowing about the project in the area.

“We’re not that far away from this residential area, and we know nothing about it,” Dyreson said.

She urged the council to delay voting on the R-1 to R-2 rezoning issue until further discussion can be held.

Barbara Lowe told the council that the drainage pond built in the area is now part of her backyard.

“It’s dangerous,” Lowe said. “It was designed dangerously. I was told there would be a fence around it. There is no fence.”

She also said she doesn’t trust the person who is developing the parcels because of unkept promises.

“I guess I’m a little anxious if duplexes are built, that there will be a higher population pressure in that area,” Lowe said. “Where we were told it was just going to be single-family houses. It was going to be nice yards behind them, and just a nice neighborhood. If it becomes duplexes, that will change from what we were originally told.”

Ald. Dave Dorsey addressed the council during the public comments portion of the public hearing, saying he was “apprehensive” when the process was started to rezone parcels from R-1 to R-2.

“I did not know about the promises that were made to the people that live around there,” Dorsey said.

He recommended the council reconsider allowing the rezoning, and take time to gather more input from residents.

Dorsey also said the roads in the area were not designed for 40 families living in the area.

It will take place on Friday, April 25 from 10:30 a.m. to 1 p.m. at Swan Park. A wide variety of electronics will be accepted at no charge, this includes computers, laptops, tablets, gaming systems, cell phones, satellite boxes, VCR/DVD players, audio equipment, routers, desktop printers, cords and most small electronics. Items requiring a disposal fee include TVs and monitors, large copy machines, microwaves, dehumidifiers, small refrigerators and window A/C units. Certain items cannot be accepted and those include

smoke and carbon monoxide detectors, thermostats, batteries, thermometers, light bulbs, full-size refrigerators/freezers and central air conditioning units. **How it works** Event staff will unload items directly from vehicles. To help keep the line moving efficiently, please unlock vehicles, pop the trunk and keep the vehicle running. “There’s typically a rush at the start of the event,” said Joshua Werner, the city’s IT Director. “If you’re looking to avoid the wait, closer to lunchtime is usually the best time to come.” **Other stuff, other options** The Waupaca County Processing & Transfer Facil-

For full event details, a complete list of accepted items, and associated fees, visit Mercury-containing items (like thermostats, thermometers, switches, and compact fluorescent light bulbs) are not accepted at this event, but may be dropped off at Waupaca City Hall during normal business hours, for free, through the city’s mercury take-back Program. The Waupaca Police Department will host a drug take-back event on Saturday, April 26, from 10 a.m. to 2 p.m.

Insurance a family affair for Johnsons

WAUPACA – A plan is in place to keep a local insurance company in the family. Pat Johnson joined his father, brother and brother-in-law at Johnson Insurance Agency Inc.’s downtown Waupaca office in 1984. His son, Kyle, joined the agency two years ago and plans to eventually take the business over. Pat’s father, Wayne, joined the company after moving back to Waupaca. “John Cormican was the owner of the business and he worked for John,” said Pat. “They moved into this location in 1966 when Farmers State Bank moved to its new location.” That location is at the corner of Main and Fulton streets at 102 S. Main St. “John had retired and the name was changed to Johnson Insurance in ‘74,” Pat said. “My brother-in-law, Jay Moe, joined in ‘76, my brother, Chris, joined in ‘80 and I joined in ‘84. We bought my dad out in ‘91. It’s truly a family business.” Moe and Chris Johnson retired in 2021 and 2022, respectively. “I said, ‘I need some help here,’” Pat said. “I talked to Kyle and he joined in ‘23.” “It’s always kind of been on the backburner,” said Kyle, a 2009 Waupaca High School graduate. “I know my Grandpa Wayne and Grandma Jere definitely talked about it with me growing up. They really wanted me to get involved in it. Grandma Jere, especially later in her life, was very adamant about somebody needing to take over.” Kyle left a job to join the family business. “Working at the lumber yard wasn’t cutting it, lifting drywall up and down stairs and stuff,” he said. “It was a big learning curve to join the business,” he said. Kyle is planning to eventually take over once Pat retires. “That’s the idea,” he said. “We just remodeled the whole place to kind of set the tone and get the future rolling here.” The Waupaca office has five employees and opened

a second office at 144 S. Main St. in Clintonville in 2007. “We had some business over there,” Pat said. “It’s a good community, very similar to Waupaca.” The Johnsons divide their time between the two offices. Pat said the agency has an advantage over other insurance businesses. “It’s service,” he said. “When they call, we respond and take care of them when they need it. I like helping people, especially if a claim occurs. I’ve been to house fires sometimes before the fire department gets there and said, ‘Hey, we’ve got you covered.’ “We’re keeping up-to-date with all the changes because there are constant rule changes and coverage changes,” Kyle said. “It keeps you ahead of the game.” Instead of dealing with one company, the Johnsons are independent agents, which means they can compare rates with other companies. “We have more options and companies to choose from,” Pat said. “If one doesn’t work, I can go to the next one. With rate changes, I think we have an advantage to give people the best rate possible.” Johnson Insurance offers life, personal home and auto, farm and business policies and used to offer

health insurance. “That got too specialized,” Pat said. “We actually have a broker in Appleton that I refer people to and that’s all they do is health insurance. Kewaunee judge oversees sand mine case

IOLA – A new decision made by a Kewaunee County judge will send the Iola sand mine case into fall before any final decisions are made. The proposed Iola sand mine on the Iola Car Show grounds has been a contentious issue for the area, namely the neighbors close to the mine who filed a lawsuit against the mine in an attempt to stop the project. The neighbors to the proposed sand mine filed an appeal to the Board of Adjustments in Waupaca County last fall, after they upheld the decision made by the Plan-

ning and Zoning Board to allow for the Conditional Use Permit (CUP) for the sand mine. The last judge in Waupaca County, Judge Vicki Clussman, made the decision to recuse herself from the case Feb. 19, this is after Judges Troy Nielson and Raymond Huber recused themselves last fall. The CUP for the proposed sand mine on the car show grounds has been an ongoing issue since May 2023 when the Township of Scandinavia recommended a denial for the CUP to the Planning and Zoning Committee. Last fall the Board of Ad-

justments heard over ten hours of testimony and public commentary, and after deliberations decided to uphold the decision to allow for the CUP. Attorney for the plaintiffs, Christa Westerberg, then filed the appeal to the Board of Adjustments in reference to the decision they made Oct. 25 to allow the CUP. Judge Jeffrey Wisnicky of Kewaunee County has taken the case and in his first ruling March 24 decided to allow Faulks Brothers to intervene in the appeal, which will allow them to provide testimony in the case. The next deadline, accord-

ing to court documents, is April 24 when all of the testimony and files from every Township of Scandinavia, Planning and Zoning Committee and the Board of Adjustments must be compiled and handed off to the Kewaunee judge. The court records also state that the plaintiffs’ brief is due by July 1, then the Faulks Brothers and the Board of Adjustments response is due by Sept. 2, then the plaintiffs reply to their response is due Oct. 1. The proposed plot of land for the sand mine will remain untouched until the case is settled.

Village reviews noise complaints

IOLA – The music ordinance in the Village of Iola was created and approved in May 2023 to outline policy for outdoor and music entertainment within the village limits. Recent complaints may be sending the ordinance back to village officials. In a March 25 working committee meeting at village hall, Jennifer Schustek, the Village of Iola board president, said that with new complaints coming in about outdoor entertainment, the board will need to address the issue. Schustek said the complaints were not about the music, with people saying they enjoy the entertainment, the complaints revolve around the frequency of the entertainment and the length of time the music is allowed for. Not wanting to negate or ignore the complaints made by village residents, Schustek said this is the main rea-

son she brought up the ordinance at the meeting. The music and entertainment ordinance states that if there is a complaint filed to village hall that the business that it is filed against will be notified and has the option to respond to it. During the meeting Schustek and Laura Krogwold, board treasurer, stated that eight complaints came in over the past couple weeks. The complaints were anonymous for fear of bullying or retaliation. There are two complaints that came in through email. Krogwold said she has to take into consideration why the person may want to remain anonymous and if the reasoning is sound the complaint can be accepted. The current ordinance already restricts time frames, both dates and times, stating that musical entertainment can be played on the weekends only, with Friday and Saturdays from 3 p.m. to 11 p.m. and Sundays 12 p.m. to 6:30 p.m. The ordinance also restricts dates that entertainment is

Superintendent to teach summer school

ATV safety, hunter education classes

CLINTONVILLE – Clintonville Superintendent Troy Kuhn will spend around 20 hours teaching hunter safety and ATV safety courses during summer school for the school district.

The Clintonville Board of Education gave Kuhn its blessing to teach the safety courses as a volunteer when it met March 10.

During the discussion, Kuhn told the board that he had been approached by several members of the community who wanted to be trained to teach hunter safety. He said in order for someone to be certified to teach a hunter safety course, they have to co-teach it with a certified instructor for a

couple sessions.

In the past, Kuhn said Danielle Angotti, the district’s former agriscience teacher, taught hunter safety, ATV safety, and snowmobile safety as part of her curriculum. He added that Danielle Ellerbrock, the district’s current agriscience teacher, had more academic ideas that she wanted to do within her curriculum.

“Knowing that, I’m one of the few people that can actually do this (teach safety courses) in the area,” said Kuhn.

Kuhn said if the board would allow him, he would volunteer to teach hunter safety during the first period the first two weeks of summer school, ATV safety the third week, and something else the fourth week.

“I would be willing to do that, so not only would it benefit the kids in this area, it would also help train the trainers that would like to teach it in the future,” Kuhn said. “The reason why I

think this is important, that it’s a school board agenda item, is my summer is not time off. Summer is me preparing for the upcoming school year.”

Kuhn said he would be dedicating 20 hours of his summer to do the safety teaching on a volunteer basis.

“I think I can do it. It’s nothing new to me,” Kuhn said. “But I just didn’t feel like I should take this on

without asking the board for permission.”

Board Secretary Laurie Vollrath said she thought it was a “great idea.”

Board member Glen Drew Lundt asked Kuhn if he would also be mentoring others while he was teaching.

Kuhn said he would be, so those people could then teach the safety courses in the future.

Utility to flip trenchers

Sell current one to fund new model

CLINTONVILLE – The Clintonville Utility has plans to sell its current 2014 Vermeer Trencher, which is used to bury underground power lines, and replace it with a smaller unit that will cause less damage to the backyards of residents.

The Clintonville Common Council approved the plan at its March 11 meeting. The approval included a stipulation that the smaller trenching machine to replace the current trencher would not be purchased unless the current trencher sells for at least \$45,000 on the Wisconsin Surplus website. A reserve would be placed on the sale of the current trencher, and it will not be sold unless the winning bid is for at least \$45,000.

Finance committee

The sale of the 2014 Vermeer Trencher was discussed at the March 10 Clintonville Finance & Personnel Committee meeting. At the meeting, Clintonville Utilities Manager Dave Tichinel told the committee that he would like to surplus the 2014 Vermeer Trencher, and then purchase a smaller trenching unit. He said the 2014 trencher is a huge machine.

“It’s actually pretty cumbersome to get in the backyards and stuff to do underground powerlines,” Tichinel said.

Tichinel said he would like to replace the 2014 trencher with a smaller machine, depending on how much money the 2014 trencher would sell for.

“We’d have to get \$45,000 for the unit we got, which, it’s worth that,” Tichinel said.

If the current trencher

would sell for at least \$45,000, Tichinel said the city could purchase a smaller trenching machine. A smaller trenching machine would allow for trenching work to be done in yards without tearing the yards up as much as the current trencher does.

“And there’s other uses for it too,” Tichinel said.

He said if the city would surplus the 2014 trencher, a reserve would be placed on the trencher. If the reserve isn’t met, the trencher would not be sold. He added that a new trencher is not in his department’s capital budget, so the only way a new trencher would be purchased, would be if the proceeds from selling the current trencher would be used.

Ald. Greg Rose asked for verification that the new trencher Tichinel wants to purchase would be a smaller trencher than the current trencher.

Tichinel confirmed that, reiterating that the proposed new trencher wouldn’t damage the backyards of residents as much as the current trencher does.

“We’re putting in a lot more underground electric, and this unit, it would obviously have more jobs than what this (current) unit provides,” Tichinel said. “What we have right now is just a flat-out trencher, and it’s a big unit. And we could serve other purposes by having a smaller one. Plus, we wouldn’t be tearing yards up. We’ve made customers angry over it.”

Rose asked if there were any projects the smaller trencher would not be able to handle.

“What we (currently) have is pretty much way over-sided for what we need,” Tichinel said.

Tichinel added that because the current trencher tears up backyards, the utility spends time and money restoring those yards, which includes reseeded them.

Roadwork ahead

Makeover for State Highway 110

WAUPACA COUNTY – The Wisconsin Department of Transportation (DOT) will be improving 4.04 miles of State Highway 110 from north of the County Trunk AA and X intersection to the south of the State Highway 110 and State Highway 22/54 intersection in the Town of Royalton. According to a DOT re-

port, the plans will be finalized in May. Construction is slated to start in 2026 but it could start in 2025 if funds are available. The work: mill and resurface with hot asphalt, patch and excavate certain locations, pave full shoulders along the low side of curves at the intersections of White Lake Road, South Shore Drive and Paap Road, replace the raised island at the 110 and 22/54 intersection, replace the guardrail along near the White Lake Road intersection, replace seven

culverts, remark all of the pavement and update railroad signs north of County Trunk AA. State Highway 110 will remain open using single lanes with flaggers except for when replacing culverts. In that case, the road will be closed to through traffic and there will be detour signs. The detour is expected to last for two to three weeks. There will be access to all properties except for short periods when the paving crew is working in front of the property.

FROM PAGE 4 allowed outside, starting Friday of Memorial Day weekend and ending Labor Day weekend. The decibel level is also taken into consideration in the ordinance with the max decibel level set at 90 [about the same as a lawnmower] and is to be measured with a sound meter. Jim Rasmussen, a village trustee, said that the first summer the music ordinance was approved that he went out to take readings all over the village, specifically close to the venues playing music themselves. The ordinance states: “Noise measurement shall be at the nearest lot line of the premises from which the musical entertainment originates. The noise me-

ter shall be placed at least three feet above the ground and at least three feet from walls, barriers, and obstructions and all other sound reflective surfaces.” Rasmussen said he would go to the properties that filed complaints and take decibel readings with a device he said was similar to what the police department has, in an effort to ensure that the new ordinance is a fit for everyone. “I went to the address involved and I never got anything above 60 decibels, which is lower than what I’m talking right now,” said Rasmussen. “That’s at the lot line of the property. So I guess my issue is, where are the facts and who’s telling the truth? That’s all I’m saying.” Dave Harper, a village trustee, also brought up

the fact that it is too late in the season to take this ordinance up. “We have to wait until fall because you have to book bands in advance,” said Harper. “And we are way too close to Memorial Day, the beginning of the season to make any significant alterations. I would say absolutely send it to the ordinance committee and then we can discuss it in September.” Sheri Miller, owner of the Thirsty Perch, was present at the meeting and said that she is almost completely booked up for the summer. Miller said she starts booking bands well in advance of the season, being that good bands need to be booked well ahead of time, saying she already has bands booked for the 2026 season.
