### White deer captivating audiences Two spotted, one missing

NEW LONDON - Two all-white whitetail deer have been the talk of the town lately. They're often spotted in the field south of Beckert Road in the Township of Mukwa. On any given evening a half dozen or more cars and trucks pull off the side of the road to view the herd of deer in the field, sometimes crowned by not one, but two all-white whitetail deer.

Beckert Road is the town line between the City of New London and Mukwa. Tyson Foods owns the fields and John Mares farms the fields.

"We watch them right out the window from the living room chair, you can see them come out in that field," said Gary Burmiester. "They stand out like a spark plug. People driveby, stop and take pictures all the time."

Burmiester says both deer aren't always together. Most of the time there is just the one, but occasionally you'll see them both out at once.

On Sunday night, Anthony Brandt and Josh Muskevitsch of Hortonville were headed home from a walleye outing on the Wolf River and saw both bucks

"You could see them all-white deer are protected plain as day," said Muskevunder NR 10.02 and may not be harvested.

According to the UW-Stevens Point Museum of Natural History, albino deer are rare. They have pink eyes, noses, ears and hooves. Their birth rate could range from 1 in 20,000 to 1 in 100,000.

White deer with brown spots, known as piebald deer, are still rare but a bit more common. The current law does not protect a piebald deer.

Recently the UW-Stevens Point Museum of Natural History attained a rare true albino buck that was hit by a car and

# Switching sports conferences

### Not so easy for Clintonville **BY BERT LEHMAN**

CLINTONVILLE - The Clintonville Board of Education heard the pros and cons of the possibility of the Clintonville School District switching to a different conference for sports, as well as the challenges it would have to overcome to make such a move.

The topic was discussed in detail at the board's March 31 board meeting.

"There's been some frustration from parents that have gotten in contact with me about their daughters or their sons coming home and they're just sick of just getting beat night and night and night again, and they don't want to play athletics," said Troy Kuhn, Clintonville superintendent.

Kuhn said he asked Shaun Liesch, the activities director for the Clintonville School District, what he thought about the district switching conferences for sports.

'We talked about it, because it's not just always about winning and losing," Kuhn said.

If the district would explore moving to a different conference, Kuhn said the "ideal option" would be to joining the CWC (Central Wisconsin Conference). This would mean the district would compete against Weyauwega-Fremont, Shiocton, Manawa, Amherst, Bonduel, and Wittenberg-Birnamwood.

One of the positives of such a move, would be less travel, Kuhn said.

Another positive would be Clintonville would be competing against students of the same demographics, such a poverty level and needs of the district.

Kuhn said a negative of such a move would be the fact that the CWC does not offer all the sports that Clintonville's current conference offers. For example, CWC does not offer girls soccer.

"There would be a couple of other things that we'd really have to put our thinking caps on and say, 'How would this work?," Kuhn said.

Kuhn said the coaches in the district were asked their opinion on switching conferences, and some coaches were adamant about not switching. They said they like the tough competition, and the athletes realize they are playing against "high-level" opponents.

"Even thought they lose, it makes their program better," Kuhn said.

Other coaches said they struggle to get students to play sports because the students know that the team doesn't have a chance to win a conference championship, Kuhn said.

If the district would want to pursue switching conferences,

# Paper mill changes ownership

STEVENS POINT-The Stevens Point paper mill will soon begin the process of changing ownership. Pixelle Specialty Solutions has operated the Stevens Point paper mill since 2020. Ahlstrom announced on April 3 that an agreement has been executed to acquire the Stevens Point facility. This transaction will be financed through a \$600 million

senior-secured financing package, with excess funds available for general corporate purposes.

Ahlstrom is based in Finland, but operates in more than 20 countries.

The Stevens Point paper mill has turned over ownership several times in the last two decades, prior to Pixelle's ownership beginning in 2020, the mill was owned by Verso Paper

since 2012, then previously NewPage began ownership in 2007, and a handful of owners before that in the mill's 107 year long history.

organizational The change is expected to take effect on May 1, 2025. Pixelle Specialty Solutions said they are committed to working with Ahlstrom to support a smooth transition for employees and customers.

Kuhn said the district would need to communicate with the schools in its current conference. He added that now would be the perfect time to switch conferences, if that is the direction the district wants to go, because Fox Valley Lutheran just dropped out of the current conference, so now there is an odd number of schools in the conference.

Kuhn acknowledged that the CWC has expressed hesitation about Clintonville joining the conference because many years ago Clintonville was going to join the CWC, but backed out at the last minute.

CWC wants eight teams in the CWC-East, and there are currently eight teams there, so one team would need to be displaced. "From what I gather, no-

body wants to move," Liesch said.

He added that any request from the district to switch to the CWC would have to go through the WIAA, and be approved by a conference realignment taskforce.

Just because we would request for realignment doesn't necessarily mean it would be given to us, even if we have support from one side or the other side," Liesch said.

Liesch said based on feedback he has received, Clintonville does not have the support needed to switch to





Ava's Golden Paw Pet Supplies at 103 Western Ave. North, is giving consumers another choice when it comes to buying their pet food and supplies in Waupaca.

Tiffany Mucha, the manager of Ava's Golden Paw, said she was working in pet retail when she was approached to help manage the new store in Waupaca.

JoAnne Thornell, the owner of Ava's Golden Paws, is no stranger to business ownership with also owning Marley's Smoke and Vape Shop with locations in Appleton, Oshkosh and Green Bay.

Thornell named the shops after her two children, with Marley being her oldest daughter and Ava being the youngest.

Mucha said Thornell had bought the shop and was thinking of ideas of how to use the space, eventually deciding to create a pet food shop that focused on holistic, limitedingredient types of foods for pets.

They offer Wisconsin brands including Stella and Chewy, American Natural Premium, Tucker's, Vital Essentials and Herb Smith.

We just definitely believe in the limited ingredient is a better food," Mucha said. "You're not going to have all

here," Mucha said. "I've only ever known one person to ever have a lizard, and then I come here and everyone's like 'do you have crickets?"

Some of the other small animals they carry products for are gerbils, hamsters, chinchillas, guinea pigs and birds. Their main focus is for cats and dogs.

Mucha said they offer a frequent buyer program on most of the products they carry, so after a certain amount of food is purchased you would receive one free.

Mucha said they will also try to price match as close as they can to Amazon and Chewy.

"We offer a little bit of everything hopefully for everyone," Mucha said.

Pets are allowed inside the store and are encouraged as the store was previously a boutique and while renovating the space they decided to put a pet photo booth area where the dressing rooms previously used to be.



# Five new school positions suggested

### Help for students slipping behind BY BERT LEHMAN STAFF REPORTER

CLINTONVILLE – The administrative team for the Clintonville School District has proposed to the Clintonville Board of Education that the district add five fulltime employees to the district.

The proposal was made at the board's March 31 meeting, and recommended the following positions be added to the district: program support teacher to be paid for with funds from Fund 17; one reading interventionist for grades 4K-5th grade and one math interventionist for grades 6-12, with both positions paid with funds from Fund 10; and two fulltime counselors for grades 4K-12, with both paid with funds from a Department of Public Instruction grant.

No action was taken by the board on the proposal recommendation, except for approving the addition of a program support teacher, which was a separate item on the agenda.

During the discussion, Clintonville Superintendent Troy Kuhn told the board that the district's administrative team had been engaged in a needs assessment for the district, particularly what students need and if the district has the staff to support those needs. He said the assessment showed that the district needed to add 10 positions to meet it's needs.

"I looked at the admin team and said, 'I'm not bringing 10 new positions to the board, that's not happening," Kuhn said.

After continuing to review the needs of the district, Kuhn said the administrative team wanted to inform the board about some of its findings, as well as solutions to meet the needs of the district.

### Assessment findings

Madalyn Simonis, Clintonville Elementary School principal, said when she started as principal last year, the district had five fulltime literacy interventionists, but it currently has only three fulltime literacy interventionists.

"I went from having three at the elementary, down to just one," Simonis said.

She added that the new curriculum is working.

"We see the data and we see improvements, but we still need to support our teachers," Simonis said.

She said she would like to see the district add a reading interventionist.

Kuhn told the board that according to the data, there is a high number of kindergarten students who are proficient or above, but as they progress to 8th grade, there are less students who are proficient, basically not keeping up.

Clintonville Middle School Principal Britney Dobratz said the middle school does not have a math interventionist, but it had one in prior years. She said she would like to the district to add a math support position to work with grades 6 through 12. The person would be working with students in the classroom.

Scores show the middle school has a good report card, but Dobratz acknowledged that how the scores are calculated have changed.

"I don't want to just say, 'Hey, we have really good data, we're doing great, lets just keep doing that," Dobratz said. "I think we need a 6-12 person to support all the kids, too."

Clintonville High School Principal James Blashe added that the number of high school students in the district who are at a basic level or below for math is high when compared to other districts. He said the district doesn't have any type of math intervention for high school students.

He added that some changes will be made for the next school year to get some help for students who need extra help.

### Mental health

The administrative team also addressed student mental health and absenteeism.

Blashe said the district is averaging around 200 students being absent from school each day.

He said one recommendation would be for the district to have one school counselor for every 250 students in the district. He said the high school has 400 students and only one counselor.

Simonis said that when the district seeks counseling help from local medical organizations, it is virtual appointments only.

"We are grossly understaffed in our school counseling department," Simonis said. "Two additional counselors would do our students a lot of good."

She added, "It hurts us to put this data on here for you guys and our community

# members, but it's the reality of where we are right now."

Kuhn addressed the question of what happened to the positions that are being requested.

"The best and worst thing that happened to school districts was COVID," Kuhn said.

Not sure of the exact amount, but Kuhn said he thought the Clintonville School District received an additional \$7 million over a three-year period because of COVID.

"That money was dedicated not just for health and safety of students and staff, but also dedicated to catching kids up from the loss of learning because of COVID," Kuhn said.

During that time, Kuhn said the district adopted a co-teaching philosophy. This had the district hiring special education teachers and paraprofessionals for every grade so co-teaching could take place. The district also had instructional coaches, as well as multiple interventionists at every level.

"When COVID money went away, it was, I'll say, our job, to figure out who stays and who goes because we don't have that extra money sitting there anymore," Kuhn said. "We proved that it can work if we have the people. But without passing local referendums time and time and time again, we can't afford the personnel to do that."

He said the positions that are being requested existed in the past because of the COV-ID funds the district received.

"Now that they're (positions) not here, we're seeing that the need that they should exist again," Kuhn said.

## One incumbent, one challenger elected to school board

CLINTONVILLE – With four candidates vying for two seats on the Clin-

tonville Board of Education on the April 1 spring election ballot, incumbent Mark Zachow and challenger Christopher Hoffmann were both elected to the board.

Hoffmann received the most votes with 1,592, while Zachow received the

second most with 1,566.

Incumbent Laurie Vollrath received 1,316 votes, while Battenberg received 1,068.

# Schley wins, two write-ins elected

Kuhn added that "the majority of the district's special development is now happening within the walls of the Clintonville School District because we have highly qualified people at Clintonville."

Barkow asked if the position would be fulltime.

Kuhn said it would be fulltime.

"We're asking that we have this position because that's what Clintonville needs at this time," Kuhn said.

### in bonds approved Sale of \$2.1 million

Funds for Oshkosh Street project **BY BERT LEHMAN** STAFF REPORTER

NEW LONDON - The issuance and sale of up to \$2.1 million in sewerage, water, and electric system mortgage revenue bonds to help cover the cost of the Oshkosh Street project in New London was approved by the New London Common Council at its March 18 meeting.

As part of the approval, the council accepted the parameters of the debt sale. As long as the parameters are met. city officials can approve the sale. The sale is scheduled to take place on April 17, with the closing expected by May 7. **Finance Committee** 

The issuance and sale of the

bonds was discussed at the March 5 Finance & Personnel Committee meeting

At the meeting, Harry Allen, municipal advisor with Ehlers, told the committee that the financing is being considered primarily for Oshkosh Street, adding that there are a lot of revenue sources to fund the street reconstruction project.

"This financing specifically is funding the sewer, water, and the utilities relocation aspect of the Oshkosh Street project," Allen said.

Another portion of the project will be reimbursed to the city from a state grant, Allen said. That grant is around \$2 million.

The non-utility cost to the city for the project will be around \$2.3 million, Allen said, adding that there may be a need in the future for the city to take out additional debt to fund the project.

"The current plan is that the city will use reserves to front the \$2.3 million and recover the grant portion when it's available, and then potentially looking at adding some of this project to tax increment district (TID) number 4. There costs for Oshkosh were Street included in that project plan.

In total, Allen said the city is looking at borrowing around \$2.5 million, which includes project costs. Of that total, \$1.5 million would be assigned to the sewer utility, and \$1 million would be assigned to the electric and water utility.

With the financing, Allen said the city would be financing around \$2.5 million of utility projects, but only issuing \$2.1 million in additional debt.

The financing would be structured to be paid off over a 20-year term. The first payment would be due in December of this year, with the final payment in 2044. Allen said the city can expect an interest rate of around 4.25%. The maximum that could be charged

is 5.5%. "We don't expect to be at that 5.5% territory, if we do see rates creep up that much between now and the sale day, that's on us to provide advice to city staff to really consider moving that sale to where maybe the market is a little more-calm and you could get a better price," Allen said.

The debt can be prepaid as of Dec. 1, 2034.

As part of taking out new debt, Allen said the city did go through a rating surveillance process with Moody's. "We got really good news

for the city, the revenue backed debt of the city was upgraded from A3 to A2," Allen said.

### School board

There were three candidates running for two seats on the school board, with one of those candidates incumbent Holly Schweitzer. Schweitzer received the most votes, 1,397, and was elected for another term on the school board. Andy Thorpe, who received 1,317 votes, was also elected to the board, as he received the

second most votes. Finishing third in the election was Patricia Toney, who received 804 votes.

### City council

In the only contested race for a seat on the New London Common Council, incumbent Tim Roberts was reelected in District 4. Roberts received 295 votes. He was challenged by Jeffrey Gulbrandsen, who received 130 votes.

Ald. Robert Besaw (District 1), Ald. BaLynda Croy (District 2), Ald. Bernie Ritchie Jr. (District 3), and Ald. Charlene Magolski (District 5) were each unchallenged in the election and elected to another term on the council in their respective districts.

# **City's wellness** program expanded

NEW LONDON - The wellness program policy for the city of New London has been expanded to include more than just fulltime and part-time city employees.

The expansion of the wellness program was approved by the New London Common Council at its March 18 meeting.

Finance Committee

At the March 5 New London Finance & Personnel Committee meeting, New London City Administrator Chad Hoerthtold the committee that the city's wellness program was created in 2011 to encourage employees to be healthy.

"To reduce insurance claims, it produces less stress, higher morale, increased production, and things like that," Hoerth said. "A lot of corporations and companies and businesses provide corporate wellness programs for their employees because they know that there's a return on investment." The city's health insurance premiums haven't increased a lot recently, in part because the city's employees do not submit a lot of claims, Hoerth said. "I do think that having a healthier employee is a definite benefit to our (city's) bottom line with our insurance rates," Hoerth said. Currently, the wellness program allows city employees access to the city

pool, fitness center, and exercise programs at no cost. The program is available to fulltime city employees and their families. It is also available to part-time employees, but not their families.

Library director Mellissa Krause went through the timeline that led up to this milestone. She remarked on the realities of running a library: rising technology costs,
