

## **Celebrating Godzilla's birthday and great attendance**

> Washington Elementary School students were treated to some special visitors last Friday as part of an innovative approach to improving school attendance.

> The school held a "Godzilla's Birthday" celebration on April 11, 2025, marking another creative milestone in a year-long attendance initiative spearheaded by school social worker Kelli Masters Morgan.

"It was more than just a fun day. It was part of a larger, year-long effort I've been leading to help our third graders understand the importance of consistent school attendance," Morgan said. "Ever since COVID, truancy rates across the state have skyrocketed. Students are missing more school than ever before, which has a direct impact on their ability to learn and make academic progress."

Morgan has employed several creative approaches throughout the school year to engage students around attendance.


"To help reverse this trend, I've been using creative, playful approaches to make the message stick with our younger learners," she said. "In addition to Godzilla, I've dressed up as the 'Attendance Fairy' complete with tutu and wings, crowned 'Attendance Royalty,' and even introduced surprise visits from the 'Polar Pals' who magically moved around the building reminding students of the benefits of excellent attendance."

The "Polar Pals" initiative also selected students with strong attendance habits to become "Attendance Elves," adding peer recognition to the program, she said. Morgan believes these playful approaches are making a difference with the elementary students.

The Friday celebration came after students tracked classroom attendance throughout the month, working toward earning the special birthday party for

alignments, tires, basic maintenance, breaks, and regular maintenance," Smith said.

Being a Napa Auto Care Center offers advantages, enabling Smith to offer a more competitive price on parts and on services like oil changes. The shop features two work bays, with a primary bay for most work and a larger bay with an 18,000-pound lift for trucks and alignment work. Smith has plans to expand in the future, and the building has plenty of room for growth.

There is a lot of additional space available in the back where he hopes to grow the business, an area currently used for storage.

Smith's next business goal is to hire a service writer to handle scheduling and phone calls, allowing him to focus on repairs. "Answering phones, scheduling things so I can just keep working," he said. The shop is currently open Monday through

Friday from 9 a.m. to 5 p.m. and otherwise by appointment.

Smith is working to increase his business visibility with upcoming plans for a website through Napa Auto Care that will eventually allow customers to order tires online through him, as well as more signage. "I'll have a big 12-foot-wide Napa Auto Care sign that's going to be going above the garage doors," he said. He plans to have the sign installed by the end of May.

Smith said his family has deep roots in the Merrill business community. Matt's grandfather, Stuart Smith, previously owned ITC Trucking, and his uncle, Doug Smith, owns KFC Taco Bell in Merrill.

"The kids had so much fun—and I believe the proattendance message really landed," Morgan said.







### New child care platform from Lincoln County native set to launch this summer

On April 9, 2025, Lincoln County native and former candidate for Wisconsin's 7th Congressional District announced the upcoming launch of a new child care platform in the Badger State.

Elsa Duranceau is the founder of the Child Care Coalition of Wisconsin (3CWI), which, according to a release from the organization, is a nonprofit established in 2023 to "address the child care industry crisis, with a mission to reinforce the Wisconsin workforce by supporting child care professionals to meet the demands of Wisconsin families through innovative programs and partnerships."

The release said the new platform from 3CWI is "designed to create a sustainable new revenue stream for child care providers across the state."

"Set to pilot in Lincoln, Langlade, and St. Croix counties in August 2025,



this innovative system will function as a reservation platform for future available infant care slots, allowing families and employers to plan ahead and providers to stabilize income through forward booking," the release said.

"Wisconsin child care providers are facing the potential end of the Child Care Counts program with no safety net," Duranceau said. "Our goal is to provide some support to providers and more financial predictability while offering employers a practical solution to a major workforce issue. This is just the beginning of what we believe will be a game-changer for the child care industry in Wisconsin."

The release said the platform will initially be available to area employers as members, with plans to open access to families as the system expands.

"Following the pilot, 3CWI plans to grow the platform throughout the St. Croix

Valley and into Marathon and Oneida counties by Jan. 2026, with full statewide rollout projected by the end of 2026," the release said.

3CWI said the initiative "would not be possible without the generous support of local partners."

"3CWI extends heartfelt thanks to the Lincoln County government, the Lincoln County Economic Development Corporation, the Our Way Foundation, and St. Croix Economic Development Corporation," the organization said. "Their leadership and commitment to child care innovation have been instrumental in bringing this project to life."

### REAL ID required for air travel in May 2025 Wisconsin DMV encourages travelers to update their driver license/ID ahead of May deadline

Airline travelers will face new identification requirements to board their flights for air travel starting May 7, 2025, when enforcement of the REAL ID Act begins.

*Regular* Wisconsin driver licenses or IDs will no longer be accepted as valid identification for domestic air travel or to enter a federal building or military base. Travelers will need to present a REAL ID-compliant driver license or state ID card or another acceptable form of identification (such as a passport).

Wisconsin's driver licenses and ID cards have been REAL ID compliant since Jan. 14, 2013. With renewals required every eight years, all Wisconsin residents have had the *option to convert to a REAL ID*. Anyone who hasn't taken advantage of that option thus far should do so now in advance of the May 7 implementation, the Wisconsin Department of Transportation (WisDOT) Division of Motor Vehicles (DMV) encourages.

"Under state law, Wisconsin DMV provides both options," WisDOT DMV Administrator Tommy Winkler said. "Those who want the REAL ID designation should start now. Visit wisconsindmv.gov/REALID to learn about what documents are required to present at a DMV, start the application online, and make an appointment for service to make your trip as quick and convenient as possible."

To date, 62% of Wisconsin's driver license or ID cards currently display the REAL ID star indicating they are federally compliant. In 2005, the federal REAL ID Act was passed by Congress to standardize state-issued driver licenses and ID cards to enhance security and prevent identity fraud.

#### Costs and requirements to get a REAL ID

Those who already have a driver license or ID may obtain a REAL ID-compliant card for \$14 (the cost of a replacement driver license) or \$16 for an ID card. There is no additional fee if the upgrade takes place at the same time as the renewal.

To obtain a REAL ID-compliant driver license or ID card, individuals must visit a Wisconsin DMV and bring the following original documents or a certified copy (not a

- Proof of Legal Presence in the U.S.
- Proof of Identity

- Proof of Social Security number
- Proof of Address





Two of the spring hunter safety classes are now complete, with another offered in September. Interested participants should register on the Wisconsin DNR website.

Club members love being part of the community in Lincoln County, and three of the Club's Directors are trained as instructors and volunteer time to teach archery at Trinity School for two weeks each year. Just last month, four students from Trinity demonstrated the skills they had learned at the Club's monthly meeting. This year, LCSC also participated in the Children's Festival held at the MARC on April 5, with furs and pelts to touch and a giant teddy bear to win!

On Opening Day for the ranges-April 26-the LCSC will continue with this commitment to developing family-friendly activities, with the inclusion of events like the Teddy Bear Hunt for 3-12 year olds, which kicks off at 9 a.m. Equipped with wooden "rifles" and accompanied by a mentor, children will scour the 240-acre LCSC property looking for their very own trophy—a teddy bear. Once found, it will be registered with a warden and the hunt will be complete. The Teddy Bear hunting season will end at 11:00 a.m. to make way for more events for all family members.

From 11 a.m.-3 p.m., an equipment swap will take place inside the

Clubhouse. While no guns will be sold, there will be something for everyone! The LCSC will have at least nine vendors selling new or gentlyused equipment, including hunting clothes, decoys, and stands, as well as archery and fishing equipment. Also at 11:30 a.m., the shooting range will open for the year. There will be several demonstrations of RimFire events, including the opportunity for anyone to try it for themselves. Firearms and ammo will be provided by the Club. If you haven't yet seen the new pistol range with a multistation shooting house or the new RSO (Range Safety Officer) building, this is a great day to check it out. # The bidding war behind the **NFL Draft**

GREEN BAY - On May 19, 1935, the NFL club owners approved a plan for a college player selection process, now known as the NFL Draft.

"The players were free to sign with any team before this," said Packers Hall of Fame Curator Brent Hensel, "and then, Bert Bell, who at the time was the Eagles owner but would become the future NFL commissioner, called for teams to select players in inverse order of how they finished from the previous season.

"The NFL owners would adopt this college draft with altruistic intentions in mind. Basically, the decision was driven by the high-price bidding war that would take place over one player, a player from Minnesota named Stan Kostka."

Stanislaus "Stan" Kostka was the son of Polish immigrants, born in St. Paul in July 1912.

"The six-foot-tall, 220-pound, blonde, fullback initially played at Oregon transferred home but to Minnesota for his sophomore year," recalled the Minnesota Golden Gophers The Daily Gopher in April 2017.

"Kostka had a monster college career. In his first game as a Gopher, Stan scored four touchdowns in the first half. Over his three seasons in ... he averaged 6.8 yards per carry. After going undefeated in 1934, Kostka's junior year, the

Big Ten announced that Stan had used all of his eligibility. The eligibility committee had decided to retroactively count his year on the freshman football team at Oregon. Despite Bernie Bierman's protests in the offseason, Stan had no choice but to turn pro.

"As soon as the end of Stan's college career was announced, each NFL franchise contacted the Minnesota Golden Gophers star. All nine teams in the NFL attempted to sign Stan. Rumors spread that various teams were close to signing Kostka, but the two teams with the most resources to throw at him were the Brooklyn Dodgers (the football team) and the Philadelphia Eagles. Kostka had an interesting negotiating tactic, 'A team would send me a wire and say they'd give me \$3,500,' he recalls. 'I'd send a wire back and say Green Bay or the Chicago Bears said they'd give me \$4,000. I kept that up."

"The Philadelphia Eagles were so angry about missing out on Kostka that they convinced the NFL of the need for the Draft. Instead of letting players go to the highest bidder, the draft would level the playing field by granting the worst team from the previous year the first pick."

Koskta only played one season of professional football.

He later coached several seasons with North Dakota State and served as a Navy lieutenant during World War II.

### Girls Bowling Team claims second consecutive State Championship

The Merrill-Tomahawk Girls Bowling Team captured their second straight State Championship at the Division 2 Girls Bowling Tournament held March 8-9, 2025.

"The girls bowled 15 baker-style games, rolling a total of 2,820 pins during the tournament," said Head Coach Melissa Wilke. "That is an average of 188 a game."

In baker-style bowling, five or six team members collaborate on a single game. For the Merrill-Tomahawk squad, four girls bowled two frames each and two girls bowled one frame each per game, Wilke explained.

The Championship team is a

cooperative effort between schools, featuring five Merrill-area students (Peyton Smith, Marley Krueger, Avery Frisch, Bella Kottke, and Izzy Scheffler) and one Tomahawk-area student (Jayden Dellinger). They faced off against 11 other teams to claim the title.

After completing their qualifying rounds, the Merrill-Tomahawk team was in the lead. "When all was said and done, Saturday evening the girls were seated in first place by 60 pins over the second place seat," Wilke said.

While the Merrill-Tomahawk team awaited Sunday's Championship match, teams placed second through fifth competed in roll-offs to determine who would face the top-seeded squad. Watertown's Girls Team emerged as the finalist.


In Sunday's Championship round, "the girls bowled two games against Watertown's Girls Team. For finals; it is two games in baker style and total pin fall wins," Wilke explained. The Merrill-Tomahawk team posted scores of 184 and 171 for a combined 355, enough to secure their second straight Division 2 State Championship.

"I am beyond proud of these girls," Wilke said. "They have grown in skill and camaraderie. It has been my honor to coach these girls through another Championship."

Wilke acknowledged the crucial role of parental support in the team's


