# **OVRS** chief says suicides, overdoses up

North Country This Week

OGDENSBURG - Ogdensburg Volunteer Rescue Squad Chief of Emergency Services Ken Gardner says he's seen a significant increase in suicide and overdose calls as the pandemic lingers on.

"In the last month, we've had eight suicides. In our district, we've had five," he said.

Gardner says he can't blame the increase in deaths and suicides directly on COVID-19 or the impact of isolation, but says he believes it's "not helping."

Gardner says he's seen younger victims and older victims. In addition to gunshots and hanging, he's seen methods used recently that are less common than what he's seen in the past.

"It's scary. It's really something I have not seen in my 35-year career," he said.

"It kind of blows your mind to see young people doing those things," he said.

Gardner spoke briefly at Monday's meeting of the Ogdensburg City Council where he shared some of the information and followed up with North Country This Week Tuesday for an interview.

Gardner said the situation isn't unique to the area, and his observation is supported by the Centers For Disease Control which published information in June 2020 regarding mental health, substance use, and suicidal Ideation during the

# Massena, O'burg eye uses for federal funds

MASSENA – The town will wait for more details on the American Rescue Plan before deciding how their share of the pandemic relief bill will be spent.

The town is earmarked for \$1.32 million, according to Sen. Chuck Schumer's office.

"Without seeing all the fine print, it's hard really to commit. it's kind of bland what the criteria was. I'd like to read the fine print before we commit to anything," Deputy Town Supervisor Sam Carbone said. "If anything else, help cover some shortfalls we've experienced over the last year. It's greatly appreciated that we have this funding source coming."

Carbone pointed out that the town in 2020 made midyear budget cuts when the pandemic hit, and they also haven't been getting pay-

ments from the state-tribal casino compact.

"That's approaching \$800,000 as a shortfall," Carbone said. He said although there

haven't been any decisions on spending the American Rescue Plan funds, they could use it to catch up on paving.

"One thing we did was didn't pave last year. It helped save us some money," Carbone said.

Another option could be an engineering study to extend town water service to the entire town. Right now, there is a water district funded by its ratepayers. Some people outside the district get their water from wells.

"Maybe it could be used for an engineering study for that," Carbone said.

"It spurs more building, having [water] infrastructure available, and more

# City beach, amphitheater, flow of traffic all part of draft development plan

OGDENSBURG – Deputy Mayor John Rishe with some help from fellow councilors has drafted a 30-page Community Development Plan he hopes will be reviewed by the planning board and the public soon with adoption anticipated this summer.

Rishe called for such a plan not long after being elected, but with a focus on cutting costs, preparing such a document is typically a pricey endeavor. Rishe, who serves as an economic developer at the OBPA, decided to take action on his own.

The document addresses economic development and job creation, waterfront redevelopment, downtown redevelopment, tourism, housing, historic preservation, recreation, transportation, education, arts and culture, state facilities and the tax rate.

It explores options to develop the waterfront, foster partnerships with colleges, improve streetscapes, change traffic patterns, preserve historic buildings and ensure the future of stateowned facilities among many other ideas.

#### **Economic Development**

The economic development section of the plan calls on the city to hire a business developer, which is budgeted for in the 2021 budget. The person would work with businesses to assist in expansions and implement a

marketing strategy to attract new businesses to the city.

It also discusses a need to develop and market the former Newell Building and work with the Ogdensburg Bridge and Port Authority to attract businesses to the industrial park.

Additionally, it discusses the need to bolster the city's Growth Fund and work to get representation on the Regional Economic Development Council.

#### **Waterfront Development**

The St. Lawrence River is often touted as the city's greatest asset, but the city has struggled to capitalize on its waterfront properties due to contamination.

# Wave of evictions expected, applications up 75%

CANTON – A member of St. Lawrence County's Fair Housing Task Force asked county legislators to consider making a possible incoming wave of evictions as "a legislative agenda item."

John Tenbusch, who is also a St. Lawrence County planner, discussed the matter with the board's Operations Committee during their Monday, March 8 meeting.

Tenbusch said after speaking with Massena Justice Diana Dufresne from the Massena-based Justice and Law Center that there have been 260 eviction applications filed for the county in the last four months. He said that's increased 75% in the last year.

There is currently a statewide moratorium on evictions through April 30, due to the COVID-19 pan-

"We're going to be inundated with eviction cases. I am not aware there is any relief provided or planned for renters who have fallen behind on their rent or landlords who can't pay," Tenbusch said. "We want you to be aware of the size and scope of the problem in SLC and ask you to put on your legislative agenda relief for tenants as well."

In February, the Board of Legislators passed a bill calling on the state to provide financial assistance to landlords who may not be able to collect rent fees during the pandemic moratorium.

# **Check BMI for vaccine** eligibility, health officials say

CANTON - St. Lawrence County's Board of Health president is suggesting people check their body mass index. It may make them eligible for COVID-19 vaccination.

Dr. Andrew Williams discussed the statewide eligibility criteria with the Board of Legislators Operations Committee on Monday, March 8.

Since the state added people with co-morbid conditions to those who can now be vaccinated, Dr. Williams said that means about half of the people in the county who aren't old enough to get the shot can now.

The state defines obesity as one of the 13 co-morbid conditions. Anyone with a BMI of 30 or greater can register for a shot. That's about 38.1% of adults in the county, Dr. Williams said.

For example, he said someone who is 5'8" and weighs 197 pounds qualifies. There are BMI calculators free online, including one from the CDC. When signing up for a vaccine appointment, the state form just asks if you have one of the 13 condi-

tions. There are no checks for things like height, weight or blood sugar at the vaccine sites. Signing the form as an attestation is all it takes.

"It's the honor system. We really want people to get vaccinated. We don't want to put up obstacles. We don't want to discourage people. We want people to be honest," he said.

Dr. Williams said those people should consider getting the vaccine.

"It's quite clear there's an association between obesity and more severe covid infection," he said.

In addition to obesity, Dr. Williams said the obesity, lung disease, heart disease, kidney disease and diabetes comorbidities make about 41,000 adults in the county now eligible for vaccination.

That includes anyone with emphysema, "over 8,000 people" in the county, he said.

Anyone with hypertension, or a history of angina, heart attacks, strokes or ministrokes are also eligible, as are cancer patients.

# Incumbents will seek re-election in O'burg

OGDENSBURG - With a crowd of supports councilors Nichole Kennedy, Dan Skamperle and Michael Powers announced they would seek re-election.

As petitions can't be filed until March 22, it's unclear if they will face opponents in primary, but at this time no one else has publicly announced a bid to run to challenge

All three councilors have been aligned for the past year acting as a counter voice to the current majority administration of Mayor Jeffrey Michael Skelly, Deputy Mayor John Rishe and councilors Steve Fisher and Bill Dillabough, who were elected following a write-in campaign.

The past year has been contentious, as the new administration has sought to cut taxes.

In the past year the city has dis-

solved the recreation department, appointed a new city manager, cut jobs from the fire department, seen an increase in workplace violence complaints, cut taxes by 10 percent, eliminated the comptroller position and modified the charter.

The decisions have left the city divided, and the incumbents seeking reelection say they provide a voice to the people who don't approve of the methods used to achieve a lower tax rate.

Councilors Skamperle and Powers could not immediately be reached for contact regarding their reelection bids, but Councilor Nichole Kennedy said she decided to run because she wants to continue being a voice for the people of Ogdens-

She says in deciding to run she decided that she wanted to support her fellow incumbents and run in a unified effort.

Kennedy, who is the only woman

on the council, says she is invested in the future of Ogdensburg. She has three children ages 1, 5 and 11 who will be raised in the community and she wants to ensure they grow up with opportunities.

"I'm not at the tail end of my time in Ogdensburg. I'm not leaving when things get tough or my term ends. I'm raising a family here and am in it for the long haul."

Kennedy says her message to her supporters and other citizens of Ogdensburg is simple.

"Our message to our supporters is 'we hear you.' We are actively trying to give you a voice on the council and we will continue to represent you," she said.

Kennedy said that while the minority council members might not have the votes needed to achieve some goals, their voice is still important and they will continue to raise concerns brought forward to them by the public.

# **Public Health Board chair says** vaccines appear to be working in SLC

A top public health doctor in St. Lawrence County says they're not seeing people who have gotten the COVID-19 vaccine ending up hospitalized with the illness.

Dr. Andrew Williams, president of the county Board of Health, talked with the Board of Legislators Finance Committee during their Monday, March 8 meeting.

"We have not had anyone hospitalized in SLC who's been vaccinated ... another endorsement of the effectiveness of the vaccine," Dr. Williams said.

"We really are not seeing people who are vaccinated turn positive on their testing. We're really not seeing

He is encouraging anyone who is eligible for vaccination to get one.

"Fighting this pandemic is very much a team sport," he said. "I

think this is a good example of what you can do to fight the pandemic."

"Vaccinations are going to help us end this pandemic and reopen the economy," the doctor added. "Vaccinations can increase the activities people can do safely."

Dr. Dana McGuire, St. Lawrence County Public Health director, said the county has not received updated guidance on masking, social distancing and travel for those who are fully vaccinated. Fully vaccinated means two weeks after the second shot of the Pfizer and Moderna vaccines, or two weeks after the Johnson & Johnson vaccine.,

"It's not something we've taken on here in St. Lawrence County, but I do believe it is coming," Dr. McGuire said. "We're hopeful that

# City to reps: Help shoulder WWTP costs

OGDENSBURG – Ogdensburg City Council is asking state and federal officials to help offset costs of the Wastewater Treatment Plant by converting existing loans to grants.

"As presently funded, the ratepayers of Ogdensburg cannot afford \$22.4 million in loan repayments, and certainly not the additional \$5 million in alternate improvements that are still needed to complete the project and have not yet been awarded," a letter issued to Congresswoman Elise Stefanik, Sen. Charles Schumer, Sen. Kirsten Gillibrand and State Sen. Patty Ritchie

"We request your assistance with identifying a source of \$5 million in grant funding to implement the remainder of this project and respectfully ask that one of the loans for the project be converted as a grant under criteria for disadvantaged communities," the letter says.

The letter points out that Ogdensburg is located in St. Lawrence County, which ranks second out of the state's 62 counties in terms of poverty and unemployment rates.

The letter also shed light on the fact that the city is classified by the state as a "Financially Distressed Community" due to its economic condition and present fiscal state.

According to a 2019 report from the state's Financial Restructuring

Board more than 26% of the population is on public assistance and median income is well-below the state average.

The letter also notes that the city has the highest tax rate of any community in the North Country, has lost 31% of its population since 1959 and that 59 percent of property in the city is tax exempt.

"At present, only 20% of the total project cost is grant funding. Meanwhile, the City of Ogdensburg has worked with the state to receive waste from a neighboring municipality – the Village of Heuvelton - whose project is funded by 69 of the total project cost," the letter says. "We are also being asked to take waste form the Town of Lisbon to assist this community with its waste water problems. We are doing our part with a Project Labor Agreement, but the State needs to do more."

According to the letter the loans can be modified in the form of principal forgiveness, negative interest rate loans, or grants.

We would argue that the state's hardship rules be analyzed again and that a larger share of this project be funded by grants by converting a larger share of the loans to grants, and by providing 100% of the \$5 million in critical alternates as grant funds," the letter says.

The letter notes that a significant portion of the city's water and sewer fees are paid for by tax exempt properties and that should any of

those facilities close, ratepayers would have to pick up the differ-

"We, therefore, ask that New York State and the Federal government's reevaluate our community's disadvantaged status for additional grant assistance based on hardship requirements. It would be less of a financial burden if the smaller \$12,000,000 pass through loans was converted to a grant. We would also request that (you) take into consideration the impact on poor residents who will be paying for the \$5 million in additional costs that will largely serve state facilities," the letter says.

The letters are signed by the full council, but the idea has been

# **County gives nod to help Ogdensburg** clean up contaminated sites

CANTON – County legislators have given the county attorney a go-ahead to help the City of Ogdensburg with efforts to clean up four environmentally contaminated properties.

The Board of Legislators took the action during their Monday, March

The four lots in question are the Shade Roller site, 541 Covington St.; MCYC site, 502 Riverside Ave.; the Kiwanis site, Riverside Avenue; and

the Sybron site, also on Riverside Avenue.

They'll be cleaned up through a partnership with the state and county that has so far cleaned up over 50 contaminated lots here. The motion notes that the city on Feb. 9 reached out to the county for assistance with getting the waterfront lots cleaned up and ready to go back on the tax rolls.

Legislator Jim Reagen, R-Ogdensburg, called the county board's action "a terrific example of a city-county cooperative arrangement and I think we'll see great

benefits to everyone and to the economy in the future."

"I just would like to thank the county attorney and his staff for their willingness to work on this with the City of Ogdensburg and I believe this will be of great benefit to both the city and the county in the long term in getting these major shoreline property back on the tax roll and back into productive uses," he said. "I thank Ogdensburg City Planning Director Andrea Smith for the efforts she's made over the past decade to get these properties to the point we can move forward.



# Burn ban underway kicks off March 16

A burn ban is in effect from March 16 through May 14 in St. Lawrence County and the rest of the state, according to the Department of Conservation.

Violators of the state's open burning regulation are subject to both criminal and civil enforcement actions, with a minimum fine of \$500 for a first offense.

Open burning is prohibited in New York, with several exceptions:

- Campfires less than 3 feet in height and 4 feet in length, width or diameter are allowed.
  - Small cooking fires are allowed.
  - · Fires cannot be left unattended and must be fully

extinguished.

- · Only charcoal or clean, untreated or unpainted wood can be burned.
- · Ceremonial or celebratory bonfires are allowed. In towns with a total population less than 20,000, you may burn tree limbs with attached leaves. The limbs must be less than 6 inches in diameter and 8 feet in length (also referred to as brush). However, this is not allowed from March 16 through May 14 due to the increased risk of wildfires.

# \$1.5 million will aid tribal housing

AKWESASNE – The U.S. Department of Housing and Urban Development (HUD) announced \$1,500,053 for St. Regis Mohawk tribal housing activities.

# Man charged with poaching, DEC withholding name

LISBON – An alleged poacher was charged by the DEC after he allegedly shot a coyote in another person's yard.

DEC says on Feb. 28, a 15-yearold girl in the town of Lisbon was home alone when she noticed two trucks pull into her driveway. Unknown men exited the truck wearing camouflage and knocked on the door.

At the same time, the teen heard sounds of dogs fighting in her backvard.

She was frightened by the knock and the presumed dog fight and did not answer the door, DEC said.

The girl saw the men proceed into the backyard, heard a gunshot, and watched as they left quickly. The teenager called her parents, who contacted a conservation officer for assistance, DEC said.

The officer's investigation determined the hunting dogs entered the yard from the rear farm field while chasing, and eventually cornering, a coyote. Because they were using

GPS collars, the subjects were able to tell when their dogs had stopped moving, DEC said.

The poachers arrived to get their dogs and took advantage of an easy, but illegal, harvest of the coyote. The officer did not identify the poacher, but thanks to some freshly fallen snow, tracks left behind provided helpful evidence, DEC said.

The officer visited the homes of five known coyote hunters in the area until finally he was able to match the tread pattern left at the scene

The poacher admitted to shooting the coyote and was issued tickets for trespass and shooting within 500 feet of a dwelling, according to DEC.

DEC did not identify the alleged poacher, and did not respond to a request for his name, age and hometown.

She always liked to be present in their activities, in her later years when she couldn't be there in person, she always would call to see how their games went, how their day was, and to find out what they had planned for the weekend.



A new type of telephone scam is targeting residents nationwide in an attempt to gain banking information from unsuspecting residents, said a press release from U.S. Customs and Border Protection.

U.S. Customs and Border Protection agents and officers nationwide are continuing to receive numerous calls from residents concerned about unsolicited calls from scammers posing as U.S. Border Patrol agents and U.S. Customs and Border Protection officers.

Residents are reporting the calls are a pre-recorded message stating, "a box of drugs and money being shipped has your (callers) name on it and it has been intercepted."

The caller is then instructed to press #1 to speak with a CBP Officer/Agent, which then attempts to get the callers banking information.

These calls are phone scams/phishing attempts and residents are urged to not provide the caller with any

The Department of Homeland Security and CBP does not solicit money over the phone. If such calls are received, people should make a note of the number and any other pertinent details about the call and immediately hang up, and report the incident if possible.

St. Lawrence County STOP-DWI announced that St. Lawrence County law enforcement agencies will participate in a special STOP-DWI Enforcement Crackdown on impaired drivers March 16 through March 21.

"There will be no warnings," said Michele James, St. Lawrence County STOP-DWI Program. "Our message is simple—Don't drive impaired. Violators can lose their licenses; pay increased insurance rates; may have an ignition interlock device installed in their vehicle; legal bills; pay fines and surcharges as well as DMV fees. When the average DWI costs the offender over \$4,000-\$8,000, wouldn't you rather have a sober friend pick you

up?"

All drinking driving fines collected from convicted drunk drivers fund the St. Lawrence County STOP-DWI Program.

State, sheriff's offices and local municipal law enforcement agencies across the state will be out in an effort to reduce the number of impaired driving injuries and deaths.

During this time period, law enforcement will vigorously enforce laws related to driving while impaired with special emphasis on impaired driving either by alcohol or drugs.

Impaired driving is preventable. All it takes is a little planning. If you're headed out for St. Patrick's Day, designate a responsible and sober driver! Remember, "Don't Drive, Get a Sober Ride"

While STOP-DWI efforts across New York have made great strides in reducing the numbers of alcohol and drug related fatalities.



North Country Assemblyman Mark Walczyk says Gov. Andrew Cuomo should either resign or be impeached.

A Republican from Watertown, Walczyk cites several recent scandals as the impetus for Cuomo to leave office or face action from the state legislature.

"It's clear to just about every New Yorker that the Governor has become a distraction.

"His office publicly admitted to altering data that shows the real number of deaths in nursing homes that his policy caused," Walczyk said in a prepared statement

"It's been revealed he ignored serious safety concerns about the Cuomo (formerly Tapanzee) Bridge just to meet his political timeline. In addition, five women have now come forward and are accusing him of serious misconduct. The Governor has lost the trust of the people. We can't let him sweep all of this under the rug."

Walczyk's statement goes on, "despite all this, the Governor made it clear Sunday afternoon that he is not resigning and plans to draw this out. His contempt is a call for the Legislature to hold the executive accountable if he does not step down."

"This is the reason why my colleagues and I introduced a resolution today that would initiate Impeachment proceedings. If the Governor continues to dig his heels in and does not do the right thing by resigning, then Assemblymembers and Senators need to help New York move on by impeaching the Governor."

# Federal funding aids law enforcement

Four St. Lawrence County agencies will receive federal funding for highway safety initiatives.

A recent press release from the state said the awards are part of more than \$37.2 million in federal highway safety grants awarded to 502 programs throughout New York State in 2021.

- St. Lawrence County Sheriff's Office, \$4,995 for police traffic service.





# State allows 75 % capacity for eateries

Governor Andrew M. Cuomo announced that restaurants outside of New York City, which have been operating at 50 percent capacity, can now move to 75 percent capacity starting March 19.

This includes eateries in St. Lawrence County.

"The data has shown that restaurants can operate safely and in accordance with strict health protocols at 75 percent capacity," Cuomo said. "New York City restaurant capacity will remain at 35 percent capacity."

"Our fight in the war against COVID-19 continues, but we are encouraged by the decrease in infection and hospitalization rates and the rise in vaccinations," the governor said.

"As we expand our vaccine distribution and celebrate the arrival of the Johnson & Johnson vaccine, we have never been closer to defeating this beast once and for all," Governor Cuomo said in a press release.

"It is critical that New Yorkers not succumb to COVID fatigue and remain vigilant. Until the day the war is won, we all need to continue the practices we know work - washing hands, social distancing and masking up," the governor

The governor went on to say that the state's current COVID-19 numbers are a reflection of the state's actions.

"When we work together, we will see the light at the end of the tunnel," Cuomo said.

# Vaccine at O'burg, Canton Price Chopper pharmacies

Ogdensburg and Canton Price Chopper pharmacies are now offering COVID-19 vaccinations for people age 65 and up.

They plan to offer both the Johnson & Johnson and the Moderna vaccines, depending on supply. Johnson & Johnson's is a single-dose vaccine.

Moderna requires one shot and then a booster 28 days later.

Price Chopper will use a new online scheduling system, which is available at www.pricechopper. com/covidvaccine.

A rolling two days of appointments will be shown at once and new appointments will load every day.

While vaccine availability is increasing, distribution remains uneven, so people should continue to check the site for appointments.

The phased allocation of vaccines to designated groups, according to vaccine prioritization guidelines established by each state and immunization jurisdiction and their local health departments, is based in part on guidance from the CDC's Advisory Committee on Immunization Practices (ACIP).

As the supply increases, vaccination will progress to the next phase.

The state is now vaccinating those in Phase 1a and initial groups from Phase 1b.

Community pharmacies are focusing on those 65 years of age and older.

The hope is to include more groups as soon as the state releases that information.

To determine eligibility for the vaccine and to register for an appointment, visitwww.pricechopper.com/covidvaccine/.

The vaccine is available at the Price Chopper/Market 32 stores listed above by appointment only.

If shot "events" are full, customers should continue to check the website on a regular basis for new availabilities.

Those who secure an appointment will receive an e-voucher to print out or display on a mobile device that should be brought to the pharmacy for their appointment, along with a government ID and insurance information.

After receiving the vaccine, each recipient will be asked to remain in a dedicated safe space on the premises for a required observation period of 15 to 30 minutes.

# 140 residents without broadband, says survey

CANTON – Out of over 900 responses to the St. Lawrence County broadband survey received through March 5, 140 said they don't have internet access, or don't know if they do.

St. Lawrence County Planning Director Jason Pfotenhauer updated the Board of Legislators on the survey during the Monday, March 8 Operations Committee meeting.

He added that out of 29 commercial responses, 12 lacked internet access. The county has partnered with the Development Authority of the North Country for the two-pronged survey. Residents can go to https://www.stlawrencecountybroadband.com until April 30 and fill out a questionnaire. Meanwhile, DANC is sending a contractor to actually go out and look at all of the utility poles in the county to see where broadband cable is or isn't, and where it could be added.

"We'll be able to develop some spatial analysis based on addresses where the gaps are with the broadband," Pfotenhauer said. "That's going to serve us well as we do a strategic targeting for funds that will help us improve the broadband throughout the county."

broadband throughout the county."

Legislator Larry Denesha, R-DeKalb, said he was initially skeptical of the survey being done online, but he sees the response so far as a good indica-

"I think that's a sign that we're probably reaching some of the folks that needed to be reached," he said.

Part of the questionnaire is actually answering questions, and part is a speed test. The speed test can be done on a cell phone but it has to be connected to wi-fi. Using the phone's data plan "would give us a false response for the speed test," Pfotenhauer said.

People can also call the Planning Office for assistance at 315-379-2292. The county is advertising the survey at the mass COVID-19 vaccination clinic in Potsdam. They're also looking at advertising it through flyers on public transit buses, and with home-delivered meals through the Office for the Aging

# **Colorectal screenings offered**

OGDENSBURG — As New York State re-opens businesses and ease COVID-19 restrictions, CHMC joins other healthcare facilities to provide colorectal cancer screenings and many other elective procedures.

CHMC has made careful consideration of the risks and benefits of providing colorectal cancer screenings during COVID-19, along with ensuring safety for both patients and healthcare personnel.

With proper precautions and following COVID-19 guidelines issued by organizations like the Centers for Disease Control (CDC) and the ACS allows for Claxton-Hepburn to provide life-saving screenings safely.

Claxton-Hepburn providers offer several options for colorectal cancer screening for people at average risk. For example, stool-based tests, such as fecal immunochemical testing (FIT) or a stool DNA test, can be done in the privacy of your home.

If you get a positive stool test result, you will need a colonoscopy.

Other screening options include CT colonography (virtual colonoscopy), flexible sigmoidoscopy, and traditional colonoscopy.

Colonoscopy is the best option and considered the gold standard in colorectal cancer screening.

Your health care provider can help you determine what screening schedule and which screening tests are best for you at this time.

CHMC follows the American Cancer Society's (ACS) colorectal cancer screening guidelines, which recommend people at the average risk of colorectal cancer start screening at age 45.

People who are in good health and with a life expectancy of more than ten years should continue regular colorectal cancer screening through the age of 75.

For people ages 76 through 85, the decision to be screened should be based on a person's preferences, life expectancy, overall health, and prior screening history.

People over 85 should no longer get colorectal cancer screening.

The ACS defines people at average risk for colorectal cancer if they do not have a personal history of colorectal cancer or certain types of polyps, a family history of colorectal cancer, a personal history of inflammatory bowel disease (ulcerative colitis or Crohn's disease), or a confirmed or suspected hereditary colorectal cancer syndrome, such as familial adenomatous polyposis or Lynch syndrome.

The ACS recommends that people at increased or high risk of colorectal cancer might need to start colorectal cancer screening before age 45, be screened more often, or get specific

This includes people with a strong family history of colorectal cancer or certain types of polyps, a personal history of colorectal cancer or certain types of polyps, a personal history of inflammatory bowel disease, a known family history of a hereditary colorectal cancer syndrome such as familial adenomatous polyposis or Lynch syndrome.


If you're at increased or high risk of colorectal cancer, have a conversation with your health care provider to learn more.

Your provider can discuss your screening options, as well as determine what type of screening schedule you should follow.

Most private insurance and Medicare, and Medicaid cover the cost of the variety of colorectal cancer screenings.

# **Medications can be dangerous for drivers**

Impaired driving claims thousands of lives every year. According to the National Highway Traffic Safety Administration, nearly 30 people die in drunk driving crashes every day in the United States.

Drivers recognize the dangers

In its 2013-14 National Roadside

• The side effects of OTC drugs can be serious.

It's easy to write off the side effects of medications that can be purchased as

However, the NHTSA notes that OTC medications can induce drowsiness, cause nausea, cloud drivers' judgment, and adversely affect drivers' hand-eye coordination.

• Some prescription medications have been linked to higher risk of crashing.

Opioids, sedatives, muscle relaxants, and some antidepressants have been associated with increased crash risk.

• Mixing medications can impair driving ability.

Mixing drugs with alcohol also can produce side effects that impair driving ability, even for drivers who do not feel as though they consumed an amount of alcohol that would normally compromise their ability to drive safely.

# What to look for when test-driving pre-owned vehicles

Pre-owned vehicles have become hot commodities in recent years, reflecting a change in what drivers are looking for when it's time to get a new ride.

Test drives remain a great way to get a feel for pre-owned vehicles and prospective buyers can consider various factors to determine if a given car or truck is for them.

# Why is tire rotation so important?

Vehicle owners need to keep maintenance on the mind to ensure their cars and trucks are operating at peak capacity.

Various components should be checked and serviced at key intervals. Oil changes and fluid top-offs are part of routine maintenance, but it can be easy to forget about other important parts of the vehicle, including tires.

Rotating tires is vital to their upkeep. Bridgestone Tires advises that tire rotation involves routinely repositioning a vehicle's tires in specific patterns from front to back and side to side. According to Big O Tires, the front tires tend to wear on the outside edges because the tire leans over when a driver turns a corner. The rear tires just follow the front ones, so they usually wear more evenly. By leaving tires in place, the

outside edges on the front tires will wear down much faster than the rest and those tires will need to be replaced

Rotation may be required by tire warranties. Rotation also keeps the tires working properly.

Experts generally advise tire rotation every 6,000 to 8,000 miles, even if they do not show any signs of wear. It is challenging to determine if weather treads are uneven or how much wear has been sustained just by looking at them. Rotating tires can prolong the life of tires and decrease how frequently they need to be replaced.

Rotating tires keeps the tread depth uniform and helps maintain traction and consistent handling. Minimizing uneven tire treads causes the vehicle to be more balanced





# Ice shanties need to be pulled by March 15

OGDENSBURG – Late season ice fishing can provide hours of enjoyment, but it also requires extra precautions when venturing out on the ice, according to the Ogdensburg United States Coast Guard Auxiliary.

Strong late winter winds and waves, and rising air temperatures can weaken the ice in the same locations where you have fished safely all winter, a Coast Guard press release said. Checking the thickness of the ice on every trip can mean the difference between a memorable day fishing or an unfortunate plunge into the icy

As a remember, per New York State law, all ice shanties must be marked on the outside with the owner's name and address in letters at least 3 inches high. Shanties must be removed from all waters by March 15 to prevent them from falling through the ice in spring and becoming hazards to navigation".

Four inches is the recommended standard for walking on the ice.

Coast Guard officials say to check the thickness with a spud or chisel as you proceed as ice thickness is not consistent. Remember that a little water on top of the ice makes it extremely slippery increasing the risk of falling. When walking on ice, keep your center of gravity over your front leg. Walk like a penguin keeping your knees slightly bent, walking flat footed while taking short shuffling steps. To be extra safe, it might be best to leave your pickup truck or ATV on shore.

Here are a few reminders to assist fishermen in planning a late winter outing on the ice. Remember ICE.

I – Information – remain informed by checking the weather and ice conditions before going out. Know your intended destination on the ice and how to call for help.

C - Clothing - wear enough clothing to prevent hypothermia. Dress for the water temperature, not the warm air temperature. Pick bright colors and reflective clothing to aid searchers should you end up needing help.

E - Equipment – Bring safety equipment: a cell phone, marine radio, Personal Locator Beacon, life jacket/float coat, a whistle or noise making device, screw rivers or ice picks which can help you pull yourself out of the water should you break through the ice. Your cell phone or marine radio can summon help should your ice break away and drift away from shore.

Complete an ice plan should include: The names and number of persons going on the ice as you should never fish alone; where and when you are leaving from your destination, and when you will return. List the cell phone number for everyone in your fishing group. Identifying information about your vehicle(s) and where it will be parked. Leave your plan with a reliable person who will notify the Coast Guard or other rescue organization if you do not return as scheduled. Should your plans change, be sure to notify the person holding your ice plan.

businesses," Carbone said. "We'll see where we land going forward."

In total St. Lawrence County and many municipalities within will receive more than \$30 million in Federal Aid with the county taking the lion's share.

Towns receiving funding include Brasher at \$230,000, Canton at \$1.12 million, Clare at \$100,000, Clifton at \$80,000, Colton at 150,000, DeKalb at \$250,000, DePeyster at \$120,000, Edwards at \$120,000, Fine at \$160,000, Fowler at \$230,000, Gouverneur at \$760,000, Hammond at \$130,000, Hermon at \$110,000, Hopkinton at \$110,000, Lawrence at \$200,000, Lisbon at \$440,00, Louisville at \$330,000, Macomb at \$100,000, Madrid at \$180,000, Massena at \$1.32 million, Morristown at \$210,000, Norfolk at \$490,000, Ogdensburg at \$1.14 million, Oswegatchie at \$470,000, Parishville at \$220,000, Piercefield at \$30,000, Picairn at \$90,000, Potsdam at \$1.69 million, Rossie at \$90,000. Russell at \$200,000, Stockholm at \$400,000 and Waddington at \$240,000.

An announcement from Sen. Chuck Schumer's office says he helped secure \$12.6 billion in direct state fiscal relief for New York State's government.

He says New York State will also receive \$358 million from the state and local fund for building out broadband infrastructure.

"It is estimated that New York State's agencies and authorities will receive \$30 billion from the American Rescue Plan, on top of the funds from the state and local fiscal relief fund," the notice says.

The funding has some strings, but appears to allow for broad usage.

Eligible uses include offsetting costs associated with responding to the COVID-19 public health emergency or its negative economic impacts including, but not limited to assistance to households, small businesses and nonprofits or aid to impacted industries such as tourism, travel and hospitality.

The funding can also be used to support workers performing essential work during the COVID-19 public health emergency by providing premium pay to eligible workers or by providing grants to eligible employers that have eligible workers who perform essential work.

The money can also be used to cover revenue losses caused by the COVID-19 public health emergency and to make necessary investments in water, sewer, or broadband infrastructure.

The funds cannot be used to cover pensions or offset a reduction in taxes.

How the funding will be used by each municipality and the county is unknown at this time, but Ogdensburg City Manager Stephen Jellie says it's a welcomed announcement.

He said the city has many areas where it could be used and he's still waiting to hear how much aid the city will receive from the state.

He said the fact that the federal payments are direct and not to be filtered through state channels is a major benefit.

#### **DRAFT**

The plan calls for development of private waterfront sites, the Shade Roller property, the former Diamond National property, the former Mobil Tank Farm property, and the former Augsbury Tank farm property.

ty. The plan also calls for bolstering of the Fort de La Presentation and the Greenbelt Area, and acquisition of surplus St. Lawrence Psychiatric Center properties among others.

Additionally, the report calls on the city to work with the state and OBPA to remediate the Port of Ogdensburg dredge disposal site as well as development of port lands on Proctor Avenue and the Bridge Approach.

Also related to the waterfront is a call to study options for selling the historical Oswegatchie River pump house and securing a new lease for the Oswegatchie River Dam.

#### **Downtown Development**

Here the plan focuses on securing grants to create a master plan for downtown redevelopment on both sides of the Oswegatchie River. It calls for the removal of federal restrictions on the core downtown area which were imposed as part of a previous federal grant.

The plan calls for studying the benefits of a single bridge to replace the twin bridges, finding funding to improve the appearance of street-scapes, seeking to win the state's Downtown Revitalization Initiative, restoring facades and selling off parking areas near the Ogdensburg mall area to promote business development.

#### **Tourism**

The plan calls for a natural amphitheater to hold musical events and band concerts and the creation of an open pavilion next to the Dobisky Center.

It also calls for a beach on the St. Lawrence River near the city's Greenbelt. Here the plan circles back to the need to develop the city's waterfront site.

The plan calls for the city to foster more events including fishing tournaments, fairs, parades, bands barbecues and more. The plan provides support for bringing a hotel and new marina to the river and encourages assisting in the development of Fort de La Presentation.

Housing

"The city staff needs to focus its attention on federal and state programs that promote and encourage better housing conditions for low and moderate income families," the report says.

The plan calls for a full court press on securing grants to assist in that matter and working with the city's Land Bank and BOCES.

Additionally it calls for exploring the idea of creating a Neighborhood and Rural Preservation Corporation in conjunction with the towns of Lisbon and Oswegatchie.

#### **Historic Preservation**

"Unfortunately, much of the city's glory, history and heritage was destroyed during Urban Renewal when many of the city's historic downtown buildings were demolished. However, the city still has numerous historic and architecturally beautiful buildings that can be saved and restored." the plan says.

The plan calls for getting some of the St. Lawrence Psychiatric Center buildings that have been left to deteriorate by the state on the historic registry. It also calls for upgrades and improvements to City Hall. "The city's engineer should review the historical plans for the building and determine if an historic restoration project could be undertaken to restore the original grandeur of the council chambers by removing drop ceiling and restoring the balcony and stage area," it says. Additionally it calls for getting the Bridge Administration Building on the historic register.

#### Recreation

Although the city recently dissolved its recreation department, the plan calls for the establishment of a community beach.

"Ogdensburg is located on one of the cleanest and most-beautiful rivers in the entire world. Unfortunately, it has been without a community recreation beach for over 20 years. The city should strive to reopen a community beach as soon as it is practical. The cost of opening a beach can be minimal. Costs can be kept to a minimum by utilizing existing lifeguards and alternating this staff between the pool and beach," the plan says.

The plan also calls for additional events to be held at the Lockwood Arena and a private restaurant and bar to operate at the center.

The plan also calls for more recreational programs for children and youth. The plan discusses improving and maintaining trails and adding amenities in a public-private partnership. It also calls on the state to further improve the St. Lawrence State Park Golf Course, which is located outside the city limits.

#### **Transportation**

Here the plan discusses the Route 37 and State Highway 68 entrance to the city, which it says is unattractive and potentially unsafe.

"An emphasis should be placed on making the intersection safer, but also more appealing as an entrance to the community," the plan says.

In this section, the plan addresses the idea of one-bridge to replace the twin bridges.

"The present arterial circumvents the downtown and water-front areas, bringing one-way traffic around rather than through the downtown corridor. It would be better if the master planning reversed this traffic pattern so that one bridge brought traffic through downtown, connecting Main and Ford Streets with a two-way traffic pattern," he said.

Additionally the plan discusses opportunities related to the port, the airport, the short line railroad and the Ogdensburg-Prescott International Bridge.

#### **Education**

The plan discusses the city's educational institutions and the need to ensure that they must meet a high standard.

"It is critical to maintain excellent schools with educational programs that rival any other in New York State and across the country. When people look to relocate to a community, one of their primary concerns is the quality of the educational system," the plan says.

It also encourages working with area colleges about using the former Mater Dei College or other buildings as an annex for college classes that would benefit the greater Ogdensburg region.

Additionally, it calls for pitching the establishment of the "St. Lawrence River Institute or Research Center" on the shores of the St. Lawrence River.

"This facility could be operated by a consortium of existing universities, and would provide waterfront access and research facilities for professors and students to study the river ecosystem," the plan says.

#### **Arts and Culture**

This section of the plan focuses on working with existing organizations to bolster their offerings.

It calls on working with Ogdensburg Command Performance to expand their offerings to include musical bands or working with other organizations that can assist with such events.

It also addresses the Frederic Remington Museum and says every effort should be made to support the museum while transitioning former city positions over to the corporation running the museum.

"While the museum has become much more independent in recent decades, the city should work with the museum to reaffirm in legal documents that the collection belongs to the residents of the city of Ogdensburg," the plan says.

Although the city plans to end financial support for the library, the plan says the Ogdensburg Public Library is "a treasure to the city and residents in the adjoining townships."

It says the city and library board should work together to create an Ogdensburg History Museum on the second floor of the library, and officially designate the museum with proper signage on the front of the building. This can act as an additional tourism draw for the community," the plan says.

Additionally it says the city should ensure the continued vitality of the library by working with adjoining townships to create a cost-sharing arrangement for monetary support based on population and patronage.

#### **New York State facilities**

The plan acknowledges the city's dependence on public sector jobs.

'Since the early 1980s, Ogdensburg offered assistance to the state when it was looking for additional locations for the correctional facilities. Ogdensburg Correctional Facility was built utilizing vacant buildings of the SLPC. Riverview Correctional Facility was built in 1988 to house New York City's and the State's rising inmate population," the plan says. "In recent years, the state's inmate population has decreased by over 50 percent necessitating that some facilities throughout the state be closed. To date, Ogdensburg's facilities have been spared closure."

The plan says leaders will need to continue to work with state officials to convince them of the value and importance of the facilities in terms of "care and cost."

"As philosophies shift toward policies of treatment vs. incarceration, Ogdensburg should work with state officials to encourage the state to set up additional treatment programs, such as those in Hamilton Hall on the grounds of SLPC," the plan says.

#### **Tax Rate**

The plan points out that property taxes can be an impediment to growth.

"If the tax rate gets too high, and is not comparable to other tax rates in the county, state or even nationally, it will serve as a major deterrent when trying to attract new residents and businesses," the plan says.

The plan says a reasonable rate would be in the \$10-\$12 per \$1,000 of assessed property value. The current rate is \$17.87.

Here the plan trumpets efforts currently underway by council such as consolidating services with the

county and reducing the rate. It also suggests the city should encourage the school district to reduce the school tax rate.

Rishe said the plan is very much a draft at this point but is hopeful the city will move forward on shaping it into a final document by summer with help from council, planners and community members.

#### **EVICTIONS...**

"How many people who own apartment buildings are going to hit that second or third year behind in their taxes," asked Operations Committee Chair Rita Curran, R-Massena. "If the apartment they live in gets foreclosed upon?"

"We don't have numbers of that. You bring up an excellent point," Tenbusch said. "The fact that landlords aren't getting steady rents means landlords can't maintain units or pay taxes."

He said that means they also may not have cash to pay for building maintenance or upgrades.

"We're afraid this cycle of disinvestment in the rental market could be huge. And right now we have no way to help (landlords)," Tenbusch said.

Other legislators said they'd like to know how many of the 260 eviction applications are renters who lost their jobs and couldn't pay, or if any of them decided to not pay because they couldn't be evicted.

"I'm not sure there's any solid criteria for not paying your rent, other than basically stating you've been affected by COVID. That's troubling. The sentiment of our board is if you're going to mandate our landlords fund that initiative, either pay for it or have solid criteria.," said Legislator John Burke, R-Norfolk. "We need a more in-depth assessment of what in the community is already there to protect people from homelessness, and some kind of a number ... I'm really uncomfortable talking about a need we have difficulty quantifying and determining the extent of the need."

"It would be nice to get both sides of the story. Those that had the ability to pay and chose not to," said Legislator Dave Forsythe, R-Lisbon.

Legislator Margaret Haggard, D-Potsdam, suggested that the solution may be to just let the cases get to court, once the moratorium expires.

"I know Mrs. Dufresne is capable of working out settlements," she said.

"Elevated levels of adverse mental health conditions, substance use, and suicidal ideation were reported by adults in the United States in June 2020," the report says. "The prevalence of symptoms of anxiety disorder was approximately three times those reported in the second quarter of 2019 (25.5% versus 8.1%), and prevalence of depressive disorder was approximately four times that reported in the second quarter of 2019 (24.3% versus 6.5%).

The report notes that given the methodological differences and potential unknown biases in survey designs, the analysis might not be directly comparable with data reported on anxiety and depression disorders in 2019.

However, according to the survey, "approximately one quarter of respondents reported symptoms of a (Traumatic Stress Related Disorder) related to the pandemic, and approximately one in 10 reported that they started or increased substance use because of COVID-19. Suicidal ideation was also elevated; approximately twice as many

respondents reported serious consideration of suicide in the previous 30 days than did adults in the United States in 2018, referring to the previous 12 months (10.7% versus

From Gardner's anecdotal perspective, things have gotten worse, not better since then

He says while overdoses were on the rise prior to the pandemic, he estimated he's seen a 25 percent increase in recent months.

He said the suicides and overdoses are not accounting for a significant portion of the 2,500 calls he expects to see this year, but the frequency has made them feel "almost routine."

"It's sad. I don't know what there is that we can do to stop it," he said.

St. Lawrence County does have

a 24-hour crisis outline, Reachout that people struggling with suicidal thoughts or drug addiction can turn to. Reachout is a "free confidential, non-judgmental crisis and information hotline serving the residents of St. Lawrence County," according to the county website. The phone number is 315-265-2422.

St. Lawrence County also provides some substance abuse services through the Human Service Center, which can be reached at 315-386-2048. Mental Health Services are also available though that number.

On top of the increase in such calls, Gardner says the Ogdensburg Volunteer Rescue Squad has struggled with a reduction in active volunteers.

He says he understands volunteers being cautious of putting themselves at risk of exposure during a pandemic, but with vaccinations available he is hopeful to see things pick up. He says he has a great group of volunteers and paid staff that are doing as much as they can, but says they are seeking additional volunteers.

# **Sen. Ritchie says** governor maintains emergency powers
