Potsdam passes chicken regs

POTSDAM — Omelets, Eggs Benedict, and lumberjack scramble with homegrown eggs will soon be what's for breakfast for village residents who want to raise laying hens in the village.

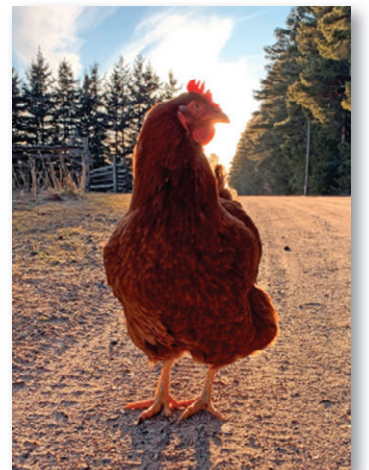
The village board of trustees at their May 17th meeting passed a resolution amending Chapter 80 of the village code and adding Chapter 180 "Keeping of Domestic Poultry" to the code.

The changes allow residents to keep up to six laying hens at village residences, with some caveats.

Now approved, the new law will become effective as soon as it is filed with the Department of State.

Since last year, the board has tried to crack this particular egg of how to regulate keeping domestic poultry in the village without giving neighbors who oppose the idea something to crow about.

While promoted as a way to provide residents some "food sovereignty," detractors of the law

commented at public hearings last year and in letters to NCTW on issues they viewed as foul, like noise, smell and sanitary issues, including the possibility of drawing in rats due to animal feed.

The new law tries to address some of those worries. No more than six hens are allowed and no roosters.

Coops need to be 25 feet from

Councilor concerned with road damage

CANTON - A Canton town councilman has expressed concerns about roughshod town roads caused by the heavy truck traffic from the company handling the transmission line replacement work.

James T. Smith voiced his displeasure to fellow board members and St. Lawrence County Legislator Kevin Acres (R-Madrid) at the board's monthly meeting.

"I've noticed over the past two months that the town roads are getting pounded by Michels. There's been a lot of traffic over 32 miles of town roads, which is close to one-third of our roads," said Smith. "And we will get left



paying for that."

Michels Power, Inc., Brownsville, Wisc., has been contracted to construct 86 miles of new transmission lines for the New York Power Authority.

"It's a \$600 million project with a company out of Wisconsin. I understand they are spending money locally but our roads are going to feel it," Smith said.

Smith suggested the town most affected by the heavy volumes of truck traffic approach

Museum celebrates 80 years

POTSDAM — The Potsdam Public Museum is celebrating 80 years in operation in its 81st year. 2020 marked 8 decades for the local institution, however, the pandemic and concerns over safety bumped the recognition of the milestone to 2021.

"We missed last year and it kind of occurred to me that we should do something," said Museum Director Erin Cheney about the 80-year milestone.

A small exhibit commemorating the 80 years of the museum has been set up, with historical photos spanning the years. Also featured are bios and photos of each of the nine museum directors over the years and their contributions.

The museum, founded in 1940 to house an English pottery collection donated by the Burnaps to the village, was housed in the basement

of its current location, the site of the former Universalist Church for the first 37 years of its existence. It moved up the stairs to its current location in 1977 after the library

moved to the adjacent space in the civic center.

Health director discusses mask changes

CANTON – St. Lawrence County’s public health director says although state guidance is changing to allow people vaccinated for COVID-19 to go unmasked, those who aren’t vaccinated for whatever reason should continue to mask to prevent future outbreaks.

Jolene Munger, the interim public health chief, said Monday, May 17 that masks are still a requirement until the written guidance from the state is updated. Gov. Andrew Cuomo made the mask announcement that day, however “current guidance as written supersedes verbal.”

“We’re waiting on guidance documents to be updated. By Wednesday, we’re hoping,” Munger said.

She said that the mask relief for the vaccinated “shows that the vaccine works.”

“The people that are vaccinated really have nothing to worry about at this point from having 50% of the county vaccinated,” she said. “There’s some herd immunity in that.”

“The vaccine is safe and effective and COVID has not gone away,” she added.

Munger is urging those who are undecided about getting vaccinated to talk it over with a trusted healthcare provider. “If you still are thinking about getting a vaccine, talk to your healthcare provider. Talk to someone you trust with your healthcare to get your info from there, and not necessarily comments on social media.”

She said that segments of society who have been refusing to accept that masks are effective at preventing COVID-19 from spreading or who believe the pandemic is a hoax could jeopardize public health progress, if they choose to ignore the mask guidance for the unvaccinated.

“That is definitely a concern for myself and the department for the amount of work it would cause. You can’t look at somebody and say, ‘Are you are vaccinated or not,’” Munger said.

Those who could be vaccinated and choose not to wear a mask for philosophical or political reasons

pose a threat to those who can’t get a vaccine because of a medical condition, Munger said.

“Be thinking about the community,” she said. “There are people who medically can’t get the vaccine. They might be immunocompromised.”

Public Health is hosting a “family vaccination clinic” on Saturday, May 22 from 9 a.m. to 4 p.m. at the Leithead Fieldhouse on the St. Lawrence University campus in Canton.

They are offering the Pfizer vaccine, which can be given to adolescents ages 12 to 17. Munger said there will be four pediatricians on site, and if the parents aren’t vaccinated, they can also get the shot.

Village wastewater plant faces major setbacks

POTSDAM — The village’s rehabilitation project at the wastewater treatment plant has faced a major setback after power was lost at the plant last week and sewage flooded the administration building there.

“We have had a catastrophic failure at the wastewater treatment plant,” said Village Administrator Greg Thompson to the village board at their meeting Monday, May 17.

Thompson said that the plant suffered a complete power outage on May 11 around 6:50 p.m. Thompson said the generator at the admin building turned on as it was designed but was not able to deliver power to the facility due to a closed breaker on the plant side of the power input.

“Obviously that is going to be one of our primary focuses over the course of the next several weeks is to find out why that happened, or why that breaker was in fact ... open,” Thompson said.

“At some point the incoming

septage found a breach in the wall between the administration building and the wet wells, this allowed for the septage to spill over and flood the administration building with approximately 35 feet of raw sewage. Which I’m happy to say we were able to pump back into the settling tanks, or the majority of it back into our settling tanks,” Thompson said.

Village workers discovered the situation at around 7 a.m. the next morning and worked to get a bypass set up to get the raw sewage back into the settling tanks. Thompson said there was some ground spillage but it was minimal compared to what might have been.

“And we are completely treating the septage that is coming in at state level, or actually a little better than state level believe it or not,” Thompson said.

Thompson said however that the plant was treating sewage again before noon, and he credited the village employees with tackling the problem and bringing the plant back online again.

The administrator said the true cost of the damage and as well as the cause of the initial power outage and why the backup generator didn’t kick in still has to be determined. He told the board that the village’s insurance carriers are backing the municipality on the damage, and are on site along with village personnel to try to determine the extent of the damage.

Thompson said the \$3 million wastewater treatment plant project was nearly complete before the incident and estimated that the flooding would set the village back from a final completion in about three months.

The administrator said the state Department of Environmental Conservation determined that spillage at the site was minimal and not an issue that would impact water quality or the environment.

SLC fair gets greenlight for summer

CANTON — With the state having given the greenlight for county fairs this summer, St. Lawrence County officials are considering how they can hold theirs in Gouverneur.

County Administrator Ruth Doyle gave a brief update on the fair to legislators during their Monday, May 17 Operations Committee meeting.

She said the fair would need a permit to exceed a capacity of 5,000, and that would include requirements for six feet of physical distancing.

She said officials are making

sure "we're both ready and able to amend, should anything occur where the numbers go back up, or provide the experience for St. Lawrence County."

Legislator Harry Smithers, R-Gouverneur, asked if families would be able to be seated as a unit when in the grandstand.

"They didn't speak in specific terms today," Doyle said. "In all environments, the family unit has been able to travel and be seated together."

At the same time the state announced county fairs can move forward, Gov. Andrew Cuomo announced the state would be relaxing the mask mandate for those

who are fully vaccinated against COVID-19.

They'll still be required in schools, healthcare, nursing home, public transit, congregate environments like correctional facilities.

"We have a mix, depending on the size and scope of county functions, a variety of these types of things," she said.

She said the county won't be looking to check vaccine cards in areas where the vaccinated don't have to mask because they can be falsified.

She said officials expect "if you've not been vaccinated, you'll follow the state's guidance and wear a mask."

Village officials approve slew of payments

POTSDAM — The village board of trustees approved payment of several bills and invoices at their meeting May 17.

The village will pay \$8,945.50 to the law firm Johnson & Laws, LLC for professional services rendered up to March 30 for the JEDA Capital 56 LLC vs. Village of Potsdam case.

The Development Authority of the North Country will be paid \$2,464 for professional services rendered through April 2021 for the Wastewater Treatment Plant Technical Services Agreement.

DANC will also be paid \$2,210 for the services during the same time period for the SCADA Wastewater Treatment Plant Capital Improvement Agreement, and \$488.75 for work the authority did through April 15 on the Crosstown Canal Project Phase II.

The board agreed to pay the firm EDR \$3,600 for services rendered through March 23 for the repainting of the water storage tank project.

Barton & Loguidice will be paid \$1,678.50 for work up to April 24 on the Water Pollution Control Facility and Pump Station Construction Administration.

The legal firm Roemer, Walls, Gold

& Mineaux will be paid \$1,500 for labor relations services for April 2021.

Finally, the board approved payment of \$5,008.71 to the law firm of Frank W. Miller for professional services rendered through April 29.

Canton plans for 'priorities'

CANTON — With several grant opportunities looming, members of the Canton Town Board took a quick comprehensive look at "priorities" at the board's monthly meeting Thursday evening.

The list voiced by board members included the Canton Pavilion, a proposed sand and salt storage building on Stiles Avenue, roads and the Canton Municipal Building.

Town Supervisor Mary Ann Ashley said she will continue to advocate for a new municipal building, constructed in 1964.

"It's old and tired and does not meet our needs. We need a better work environment for our employees," stated Ashley.

Councilman James T. Smith, always a proponent for new roads, voiced his displeasure with the condition of many town roads.

"For me it's always roads. We need to do five miles of roads per

year. Over the last few years we have been falling short of that," said Smith.

"Last year we did less than three miles. Good roads are good for business and housing. People like smooth roads. We need to get back to the five-mile mark and it would be nice to get to the six-mile mark."

Councilman Bob Washo stressed the importance of completing an architectural study for the salt/sand structure.

"We need to get the architectural work done to include it with the grant application," he stated.

Board member Martha Foley Smith pointed to the Canton Pavilion, citing a need for a "needs assessment."

"We need to imagine a new future for the pavilion, maintenance and upkeep and broaden its use as a community resource."

The town board has scheduled a joint meeting with the Canton Village Board on May 26.

Officials hopeful methadone clinic opens in 2021

MASSENA – A St. Lawrence Health representative told county legislators that SLH officials are “hopeful” they will be ready to open a methadone clinic in Massena at the end of this year.

Dr. Jayme Smith, SLH director of behavioral health services, updated legislators on the methadone clinic during the Monday, May 17 Operations Committee meeting.

The clinic would be in the St. Lawrence Centre mall, sharing an entrance and divided by a wall with a separate, SLH-run psychiatric clinic. Right now, patients have to go to either Watertown or Plattsburgh to be able to receive methadone treatment.

“Unfortunately COVID has slowed everything down. It’s been really difficult to move on lots of different projects, not just this one,” Smith said in response to Legislator John Burke, R-Norfolk, asking what’s taking so long in opening the clinic.

The clinic is being funded by a \$900,000 Department of Justice grant. In November, county legislators in an 8-7 split vote along party lines decided to award a contract to

run the clinic, and the \$900,000, to St. Lawrence Health.

Smith said they’re now at the point where they have to apply from the state for a Certificate of Need to run the clinic. It also has to go through “several layers of approval” at the Office of Alcoholism and Substance Abuse Services (OASAS) before it can go to the Drug Enforcement Administration. They can’t open a methadone clinic without the DEA approving their plans.

Smith said they’ve finalized floor plans, construction costs and hired a construction manager. They’re in the process of working on a lease with the Shapiro Group, the Montreal-based company that owns the mall.

Legislator Kevin Acres, R-Madrid, asked Smith how long of a lease they’re looking at to get a return on their investment.

“We’re looking at five years. I think that’s one of the points they’re trying to nail down,” Smith replied.

Once the methadone clinic opens, they’ll use an electronic medical record system called Methasoft. Smith said it electronically interfaces with the liquid methadone dispenser. The patient scans

their finger print and it gives a dosage based on their medical records. “It’s all done electronically through the medical record, so it significantly reduces human error,” she said.

And she said that patients at the nearby Veterans Administration clinic would be able to come to the SLH psychiatric clinic for those services.

“We really think this will be wonderful for the community. The psychiatrist will be able to operate out of both clinics,” she said. “It will be helpful, we’re hopeful, for folks at the Veterans Administration, should they need mental health services.”

County releasing \$30K for Bassmaster Elite event

CANTON – St. Lawrence County legislators gave preliminary approval to release \$30,000 for the 2021 Bassmaster Elite in Waddington.

They voted on the measure during a Monday, May 17 Operations Committee meeting. They will have to vote on it during their full board meeting in June to make it official.

Legislators who spoke during a discussion on the bill said they think it’s important the county shows support for the Waddington event after it had been canceled last year due to the COVID-19 pandemic.

“I would urge the business community in SLC to show their support for this tournament. This past year the committee of volunteers that was running it was hard pressed because of the pandemic,”

said Legislator Jim Reagen, R-Ogdensburg.

He said he was voting to release the funds to “send a message that the event will happen this year. We still need the business community and citizens supportive of our efforts to build a tourism economy in St. Lawrence County to step forward and help make this a reality.”

“I think by releasing these funds now, we’ll show the communities we’re supporting this series and fishing in St. Lawrence County,” said Legislator Kevin Acres, R-Madrid.

The resolution notes that the county gave \$75,000 from tribal gaming compact funds to the first Waddington Bass Elite in 2013, and “continued to provide financial support ... for events in 2018 and 2019.”

It also notes that Bassmaster is planning a “National Regional Tournament” in Waddington in 2022.

Water tower, painting projects underway

POTSDAM — The village water tower rehabilitation and painting project was to start Tuesday, May 18.

Village Administrator Greg Thompson told the village board of trustees at their meeting May 17 that the telephone companies were to be onsite at the tower located on the Clarkson campus Tuesday to take down their antennas off the tower and set up their temporary stands. The removal will clear the way for the contractor handling the rehab to get on the tower and start the actual project work.

"I will say that within the next 7 to 10 days our actual contractor will be onsite and will begin draining the Clarkson tower," Thompson said.

The administrator told the board that all major water users in the village have been advised to limit water consumption over the next several months while the work the is underway. The fire department will be operating a tanker task force with water draw stations set up on the river and both colleges and the hospital have been notified to limit heavy water use during June, July and August, said Thompson.

The work will include relining construction of the 1.5 million gallon tank and painting and needs to be complete by mid August before the college students return.

The village board passed a bond resolution last month that sets a maximum cost for the work of \$2.5 million. It indicates that the village will use \$575,000 in available funds, and have access to up to

\$1,925,000 in serial bonds to pay for the work.

At the May 17th meeting, the mayor and trustees accepted a bid from Amstar of Western New York, Inc. for repainting the tank. Amstar's bid, received by Environmental Design and Research which is the engineering firm on the project, is for up to \$912,000 for the work.

Ashley earns Democratic nomination for supervisor

CANTON - Town Supervisor Mary Ann Ashley received the Canton Democratic Party nomination for town supervisor at a Wednesday, May 12, caucus, outdistancing challenger Karen McAuliffe.

Ashley garnered 112 votes while McAuliffe collected 51 votes. Canton Democrats did not nominate a candidate for Canton Town Clerk. Earlier this month, acting town clerk Karin S. Blackburn withdrew from the race citing disrespectful treatment and a "toxic environment" at the municipal building. With no Democratic candidate nominated, that leaves Republican candidate Heidi L. Smith running unopposed. Democrats also endorsed David

K. Nelson and current Councilor James T. Smith, each running for a four-year term on Town Council; and Martha Foley Smith, running for a two-year unexpired Town Council term.

On the Republican ticket are John S. Taillon, Robert T. Santamoor and Paul J. Baxter, running for town town council seats.

Wednesday's caucus attracted 191 people, reported to be the largest Canton Town and Village Democratic caucus in history.

A Democratic caucus had to take place after petitions filed by Democratic candidates for the 2021 town election were disqualified in April.

No word on \$10M coming to Potsdam

POTSDAM — The governor has started to release funding to some of the 2019 recipients of the state Downtown Revitalization Initiative, however there is no word on when the village will be receiving any of its \$10 million award.

Village Administrator Greg Thompson and Village Planning Director Fred Hanss told the board

at their meeting May 17 that Potsdam has not yet received notification from the state on its funding allotment.

The village was selected in 2019 to be one of ten municipalities statewide to receive \$10 million in state DRI money to be used to revitalize downtowns by funding projects like streetscape improvements, business and economic development initiatives and infrastructure rebuilding.

"We remain hopeful that we will hear something and get us back

underway very soon, but as soon as that announcement does get made we will let everyone know," Thompson said.

Hanss said the governor has announced funding releases for the town of Baldwin, the city of Peekskill, the city of Fulton, the city of Niagara Falls, and the town of Seneca Falls.

"So he is half done with the ten awardees in the 2019 class. So hopefully we'll hear something this week," Hanss said.

Trail passes coming for SLC multi-use trail

St. Lawrence County's Multi-Use Trail opened for the season on Saturday, May 15. The trail will remain open until Sept. 15 with an increase in traffic expected as restrictions related to COVID-19 continue to decrease.

On May 3, the St. Lawrence County Board of Legislators adopted a new Local Law that creates a Trail Fund to support and maintain the trails for this year and many years to come. There has been great anticipation and input from stakeholders to help create the Local Law for the Multi-Use Trail. An important part of this Local Law creates the opportunity for residents and visitors to purchase new Multi-Use Trail Passes to ride on the trail. The new Trail Passes are not available yet, so please get out and enjoy the Multi-Use Trail.

"We are looking forward to kicking off the 2021 Trail Season in St. Lawrence County! We are encouraged to have a local law in place that will provide the tools going forward to ensure a sustainable Multi-Use Trail Fund for generations to come," said Bill Sheridan, chair of the Board of Legislators. "This will be for the exclusive use to support the trail. We will be engaging county departments and local businesses along the Multi-Use Trail to assist the County in having locations to obtain trail passes as soon as possible."

"We are so excited for the 2021 Season and look forward to welcoming residents and visitors to the County and the Multi-Use Trail. I would like to extend my appreciation to all of the volunteers who make this happen out on the trail

year after year and county staff for the local laws and policies that have prepared us for this. This has been a true team effort," Trails Advisory Board Chair Tony Arquiett (Legislator representing District 13, Helena) said. "The adoption of the Local Law to improve the Multi-Use Trail with a dedicated fund is a tremendous long term solution. The commitment by the County is a great accomplishment. As we get ready to distribute the Trail Passes, the County will not be enforcing the pass requirement yet."

The County would like to remind users of the Multi-Use Trail System that passes will not be required on the trail for opening day through Memorial Day. The County will begin enforcement of the Trail Pass requirements on June 1.

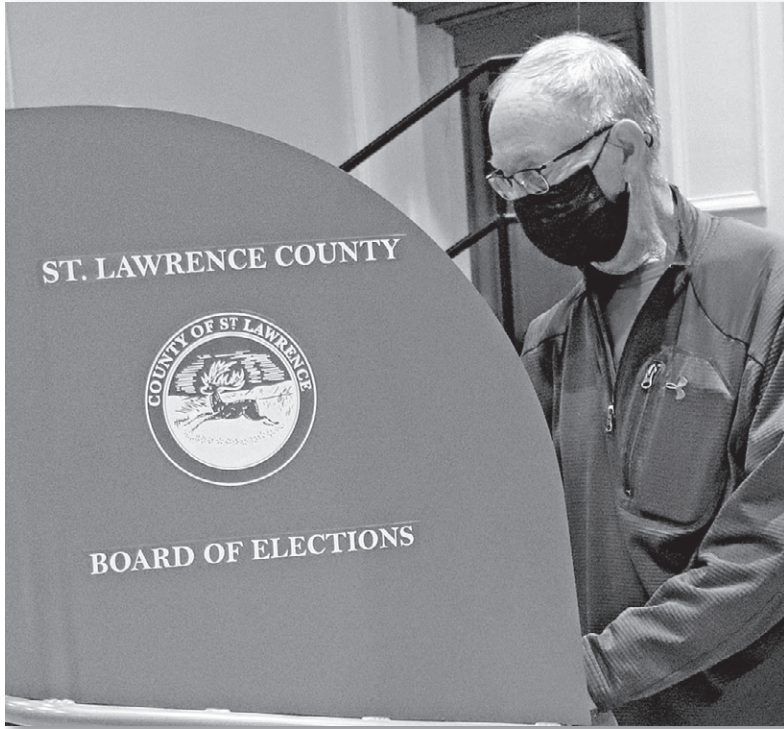

Casting a vote

Bruce Kent votes on the school budget and school board candidates Tuesday morning, May 18, at Potsdam Central School.

CCS budget, project approved

CANTON -- Canton Central School District voters approve the \$33,107,411 2021-22 budget by a 646-141 vote.

Also on the ballot was a proposition to approve a \$27.5M capital project and a proposition to purchase three buses. Voters approved each of those.

The capital project saw 608 yes votes, to 180 no votes.

The project will renovate all three cafeteria lines and the two kitchens. The project will replace the pool which is now over 50 years old. It will be relocated to an area that does not present a leak threat to electrical infrastructure and it will be designed to eliminate the corrosive effect that the pool filtration system has on the building's infrastructure. CTE classroom and learning labs/shops will be renovated for better safety and to meet the needs of current technology. The auditorium will see upgrades on the curtain control system and safety upgrades to the lighting control

system.

Additionally, the capital project, if approved, will replace existing, original water and sanitary lines as well as the remaining original brick lined manholes. The parking surfaces will be rebuilt and an additional parking lot will be constructed. The soccer field will be relocated to the behind the building where a lighted, multi-purpose artificial turf field will be constructed.

The project also proposes renovations to the Banford School and High School offices for security.

Voters also chose five school board members from a pool of seven candidates. They top five vote getters were Wendy Todd, with 564 votes, earning a 3-year term; Victor Rycroft, 537 votes, a 3-year term; Christopher Marquart, 2-year term; Kate Halleron Murphy, 523, 2-year term; and Robert Larrabee, 480, 1-year term. The Canton library proposition passed 638-152. Also, a bus proposition passed with a 661-127 vote.

PCS budget, propositions pass

POTSDAM -- Potsdam Central School District voters approved the 2021-22 budget 340-55 on Tuesday. The budget is \$35,815,351.

District residents named Joshua Fiske, James Hubbard and Lynzie Schulte to the school board with 324, 315 and 70 votes respectively.

"I am grateful for the support of the Potsdam community," said PCS Superintendent Joann Chambers.

"Each day we work hard to achieve our mission of inspiring, preparing, and empowering our students to lead fulfilled lives as compassionate, productive and engaged citizens. Our continued success is the result of the hard work of our staff and the continued support of our community." Additionally, a bus proposition to purchase three buses passed with a 346-48 vote.

Village approves Potsdam airport project

POTSDAM — The village board is moving forward on its airport taxiway reconstruction project at Damon Field.

Village Administrator Greg Thompson told the board of trustees at their meeting May 17 that

work on the taxiway is slated to begin "on or before" June 28. Thompson said the village held a pre-project walkthrough of the project last week with the contractor Marcy Excavation. Thompson said the firm is contracted to wrap up the work in 120 days, but they hoped to be finished in 60.

"With minimal shutdown, pos-

sibly no shutdown to the airport during that time," Thompson said.

In other action related to the airport, the board of trustees has hired Passero Associates of Rochester as the consulting engineers for the airport.

The firm will provide services for five years with the term expiring on May 31.

Potsdam approves roadwork

POTSDAM — The town board increased the highway rehabilitation and repair budget with additional state funding expected this year for local road work. The board also has approved planned repairs to several town roads.

At its meeting Tuesday, May 18, the board increased the road repair budget from \$352,821 to \$643,515.24.

According to a resolution passed by the town board Tuesday, the state Department of Transporta-

tion has released the final funding amounts for the year to the municipality for road repair. The town has received \$434,219.50 in state CHIPS funding for highway repair, \$112,798.29 in PAVE NY funding and \$96,497.45 in state Emergency Weather Repair funding, the resolution said. The town, like other municipalities, often counts on receiving state CHIPS money to fund local road work, however the town is getting more than initially accounted for this year.

Clarkson awards hundreds of diplomas

POTSDAM -- Clarkson University awarded nearly 750 bachelor's, master's and doctoral degrees to students from 26 states, 19 countries and 52 New York state counties at its spring 2021 commencement, today, Saturday, May 15.

The \$1,500 prize is given "in recognition of the importance of superior teaching." Candidates are

Both are \$1,000 prizes given to "a student who demonstrates the best combination of scholarship and promise of outstanding professional achievement."

On May 22, Clarkson will celebrate the Class of 2020 with their commencement ceremony.

This Commencement ceremony recognizes the 949 May 2020, August 2019 and December 2019 graduates, who have earned 22 doctor of philosophy degrees, 20 doctor of physical therapy degrees, 263 master's degrees, eight advanced certificates and 636 bachelor's degrees, as well as two honorary degree recipients.

an appointment Tuesday-Thursday from noon to 4 p.m., things are starting to resume a more normal operation for the downtown museum on Park Street as concerns about the pandemic have begun to wane.

"We are taking things slowly, we want to be safe," she said, adding that the museum takes its operational cues from the village in terms of pandemic plans.

Cheney said a new exhibit will be tentatively announced at Summer Fest and the museum is planning to have a table at the event in July. However, those plans are subject to change depending on the public health situation at the time.

The director said an open house

The director said the closure during the pandemic has made the museum focus more on their digital presence. The museum's website <http://potsdampublicmuseum.org/> contains links and information on the museum's current exhibit "Can You Hear Me Now: A History of Telecommunications" (which is being extended to allow the public more of a chance to view it), along with photos and details about past

exhibits.

In addition, the site contains information about the history of the community, the museum's various collections, historical maps and the Pin Point Potsdam 1865 project, a community-driven research project on Potsdam circa 1865.

The Pin Point project, started by previous director Mimi Van Deusen who retired earlier this year, focuses on a map of the community from 1865 and invites members of the public to pick a location and spearhead a research project focusing on the spot. Cheney plans to expand upon the idea and has been speaking with SUNY Potsdam faculty to open the project up to college students studying history or museum studies. "Community is important, and a place like this can help you learn about your community," Cheney said. "We want to entertain,

we want to teach."

any door or window of any neighboring dwelling and five feet from rear and side lot lines. Coops cannot be located in front yards.

No outdoor slaughtering of chickens is permitted. And, finally a biennial permit costing \$25 is required to keep the hens.

Trash removal contract approved in village

POTSDAM — The village board here has authorized the mayor to sign a trash removal contract with Casella Waste Services based in Potsdam.

The board approved the authorization at their meeting Monday, May 17. Under the terms of the agreement the contract will last 5 years, from June 1, 2021 to May 31, 2026.

Trash removal for residents will

cost \$10 per unit per month under the contract.

Village of Potsdam logo trash bags will cost \$19.50 per package which are either 10 fifteen-gallon bags or 5 thirty-gallon bags.

The company will provide zero-sort recycling pickup as part of the service.

Finally there will be a flat fee of \$2,350 per month for village facilities container service.

School plans new classroom

CANTON — The newest school in St. Lawrence County is considering opening a second classroom as its initial enrollment capacity is close to full.

St. Catherine of Siena Academy will be an independent liberal arts school in the Catholic tradition for students in grades K-4.

Operating at 2 Powers Street in Canton, Siena Academy initially planned to only accept a small number of students for a one-room school experience in its first year, but due to demand the Governing Board is now considering adding a second classroom.

The school has plans for steady growth, with a grade to be added each year, and long-term plans to open a high school.

Though only May, the first room is almost at capacity and the school's governing board is considering opening up more spots for additional students. The two classrooms

will be split into a K-1 classroom and a 2-4 classroom. The school is the only school operating in the Catholic tradition in the Canton/Potsdam area. SCSA plans to be open

for 5 days a week, full day, in-person instruction next year while following NYS guidelines on COVID19 safety.

"Siena Academy brings a successful educational model to the North Country," said Tina Taillon, retired educator and SCSA committee member. "Students will have a chance to learn about themselves and the world through a lens of Catholic tradition in a classroom that values a strong academic foundation. In a world of chaos, the school will be an oasis of loving calm, giving children a chance to be children. What they learn at Siena Academy, they will carry with them into the world, a sign of hope for the future."

Fr. Stephen Rucker, pastor at St. Mary's Church in Potsdam and SCSA committee member, expects the school to be successful. "It's wonderful news that Siena Academy is adding a second classroom. It's often the case that 'more begets more,'" Rucker said.

What kind of a message are these habitual offenders communicating to others?

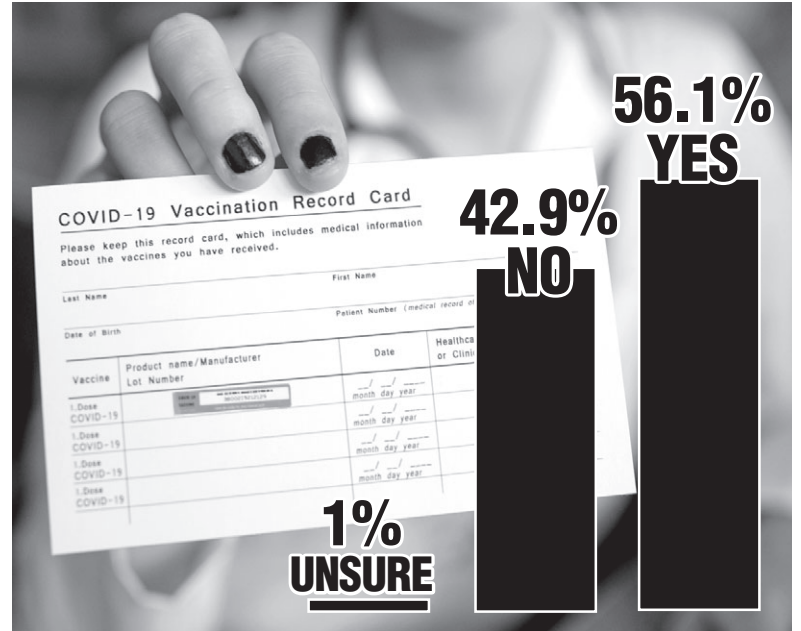
So, the next time you litter, ask yourself, why did I do that?

Students feed each other through food market

POTSDAM –Potsdam High School students are now operating a free food market, easily accessible to all high school students and their families.

Plans are also underway to expand the market to middle school this summer, offering healthy food including canned meats, cereals, and other nonperishable foods.

“The food market is for everyone in the school, of any economic background. There are no eligibility forms. We are destigmatizing the service, calling it a food market, not a food pantry,” said junior Maddie Wheeler, Positivity Club President.

The P2 Food Market is run by several high school members of the Positivity Club, and overseen by club advisor Dan Davis, and teacher assistant Lisa Boldt.

“We’re making it as friendly as possible, by making the food market anonymous,” said freshman Ali Grainger.

Food market manager Johannes Richter, a freshman, explained students or their families can place their food orders using a paper form or online each week using the high school’s website under the Student tab. Orders submitted by Thursday night are available for pick-up the next Tuesday in the guidance office.

“Mrs. Boldt assigns a number to each order received to keep it anonymous. I keep track of inventory and make out a weekly shopping list for Mrs. Boldt and Mr. Davis to buy food each week. Then club members put the requested food in numbered bags. Lola Buckley, Viola Partridge and I restocks the shelves,” said Richter.

High School Principal Mark Bennett presented the idea for the food market to the Positivity 2 Club, along with his \$500 personal donation to get it started. But he attributed the success of the program to the students. “It’s all the kids,” he said.

Advisor Dan Davis obtained additional start-up donations and supplies from Barstow Motors, J. E. Sheehan Contracting, Jake’s, Triple A Johnson Towing, Stewarts Shop of Potsdam, Price Chopper, Walmart, Dunkin Donuts on Maple St., Greg Lapinski, Sue

Waters, and Kat Pike.

St. Lawrence County Community Development reimbursed the market for food purchased the first few months to help start the program, but funding ended May 14.

“The club is seeking more donations to buy food the next few weeks until we begin getting food shipments from the Food Bank of Central New York,” said Davis. The school was recently approved as a nonprofit organization and will soon receive free food from the food bank, he said.

“Donations are also needed to purchase many hygiene products, which are not available through the food bank,” said Davis.

“The food bank will donate 40 boxes or more of food every two weeks, allowing the P2 Food Market to expand to middle school families starting this summer,” said Davis.

Future plans are to obtain grants for refrigerators and freezers so the market can also accept perishable food from the Food Bank of Central New York.

Student manager Richter credited the guidance and main offices for their help, along with

Mr. Davis for his advising and fundraising, Mrs. Boldt with her technology, and Mrs. Lisa Davis for help with signage. “They have been huge assets in helping us,” he said.

“The students running the P2 Food Market are incredible. I am inspired to support them because of how they care about their fellow students. It’s truly amazing,” said Davis.

“It’s nice the food market is so accessible for everyone in the school,” said student Lindy Betrus.

“The food market gives a great opportunity for students to provide food for their family,” said student Steph Andreescu. “We make sure the food is healthy food.”

The school’s food market is certified by the NYS Health Department and will provide healthy eating information to families.

“It’s so satisfying to see the program grow and help so many people,” added member Ali Grainger.

The Riverside Run features eight trails that allow you to enjoy a majority of your walk along the five major rivers of St. Lawrence County.

The trails can be short or long and although they make for a great walk, they can be enjoyed as a trail running challenge too. These trails stretch from the Crooked Creek preserve in Hammond on the St. Lawrence River, to the Stone Valley Trail on the Raquette River in Colton and on to the Moore Trail in Wanakena, along the Oswegatchie River.

Reenactment preview at Power & Equipment Museum

MADRID – On Saturday, May 22, at 1 p.m., a Civil War Roundtable will feature an in-person tour of Civil War Fort Tribute and a preview of the Reenactment Weekend on July 24-25.

This event is co-hosted by the St. Lawrence County Historical Association (SLCHA), and the St. Lawrence Power & Equipment Museum (SLPEM), where the event will be held. SLPEM is located at 1755 State Highway 345, Madrid.

Fort Tribute is a historical stockade fort built on the SLPEM property as a living tribute to nearly 6,000 St. Lawrence County residents who mustered in and fought in the American Civil War, 1861-1865.

Regiments included the New York 16th, 18th, 50th, 60th, 75th, 78th, 86th, 92nd, 93rd, 98th, 100th, 102nd, 105th, 106th,

142nd, 164th and 193rd Volunteer Infantry; 2nd, 6th, 11th, 12th, 13th, 16th, 18th, 20th and 26th Volunteer Cavalry; and 1st, 13th, 14th and 16th Volunteer Artillery.

The fort includes barracks, officer's headquarters, sutler store and a parade ground with a flag pole as its center piece.

The 2020 Civil War Reenactment Weekend was cancelled due to the COVID pandemic.

Norwood-Norfolk grad saves child's life while on duty

NORWOOD -- A Norwood-Norfolk Central graduate saved a child's life while on the job as U.S. Customs and Border Protection (CBP) officer.

Spencer Warner, who works in Baltimore, was inspecting a plane headed for Jamaica shortly before 12:30 p.m. May 5 when a pilot told him a child on board was unresponsive.

"My partner and I took off running," he said.

When he arrived on scene he was handed the limp body of an 8-month old boy.

As Warner began CPR on the baby, the child's mother was "extremely distraught" in the background, Warner said.

The child had no visible pulse and was not showing signs of breathing, he said. After about 10 chest compressions, the child took a gasp of air.

"That was a huge sigh of relief," the hero said. "

About a minute later a pediatric nurse arrived on scene and took over. She believed the child was having a seizure, Warner said.

Fire and rescue personnel arrived a short time later and rushed the baby off to the hospital.

Warner, who is father to a two-year girl, said this is the first time he has had to use his life-saving training in a real situation.

"You hope you never have to use training like this ... it was very scary," he said. But thanks to his training he was able to save the child's life.

Warner is the son of Norwood Mayor Tim Levinson, and Shelley Warner-Levinson.

"We are very proud," Warner-Levinson said.

Receives 125 cards for 90th birthday

CANTON -- Walking into Lucia Johnson's apartment in the Assisted Living wing of United Helpers Rehabilitation and Senior Care in Canton, one can't help but to notice the unique décor on her walls.

There are funny cards and serious cards, religious cards and heartfelt cards, many even from strangers, on display. Some of the cards contain handwritten notes, while others just have a signature, but they all say one thing, "Happy Birthday."

Mrs. Johnson turned 90 years old on Tuesday, April 13.

"So far I've received 125 cards," Mrs. Johnson said. "I don't know what to do with them all, but I have read each one."

In addition to birthday cards, there are a couple of other items plentiful in her apartment, recipes and poems.

"I worked as a field editor for Taste of Home for 10 years or so," she said, adding that over the years she's had several of her own recipes published in the magazine. "If you go online, you can find my picture and some of my recipes there." (see recipes at end of article)

"I'm full-blooded Italian, so you know that means I love to cook," she said, noting her maiden name

is Catanzarite. "Whenever we had guests or friends over I would always make something I had never made before."

Mrs. Johnson even noted she's self-taught in the kitchen. "My mother had six children, and she never wanted us in the kitchen while she was cooking, so I had to learn on my own," she said. "I think I did alright."

As for the poetry, Mrs. Johnson published a book of her poems as a fundraiser for the Alzheimer's Association, raising over \$500 through sales of her book. That's only a drop in the bucket though when considering that with three of her daughters, Marilyn, Stephanie, and Charlene, the family has raised more than \$50,000 for Alzheimer's research.

"That's something we're very passionate about," she said. "My husband Leon passed away from that."

Prior to moving to Assisted Living just over a year ago, she lived in Massena, where she was born and raised. "I lived there my whole life, until I came here," she said. "I love it here though, everyone is always so nice."

Mrs. Lucia said she's not planning to go anywhere anytime soon. "I had an Aunt who lived to be

108," she said. "Her mind was fine all the way to the end. We used to love to hear her tell stories about Italy, because she grew up there."

Mrs. Johnson also said that history was also a popular topic of conversation with her aunt. "She remembered when the Titanic sank and she would often tell us about that or other major events from her lifetime," she said.

Now Mrs. Johnson is the one telling stories, looking back at an incredible life full of accomplishments, and changes in the way we live that no one could have ever imagined when she was growing up.

"One of my daughter's wanted to post something on Facebook as a way to thank people for all of the cards. She asked me what to write. "I told her to say, 'I had a wonderful 90th birthday,'" Mrs. Johnson recalled with a laugh.

Emily Russell was honored for her story, "Fastest Known Time," which focused on competitive runners in the Adirondacks and their pivot to setting speed records when the Covid-19 pandemic forced the can-

cellation of organized races.

"Our news team leaned in for deep and subtle reporting about race and policing in the North Country immediately after the protests surrounding George Floyd's death began last summer," said David Sommerstein, NCPR's Director of News and Local Content. "And Emily Russell continues to explore sports and outdoor recreation in the Adirondacks in unique and subtle ways. These competitive awards are a tribute to the incredibly hard work of our news team during this unprecedented year."

The stories were honored in RTDNA's Region 11, which includes radio and TV stations in New York, Pennsylvania and New Jersey.

They are now under consideration for National Murrow Awards, which will be announced later this year.

"This past year has probably been the most difficult and complicated year our reporters will ever know — both for the stories they covered and the circumstances in which they worked," said Mitch Teich, NCPR Station Manager. "I'm so glad their stellar work was recognized and honored."

New round of EIDL funding available

The U.S. Small Business Administration launched a new round of Economic Injury Disaster Loan (EIDL) assistance called Supplemental Targeted Advances on April 22, 2021 that will provide \$5 billion in additional assistance to 1 million small businesses and nonprofit organizations that have been most severely affected by the economic effects of the COVID-19 pandemic.

The Supplemental Targeted Advance program is the latest SBA relief program to launch as part of the American Rescue Plan Act on March 11, 2021, said a press release from the organization.

The SBA's Supplemental Targeted Advance program aims to reach those businesses with 10 employees or less who need our help today, said SBA Administrator Isabella Casillas Guzman.

SBA also announced on March 12 that the agency would extend deferment periods for all disaster loans, including COVID-19 EIDLs, until 2022 to provide more time for businesses to build back.

Effective April 22, 2021, the SBA modified the Tar-

geted EIDL Advance application process to determine if businesses also qualify for the additional \$5,000 Supplemental Targeted Advance. SBA will contact eligible business entities to apply and applications will be processed on

a first-come, first-served basis.

To qualify for the Supplemental Targeted Advance, an eligible business entity must be in a low-income community, suffered greater than 50 percent economic loss, and have 10 or fewer employees.

Section 2. Twelve (12) and thirteen (13) year old licensed hunters shall be allowed to hunt deer, under the supervision of a licensed adult hunter, age 21 years or older, with a rifle, shotgun, or muzzle loading firearm in areas where and during the hunting season in which such firearms may be used. Section 3. Twelve (12) and thirteen (13) year old licensed hunters shall be allowed to hunt deer under the supervision of a licensed adult hunter, age 21 years or older, with a crossbow during the times when other hunters may use crossbows. Section 4. Supervision of a licensed adult hunter, age twenty-one (21) years or older, with at least three (3) years of experience who exercises dominion and control over the youth hunter at all times is required. Section 5. All licensed twelve (12) and thirteen (13) year old hunters as well as their adult supervisors shall be required to wear fluorescent orange
