Democratic petitions

CANTON - Petitions filed by Democratic candidates for the 2021 town

election have been disqualified, and the resulting caucus now required leaves a door open for another Democrat candidate for town supervisor.

According to the county Board of Elections, objections to petitions filed by Democratic candidates were filed by Bonnie St. Denny recently. According to section 6-108 of state Election Law, a town of Canton's size requires party nominations of candidates to be made at a caucus, not by petition. Denny's objection was upheld which caused the petitions to be disqualified, sparking a caucus to decide the nominees for the party.

The county Board of Elections said that the deadline to file a certificate of nomination from a caucus is July 22.

The Canton Democratic Committee endorsed the following slate of candidates who had filed petitions on March 25: Supervisor, Mary Ann Ashley; Town Clerk, Karin Blackburn; Town Council, Dave Nelson and Jim Smith for two fullterm seats and Martha Foley Smith for the two-year unexpired term. Those candidates will now have to be approved at a Democratic caucus open to all registered Democrats residing in the town.

POTSDAM – A recent gathering aimed to call attention to sexual harassment and sexual assault on SUNY Potsdam's campus raised criticism of how they were handled by the college.

The rally included calls for change and included signs that said "Me Too" and "Sexual Assault@Crane."

Among those in attendance was Jaiden Widdall, a former student who attended Crane from Aug. 2020 to Jan. 2021. She says she experienced sexual harassment from a professor while attending classes there.

In email exchanges with North Country This Week she raised concerns regarding the Title IX process she went through after reporting the incident and was troubled by what she says were efforts by the college and faculty to keep her quiet about her experience.

incident, though she says that person has since retired from the college.

Other students reported similar concerns to North Country This Week, but wished to remain anonymous due to fear of repercussion or damage to reputations.

Some complaints alleged, though not verified by North Country This Week, that reports they made to university police did not result in action due to lack of evidence.

"I am a junior at the Crane School of Music at SUNY Potsdam. I would prefer to stay anonymous, as I fear that speaking up will wreck my reputation at this institution and could have severe consequences on my academic life and career," one of the students said.

St. Lawrence County school officials are making plans to bring back more students following revised New York State Department of Health COVID-19 guidance for schools. Any changes will involve discussion with school boards and other stakeholders.

On Friday, the NYDOH released updated guidance that would allow schools to reduce social distancing between students in the classroom from six to three feet with certain protocols in place.

"Following the updated guidance from the CDC, we have been expecting the change in social distancing and have been working with staff and parents to plan for changes this school year," said Potsdam Central School Superintendent Joann Chambers.

Allowing more students to attend in-person instruction has Norwood-Norfolk Central School Superintendent Jamie Cruikshank excited.

"I am very pleased that the DOH has changed their guidance and is now adopting the CDC guidelines," he said.

Rep. Walczyk concerned about long-term effects of state budget

New York State's record-breaking \$212 billion budget sends a lot of money to a lot of places that need funding, but Assemblyman Mark Walczyk, R-Watertown, questions the long-term impact of increasing spending by \$36 billion in a single year.

Weeks before the budget passed, Gov. Andrew Cuomo warned of a \$16 billion gap, then \$5 billion in new revenues were

found and the federal government bolstered state coffers to the tune of \$28.5 million.

The end result?

New York lawmakers went into the budget season with a massive gap and increased overall spending by nearly 25 percent.

The budget includes a \$29.5 billion injection aimed at making good on a judge's ruling that school spending should be equitable and fair, though there is no guarantee that it will continue in years to come.

It also moves massive funding to public and private green economy initiatives, invests in affordable broadband to assist low income families, and earmarks \$1 billion toward small business assistance.

"Do I like anything in the bud-

get? Of course. If a family goes out and maxes out three credit cards for Christmas, it's going to be a good Christmas, but what's that mean for the next three years?" said Walczyk.

SAM Grants

Walczyk said the budget contains loads of pork and pointed to State and Municipal (SAM) funding grants as one of the largest examples.

The budget sets aside \$385 million in new funding for grants that are largely based on politics, according to Walczyk. That's because funding isn't distributed by need or overall interests of the state, but instead is allocated to members and districts based on political affiliation and seniority. The members then choose

which projects to fund and party leaders and the governor ultimately determine the fate of SAM grants.

Walczyk says SAM grants generally serve good purposes. They can help fund projects like salt barns, recreation centers and fire hall rehabilitations that might otherwise fall into disrepair.

But Walczyk says the funding tends to be disproportionate, with huge disparity between who gets what money based solely on seniority and party affiliation.

"Why would people in this senate district be valued less by the state simply because there are more senior members elsewhere? It's inherently political," he said.

Walczyk said the grants can often manipulate the relationships between reps and the people they represent.

"A town board member might be less likely to criticize a legislator when they are hoping to get funding for a program," he said, adding that they have the potential to impact legislative races.

Bullet Aid

Another "pork" program is bullet aid, which is distributed to party members based on seniority and party affiliation rather than need. While Bullet Aid can be very helpful as it provides no-strings direct revenue boosts to schools or libraries, but Walczyk says the aid is again based more on politics than actual need.

He says Bullet Aid, like SAM grants, can and is put to good uses, but again it is funding assigned to members to use, not distributed equally or based on need.

Walczyk says this sets up the same dynamic as SAM grants between constituents and representatives. But he says when it comes to school aid, it can be viewed as a direct conflict with the Campaign for Fiscal Equality ruling. That ruling required the state to fund schools in a formalized equitable manner, something the state has failed completely at doing until this year, despite a 2007 court order.

Walczyk says that when schools are underfunded bullet aid under-

mines any concept of equitable funding.

General 'Pork'

Walczyk said that aside from SAM grants and Bullet Aid, the record-high spending plan also contains pork spending for some more defined items like \$4.6 million for the Buffalo Bills, \$108 million for the Kingsbride Armory and even money to help with building improvements for a yacht club.

Walczyk said the budget contains even more ambiguous wording for which he was unable to even know where the lumps of money were going.

"Some of this stuff is not enumerated. You just see a price tag for a municipality or organization or non-profit and if you ask what it's for they say we are still working on that," he said.

The Budget

Walczyk said that while he is glad to see schools get a boost in aid, he is fearful it will be a temporary shot-in-the-arm rather than a permanent fix.

He said the runaway spending in this budget was exacerbated by a unique dynamic created by Cuomo's impeachment investigation.

He said in a typical budget year, the governor presents a budget that comes in on the low end and trusts that some of the funding will be restored. This is often the case for things like school aid, which traditionally gets a major boost in the final budget.

"He'll cut programs that he knows the legislators are going to restore. This year, you'll see the governor's cuts weren't as deep, because he couldn't afford any more political hate," said Walczyk.

Walczyk says that traditionally the legislative majority goes into a budget conversation trying to get as much as their members are asking for and "traditionally you have the governor and comptroller there to say, 'let's be realistic'." But Walczyk said that didn't happen this year.

He said that Assembly Speaker Carl Heastie has the votes right now to impeach the governor if he wants to and having that dynamic going into the budget season stopped Cuomo from "being the adult in the room."

CANTON — The town board passed a budget amendment to increase the town code enforcement officer salary recently.

At their meeting April 8, town board members opted to increase the salary by \$10,000 to \$53,375 per year.

Traditionally, the position of code enforcement with the town would have covered both town and village code issues, with the village sharing the cost of the salary.

After the recent departure of Code Enforcement Officer Jeff Murray, who left to take a code enforcer position with the town of Potsdam, the municipalities decided to each field their own CEO instead.

The town recently hired Miranda Corbine, a former Canton Central graduate, to take over the position on a provisional basis starting April 12 at the \$53,375 annual salary.

Awareness raised for sexual assault

CANTON -- Just days prior to a local rally aimed at raising awareness about sexual harassment and assault, St. Lawrence County designated April as Sexual Assault Aware-

ness Month. The goal is to raise public awareness about sexual violence and to educate communities and individuals on how to prevent sexual violence.

"Sexual harassment, assault and abuse can happen anywhere, including online spaces, and as we connect online we can learn how to practice digital consent, intervene when harmful content or behaviors are seen, and ensure that online spaces- whether they be workspaces, classrooms, social media platforms, or otherwise – are respectful and safe," the resolution says.

The resolution came not long after a local teen took his life after following victim to an online extortion scam in which the scammers exchanged elicit photos with the teen then blackmailed him for money after acquiring photos in return.

Just days after the resolution passed, protestors rallied calling on SUNY Potsdam to improve handling of reported sexual harassment and assault incidents at the campus.

The resolution notes that "sexual assault is a serious and widespread problem and St. Lawrence County can highlight sexual violence as a major public health, human rights and social justice issue and reinforce the need for prevention efforts by working together to educate our community about sexual violence prevention, supporting survivors, and speaking out against harmful attitudes and actions."

Legislators encouraged all citizens of the county to join advocates and communities across the country in playing an active role to raise awareness to help prevent sexual assault.

More responses sought for internet survey

Over 1,500 residents and businesses have responded to the St. Lawrence County broadband survey so far, but more responses are being sought to ensure a clear understanding of the locations that are unserved or underserved by broadband access.

In particular, more responses are needed from the towns of Louisville, Waddington, Madrid, Gouverneur, Norfolk, Hopkinton, Edwards, Fowler and Oswegatchie, although additional surveys from all towns are welcome, according to the St. Lawrence County Planning Office.

The survey can be taken from any computer or mobile device, including a smart phone, at this link: www.stlawrencecountybroadband.com. St. Lawrence County and the Development Authority of the North Country partnered on the project, which will allow the data to be mapped to determine where the needs are. The information will be used to collectively develop an action plan to address those needs, planning officials say.

The broadband survey is tailored to ask questions pertinent to homes and businesses both with and without access to broadband.

Respondents need to enter an address and indicate whether it is for a home or business and will then proceed to a survey designed to collect information on the demand for services unique to their location.

So far, more than 11 percent of respondents have reported that they have no internet access. Of those who do have access, 34 percent report that they are not able to purchase the speed they need.

For those without internet access, public access to a computer is often available at local libraries. The St. county Planning Office can also assist those without internet access at 315-379-2292.

Local hydro project starts

POTSDAM – Hundreds of local customers, including Meadow East Apartments and Paul Smith's College, have started receiving locally-sourced electricity through the Sissonville Community Hydro Project.

The Sissonville project, over a year in the making, is now the state's largest local renewable energy initiative, according to Northern Power & Light.

In the coming year, 15,000 MWh of electricity generated on the Raquette River at the Sissonville hydroelectric facility will be sold to subscribers in surrounding communities, according to a press release

from Northern Power & Light.

The project by Saranac Lakebased Northern Power & Light and Boralex Hydro is part of a state program called Community Distributed Generation, which allows customers to purchase their electricity directly from local power producers.

"Through this initiative, providers retain more of the value of the electricity they make, and customers served by National Grid can connect directly to local sustainable electricity at no additional cost. Currently only 10% of National Grid customers choose to receive renewable electricity," the release said.



CANTON - A community-driven effort to rehabilitate the busted boards and crumbled surface of the outdoor ice rink next to the Canton Pavilion into a multi-use space is underway.

The rink, which hasn't been used actively for a few years, has seen better days. Holes smashed through the sideboards are the most obvious maintenance on the list, but a host of other work needs to be done there as well. An all volunteer group has decided to tackle the work and revive the rink for year-round use.

Tim Abplanalp who is organizing the effort to bring the space back to life says the rehab work is going to require a good deal of fundraising. "Just for the (main) stuff we plan

to do, we're looking at \$40,000, maybe more," he said.

However, an anonymous local donor has agreed to commit \$20,000 to the effort, Abplanalp said.

Abplanalp said fundraising is being run through Canton Minor Hockey which has non-for-profit status, but the rink will be a must-use space available all year round.

"Right now we are planning a lot of different things," Abplanalp said. "It would be cool to have a food truck night (at the pavilion on Lincoln Street)."

Other ideas include a benefit lacrosse tournament. The group will be looking for corporate sponsors, local organizations and community members to raise money for the effort as well.

He said while the space has traditionally served as an outdoor rink for local hockey and skating, the focus now is on multi-use. The grass-roots group working on the project plans to add basketball courts and have the space open

for roller hockey, box lacrosse and skateboarding as well.

Busted rink board needs replacement

Bringing the old rink back to life was put forth on an earlier community survey circulated by the Canton recreation department, said Village Mayor Mike Dalton. Canton Village Trustee Carol Pynchon said the idea originally was maybe to turn the space into a dedicated outdoor skatepark (the village is still interested in exploring that idea at another location in the future, Pynchon said).

Abplanalp said rehabilitation and maintenance of the outdoor rink came up again at one of the recent **Reimagining Canton Recreation** meetings he attended.

"I was part of the generic crowd. I opened my mouth and somebody said, 'Well go ahead and do it if you want." Abplanalp said.

One of the most obvious needs at the rink are new boards, with higher backsplashes to keep play on the court/rink.


"We hope to keep the metal and put some new boards on, but it will need some realigning," he said.

He said he hopes to have some of the funds raised by May to get work started. Abplanalp said they would like to be able to approach manufacturers with around \$10,000 to order the sideboards by then.

Abplanalp welcomes help and suggestions from the community on the project as well.

"I'm up for suggestions on fundraisers or suggestions on what they would like done," he said.

Building permit for LC Drives facility okayed

POTSDAM — The town planning board has approved a building permit for a 30,000 square foot manufacturing facility planned by electric motor developer LC Drives on Route 56.

However, the company will not be breaking ground on the new plant unless the state opts to invest in the project and a future expansion into a 150,000-foot facility at the site.

An LC Drives manufacturing facility there is expected to employ up to 500 people.

LC Drives has been courting the state for an investment of up to \$50 million since 2019, but the 2020 pandemic seems to have stalled progress on that.

The planning board met Tuesday, April 6 and held a public hearing on the company's proposed building project before approving it. "The town has been incredibly supportive," said Devon Sutton, LC Drives Director of Strategic Operations, told North Country This Week.

Sutton said, however, that the project is going to need participation from the state and investment before the company could begin construction at the site.

LC Drives, currently based in the Clarkson University incubator complex in Damon Hall and Old Main in downtown Potsdam, produces a new form of electric motor, which the company says is in high demand. The motors are especially applicable in the marine industry and renewable wind energy sector.

In an earlier conversation with the paper, Sutton had said LC Drives was looking at other options for locating their new manufacturing plant out of state, if New York opted out of getting involved.

"(But) we really have enjoyed doing business here, we have

momentum here," Sutton said.

Now that the state is opening back up economically following the pandemic, the company is hopeful of reopening negotiations with the state to secure investment in the expansion.

LC Drives has had \$15 million in investment from Koch Engineered Solutions, several hundred thousand dollars in grants and access to loans from the county IDA and the town of Potsdam recently approved the formation of \$10 million water and sewer districts which would service the Route 56 site and supply the company with services.

The approval by the planning board of the 30,000 square foot facility on Route 56, which would be an interim facility until a larger 150,000 square foot building can be constructed at the site, will allow LC Drives to consider designs, but a groundbreaking waits on the state.

"We are excited for them to come back to the table," Sutton said.

Childcare center being planned in Ogdensburg

OGDENSBURG – The Ogdensburg Bridge and Port Authority is looking into building and operating a childcare facility on the Commerce Park grounds.

A new committee met Thursday, March 18 to start that process. It includes chair Toni Kennedy and board member Nichole Terminelli. 'Both members have young children at home and understand the difficulties involved in working a full-time job and the care of young children," OBPA said in a news release. "Such a facility will help provide a need for St. Lawrence County families." While it was the first meeting of this committee, the timetable for such a facility seems to be anywhere from 18 to 36 months, according to OBPA. The next meeting should occur within the next two weeks and an established child-care organization will be invited to provide committee members with additional information. During a visit to Ogdensburg last year, Senator Kirsten Gillibrand urged Congress to create a \$50 billion Child Care Stabilization Fund, through the Child Care is Essential Act to combat the growing child-care crisis.

Mother of Lisbon girl who committed suicide speaks out

LISBON - When Rosemarie Maneri read the story of a recent teen suicide in Potsdam that was sparked by an online blackmail, the similarities to the death of her foster daughter were striking.

Shylynn Dixon, 18, of Lisbon took her own life on March 3 after what appeared to be an ongoing online harassment and blackmail for a year and a half, Maneri said.

The case is still under investigation by State Police, but Maneri said an unknown party on Facebook had convinced the girl a year and a half ago to send them suggestive photos of her. The blackmail started after that, with requests and then threats for more photos, until she blocked the individual on Facebook. Then the blackmailer made good on their threats and Shylynn's friends received messages from the profile that was harassing her. She took her own life soon after that.

Due to the case involving a suicide, and that it is currently active, State Police could not comment on specifics of the investigation, said Trooper Jennifer Fleishman, State Police spokesperson.

However, Fleishman told North Country This Week that the Dixon case and the Basford case shared some similarities.

"It was very similar to what happened to Riley (Basford of Potsdam)," Maneri said. Basford took his own life on March 30 after he was blackmailed and harassed online for suggestive photos.

"She was always smiling, always happy," Maneri said. "We didn't find

out until she left a note."

"She was just pushed to the limit ... It was an absolute complete shock," Maneri said.

"She left a note, went upstairs into my bathroom, took one of my guns and shot herself. There are no words to describe what goes through a mother's head. The phone call was something I will never ever forget," she said.

Maneri said Shylynn's family learned what was really going on, unbeknownst to them, after speaking with investigators who had reviewed Shylynn's phone.

She said it was just a name online, on Facebook. Maneri said they started following the man's profile and by the Friday after Shylnn's death he had just disappeared. She said investigators said they believed the profile was connected to someone in Pakistan.

Shylynn had lived with Maneri as her daughter for the last year and a half, had been a part of her family for the last five years, and was thought of as a sister to Maneri's birth daughter. She had just turned 18 this year and seemed to have a happy, well adjusted life.

Maneri said it appears that the harassment and blackmail had started about a year and a half earlier.

Maneri cautions parents with children online to be wary, and has strong words about social media.

"Facebook needs to be shut down. Facebook is the worst thing that was ever put up," Maneri said.

According to Maneri, investigators said foreign parties obtain photos through social media accounts from unwitting teens by posing as other teens online. They then take the photos and sell them on the black market where they are then purchased by online pornography sites.

State Police recently released information for parents on how to protect their children from this type of online extortion from unknown operators on social media sites.

Tracking down perpetrators in cases like these can be difficult and take time. In this case, Maneri said State Police are still waiting on a warrant to be able to access Shvlynn's Facebook account so they can get the IP address of the blackmailer. "It's absurd," she said.

Investigators told her at the time of the death, that Shylynn was not the only child this was happening to and investigations are happening in other states as well and that Homeland Security was involved.

While they could charge the blackmailer with extortion if they locate them, Maneri said the charge really should be murder.

Jeff Domanski, community choice aggregation (community solar) specialist, of Hudson Valley Energy, talked about how such programs might fit with Canton's overall sustainability goals at the April 6 meeting.

The village, like other local municipalities including the Town of Potsdam, is researching ways and companies to set up community choice aggregation to allow local residents to participate in what is essentially a buyers club for renewably generated electricity. Through the program, municipalities contract with companies which handle the administrative side of the buyer's club on behalf of the town, managing bids and contracts for energy purchases and working with community solar suppliers and National Grid, and designing how the program will be set up. In the town of Potsdam, the

'This is a program by which you can get a win, win, win scenario, three wins, for electricity supply, with the focus for us on renewables, promoting renewable supply on the New York State Grid," Domanski said at the April 6 meeting. .

Domanski explained that since deregulation of energy companies in the 1990s, National Grid merely serves as transmission services to power generated elsewhere. Domanski said that since deregulation, individual customers can go into the supply marketplace and source their individual electricity supply, either for cost savings, or to obtain power from a renewable source through the distribution network.

He said that a recent survey indicates that 76 percent of people want renewable energy. And, in 2016 the state enabled the formation of CCA networks for electricity customers in the state as a means to purchase that renewable energy as a group at

default energy supply decision is made. Without CCA, individual electricity customers can choose from where the energy they consume is supplied, whether renewable or not. However, if they do not make the choice, then National Grid makes the default decision. With CCA, the local community under the program can make the default decision to pick renewable sources.

CCA programs need to be approved by the state Public Service Commission before they are implemented.

Canton's municipalities are expected to discuss the idea further at upcoming meetings.

At the next village board meeting on April 21 there will be a public hearing at 6:20 p.m. on the first step of the CCA process, a resolution enabling the village to begin the process by gathering information both for the board and public on how CCA would operate and impact the community.





Superintendent Chambers said school officials plan to reconvene the reopening committee that met last summer to review the new Department of Health guidance and update the reopening plan, which will be posted on the district website.

"We've discussed anticipated changes with the Board of Education and hope to present our revised plan at the April 19 Board of Education meeting," she said.

Chambers said it expected that kindergarten students would return to full-day programming. To accommodate this, the school plans to hire an additional teacher to reduce class sizes.

"We also expect to combine the two middle school cohorts to return students to in-person instruction four days a week," Chambers said. "We plan to continue the current model at the high school, but the change in social distancing will allow any remote student who is interested to return to in-person

instruction."

The Potsdam super said parents of remote students at any grade level who would like their children to return to in-person instruction should contact the building principal to make the necessary arrangements

Norwood-Norfolk Central

Although the guidance is new, NNCS and other districts have tried to be creative in bringing back more students for traditional learning.

"Throughout this school year our principals have been trying to bring as many students back to in-person learning as the guidelines allow," Superintendent Cruikshank said. "Each week they have been challenged to increase opportunities for our students to develop positive relationships with school; which is best done when students are physically here.

Cruikshank said it's the district's intention to safely continue to shift toward in-person learning this year. "We hope to bring as many students back to in-person learning as the health and safety standards dictate," he said.

The super has had preliminary discussion with the Board of Education on the CDC recommendations and has also provided parents and community members an opportunity online to speak with him.

"I imagine any change in our

plans would involve continued discussion with the Board and community," Cruikshank said.

NYSUT statement

"As educators, we know that the best place for our students to learn is in person in the classroom," said New York State United Teachers President Andy Pallotta. "What we've wanted from the very beginning of the school reopening process is for that to happen in the safest possible environment.

"In adopting new physical distancing guidelines in line with CDC recommendations, the state is making it crystal clear that distancing is only one part of a layered mitigation strategy. These revised guidelines not only draw distinctions between when it's appropriate to have three feet of distancing and when six feet of distancing is still necessary, they also mandate masks at all times and lay out specific ventilation recommendations while maintaining important provisions for cleaning, hygiene and contact tracing. What's more, the guidelines are clear that community transmission - with a majority of New York counties currently at high levels of transmission, per CDC metrics - is a critical factor in how physical distancing changes are implemented. And before districts make changes, school communities, including parents and educators, must be given an opportunity to provide input on updates to reopening plans. That has always been and must continue to be essential to the reopening process."

ASSAULT...

That student expressed concern that incidents aren't being taken as seriously as they should be.

In response to the protest SUNY Potsdam President Kristen Esterberg released a statement saying the college would do better.

"I have received a number of messages in recent days from students, past and present, regarding their experiences with sexual harassment and assault on campus. I want you all to know that I have read your words, and I take them to heart, and at my direction, we will launch an immediate, and thorough investigation of all past reported incidents of sexual harassment and assault," she said.

Esterberg said the investigation is needed to ensure that every incident reported to the campus was thoroughly reviewed, investigated and if warranted, referred to local law enforcement authorities for further action

"It is not easy to share such personal and painful stories. We respect and appreciate each of you for your efforts to raise awareness about these issues and make our campus community safe. Your safety and well-being are of the utmost importance. I deeply appreciate each and every one of you. Please know that we hear you and will do all that we can to ensure that we better serve and support every member of our campus community," Esterberg said. "No one should ever feel alone, intimidated, or ignored after reporting an incident of sexual harassment, sexual assault, bias or any other violation, which is why we need to conduct this further review of all past cases to provide confidence to all those who reported incidents that every incident was thoroughly reviewed. To anyone who has ever felt this way: We are deeply sorry, and we pledge to do better." Esterberg says that the college does address all issues reported incidents, but added that they must also comply with union protections when doing so.



Heating, Ventilation, Air Conditioning/ Refrigeration

The HVAC/R program prepares students to apply technical knowledge and skills to install, service, maintain and repair the operating condition of heating, ventilation, air conditioning and refrigeration systems.

The curriculum includes instruction in diagnostic techniques; the use of testing equipment and the principles of mechanics, electricity and electronics as they relate to those systems.

Students will learn how to work safely and effectively in the field of HVAC/R as an entry level technician.

Earlier in March, junior students at Northwest Tech Center worked on wiring smoke detectos and ceiling lights in the mock house at the center, while other students worked practicing with copper piping skills.

The senior class at Northwest Tech Center had a presentation from the United Association Plumbers, Steamfitters & HVAC/R Local 81. Marcus Williamee and Aaron DeBolt gave the students some insight on the actual jobs they could be performing when they are fully trained.

The two-year HVAC program is offered at the Northwest Tech Center in Ogdensburg, and the Seaway Tech Center in Norwood.

How to bring bees back

Bees, birds and butterflies play integral roles in pollinating many of the crops humans rely on for sustenance.

The National Pollinator Garden Network, through the National Wildlife Federation, recently launched the Million Pollinator Garden Challenge, an effort to increase the amount of nectar and pollen food sources as the organization aims to reverse the alarming decline of pollinators such as honey bees, native bees and monarch butterflies.

Many people are afraid of bees because of their propensity to sting. Unlike their wasp and yellow-jacket cousins, honeybees and bumblebees are much more docile and content to hop from bloom to bloom without paying humans any mind.

The only time such bees may resort to stinging is if someone inadvertently steps on them.

Bees are beneficial for yards. Gardener's Supply Company says one out of every three bites of food humans take depends on a pollinator.

That's because about 150 crops grown in the United States depend on pollinators.

Even though there are 4,000 species of native or wild bees in the continental United States, many populations are in decline.

No-till/Interseed progam

 ${\sf CANTON-The\ St.\ Lawrence}$ County Soil & Water Conservation District (SLC SWCD) has disposed of their no-till grain drill last spring. To continue to offer assistance, they are offering a no-till/inter-seeder cost-share program to help offset the costs of renting or implementing no-till or inter-seeding methods by other means. The cost-share rate is \$19/ acre, for a maximum of 30 acres per accepted applicant. Alternatively, call their office at 315-386-3582 and apply over the phone. Applications must be received by April 23.

According to the Pollinator Partnership, various areas of North America have lost more than 50 percent of their managed honeybee colonies in the past 10 years.

Bringing these important pollinators back will take a little work, but it is possible.

• Plants that offer cover can be attractive to bees that desire a respite from the sun and heat. Coleus and other ground cover offerings can be handy.

• Offer water in shallow dishes, as even bees need a cool drink to stay hydrated.

• Bees like various plants, so plant more than one species. Some plants that bees tend to like include alyssum, aster, geranium, bee balm, poppies, and clover.

• When planting, include some native species.

• Brush piles, dry grasses and dead woods offer nesting areas for bees.

The Gardener's Supply Company also says that bees find blue, purple and yellow flowers most appealing. Opt for more of these hues when planning gardens.

• Above all, avoid using pesticides in the yard.

Even organic ones can be toxic to bees and other pollinators, and they may contribute to colony collapse disorder.

Look for size, color, behavior **Tips to identify blacklegged ticks**

Lyme disease poses a bigger threat to people living in certain areas than it does to others.

For example, the Centers for Disease Control and Prevention reports that the highest incidence rates for Lyme disease occur in regions including New England, the mid-Atlantic and the upper midwest. However, no one, regardless of where they live, is immune to Lyme disease.

According to the CDC, blacklegged ticks are the specific type of tick that causes Lyme disease. Nature enthusiasts might be surprised to learn that blacklegged tick bites also can transmit other diseases and infections, including anaplasmosis, babesiosis and Powassan disease.

Various types of ticks pose a threat to human health, but blacklegged ticks may inspire the most fear due to their connection to Lyme disease. Learning to recognize blacklegged ticks can calm those fears and increase the likelihood that homeowners can prevent tick infestations before they get out of hand. According to the pest control experts at Terminix®, the following are some characteristics of blacklegged ticks.

• Size: Blacklegged ticks are tiny. Nymphs can be as small as the size of the head of a pin, while adults measure one-eighth of an inch. This



size underscores the importance of conducting thorough examinations of your body and the bodies of your children after spending time in the yard. Inspect carefully, as ticks are so small that it's easy for them to go unrecognized.

• Color: Ticks are dark brown to black and have dark legs. It's easy to mistake ticks for freckles or moles. Look carefully if you notice any areas on you or your children's skin that seem to have a new freckle or mole.

• Behavior: Ticks need blood meals at each stage of life in order to grow. Though it's possible to find

ticks anywhere on the body, the CDC notes that they tend to seek out certain areas. Such areas include under the arms, in and around the ears, inside the belly button, the backs of the knees, between the legs, and around the waist. Ticks also can be found in and around all head and body hair, so it's vital that people ask someone to inspect the hair on their heads and use a mirror to inspect private areas. Parents should carefully check their children's hair and even insist that kids wear hats when spending time in the woods or yards where ticks have been found.

Pollinators are an important part of gardens

A thriving backyard garden requires homeowners to take steps to ensure the garden has the best environment in which to grow and thrive.

The right tools and components, including trowels, rakes, soil, amendments, and fertilizer, can help gardeners create beautiful spaces. It's also important that pollinators are made to feel welcome in the garden.

The United States Department of Agriculture reports that one-third of all agricultural output depends on pollinators.

The USDA notes that insects and other animal pollinators are vital to the production of healthy crops for food, fibers, edible oils, medicines, and other products.

Pollinators also are essential for maintaining habitats and ecosystems that many wild animals rely on for food and shelter.

The U.S. Forest Service says that, without pollinators, the human race and all of the earth's terrestrial ecosystems would not survive. Pollination done the natural way often vields large, flavorful fruits.

Pollinators are make-or-break components of large-scale agriculture, and they're just as important in private home gardens.

The Pollinator Partnership, an organization that works to protect pollinators and their habitats across North America, says pollinators include bees, butterflies, beetles, birds, and bats.

These animals travel from plant to plant carrying pollen on their bodies. The following are some ways to maintain healthy pollinator habitats.

· Consider the soil and types of plants that will thrive in it before choosing what to plant.

Fix drainage issues and plant with sunlight in mind.

· Vary the colors and shapes of plants to attract a greater array of pollinators. Plant flowers close to vegetable gardens to attract pollinators.

 \cdot Group plants together when planting to more effectively attract pollinators.

· Select plants that flower at different times of the year so that nectar and pollen sources are available vear-round.

 \cdot Whenever possible, choose native plants.

• Avoid the use of pesticides. · Provide a water source for pollinators, such as a shallow dish with stones half-submerged for perching

Addressing moss in the lawn

The first step to controlling moss is to test the soil. Soil test kits are inexpensive and available at most home renovation stores. Test results will reveal if the soil is lacking nutrients or if lime needs to be applied and when to apply it. Such a report also will indicate when to fertilize the lawn, which can help restore the turfgrass so it's more capable of competing with the moss.


If the underlying cause of moss is shade and/or moisture in the yard, homeowners can speak with landscaping professionals to discuss their options. Replacing existing turf with one that is well-suited to shade and/ or moisture may prevent mold from overtaking the lawn in the future.

Some turfgrasses may be best-adapted to shaded, well-drained soils, while others may be more likely to thrive in shaded, moist soils. A local landscaping professional can help homeowners find a turf that will thrive in the conditions in their yards, and also in their local climates.

CANTON — Spring leaf pick-up in the village began on Monday, April 5, and continue through Friday, May 14.

During the pick-up period, the village DPW crew follows a route that covers about 16 miles of village roads. Once complete they run the route again, following a system to ensure they cover all neighborhoods equally.

The crews will pick up brush, leaves, and grass bagged in paper bags, and they will chip and remove wood and branches under 6 inches in diameter.

Brush must be left in paper leaf bags, which are available at most of our local stores and are very competitively priced. The use of plastic bags has been eliminated because of the Village's recycling program; plastic bags will not be picked up.

The DPW will also do pick ups once a month - on the last Thursday of the June, July, August, and September.

Septic funding offered to SLC homeowners

Up to \$15 million in funding is available through the State Septic System Replacement Program to support homeowners in St. Lawrence County and other areas around the state.

The grants are the second round from a total of \$75 million provided to improve water quality and protect public health through the targeted replacement of aging and sub-standard septic systems and removal of cesspools in communities statewide, said a press release from the governor's office.

The program is a collaboration between the Department of Environmental Conservation, Department of Health, Environmental Facilities Corporation, and participating counties to administer funding to qualifying homeowners. The Septic Replacement Program improves water quality by encouraging and incentivizing homeowners' replacement of cesspools and failing or inadequate septic systems around a waterbody known to be impaired by septic system discharges.

DEC and DOH identified priority geographic areas in which property owners are eligible to participate based on the presence of a solesource aquifer used for drinking water, known water quality impairment linked to failing septic systems, and/or the ability for septic system upgrades to mitigate water quality impairments.

EFC will be providing detailed information about how to access the funding to counties with identified priority geographic areas. DEC and DOH will re-evaluate priority waterbodies in future rounds of funding.

New York State will provide funds to counties to reimburse eligible property owners for a portion of the cost of replacing cesspools and septic systems and installing more environmentally effective systems. Eligible property owners can be reimbursed 50 percent of eligible costs up to \$10,000.

Counties may also set graduated incentive reimbursement rates for septic system projects to maximize program participation and pollution reduction goals.

Retiring from SUNY Canton after 32 years

CANTON -- A dedicated educator, administrator and student advocate will be retiring from SUNY Canton following a 32-year career.

Molly A. Mott, Ph.D., who is currently the college's Associate Provost and Dean of Academic Support Services, announced her retirement beginning April 1, but she will continue working on a part-time basis as part of a bridge for the next year.

Mott's career has been marked by many firsts. She was the first Licensed Veterinary Technician SUNY Canton hired, working at the college's former farm on State Route 68 in Canton. She managed cows, sheep, horses, heifers, and the ever-important farm cats. She went on to create courses in animal behavior and the human-animal bond and was the recipient of the New York State Veterinary Technologist of the Year award. She received national attention as the cover story for the Veterinary Technician Journal. She was one of the first two instructors to develop and teach online courses at SUNY Canton and used videoconferencing to teach a behavior class to all technology sector colleges synchronously. Later, she became the college's first Director of Online Learning and the first Dean of Academic Support Services.

Most recently, she oversaw the college's Admissions Office, which notably has maintained enrollment goals and expanded higher education access amidst state-wide downward trends. According to Executive Director of Enrollment Melissa J. Evans, it's tremendously difficult to see a part of the college that Mott has not influenced.

As the senior administrator responsible for the Southworth Library Learning Commons, Mott helped transform the building into a learning space focused on access for all. Under her guidance, the library integrated an expanded tutoring center into the Learning Commons, positioning Canton as one of the first SUNY institutions to do so. All of these changes were made in an effort to expand the resources for students, faculty and the campus community.

Clarkson professor honored

POTSDAM -- Devon A. Shipp, a professor at Clarkson University has recently been recognized as a pioneering investigator by the Journal Polymer Chemistry, a leading peer-reviewed journal in the polymer field published by the Royal Society of Chemistry (U.K.).

Shipp is the Director of the Center for Advanced Materials Processing (CAMP) at Clarkson University and teaches in the Department of Chemistry & Biomolecular Science

He was invited to submit an article to polymer chemistry as part of the Polymer Chemistry 2021 Pioneering Investigators collection.

This collection gathers the very best work from mid-career researchers who have firmly established themselves in the field of with professor Patrick Mather of Bucknell University, enables self-healing, shape-memory and improved adhesive properties, and may find use in biodegradable biomedical devices.

The paper was co-authored by graduate student Kelly Tillman and undergraduates Rebecca Meacham, Mikenzie Barankovich, Anne Rolsma, and Ana Witkowski.

Shipp has been at Clarkson since 1999. He was chair of the Department of Chemistry and Biomolecular Science from 2015 until his appointment as CAMP Director in 2020.

He is an internationally renowned scholar and student mentor, his research has garnered multiple American Chemical Society

Bridge team in virtual contest

CANTON -- A group of SUNY Canton seniors from the Canino School of Engineering Technology have beaten the odds to enter the 2021 American Institute of Steel Construction (AISC) Regional Student Steel Bridge Competition.

The college was selected as a host school for the annual AISC competition in 2020, but the event was cancelled due to COVID-19. Rather than scrap their plans, the students have retooled and modified their entry for a virtual competition this year.

"Everything was shut down and our work went right out of the window when the pandemic hit," said Paul D. Hitchman, faculty mentor for the AISC student chapter. "This group of students' interest and familiarity with the bridge allowed them to take sole possession of the project and see it through as a small group."

Hitchman said this bridge was originally designed by students who have since graduated from college and have either started careers or are continuing their education toward advanced degrees. Part of the challenge included both deciphering the original design choices and adapting the original solutions to a compete in a bridge competition despite the hiatus and setbacks. "The team has proven themselves to be ready to compete and demonstrate what we can do even after being halted by the pandemic," he said.

In addition to Harris, Civil and Environmental Engineering Technology students who are participating in this year's competition as part of their senior-level capstone project are: Darren Leblanc of Brushton; Stephen J. Schermerhorn, Cicero; and Tristan L. Trombley, Keeseville. Other members of the 2020 team include: Jaden A. Caldwell, Canton; Benjamin P. York, Auburn; and Joshua E. Godbout, Lisbon.

AISC steel bridge entries come from colleges across the U.S. and are judged on a variety of factors, including strength, aesthetics, and construction speed. Speed has traditionally been the factor that helps the SUNY Canton team win. The student-led club has earned 15 first place finishes in about 25 regional competitions. The college landed a first-place finish in both the regional and national competition in 2009. In 2018, the college picked up a second-place win at regionals and a ninth-place finish at nationals. The steel used to construct the bridge was donated by 1991 alumnus Eric S. Tessmer, who owns Riverside Iron, LLC, Gouverneur. The team also receives support from the College Foundation and the president's office.

According to Associate Professor Adrienne C. Rygel, Ph.D., the students are submitting the bridge as their senior-level capstone project in the Civil and Environmental Engineering Technology program.

The first of three phases required to meet their assignment, and to fulfill competition requirements, was to submit a competition proposal due in February. The second phase is to record themselves constructing the bridge under the watchful eyes of an impartial judge. The team is planning to complete the second phase during the week of March 30 in preparation for an April 1 deadline. The final phase will be to take what they've learned and develop a new and improved design.

Dale R. Harris of Dundee is one of the four senior-level students to take the lead on the steel bridge entry, said he told his fellow graduating classmates from the AISC team that he strongly believed they could still

Breaking ground for new McDonald's

CANTON - A new McDonald's Restaurant may open as soon as August in the Price Chopper parking lot.

Construction crews began work this week for the 4,400 square foot facility, and local dignitaries were on hand for the official ground-breaking took place this morning.

"This is important to us. We've been waiting a long time," said Mayor Michael Dalton. "We're tickled to see you here and having McDonald's coming back."

The original Canton McDonald's at 64 Main St. was closed in 2015 by McDonald's Corporation due to "underperformance" due in part to a lack of a drive-through window. It was one of more than 100 restaurants shuttered for similar reasons that year.

Plans for the new McDonald's at 111 East Main St. were first pro-

posed back in late 2014 but the project never moved forward until 2019, when plans were approved by the St. Lawrence County Planning Board

On hand this morning were Mayor Michael Dalton, Supervisor Mary Ann Ashley, Mayor Michael Dalton, and other village and town officials, along with owner Paul Ross, Brandon Cora, area supervisor for McDonald's, and Al Burgazoli, construction manager for the project.

Burgazoli and Ross said the

new restaurant will "have all the bells and whistles," including kiosk ordering, a double drive-through and an outdoor patio. The building will take the same modernistic style of many recent McDonald's overhauls.

Ross said the \$3.5 million facility is expected to employ 65 to 75 people. The site plan describes the building as being 22 feet high, with 30 parking places, built on 0.936 acres. It is in the southwest corner of the 7.48-acre Price Chopper lot, with Mountain Mart to the west and Monroe Muffler to the east.

Access to the site will be through the existing entry to the Price Chopper lot off Route 11

During peak a.m. hours, the new restaurant is expected to draw about 200 vehicle trips through the dual-lane drive-through according to the site plan presented to county officials in 2019.

The building itself will have more than 87 seats, the site plan indicates.

SUNY Canton engineering students beat the odds

CANTON - A group of SUNY Canton seniors from the Canino School of Engineering Technology have beaten the odds to enter the 2021 American Institute of Steel Construction (AISC) Regional Student Steel Bridge Competition, said a press release from SUNY Canton.

The group of students includes St. Lawrence County residents Darren Leblanc of Bruston, Jaden A. Caldwell of Canton and Joshua E. Godbout of Lisbon.

The college was selected as a host school for the annual AISC competition in 2020, but the event was cancelled due to COVID-19. Rather than scrap their plans, the students have retooled and modified their entry for a virtual competition this year.

"Everything was shut down and our work went right out of the window when the pandemic hit," said Paul D. Hitchman, an instructional support associate and faculty mentor for the AISC student chapter. "This group of students' interest and familiarity with the bridge allowed them to take sole possession of the project and see it through as a small group."

Hitchman said this bridge was originally designed by students who have since graduated from college and have either started careers or are continuing their education toward advanced degrees. Part of the challenge included both deciphering the original design choices and adapting the original solutions to a different set of problems.

According to Associate Professor Adrienne C. Rygel, Ph.D., the students are submitting the bridge as their senior-level capstone project in the Civil and Environmental Engineering Technology program.

The first of three phases required to meet their assignment, and to fulfill competition requirements, was to submit a competition proposal due in February. The second phase is to record themselves constructing the bridge under the watchful eyes of an impartial judge. The team is planning to complete the second phase during the week of March 30 in preparation for an April 1 deadline. The final phase will be to take what they've learned and develop a new and improved design.

"They get to bring it to life and then work on improving the design afterwards," Rygel said.

Corrections Academy now accepting applications

CANTON - SUNY Canton's Corrections Academy is now accepting applications for its two upcoming summer classes.

The academy classes will be held beginning June 1 and July 12 in Dana Hall, corresponding with the college's summer sessions.

The spacious new classrooms will allow for required distancing between students and a safe learning environment for the in-person trainings. Housing options are available at Kennedy Hall.

The curriculum incorporates a combination of traditional lectures and hands-on training.

Cadets learn defensive tactics, hostage-survival techniques, first aid, crime scene preservation, effective communication strategies, and other safety procedures.

The Corrections Academy is run through the college's new Center for Criminal Justice Intelligence and Cybersecurity which ties in all of the college's related programing to create an immersive experience for students interested in a multi-faceted approach to their education.





Both Hitchman and Rygel noted the strategy this year is very similar to how engineering projects transpire in a professional environment and the experience adds to students' critical thinking abilities.

Dale R. Harris of Dundee is one of the four senior-level students to take the lead on the steel bridge entry, said he told his fellow graduating classmates from the AISC team that he strongly believed they could still compete in a bridge competition despite the hiatus and setbacks.

"The team has proven themselves to be ready to compete and demonstrate what we can do even after being halted by the pandemic," he said.

AISC steel bridge entries come from colleges across the U.S. and are judged on a variety of factors, including strength, aesthetics, and construction speed. Speed has traditionally been the factor that helps the SUNY Canton team win.






