# Paper bags for brush in Massena

MASSENA - Village residents will be required to use paper backs for grass clippings and leaf pickups in the spring and fall after village trustees approved a new local law requiring the use of such bags. Trustees approved the measure during a board meeting on July 18 but made an amendment to the resolution so the new law would not go into effect until next March. Originally, trustees had planned to implement the law for cleanup this fall but agreed to change the start date after two residents voiced a number of concerns during the public comment period prior to passing the law.

# Sex abuse claims push Diocese to file bankruptcy

OGDENSBURG – The Ogdensburg Diocese has filed for bankruptcy, a move triggered by 124 pending lawsuits from more than 50 alleged victims who say they suffered childhood sexual abuse at the hands of clergy from the 1940s to 1990s.

The Diocese encompasses 12,036 square miles of northern New York, including Clinton, Essex, Franklin, Hamilton, Jefferson, Lewis and St. Lawrence counties, as well as northern Herkimer County.

"This difficult yet necessary decision was made in response to lawsuits filed against the Diocese under the Child Victims Act. 124 cases are currently pending against the Diocese following implementation of the act, which allows individuals who assert that they were the victims of childhood sexual abuse to file claims, regardless of when the alleged abuse took place. The claims filed against the Diocese date back decades (1940s through 1990s), prior to the institution of the Diocese's safe environment policies and procedures," spokeswoman

Darcy Fargo said in a prepared statement.

The Diocese has been encumbered with lawsuits related to sexual abuse allegations and had acknowledged years ago that bankruptcy was being considered.

"The goal for filing a reorganization case is to resolve the legal cases in a fair and equitable manner while allowing the Diocese to continue its mission. Had the Diocese not filed for reorganization, civil actions would continue for many years, with claimants who filed the first lawsuits potentially receiving larger awards or settlements, leaving little, if any, money for the remaining claimants. Filing for reorganization does not hinder claims filed by survivors," said Bishop LaValley. "Instead, it establishes a process for all claims to be treated fairly."

Attorneys who represent victims of the Diocese see things differently though.

"The Diocese of Ogdensburg's decision to file for Chapter 11 Bankruptcy is an unfortunate yet predictable attempt to conceal the truth about the diocese's


Plastic bags require crews to rip the bags open to dump the contents into refuse trucks during cleanup. "It's a matter of saving time and

FOWLER — State Police arrested Tiara K. Allen, 25, of Gouverneur, on July 13 for reckless assault of a child, and endangering the welfare of a child.

Police said Allen was charged after an investigation determined that on July 7, around 9:40 a.m., she was in the care of her boyfriend's 5-month-old child at their residence on Sand Road in the town of Fowler.

Allen became frustrated with the child's incessant crying and began to shake the child, police said.

Shortly thereafter, the child became unresponsive and was

# School project almost done

MASSENA — Massena Central School District's \$49.6 million capital project is nearly complete and may come in under budget.

The project, which began during the summer of 2020, included extensive site work, roof replacement and repair, as well as asbestos abatement in phase one.

Phase two included significant work at each elementary school, masonry work, boiler replacement and work at the district's transportation facility.

Phase three wraps up work at the high school and junior high, as well as electrical work at the transportation facility, among other projects.

According to interim Superintendent Pat Brady, nearly \$400,000 could be left over for other work once the third phase is completed this fall.

Brady said many of the projects that could be considered would be on a smaller scale.

"For example, if we wanted to do

pool work, that would not be feasible because we don't have the time. We have to look at long lead times for equipment, architect review, SED review," Brady said.

Brady did say that the auditorium could see some upgrades from the funds, including carpeting, lighting on the carpet and aisle lighting.

Other ideas include new doors and ceiling tiles that could be installed by district employees without the help of contractors.

"We wouldn't have to worry about construction contractors doing it because they're coming to the end of this project and they're now going on to other projects and it's a short summer," Brady said.

With the project nearing completion, officials are already looking to the future for the next capital project.

IBI Group, who have overseen the current project, have assisted the district in assessing priorities for future projects, with ongoing discussion expected regarding the five-year plan that is in place.

# Baseball bat beating could mean 7 years in prison

OGDENSBURG — An Ogdensburg man will face up to seven years in prison after he allegedly struck a female victim in the head with a bat in 2022.

In May of 2022, Ryan Joanette, 36, was accused of striking a female victim he was in a relationship with in the head with a baseball bat multiple times and dragging her inside his home after she attempted to call out for help.

Ogdensburg police said she suffered "serious physical injuries."

The incident occurred at 217 Spring Street.

He also allegedly made death threats to the victim during the incident.

Joanette was originally charged with attempted murder and first-degree assault, but because the injuries to the victim were not "long-term" a jury in a July trial did not believe there was enough evidence to warrant those charges.

Instead, jurors convicted Joanette of second-degree assault, first-degree unlawful imprisonment and two counts of endangering the welfare of a child.

His mother, Kim Joanette, faces up to four years for charges of tampering with evidence and hindering prosecution.

She is accused of cleaning up the evidence following the incident.

St. Lawrence County District Attorney Gary Pasqua says that while he doesn't necessarily agree with the jury's decision on the lesser charges, he respects the decision and is pleased that the Joanettes will see prison time for the crime.

Pasqua said his office will be requesting the judge for the full seven years when sentencing takes place in September.

# Stec praises efforts to expand broadband

MASSENA — State Senator Dan Stec, R-Queensbury, visited St. Lawrence Recreation on July 12 to highlight work completed by SLIC Network Solutions bringing high speed broadband to 13 homes and St. Lawrence Recreation.

According to SLIC Chief Operation Officer Kevin Lynch, the project began in 2017 after St. Lawrence Recreation owner Shaun Prentice contacted him regarding a lack of broadband service to his business.

"We looked at it in our network... and the problem is that 13 houses and one business, economically, is really hard to justify because of the cost to build it. The return we would get, plus the operating costs is like 'boy, Shaun, I'd love to do it. I just don't know how we can piece that together," Lynch said.

But with help from the St. Lawrence River Valley Redevelopment Agency and St. Lawrence County Industrial Development Agency, progress began to happen.

Lynch said the IDA agreed to contribute \$20,000 to the project for the cost of construction, with the town also willing to contribute some funds. SLIC also heavily discounted the cost of labor in order to facilitate the project, however state regulations passed in 2018 stopped the project.

"Just as we get ready to go, the state passed a fiber occupancy fee," Lynch said.

With that legislation in place, the state would be able to charge SLIC a fee per foot of fiber optic cable that would run along state highways.

"So it took a project that was cashflow positive, just enough, but that's what we do, and put it in the red. We couldn't do it and that's when I had to contact Shaun like, 'Shaun, I'm sorry. I can't start the project.' I laid it out for him. He's a businessman, he understands that you can't run a business and give money away.

Insert Senator Stec, who lobbied the state to repeal the occupancy fee that affected every internet provider around the state.

With the fees removed, that allowed Lynch to give the green light for the project.

For Prentice, the addition of high speed internet could be one that saves his business.

"We were teetering on not being able to do business just because everything today, it's all online based. Whether you're ordering parts, looking at parts, being a DMV licensed dealer...there's things that have to be done on the DMV portal that can only be done online. There's no other way to do it," Prentice said.

Prentice also noted that paying state taxes is now entirely online,

yet another reason he needed high speed internet. "It's not like the old days when you fill out the paper and send it in to the state," he said.

Prior to receiving service from SLIC, Prentice said he reached out to a number of other service providers in hopes of finding high speed internet. But that effort was met with issues of feasibility and cost.

According to Prentice, one provider quoted him \$180,000 to run fiberoptic cable to his business.

"That isn't feasible for any business, there was just no way," he said. Prentice voiced his appreciation for the work Stec and Lynch put in to get the project completed after six years.

"The multiple agencies involved, working with the local governments, you know nobody looked away. They stayed the course. They knew this was important," he said.

# County to be dropped from lawsuit over migrants

CANTON — In a relatively abrupt turnaround, Palisades EOM has filed a motion to amend its legal complaint that named St. Lawrence County as a defendant.

Under the complaint, St. Lawrence County and a large number of New York state counties were named for declaring a state of emergency following the expiration of Title 42.

St. Lawrence County lawmakers first declared the state of emergency in early May following the expiration of Title 42, a Trump era policy that extended into the Biden administration and restricted travel of migrants at the borders.

County lawmakers previously said that the county was ill prepared for a potential influx of migrants, hence the declaration of a state of emergency. With the state of emergency in place, officials would be able to request FEMA money to support any potential migrants that may come to the North Country. Alarm bells first went off last month when it was reported that two migrants left a shelter in New York City, making their way north to Rockland County where they were able to obtain Department of Social Services benefits without being citizens, having social security numbers or working papers.

In response, Rockland County, Orange County and Niagara County all filed for a temporary restraining order and a state of emergency.

In total, 31 counties have filed a state of emergency, though not all have taken the added step to also announce emergency orders or provisions that would bar hotels from housing migrants.

To date, St. Lawrence County has not announced any emergency orders or hotel provisions.

Though the county should be removed from the complaint in the near future, the county will still be on the hook for legal fees after hiring Attorney James P. Youngs of Hancock Estabrook law firm due to state licensing requirements for attorneys in the southern district of the state.

Troopers determined a white Toyota Tundra was traveling south and a Red Toyota Rav 4 was traveling north on State Highway 37, in the town of Lisbon.



Murdock, 35, both of Massena, went into the opposite lane of traveling causing a head on collision with the Toyota Rav 4 operator, Michael K. Barkley Jr., 51, with passenger Michael K, Barkley Sr.,79, both of Ogdensburg.

Snyder and Murdock were treated on scene and transported to Canton-Potsdam Hospital for non-life-threatening injuries. Barkley Sr. was being treated on scene and was subsequently air lifted to Upstate Medical Center where he is The operator of the Toyota Rav 4, Barkley Jr. was pronounced deceased at the scene by the St. Lawrence County Coroner.

The NYSP Collision Reconstruction Unit and the Bureau of Criminal Investigation responded to this incident.

Ogdensburg Fire and Rescue and Lisbon Fire and Rescue assisted with the scene.

This is still an ongoing investigation, but state police did not list any charges in the press release.



# Updates on school safety policy now available online

MASSENA — The updated Massena Central School District's safety plan is now online for residents to review.

Board of education members are expected to approve the update plan during the board's August meeting, however public review and comment will continue until that time.

Board members recently heard about the updated plan when District Safety Team co-chair Duane Richards Jr. presented to the board.

"One of our roles as a safety team is to be able to review and update this plan so that you as a school board can adopt it and have it in place by Sept. 1," he said.

Richards said the plan aims to "minimize the effects of serious violent incidents" while allowing the district to coordinate within the district and with community resources.

While the safety plan is available for public viewing, Richards Jr. did note that building-level safety plans with further details are not available to the public. Richards said each individual building plan shows the "secret nitty gritty" of each individual building plan. Officials say the district safety plan is reviewed every year and largely remains the same, however one update this year is staff contact information, as well as additional plans for suicide prevention efforts and remote instruction.

According to Richards, the district safety plan has three parts that encompass the purpose and concept of operation of the plan, mitigation, prevention and response planning and district responses to specific event types.

Section two, mitigation, prevention and response, is where lockdown and evacuation drills are contained. In section two, information can also be found regarding relationships with local agencies like police, fire and rescue, along with protocols visitors must follow.

Section three includes communications, Richards said.

"That's communication, whether it's cancellations, delays, evacuations, the whole process that's involved in that," he said.

The new section is one that has seen a significant amount of work in recent months, as committee members assessed numerous threat types, along with cybersecurity, suicide prevention, conflict resolution and remote education.

"The first plan is listed there as a threat assessment plan. That's not new to the district. It's well-established. Each building has their threat assessment piece, and there's also a district threat assessment piece to that, so that plan is well in place," Richards said. School officials say the plan needs to be submitted to the state Education Department by Sept. 1.

Tournament boundaries include the St. Law-



# **Cryptocurrency mining moratorium extended in Massena**

MASSENA - Massena Town Board members agreed unanimously to extend the moratorium on cryptocurrency mining until December 31, 2023.

The move came during the board's July 19 meeting.

No comments were made during the public comment period against or in favor of the move.

The extension of the moratorium is another move by town officials to buy time while final regulations are worked out by Town Attorney Eric Gustafson. The moratorium was first brought up in July 2018 after residents expressed concerns that regulations did not adequately address crypto operations within the town.

Town officials quickly took action soon after and have continued to extend the moratorium over the last few years.

State officials have also taken action, implementing a two-year statewide moratorium late last year. The moratorium in place at the state level is for proof-of-work cryptocurrency mining and seeks to address some of the environmental concerns that lead many to argue against such operations.

Many of the operations that have come through Massena are themselves proof-of-work operations that use a blockchain-based algorithm to mine for crypto currencies such as Bitcoin and Ethereum.

In other action, board members opted to table a resolution that could have led to a potential moratorium on billboards in the town.

Town Supervisor Sue Bellor said board members wanted to take more time to gather further details and to solicit public feedback before considering a moratorium.

Board members also held a second public hearing regarding the district formation for the Massena water district project.

That water district would cover part of State Highway 37 and would cover the entirety of County Route 46 in the Town of Massena, Board Member Francis Carvel said. Anyone with the district would be required to pay for the debt retirement of the project but is not obligated to participate in the service or offer an easement for lateral service, officials say.

# School receives 'Champion of Change for Kids' award

MASSENA — The Massena Central School District has been awarded its third "Champions of Change for Kids" award for the work completed on a student-created website aimed at helping students with mental health issues.

The award comes from the New York State School Boards Association and was officially awarded during a recent board of education meeting.

On hand to present the award was NYSSBA Area 6 Director Wayne Rogers, who brought a banner for the school to hang in recognition of the honor.

"Champions of Change for Kids" seeks to celebrate programs that use existing resources "to address issues of equity, demonstrate strong student academic performance and introduce unique learning environments that are cutting-edge."

"The recognition program has been in place for three years and Massena has gotten a recognition banner every year that the program has been in place. So, it's thanks to students like you and others on staff and so forth that have put together programs that are brought that kind of recognition to us," Board of Education President Paul Haggett said.

The website, called "On the Mend," was the work of Kristen Oliver. Oliver was also on hand for the presentation to accept the banner for her work.

"Champions of Change was set up three years ago to allow us to share information on some of the really good things that happen in individual school districts that could also be duplicated and could be beneficial to other districts across the state," Rogers said.

Rogers complimented the work done on the website, saying the focus on mental health resources was impressive to read.

For Oliver, the website was a summer project for her and an opportunity to step in to make a difference in other student's lives.

Extensive research was conducted on other, similar programs but Oliver said nothing was really tailored to fit Massena Central because of the dynamic.

It was at that point that Oliver jumped into action to create the new resource.

"The whole program was aimed at an issue that we all know we're facing in schools right now, which is student mental health and, by proxy some of the behavioral stuff as well," High School Principal Alan Oliver said.

Oliver noted that the project was student-led from start to finish as well.

The website was developed by the school's Climate Committee called Project Raiders.

On the website, viewers will find guidance resources, social work resources, school clubs and various other resources that may assist students dealing with mental health issues.

As part of the project, the group completed a bracelet project to raise awareness about various mental health disorders.

Each mental health disorder was issued a different color bracelet, which were sold in the school lobby for a week, according to officials.

MASSENA — Two Massena Town Board seats are up for grabs this fall and four candidates have been nominated to vie for those seats.

Massena Republicans nominated Lindsay Hendricks and Sabina De La Porte for the two seats, while Democrats nominated Kristy Baker and Raymond Lancto. Those two seats are currently occupied by Debra Willer and Francis Carvel, both of whom chose to not seek another term on the board. Miller has held the seat since 2020, following the retirement of Pamela Catanzarite. She had previously served as deputy clerk since 2016.



#### One of Northern NY's hidden gems

Town and county officials seem to be constantly looking for ways to promote tourism and "fun" summer activities in our area. Outdoor pursuits such as golf, fishing, bicycling and hiking are great attractions for anyone inclined to participate. There is, however, another wonderful opportunity that very few area residents are even aware of. That is go karting on a world-class outdoor go kart road course.

The NY Race Complex, in Morristown, New York offers a kart racing school, competition kart track days, and several weekend competitions for novice to seasoned expert kart racers. The larger races attract drivers and teams from all over the nation and often other countries. While talking with national race team members I've been told that it's arguably the best outdoor kart track in North America.

The Kart Racing School experience consists of three 10-minute track sessions on their fast and fun school karts. When the participants of all ages arrive, they are outfitted with a driving suit, helmet, neck support collar, and driving gloves. An outdoor classroom session follows consisting of a familiarization with the kart, rudimentary kart driving skills and etiquette and track flagging structure. Before being released onto the track the students are led around the track at a very slow pace to familiarize them with the optimal racing line, after which they are released to work on honing their skills. After each session questions are answered and suggestions for improvement

are available. The cost for this fun and informative experience is \$60 per person. A driver can return any time for more track time at the same cost. I've seen many people try it and return over and over, sometimes with a newly purchased go kart of their own.

Whether it's the Easy Kart School, doing track days, joining a race league, corporate team building or watching top-level teams compete, the NY Race Complex is indeed a North Country gem that needs to be discovered. # Oaks will be okay despite hard freeze in mid-May

If you've wondered what awful new malady has struck our oak trees this spring, resulting in shriveled, deformed and dead leaves, the answer is chilling. Literally; as in cold. A hard freeze on the night of May 17-18 happened at just the right – or wrong – time, catching oak foliage at a critically tender stage. Since trees can't change their locations (to my knowledge, at least), I guess you could say that oaks were in the right place at the wrong time.

Periods of unusually warm temperatures between April 12-22, and again from May 6-13, enticed many trees to push out new growth quickly. This likely set the stage for more widespread harm than if the

mid-May freeze had occurred in the midst of a slow, gradual warming trend.

Other tree species that bud-out late such as hickory, butternut, and walnut were also affected to various degrees. Across the region, the extent of freeze injury varies from slight to severe, depending on things like slope aspect, genetic variation among individual oaks, whether trees were partly sheltered by the surrounding forest, and soil pH (bud-break is a bit earlier on acid soils). In many places, the damage looks harsh – even zipping along a highway, one can pick out which trees are oaks by the sparse canopies and unusual reddish cast to the foliage.

Young new growth is rosy because after that hard frost, oak trees now want to protect their leaves from sunlight. A class of chemicals called anthocyanins, which produce the red and purple color range in plants, act as UV protectants. It sounds bizarre to put sunscreen on leaves, which need sunshine to photosynthesize. But it turns out chlorophyll can be destroyed by intense UV rays at low temperatures. Eventually, the red will give way to green as anthocyanins break down and are not replenished (these large molecules cost plants a lot of energy to create, and while investing in them in springtime makes sense, no one has yet explained why trees make them in the fall after chlorophyll is gone).

In the spring of 1993, a similar thing took place where I was living in the Saranac Lake region. That time, a freeze occurred when beech trees were just leafing out, and I was flooded with calls about a new "beech-leaf blight." And then in 2011, sugar maples in the St. Lawrence Valley got touched by frost when their leaves were still folded. As the leaves opened, long gaps appeared, and I was awash in questions about what was "eating" the maple leaves.

At this time, I see no need to despair about the future of oak trees, although feel free to do so if you really want. Many oaks are still in the process of pushing out a new crop of leaves, and even those that go through the season with minimal leaf-surface area have energy reserves on which to rely. Dry soil conditions can inhibit re-foliation, so as long as we get a reasonable complement of rainfall this summer and don't have an outbreak of defoliators like spongy-moth or tent caterpillars, the oaks should be OK.

#### Foreign rescue dogs raise red flags

North Country Now recently reported that an animal rescue/ adoption operation which imports dogs from war torn countries and Chinese meat markets is seeking a special use permit in the Town of Canton. The St. Lawrence County Planning Board has already denied the No Dogs Left Behind permit; having discussed the need for an environmental impact study, humane care for the dogs and potential threats to residents in the county.

But the Canton Town Planning Board will have the final say. In my opinion, they should deny this permit as well.

The primary reason is that according to a warning posted on the Center for Disease Control website, foreign dogs introduce diseases and parasites that can endanger dogs and people in our communities. (https://www.cdc. gov/importation/bringing-an-animal-into-the-united-states/get-thefacts.html#print)

Beginning 3/1/23, all dogs entering the US from the over 100 listed high-risk rabies countries must have a valid CDC Dog Import Permit and a CDC Rabies Vaccination and Microchip Record. Fraudulent operations can falsify such documents. Does the Town of Canton intend to individually monitor the records of 50-500 dogs being brought to this proposed facility? Does the town have liability when an infected dog harms another animal or a resident?

Even if the dogs are initially examined by a vet upon arrival, difficult-to-treat parasitic diseases like leishmaniasis can go undetected for 3-18 months before symptoms begin to appear. Suddenly that newly-adopted pet is vomiting and extremely ill. The vet bills mount while a spreadable infection has gone undiagnosed.

The second reason for concern is that these traumatized, feral animals being captured, forced into crates, shipped and flown thousands of miles aren't necessarily socialized animals. These stressed dogs require specialized handling and, in the end, may not be suitable for adoption. What then?

There is no doubt that we, as pet-lovers, are saddened by the tragedy of dogs abandoned in wartorn countries or being slaughtered in service to Chinese meat markets. But rescued dogs being brought into the US carry many unnecessary risks.

St. Lawrence County shelters and their volunteers are already overwhelmed in their efforts to place pets into loving homes. I think the Canton Town Planning Board should reject the permit request by No Dogs Left Behind and encourage support for local adoptions instead.

Please join in voicing your objections to foreign rescue dogs being unnecessarily introduced into our communities.

# How to share your extra garden

Nothing beats the taste of those first few harvests from the garden. The flavor and freshness, combined with the pride of having grown it yourself, just can't be beat ... but when the novelty wears off, the freezer fills, and the excitement of processing your harvest turns into a chore, you might find yourself with an excess of wonderful food and no energy left to deal with it.

When you find yourself with an overabundance, you can share it with the people in our community who love delicious, fresh food, but have no means of growing their own. Here are some suggestions for connecting with them:

GardenShare has created a comprehensive interactive map where you can filter for food pantries and community meals. Locations and details are listed online at gardenshare.org/food-guide. United Helpers has a number of subsidized housing units throughout the county, and their house managers would be glad to talk to you about donating to the residents. Recovery and Safe Houses also welcome donations and reaching out to their respective directors would help you understand what they need most, or what they could consume.

There are many food donation options in every community here in the North Country. In my experience, these organizations and the people they serve are always grateful for fresh, nutritious food, even if you have enough for one family. Free will dinners sometimes provide "take home food" when they have extras, and your produce could be part of that offering. If we all share just a portion of our harvests, the impact will be staggering.

I recommend looking for an organization near you now, even if your harvest isn't ready. Find out who the best contact is, where you can drop things off, and what they will/can accept. Once you make that connection, when the busy harvest time arrives, it will be easier to follow through with the donation. When you create a connection with someone in your community who is doing wonderful work to serve your neighbors, I'm confident you'll be impressed with their dedication, and you'll learn about the real needs that are present right where you live. Those are the connections that make the world a better place.

Test it out this year to find your place, then as you plan for next year, consider increasing plantings of one or more crops that you can share. For most gardeners, the garden is our happy place and our therapy. By sharing our harvest, it also becomes a chance to grow our community.

# Ingredients

**Noodles** 

• 1/2 to 1 package rice noodles

## Stir fry

• 1 medium-large bunch leafy greens (bok choy, kale, swiss chard, collards, etc), chopped roughly

• 1-2 cups chopped mushrooms (small button varieties, such as crimini)

- <sup>1</sup>/<sub>2</sub> cup small diced radishes
- 3 scallions, chopped
- 1/4 -1/2 cucumber, chopped
- 6-8 garlic scapes, chopped

• 1 package tempeh, cut in 1/4 inch-1/2 inch squares (see protein substitutions below)

• 2 TBSP olive oil

#### Sauce

• 1 small bunch cilantro, chopped

• 3-4 TBSP peanut butter 2-3 TBSP soy sauce or coconut


- 1/2-1 can full coconut milk or 1 cup regular milk
  - 1 TBSP sesame or olive oil
  - Lime juice to taste

# Instructions

1. In a medium bowl, combine all sauce ingredients and whisk together until a lightly thickened sauce forms. If the sauce is thick and doesn't spread well, add more coconut milk or milk to achieve a thinner sauce.

2. Cook noodles of your choice according to package directions. Drain and rinse with cold water.

3. In a medium to large pan, heat olive oil over medium heat. Cook tempeh until golden on each side, approximately 5 minutes. Remove from the pan and place onto a plate. 4. In that same pan, add additional oil if needed. Add in mushrooms, garlic scapes, and scallions. Cook until softened. Add in greens and



cook until wilted and slightly soft. Remove from heat. Toss in radishes and cucumbers raw for an added crunch or keep separate.

5. Assemble your dragon noodles either by tossing noodles, vegetables, tempeh all in one big bowl with sauce or place noodles, vegetables, and tempeh topped with sauce in individual bowls.

6. Top with a squeeze of lime juice and/or chopped peanuts if desired.

# Notes

• You can use any type of milk, sub approximately 1 cup of milk instead of the coconut milk.

• To make prep easier, try a food processor to lightly chop radishes, cucumber, mushrooms, scallions, and garlic scapes. Process the radishes and cucumber separately from the ingredients that will be cooked so you can add them raw. Overprocessing will result in mushy bits.

• Vegetables can be prepared ahead to be ready for busy weeknight cooking.

• Cubed chicken, thinly sliced beef, shrimp, etc, can replace the tempeh.

• Adjust sauce spicing to your liking - such as adding red pepper flakes, ginger or lemongrass.

• Increase sauce as needed to coat

# Notes

 You can increase the amount of sweetener in the popsicles because cold foods reduce the tongue's perception of sweetness. • Popsicles are flexible, experiment with dairy or lactose free substitutes such as silken tofu, oat milk, or coconut milk.



He also noted that high diesel prices are a contributing part of the problem.

falling apart.

Miller said there might be a few growing pains while his crews get the schedule for pickups down but if that were to happen, his crews would clean up everything.

Paquin also chimed in, saying his paper bags endured a rain storm last year before pickup and DPW crews were still able to remove them without issue.

"I'm just saying, if they get wet and fall apart I'm just going to sweep it down the street," the woman said.

Later in the meeting, Trustee Ken McGowan reminded residents that to dispose of clippings and leaves on village streets is a code violation.

While the two residents voiced concerns about the extra cost associated with paper bags, Miller also spoke to the cost of the service in general, saying it costs taxpayers thousands of dollars every year for crews to pick up the waste.

"Brush chipping alone costs somewhere in the neighborhood of \$16,000 per year. That's a service that we provide to residents that is being paid for by residents but it's necessary," he said.

Miller also mentioned that during cleanup in the spring and fall, crews are working extra hours to meet the demand, which in turn leads to other tasks not being completed around the village.

The time potentially saved with paper bags would mean DPW crews could more quickly move onto other tasks, Miller said.

Paper bags are also biodegradable, something that trustees and Miller alike said was a selling point to make the switch. In the end, trustees opted to amend the resolution to begin the requirement of paper bags for pickup in the spring cleanup season.

"I think that is a fair solution and will give us time to get organized," Paquin said.

Residents will still be allowed to use plastic bags if they so wish, however they will be required to dispose of them themselves, Paquin said.

Village Administrator Monique Chatland also suggested speaking with local vendors to possibly purchase bags in bulk to resell to residents at cost to save them money.

Miller said he would look into a bulk purchase option and would report back to trustees in the near future.

self-serving practices at the expense of child sexual abuse survivors," Jeff Anderson and Associates law firm said in a join press release with LaFave, Wien & Frament, PLLC. "The Diocese of Ogdensburg's

resolution to declare bankruptcy shows, once again, a continuity in their intentions-which are, solely and purely, in service to their own self-interest," said attorney Cynthia LaFave. "In declaring bankruptcy, the Diocese knowingly obstructs survivors' long-awaited opportunity to say their piece; to be heard, to be acknowledged. Make no mistake, silencing survivors is exactly what the Diocese has always done. This decision is another in a long line of decisions aimed at preserving the Diocese's frail veneer by undermining the humanity and dignity of survivors."

The law firms say over half of New York's eight Catholic dioceses have filed for Chapter 11 bankruptcy to date.

"The Diocese of Ogdensburg is running from accountability," said attorney Jeff Anderson. "Instead of standing up for the people entrusted to their care and acknowledging the harm done to children for which they are responsible, the Diocese is taking drastic, self-serving measures in an attempt to suppress the truth," the firms said.

Bishop LaValley however, said that the Diocese has instituted extensive policies and procedures to prevent sexual abuse.

'The procedures also ensure that allegations are responsibly and justly handled," according to the Bishop.

"We believe that the fact that there have been no claims filed alleging abuse occurred in the last 20 years is evidence that we have made great progress and are on the right course. Nevertheless, we remain vigilant."

The Bishop added that he is available to meet with every abuse survivor, and the Diocese continues to reach out to them with a goal of fostering reconciliation and healing for those who have been so immeasurably harmed." The Diocese said that prior to the implementation of the CVA, the Diocese offered assistance to survivors of abuse who made prior claims.

"In 2018, as part of the Year of Mercy, diocesan officials reached out to survivors through the Independent Reconciliation and Compensation Program (IRCP) seeking reconciliation with them and offering compensation for their suffering. Through the IRCP, 38 claims were resolved. An additional 14 claims were also settled outside the program.

The law firms say they have no plans to quit pushing forward.

"The survivors' courage and strength will not be extinguished by today's bankruptcy filing," added attorney Taylor Stippel. "North Country survivors are resilient. The true nature of the Diocese's dangerous patterns and practices will be revealed."
