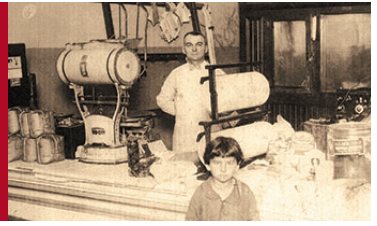

Reviving Massena harvest fest

MASSENA — A pair of Massena village trustees and various other volunteers are working to bring back a revamped version of the Harvest Festival.

Trustees Shelyn Peets and Ken McGowan say they and other volunteers are working on Fall Fest 2023: Pumpkin Palooza in an effort to revive a former tradition of Massena.

Peets told trustees recently that the idea was to bring a traditional event back to Massena, much like the Seaway Festival in Ogdensburg and Homecoming in Waddington.

Peets said many events occur in the summer and winter, leaving fall wide open for Massena to host an event again.

The event, scheduled for Oct. 14, is set to take place in downtown Massena. Peets said it is her hope that the event will help local businesses see increased foot traffic.

"We are slated to have vendors, food trucks, music, activities for the kids and more," she said.

Peets said the plan is to eventually hand control of the festival over to the Massena Chamber of Commerce in the future.

Officials say they expect the chamber to eventually merge with the St. Lawrence County Chamber of Commerce, a move that would see a full-time representative available in the village to represent the interests of Massena with the county chamber.

Part of the event is also designed to aid in the Schine Theater restoration project.

Members of the Massena Arts and Theater Association, a nonprofit group, sought a large portion of the village's \$10 million Downtown

Murderer faces 22 to life

Howell offered kindness in her final moments

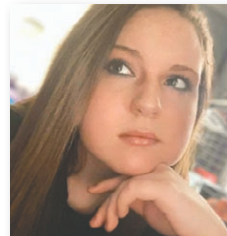

MASSENA — In her final moments on Feb. 18 of 2022, Elizabeth Howell offered help to the man who beckoned her to his vehicle feigning a need for directions.

Michael Snow, her murderer, repaid her kindness with three shots from a .22 caliber "ghost gun" he says he purchased online.

In the courtroom Howell was described as a helper who cared for other people. She fought for her peers and worked to save other lives as a lifeguard for a time, according to her family.

She worked to bring good into the world and her killing tore a hole in her family and communities that can never fully heal. She was a SUNY Potsdam student when

she was killed and had performed with the Crane Symphony Orchestra and the Crane Chamber Orchestra.

She was a cellist and regarded as a "star" student who was working

toward her goal of being a music educator. Snow took that dream away from her and robbed future generations of a teacher who would likely have touched many lives during her career.

That reality was expressed in an impact statement her family submitted to be read by District Attorney Gary Pasqua at Snow's sentencing on Friday.

Snow's killing of Howell took more than her life.

"He took our lives as we know them," her family said in the statement.

Her family said that while Snow will be in prison for at least 22 years, those who knew and loved Howell will remain in a prison of grief for the rest of their lives.

In the impact they talked about the loss. How they will wait for her to walk through a door she'll never open.

How their holidays and family gatherings would be changed.

How they will not get to see her achieve her dream of spreading her love of music to others or get to see her graduate college.

Her parents, who are also musicians, won't be able to enjoy songs they once

State plans to tear down former Letchworth complex at SLPC

OGDENSBURG — After years of lobbying from public officials, the state is poised to demolish nearly a dozen buildings at the St. Lawrence Psychiatric Center.

The demolition would include the Letchworth Building Complex and would be completed in two phases with five buildings being torn down in each phase.

Constructed in 1890 the Letchworth Building Complex has been vacant for 35 years and is currently dilapidated and deteriorated.

The first step in the process involves an environmental impact review. Although no monetary figure has been put forward yet, public officials say the Dormitory Authority of New York has offered assurances that the project will move

forward.

Perhaps even better news for the city is that additional dilapidated and deteriorated buildings on the SLPC campus are also under consideration for demolition, a letter issued

by DASNY and obtained by North Country This Week says.

"It is good news for the city of Ogdensburg and all of SLC," Interim City Manager Andrea Smith said. "The City has been trying to get the attention of New York State with regard to the condition of buildings on this property for the last 20 years."

Smith said the state's focus on Ogdensburg is welcomed and she is hopeful that the state and the city will be able to work closely as the project moves forward. She says it opens up potential for more potential talks about PILOTs and ensuring the former prison that was recently shuttered isn't left to deteriorate.

"There is a lot of property down there. They are showing their commitment to changing the landscape of that area.

Charges follow chase, crash

MASSENA – A Massena man was apprehended by state police after leading police on a 12-mile chase, crashing his vehicle and spending the night in the woods.

Gregory P. Baxter, 40, was charged Thursday, July 27, with first-degree unlawful fleeing an officer in a motor vehicle. He was also issued multiple vehicle and traffic tickets.

According to state police, on July 21, around 11:06 p.m., troopers observed a blue 2011 Ford F250, traveling on County Route 52, in the Town of Lawrence at a high rate of speed.

The trooper attempted to initiate a traffic stop on the vehicle but it failed to comply, a pursuit was initiated.

The pursuit lasted for about 12 miles when it came to an end near the intersection of State Highway 458 and Dave Mills Road.

The operator of the Ford F250 failed to negotiate the curve causing the vehicle to leave the roadway and overturn.

Troopers quickly responded to the overturned vehicle but there was no operator in the vehicle.

The operator fled the accident scene into the wooded area.

State Police K9 unit responded to the scene, along with the St. Lawrence County Sheriff's K9 to attempt to locate the operator of the vehicle.

On July 22, around 9 a.m., the operator of the vehicle was seen walking down State Highway 458 and was identified as Baxter. He was provided medical attention and transported to Canton-Potsdam Hospital for a large laceration on his arm.

Baxter was later released from the hospital.

He arrived at SP Massena on Thursday where he was processed for the incident.

He was released on appearance tickets returnable to the Town of Lawrence Court and the Town of Hopkinton Court for later dates in August.

Body of suspected human smuggler found

AKWESASNE - The Akwesasne Mohawk Police Service identified the body of a man that was found in the St. Lawrence River on July 3 in the area of Ross Island, Akwesasne.

The coroner's office has provided confirmation that the individual is Casey Oakes, age 30 of Akwesasne, who went missing in March 2023.

"We wish to extend our condolences to Casey's family and thank them for their patience during a difficult time," police said.

No further information will be released at this time, police said.

The investigation into Casey's death and the deaths of eight foreign nationals who were crossing the river by boat in March remains underway.

Appellate Court affirms conviction of Hebert for 2014 Massena murder

St. Lawrence County District Attorney has announced that the man convicted in the cold case murder of Lacey Yekel has lost his bid to overturn his 2019 conviction.

The Appellate Division, Third Judicial Department, on Thursday, July 27, denied the appeal of Christopher A. Hebert, 51, who argued that his conviction was not supported by the evidence and that other errors were committed during the trial.

Hebert killed Yekel on or around June 7, 2014 in Massena. Her skeletal remains were recovered from a wooded area near the Massena Industrial Park on Aug. 29, 2014.

In a unanimous decision, the Appellate Court found that the evidence was legally sufficient to support the verdict, and there were

no other errors that would warrant reversal, Pasqua said in a press release.

"Although defendant could not be convicted solely upon his statements to others, there was significant evidence that corroborated the commission of the crime, including the fact that the victim's skeletal remains, clothing and a tarp were found in the precise location relayed by defendant," Justice Michael C. Lynch wrote.

In addition, the Court found Hebert's claims of prosecutorial misconduct unpersuasive stating "The challenged statement and lines of inquiry by the prosecutor were either fair commentary on the evidence, necessary to complete a narrative, or were not so egregious as to deprive defendant of a fair trial."

"We are very pleased with the Appellate Division's decision today affirming the jury's verdict and conviction of Christopher Hebert. I hope this will bring some sense of closure and peace to a family that waited almost five years for answers while the murder of their loved one went unsolved," said District Attorney Gary Pasqua.

"Christopher Hebert violently murdered Lacey Yekel in cold-blood, confessed about that killing to several people, and then nearly avoided responsibility for that crime. Today's decision confirms he committed this horrendous crime and provides the justice this young lady deserves," Pasqua said.

At the original 2019 trial, five witnesses testified that Hebert told them he murdered the 24-year-old. One of his confessions was captured in a 2017 jailhouse recording and played in the courtroom. He was heard on the recording saying he was "consciously aware" of what he was doing and said he killed the woman because he had beaten her so severely that he would have gone to prison even if she hadn't died.

Testimony at trial revealed the killer and victim had been using cocaine together the day of the murder, injecting it with needles. Hebert had agreed to accept guns from Yekel to pay for the cocaine she was getting from him.

They went to the Industrial Park on the night of June 7, but there were no guns there, and that's when Hebert killed her, according to the evidence presented at the trial.

During the trial, Hebert took the stand in his own defense, claiming Yekel died of a cocaine overdose. During his testimony, he said he lied to people about murdering Yekel to gain clout among his criminal associates.

However, the jury didn't buy Hebert's story and ultimately found him guilty.

Accused of killing cats with hammer

MASSENA – A Massena man was charged Monday after allegedly beating and killing three cats with a hammer, according to state police.

Edward A. Briel, 28, was charged with three counts of aggravated cruelty to animals, police said.

Troopers said Briel allegedly took the victims three cats and struck them with a hammer. Two cats were dead at the scene and one was euthanized at Java Veterinarian Clinic due to its injuries, police said.

The incident took place on SH 37 around 5 p.m., officers said.

Briel was arraigned in Norfolk court and released on his own recognizance, police said.

Schumer pushes dairy insurance bill

LISBON — Senate Majority Leader Chuck Schumer is pushing a bill to keep the Dairy Margin Coverage (DMC) Program intact.

In a visit to Keystone Dairy today, Aug. 1, Schumer said it was time to “churn up support to protect this program for upstate New York farmers and consumers.”

“St. Lawrence County is the heart of Upstate New York’s dairy industry, with over 230 dairy farms, and by the end of this year many could be looking over a ‘dairy cliff’ that threatens lifeline payments, puts the industry in limbo, and increases the price of milk,” Schumer said.

The program, first passed in 1999, was authored by Schumer during his first term in the Senate.

The DMC is a program that offers monthly price support payments from the federal government to dairy farmers during times when expenses to produce dairy products outweigh the income from the sale of such products.

Though the program has been utilized this year, pumping millions of dollars into dairy farms across the country to offset declining dairy prices, Schumer said in many years such payments have not been necessary to keep farms afloat.

“This program gives monthly payments to our dairy farmers to make up the differences for the price of milk and dairy products. It’s a lifeline to our farmers. But if Congress doesn’t pass it, it could expire and that could mean our farmers go without the insurance provided by the DMC,” Schumer said.

According to Glenn Bullock, executive director of the Farm Service Agency for the USDA, DMC payments released to farms nationwide yesterday and today totaled \$797,831,245.

For farms in New York state, \$74,468,950 has been received over the last two days.

Schumer said he worked with the New York Farm Bureau in 2018 to pass the bill that offered a “vital lifeline” to many farmers.

“We need to get this done and there are problems in the agriculture bill. That shouldn’t affect the DMC. I’m launching a new course to protect this program and as Senate Majority leader...I’m going to do everything I can to see this program is produced as part of the whole farm bill, or separately if we have to do that,” he said.

But other issues will also arise if the bill isn’t passed, Schumer said.

“The price of milk could potentially double. Cheese and other milk products could also double in price. And then we’d see billions of dollars in avoidable government spending because the Fed would go back to a policy from the 1950’s where they bought milk off the market,” Schumer said.

Schumer said St. Lawrence County, the second biggest milk producing county in the country, would be among the first impacted if the bill

is not approved by Congress before Sept. 30.

According to Schumer, a lapse in the DMC would endanger North Country farmers and could have irreparable harm to the local economy.

But Schumer said the bill, which has always had bipartisan support, is a top priority for both the House and Senate as the deadline looms.

“Right now, margins for dairy producers are about as tough as I’ve ever seen them. Thankfully, the DMC program is built for times like these,” said Keystone Farms Co-owner Eric Fonda.

“In recent years, the DMC program has provided our 7-million-pound dairy farm with much needed support in the face of milk prices falling below the cost of production, providing as much as 10% of our farm’s income some months,” Fonda said.

Schumer and Fonda alike both spoke to the impact dairy farms have on the local economy, with dairy farms in St. Lawrence County selling around \$140 million in dairy products every year.

“That’s 72% of the profits of agriculture products in the whole county,” Schumer said.

Catherine de Ronde, Vice President of Economics & Legislative Affairs, Agri-Mark Dairy Cooperative also spoke to the initiative to pass the DMC, saying dairy farmers also play a crucial role in regional food security.

“The Dairy Margin Coverage (DMC) Program is a vital safety-net that has proved invaluable in recent months. Congress must act to reauthorize the pending 2023 farm bill and ensure that the DMC program remains intact and evolves to fit the needs of today’s dairy farmers,” de Ronde said.

Congress is expected to take up the bill again in the near future, with hopes of both the House of Representatives and Senate passing it before the current bill expires on Sept. 30.

Waddington officials launch community survey for NY Forward Grant investment plan

WADDINGTON — The village of Waddington is set to receive \$2.25 million in funding from the NY Forward grant program and officials are soliciting feedback from residents to guide the investment plan.

Village officials say the NY Forward Strategic Investment Plan involves “a broad section of the community in creating the concepts that will help guide the process.”

“NY Forward is an important puzzle piece in helping Waddington to realize its vision and keep up with the changing economy of the new century,” said Village of Waddington Mayor Michael Zagrobelny previously said.

“Collaboration, communication, and creativity between local stakeholders, industry experts, and state agencies will be the key to our success. Those three qualities are hallmarks of the Waddington community as it reemerges as the jewel of the St. Lawrence River Valley.”

A Local Planning Committee and the project team will guide the process as village officials consider how to spend the funds.

The NY Forward program first came about in 2022 as a central

focus of the state’s efforts to further develop local economies.

Working together with the Downtown Revitalization Initiative (DRI), the program seeks “to accelerate and expand the revitalization of New York’s downtowns.”

NY Forward in particular is designed to support smaller communities with historic character that distinguishes them from larger, more urban central business districts typically funded through DRI, according to state officials.

Communities that receive NY Forward fund are usually more walkable, less dense areas that serve the immediate local community.

With such funds distributed, smaller communities are able to receive planning and project implementation support in an effort to attract more businesses, residents and visitors while improving the quality of life for all residents.

The NYS Department of State (DOS) administers the NYF program in close coordination with NYS Homes & Community Renewal (HCR), Empire State Development (ESD), and New York State Energy Research and Development Authority (NYSERDA).

In the first year of the NYF program, each of the State’s 10 Regional Economic Development Councils had the option of nominating two communities for \$4.5 million NYF awards or three communities, one of which will receive \$4.5 million and two that will be awarded \$2.25 million.

For Waddington residents who wish to submit feedback, the survey can be completed in about five minutes.

10 more miles of county roads to be paved this year

CANTON — St. Lawrence County will see an additional 10 miles of county roads repaved this summer, in addition to the projects already slated for completion this summer.

Legislators approved a budget modification of \$1.2 million during the finance committee on July 31.

In the 2023 budget, legislators originally approved paving 38.65 miles of roads.

County Highway Superintendent

Don Chambers told legislators on the finance committee that he and County Administrator Ruth Doyle sat down for a meeting two weeks ago to discuss adding additional miles to the existing projects in progress.

“We’re going to slowly add additional road mileage to the county work this year,” he told legislators.

Chambers said he reviewed the entire county roadway system and came up with an additional 10 miles that would fit into the current plans.

Those roads that will see some

work done will be recycled and surface treated, he said.

According to Chambers, it is his hope that additional CHIPS funding will become available in the future so more projects can be completed during the 2024 paving season, allowing the county to continue to expand on planned projects.

Last year, legislators and Doyle recommended adding 10 additional miles of paving to the planned schedule, which cost \$2.1 million due to higher costs of materials.

Legislators again recommended adding an additional 10 miles

this year as well to “address the challenges associated with ongoing maintenance of the county road system.”

In 2022, the county received \$3,903,961 from the Consolidated Highway Improvement Fund and an additional \$891,118 in PAVE-NY funding from the state, allowing the county to complete 26 miles of paving last summer.

In total, St. Lawrence County has 573 miles of county roads to maintain, along with other infrastructure.

Annually, the county has repaved anywhere from 28 to 32 miles of roads, officials say.

All county roads that are expected to be repaved this summer will be completed by county employees.

The modification will now need final approval by the full board when they meet again next week.

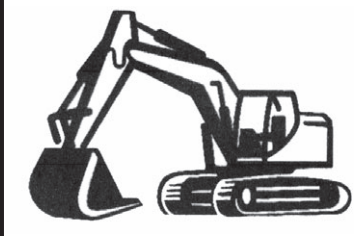

Waterfront project coming together in Massena

MASSENA — The Village of Massena's Local Waterfront Revitalization Project is coming together, with further progress being made during a recent meeting to solicit public feedback.

Village Administrator Monique Chatland said the meeting, the third of its kind thus far, was the best attended thus far.

"We had 18 people in attendance and they all gave us a lot of great feedback," she said.

A public survey has also been posted for months now, providing those who cannot attend in person an opportunity to provide feedback.

Some of the projects in the works include a farmer's market that officials hope will be utilized all four seasons, along with downtown streetscape improvements, downtown building facade updates, additional parking downtown and various other projects that will "leverage Massena's natural elements" along the river.

Chatland said many projects received positive feedback but a few in particular received the most feedback.

"There was a lot of support for the multi-modal trail, connecting downtown Massena to the Town Beach, which led to conversation about potential economic development, as well as community development. Utilizing the open space near Parker Avenue bridge, with a pavilion to host a Farmer's Market and other things, such received support. Many great ideas derived from the public meeting; I was enthused with the number of interested parties in attendance," Chatland said.

Village officials, LWRP committee members and members of the public alike have been brainstorming ideas for months, Chatland said.

In the earlier stages of brainstorming, there plenty of possible projects discussed. One of those potential projects was the idea of creating a dog park, however, we failed to include that as a draft project. At Monday night's meeting we heard that there public support for

this project. Concerns about parking along Main Street were heard, as well as suggestions that included replacing one of the large sidewalks on either side of Main Street to allow for diagonal parking, thereby creating additional spaces. A lot of great ideas were derived from the public information meeting," she said.

Chatland commented that the LWRP has been a work in progress for some time now, especially since the village was awarded the Downtown Revitalization Grant in December 2021.

That \$10 million grant will kick start many of the projects downtown, enhancing and updating many businesses.

Further grant funding opportunities are also available for projects.

"Once the LWRP is formally adopted by the Village Board of Trustees, which is expected to be presented late this winter/early spring) it must be reviewed and approved by various state and federal agencies. We will then begin looking at funding opportunities to make these projects come to fruition. With an adopted LWRP, the Village will have an increased opportunity to apply for financial assistance from State funding sources to implement our LWRP by identifying a clear and consensus-driven direction for appropriate future development of the waterfront," Chatland said.

Chatland said when the time comes to apply for such funding, village officials will aggressively pursue all opportunities to ensure each project selected is fully funded.

Chatland said efforts are also being made to fund other projects outside the scope of the LWRP as well.

"We will continue to seek grant funding for any and all potential projects, those included in this plan, as well as other priority projects throughout the Village," she said.

Though the next meeting date has not been announced yet, Chatland said the LWRP and village officials will plan more in the future and will continue to discuss the project during village board meetings, as needed.

Arrested on sealed indictment

MASSENA — A Massena man has been arrested by the Massena Police Department on a sealed indictment warrant for multiple felonies.

Clarence Wright, 39, was charged with two counts of third-degree criminal possession of a controlled

substance: narcotic intent to sell (B Felony) and two counts of third-degree criminal sale of a controlled substance: narcotic (B Felony).

Wright was transported to the St. Lawrence County Correctional Facility to be arraigned in St. Lawrence County Court at a later time.

Indian citizen pleads guilty to alien smuggling

Simranjit Singh, 40, a citizen of India living in Canada, pleaded guilty July 28 to alien smuggling and conspiracy to commit alien smuggling through Cornwall Island and the Akwesasne Mohawk Indian Reservation into the North Country.

At the request of the United States, Singh was taken into custody on June 28, 2022, in Ontario, Canada. Singh was extradited from Canada to the United States on March 30, 2023.

The announcement was made by United States Attorney Carla B. Freedman, Chief Patrol Agent Robert N. Garcia, United States Border Patrol, Swanton Sector, and Matthew Scarpino, Special Agent in Charge of the Buffalo Field Office of Homeland Security Investigations (HSI).

In pleading guilty, Singh admitted that from at least

March of 2020 through March of 2021, he facilitated the smuggling of numerous Indian nationals from Canada into the United States, via Cornwall Island and the Akwesasne Mohawk Indian Reservation in the St. Lawrence River region, for profit.

Sentencing is scheduled for December 28, 2023, before United States District Judge Mae A. D'Agostino in Albany, New York, at which time Singh faces a mandatory term of 5 years in prison and up to 15 years in prison, a fine of up to \$250,000, and a term of supervised release of up to three years. Singh will be subject to deportation following the conclusion of his sentence, which is determined by an immigration judge. A defendant's sentence is imposed by a judge based on the particular statute the defendant is charged with violating, the U.S. Sentencing Guidelines, and other factors.

Numbers stay consistent at community clinic

CANTON — Numbers remain consistent within the Community Services Clinic, including with addiction services, the mental health clinic and Outpatient Treatment Program (OTP).

Community Services Director Jay Ulrich told county legislators recently that the averages for each department remain about the same, despite a history of numbers declining slightly during the summer months.

“The numbers are not quite as strong this month but they’re about the same,” he said.

Ulrich said changes to scheduling were made, with the month of June being the first month to reflect those.

“We met with each councilor and we came up with a matrix or a mix of what they needed in terms of how many 45 min visits, 30 min visits, 15 min visits they needed,” he said.

Ulrich said the scheduling assessment and changes are part of a corrective action plan to better utilize

appointment slots.

According to Ulrich, in some cases appointments scheduled to last 45 minutes only lasted 30 minutes, leaving time available that could have been utilized for additional patients. “We need to correct that and adjust,” he said.

The summer months are tough months for Community Services, he said, noting that a number of patients don’t come in for a variety of reasons, including nicer weather.

When it comes to the waitlist, Ulrich said the only two people still on the list are seeking OTP services currently.

“At the time it was five, now we’re down to two. Those are individuals who can’t be seen in a five day period,” he said.

Billing services have also improved, he said, with the previous issues largely being sorted in recent months.

“In terms of the billing process, I’m fairly confident we’ve got it about 90% fixed,” he said.

Ulrich said fixes have been put in place for background settings that have

made it easier to get reimbursement.

Insurance claims are also dropping and getting reimbursed faster and in full, he said. Revenue for Community Services totaled \$257,016 for the month of June, with \$165,000 being accounted for through OTP, Ulrich said.

During the meeting, Legislator Harry Smithers questioned the decline in wait list numbers, in particular those seeking mental health assistance.

“How do you explain it going down to zero? Are they getting help somewhere else,” he asked.

Ulrich said his staff has brought more people in and in many cases have been able to reach those who are in need. But hiring is still an issue, as two positions still remain open. “We’ve had them for well over a year,” Ulrich told legislators.

Despite the two open positions, Ulrich said he and his staff will continue to look for ways to improve services and ensure everyone who needs care will be able to receive it in a timely fashion.

Alisha Crump, 38, of Massena was charged with second-degree criminal possession of a controlled substance: stimulate over 10 grams, third-degree criminal possession of a controlled substance: narcotic intent to sell, fentanyl, third-degree criminal possession of a controlled substance: narcotic intent to sell, cocaine, fifth-degree criminal possession of a controlled substance (controlled substance intent to sell, methamphetamine and first-degree criminal nuisance.

Dominique X. Abortion is a right in many areas of the world, with first world nations having and promoting access to it. Our nation claims to be the best and brightest and the

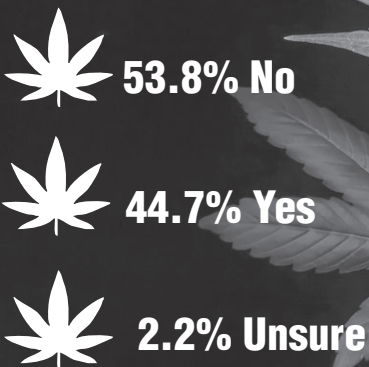
“leader” but a small minority that has powers is pulling the nation backwards.

Most do not want marijuana being sold at events in St. Lawrence County

The Question:

Do you support marijuana being sold at fairs, festivals and other events in St. Lawrence County?

MARIJUANA CAN NOW be legally sold to adults over age 21 at fairs, festivals, and other venues in New York state under a measure approved by state regulators July 19. Pot farmers around New York have said they entered this growing season still stockpiling marijuana from last year because the state has been opening stores too slowly. There are only 20 licensed retailers currently open statewide, and more than 40 in development, according to regulators. Do you support marijuana being sold at fairs, festivals and other events in St. Lawrence County?

HERE ARE COMMENTS from some survey participants:

‘If the wineries are allowed to sell their products, marijuana growers should be allowed to sell products as well.’

‘Yes, as long as it is only sold to adults over 21 years of age. Just like alcohol, ID is mandatory in order to buy it.’

‘I’ve seen people cause a scene because they got drunk at a public event. I have never seen someone make a scene while high at a public event. Weird.’

‘No! I will immediately leave any fair or festival selling pot. This is crazy and dangerous.’

‘Absolutely not due to the presence of minors at all these events. Keep it accessible in stores that minors are not allowed to enter.’

On July 15-16, 2023 The Fort La Présentation Association was proud to host a variety of French and Indian (Seven Years War) reenactors, sutlers, and the public for "Le Siege du Fort de la Présentation" on Van Rensselaer Point in Ogdensburg.

The Association also joined forces for the first "Fort Fest" event. The Fort Fest was hosted by the Ogdensburg Chamber of Commerce. The Chamber had several vendors at the Fest which benefited both organizations by allowing visitors to examine the wares of the vendors who participated, as well as enjoying the Abbé Piquet Walking Trail and visit the camps, demonstrations, and sutler stores. Sutlers were merchants of the 18th and 19th century who provided needed supplies, for a price, to soldiers and citizens alike on the frontier.

The weather turned very warm, but that did not deter the reenactors or the observers from the stands, from having a very exciting experience.

The description of the battle was provided by St. Lawrence County Legislator Jim E. Reagen. We appreciate Mr. Reagen sharing his knowledge of this historical period.

The Siege of Fort Levi began on August 19, 1760. The English forces comprised of 10,000 allied troops and 1,000 First Nation warriors surrounded, by water, the small fort whose defenders were composed of 350 French troops, and Canadian militia. The Siege lasted three days before the French commander agreed to terms of surrender.

The siege of Fort Levi was, in effect, the last river battle of The French and Indian War on the St. Lawrence.

The association received letters of thanks from the reenactors expressing their gratitude for the hospitality and support the Association gives them each year. The reenactors travel from the Northeast and Canada, at their own expense to celebrate our mutual history.

We wish to thank all who participated, supported, and witnessed our event. Without your support we could not have achieved our success.

Let's not blame it on price of eggs

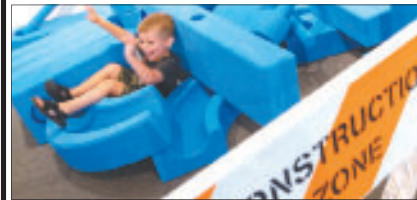

Generational grocery store

Peter Smith's Meat Market, a longtime staple of Norfolk, remains a primary grocery store for residents in town generations later. The Smith family also own and operate a pizzeria, hair salon and hardware store in the same block on Route 56.

A growing community

Downtown Norfolk, circa-1930's, was a bustling district with numerous businesses that supported a growing community of factory workers and loggers. Today, many of the previous buildings and businesses no longer exist as workers sought employment in larger towns.

Mills, railroad, library and fires part of Norfolk's history

On April 9, 1823, the town of Norfolk was divided from Louisville as a large swamp

forms a natural dividing line between Louisville and Raymondville.

Norfolk became a separate township in excess of 35,000 acres, when a section of

Stockholm was annexed.

On April 5, 1844, a portion was returned to Louisville, Raymondville soon became known as Lower Village to distinguish it from Norfolk, the Upper Village, and East Norfolk became known as Slab City.

The first Norfolk Village Post Office opened on May 22, 1823. The first saw mills were built in East Norfolk in 1824 and 1825.

The growth of the young town was reflected in the development of its churches: Grace Episcopal Church, organized in 1825. In 1820 the Episcopal Church Society had been organized by Russell Atwater. This church was destroyed in a 1915 fire which burned both sides of West Main Street and never rebuilt. The First Presbyterian-Congregational Church in Raymondville was formed in 1828 as a branch of the Norfolk village church.

Here are some Norfolk historical highlights:

- 1871: Present Town Hall was built, cost \$300
- 1874: First Butter Factory built by Charles Clark at Raymondville
- 1901: Remington-Martin paper mill built by Charles Remington and Orrin Martin and began operating paper mill and Norwood & St. Lawrence R.R. in 1902
- 1904: Raymondville Paper and Pulp Mill and R.R. extended to Raymondville
- 1906: Union High School opened
- 1913: First Norfolk High School graduating class
- 1915 and 1918: Two worst first in Norfolk history
- 1920: High school opened
- 1921: Hepburn Library opened on Hepburn Street
- 1922: New high school opened

cherished with their daughter. They will never get to hold her again. Howell, though, will not be forgotten. Her legacy as a musician and goal of becoming an educator will live on through scholarships established in her name. St. Lawrence County District Attorney Gary Pasqua did not mince words at the sentencing. He said that when Snow is up for parole two decades from now, whether he is a private citizen or a district attorney, he will do his best to convince the parole board that Snow should remain incarcerated for the rest of his life.

Pasqua revealed previously undisclosed details about Snow's plan to kill someone, which began more than two years prior. He said Snow twice attempted to purchase an AR 15 rifle, but had been denied. Snow was angry over the loss of a family member as well as co-workers whom he believed were at fault for him losing his job. Pasqua said he stalked the co-workers and had plans to take revenge on them and when they became aware of his plans he changed his course of action. He would instead take revenge on their employer SUNY Potsdam. His plan was then to hurt their reputation with an act of violence.

On Feb. 18, 2022, he put that plan into action.

His plan to kill someone was not spontaneous, according to Pasqua. Although the murder was planned, the victim was chosen at random.

She was simply walking home, when Snow beckoned her over to his vehicle under the guise of needing directions and shot her three times, Pasqua said.

Snow, himself, described Howell as "helpful" and "pleasant," in the moments before he shot her, according to Pasqua.

He says Snow has failed to show remorse for his actions.

Snow also spoke at sentencing. He said he regretted his actions and offered an apology to the family, but those in attendance did not appear

convinced by or concerned with his statement.

They weren't alone. Judge Craig P. Carriero agreed that Snow should remain behind bars for the rest of his life.

"All Beth was trying to do was help you with directions. And you killed her," he said.

Carriero did not know Howell. However, he was still touched by her as he read through the impact statements. He said that he believed she would have been the kind of teacher who would help talented musicians flourish while also ensuring those without such natural gifts could be drawn into and touched by music.

He said that in two decades on the bench, Snow's case was the worst. "The killing of Beth Howell was cold, random and senseless," he said.

He said that the record of the court will show that his actions were "evil."

In a brief press conference following the sentencing, Pasqua and his team and members of local law enforcement discussed the sentencing.

Pasqua said that quick action by multiple law enforcement agencies allowed his team to build a strong case against Snow and led to the plea that could keep Snow behind bars for life.

Pasqua was clear though, that even if Snow remains imprisoned, it will never bring peace to those who knew and loved Howell.

In an email sent to the SUNY Potsdam community President Suzanne Smith said grieving services were being offered and invited those looking to reflect and remember Howell to visit Cassie's Harp, a memorial space dedicated to all SUNY Potsdam students "who have been lost too soon."

"Our hearts are with Beth's family and friends, and with all members of our community who have been affected by her tragic loss—today and always.

For all who knew and loved Beth, there are no adequate words of solace or comfort, even as her murderer is sentenced. A talented Crane School of Music student, Beth was a

gifted cellist and an aspiring music teacher who was beloved by all who knew her. She was set to graduate with honors in May 2022.

Right now it detracts from the community. Hopefully these projects can make the properties more attractive," said Smith.

For more than a decade Ogdensburg has sought action on vacant and dilapidated psychiatric center properties, which remain off the tax roll and out of reach for development.

Assemblyman Scott Gray said the news is a major win for Ogdensburg.

"Today's news that DASNY will begin demolition of the Letchworth Building Complex, otherwise known as the St. Lawrence Psychiatric Center, is a win for Ogdensburg, St. Lawrence County, and the North Country as a whole. Abandoned since 1988, these buildings have deteriorated into not only an eyesore but a public safety hazard as well," Gray said.

He said the demolition of the Psychiatric Center is a much-needed first step in the development of abandoned properties.

One of the strongest advocates for action on the properties was former New York State Sen. Patty Richie.

Ritchie and her then staffer, but now County Legislator Jim Reagen had sought to see 160 acres of unused land at the psychiatric center returned to the community for economic development and job creation as far back as 2013.

Although the demolition of Letchworth is a far cry from that plan, she says it's a step in the right direction.

"Former State Senator Patty Ritchie and I worked very hard to make Albany aware of the problems the state caused Ogdensburg by abandoning these buildings with no plans to redevelop them or get them back on the tax rolls," Reagen said.

"It's unfortunate that many of these beautiful buildings were allowed to deteriorate to the extent that their floors collapsed and they could not be redeveloped. But we are very pleased that the state is now tearing them down. We hope this is the first step in a new attitude in Albany in which the state will work with local officials to get this property back on the tax rolls and back into productive use."

That concern was shared by Sen. Mark Walczyk as well as Smith.

"I'm glad to see that they are finally acknowledging this issue and doing something with these buildings that have been dilapidated since the late '80s," he said. "It's a good start."

Walczyk said that buildings likely contain quarry-cut stones and old-barn style beams that have historic value and should be preserved.

Smith shared that sentiment. "The material and construction are of such high quality that there is potential for reuse," she said. She said the buildings should never have been left to fall into disrepair as they are "historic gems."

Walczyk said he's issued a letter seeking clarification on the preservation of materials as he doesn't want to see historical materials "thrown into a pit."

As recently as this year, Ogdensburg City Councilors have renewed calls for the state to take action on the psychiatric center's dilapidated properties, which they say are unsafe.

Among the most vocal about the properties is Councilor John Rishe who has been pushing for legislation that would allow the state to make payments in lieu of taxes on properties that it owns, but do not no longer provide economic benefits.

That's something Assemblyman Gray needs to continue.

Over the last 40 years the St. Lawrence Psychiatric Center has downsized substantially and more recently the state closed Ogdensburg Correctional Facility. Rishe and his fellow councilors have asked the city to repurpose the prison and have long called on the state to at least tear down the "dangerous" buildings at the psychiatric center.

Smith says the council is set to discuss the project at the Aug. 14 meeting and she is asking residents who are supportive or those with concerns about the project to share them then.

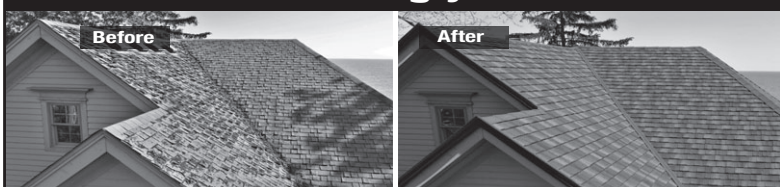
