# Massena Rite Aid set to close

MASSENA — The village of Massena will soon have just two pharmacies following the announcement that Rite Aid is slated to close on Sept. 20.

The announcement came via a company email that stated the store will close at the close of business on Sept. 20.

In the email, officials said that

customers can pick up prescriptions at the Walgreens Pharmacy, located at 303 Main Street.

Kinney Drugs is also located across the street from Walgreens at 300 Main Street.

The decision to close the Rite Aid location did not come lightly, as company officials stated that, like all retail businesses, locations are reviewed periodically.

After consideration, company officials say the decision to close

was "based on a variety of factors, including business strategy, lease and rent considerations, local business conditions and viability and store performance."

Company officials also say other factors are weighed in these decisions, including neighborhood reviews to ensure "customers will have access to health services, be it at Rite Aid or a nearby

# **Developer sets** eyes on former **Ogdensburg prison**

 ${\tt OGDENSBURG-A\,Watertown}$ developer told city council Monday he's interested in developing the former Ogdensburg Correctional Facility and St. Lawrence Psychiatric Center properties, but details on the project were very limited.

Rick St. Jean, Kirkland Realty trustee, told the council he'd like to develop affordable housing using the state properties.

St. Jean estimated ambitiously that the a \$300 million to \$400 million project could include housing at the prison as well as a business turning shipping containers into small homes that could be shipped out of the area.

St. Jean shared the vision with council in hopes of securing an endorsement he could submit alongside his proposal to the state.

Councilor Dan Skamperle thanked St. Jean for coming before the board, but said that as a member of the Prison Task Force, he'd like to see the facility used for manufacturing or light industry.

Skamperle said he did not believe the plan laid out by St. Jean fit that vision and said he believed that the city had enough low income hous-

St. Jean pointed out that affordable housing and low income housing were not the same thing.

Councilor John Rishe offered appreciation to St. Jean for speaking with council and said that he was glad to see a private company showing interest in developing the properties that have long been off the tax rolls.

Council did not commit to offering a letter of support.

St. Jean said he would be attending a Watertown City Council meeting to share a similar proposal in that area.

Governor Kathy Hochul established a New York Prison Redevelopment Commission, to reimagine closed prisons across New York State for innovative redevelopment.

# County legislators opposed to plans for housing migrants from NYC

CANTON — St. Lawrence County legislators say they are in direct opposition to potential executive orders that could be utilized to force the county to house migrants currently based in New York City.

The resolution comes after New York City officials floated the idea of sending migrants to the North Country when New York City Mayor Eric Adams mentioned the possibility of sending migrants to the Massena International Airport.

Legislators approved the resolution unanimously during the full board meeting on Sept. 11, saying such a move would have dire consequences for migrants

and North Country residents

Legislator John Gennett was not present for the meeting and was therefore unable to cast a

Massena has been in the crosshairs of New York City officials for several weeks now, first with the owner of the Quality Inn hotel first floating the idea of using his property to house up to 180 migrants in downtown Massena.

That idea was met with resounding opposition by local, state and federal lawmakers who all said the plan was a non-start-

Just a few weeks later, a report from CBS News listed Massena International Airport as a possible location for housing migrants at the suggestion of the Department of Homeland Security.

Once again, local, state and federal lawmakers shut down the idea, saying the airport has no space to house anyone and is fully utilized. Some lawmakers also raised security concerns with the idea, noting the airport handles multiple flights daily to and from.

Between the spring of 2022 and Aug. 2023, over 100,000 migrants have entered New York City, straining resources, according to city officials.

Those migrants are largely coming from the southern border via bus after Texas Governor Greg Abbott used executive authority to remove the migrants from

# **Village condemns Orvis Street building**

MASSENA — Village trustees have condemned a fire damaged property located at 23 1/2 East Orvis Street following a public hearing on Sept. 12.

Officials say the property is dangerous and unsafe following the fire and is in direct violation of village code

Village of Massena Code Enforcement Officer Aaron Hardy said a number of neighbors adjacent to the property have filed formal complaints with his office, saying they are concerned about the structural integrity of the building, about the potential for it to damage properties around it, as well as trash and debris from the site.

"We've also found animals living in it as well," Hardy said.

A structure fire damaged the property in 2022 and no improvements have been completed short of a partial board up of large openings, according to Hardy.

Village Attorney Matthew McArdle, who operated as the hearing officer on Sept. 12, asked Hardy if

the property remained in the same condition today as it did in March 2022 after the fire.

"It's continually getting worse," Hardy replied.

Hardy told trustees and McArdle that he completed every requirement before recommending the property be torn down. According to Hardy, two notices were sent to the owner on file, and a phone call to the owner's lawyer went unreturned despite the attorney saying they would call back. Hardy said he also completed an inspection on Aug. 7, 2023 that included a full walk around, photos of the property, photos of the interior of the property from areas that remain open and a video from the day of the fire.

Those photos and videos were submitted to McArdle and trustees to paint a picture of the extent of the damage.

As part of village code, Hardy also said the property was in violation of multiple aspects of village code chapter 120, which governs unsafe structures in the village. Under the code, the property is violation due to extensive foundation damage, improperly distributed loads due to

fire damage, inadequate sanitation, large openings due to fire damage, along with smoke damage, insufficient stairways, lack of egress, detached parts that are on the verge of falling down and other dangers that present health and safety concerns to the public and neighbors.

According to Hardy, animals have also been seen coming and going from the property.

When asked what his recommendation would be for the property, Hardy did not hesitate.

"My recommendation is that the structure should be demolished and torn down," Hardy said.

Trustees followed Hardy's lead, voting unanimously to remove the structure if the owner does not bring it into compliance with village code, a feat that Hardy said will be impossible to do given the extent of the damage from the fire and the decay of the property over the last year and a half.

"This has been an issue within this community for quite some time and the neighbors would be happy to see it removed. I'm concerned this structure may not last another winter," Hardy said.

# Town officials to hold budget workshops

MASSENA - Town of Massena officials are slated to hold budget sessions during the afternoon of Sept. 20 prior to that day's regularly scheduled town board meeting.

Beginning at 2:30 p.m., town council members will hear from representatives with the Celine G. Philibert Cultural Centre and Museum, dog control, Greater Massena Chamber of Commerce, Highway Department, Massena International Airport and Massena Public

All budget sessions are open to the public.

At a recent board meeting, Council Member Debra Willer noted that library staff had finalized and submitted the budget prior to the meeting, well in advance of the deadline before budget sessions.

Further budget sessions will be held at 3:30 p.m. involving Massena Meals on Wheels, Massena Senior Citizens, the town assessor town clerk, town court and town tax

Once budget sessions are completed, the regularly scheduled board meeting will be held beginning at 4:30 p.m., which includes two public hearings.

First up will be a public comment period for a planned local law that would create a moratorium on the development and construction of new billboards throughout the

Officials say the current moratorium is set to expire Feb. 28. An extension of that moratorium will allow town officials to create further regulations regarding billboards.

Council members previously said that planning board members were warned that new plans to develop billboards would likely come through in the near future, something that the town council needs to further address as well.

According to Council Member Francis Carvel, it's only a matter of time before more billboards are put

"It might be time to come up with some sort of code. How many more are we going to get? How close together are they going to be," he asked.

Deputy Town Supervisor Pat Facteau suggested there be control for different spots in the future to ensure the town is not inundated with signs.

Town law states that billboards are only allowed in Neighborhood Commercial and Highway Commercial districts, with planning board approval.

Town council members are also expected to seek authority to override the 2% tax cap for the 2024 budget, if necessary.

That public hearing will also come at the beginning of the regularly scheduled town council meeting at 4:30 p.m.



# **Public health director resigns**

CANTON — St. Lawrence County Public Health Director Jolene Munger has informed county administration that she is resigning from her position on Jan. 31, County Administrator Ruth Doyle said in an official county statement Friday, Sept. 8.

Munger took over as the Interim Public Health Director on March 27, 2021, a position she held until she was appointed as the Public Health Director on April 5, 2022.

St. Lawrence County Board of Health President Dr. Andrew Williams, MD, thanked Ms. Munger for her service.

"The last few years have seen great change within the health field, specifically in the arena of public health. We appreciate Ms. Munger's willingness to serve St. Lawrence County during the past several years," Williams said.

Doyle echoed Dr. Williams' senti-

"Jolene served at a difficult time in the history of public health. St. Lawrence County appreciates her service and wishes her the best in her future endeavors," said Doyle.

Munger's departure from the St. Lawrence County Public Health Department will be preceded by a period of leave, prompting an early search for a replacement.

The St. Lawrence County Board of Legislators, in conjunction with the St. Lawrence County Board of Health, is likely to begin a search for a replacement as soon as possible.

# Louisville, Norfolk residents to see tax drop

MASSENA — Tax rates have been approved by the Massena Central School District board of education and taxpayers in both Louisville and Norfolk will see a tax rate decrease.

Residents in Massena and Brasher will see slight increases in their school taxes, with Brasher rising 0.19% and Massena's rising 0.05%.

Tax rates stand at \$17.667277 for Brasher, \$23.103363 for Louisville, \$18.313691 for Massena and \$21.724947 for Norfolk.

The tax rates remain relatively flat after the 2023-24 budget had no tax levy increase.

The total tax levy to be collected is \$14.8 million, the same as the previous fiscal year, officials say.

This all comes after equalization rates went down across the board,

meaning properties are assessed at less than they are worth.

An equalization rate is the measure of a municipality's assessment of properties and comes from the percentage of the assessed value compared to the market value of properties.

In the case of Brasher, the town's equalization rate stands at 85% compared to Louisville's equalization rate of just 71%.

When compared to previous equalization rates, each municipality in the district dropped a fair margin, with Brasher dropping 10.5%, 10% in Massena, 9% in Louisville and 6% in Norfolk.

"Ideally your equalization rate should be 100%, right," Board President Paul Haggett asked.

Haggett said it appeared the four townships appeared to be looking at a revaluation in the near future,

which would lead to equalization rates rising.

According to business manager Nickolas Brouillette, it is possible rates might drop after a revaluation.

"It's up to the local taxing jurisdictions whether they want to do a reval or not. Some areas have a considerably lower rate than we have. But Massena did just start trending downward in the last couple of years. They've held it at 100% for a long time," he said.

Brouillette also told board members that taxable assessed values increased in each of the four towns, with Norfolk seeing the highest percent change at 2.57%. That represents a nearly \$1 million increase.

He said that in many cases improvements to properties and new builds played a large part in the nearly 0.8% change seen district

# Village tax revenue higher than expected

MASSENA - The village of Massena has received more tax revenue than expected, according to Treasurer Kevin Felt.

Felt informed village board members that sales tax receipts came in \$147,098 over the budgeted amount of \$2,255,000.

The total tax revenue of

\$2,402,098 represents an 8.8% increase compared to the previous fiscal year, Felt said.

Felt also passed along more good news, saying the village received a sales tax payment of \$593,065 for the fourth-quarter from St. Lawrence County. That sales tax revenue figure was 8.7% higher compared to the previous fiscal year's fourth-quarter.

"That's good news. It will be nice

to see if that trend continues still," Felt said.

Trustees also made a change to the payment plan for a new ambulance at Felt's urging.

With the change of plans, the village will put down 20%, plus \$100,000, for the ambulance as opposed to the 10% down payment originally planned.

Felt noted that the higher down payment will allow the village to lock in a lower price for the equipment that is being added to the chassis.

That move comes after Aaron Hardy, fire department foreman and village liaison to the rescue squad, said the cost of equipment would rise 8% in October. Hardy said it was important to take action and lock in the price now, saving the village thousands of dollars in the future.

"It's going to be a significant increase on all the equipment that we're looking to have new on that ambulance. So, that's to lock it in now," Hardy said.


The new plan to pay a larger down payment for the ambulance means the village will not be required to pay additional costs down the road. Those funds were budgeted already, according to Mayor Greg Paquin.

Trustees also approved a \$6,000 transfer from the Department of Public Works' water contingency account to cover a shortfall in annual credit card processing fees.

# Coalition seeks to raise suicide awareness throughout the county

CANTON — Members of the St. Lawrence County Suicide Awareness Coalition are taking steps to educate the public about mental health concerns in an effort to reduce the number of suicides throughout St. Lawrence County.

Officials with the coalition recently presented the organization's future plans during the county legislature's full board meeting on Sept. 11.

Officials with the coalition say the county has been struck by a number of high profile suicides in recent years.

Officials say they met with a number of organizations and coalitions in 2022 to enhance and refine the coalition's offerings.

New systems were put into place, along with the creation of new bylaws, as part of the new plan.

Member agreements were also created and a new member recruitment pack was created to boost the coalition's numbers.

# Woman airlifted after crash

Sherry L. Langevin, Oswegatchie was extricated from her Ford Explorer after it was struck by a semi-truck being driven by Kira Craw of Mexico, NY, deputies said.

Langevin is currently listed in stable condition.

U.S. Highway 11 was shut down for about three hours following the accident as deputies investigated the scene.

# Masks back on at SLH

A facility-wide masking mandate has been implemented once more at all St. Lawrence Health facilities due to a substantial uptick in reported COVID-19 infections.

All SLH facilities fall under the mandate.

Facilities include Canton-Potsdam Hospital, Gouverneur Hospital, Massena Hospital, Edwards Health Center, St. Lawrence Health Medical Campus in Canton, E.J. Noble Professional Building in Canton, Helen Snell Cheel Medical Campus in Potsdam, the MH Medical office building in Massena, and the 20 Cottage Street Medical Campus in Potsdam.

Patients, visitors or staff arriving at any of the SLH buildings who do not have masks of their own can pick one up at the facility entrances.

SLH had previously implemented facility-wide, universal mask mandates during the pandemic, until the end of the COVID-19 Public Health Emergency Declaration by the U.S. Department of Health and Human Services on May 11. Masking still continued in certain highrisk areas, including areas serving immunocompromised patients.

The newest mandatory masking protocol is reportedly in response to an increase in reported COVID infections within the county and at the health system facilities.

Lindsay Best, a steering committee was formed to hold monthly meetings that will help guide the coalition's efforts and to make important decisions about its future.

The steering committee consists of Alexa Backus Chase, Lindsay Best, Patti Hogle, Anne Marie Snell, Jay Ulrich, Michele Catlin and Mary Wills.

The executive committee also consists of a number of members, including Chair Lindsay Best, Vice Chair Anne Marie Snell, Treasurer/Secretary Michele Catlin, Education Workgroup Chair Alexa Backus Chase and Awareness Workgroup Chair Patti Hogle.

The coalition also has a clear mission statement now, she said.

Backus-Chase also spoke to the seriousness of suicide in the county, breaking down a number of figures for legislators.

According to Backus-Chase, there have been 11 suicides in St. Lawrence County thus far in 2023.

In 2022, the county experienced 12, while 2021 saw nearly 20 suicides county wide.

In the majority of instances, men are more likely to commit suicide, with all suicides in 2023 being men, she said.

Since 2006, the county has seen nearly 300 suicides, with the most coming in the 40 to 49 year age bracket with 45 suicides. Persons in the 50-59 year age bracket rank second with 43 suicides and persons in the 20-29 year age bracket rank third with 36 total.

In most cases, Backus-Chase said suicides come from firearm use, however other methods have included hanging and overdoses on medications.

Officials with the coalition track the deaths by obtaining coroner reports, though it is not always possible to obtain the information from each report, she said.

Due to the increasing number of suicides, Backus-Chase said the coalition have stepped up efforts to help remove the stigma about seeking help for mental health issues while raising awareness about suicide prevention.

Education has been a large focus for the group, with QPR training being a large facet.

QPR training is a 60 to 90 minute, lifesaving, evidence-based suicide prevention intervention training, officials say.

Like CPR, QPR is a simple process anyone can be trained to use to help save a life of someone contemplating suicide. QPR training allows them to recognize risk factors and warning signs of suicide, know how to offer hope and know how to get help and save a life.

A total of 120 individuals have received QPR training to date including individuals in higher education, law enforcement, school nurses, hospital staff, inpatient substance use treatment, office for the aging meal site staff and veterans.

Classes are free and sponsored by the St. Lawrence County Suicide Awareness Coalition with class sizes ranging from 15-25 attendees with no more than 35 allowed, officials say.

Coalition members have also been raising awareness for suicide prevention through a 988 billboard campaign in recent months. 988 is the national suicide prevention hotline.

Coalition members are also reaching out to students in area schools through "Gizmo's Pawesome Guide to Mental Health," Backus-Chase said.

The initiative, held in conjunction with the St. Lawrence County Youth Bureau and St. Lawrence County People Project, is a "proactive approach to support mental health which is both data-driven and evidence informed."

Backus-Chase said the coalition is teaching students self-care strategies in a non-threatening way to self-identify the warning signs and how to practice healthy coping exercises.


Students are also taught how to learn characteristics of trusted adults and "how to open communication when it's uncomfortable due to feelings and fears."

The program was introduced in the spring of 2023 and has visited 12 school districts so far, including Ogdensburg, Hermon-DeKalb, Heuvelton and Norwood-Norfolk.

Backus-Chase said the coalition plans to schedule more events with area schools and classrooms throughout this fall.

MASSENA — The village of Massena has received more tax revenue than expected, according to Treasurer Kevin Felt.

Felt informed village board members that sales tax receipts came in \$147,098 over the budgeted amount of \$2,255,000.

The total tax revenue of \$2,402,098 represents an 8.8% increase compared to the previous fiscal year, Felt said.

Felt also passed along more good news, saying the village received a sales tax payment of \$593,065 for the fourth-quarter from St. Lawrence County. That sales tax revenue figure was 8.7% higher compared to the previous fiscal year's fourth-quarter.

"That's good news. It will be nice to see if that trend continues still," Felt said.

Trustees also made a change to the payment plan for a new ambulance at Felt's urging.



# County leaders oppose ammo fee law

CANTON - St. Lawrence County legislators have voiced opposition to the state's new fee and background check scheme for ammunition pur-

During the legislature's full board meeting on Sept. 11, legislators voted to approve a resolution outlining the body's opposition to the laws, which were implemented through the Concealed Carry Improvement Act (CCIA) in 2022.

The vote was a roll call vote at the request of Legislator Glenn Web-

Thirteen legislators voted in favor of the resolution, with Legislator Margaret Haggard being the lone 'no' vote. Legislator John Gennett was not in attendance for the meeting.

Under the CCIA, state police will handle all firearm and ammunition background checks with the state's move to a Point of Contact state.

Under the previous system, state gun dealers would call in background checks to the FBI National **Instant Criminal Background** Check System to conduct all background checks on firearm purchases at no cost.

Now, dealers will have to submit information for both firearm and

ammunition purchases to the state police, who will act as an intermediary for dealers.

The information will be submitted to NICS by the state police, who then relay the decision back to

Before conducting a background check, dealers must pay \$2.50 per background check for an ammunition purchase and \$9 for all firearm background checks.

Prior to the CCIA, dealers did not conduct background checks on ammunition and no fees were required to conduct said checks.

In the resolution, legislators cited District of Columbia v. Heller, McDonald v. City of Chicago and NYSRPA v. Bruen as primary cases that asserted an individual's right to keep and bear arms that extended outside of the home for self-defense.

Legislators say the CCIA and its proponents are a way to circumvent those decisions while depriving citizens of their right to self defense and is another way the state will "flout the Bruen precedent" by creating another set of new, stringent requirements in order to obtain a concealed carry license.

In the resolution, legislators also noted the multiple ongoing lawsuits against the state in relation to the CCIA, saying the legislators have also authorized County Attor-

ney Steve Button to explore legal options to challenge the CCIA.

Button is currently serving "of counsel" in the ongoing Antonyuk v. Bruen case after legislators approved his participation last fall.

In that case, a judge in the Northern District of New York Federal Court struck multiple portions of the CCIA, however the Second Circuit Court of Appeals reversed that decision, allowing the CCIA to stand almost in its entirety.

"The initial decisions regarding the Concealed Carry Improvement Act makes clear that the legislation is constitutionally infirm and should not continue forward," the resolution states.

Legislators say a copy of the resolution will be sent to Governor Kathy Hochul, Senator Mark Walcvzk, Senator Dan Stec, Assemblyman Ken Blankenbush and Assemblyman Scott Gray.

Despite the recent increase in voter turnout, too many eligible Americans still fail to exercise their most essential democratic rightthe right to vote freely.

Out of 49 professed democracies, the United States, ranks 31stbetween Greece and Colombia, in the percentage of eligible voters who turn out at the polls.

This would be disturbing at any time, but it is particularly alarming now, when, as most of us would agree, the stakes will be so high in the coming elections, especially in

The goal of National Registration Day (NVRD)—a nonpartisan civic holiday celebrated every September—is to encourage all eligible citizens to make sure they are properly registered.

Every year, millions of Americans find themselves unable to vote because they miss a registration deadline, forget to update their registration after they move, or just aren't sure how to register.

On NVRD, organizations ranging from Fortune 500 companies to local food banks and public libraries join forces for a one-day, nationwide democracy blitz to create broad awareness of voter registration opportunities and pro-

This year, National Voter Registration Day is September 19. In St. Lawrence County, the League of Women Voters will be celebrating NVRD by staffing registration tables at SUNY Canton and SUNY

For students who prefer to vote at home, where they may feel more familiar with local issues, we use

a NVRD QR code and website to direct them to their home state's Board of Elections to register and, if their state allows it, request an absentee ballot online.

In addition to registering voters, NVRD seeks to make registrants "Vote Ready" by explaining state-specific deadlines, policies, and options for casting a ballot, and providing information on local

This November, most elections will be local. Because voter turnout tends to be lower for local elections, individual voters have far more electoral clout.

From property taxes and police funding to trash pickup and school curriculum, the decisions of local officials have direct effects on our daily lives.

Registering and voting enable citizens to actively engage in democratic self-government, from the most momentous issues to the most locally relevant.

The League of Women Voters urges all eligible citizens to first make sure you are properly registered, then, come November, get out there and Vote It Counts!

no less compelling than that of our nation's beloved 16th president, Abraham Lincoln, and parallels that of Lincoln's in several ways. It becomes clear, upon learning more about each man, that they were the right men, in the right places, at the right time, to guide America through a terrible and tragic period.

One thing that stood out in my reading about Ulysses Grant is how much the American "press" of his time, now known as "the media", attempts to influence our nation's direction, for good or bad.

Just like today, news organizations of the 19th century tended

to have a bias such as pro-slavery, or pro-Union. And, in the 1850s American leaders failed to seize the chance to head off a regional conflict that devolved into four years of bloody civil war, fought over states' rights and slavery.

By 1860, and Lincoln's election, we were a divided nation, North and South.

Today, I feel we are divided again, with media giants pushing Americans further apart based on our moral standards: conservative versus liberals, right versus left, good versus evil.

As South Carolina's U.S. Senator

and GOP presidential candidate Tim Scott said in a recent AMAC interview "Our nation, our shared values, and our people are strongbut our leadership is weak." He added, "We've worked for 250 years to create a more level playing field, a more perfect union, and life in America has never been more fair and free.

Reader, please take time to learn your American history, and maybe, God willing, We, The People, can head off another civil war on this continent.



Wimpy's Inn first opened its doors in 1932 by a man named Ed Peterson.



Addiction is not solely about the individual struggling.

"When an individual is struggling from addiction, it doesn't mean they are a bad person or there is something wrong with them. It just means they are human and need support," Doyle said. Something happened to that individual to bring them to that point, and instead of judging or labeling them, we need to ask them what happened and how we can help. Recovery is possible."

Recovery Month celebrates

everyone who is in recovery from a substance use disorder, and points out how recovery is possible for individuals who are not seeking help, or who have had a recurrence. Since the first Recovery Month in 1989, tens of millions of Americans have been able to share their stories with the world, which helps to create hope for those who are still struggling.

According to the National Institute of Alcohol Abuse and Alcoholism, alcohol continues to be the number one substance when it comes to deaths in the United States. In 2021, there were 140,557 individuals who died from an alcohol-related death. Alcohol use disorder can start at any age, and may be the result of environmental factors, genetics, or psychological diagnosis. In 2021 there were 29.5 million Americans ages 12 and older with an alcohol use disorder.



pharmacy, and we work to seamlessly transfer their prescriptions so there is no disruption of services. We also strive to transfer associates to other Rite Aid locations where possible."

Village officials say they plan to work with the St. Lawrence County Industrial Development Agency in a combined effort to fill the space quickly.

This is the second time a pharmacy has closed in the North Country this year, following the closure of Canton's Walgreens Pharmacy on March 6.

That location, which was formerly a Rite Aid store, opened at the East Main Street location in 2018 following a move from the Jubilee supermarket plaza.

The former East Main Street Walgreens will soon reopen as an Ace Hardware store.

unveiled in Unlocking Opportunity: The Report of the Prison Redevelopment Commission, a 140-page report that includes detailed site analyses of 12 closed prisons and considers redevelopment opportunities for each site to help them better serve the State's economic needs.

Though little was detailed about potential reuses for the Ogdensburg Correctional Facility which closed last

Ogdensburg City Council has been vocal regarding concerns that the building should not be left to fall into disrepair. Council was successful in convincing the state to keep the heat on at a level that would prevent deterioration of the facility.

declared a state of emergency, which was quickly followed by the county also passing a state of emergency.

Thirty of 57 counties outside of New York City have declared a state of emergency, legislators say.

In doing so, the state and county both could potentially qualify for federal aid to assist with the migrant crisis.

County legislators noted that New York City has struggled to respond to the arrival of the migrants, with Adams recently taking steps to discourage migrants from seeking refuge in New York City. Adams has also sought help from state officials to disperse the migrants around the state to alleviate the strain on city resources.

In response, Governor Kathy Hochul has pledged that no county or municipality will be forced to assist with housing migrants and only those who have pledged support will be asked to assist.

"We cannot and will not force other parts of our state to shelter migrants. Nor are we going to be asking these migrants to move to other parts of the state against their will," Hochul said on Aug. 24.

Adams also urged Hochul to pass an executive order to move migrants out of the city and into upstate communities, while also requesting \$6.5 billion in aid from the state, according to the resolu-

Another hangup with Adams' plan is that local municipalities will also not receive any resources for migrants placed after Dec. 31, 2023, leaving local taxpayers to foot the bill, according to the resolution.

Legislators also raised concerns about the inclusion of state universities on a list of possible sites to house migrants that was advocated for by the City Law Department.

Officials have said on multiple occasions before that both SUNY Potsdam and SUNY Canton would not house migrants and were never formally considered for inclusion in a plan to do so.

Legislators also say the placement of migrants around the state "merely shifts the problem from the city of New York to other counties, rather than solving the problem."

Though the resolution praises Governor Hochul for opposing Adams' plan, legislator Margaret Haggard did voice a

concern that the title may be misleading, noting that no executive orders were ever passed.

"There weren't executive orders, it was a suggestion by Eric Adams, mayor of New York City. It suggests there was an executive order, there wasn't," Haggard said.

"If somebody looks at this they're going to think that the title is incorrect," she continued. Legislator Joseph Lightfoot noted that the resolution is intended to cover what may or may not happen, while County Attorney Steve Button pointed out the body

of the resolution clearly states the intention of the legislature and the governor's opposition to the plan from city officials.


