## Hydrogen plant plans moving forward

MASSENA -- LaBella Associates, D.P.C. will conduct an evaluation of the water treatment plan for a proposed hydrogen production facility in the town of Massena.

Village officials signed off on the deal during the board's Dec. 19 meeting, saying the green hydrogen production facility, which will be owned and operated by Air Products, will need to meet strict regulations.

The village was recently awarded an Empire State Development grant for \$38,500 to help cover the cost of the \$77,000 study.

Mayor Greg Paquin said the grant funding will be used to evaluate the village's water treatment facilities and water tower, which LaBella will assist with.

That process will help speed along development of the green hydrogen facility in the coming months, officials say.

The facility, which will inhabit over 84 acres on Pontoon Bridge Road, is in the planning stages currently, however land clearing has been underway for some time now with lumber being removed from the site.

Department of Public Works Superintendent Marty Miller said a verbal

## Volunteer EMS shortage raises concerns about response times

Imagine experiencing a medical emergency, calling for an ambulance and waiting more than an hour for help to arrive.

Although uncommon, that's happening more frequently in St. Lawrence County as emergency medical providers struggle with volunteer shortages.

With the new year underway, St. Lawrence County Bureau of Emergency Medical Service issued a letter to St. Lawrence County EMS agencies and municipal leaders showing that a high number of turnover calls occurred last year.

"Call turnovers are considered any call in which the agency is toned and is unable to respond with an ambulance, thus requiring mutual aid," the report says.

This can be due to a variety of reasons including

inability to staff an ambulance with the appropriate personnel, multiple calls for the agency resulting in no apparatus available and a variety of other issues.

"It is important to note that a call turnover results in having to dispatch an ambulance from another jurisdiction, reducing that mutual aid ambulance service's availability to provide coverage for those in their primary response territory," the notice says.

The notice notes that intervention is needed, but exactly what that might look like remains to be seen.

"EMS in our County is struggling, and intervention is necessary to keep the system afloat and operational. County call turnover statistics, as displayed above, are at an all-time high (2020: 94% coverage rate, 2021: 90% coverage rate, 2022 88% coverage

# Illegal border crossings raise concerns among state officials

MASSENA -- Illegal border crossings rose over 550% in the Swanton Sector, which encompasses the entire north country, and state representatives want Governor Kathy Hochul to provide more resources to stem the tide.

## Northern Border Crossings

According to U.S. Border Patrol officials, Border Patrol agents apprehended 1,850 subjects from 43 different countries in October and November 2023 alone. Those figures surpassed the number of apprehensions in fiscal year 2021 and 2022 combined, officials say.

In total, migrants from 79 different countries were caught in the Swanton Sector in 2023, officials say.

Though the numbers are nowhere near those seen on the southern border, Senators Dan Stec, Joe Griffio and Mark Walczyk submitted a letter to Hochul to request state resources to combat the rising numbers.

The three senators raised a number of concerns regarding the number of migrants entering the country illegally from Canada, saying policies need to be addressed.

"We are not insensitive to people fleeing oppression and seeking a better life elsewhere and recognize that federal immigration policies

need to be addressed, strengthened and revised to ensure that those entering our country do so legally and properly," the senators wrote. "However, we believe that it is imperative that New York take whatever actions are necessary to ensure that its residents, families and communities are protected and that its border is secure."

The senators spoke to the issues agents are having on the northern border, which encompasses roughly 295 miles across New Hampshire, Vermont and New York, saying there were more migrants caught crossing in 2023 than there had been in the previous 10 years combined.

Border protection is largely a federal issue, however the senators requested assistance from state law enforcement in the letter.

"Reports such as this highlight the need for further action from your administration, and we ask that you examine and consider all options that may currently be available to address this issue. This can include additional funding for increased state and local law enforcement patrols along the border as has been done recently in New Hampshire and further collaboration with local,

state and federal partners," they wrote.

## St. Lawrence County Responds

In St. Lawrence County, legislators have continued to extend a state of emergency revolving around the migrant crisis.

The extension now means the state of emergency will run until at least February 4, at which time county officials will once again assess the ongoing situation and decide whether to extend the state of emergency for an additional 30 days.

County officials have said in the past that the state of emergency was put in place to address concerns surrounding the ongoing migrant crisis in the state.

St. Lawrence County shares 75 miles with Canada, which some officials say poses a risk of migrants crossing to seek shelter in the state.

County officials say St. Lawrence County consistently ranks in the state's top ten most impoverished counties in the state, saying the county is "ill-equipped" to meet the potential needs of migrants.

## Massena Hotel Considered

Much of the attention on the

border crisis revolves around the thousands of migrants apprehended every day on the southern border but with Texas Governor Greg Abbott bussing migrants into New York City every day, state officials are looking for solutions. To date, well over 110,000 migrants have been shipped to New York City, despite city and state officials saying there are nowhere near enough resources to care for them.

New York City Mayor Eric Adams has made numerous requests to Hochul in the last year, including permission to send migrants to upstate communities.

That move prompted over 20 counties to pass resolutions that would make it illegal for private business owners like hotel and motel owners to house the migrants in exchange for financial assistance from the state. In response, lawsuits have been filed to contest the county restrictions, many of which are still playing out in court.

One such instance arose in Massena, when Gary Melius, owner of the Quality Inn Hotel in downtown Massena, attempted to lobby state officials and New York City Mayor Eric Adams to house migrants at the struggling hotel.

There was only one catch. Melius was behind on his tax payments and owed over \$385,000 to the county. Though that was averted, the back taxes were paid by the lien holder, according to St. Lawrence County Attorney Steve Button.

Local officials in Massena shot down the idea of housing migrants at the hotel, citing code regulations that would disallow the property from even being considered.

Massena Mayor Greg Paquin and Town Supervisor Sue Bellor both spoke to the situation, saying the state had "not done their research" and should go back to the drawing board.

"We would all be setup for failure. The migrants and village both would be set up for failure and I think the state knows that," Paquin said.

Bellor also spoke to the situation previously, saying the extensive needs of the migrants make it nearly impossible to care for them properly in Massena.

"While I understand that the migrants are in a challenging situation in the large cities, how will the situation be improved in a small village in a small town without any municipal transportation and with limited healthcare," Bellor asked.

## Massena Airport on DOH List

Just two weeks after that news broke, Massena was once again in the cross hairs of Adams and city officials.

Homeland Security Secretary Alejandro Mayorkas provided Adams with a list of 11 potential sites to house asylum seekers last August, a list that included Massena International Airport.

The inclusion of the airport drew the ire of local, state and federal representatives who called on the city to address the migrant crisis by other means.

Bellor previously told NCTW that town officials were completely in the dark when the news broke.

"We have not been communicated with in any way. We have yet to hear anything from state officials regarding the situation. It makes me wonder if they have done their due diligence and actually researched what the airport has to offer. There certainly are no living quarters or housing options there," Bellor said.

It remains to be seen whether the governor will take direct action on the migrant crisis, however state officials say Hochul will cover the topic in her third star of the state address on Jan. 9.

# County launches emergency update text service

CANTON — Simply text Lawrence to 67283 and you will be among the first to know about potential emergencies that may occur when thousands of tourists

flock to St. Lawrence County to view the full solar eclipse on April 8.

During the operations committee meeting on Jan. 8, legislators approved a contract with Rave Mobile Safety to implement an alert notification program. Legislators also approved a budget modification

to fund the program. The cost will be \$23,941 and will come from a contingency account.

In a presentation to the board prior to the vote, Joseph Braun, account executive for Motorola Solutions, gave legislators a preview of the program's capabilities.

Braun detailed the opt-in process for those interested, saying that texting Lawrence to 67283 is the easiest and fastest method, but residents can also sign up online.

When first signing up, users will receive a text with a message to opt-in to receiving alerts. Once the user has opted-in, messages sent by the Emergency Services Department, Sheriff's Office and other support services can be received via text, email, voice call, RSS or social media.

Users are able to opt out at any time if so desired and are even able to opt-in for a set period.

"They can opt in for any length of time or forever if they want to. Even just a weekend," Braun said.

With the new program, Emergency Services will be able to craft messages from scratch and send to designated users or use more general template-style messages.

Predetermined lists of recipients can also be set up prior to use for faster messaging, Braun said.

Doing so would allow the county to alert users of emergencies, road closures or other situations that may arise during the eclipse, according to Braun.

Another aspect of the program that the county will eventually opt into using is a wireless emergency alert system that is federally regulated through FEMA.

That program, which is how AMBER alerts are sent out, would allow the county to send emergency messages to any phone within a geographic zone, regardless of whether a resident had opted into receiving messages or not.

"We can message the entire county or draw a zone, a circle, square, whatever shape we need to (to mes-

sage residents)," Emergency Services Director Matt Denner said.

That system could prove crucial in the event of a larger emergency, Denner said.

When messages are sent, county personnel will be able to see who received the message and by what method. By doing so, the county will be able to ensure messages are being successfully received and progress can be tracked as they go out.

In the event an emergency situation continues to evolve, the county would be able to send a followup message, Braun said.

The learning curve for the program will be slight as training is available for county officials, free of charge.

Braun said Rave Mobile has a training mode that allows emergency personnel to complete every step short of sending a message.

A library of step-by-step training is available along with weekly webinars and personnel to assist with any questions during training.




## Forsythe named SLC chairman

CANTON -- The St. Lawrence County legislature has voted and Legislator David Forsythe will once again serve as chairman.

The vote came during the Jan. 2 organizational meeting, with Forsythe winning by a 12-3 margin along party lines.

Legislator Rick Perkins was also re-elected to serve as vice chairman again.

Forsythe thanked his fellow legislators, saying the past year has been an enjoyable experience that went by much faster than anticipated.

"Thank you from the bottom of my heart. I would like to thank all of the legislators who voted for me to continue to chair in 2024. It's hard to believe it's already been a year," he said.

"I have truly enjoyed the last year (as chairman)," he continued.

In his brief speech to the legislature, Forsythe highlighted the projects completed or underway in the last year, including renovations to the county jail, approval of a \$7.5 million upgrade to the county public safety complex, as well as the completion of the third and final highway department outpost that is now operational.

"We also paved an additional 10 miles of highway on top of what was originally scheduled," he said.

Other highlights include opening a new satellite office for the Department of Social Services in Massena, opening a new recycling facility in Lisbon with new scales and updates to the county clerk's office and community services department.

"Our new mobile clinic is also operational and our true value tax rate is at its lowest since 1980," Forsythe said.

Under his watch, Ogdensburg also began taking action to collect property and sales tax on their own as well, he said.

"Everyone here, all of the staff, you all made it happen," he said.

Forsythe also spoke to the new sheriff and under-sheriff in town, with Rick Engle and Shawn McCarger taking the reigns following the retirements of Sheriff Brooks Bigwarfe and Under-Sheriff Sean O'Brien.

Forsythe was complimentary of Engle and new Under-Sheriff Shawn McCarger, saying both will continue to do good work for the county.

"I, along with this board, look forward to working with you in the coming year," Forsythe said.

Forsythe said he did not know

Engle well previously, despite both being from Lisbon, but throughout the year and through many conversations he quickly learned what an asset Engle would be to the county.

"I wanted to introduce him to the people of our group and let him know that we've got his back," Forsythe said.

"They will do an outstanding job. I've been impressed with both of them," he continued.


Though focused on the present, Forsythe also spoke to the future of the county and local politics, calling on younger generations to engage in politics.

That notion is not a new one for the Forsythe family, with the chairman's son Hunter Forsythe officially taking his seat on the Lisbon Town Board.

"We were able to attend his swearing in and it was a very proud moment for our family," the chairman said.

He went on further, encouraging the public to get involved locally and to engage with community leaders to find the best path forward for the North Country.

Forsythe said he looks forward to the year ahead and is hopeful the legislature will be able to continue to better the county in the months ahead.

# Several new state laws now in effect in New York

In a flurry of action over Christmas weekend, Governor Kathy Hochul signed nearly 100 bills into law, including a handful that have stoked controversy in the North Country.

Hochul took action on hundreds of bills last year, from changing local elections to even-numbered years, to banning some hunting derbies and sealing criminal records of former convicts with the Clean Slate Act.

## Election move to even-years

A number of local elections will now be moving to even-numbered years after Governor Hochul signed legislation in hopes of boosting participation in those elections.

The new law, which was signed around the Christmas holiday, moves the majority of town and county elections that were previously held during odd-numbered years to even-numbered years. In doing so, those elections will fall at the same time as state and federal elections that historically have a significantly higher voter turnout.

According to state officials, voter turnout in New York State was around 64% in 2020, the most recent presidential election.

That figure declined significantly in 2021, when local elections were held, to just 25%.

The legislation will impact all elections for which dates can be

changed through legislative action, though a number of offices like judgeships and offices in any city in the state must be changed through a constitutional amendment, state officials say.

Hochul claims the move would "be a fiscally responsible approach that would reduce the taxpayer cost of election administration by avoiding the need for elections to be held every single year."

State officials say the move will ensure higher voter turnout for local elections "when most voters are already planning to participate in an election."

State officials say the move to include all elections in even-numbered years will also assist voters and employers alike, making it easier to pay for time off and travel to polling sites.

## Second Family Court Justice

St. Lawrence County will also see a second Family Court justice added in 2024 after Hochul signed a bill into law to add 21 justices throughout various courts around the state.

The move to add another justice is one the county has long explored, according to County Attorney Steve Button.

"When assessing the number of cases St. Lawrence currently has and after conversations with the Office of Court Administration it became apparent that St. Lawrence County has twice as many cases as the next closest court within the judicial district," Button said.

That backlog has caused a number of problems in recent years with multiple parties arguing that the process to be heard in court is taking far too long.

County officials were joined by state representatives in recent years to request the addition of a second justice but it was just last week that the Governor signed legislation to add the position.

Button said adding a second justice to Family Court will provide relief and will hopefully speed up many cases but that relief is still some ways off.

"This will alleviate the significant delays in these sensitive matters and we are pleased to see this come to fruition," Button said.

Button said the position is expected to be on the ballot in 2024 with the elected justice slated to take the seat in 2025.

## Hunting Derbies

Governor Hochul has signed legislation that largely outlaws some hunting and fishing competitions in an effort to curb "the wasteful taking of certain wildlife."

In a press release issued by the governor's office, Hochul said the legislation targets contests, competitions, derbies and tournaments held for prize money or entertainment.

The new regulations will go into effect in November 2024.

The new law now makes it illegal to organize, conduct, sponsor or take part in such competitions.

Department of Environmental Conservation officials will now be able to seize wildlife taken during such competitions and participants can be fined anywhere from \$500 to \$2,000, according to the legislation.

In the future, only competitions aimed at targeted wildlife management of certain populations will be lawful in New York.

Competitions excluded from the legislation include contests related to the hunting of white-tailed deer, turkeys, bears and fishing competitions.

Hochul said those competitions are being excluded due to the "careful regulations by the state."

## Clean Slate for convicts

Hochul also signed the "Clean Slate" Act into law, broadening the allowances for sealing criminal records.

The legislation would automatically seal certain criminal records after a required waiting period – three years after conviction or release from jail for a misdemeanor and eight years after conviction or release from prison for a felony – provided they have maintained a clean record and are no longer on probation or parole.

Proponents of the measure say it was enacted to protect public safety and ensure the state is "sealing the records of people who have truly committed to turning their lives around, there are instances where people will not be eligible for seal-

ing. Those with pending criminal charges, who are required to register as a sex offender, who received a life sentence, or who have been convicted of a class A felony – like murder – are ineligible to have their records sealed under Clean Slate," a statement from the New York State Assembly states.

Detractors say it compromises public safety and have gone as far as to call the act "pro-criminal."

Although records will be sealed, legislation provides access to otherwise sealed records for certain necessary and relevant purposes, including law enforcement purposes, licensing or employment for specific industries where a criminal background check is required to be performed employment where a fingerprint-based background is performed, extending employment to a person in jobs where they may work with such groups as children, the elderly or other vulnerable populations, when an individual

# Forum planned as Ogdensburg hospital transitions

OGDENSBURG - Claxton-Hepburn Medical Center officials will hold a public forum for those looking to learn more about the transition to a critical access facility.

The meeting will be held at 4:30 p.m. at the Ogdensburg Elks Lodge Jan. 18.

The news comes on the heels of a recent announcement from CEO Richard Duvall that CHMC is now under management of Carthage Area Hospital as part of the North Star Alliance.

"We are pleased to provide an update to the North Star Health Alliance strategic plan. This past summer we shared information with the public that included shared services with Carthage Area Hospital and Claxton-Hepburn Medical Center, the CHMC hospital campus conversion to critical access and the creation of a standalone mental health hospital," a recent announcement from the hospital said.

Duvall explained that the most recent update involves outpatient services at Claxton-Hepburn Medical Center (CHMC) and Carthage Area Hospital.

He said the New York State Department of Health has granted approval for the first phase of the Critical Access Transition, which involves a strategic shift in the management of rural health clinics in Ogdensburg, Canton, Madrid, Hammond, and Waddington to management under Carthage Area Hospital through the North Star Health Alliance.

"In our commitment to providing exceptional healthcare, we want to make it clear that there will be absolutely no interruption or reduction in the range of services offered. Patients can rest assured that they will continue to see their current healthcare providers and have access to the same services with the same provider at the same locations

where they are currently receiving treatment," Duvall explained.

This initiative marks the initial phase of the Critical Access Transition, which has received approval from the New York State Department of Health.

Duvall said it was a milestone in the plan.

"This initial phase of the Critical Access Transition, sanctioned by the New York State Department of Health, represents a pivotal step. It's crucial in helping us meet our three core objectives: preserving our range of services, safeguarding jobs, and ensuring the honor of Claxton-Hepburn's employee pensions."

Last year Duvall went into detail about the changes needed to stay solvent.

He said the acute care center will be designated as a critical access hospital, which will help ensure the facility's future because it is expected to then qualify for increased reimbursement rates for Medicare and Medicaid.

Duvall said the hospital currently employed 720 people at that time, all of whom would retain their jobs, salaries and benefits once transitioned to North Star.

North Star was established roughly seven years ago and at one time included CHMC, Carthage Hospital, Meadowbrook Terrace, North Country Orthopedics and

River Hospital. However, River Hospital has since broken away.

The Claxton-Hepburn Mental Health Center will continue to operate 40 beds while serving solely as a behavioral health clinic.

The biggest change will be at the acute care facility which will be downsized from 87 total beds to 40 beds to include 25 acute care, five observation and 10 mental health beds.

"There will be no job reductions and no service reductions," he said.

Duvall said downsizing the number of beds is what allows the hospital to receive the critical access designation, which in turn will provide higher reimbursements and allow the facility to survive.

"We view this transformation plan as a continuation of years of effective collaboration and shared services agreements between two hospitals that understand the intricacies of providing high quality care in rural communities," he said.

Duvall said many options were explored as the hospital sought to regain its footing following the pandemic, but this option yielded the best results for employees and the community alike.

Duvall said over the past 10 years, CHMC has seen about 25 to 30 inpatients per day and expects that number will continue. He believes the new critical access center will be able to meet that need.



# Winter storm causes major damage with wind, rain and snow

More than 10,000 St. Lawrence County residents remain without power Wednesday following a winter storm that pounded the area with wind, snow and rain and ended early Wednesday morning.

Large portions of Canton and Potsdam lost power and a smattering of smaller outages were reported in Pyrites, Heuvelton and other towns throughout St. Lawrence County.

The hardest hit area appears to be the center portion of the county with river towns not receiving quite as much damage from the storm, but powerlines, trees and limbs were down in nearly all parts of the county, according to reports.

State police reports show they

were busy assisting people with disabled vehicles and accidents Tuesday evening and early Wednesday morning. There were also reports of attempts to locate people.

In Potsdam one side of Market Street appears to be without power, with no power on the McDonald's-side of town. A huge tree is reportedly down on the corner of Market and Canal Streets.

Along U.S. 11 from Canton to Potsdam power remains out, according to reports.

Crews in the Canton area had cleared branches from roadways, and power was restored to parts of downtown Canton. Canton firefighters were directing traffic there Wednesday morning after a traffic

light failed at the intersection of 310, Route 11 and State Highway 68.

In Colton, witnesses reported seeing multiple downed trees on back roads as well as damaged roofs and lawn furniture and debris blown about. Downed trees were also spotted in Hannawa Falls.

People started losing power late evening and into the morning hours as winds intensified. Many are still without power.

Many fire departments reported being out clearing trees, and assisting local residents in a variety of ways following calls to the station.

Witnesses reported down trees in some areas and a quick melt left a number of people with flooded basements.

## Agencies will get share of funds seized by federal law enforcement officials

CANTON — St. Lawrence County law enforcement agencies and the District Attorney's office are set to receive a share of funds seized by federal agencies in St. Lawrence County after legislators approved a resolution to sign off on the Federal Equitable Sharing Program.

Legislators approved the resolution during the Jan. 8 Operations Committee meeting.

According to St. Lawrence County District Attorney Gary Pasqua, the funds are part of a recurring

program that is awarded every January and February.

Pasqua said he applies every year through an electronic program, giving the county access to the seized assets.

"Whenever federal law enforcement agencies seize any money in a federal investigation in St. Lawrence County, my office has any nexus to that. They share that with my office, as well as local law enforcement agencies," Pasqua told legislators.

The funds, which are seized by agencies like Customs and Border Protection (CBP) and the Drug Enforcement Agency (DEA), come

from busts that occur within the county throughout the calendar year, Pasqua said.

Legislators and the chairman of the legislature work in conjunction with Pasqua to keep track of the funds and to ensure the application is submitted and approved on time to ensure the flow of funds, he said.

"The chairman has to sign off every year. This resolution needs to be done so that when I go and fill out that paperwork before March 31 we can say we've met as a group," Pasqua said. The resolution now moves to the full board for approval in February.

## Shoplifter injures employee

POTSDAM — An Ogdensburg woman was charged after allegedly injuring a Price Chopper employee who attempted to stop her from shoplifting Jan. 5, according to village police.

Billie Jo Planty, 44, was charged with second-degree harassment and petit larceny at 3:10 a.m. last Friday, officers said.

Planty allegedly left the store with a cart full of groceries without

paying for them.

A store employee attempted to grab the cart from her in the parking lot and Planty grabbed his hand and bent his finger back, causing minor injury, police said.

Planty reportedly fled the scene before police arrived.

She was picked up by other law enforcement and turned over to Potsdam police and charged, officers said.

## Settlement ends Akwesasne dispute

AKWESASNE — The U.S. District Court for Northern New York approved an agreement between the Saint Regis Mohawk Tribe (the "Tribe") and Franklin County (the "County") settling the parties' dispute over the County's assessment of its "Vehicle Use Tax" on members of the Tribe.

The Settlement will exempt qualified Tribal members from payment of a bi-annual County "Vehicle Use Tax" and provide refunds.

The Tribe filed a lawsuit in April 2023 as a result of years of unsuccessful efforts with the County to adopt and implement a tax exemption form for Mohawk Tribal members who live on and garage their motor vehicles on the Saint Regis Mohawk Reservation.

The Tribe's complaint in the case cites numerous instances going back over the last 10 years where the Tribe has complained about the tax assessments and formally requested action by the County to cease its collection. Under the terms of the settlement, Franklin County has revised its County Vehicle Use Tax Exemption Certificate to add a Tribal Member exemption on its exempt form.

Until now, there are only exemptions for non-county residents, non-profits, and farm vehicles.


In addition, the settlement will allow qualified Tribal members to obtain refunds for any Franklin County vehicle tax they paid within the last 10 years. Tribal members will be required to show proof of membership, paid the fee, and the fee was on a vehicle that was garaged on the Reservation. The Tribe will assist Tribal members

with their claim forms.

"The amount of the vehicle tax is relatively small--\$20 every two years, but no matter how small the amount, it is money that members should not have been charged

and should not be charged in the future," stated the Tribal Council.

The Tribe will be disseminating additional information about the exemption in the coming weeks.



## New year, new...relationship with the deceased

Grief around the holidays is tricky. You may have felt as though people were walking on eggshells around you, fearful to so much as mention the name of the person who died.

Maybe people kept asking how you were, but you truly did not even know how to answer, so you simply smiled and said "I'm ok." until your face hurt. Now you're in a new year, perhaps the first calendar year without the person you're grieving, and you're entering uncharted grief

territory.

This new year may not be the year for a "new you", the challenges of grieving do not make space for this type of change. (As a quick aside, I've always found the idea of "new year, new you" to be confusing. What happens if I, usually, like who I am,

find purpose in my work, and know people love me? Why would I change that?) Rather than trying to change yourself, while trying to adapt to a world without the person who died and grieving, why not change the type of relationship you have with the person who died. If you're looking for ways to have a healthy relationship with a person who died Hospice of St. Lawrence Valley offers the following:

- The death of a person does not erase the relationship that existed. I have a friend whose sister died. When we first met and were discussing family structure she said, "I have two sisters, one is dead." She still considers herself to be a sister to the young woman. I have a relative who simply tells people she has "two living sons and one who is no longer with us.", she will forever be the mother to her deceased son. It is ok to still refer to the person who died as your friend, mom, significant other, husband, etc. Who they were to you, whatever title they had, does not change simply because they're deceased.

- Communication with them looks different now. It is ok to still talk to people who are dead. I'll just say that once more: it is ok to still talk to people who are dead! As long as the thin air or picture you're talking

to does not start talking back then you're doing fine. Did you call your mom most days on the way home from work just to talk about the mundane? You can still talk to her during the drive. Find the perfect meme to send a friend who has died? Send it anyways. Communication is different in that it may feel more one-sided, but if it brings you comfort that's all that matters.

- They can still be included in big events. The fact a grandfather did not live to see a grandson's high school graduation does not mean he cannot still have a place there. If possible, place pictures of the person on a special table at the graduation party. Light a candle for those who cannot be at the wedding. Take a moment to acknowledge the grief happening at the same time as the happiness.

Adjusting to a whole new calendar year, one the person who died will never see, is a huge undertaking. Redefining who you are in relation to them is even larger. Rather than working to make a "new you" work to create a connection which brings you comfort. ## Backstroke to improved health


the heart muscle and improve lung function and endurance. Because it lowers blood pressure and improves circulation, swimming is a great way to get the heart pumping.

A gentle, 30-minute swim can burn up to 200 calories, which is more than walking. A faster swim can burn calories more quickly than running or cycling.

However, since water supports up to 90 percent of the body's weight, this activity will put less stress on muscles and joints while one is exercising.

Individuals with mobility issues or arthritis pain may find that swimming helps relieve discomfort and improves range of motion.

Again, because the water is doing much of the work holding up the body, it will take the stress off of joints, helping a person to feel better while stretching and moving gently in the water.

## How diet can combat age-related bodily changes

The human body is a marvel. How the body transforms over the course of an individual's life is one of its more remarkable qualities, and those changes never cease, even as individuals near retirement age.

The changes associated with aging include physical transformations but also more subtle shifts the naked eye cannot see. For example, metabolism slows as individuals grow older, and aging also can lead to a decrease in bone density and muscle mass. These changes affect how men and women at or nearing retirement age should approach their diets in recognition of the various ways their nutritional needs change at this point in their lives. Any modifications to a diet should first be discussed with a physician, but the following are some ways aging adults can use diet to combat age-related changes to their bodies.

Prioritize protein. The authors of a 2010 study published in the journal Current Opinion in Nutrition and Metabolic Care recommended that older adults consume between 25 and 30 grams of protein with each meal. The researchers behind the study concluded that such consumption could limit inactivity-mediated losses of muscle mass and function.

Overcome reduced production of vitamin D. WebMD notes that people over 65 typically experience a decrease in natural production of vitamin D. Vitamin D is not naturally found in many foods, so aging men and women may need to rely on supplementation to ensure their bodies get enough of it. Vitamin

D helps with anti-inflammation, immune system support and muscle function, among other benefits. So it's vital that aging men and women find ways to get sufficient vitamin D.

- Consume ample dietary fiber. The National Resource Center on Nutrition & Aging notes that fiber plays an important role in the health of older adults. Fiber has been linked with heart health, healthy digestion, feeling full, and preventing constipation, which the online medical resource Healthline notes is a common health problem among the elderly. Though the NRCNA notes that older adults need slightly less fiber than their younger counterparts, it's still a vital component of a nutritious diet. The feeling of fullness that fiber consumption can provide also is significant, as it can ensure adults who aren't burning as many calories as they used to aren't overeating in order to feel satisfied. That can make it easier for such adults to maintain a healthy weight.

- Monitor intake of vitamin B12. The NRCNA notes that vitamin B12 is involved in a host of important functions in the body, including nerve function and the formation of red blood cells. Vitamin B12 is most easily found in animal products, which many aging men and women must largely avoid due to other health concerns. In such instances, men and women can discuss supplementation with their physicians as well as alternative food sources of B12, such as fortified cereals, salmon and other items.

## How caregivers can alleviate stress

Serving as a caregiver for a friend or loved one can be both rewarding and taxing at the same time.

The senior housing authority A Place for Mom indicates that 41 million Americans offer unpaid caregiving services, and that number is expected to increase as the aging population grows in the coming decades. Formal caregivers are paid care providers in a home or care setting.

However, an informal caregiver is an unpaid individual that assists others with activities of daily living as well as medical tasks.

The fatigue that arises from caring for another individual is often referred to as caregiver burnout. Since caregiving takes place over several years, the impact can escalate over time. Caregiver stress is directly related to burnout.

The Mayo Clinic says signs of caregiver stress include:

- worrying all the time
- feeling tired often
- changes in sleep
- gaining or losing weight
- becoming easily irked or angry
- losing interest in activities once enjoyed
- feeling sad or depressed
- experiencing frequent headaches, pains or other health problems
- misusing drugs or alcohol, including prescriptions
- missing your own medical appointments or other appointments

Caregivers need to put themselves first at times in order to help avoid health complications that can come from the stress and demand of caregiving. Make use of these caregiver stress management tips, courtesy of the Mayo Clinic and Penn Medicine.

Ask for help. Figure out ways that others can help out and then be sure to let them know and accept anything that is provided.

Do the best you can. Every caregiver feels they are not doing enough at some point in time. Do whatever you can manage and know that it is adequate.

Set small goals. Categorize responsibilities into smaller, more manageable tasks. Make lists of what is most important and tackle those goals, moving on as needed.

There are support groups for many different types of needs, including caregiver support. People who are experiencing the same highs and lows as you can offer advice or just be there to listen.

Find ways to rest and sleep. Many caregivers are sleep deprived. If sleeping has become an issue, discuss potential remedies with your own doctor.

# How to protect long-term cognitive health

Cognitive health is not something to take for granted. Although a certain level of memory loss can be expected as people age, when the ability to clearly think, learn and remember is compromised, those changes can affect an individual's ability to perform daily activities and should serve as a cause for concern.

Brain health should be a priority for everyone. The National Institute on Aging says brain health is an umbrella term that encompasses a host of factors, including:

- cognitive health, which is how well you think, learn and remember
- motor function, or how you make and control movements
- tactile function, which is how you feel sensations; and

Harvard Medical School says nurturing social contacts, engaging in stimulating mental activities like reading and doing puzzles, seeing new places, and learning new things can help keep the brain in top form.

## Manage stress

Stress can take its toll on the body, and there is reason to believe that it may adversely affect cognitive health as well. Make every stride to reduce stress, whether that involves taking vacations, meditating,

ing, laughing with friends and family, or engaging in relaxing activities that relieve stress.

## Get enough vitamin D

Vitamin D is linked to a host health benefits, including its potential to promote a healthy brain. Individuals can get more time outdoors to get vitamin D naturally

from the sun and eat foods rich in vitamin D. If doctors find that vitamin D levels are exceptionally low, supplementation can help.

## Pay attention to hearing loss

Certain hearing loss has been linked to cognitive decline, says Healthline. Researchers in Italy concluded that people with central

hearing loss had a higher risk of mild cognitive impairment than those with no hearing loss or peripheral hearing loss. Individuals with central hearing loss are urged to speak to their physicians to determine if they can take preventive action to stave off further decline.



rate, 2023 89% coverage rate), which has resulted in overutilization of mutual-aid ambulance companies; companies that may see little-to-no financial reimbursement for coverage. Average ambulance response times have increased 5 minutes 13 seconds from 2019, with the longest response time of 2021 being 1 hour and 43 minutes, and the second longest being 1 hour and 26 minutes," the letter says.

The problem isn't new. In recent years Ogdensburg Volunteer Rescue Squad Chief Ken Gardner has been vocal about the shortage of volunteers.

He said there are a number of contributing factors which were exacerbated by the pandemic.

However, more stringent state regulations, training requirements, the reduction in dairy farms and the need for multiple people to work full-time jobs to support families have made things more difficult for those who traditionally volunteer.

In 2022 St. Lawrence County Emergency Medical Services Advisory Board Chair Mark Deavers and Jonathan Mitchell, County EMS Coordinator, issued a letter to legislators noting the Emergency

Medical Service is collapsing due to a lack of volunteers.

According to that letter, most SLC EMS agencies were formed in the 60's and 70's and were largely staffed by volunteers, but volunteerism has declined significantly.

"This trend has been evident in both EMS agencies and Fire Departments across rural America. This can also be seen in the number of people enrolling in EMT classes. In the 1990's and early 2000's, St. Lawrence County would typically run two EMT classes a semester with a combined enrollment of 72. In 2021, the two original EMT certification courses had a combined enrollment of 39," the letter says.

The letter also points out that state laws have contributed to the problem. In 1999, lawmakers began requiring a certified EMT to be attending to a patient in ambulances. At the same time the state increased the minimum hours of Basic EMT education.

"To attend EMT class and receive certification, volunteers are required to drive to and attend class two nights a week and several Saturdays for four months, totaling 150 hours of instruction," the letter said.

The letter says the state also phased out a program that allowed

volunteers to provide advanced level care including narcotic administration, intubation, cardiac monitoring, and advanced level cardiac arrest management.

They also pointed out that the only available alternative to that program is paramedic which has significantly higher training requirements including 2,000 classroom hours, clinical rotations and significant tuition payment.

"These barriers to EMS education result in less people willing to become certified EMT's or paramedics and who receive no remuneration," the letter says.

The issue has been discussed many times by St. Lawrence County legislators but no action has been taken thus far.

Legislator David Forsythe has said that he'd like to see a multi-pronged approach to addressing the problem, including cross training for other emergency responders such as police officers who are often first on the scene.

agreement will suffice in the meantime for the water treatment plant assessment.

Miller said he currently has to submit paperwork back to ESD but

once they send the incentive proposal to Mayor Paquin for his signature, the agreement with LaBella can be signed.

"Because of time being of the essence with Air Products and their engineering firm, we're hoping they can work together and expedite this with the piping from the intake to the plant," Miller said.

The study moving forward is welcome news to Massena with Air Products saying the facility will create a few hundred jobs during the construction phase and 90 or so jobs when it becomes operational.

Construction is expected to begin this spring with interior work slated for winter 2024, according to Air Products officials.

If all goes according to plan, the facility should be online by the first quarter of 2027.

Village officials previously signed an agreement with Air Products to supply Air Products with some water that will net the village \$300,000 per year.

The process to create green hydrogen will require 1 to 1.2 million gallons of water daily, according to officials.

## Land clearing to begin for hydrogen plant

MASSENA -- Land clearing may be underway already but members of the public who wish to issue a public comment on the planned construction of a green hydrogen manufacturing facility in the town of Massena will now have their chance.

Public comments are now being accepted regarding the planned discharge of treated water that would re-enter local waterways. The discharge of treated water is one phase in the manufacturing process of green hydrogen, which will be used for commercial vehicles.

Department of Environmental Conservation officials say the treatment system is in the design phase currently but Air Products must submit the final design before receiving approval.

As part of the process, Air Products has applied for a State Pollutant Discharge Elimination System (SPDES) permit with the DEC in order to be allowed to discharge treated water.

Officials say the water must meet DEC standards in order to be discharged into local waterways.

The draft permit has been issued by the DEC and is subject to public comment. This phase of the project will allow residents to comment on the potential discharge of treated water into local waterways, which would potentially be up to nearly 1

million gallons per day.

Officials say the treated water would be discharged into the Massena Power Canal.

Some residents raised concerns during public information sessions held by Air Products, with some wondering if chemicals would be discharged into waterways.

Representatives with Air Products say no chemicals would be in the water when discharged.

"The water that is being discharged is cooling water. We have


no processed water because we have no process," Air Products Senior Project Manager Jonathan Traynor said.

"There's no discharge. It's just oxygen and hydrogen as what's called the fuel because that's what the water is. As the fuel runs out we just put more water in there. There is no discharge from the facility from the process of splitting the oxygen and hydrogen."

Air Products Director of Large Product Business Development

Harry Johnston said the process does not involve chemicals that have been used in manufacturing processes at other plants in the Massena area over the last 100 years.

The \$500 million facility is currently in the planning stages, however land clearing is underway already with plans to begin construction this spring. Once complete, the facility will employ around 90 workers to produce 35 metric tons of green hydrogen everyday.


