## Local schools set to lose millions

CANTON -- Local school districts are set to lose millions in foundation aid from the state, if the governor is successful in removing the hold harmless provision from the state budget.

Assemblyman Scott Gray is one of many leaders opposing the change. He says the proposed cuts disproportionately affect a handful of districts within the county.

With the provision in place, the state is required to offer at least as much foundation aid each year as it did the year prior, essentially ensuring the state is unable to reduce aid indiscriminately.


"That would be removed under the executive budget," Gray said.

Gray said those funds, which were largely used for salaries, academic development and emergency projects up to a certain dollar amount, would be heavily cut.

"That has basically kept districts whole so they didn't see a decrease year over year in their foundation aid funding," Gray said.

Gray said those funds will be shifted

## Cheese plant demo

Ogdensburg's defunct cheese plant is coming down. The city accepted a bid of \$1.2 million from Bronze Contracting in November to perform the work. In May, Ogdensburg received a \$1.8 million Restore New York grant, which will be used to fund the demolition. The tear-down marks the end of a lengthy tale involving years of litigation and will help make the city's nearby waterfront more attractive to potential developers.

## Fisher hopes to return to city council

OGDENSBURG -- Former Deputy Mayor Steven Fisher is hoping to reclaim a seat on city council following a vacancy created by Michael Powers, who retired from council to maximize his retirement benefits recently.

Fisher was an outspoken member of council who decided not to run for reelection after his first term.

During his time on council Fisher supported various controversial actions including cuts to the fire and police departments.

Fisher was critical of St. Lawrence County legislators who chose to change the sales tax distribution formula at a cost of roughly \$2 million annually for the city

and was outspoken about the city's need to tighten its belt to become financially solvent.

He was often at odds with Councilor Powers who was critical of cuts to the fire and police departments.

Powers has long called for a rebuilding of relationships with the county in the wake following years of bad relations between the entities.

At the most recent council meeting Councilor Michael Powers announced he would be retiring from council in order to maximize retirement benefits as he is also ending his lengthy career at the department of corrections.

Powers had also served as New York State Corrections Officers and Police

## Massena restricts parking to address Willow Street concerns

MASSENA -- Village trustees have banned parking on the south side of Willow Street between Somerset Avenue and Woodlawn Avenue, saying that a drive-through for a business in the area is causing traffic concerns.

Police have been heavily patrolling the area out of concerns that traffic collisions may occur due to the drive-through.

Mayor Greg Paquin said on multiple occasions he received calls from concerned constituents wondering why police were there all the time.

The move to prohibit parking would ensure public safety and potentially free up police to patrol other parts of the village, he said.

"This will help because of that allowed exit over there," Paquin said.

Paquin addressed the issue during a recent village board meeting, saying the planning board should have considered a number of factors, including possible congestion that would occur with the creation of the drive-through.

"I think when that was allowed to happen, the

drive-through, I think everyone kind of lost sight that there's a bend here and traffic can be moving pretty quick," Paquin said.


The drive-through in question was a point of contention for former Mayor Jim Hidy, who questioned why it was allowed in the first place.

Paquin said he was "sure it was brought up during the planning board hearing" but said he was only there for a short amount of time before he had to leave.

"I think it was brought up, but I think ultimately they agreed that as long as it was going around.

She was supposed to have a fence out there. Any other possible things that are going on, I can't comment publicly right now," Paquin said.

The fence Paquin spoke of was one that DPW crews were required to install after the business failed to comply with a request from the village, he said.

# Sentenced for manslaughter at prison

CANTON — St. Lawrence County District Attorney Gary M. Pasqua announced Thursday, Feb. 1 the sentencing of Londell Dyson, 34, of Dutchess County for his convictions of first-degree manslaughter and second-degree assault.

A St. Lawrence County trial jury found Londell Dyson guilty in October of killing his cell mate while housed at the Gouverneur Correctional Facility.

Dyson was sentenced to a persistent felony offender after it was determined at a separate hearing that his criminal history and the nature and circumstances of his crimes were such that an enhanced sentence would best serve the public interest, a press release from Pasqua said.

Londell Dyson was sentenced to an indeterminate term of incarceration of 20 years to life on his first-degree manslaughter conviction, and an indeterminate term of incarceration of 15 years to life on his second-degree assault conviction. The sentences will run concurrently.

Pasqua commended Assistant District Attorneys Jamie Biondolillo and Michael Abbruzzese for their work in assisting him to secure this conviction.

He also thanked the New York State Department of Corrections and the New York State Police for their assistance with the prosecution.

## Animal cruelty charge leveled after dog found dead

NORWOOD — A Potsdam man was charged Tuesday after a dog was found dead in Norwood Lake last summer, according to village police.

Norwood Village Police charged Joshua D. Brownell, no age listed, with animal cruelty on Feb. 6 stemming from an investigation into the death of a pit bull found deceased last summer in the lake.

Officers were assisted in their investigation by the Potsdam Animal Control Officer and Potsdam Humane Society officials.

Brownell was reportedly released on an appearance ticket and will answer the charge in Town of Potsdam Court.

“The Norwood Village Police Department would like to remind everyone of the essential role the Potsdam Humane Society has in caring for homeless animals every day,” police said.

# Police investigating school incident, no charges expected

OGDENSBURG -- Ogdensburg Police Chief Mark Kearns said police are investigating an incident at Ogdensburg Free Academy Thursday, but no charges are expected.

Kearns said the school was locked down after a Student Resource Officer at the building received a report that a student may have been in possession of a firearm. Although the investigation is still underway, Kearns said no gun was found at the school and no one was in danger.

“Today at approximately 2:50 p.m. the Ogdensburg Police Department’s School Resource Officer assigned to the Ogdensburg Free Academy was notified of a possible subject with a gun on the school campus. The school district followed emergency protocols and went into lock down. The Ogdensburg Police Department responded to the school, establishing incident command and starting an initial search for any potential threats,” Kearns said in a prepared statement.

### A unified response

“Assistance from the St. Lawrence County Sheriff’s Office and the New York State Police quickly arrived. No threats were located and students were sent to the Dome for reunification with their parents. United States Customs, Border Patrol, Homeland Security, DEC Police, and the Village of Canton Police all arrived to assist as well. The Ogdensburg Fire Department and OVRs were on standby and assisted with parent reunification. No injuries occurred and this incident remains under investigation.”

Despite rumors circulating on social media, Kearns said there was not an “active shooter.”

“There was no active shooter at

any time. The Ogdensburg Police Department is thankful for its partnerships with the Ogdensburg City School District, as well as our law enforcement, EMS/Fire partners,” he said.

Kearns said the incident remains under investigation.

At this time no one has been charged.

Ogdensburg City School District Superintendent Kevin Kendall also released a statement and noted that the school was locked down as protocol.

“Earlier this afternoon, Ogdensburg Free Academy went into a lockdown after a student was reported to have had a gun on campus. Law enforcement agencies responded and swept the building for any potential threats. They have determined that the building is secure. No injuries were reported,” Kendall said.

### A look from inside

Among those inside the locked down school was St. Lawrence County Legislator Jim Reagen who serves as a Key Club Advisor.

“It was a little different hearing the announcement and waiting in a room to find out what was happening,” he said.

Reagan said he was with students who had certainly been through a lockdown drill before and as they grouped together in the room students on their phones notified him that it was not a drill.

He said he was impressed with students who remained calm and was even more impressed at how smoothly everything went.

“As I sat inside the locked classroom at OFA as our law enforcement community was responding to the threat, I was very impressed by the professionalism and composure of our teachers and staff who rose to the occasion despite whatever dangers might have been going on in or around the building. Our students made me very proud. You could not have asked for a better response by our young people who kept their heads, listened to instructions and followed them,” he said. “Like every one, I was relieved when Ogdensburg Police knocked on our door, entered the room and told us we would be escorted to the Golden Dome. StLawrence County Sheriff Rick Engel met me in the hallway. Heavily armed troopers, deputies, border patrol, city police and others were stationed at key points in the building as the officers went door to door checking each room.”

Reagan said it was clear that everyone was well prepared for this type of incident and that multiple agencies were acting as one during the event.

“As a county legislator, I was proud to see how everyone came together during this crisis. I know our law enforcement community has repeatedly trained for such an event at our schools. It was wonderful seeing how school personnel and law enforcement executed their plans to keep our children safe during what could have been a horrific tragedy,” he said.

# Up to 6 years in prison for man who left infant to drown

OGDENSBURG – A man who left his 11-month daughter unattended to drown in a bathtub will face 2 to 6 years in prison for the crime.

Trevor James Samarco was charged with second-degree manslaughter following a police investigation on May 11.

Police responded to a complaint at 423 Belmont Courts at 11:30 a.m. Ogdensburg Fire Department, Ogdensburg Volunteer Rescue Squad and Ogdensburg Police Department members performed lifesaving measures upon arrival, but despite the efforts the baby was pronounced deceased at Claxton-Hepburn Medical Center a short time later, police said.

An investigation revealed he allegedly left the infant unattended in a bathtub while falling asleep in another room on a bed, according to court documents.

In December he pleaded guilty to the charge.

St. Lawrence County District Attorney Gary Pasqua said that in regard to the sentencing it's important to remember that the child's death wasn't intentional.

Pasqua said that Samarco should and is being held accountable to the crime of manslaughter which has very different potential sentences than intentional homicides.

Pasqua also noted that the outcomes were discussed and understood by the child's mother.

## Three hospitalized following two-car crash

Three St. Lawrence County residents hospitalized following two vehicle crash in Lisbon

LISBON — Three St. Lawrence County residents were injured in a two-vehicle accident Jan. 28 on State Highway 68, according to state police.

Troopers responded to an accident around 11:45 a.m. near Cemetery Road and investigation determined a white 2018 Toyota Highlander operated by Lisa A. Gardina, 70, Lisbon, failed to yield

the right of way to oncoming traffic making a left turn.

This caused a gray 2013 Nissan Rogue operated by Delberta M. Carr, 78, Ogdensburg, to strike the vehicle, police said.

Gardina was reportedly transported to Canton-Potsdam Hospital for non-life-threatening injuries. Carr and passenger Larry A. Simzer, 76, Ogdensburg, were taken to Claxton Hepburn Medical Center.

Carr was later transferred to Upstate Medical Center due to the

severity of injuries, but they are non-life threatening, officers said.

Simzer sustained non-life-threatening injuries as well, police said.

Gardina was cited for moving from a lane unsafely, failing to yield right of way and failure to yield right of way while making a left hand turn. All tickets are returnable to the Town of Lisbon Court for a later date in February, police said.

## Man allegedly tries to ignite oxygen tank to set home ablaze

OGDENSBURG — An Ogdensburg man is accused of trying to blow up an oxygen tank in an attempt to set a home on fire on King Street last month, according to city police.

Brandon J. Baker, 56, reportedly rented a room at a King Street residence and during a dispute with people there he tried to use a lighter to ignite tubing going to his rental oxygen oxidizer, officers said.

Police, who were responding to a reported structure fire, said Baker had stopped trying to start the fire before they arrived on scene. No fire was ever started.

Baker was arrested on a warrant at 8:25 a.m. on Jan. 25 and charged with second-degree attempted arson and first-degree reckless endangerment, officers said.

Police said Baker no longer lives at the King Street residence.

He was cited and released, officers said.

## Four accused of stealing over \$3,700 during burglary

MASSENA — Four St. Lawrence County residents are accused of stealing more than \$3,700 during a burglary, according to village police.

Officers said they investigated a commercial burglar complaint on Jan. 4 in which \$3,729.48 was stolen.

On Feb. 2 police charged the following people with third-degree grand larceny, and third-degree burglary, felonies:

All four subjects were arraigned in Massena court, officers said. Snyder was held on \$5,000 bail and the other three subjects were released on their own recognizance, police said.

Goodeau was ordered held in jail, officers said.

# Morristown Central School voters to decide on \$16.9 million project

MORRISTOWN — Morristown Central School District residents will be asked to vote on a \$16.9 million capital improvement project proposal on Tuesday, Feb. 13.

The project prioritizes building infrastructure, safety and security, and space adequacy needs in the district, according to BOCES spokesperson Brittany Frank..

The scope of the proposed project was determined following a recent Building Conditions Survey, during which target areas for improvement were identified.

With a primary focus on building infrastructure, the project includes roof replacements, HVAC

enhancements, necessary improvements to parking lots, masonry restoration, and site drainage maintenance at the bus garage.

"Space adequacy improvements outlined in the proposal are intended to optimize student learning environments and educational support areas," Frank said.

These improvements will include the renovations and expansion of the STEM classroom into a STEM suite, the addition of a choral music classroom and dedicated performance stage, the expansion of the fitness center which will allow for community access, and full reconstruction of the kitchen

and cafeteria spaces.

Additionally, the project will include door and lock replacements, the installation of individual restrooms at the elementary level, an expanded Nurse's Office, replacement of seating in the gymnasium, and controlled exterior access to building bathroom facilities.

These improvements will address safety and security needs in the district.

"The \$16.9 million project will be largely funded by state aid, with a building aid reimbursement rate of 79.9%," Frank said.

The district will contribute \$3.5

million in reserve funds to offset the impact on local taxpayers, resulting in an estimated tax levy of .695% to make up the remaining \$28,118.

This estimated levy will result in minimal increases to local taxes, estimated at \$.095 per \$1,000 of home value.

"We understand the importance of fiscal responsibility and have diligently worked to minimize the impact on taxpayers while addressing critical needs within our school," said Morristown Central School District superintendent, Staci Vaughn.

"This investment will directly

benefit our students, providing them with renovated facilities, updated learning spaces, and improved safety measures that support their academic success and well-being."

The Morristown Central School District capital improvement project vote will be held on Tuesday, February 13 from noon to 8 p.m. in the school's Main Lobby.

All qualified voters must be registered in advance with the District Clerk or the County Board of Elections.

If approved, the project construction is anticipated to begin in 2025.

# Mother of teen who committed suicide says Sen. Schumer is holding kids online safety bill hostage

CANTON – While describing her trip to Washington, D.C. worthwhile, Mary Rodee left the nation's capital with doubts about senators and CEOs from major social media platforms taking a serious look at the dangers of online pressures placed on children.

Rodee, the mother of Riley Basford, a Potsdam teenager who took his life in an online sextortion scam in 2021, wanted to see first-hand what a new education campaign called Parents SOS (Parents for Safe Online Spaces) had to offer.

Rodee, a teacher at Canton Central School, and other parents, attended a Jan. 31 Senate Judiciary Committee hearing featuring CEOs from major social media platforms, including Meta, TikTok, Discord, and Snap, who addressed their companies' roles in safeguarding children online.

## Confused by politics

"Hearing the frustrations the senators feel about the situation is confusing. Them saying we put bill after bill out of this committee and big tech kills them all. Why would a senator ask unchecked CEO's to let him know what parts of any of the online safety bills they would agree to? I can't even wrap my mind around how any of this works. There's obviously so much lurking in the bushes, so much back door decision making and back scratching," Rodee remarked. "The CEOs lied under oath, it's all incomprehensible and there are points it feels like further trauma. I find myself questioning whether the lawmakers are as guilty as big tech."

"The rally was a good experience, the young adults are very moving. One particular group wore shirts that said, I'm worth more than \$270 since internal Meta documents show them assessing young users as a \$270 profit per year. Meeting and spending time with the whistle blower Arturo Bejar was incredible,

real validation that the lack of transparency and checks was great," she continued.

Rodee spent the next day experiencing the city but with a heavy heart.

"I love seeing the places and offices and being in the capitol. Riding the trolley and subway under the capitol, being in the rotunda, being in the city, it should be fun and feel exciting but I can't get there," she stated. "Meeting new parents each trip while also continuing to get to know the mom's who have forged this path before me and learning that some of them have been fighting this for 12 years is unbelievable."

## Disturbed by Senators

Rodee is also disturbed by U.S. Senator Kirsten Gillibrand and Charles "Chuck" Schumer's refusal to meet with her to discuss KOSA (Kids Online Safety Act).

"Knowing that the predators who did this to Riley continue to do it to others while Gillibrand and Schumer never take my meeting requests. This time Gillibrand's staffer was "new to the team". Schumer's staffer said, "it's hard to get floor time." It's all meeting to meeting to meeting to listen to double talk," said Rodee. "Schumer is quite literally holding KOSA hostage while more kids get harmed every minute.

Her meeting with Congresswoman Elsie Stefanik, however, was a pleasant experience.

"Rep. Stefanik is great to talk with and her staff are hospitable and helpful. Elise says that she will support KOSA when it gets to the House, but it's easy to say that to our grief stricken faces when there's no bill in the house yet," Rodee noted. "I hope the hearings prove to everyone that they are not going to stop addicting people and using us as profit."

## Accountability needed

Rodee praised the mission of KOSA as the world deals with an ever-changing social media industry.

"We need KOSA because KOSA puts accountability on good design

practices. There have been no internet laws in 25 years, we know the industry is changing rapidly, the number of children harmed is growing exponentially," she said.

"I would really appreciate NY constituents calling Schumer and Gillibrand and telling them that you want KOSA, if someone needs a script, I'll give them one," Rodee said.

The main goal of Parents SOS is to raise awareness around the Kids Online Safety Act (KOSA) and really bring home the human-interest framing and highlight the lives of families who have been permanently altered by online harms.

"Social media companies profit off our children at the expense of their wellbeing and safety. We've come together to form Parents SOS because we refuse to let any other family experience this devastation. We are empowered by the memories of our beautiful children, turning pain into action," a statement from Parents SOS says.

The family has established the Riley Basford Legacy Fund through the Northern New York Community Foundation. The charitable mission and purpose of the fund is to support youth in their pursuit of safe and meaningful experience throughout their lives and in the community.

The fund supports three important focus areas. A top priority is to provide funding for education, training, and awareness to St. Lawrence County school for programs and projects centered on cyberbullying and cyber safety, anti-bullying and character education.

Rodee and Riley's father, Darren Basford have said the best way to remember Riley is to foster strong relationships with youth and educate all community members about the hazards of social media.

# Attorney sets sights on new family court judge seat

"Working with the staff of the court, nearly 90% of cases, assigned to her, were disposed of within six months. The best interests of children are her top priority. A trained mediator, she incorporates various skills to work towards settlement of cases, and encourages positive relationships between the parties. Effie has presided over trials, and has issued thousands of Court Orders and Orders of Custody," the release says.

"Delaying cases results in continuation of turmoil and discord in the families of our community. The People of our county deserve to have their cases heard quickly and efficiently. 
# Charged with drug felonies



# Ogdensburg reminding residents to keep streets clear for plows

OGDENSBURG -- The City of Ogdensburg is reminding residents that winter is now in full swing and with that the need to maintain safe passage on streets and sidewalks.

In the city, overnight on street parking is prohibited from Dec. 1 through March 31 and property owners are responsible for the clearing of their sidewalk after each snowfall.

In a release issued Feb 2, the city also provided city ordinances related to with parking and snow

management.

Residents should remove any snow that they might accidentally place in the roadway. They should also remove snow from their sidewalks.

"It is the property owner's responsibility to ensure that their sidewalk is passable and available to the walking public," the release says. "Be courteous to where you place your snow. Are you placing it where it could be pushed into a neighbor's yard or driveway?"

According to the release home and business owners are responsible for the actions of whom they might contract with for snow removal needs.

"Please ensure that they are aware of the city's ordinances and requirements for compliance," the release says. "Report illegal activity to the Code Enforcement Office or Department of Public Works so that it can be addressed. Anonymity will be honored as permitted under law."

Residents should not push snow out into the street for city plows to manage.

"It is illegal to place snow or cause it to be placed in a roadway. Please remove any snow that you might accidentally fall into the roadway.

Residents should not block sidewalks or crosswalks with snow.

"Be courteous to the walking public," the release says.

"Do not push snow onto a neighbor's property without their per-

mission. If you have permission to push snow across the roadway from a neighbor, please ensure that you clean all the snow out of the roadway. Be courteous; do not make it someone else's problem. Do not place your garbage containers in the roadway. Place them in your driveway or between the sidewalk and the street."

## Sheriff warns of 'Order of Arrest' scam

The St. Lawrence County Sheriff's Office, would never forward an "ORDER OF ARREST" through such means.

Moreover, under no circumstances would the Sheriff's Office demand payment over the phone to cancel an arrest warrant.

Citizens are urged to exercise caution and vigilance, the Sheriff's Office said.

If you receive a phone call or are presented with this fraudulent document, refrain from forwarding any funds.

Instead, contact law enforcement immediately to report the incident. The Sheriff's Office can be reached at 315-379-2222.

For me, I have been riding St Lawrence County Trails for 33 years and it is great to be able to hit the trails from home.


We all see snowmobiles on trailers heading up north and it is great having the ability to ride right here in St Lawrence County and not having to trailer our sleds for hours to ride.

**Is it party over country?**

The recent publication in North Country Now of the list of elected Republican and Conservative town, village and county officials backing the re-election of Elise Stefanik in the 21st Congressional District has raised some concerns.

What has caught our attention are the positions the Congresswoman has taken during her time in Congress.

We understand she wants to be a candidate for Vice President, but find her positions on critical issues facing our country problematic.

**Questions green hydrogen plan**

Is the green hydrogen plant being proposed for Massena a good idea for northern New York?

Given the increasing drought conditions in this country and the seasonal droughts that affect northern New York, I question whether taking huge amounts

of water from the St. Lawrence River (nearly 1,000,000 gallons a DAY) and changing it to hydrogen is wise.

This is not water that is returned to the environment like when we take a shower, prepare dinner, or water plants.

It is water that is turned into hydrogen and oxygen ... our water is lost forever so there is less water in the atmosphere and more hydrogen.

The Department of Energy “acknowledges that water consumption for H2Hubs could place additional stress on regional water resources.”

In northern New York we are not experiencing the drought situation that exists in the west but we do have drought conditions here at times and it seems these would be worsened by a hydrogen plant that removes so much of our water from the environment.

Before we accept a hydrogen plant locally, we should be sure that the plant does not affect the water supply for other essential purposes such as home use of water and agricultural use of water.

In other parts of the country, hydrogen plants are considering the adoption of seawater desalination to supply the millions of gallons of water needed every week for these plants.

It is, however, probably cheaper to use the water from the Great Lakes and the St. Lawrence River than to remove the salt from sea water but is it in our interest to allow hydrogen plants to use up our fresh water ... again, not to use the water and then return it to the environment but to permanently remove it by making it into hydrogen and oxygen?

How long would it be before northern New Yorkers started experiencing seasonal or more severe droughts?

How would the proposed hydrogen plant affect local agriculture, tourism, and the enjoyment we get from our abundant fresh water?

I am not an expert on any of these issues and therefore would love to hear what local farmers, meteorologists, and environmental engineers think about the hydrogen plant and the approximately 1,000,000 gallons of fresh water we would lose every day.

It also seems possible that the 90 permanent jobs that the hydrogen plant would provide could instead be provided by a lithium battery plant or an electric vehicle plant or solar energy manufacturer.

These types of manufacturing plants are currently being created all over the country by the Inflation Reduction Act.

It seems like our Senators and Representatives could help us get some of this manufacturing in Massena or Ogdensburg.

Parties with family and friends, concerts, movies, and sporting events now fill calendars, much as they did before the world learned of COVID-19.

Even though the novel coronavirus that arrived in late 2019 remains a concern, the vast number of people who have been vaccinated and boosted, or have developed antibodies, has allowed people to return to a more normal life.

While COVID-19 once was a major safety concern for party hosts and hostesses, it's not the only safety issue that can affect social activities.

When hosting any gathering - whether it's an intimate cocktail party or a backyard bash - hosts can heed these safety guidelines.

### Pace/control alcoholic beverages

The National Highway Traffic Safety Administration says every day 32 people die in drunk-driving crashes in the United States. That equates to one person every 45 minutes.

These deaths are all preventable, and one of the simplest ways is to limit opportunities for people to drive drunk.

Party hosts are responsible for monitoring guests' drinking. Spacing out drinks and limiting access to alcohol can keep guests from becoming overly intoxicated.

Stop serving alcoholic beverages two hours before the party ends so there's little opportunity to drive intoxicated.

Provide alternative transportation to those guests who still may be unsafe to drive.

### Make safety products available

Even though COVID-19 is no longer first and foremost on the minds of people, it has not completely vanished.

New variants of the virus are still developing, and many of these spread much more easily than prior versions, even if they produce milder symptoms.

Recommendations to stop the spread continue to be relevant today.

Wipe down surfaces, mask up if you will be in close contact, improve

ventilation, and encourage regular handwashing or use of hand sanitizer in the party space.

### Opt for single-serve foods

Communal buffet dishes mean crowds are scooping from the same pan or pot.

To reduce the potential spread of any unwanted pathogens, consider offering pre-portioned items that guests can grab and go.

Food already portioned out on to small plates or in cups can reduce the risk of cross-contamination for those with food allergies.

### Minimize entry points

Avoid the pitfalls of an invite-only event becoming a free-for-all, which can occur when teens or young adults host parties.

Have one entry and put a responsible adult in charge of checking invitations at the door.

Similarly, have a plan in place should any guests get out of hand.

Safety should be a concern at any party, large or small. Some simple strategies can ensure everyone has a safe and fun time

## United Helpers closing assisted living program

CANTON -- More than 30 residents living at United Helpers Assisted Living program in Canton

will need to find new homes. United Helpers announced Wednesday that the Assisted Living Program at 205 State Street in Canton would be closing. Like many healthcare providers

United Helpers has struggled to make ends meet due to low reimbursement rates and staffing difficulties. The closure is difficult news for the organization as well as the area which has limited offerings for those in need of assisted living.

Calls to United Helpers Assistant Director of Corporate Services Jordan M. Downing-Duke were not immediately returned.

However the organization did issue a press release stating that the decision was made after "careful consideration."

The release states that the closure of the Assisted Living Program will not affect the services provided by the 96 bed Skilled Nursing Facility.

"An announcement of the plan to cease operations as an Assisted Living Program has been made to the residents and resident representatives, and work will begin immediately to assist residents with making

arrangements for safe transfer to care providers of their choosing.

"This decision was not made lightly and follows months of deliberation and careful consideration. Critical factors driving the closure include significantly inadequate reimbursement, increasing costs and staffing shortages," the press release said.

"United Helpers Assisted Living Program in Canton, is a New York State certified, Assisted Living Program that provides supportive 24 hour services to 34 Residents. The New York State Department of

Health has reviewed and approved a comprehensive closure plan and United Helpers officials have begun the process of notifying all parties who receive services or conduct business with the program/facility.

## Marijuana license suspended

AKWESASNE— King Canna's retail cannabis license has been suspended, according to Saint Regis Mohawk Tribe's Cannabis Compliance Office.

The grounds for this suspension stem from King Canna's failure to remit retail fees in accordance with the SRMT Cannabis Ordinance, Tribe officials said.

They issued a notice of the suspension for the marijuana dis-

pensary, located at 18 Raquette Point Road, and said the notice was served to the owner on Jan. 12.

The notice signifies the immediate suspension of the SRMT Cannabis license, officials said.

Officials said that over the past six months, the Tribal Cannabis Compliance manager has made consistent efforts to bring the business into compliance. Despite a final warning letter issued on Nov. 17, the non-remittance of fees persisted, leading to the subsequent suspension.

"Member-owned licensed prop-

erties that comply with tribal regulations play a crucial role in supporting programs that assist Tribal community members," said Anthony Tillman, Cannabis Compliance manager. "We work closely with our licensees to help educate on the importance of compliance for the health and safety of our community, ensure timely remittance of fees to support the program, and to build a compliance program that is a model for other Nations. We will continue to work with the licensee to take steps to return to fully-licensed status."

## SLC unemployment rate slightly above state average

The unemployment rate in St. Lawrence County currently stands at 5.2%, without seasonal adjustment, 0.7 percent higher than the New York state seasonally adjusted rate.

According to a state Department of Labor report issued this week, the county's unemployment rate increased 1.2 percent when comparing Dec. 2022 to Dec. 2023.

The state unemployment rate is 4.5 percent.

In neighboring counties, the

unemployment in Jefferson County is 5.4 percent, up 1.1 percent from 4.3 percent in Dec. 2022. Franklin County's unemployment rate is 4.6 percent, an increase of 1.0 percent from 3.6 percent in Dec. 2022.

Rates are calculated using methods prescribed by the U.S. Bureau of Labor Statistics. The State's area unemployment rates rely in part on the results of the Current Population Survey, which contacts approximately 3,100 households in New York State each month.

Benevolent Association President from 2014 to 2023.

Powers said he was acting on advice from the state comptroller's office.

Such retirements are not uncommon among public officials holding office, in most cases they are simply reappointed, sometimes even at the same meeting.

Although Powers is hoping to be reappointed to the positions, the city's charter establishes a process for filling vacancies that has allowed Fisher to challenge him for the position.

Ogdensburg Mayor Michael Tooley said he expects a decision to be made at the Feb. 12 Monday meeting.

He said that both names will be presented to council and a vote will be taken. If one of the candidates receives the majority of votes, that candidate will be sworn in immediately.

While that outcome sounds likely it's not guaranteed.

In July of 2023 Tooley and Robert Edie were nominated to fill a vacancy on council left by former councilor Nichole Kennedy.

Under the process a vacancy committee recommends candidates, then the council chooses which candidate will get the appointment.

The charter required council to vote indefinitely until a candidate received a majority, but after 20 consecutive votes council remained split 3 to 3 between Robert Edie and Michael Tooley.

However, despite 20 votes taken to choose a candidate in July, no consensus was made.

At the July meeting Edie, who was present, eventually asked his name to be removed for consideration in order to allow the city to move forward.

Although Tooley was then the only remaining candidate, a resolution to appoint him to the position failed in a 3-2-1 vote.

Voting in favor of Tooley's appointment were councilors John Rishe, Michael Powers and Dan Skamperle. Against the appointment was Bill Dillabough.

Although they didn't explain their reasons for doing so, Skelly and Deputy Mayor Fisher abstained.

The vote failed, according to City Clerk Cathy Jock who said a quorum, or 4 affirmative votes, was needed for the resolution to pass.

However an opinion from the city attorney stated that according to the charter, a resolution was not necessary and that only a majority of votes was needed, which raised the questions as to whether Tooley should have been sworn in. He was never appointed to council despite the attorney's opinion, but was elected mayor months later.

to other areas the governor has prioritized in the proposed executive budget.

"This year that's been removed and we're seeing significant shifts in where the school aid is going," he said.

Districts that would be affected include Canton, Hammond, Madrid-Waddington, Morristown and Ogdensburg.

Those five districts aren't alone however, as Clifton-Fine is also set to lose nearly \$1 million under the proposed budget.

Clifton-Fine has also issued a statement to district residents, with Superintendent Matthew Southwick detailing a proposed cut of 24%, which would be a \$940,000 foundation aid reduction.

That would mean that taxpayers would be on the hook to make up the losses.

Foundation aid is essential for the fiscal health of many districts, according to north country reps, funds that are largely used for salaries, academic development and emergency projects up to a certain dollar amount.

Southwick was critical of the proposal, saying it "lacks care and concern for small rural communities such as ours and the ability for all students in the state to have the same opportunities regardless of where they live."

If foundation aid were cut to Clifton-Fine, Southwick said it would have "severe consequences in our ability to assist the students we serve," and could translate to a 21% increase in the tax levy for district residents.

School officials would also have no way to recoup those losses locally with a state imposed tax cap restriction, which limits the school's ability to raise revenue, he said.

"We acknowledge that our enrollment numbers may have decreased compared to when Save-Harmless was enacted, largely in part due to factors such as local families leaving the North Country and the ease of home-schooling requirements. Yet, the needs of our students we serve have continued to increase significantly," Southwick wrote.

School officials say the district helps families with clothing needs, while also providing food with an internal food pantry and mental health services for students and families alike.

Senator Dan Stec has also been a vocal opponent of the measure, taking aim at the state Education Department during a recent hearing.

Stec pointed to the fact that 24 of 47 schools in his district will receive almost \$8 million less in foundation aid combined, with Clifton-Fine receiving a 24% cut to aid and Parishville receiving a 12% cut as references.

Stec, who represents a sizable portion of St. Lawrence County, participated in a joint Legislative Hearing on Elementary and Secondary Education for the 2024 executive budget on Feb. 1.

During his allotted time, Stec questioned state Department of Education Commissioner Rosa about the proposal to eliminate the provision, a move that would heavily impact multiple districts in St. Lawrence County.

Stec joins the growing list of state representatives from both sides of the aisle who are voicing concerns over the governor's plans to eliminate the hold harmless provision.

Democrats and Republicans alike took aim at the proposal, saying it disproportionately affects rural and smaller suburban districts while also maintaining or even increasing aid levels for larger suburban districts and city schools.

Another crucial change proposed would be the way the rate of inflation is calculated when doling out foundation aid as well.

Rather than utilizing the Consumer Price Index, Hochul wants to use the average rate of inflation over a ten-year period that would then see the elimination of the highest and lowest numbers to settle on the average rate.

State legislators have said that the change would mean an increase in foundation aid of just 2.4% instead of a 3.8% increase based on the Consumer Price Index calculation method.

During the public hearing, Rosa herself admitted that the new system does not make sense.

Hochul has continually said that the idea that foundation aid is being cut is "inaccurate," saying that aid has increased by over \$7 billion in the past two years as the result of a court order that forced the state to increase aid.

Hochul said recently that districts "cannot expect that every year" and called the proposed changes "common sense" when assessing districts, in particular rural ones, that have seen enrollment declines over the last decade.

Critics of that stance, including north country reps, argue that more aid is needed for such districts because tax revenue has also declined as a result of families leaving the state in recent years.

Over the past 25 years, this winter's weather so far has been the third warmest. Only Dec. 2015/Jan. 2016 with 29 °F average temperature and Dec. 2001/Jan. 2002 at 28.93 °F average temperature have been warmer.


