Canton has Midtown Plaza developer

CANTON — A developer has been selected for the Midtown Plaza project.

On Wednesday night, the village board approved the Request for Proposal (RFP) from the Vecino Group, Troy, N.Y. They were one of five developers to submit RFPs. The other RFPs were from Sarto Group Inc. of Florida, Rochester's Cornerstone Group, Ltd., Blue Water Development, Ocean City, Md., and Potsdam Housing Authority & Rockabill Consulting and Development.

"Their design concept deeply researched our community and the developed plaza integrates into our downtown," said Deputy Mayor Anna Sorensen who spearheaded the RFP search process with Canton's Director of Economic Development Leigh Rodriguez. "They have really deep experience in housing with a flexibility and diversity of housing options."

"They had glowing reviews. We're really pleased to receive their proposal," she added. "This was a really big decision but we feel very confident that this is going to get the project done."

Voting in favor of the Vecino Group RFP were Mayor Michael Dalton, Trustees Barbara Beekman and Beth Larabee and Sorensen. Trustee Jonathon Pinckney voted No.

The 19 Miner Street Vision, according to the RFP, says Canton's historic Main Street is a destination of culture and commerce for the area; it boasts not one, but two campuses of higher learning, SUNY Canton and St Lawrence University; the Grasse River weaves through the fabric of the Village connecting all

to nature via Willow Island and Canton Island Parks.

Poised at the epicenter of all, the Vecino Group's vision is a 3-story mixed use development of 56 residential units, a 10,350-square-foot Innovation Center for SUNY Canton, 2,500 square feet of commercial space, a community garden and dog park, as well as 105 parking spaces for tenants, customers and the community at large.

The 1-and 2-bed apartments will be as attractive as they are functional, as is the way of each Vecino Group development. The goal is always to create affordable

units on par with market rate ones.

All units will come complete with full sized appliances in the kitchen, central heat and A/C, all electric utilities and free, building-wide WiFi, plus dedicated internet connections in each unit.

Anchoring the development will be the SUNY Canton Entrepreneurship Center, setting this development apart from anything else in the North Country. It will feature a community fabrication space, co-working facilities and education areas to help build

POTSDAM — A Potsdam town board member faces potential censures from both county and town levels over Facebook comments she made regarding the assassination attempt on former President Donald Trump at a campaign rally on July 13 in Butler, Pennsylvania.

Town Council member Christine Paige, who said in a Facebook conversation that shooting the former president would be like "putting down a rabid dog," told North Country This Week in a separate conversation that she has a right to freedom of speech and she did not apologize for her statements.

Her comments were part of a larger conversation threat in which the original poster said "Shit they missed his head," in the wake of a failed assassination attempt.

The comments by Paige have come to the attention of a county legislator who plans to introduce a formal resolution condemning her comments as a Potsdam town council member.

"It is totally unbecoming of a government official to say something like that," said Glenn J. Webster, District 11 Legislator. Webster, who is from Norwood, represents a section of the town of Potsdam at the county level.

Concerns raised about Judson flooding

CANTON — Residents on Judson Street voiced their concerns Wednesday night about persistent flooding problems and severe damage in their basement following the July 10 major rain storm.

First to speak was Matilda Larson, 25 Judson St., who told members of the village board that she and her son attempted to clear debris from two storm drains to alleviate the rising water but eventually to no avail.

"It became apparent that the second event was worse than the first. It flooded the front and back of our yard that I have never seen before. The water was not going down the drain," stated Larson,

noting there ended up being 20 inches of water in her basement. "The Canton Fire Department helped pump out but there was quite a bit of damage in our cellar."

In fact, she said they now need to have a new furnace installed at a cost of \$11,000.

"My biggest concern is that I don't want to put in a new furnace if it's going to happen again," Larson remarked.

Her husband Jon Rosales also spoke, suggesting the installation of backwater check valves.

A climate scientist, he told elected officials to expect more rainfall.

"It's going to get worse. The board needs to embrace this. It's right up there with clearing roads

of snow," he said.

Jennifer Pfotenhauer, 12 Judson St., echoed their statements.

"There was so much water there was a current into our basement," said Pfotenhauer, who noted she and her husband had resided at that address for 25 years. She said flooding events have occurred in 2018, 2021, 2022 and now 2024.

"Our concern is the big picture," she said. "The county drains into this area. Are they doing anything about this?"

Neighbor Raymond Cutway, 10 Judson St., said he has had to replace a sump pump and now needs to replace his furnace.

"This is my wife's dream house

CANTON — A new police officer has joined the Canton Police Department.

The probationary appointment of Colin Carroll was approved by the village board at its monthly meeting on Wednesday night.

Carroll attended Canton Central Schools and has been an active volunteer firefighter in the Canton Fire Department.

"Colin interviewed well and we are excited to invite him into the fold at the Canton Police Depart-

ment," stated Police Chief James Santimaw.

Carroll's first day on patrol will be Aug. 1 and his starting salary will be \$54,237.

He will be attending the Police Academy at SUNY Potsdam beginning Aug. 14. Carroll is filling the vacancy created by Joseph Mastro who left the department on April 7 for the New York State Police Academy.

"I am really impressed with Colin. He is very community oriented and is a team player," said Trustee Beth Larrabee, who was on the interview team.

Stolen jet ski, drugs seized

CANTON — A traffic stop by Canton police turned up a stolen jet ski and drugs and the arrest of four people.

A Canton Police Department press release reported that on Friday, July 5, at approximately 10:08 p.m., Canton police conducted a traffic stop on a motor vehicle that was towing a small trailer with a jet ski on Park Street in the Village of Canton. Upon further investigation it was determined that the jet ski had been reported stolen in the Town of Potsdam earlier that same evening. The vehicle towing the jet ski and trailer was also determined to be displaying switched license plates, had no insurance and the trailer had no working lights.

Additionally, the driver and three passengers were found to be in possession of a substance that tested positive for crystal methamphetamine and other drug related items.

One of the subjects was also found to be in possession of a switchblade knife.

Arrested were Brandon D. Dority, 36, the driver of the vehicle, of

53 Pleasant St., Hermon; Justin P. Dority, 33, of 53 Pleasant St., Hermon; Sylvia L. Gonzalez, 30, 53 Pleasant St., Hermon; and Courtney M. Barber, 31, of 815 Main St., Ogdensburg.

All four subjects were charged with one count each of fourth-degree criminal possession of a controlled substance. Brandon D. Dority was additionally charged with one count of third-degree criminal possession of a weapon and numerous NYS Vehicle & Traffic violations to include switched license plates, unlicensed operator, no trailer lights and others.

All four subjects were arraigned before Hermon Town Court Judge Velez and only the driver, Brandon Dority, was subsequently held at the St. Lawrence County Jail on no bail.

All defendants are scheduled to appear on Aug. 26 in Canton Town Court.

The Canton Police Department was assisted by the St. Lawrence County Sheriff's Office who handled the stolen jet ski and trailer portion of this matter.

Village DPW projects moving forward

POTSDAM — The village's summer public works projects schedule is moving along at pace, said Village Department of Public Works Supervisor Greg Thompson.

"We've been extremely busy over the course of the last few months," Thompson told the village board at their meeting July 15. "We came into our normal construction season with a very ambitious agenda to say the least."

"I'm happy to say that at this time we are beginning to see positive progress being made," Thompson said.

The supervisor said the village should be able to complete all of the projects on the list prior to the end of the building season.

Thompson said recent projects include construction of the batting cages at Sandstoner Park, the ongoing installation of the new parking signs throughout the village, and the start of construction of about 750 feet of sidewalk on outer Main Street.

The DPW is also engaged in painting of parking spaces, stripes and street curbs.

Milling and paving on Pine

Street, May Road, Main Street and Canal Street was also on the docket for the DPW.

"I know there have been comments from people who have hit manhole covers. I apologize, we are trying to get orange paint on them so they are more visible," Thompson said.

He said the problem the DPW faces is that some streets have to be milled before they can be painted in order to maintain a "curb reveal."

"And we have to take the milling machine when we can get it, and a lot of times that's somewhat earlier than we can pave," Thompson said. "Our apologies if it's been an inconvenience to anyone."

In addition to the street work, the DPW is also conducting ongoing brush pickup, park and airport upkeep, point and patchwork on the facade of the civic center, and dealing with multiple water main breaks earlier this season.

Thompson said the crews have also taken down five trees that were in various states of degradation, prepped Sandstoner Park for the summer, assisted (when necessary) the firm charged with testing the lead service laterals, and installed the kayak/canoe launch in Ives Park.

The village's DPW crews also take care of street sweeping, sewer system maintenance, needed repairs and renovations at the municipal buildings, and pothole patching.

"And honestly, that's not even everything. As you can easily see there is a lot more to our DPW than paving roads and plowing snow," Thompson said.

"Our crews work extremely hard and we take a lot of pride in the upkeep and the care we give the village of Potsdam," Thompson said. "No matter if it's 20 below or a 100 degrees, snow, ice or extreme sun, my guys are out there and they are getting the job done."

"It's been a tough year with the resignations and retirements of several longtime employees, and the looming reality of several more we believe will be leaving in the near future. As we move forward I would ask the board to be patient and understanding. Many of these projects cannot be completed overnight and when we are expected to work on several at one time that just complicates matters for all of us," Thompson said.

"We are very fortunate to have the crew we have and I'm very confident we will complete that long list of 'to do,'" the supervisor said.



Village water needs drop by more than 50%

POTSDAM — Water production has dropped more than 50 percent over the last three years in the village while still meeting consumption demands.

The decrease seems to indicate that improvements to the village's production facility as well as infrastructure improvements and conservation measures are having an effect.

According to information relayed by Village Administrator Isabelle Gates-Shult at the village board meeting on July 15, the village's water production numbers show a large drop in production since 2022.

Gates-Shult said that the village's chief water operator calculates that in June of 2022 the village produced 23,179,000 gallons of water.

In June of 2023, the village produced 15,541,000 gallons of water.

North Country reps push to reuse closed prisons

Senator Dan Stec is calling on his fellow state lawmakers to support legislation that would ensure closed state prisons can be repurposed instead of sitting dormant.

In a recent press release, Stec was critical of the failure to advance prison reuse amendments which would have allowed municipalities affected by prison closures to repurpose the facilities.

"I've said for years that the state government must enact a reuse plan for dormant prisons. But I've done more than talk about it; I've acted. This year, my constitutional amendment that would allow for New York State to sell the closed Camp Gabriels facility passed the state Senate. It's not the first time my amendment has passed the Senate, however. Since taking office in 2021, the Camp Gabriels amendment has passed each year I've been in office," he wrote.

Despite the legislation passing the Senate again, Stec said Assembly members failed to advance the bill.

He noted an "11th hour push from the governor's office" that would lead to a constitutional amendment

in June of 2024, the administrator said, with only 10,789,000 gallons produced.

"So this means the water consumption has decreased around 53 percent over the last three years," Gates-Shult told the village board.

"And I think with the continued changes and improvements happening within the water department, as well as continued conservation of water, finding those leaks and other issues, we'll hopefully continue to see a decline in that water usage. That is the goal," she said.

The village produces water for about 10,000 residents, including the water provided to SUNY Potsdam and Clarkson university.

The water is drawn from the Raquette River to the village's treatment plant where it is filtered through a sand filtration system, to two elevated storage tanks. From there it supplies several miles of water mains which bring the water to village residences, businesses and other buildings.

to allow the sale of three shuttered prisons, however it "failed to surface in either chamber of the legislature."

Stec pointed to Governor Hochul's decision to delay congestion pricing in New York City as a likely reason for the amendment's failure to surface.

According to Stec, it is almost a certainty that the legislature will reconvene this year to address the MTA situation again.

"At that time, the Assembly should do the right thing and pass the Camp Gabriels amendment for the first time. That way, we can move one step closer to finding a new use for the facility that helps it become an economic driver, rather than blight. Or, the Legislature should take up the three-prison amendment the governor's office has proposed, but not submitted," he said.

Stec said if neither option comes to fruition, "the governor and Assembly Democrat leaders owe the North Country an explanation as to why they refuse to move forward with these or any substantive prison reuse plan."

Stec's statement comes as the Governor's office has signaled more closures will be announced in the

SLC unemployment rate flat

The unemployment rate in St. Lawrence County in June was 4.6%, without seasonal adjustment, 0.4 percent higher than the New York state seasonally adjusted rate.

According to a state Department of Labor report issued this week, the county's unemployment rate increased 0.3 percent when comparing June 2023 to June 2024. The unemployment rate in St. Law-

rence County currently sits at 4.6%.

The state unemployment rate is 4.2 percent.

In neighboring counties, the unemployment in Jefferson County is 3.9 percent, up 0.2 percent from 3.7 percent in June 2023.

Franklin County's unemployment rate is 3.5 percent, an increase of 0.2 percent from 3.3 percent in June 2023.

Troopers say Massena teen found dead after boat capsized on river

WADDINGTON -- Attempts to rescue a missing teenager who was a passenger in a boat that capsized near Cole's Creek has ended in tragedy.

New York State Police say the Underwater Recovery Team located Ayden J. Buffham, 19, of Massena, who was pronounced dead at the scene. Rescuers had been searching for the missing passenger of a capsized boat since Monday afternoon.

State Police members responded to Cole's Creek near Cole's Creek Road in the town of Waddington for a report of a boat capsized. Police say there were two

passengers on the boat when it overturned, sending them into the water. One passenger was able to safely get to shore, while the other wasn't located until 2:31 p.m. Tuesday.

State Police were assisted by the St. Lawrence County Sheriff's Department, New York State Department of Environmental Conservation, Massena, Waddington, Potsdam, Ogdensburg, Parishville, Hogansburg, Louisville, Brier Hill, Rensselaer Falls, Morristown, dive, and fire and rescue teams.

Snowmobile trail grant program resolutions pass

CANTON -- St. Lawrence County legislators have signed off to sponsor a snowmobile grant application through the state Office of Parks, Recreation and Historic Preservation.

According to the resolution passed during the full board meeting held July 1, St. Lawrence County has served as the local sponsor of the New York State Snowmobile Trails Grant-In-Aid Program since 1988.

The snowmobile registrations will be remitted to St. Lawrence County to be used for snowmobile trail development and maintenance, officials said.

Officials said the St. Lawrence County Snowmobile Association and North Country Trail Maintenance Alliance are committed to continuing the maintenance of trails within the County.

In other action, legislators also passed a resolution to sign contracts with designated trail maintenance entities associated with the New York State Snowmobile Trail Grant Program.

SLC to receive \$66,000 for jail medication treatment program

CANTON -- The Community Services Department of St. Lawrence County is set to receive \$66,000 each year for three years to support the state mandated Medication Assisted Treatment Program at the St. Lawrence County Jail.

County legislators approved the one-time funding opportunity during the Jul 15 services committee meeting, which will be used to offset St. Lawrence County Addiction Services costs.

The funds are part of the opioid settlement that St. Lawrence County, like many others, took part in.

Addiction Services currently offers Opioid Treatment Program (OTP) services, as well as counseling and peer services at the correctional facility, officials said.

At present, around six inmates at the county jail are currently in the program and receiving Methadone treatment, according to Community Services officials.

"The Board of Legislators recognizes the need for access for individuals with Opioid Use Disorder (OUD) to recovery services in St. Lawrence County," officials say.

The one-time funding opportunity will be used to cover expenses over a three year period, running from Oct. 1, 2024 through Sept. 30, 2026.

New AEDs for Norwood FD

NORWOOD -- The Norwood Volunteer Fire Department recently purchased three brand new automated external defibrillators (AEDs) and five fully stocked first aid bags to be placed on the fire trucks thanks to the generous donations from the community.

The money was raised during the department's annual "coin card" fundraiser.

Officials said the program establishes a mechanism for allocating funds to local governmental sponsors engaged in the development and maintenance of snowmobile trails, designated as part of the NYS Snowmobile Trail System.

According to the resolution, the county is designated as the recipient of funds under the program and is designated as a "local sponsor" for receipt of NYS Snowmobile Grant funds.

"The Program establishes a mechanism for allocating funds to local governmental sponsors that engage in the development and maintenance of snowmobile trails designated as part of the State Snowmobile Trail System," the resolution states.

The county Planning Office has been tasked with the role of Authorized Project Administrator and will oversee the operations and deliverables on behalf of the county, officials say.

"Several snowmobile associations assist the County in maintaining the trail system and may be designated as Trail Maintenance Entities," officials said.

Joseph Lightfoot asked whether the new funding stream would cut down on the costs for the county or altogether eliminate the required contribution.

Though officials did not have an exact figure on what remaining balance would be covered by the county, officials said it would be dramatically reduced over the next three years.

In other action, legislators also signed off on a contract with Thrive Wellness and Recovery Inc. to accept pass-through funding from the New York State Office of Mental Health.

County officials a contract was previously signed with North Country Transitional Living Services to accept pass through funds, however with a merger between North Country Transitional Living Services and Credo filed recently, Thrive Wellness and Recovery Inc. is the sole surviving entity, necessitating the

DSS building needs basement floor repairs

CANTON -- St. Lawrence County legislators have signed off on a budget modification that will allow the Department of Social Services to repair damaged flooring in the basement of the Harold B. Smith building.

According to DSS Commissioner Joseph Seeber, DSS maintains a large server infrastructure for storage and access in the basement of the facility.

But flooding in 2021 damaged the raised flooring in the basement, necessitating repairs and replacement this year.

He told legislators the damage was significant, with the raised flooring being heavily damaged by the water.

In some areas, hatches are unable to be opened, he said.

According to the resolution, the raised floor has not been replaced since the flooding in 2021, making it even more difficult to maintain critical equipment for DSS.

Though a modification of \$45,000

is required to pay for the floor, Seeber said the issues were known prior to budget planning which allowed DSS to plan ahead and budget appropriately.

"This resolution is just to move money around, we already budgeted for this," Seeber said.

In other action, legislators also signed off on a budget modification to roll over \$2.16 million in remaining funding for child care throughout the county.

Seeber told legislators DSS is allocated funding from the New York State Child Care Block Grant, with funds rolled over from the previous fiscal year.

In total, there were \$2,162,178 in funds remaining from the prior fiscal year for the Child Care Block Grant, along with \$366,155 in unspent ARPA funds as well.

Seeber said the modification to the budget is to "just clean up the budget to make sure it goes back to the Block Grant for day care services."

He said child care throughout the

county has grown exponentially, with 44 providers in July of 2022, 61 in July 2023 and now 87 in July 2024.

With the number of child care providers increasing, Seeber said the number of unique individuals enrolled also rose.

In June 2022, 174 children were enrolled, while 350 were enrolled in June 2023 and 473 were enrolled in June 2024.

Seeber told legislators that the ARPA funds was "money well spent."

He said that access to child care has improved with so much state and federal aid, however Seeber credited the expansion of eligibility as a large reason that so many families are able to utilize day care services as well.

"The broadening of eligibility standards means more people can send their kids to child care," he said.

Seeber also credited the Child Care Council and county for assisting with recruitment and the funding of numerous childcare facilities in recent years.



1. To equitably apportion the cost of participants consistent with the risk brought to the plan and the participant's recent experience, thereby encouraging participants to focus on accident prevention coupled with early and safely returning injured workers to productive work. Local Law No. 3 for the year 1993 is hereby REPEALED. Local Law No. 2 of 1956 [A Local Law enumerating Rules and Regulations for the Administration of the St. Lawrence County Self-Insurance Plan] to establish apportionment of costs to plan participants, together with such other amendments and additional new rules and regulations necessary for the efficient administration of the Self-Insurance Plan is hereby AMENDED; and

2. The apportioned funds will be exclusively used for plan operation, including all direct and indirect expenses; and
3. To allow "fire districts" with taxing authority or that are municipal corporations shall be eligible plan participants as an independent entity as provided under Workers' Compensation Law §60 provided such fire district, if currently apportioned as part of another participant, shall first agree with said participant how the ongoing liabilities of any claims incurred prior to such conversion shall be paid; and

4. To establish a method for making actuarial calculations of plan liabilities for any purposes (including the sum owing from an entity withdrawing from the plan and establishing a buy-in rate to entering participants), an installment methodology for both entering and withdrawing participants, provisions relating to the role and responsibilities of the plan administrator, determining the maximum reserve upon an actuarial determination of plan liabilities, requiring proof of medical testing for certain titles as prescribed by law, codifying the required labor management safety committee together with its powers, and methods of enforcement plan provisions and the governing law, including but not limited to, withholding of sales tax proceeds; and

DEC listens to public outcry about Deer River

BRASHER — Department of Conservation officials and residents affected by the pollution of the Deer River met Tuesday, July 23 in a public forum in an effort to inform the public of the processes and actions taken by the DEC.

Public outcry by residents affected by the pollution that has been tied back to North Country Dairy, a dairy processing plant on the river, reached a fevered pitch in recent weeks, prompting the DEC to host the meeting.

According to Region six Director Randall Young, the long process began last year when reports of a red substance appeared in the river.

"It was at that time we began an investigation but it takes time," he told the residents in attendance.

But for the more than 50 people in attendance, that answer did not sit well in what was a sometimes contentious meeting.

Residents questioned why DEC officials took so long to address concerns that some said began three years ago.

"For three years we have called and complained. For three years we filled out the online complaint form. Nothing, we got nothing," one attendee said.

Others suggested the DEC would just modify the existing permit to allow for the discharge that has negatively impacted the river.

But Young attempted to assuage those concerns, saying it would not even be legal to do so.

"We would not do that. It is not possible to issue a less stringent permit for a facility that has already been permitted," he said.

Young told onlookers that the DEC would issue a modified permit with tighter restrictions and less output, if a new permit were to be issued.

Other residents raised concerns that the wildlife in a nearly 12 mile stretch of the river would never come back but Young said the DEC is confident the ecosystem would bounce back once the pollution ends.

Young said after two notices of violation North Country Dairy is well aware there is an issue that requires correction.

"It is our hope they are already taking corrective action. If they are wise, they are already working on that," he said.

About That Medicare Part D Mailing

Some North Country residents received a scary mailing about Medicare Part D, financed by an obscure "Seniors for Better Health," claiming passage of HR 4895 would "force as many as 2 million seniors off their Part D plan" and lead to "Part D premiums rising by 50%."

These claims, supposedly backed by "numerous (unnamed) studies," are footnoted, sort of. One citation, "KFF, Medicare Part D in 2024, 11/8/24," is elusive; a search at KFF.org, netted nothing relevant.

Another citation: (unnamed) "Managed Healthcare Executive, 3/19/24."

Any junior high student should recognize inadequate sources.

This is not misinformation; it's intentionally misleading disinformation.

HR 4895, named the "Lowering Drug Costs for American Families Act," is intended to expand Medicare's new ability to negotiate better drug prices that seniors will begin seeing in 2026 to hard-working Americans on private plans, benefiting an additional 164 million Americans and their families on employer-based plans and 16 million Americans with Marketplace coverage.

"Big Pharma" lobbied for years to prevent Medicare from negotiating lower drug prices until the 2022 Inflation Reduction Act (IRA) enabled it.

They fear the expansion to private plans for obvious reasons: Americans might stop paying 2.78 times more for drugs than 33 other countries. (2024 Rand study)

HR 4895 also adopts the IRA's provision that penalizes drug companies from raising prices faster than inflation.

Lower drug prices for others forces seniors out of their Part D plan? Ridiculous!

A 50% rise in Part D premiums? According to a 1/24/24 HealthWell Foundation article, "the Inflation Reduction Act has a Part D premium stabilization provision starting in 2024, through which the Medicare Part D base beneficiary premium is capped at a 6% annual growth rate."

Seniors4BetterCare.com sounds like "grassroot grandparents."

The site has no "About Us;" one must open the "privacy policy" to discover its American Prosperity Alliance, a dark money group formed in 2022 to fight the IRA, according to Open Secrets, and whose Articles of Incorporation state "2. The Corporation shall have no members," but has a "sole incor-

porator," a corporate tax lawyer named Tom Antonucci. No seniors?

How much did it cost to spread this disinformation across the nation?

It wasn't from a bunch of "grassroot grandparents," but rather the wealthy again protecting profits

at the expense of Americans who continue to pay some of the highest drug prices in the world.

Vote blue in November.







community collaboration and networking opportunities.

"As entrepreneurs find success, they can take advantage of one of the commercial storefronts within the development—which is connected with the downtown via hardscaped pedestrian paths. With its focus on today and the future, our vision for 19 Miner will serve the housing needs of both the Village of Canton and its surrounding communities, while establishing the foothold of an innovation hub and retail center that will serve the North Country for decades to come," the proposal states.

"Funding is typically the other large hurdle, but many positive strides have already been taken to mitigate this issue. The Village and SUNY Canton have done a won-

derful job securing over \$6 million for the project, with the potential for more funding through Forward NY. This secured funding will send a very clear message to HCR, enabling us to have a high probability of securing 9% LIHTC funding in the 2025 round. HCR likes to see other entities with a financial stake in the project, this has occurred here."

Sorensen noted the Vecino Group RFP is not a final concept or design.

"It will be important for the public to know that the concept presented by Vecino is not the final design that will be implemented. They will begin a process of marketing/housing studies and engaging stakeholders and the community to develop a final design that meets our needs. Much more planning and discussion to come and we're very excited to begin that

work," Sorensen remarked.

In May of 2023, the Village took ownership of the six parcels that make up the plaza for \$1,280,000. The Village was also awarded \$2,000,000 from the Restore NY program that will be used toward demolition of the existing structures and abatement of anticipated hazardous materials.

The Vecino Group was awarded a 2022 New York State Preservation Award for its work on Old Snell Hall in downtown Potsdam. The national affordable and supportive housing developer, along with partners the Village of Potsdam and Clarkson University, spent more than four years rescuing the 103-year-old former campus building to redevelop and serve its community as affordable housing and arts-driven programming.

Now operating as The Quarry—named for the famous, locally-sourced sandstone used as its structure—the newly renovated building provides 59 apartments for people living at or below 70% of the area's median income as well as a library, a community room and fitness center. The first floor provides community connection via flexible programming areas for Clarkson University as well as additional community-centered spaces such as a gallery, art studios and the completely restored auditorium.

"It's basically political assassination, it's terrorism," Webster said of the assassination attempt on the

former president.

The legislator said there are a lot of people he does not agree with, and some he doesn't respect, but he would never wish them murdered.

"There is no room for people in our government (to say things) like that. That's why we are where we are right now."

Webster said Paige's statements have caused a stir and he has been urged to do something formally over the comments.

"I have had quite a few constituents call me and ask me to do something about it," he said.

Webster said he will introduce a formal resolution at the next county legislature meeting which denounces Paige's statements and calls on the Town of Potsdam to remove her from office.

"This isn't somebody saying this in their house to a neighbor or a friend," Webster said, pointing out that statements made on social media forums have more reach and influence. He said Paige's statements, as an elected official, incite political violence.

Webster suggested that Paige be asked to resign to do what's best for the town.

"This isn't something I want to do, but I feel like I have too," Webster said.

Potsdam Town Supervisor Marty Miller said the town board will be discussing the issue at the next town board meeting in August.

"I've been made aware of the situation and we are working on it. There will be some sort of action taken at the next town board

meeting," Miller said. Miller did not have any further comments on the issue.

For her part, Paige is not apologizing for her statements and said it's a First Amendment issue.

"My right to free speech is guaranteed by the First Amendment, whether you agree with it or not," Paige said. "As is everyone else's."

The town council member said she is not heeding any of the blowback that has resulted from her statements.

"I don't really pay much attention to it. They have a right to their free speech," she said.

Paige said however that she has gotten some hate mail regarding her Facebook exchange.

She said she will continue to be outspoken about the things she believes, whether people are critical or not. "That's the beauty of America," Paige said.

As for the critics of her statements and those calling for her ouster, she believes those comments will eventually subside.

"I've lived in the North Country my entire life and I've dealt with this type of individual many times," she said.

"I don't pay attention to their foolishness. This will blow over," Paige said.

but now I'm not sure I want to live there," said Cutway. "The water was five feet deep in my basement."

Mark McKenna, 65 Court St., encouraged the board to address drainage issues on Court Street.

"There has been water in our basement since I was a kid," stated McKenna, noting the July 10 storm dumped four inches of water in his basement.

Mayor Michael Dalton sympathized with the Judson Street property owners but pointed to the cost associated with these projects.

"I'm familiar with what's going on. We know it's probably going to get worse and we know we need to do something," the mayor stated. "My concern is no matter what we do we can't handle the capacity with such a storm. We have to leave it to the engineers to review what is needed."

Cost estimates are \$1.2 million for the Cleveland Avenue project; \$2.75 million for Judson Street.

"Four million dollars has a substantial impact on the taxpayers," said Dalton, hoping grant money will become available.

The village is currently engaged in drainage improvement projects for Cleveland Avenue and Judson Street, with a similar study eyed for Court Street. The village has contracted with the engineering firm Barton & Loguidice, Watertown.

A memo from Alexander Kerr, from Barton & Loguidice, to Village Superintendent Tim Bacon, indicates the problem.

"Judson Street has a history of localized flooding. The Village of Canton has commissioned this study to analyze the existing network in order to quantify capacity issues and develop preliminary drainage improvements," the memo reads.

Field observations report that Judson Street features aged drainage infrastructure and the existing network has proven to be undersized for recent storm events, which caused localized flooding in various locations along the corridor.

The consensus of the board was to come up with some short-term solutions to combat the potential flooding problems. The mayor said the board will provide updates on the Judson Street drainage issues at its next meeting on Aug. 21.
