Ogdensburg wants to bolster PD

City to offer \$15,000 sign-on bonus for police officers

OGDENSBURG -- Ogdensburg city council will offer a \$15,000 sign-on bonus for officers willing to commit to a three-year contract on the force.

Council approved the resolution Monday after Ogdensburg City Police Chief Mark Kearns painted a dire picture of the city's

struggling department. Although the city has budgeted for 21 sworn officers, the department is limping along with about 16.

Kearns said the city has an injured school resources officer, a patrol officer who is out on a discipline matter, recently lost an officer who is transferring to the sheriff's department and a pending retirement.

The city has also had a vacant position in the department that's been unfilled for nearly one-full year.

The lack of staff could force the city to end a night shift due to a lack of officers.

Kearns said that to operate as a well functioning department the city would need to have 23 sworn

Ogdensburg park will honor late Mayor Wayne Ashley

OGDENSBURG -- Ogdensburg will honor late Mayor Wayne L. Ashley by establishing a park in his namesake.

The park will be located on a 1.3 acre city-owned plot on Lower Lake Street.

The city council had been discussing a way to honor Ashley for the past several months, with City Councilor Storm Cilley initially

suggesting the idea.

Several council members spoke highly of Ashley at the meeting, including Councilor Dan Skamperle who said he grew to be good friends with the former mayor and that the city could use more people like him.

Wayne L. Ashley was elected Mayor of the City of Ogdensburg in November 2015, serving in that capacity from January 1, 2016 to December 31, 2019. Prior to that he served

as a member of city council from November 2011 through December 31 2015.

"Under the leadership of Mayor Ashley the city received nearly \$8.5 million to address flood damage caused in 2017 and 2019, oversaw the designation of the north country's first NYS DOS Brownfield Opportunity Area Plan in 2016, and established the Ogdensburg Land Bank in 2018,"

Buried by violations in Massena

Department sees 10-fold increase in average monthly calls over past 20 years

MASSENA -- Code Enforcement officers in the village of Massena are handling roughly 700 calls on average each month, a case load that is nearly ten times what the department was seeing two decades ago.

According to Code Enforcement Officer Aaron Hardy, the department has remained relatively the same since the late 1990's, with the same manpower.

During a recent village board meeting, Hardy informed village board members the department handled roughly 88 calls per year 20 years ago with the same manpower.

He said one of the largest differences is the timeliness of residents responding to code violations.

"Years ago, if we had an issue with someone who may have not mowed their yard or had trash or

debris that needed to be picked up, we'd write up a violation and the next day we'd get a call apologizing. It would be taken care of. These days, it's not like that anymore. A number of times we have to follow up and continue further along with the process," Hardy told NCTW recently.

Village officials say they are aware of the workload the department is under and hope to address staffing in the near future.

According to Hardy, the department is currently staffed by seven officers who also do double duty as permanent firefighters as well.

"One of the biggest parts of our discussion is workload and staffing. I think that we're planning to address it here in the near future," Deputy Mayor Chad Simpson said.

One of the primary reasons village officials hope to address staffing in the future is due in large

Local airports get \$4.2 million in fed cash

MASSENA -- Senate Majority Leader Chuck Schumer and Senator Kirsten Gillibrand have secured over \$4.2 million combined for Massena International Airport and Ogdensburg International Airport.

The news broke as Schumer and

Gillbrand announced nearly \$60 million in funding for airports across the state.

The grant funds, which come from federal funding, will be used to modernize facilities and strengthen airfield safety at 26 different airports across the state.

"From big cities like Buffalo & Syracuse to our rural communities

in the North Country, Upstate NY's regional airports are gateways for commerce, tourism and travel for residents. It is essential that they have the resources they need to deliver a safe and comfortable experience to all travelers, which is why I am proud to deliver a whopping \$59+ million for airports across the Empire State to help our airports of all sizes reach new heights," said Schumer.

"This \$59+ million federal investment in new terminals, taxiways, safety, and other critical infrastructure upgrades will help airports soar. I fought hard to bolster the Airport Improvement Program in the FAA reauthorization this past year because I know this program is the main federal life-line for these airports and today's investment will help our local economies take off!"

Massena International Airport will receive \$2,254,896 to construct a new sand storage building, while Ogdensburg International Airport will receive \$2 million for an ongoing terminal expansion project.

"New York's airports welcome millions of travelers each year, and it is vital that they have up-to-date infrastructure needed for passengers to travel safely," said Gillibrand.

"This nearly \$60 million in federal funding will bring much-needed safety and infrastructure improvements to airports across New York State. I am excited to announce this funding and will continue fighting to bring vital modernization efforts and improvements to airports across New York State."

Massena town officials recently took action during the Aug. 21 board meeting to accept any potential future grant offers by the FAA for the sand storage building project.

The project has been in the works for several months as Highway Superintendent Dylan Casselman and other town officials have sought funding for the project in hopes of completing the new storage facility before winter.

Officials previously said the project would greatly benefit airport crews in maintaining facilities around the facility.

For Ogdensburg, the funding comes on the heels of an additional \$2,565,051 grant received just three weeks ago.

The Ogdensburg airport funding is earmarked for expansion and reconstruction of the terminal.

Sen. Schumer visits Ogdensburg to launch two-pronged plan to combat EEE, West Nile

Mosquito tracking, an extra \$2 million for CDC programs on the table

OGDENSBURG -- Senate Majority Leader Chuck Schumer was in the North Country today, Sept. 5, to launch a two-pronged approach to combat Eastern Equine Encephalitis and West Nile throughout the county.

In his address to local officials and media, Schumer said he would continue to advocate for advanced funding at the federal level to combat the rise of EEE and West Nile.

To date, five horses have been infected with EEE, while another horse has been identified to have tested positive for West Nile.

"Anyone who was outdoors over Labor Day weekend in the North Country knows the mosquitoes are buzzing this season. But here in St. Lawrence County people fear more than just an itch, as the region has seen an unsettling spike in EEEV cases among horses and West Nile Virus being found in many parts of the state," said Senator Schumer.

"This mosquito season could last well into fall because of all the recent flooding and very wet summer. So, today, I am here to launch a two-pronged push to get the feds to step up efforts to help New York & local officials and surge the resources to zap these bugs and beat back these diseases before they spread."

As part of his approach, Schumer said he is calling on the Centers for Disease Control and Prevention (CDC), which works in conjunction with the Environmental Protection Agency (EPA) to ensure coordination and outline a plan for working with New York State and local communities to survey and track mosquitoes.

Schumer said the CDC and EPA must make sure communities have the resources they need to deal with the new threats that the mosquito population brings, like the surges in mosquito-borne illnesses we are seeing this summer and could keep seeing into the future if the trend continues.

Along with his push for the federal government to track mosquitoes, Schumer is pushing for a \$2 million increase for the CDC's Vector-Borne Diseases program, which includes

EEEV and WNV.

"With five horses testing positive for Eastern Equine Encephalitis across the northern part of the county, and now an additional horse that tested positive for West Nile Virus, it is clear that we need to be concerned about the mosquitoes in our area," said St. Lawrence County Public Health Director Erin Streiff.

"Because these viruses are transmitted by mosquito bites, we are urging everyone to please take precautions to avoid being bitten. That includes limiting time spent outside between dusk and dawn when mosquito activity is higher, and wearing long-sleeved shirts, pants, and socks as well as using an approved insect repellent, like one containing DEET. We appreciate Senator Schumer's efforts to increase awareness as well as funding to address this issue and help protect our health."

In conjunction with Public Health officials, the St. Lawrence County Chamber of Commerce has also advocated for assistance as outdoor recreation has been a key component of multiple initiatives in recent years.

"The St. Lawrence County Chamber of Commerce works to create a vibrant business climate that encourages growth, while building a strong and vibrant future for the generations to come. We are also advancing sustainable tourism as the Tourism Promotion Agency for our county, one that has boundless outdoor recreational opportunities. Yet the increasing incidence of mosquito-borne illnesses pose a threat to these goals and may impact many aspects of our county, from economic and business development to resident attraction, tourism, and public health," said St. Lawrence County Chamber of Commerce Executive Director Ben Dixon.

So far in 2024, the state Department of Health has identified 20 human cases of West Nile virus and 1,868 WNV-positive mosquito pools, including at least three human WNV cases, two horse WNV cases, and 226 WNV-positive mosquito pools across Upstate NY.

Over the last week, local public health officials have confirmed multiple human cases of West Nile in Upstate NY, including a Jefferson

County man who contracted the county's first WNV case in more than 15 years and an adult man in Wayne County who has been hospitalized with WNV.

Though EEE is rarer, humans are susceptible to the virus as well, Streiff said.

Just recently, a New Hampshire man passed away after being infected with EEE, Schumer said.

The NYS DOH has confirmed the presence of at least fourteen cases of EEEV in horses across ten Upstate NY counties, including St. Lawrence, Madison, Oneida, Cayuga, Orange, Ulster, Wayne, Washington, Clinton, and Franklin, as well as at least nineteen EEEV-positive mosquito pools. There have been 11 human cases of EEEV in NYS since 1971 and seven of those cases were fatal. Standing at Ogdensburg City Hall, Schumer noted the "Imminent Threat To Public Health" in St. Lawrence County, which has been Upstate NY's epicenter for mosquito-borne illness so far in 2024.

The rise in cases is a threat not only to the quality of life of North Country residents but also to tourism and recreation, Schumer said.

Schumer said while there is no commercially available vaccine for EEEV or WNV, the best protection is to prevent mosquito bites and encourage New Yorkers to stay safe and closely monitor public health warnings.

Schumer said, "Prevention is the best way people can protect themselves from exposure to mosquito-borne illness. When you are outdoors, consider wearing clothes to cover your skin and effective mosquito repellent."

Public Health officials suggested using products with Deet in them, such as off, while also wearing long-sleeved shirts and pants when possible.

Residents are also encouraged to avoid being out during the early evening hours, as mosquitos are most likely to be active during those hours.

MASSENA -- Massena Police have charged a former bookkeeper for Frenchie's Chevrolet with stealing thousands of dollars from the dealership.

Police say Sarahlynn A. Burnett, 39, was charged with Grand Larceny second-degree: value greater than \$50,000 (C Felony).

According to police, the charge stems from Burnett allegedly stealing approximately \$70,000 while working as an employee at Frenchie's Chevrolet.

According to court documents, Burnett overpaid herself more than \$34,000 and charged roughly \$30,000 on company credit cards at Walmart and an additional \$6,500 at Amazon.

She was arraigned in Town of Massena Court and released.



***SIGNIFIES STLC CHAMBER MEMBERS**

Town amends local code to add enforcement mechanisms for some violations

MASSENA -- Town of Massena officials approved town code changes following a public hearing at the Aug. 21 town board meeting.

The move to update the town code comes as town officials seek to rectify a number of known issues around the town that they previously did not

have authority to act on.

Supervisor Sue Bellor said the move to implement the code is also a requirement following the town's hiring of Code Enforcement Officer Pat O'Brien earlier this year.

Both O'Brien and Town Attorney Eric Gustafson said the amendments to the town code will allow O'Brien to enforce aspects of the code that previously "lacked a mechanism to

do so."

One aspect of the amendments is to give the town code enforcement officer the authority to issue appearance tickets for violating town code related to brush and grass dumping in what Gustafson described as "uncontrolled private spots."

Gustafson also commented that the amendments would allow enforcement of code related to

unsafe structures, fire prevention code, debris accumulation in streets that would be flammable and other "fairly routine stuff" that would be appropriate.

O'Brien said that ultimately the code amendments are designed to mirror village code regulations, saying the town "didn't really have mechanisms before this." The changes could also be a cost saver for the

town, O'Brien said.

While the village might have code in place to handle some situations with a fine through enforcement regulations, O'Brien said it could have cost the town thousands of dollars to correct code violations without those "mechanisms" in place.

"Something that in the village could be a \$50 fine, it might cost the town thousands of dollars because we don't have this in the code," he said. O'Brien called the code amendments a "better use of taxpayer funds" than involving Gustafson to litigate issues.

"It's going to involve a hearing with the state. So, it's kind of a better use of taxpayer funds. It makes no sense to spend thousands of dollars in legal fees to recover a \$100 fine because somebody won't open up their yard or mow the lawn or simple stuff like that," he said.

But what O'Brien sees on a day-to-day basis is usually "little stuff" that goes unaddressed, such as lawns that are not mowed in a timely manner or trash and debris being removed from properties.

"Most of these things, we work with people for quite a long period of time before we ever get to that point, and 90% of the people are awesome to deal with. It's that 10%," O'Brien said. O'Brien said the town first seeks to work with individuals to rectify a code violation.

"We're not punitive by nature, that's not what we want to do. We want to work with people to assess and address a code violation, if possible," he said.

Both the town and village have also had significant issues for many months regarding unsafe structures, O'Brien said.

He told board members the town has two structures in particular that need to be dealt with but that they "lacked the mechanism to deal with them."

"The grass, the weeds, things like that. It allows us to kind of go after properties where people aren't taking care of them. We're certainly not nitpicking people over an inch or two of grass," he said.

While some issues are obvious, O'Brien said the department still relies on individuals around the community to inform his office of potential code violations.

Since moving to a new, online reporting system O'Brien said he has been very busy handling complaints but noted that they are making "some progress" and that it was getting better.

One aspect of the new system that has greatly benefited the department is the requirement to leave contact information when filing a complaint.

O'Brien said the policy to not accept complaints sent anonymously has really help with time saving.

He said saving time on complaints has allowed him to search for answers on other calls, such as one house that was abandoned "for years and is in pretty horrible shape."

O'Brien said he has spent many hours on the situation, making phone calls, sending emails and letters in an effort to identify the owner.

"I sent letters to National Federal Mortgage, which is the current lien holder. At least that's what the records show. But, it also takes a while for proper records to update. So, just because that's what it shows right now in the system or with the county, it doesn't necessarily mean that's who currently owns it," he said.

O'Brien said the adjacent property owners were "thrilled" to see code enforcement was looking into the situation and assessing the property.

"We should be able to start making some progress on that. It is getting better," he said.

EPA to fix cap in Grasse River to contain PCBs

MASSENA -- More work needs to be done to fix a cap on the bottom of the Grass River which was damaged by an ice jam in 2022.

The Environmental Protection Agency will be hosting a public information session from 6-7:30 p.m. on Sept. 11 at the Hawkins Point Visitors center to discuss the particulars of a planned project to place more capping material on the damaged areas of the river bed.

Officials say the work is expected to begin this month and will seek to replace the sediment that was moved as a result of the ice jam.

According to reports, the section immediately upstream of the Route 131 bridge in Massena is where the repair work is most needed. EPA officials say they will oversee the work, including monitoring air quality, noise and water quality throughout.

No overnight work is expected, with contractors working from 6 a.m. to 6 p.m., officials said.

The event is expected to include representatives from Arconic, the Department of Environmental Conservation, EPA, the state Department of Health and the St. Regis Mohawk Tribe Environmental Division.

Arconic and EPA officials will also address the expected repairs required and answer questions from the public, officials said.

The initial dredging began prior to the COVID-19 pandemic before being completed in the fall of 2021 after Arconic capped 7.2 miles of the Grass River to remove and cover a portion of the river that was contained with high quantities of polychlorinated biphenyls (PCBs).

Work on the armored cap will carry into spring 2025 due to a need to allow each layer to properly settle before future layers can be brought in, EPA officials said.

CANTON -- Governor Kathy Hochul is seeking a new Major Disaster Declaration to secure federal funding for St. Lawrence County to assist with recovery efforts following extensive flooding from Tropical Storm Debby on Aug. 9.

The news comes just over a week after Hochul announced a Major Disaster Declaration for the North Country following an initial round of flooding July 10 and 11.

Though St. Lawrence County was affected by the July flooding, many state and local lawmakers continued to urge Hochul to seek a MDD for flooding that occurred in August as well.

"We must provide relief to areas impacted by the storm, and my administration will take every measure necessary to ensure their speedy and full recovery," Hochul said at a recent press conference.

A MDD secures federal financial assistance through FEMA's Public Assistance Program, which provides funding to local governments and non-profits for disaster relief efforts.

Funds can be used for debris removal, repairs to buildings and infrastructure, as well as emergency measures, according to FEMA.

County officials have been vocal for weeks following the Aug. 9 flooding that caused millions of dollars in damage to highways and other municipal infrastructure throughout the region.

Legislators passed a resolution during the Aug. 26 Finance Committee meeting, authorizing \$650,000 for emergency road and structure repairs to reopen all affected roads.

County Highway Superintendent Don Chambers said the work to repair many roads and structural

projects like culvert replacement are still underway, with crews having begun the work just hours after the storm subsided Aug. 9.

"It's going to likely be into the several million dollars to complete repairs even though we have, for example, some bridges that have already been replaced or had extensive repairs," he said.

Chambers said the \$650,000 the resolution approved spending is just for emergency repairs to ensure "roads are safe to the traveling public."

He said some structures, like culverts, would require improvements to a standard set by the Department of Environmental Conservation (DEC) following an assessment after the storm.

Chambers said larger culverts and significant road repairs were needed around the county but said it was his hope the state and federal government would help financially.

"Hopefully what we'll see is some help from the state and federal government to address these final needs, but I just wanted to be clear this is for getting theemer-

gency repairs done," he said.

Chambers said the county and other area counties like Lewis County suffered enough damage to meet the threshold for the state to apply for emergency aid through FEMA.

Despite that, Chambers said he was unsure if the county would be made whole for all repairs or just the emergency repairs through FEMA.

Loud exhaust nets drug charges for pair

BRASHER -- Two Winthrop men face multiple drug-related charges following a traffic stop in the Town of Brasher early Monday morning.

Troop B- Violent Gangs and Narcotics Enforcement Team charged Bryan I. Hartson, 53, and Timothy R. Kerrick, 35, with numerous counts related to a traffic stop by New York State Troopers at approximately 1:55 a.m. on State Route 11C for a loud exhaust. During the traffic stop, numerous amounts of narcotic drugs were located in the vehicle, including approximately 1.3 ounces of cocaine, 15 grams of MDMA, and numerous pills of several different types.

Kerrick was charged with 5 counts of Criminal Possession of a Controlled Substance 3rd (B-Felony), 6 counts of Criminal Possession of a Controlled Substance 7th (A-Misdemeanors), Resisting Arrest (A-Misdemeanor), and Obstructing Governmental Administration 2nd (A-Misdemeanor).

Hartson was charged with 4 counts of Criminal Possession of a Controlled Substance 3rd (B-Felony), 6 counts of Criminal Possession of a Controlled Substance 7th (A-Misdemeanors), and a traffic ticket for loud exhaust.

Kerrick and Hartson were both arraigned in the Town of Stockholm Court. Hartson was released on his own recognizance, while Kerrick was remanded to St. Lawrence County Jail in lieu of \$25,000 cash.

part to rundown and dilapidated properties that take up significant amounts of time for the department.

Trustee Ken McGowan commented that the severity of issues has also increased in recent years, with many code violations revolving around "simple matters" like lawns. Now, the Code Enforcement Department is stepping in to tackle much larger, more complex issues, he said.

One such issue is finding current property owners' contact information, Hardy said.

Earlier this year, village officials implemented a landlord registry in an effort to gather contact information from rental property owners and managers to ensure code enforcement will be able to conduct fire inspections or rectify code violations.

That move was met with support from many local landlords and residents who said they wanted the village to crack down on "absentee landlords" who did not live in the North Country.

In some cases, Hardy said it has been difficult to track down the owner of some properties that are in violation of village code.

It is much the same for the town of Massena and its Code Enforcement Officer Pat O'Brien who recently said he was also attempting to track down owners on a handful of abandoned properties.

According to Hardy, the village landlord registry currently has 255 rental units registered, 56% of which are owned by out-of-town landlords.

McGowan suggested that the reason so many properties are owned by out-of-town landlords is due to the cheap real estate when compared to other areas of the country.

"The property's cheap here. 'Oh, I live in California. I'm going to buy this property and I'll never come here. But, I'm going to make some

money and if I don't, whatever, I'm going to sell it," McGowan said.

McGowan went on further, saying it may be time to look into empowering police officers with code enforcement rights to address some of the issues in the village.

He said similar powers have been bestowed on officers like his brother-in-law in California.

"He's a police officer in California and he's a lieutenant. For him to be a lieutenant, he had to become a code enforcement officer. I don't know if that's where we have to go with this. But, he goes, 'We're out and we're doing it all,'" he said.

While it is not the first option village officials are exploring, Chief of Police Jason Olson said the department could possibly take on the task if village officials want to go that route.

He commented that west coast police departments many times have a code division to handle such matters.

Olson said the department could do it if the officers were to go through the civil service exam but clarified that the exam would have to be titled properly in order to work.

The idea of expanding the Code Enforcement Department is one that comes as the village took action on multiple properties recently, including 18 Park Ave., 31, 33 Pine St. and 21 Tamarack St.

Village of Massena Code Enforcement officials have shut down the property located at 18 Park Avenue after deeming it unfit for human

structural integrity. Bean said the property owners have failed to do so, leading to the porch and front roof assembly beginning to collapse right near the sidewalk and street.

He said for that reason the village must take action on the property to ensure public safety.

Mayor Greg Paquin has signaled in recent meetings that the village is going to start playing hardball with rental property owners in violation of village code, a sentiment echoed by McGowan Aug. 20.

"This is what we're going to do. We're not going to play games anymore. The police department doesn't have time. The fire department doesn't have time. If you're going to be a good neighbor, be a good neighbor. If not, oh well, get your checkbook out," McGowan said.

officers.
He said the city has just one detective at this time. Last year he handled 33 violent crimes including one murder, seven rapes 21 aggravated assaults and four robberies.

Kearns said that's nearly double the amount of violent crimes handled by Massena police, which has a staff of 23 working officers and multiple detectives.

Kearns said the lack of staff has made Ogdensburg a reactive department, rather than a proactive department and the criminals are aware. "Our informants tell us that the drug dealers are laughing at us," he said.

Kearns said the bulk of serious crimes in the county occur with-

in the city limits, which means Ogdensburg faces the most amount of crime with the fewest number of officers.

He pointed out that Ogdensburg police contend with arrests made at the border crossing and situations at Claxton-Hepburn, which is the county's only hospital with a mental health unit.

"We are a very unique city and a very unique agency," he said.

Kearns said a \$15,000 incentive for new hires could encourage lateral transfers, that is, it could bring experienced officers to the department, which could save the city substantially in training and overtime costs.

"The simple fix would be, let's hire experienced officers now," he said.

Kearns noted that while the city is facing a very difficult time, the

police shortage is a national problem.

"We are desperately short in this city. We need the help now. The citizens need the help now. Our officers need the help now," he said.

Kearns said bringing the department to 23 officers could help fight fatigue and burnout and make the department more stable.

He said retention has been a problem at the department for recent years and he and the current Lieutenant will be eligible for retirement in 2026. Kearns said the city needs to be thinking about the future, because the decisions made today could take two-years to before they have an impact on the ground. That's due to the academy and training for officers.

Kearns' presentation and request was met with support from the council.

Why Autumn pruning is bad

When I was younger, an old-time arborist I knew used to say "The best time to prune trees is when the tools are sharp." This guy was beset with shoulder injuries and knee problems because he also believed "What doesn't kill you makes you stronger. Sadly, both of these old saws are dangerous lies.

Although tree-care companies have year-round expenses and need income in all seasons, a truly professional arborist knows there are two times of the year when pruning should be avoided. Late spring between bud-break and full leaf-out is one period of pruning abstinence, and the other is in the fall from the time leaves start to change colour until trees are entirely bare. There are a number of reasons to put away pruning tools at this time of year.

The Claw-Back Clause: As days get shorter, deciduous trees and shrubs start to make a waxy layer between each leaf base and the twig to which they're attached. The wax will eventually seal the vessels that moved water and nutrients into, and sugars out of, leaves all summer. This blockage is what breaks down green chlorophyll and unmasks the yellow and orange pigments. Before the tubes are entirely blocked, though, trees "claw back" about half the nutrients from each leaf: nitrogen, iron, magnesium, manganese, and other essential elements. This is very important to the nutrient budget of woody plants.

Trees also move sugars, the product of a season's worth of photosynthesis, from twigs and branches down to the root system for storage and later distribution. Pruning branches now will deprive trees of both nutrients and energy needed for the following year.

The Illness-Infestation Angle: All woody plants have internal defense systems that make special antifungal and antimicrobial compounds to fight infections at the site of injuries like pruning cuts. This "tree-mune response" becomes active in the early spring and is on high alert through the summer, after which it starts to shut down. Wounds made in the fall are more likely to be infected by what are called perennial cankers. Nectria and Eutypella are the two primary genera of pathogens, but there are others. In addition, the level of disease spores in the air is highest in the fall.

Even though pines and spruces only lose a small portion of their needles, the same principles hold true. Cutting evergreen branches in the summer will rob trees of a share of the nutrients and sugars they need, but it also attracts a type of moth called a pitch-mass borer to lay her eggs on fresh pruning cuts. When the eggs hatch, the grubs feed on the sap as they enlarge the wound. In the process, they trigger excess pitch production. If you've ever noticed unsightly, oozing pitch on the trunks of pines and spruces, that's

a result of summer pruning that invited pitch-mass borers to set up housekeeping.

The Moral Imperative: The last reason to stash the saw until trees are fully dormant is the danger of running into a self-righteous arborist who views fall pruning as a moral failure. They may give you the hairy eyeball, or worse yet, might try to make you feel guilty through "pruning shaming." I'm not saying that I've ever engaged in this kind of behaviour...


Camp Serenity is the result of that goal and all the hard work over the years. Started in 2019, the camp ground is now available as a seasonal camp.

The program then leapfrogs into the 20th Century with Michael Abels "Delights and Dances," a work that abounds with references to a variety of popular music styles, including Blues, Gospel, and Bluegrass.

This selection is scored for a string quartet of soloists accompanied by string orchestra, and our performance will feature the virtuoso talents of the Julia Trio.

Based in Potsdam, the Julia Trio includes Liesl Doty, Shelly Tramposh, and Marie-Elaine Gagnon, and they will be joined by frequent collaborator and ONNY member Tim Yip to round out our quartet of soloists.

The second half of the concert will feature Beethoven's Seventh Symphony, perhaps the epitome of a classical work inspired by dance.

As with our October concert, this program promises to appeal to a wide range of tastes and expectations and would be an excellent introduction for anyone curious about attending an orchestra concert!

I hope you are as excited as I am about the upcoming ONNY season, and I look forward to seeing old friends and making new ones at our concerts in Potsdam, Watertown, and throughout the North Country!

We are the only year-round professional symphony orchestra from Rochester to Burlington and Ottawa to Syracuse.

The Orchestra's vision is to have people of the North Country embrace ONNY as the leading producer of orchestral music of all genres. Our values are excellence, community, respect, and sustainability.

This past July, I assumed the role of Board President after the completion of Kimberly Busch's (Hannawa Falls) second term as president. I am grateful to Kimberly for her steadfast leadership through the COVID lockdown and ONNY's subsequent return to the stage.

Outreach in the Adirondacks

For the last few summers, 671 people enjoyed concerts of "Music Amid the Pines." Concerts were held in Childwold, Wanakena, and Lake Clear, and in Potsdam.

These programs were made possible by support from the Secret Sits Pro Musica Ensembles, Inc., a charitable organization dedicated to "Better Music, Better World."

TSS, Inc. was created in memory of Marie

S. Patten of Athens, GA and Gull Pond, NY.

In 2021, TSS donated \$125,000 to ONNY for these outreach activities and other initiatives, including in-school performances, throughout the Adirondacks.

School programs began last year when more than 746 students at 11 schools, including 200 at St. Regis Falls Central School, delighted in performances by the Potsdam

Brass Quintet and the Aria Reed Trio. More concerts will take place in 2024-2025.

The "Music Amid the Pines" concerts and in-school performances were also supported by a generous donation from James and Diane Woods, Armonk and Gull Pond, NY.

ONNY thanks the Presbytery of Northern New York for graciously hosting these concerts.

Programs for Young People

Exceptional students attending the Crane School of Music are invited to perform with the seasoned professional musicians that comprise the Orchestra of Northern New York.

High expectations are set for these apprentices and they enjoy an extraordinary opportunity to play with a symphony orchestra.

Since 2019, The Secret Sits Pro Musica Ensembles, Inc., of Athens, GA and Gull Pond, NY, has underwritten the apprentices' fees.

As a result, more than 80 students have received an unparalleled experience and compensation as young professional musicians. ONNY is grateful to TSS, Inc., for its support of this apprenticeship program.

Young Artist Competition

New ONNY Music Director Has Extensive Experience, Committed to New Music

Michael J. Colburn is a freelance guest conductor and clinician who regularly leads professional and student ensembles in festivals, residencies, and a variety of other settings throughout the country.

In June 2024, he was appointed Music Director and Conductor of the Orchestra of Northern New York, a professional orchestra based in Potsdam, NY.

He is also the Music Director and Conductor of the Me2 Orchestra in Burlington, VT, a classical music organization devoted to erasing the stigma of mental illness through supportive rehearsals and inspiring performances.

He also serves as an Affiliate Artist at the University of Vermont.

In 2024, he became a member of the Educational Consultant team at the Conn Selmer Division of Education.

From 2014 until 2022, Colburn served as the Director of Bands at Butler University in Indianapolis, where he conducted the Butler University Wind Ensemble and offered instruction in conducting, euphonium, and the history and literature of the wind band.

Before his tenure at Butler, Colburn served for 27 years in "The President's Own" United States Marine Band, where he held a variety of positions including Principal Euphonium (1991-1996), Assistant Director (1996-2004), and Director (2004-2014).

As Director, Colburn was music advisor to the White House and regularly conducted the Marine Band and Chamber Orchestra at the Executive Mansion and at the Presidential Inaugurations of George W. Bush and Barack Obama.

He was promoted to Colonel by President Bush in a private Oval Office ceremony in 2007, and in 2014 he was awarded the Distinguished Service Medal by Gen. James Amos, Commandant of the Marine Corps, and the Medal of Honor by the Midwest Band and Orchestra Clinic Board of Directors.

Committed to the promotion of new music, Colburn has commissioned band works from several highly accomplished composers including John Williams, Michael Abels, Stacy Garrop, Michael Gandolfi, David Rakowski, Melinda Wagner, Michael Schelle, and Frank Felice.

He has served as the chair of the Sousa-ABA-Ostwald Award, and as an adjudicator for the Sudler Award, the Barlow Endowment, Music for All, and the Col. George S. Howard Award for Excellence in Military Bands.

Colburn is a Past President of the American Bandmasters Association, has been a board member of the National Band Association, and currently serves as Vice President for Project Enhancement for the John Philip Sousa Foundation.

NYS Council on the Arts Awards \$40,000 to ONNY in 2023 and 2024





Only three people from St. Lawrence County were among the twenty individuals receiving the honor.

Dr. Angstadt has been the Orchestra's volunteer Webmaster for eleven years and its volunteer Technology Director for the last four years.

Prior to his presidency, he served as Vice President of the Board, Chair of the Board Development Committee, and Co-chair of the Personnel Committee. He also worked on the Marketing and Finance Committees.

Kevin is an Assistant Professor of Computer Science at his alma mater, St. Lawrence University, where he has begun his fifth year as a member of the Math, Computer Science, and Statistics Department.




