Potsdam sets sights on future

Community members brainstorm plans for development

POTSDAM — Do you have ideas for future development in Potsdam?

Is the village headed in the right direction?

What changes would you like to see downtown?

Residents, business owners and those who work in Potsdam now have an opportunity to chime in and contribute to an ongoing online brainstorming session in the form of a survey online.

The village's Office of Planning and Development recently held a workshop to brainstorm ideas about the future of the village, and an online survey has been launched to gather even more input and ideas from residents and those who work or own businesses here.

Village officials, and committee members gathered for the Village of Potsdam Vision Exercise, led by Economic Developer David Thurlow, after the Oct. 21 village board meeting to hash out ideas for the future of Potsdam.

About 25 village officials gathered for the workshop event where they broke into small groups and filled out worksheets with ideas for economic and cultural development in the village. The groups then shared their ideas with the rest of the group and discussed their favorites.

The survey, posted on the village website after the workshop for members of the public, follows along the same path.

Call for mistrial fails in double-homicide case

CANTON — Accused murderer Adam Smith is currently on trial in St. Lawrence County Court, roughly a year-and-a-half after the murders of Ronald "Huck" Durham and William Freeman.

Smith stands accused of both men's murders after a lengthy police investigation that the prosecution says "points directly to Smith."

Contentious start

An opening statement from defense attorney Brian Barrett was called into question multiple times by District Attorney Gary Pasqua.

As he sought to address the 12 jurors and four alternates, Barrett said Pasqua and his associates were going to "piece together this puzzle of a million pieces by presenting grisly evidence of two horrific crimes.

"He is innocent and presumed innocent by law. Since March 2, 2023, Adam has been living a nightmare, falsely accused of two murders and other associated offenses that he did not commit," Barrett said.

"The police didn't pay any attention to a word Adam said, but they should have because in this very complex case, the facts don't add up to Adam committing any crimes that he is accused of," Bar-

rett said.

But District Attorney Gary Pasqua said the case is cut and dry. "Ladies and gentlemen, this

really isn't a complicated case. Yes, there are going to be hundreds of exhibits, there is going to be scientific evidence, there is going to be some very technical evidence. But the nature of it does not make this complex because if you follow the evidence, it all aligns and leads to only one conclusion. If you pay attention to the evidence, it all aligns that this defendant is guilty beyond any reasonable doubt in the murders of both Ronald Durham and William Freeman," Pasqua said.

Pathologists testify

Prosecutors in the Adam Smith murder trial called their first witness on the opening day of the

trial, bringing Dr. Scott LaPoint to the stand.

A pathologist, Dr. LaPoint conducted the autopsy on Robert Durham shortly after his death on February 11.

Upon initial examination, Dr. LaPoint commented it was "very apparent very quickly that there was a large cut type wound across his neck" when referring to Durham.

Photos presented by Pasqua and entered into evidence showed Durham's body still fully clothed, covered in blood. In one photo, the front of Durham's shirt was almost entirely stained with blood.

Group forms to address flooding events

POTSDAM — About 30 people attended a meeting and presentation of the Potsdam Flood Free Coalition Monday, Oct. 28, including representatives from the village, town, school and hospital.

Organizers Heather Wheeler and Ryan Deuel told North Country This Week, that the coalition held the meeting as a way to foster a working relationship between the municipalities, school, hospital and community on flooding issues which have been an issue in the village for years, but were most recently brought to a more serious depth during the August 9 weather event.

"We are hoping to foster a partnership and cooperation," Wheeler said.

"The goal of the coalition is to bring the village, town, the school and other stakeholders together for the common problem of flooding in the village of Potsdam," Deuel said. "That was really our goal."

The Coalition, a group of resi-

dents and business owners from Pleasant, Waverly, and Elderkin streets, aims "to bring together community members and government officials to work toward climate-smart solutions that will help mitigate future flooding in the Village of Potsdam," a recent press release from the organization said.

The August flooding event, powered by a hurricane, closed many roads, flooded basements and caused thousands of dollars in damages across Potsdam and the North Country.

The village alone incurred more than \$17,000 in damages and expenses dealing with the flooding.

The town highway department, village Department of Public Works and the Potsdam Fire Department dealt with hundreds of calls ranging from flooded basements and disabled vehicles to road washouts.

Meanwhile residents and business owners have high repair costs of replacing furnaces, plumbing fixes and electrical repairs resulting from the flooding, as well as proba-

ble foundation and structural damages to their buildings.

In many cases, flooding disaster aid is not going to be available for some homeowners who don't meet qualifications, and many residents have reported that insurance payouts are not going to be forthcoming either.

For the Coalition however, the focus is on infrastructure improvements that the municipalities and the school can make to mitigate the flooding issue, which is not just limited to the major events that get the headlines, but includes chronic standing water in the neighborhoods in the center of the village near Pleasant, Waverly, and Elderkin streets and in some areas along Pine Street among others.

"The affected area has widened," Wheeler told North Country This Week. "And we struggle with an aging canal system that can't handle the type of storms we are getting."

The Crosstown Canal stormwater sewer system, decades old, has been prone to flood issues and an ongoing maintenance issue for village officials over the last few years.

The coalition meeting featured a presentation by Clarkson University civil engineering professor Erik Backus focusing on previous engineering studies and ongoing environmental impacts on the local system.

"I don't think we got complete answers, but that was expected. What we did get is commitments from the town to work with the village on an engineering study," Deuel said.

There have been various efforts by the various governments, the hospital and school to mitigate the water issue, but both Wheeler and Deuel said the coalition's interest is to urge the various parties to work in concert on the issue.



Frustration grows over Canton clogged drain issues

CANTON — The village is in a bit of a quandary in regards to dealing with sewer issues along Judson and Court Streets, reported Deputy Mayor Anna Sorensen at the monthly meeting of the Canton Village Board on Thursday night.

"Ultimately we need to upsize our pipes and ideally get grant money. There is no real grant money out there," said Sorensen. "What do we do in the meantime? We're a bit stymied."

The initial sewer project study conducted by the consulting firm Barton & Loguidice, Watertown, focused on Judson Street with a price tag of approximately \$2.7 million. The study has now included Court Street at an additional cost of \$800,000. A separate Cleaveland Avenue project totals \$1.2 million.

Sorensen said the village is hesitant to spend money that will really not solve the problem, for example spending money on a camera to scope the village sewer lines. She said Barton & Loguidice recommends the village does not start from the bottom and work their way up. To properly correct the problem, work needs to be done from the Grasse River up.

"It's a poor choice," Sorensen remarked. "We have asked Barton & Loguidice to think out of the box with us for the short term without placing the entire burden on taxpayers."

It was also noted that St. Lawrence County officials are working on solving flooding issues stemming from the county's Judson Street parking lot.

The flooding situation came to the forefront in July and August when two massive rain storms saturated the village's storm drains and flooded basements and streets in

the Judson, Farmer and Cleaveland areas. Flooding, not as intense, was reported throughout the village, including major flooding at Taylor Park and Canton Island Park.

The lone two speakers during public comment were Jon Rosales and his wife Matilda Larson, who reside at 25 Judson Street. The couple have experienced significant damage from flooding at their residence.

Rosales told village leaders that St. Lawrence University and Clarkson University will be hosting an event in storm resiliency; the Clarkson event focusing on watersheds. He added that taking a watershed approach may lead to ideas on how to control water flows in the near term.

A report from Barton & Loguidice noted the village has commissioned this study to analyze the existing network in order to quantify capacity issues and develop preliminary drainage improvements.

The study area for this analysis consists of Judson Street between Court Street and Pleasant Street, including the Grasse River outlet. The closed drainage network on Judson Street and those of adjacent streets that link to the network on Judson Street along with the network extending to the Grasse River outlet from Court Street and Chapel Street were studied as part of this analysis.

Existing conditions and field observations were reported that Judson Street features aged drainage infrastructure and the existing network has proven to be undersized for recent storm events, which has caused localized flooding in various locations along the corridor. Tributary stormwater flows enter the Judson Street closed drainage network from the north from overland flows and the closed drainage networks on Goodrich Street, Cleveland Avenue, and Farmer Street. Stormwater discharges from the Judson Street network via pipes out-letting to the south at Court Street, Fisher Street, and Cleveland [Ave.] Street. All of the stormwater that exits the network at the above locations converges at a structure at the intersection of Court Street and Chapel Street. These flows are then conveyed within the existing closed drainage system on Chapel Street and ultimately outlet through a 30" reinforced concrete pipe into the Grasse River just south of an apartment complex at 35 Riverside Dr.

Canton Fire Department, with assistance from several area departments, battled a fire early Thursday morning at the Maple Ridge Kennel, No Dogs Left Behind sanctuary. Forty-four dogs died in the blaze.

44 dogs die in fire at No Dogs Left Behind kennels

CANTON – Forty-four animals at the Maple Ridge Kennels, No Dogs Left Behind, perished in an early morning (Oct. 24) fire at the kennel, 1743 State Highway 68, Canton.

A passerby spotted the flames around 1 a.m. Oct. 24 and called 911. Canton Fire, Canton Rescue, and County Car 4 were dispatched to the structure fire, according to First Assistant Chief Robert Crowe.

At 1:03 a.m. firefighter Wayne Stripp, who lives less than a mile away from the fire location, advised it was a confirmed working fire. Shawn Chief McGregor then activated the taker task force for that zone along with manpower from the Pierrepont Fire Department. The

tanker task force would bring tankers from Pierrepont Fire, West Potsdam Fire, Potsdam Fire, Pyrites Fire, and Russell Fire to the scene.

Engine 7 was enroute at 1:05 a.m., arriving at the scene at 1:12 a.m.

Firefighters were met with heavy fire in the kennel building and unfortunately, due to the volume of fire, all the animals housed in the building perished, Crowe reported.

The cause of the fire remains under investigation by the St. Lawrence County Fire Investigation Team. There were no firefighter or civilian injuries. Thirteen Canton Fire members responded and all units were back in service at 6:11 a.m.

Two SLC brothers face Jan. 6 charges

Two St. Lawrence County brothers were arrested Thursday for allegedly assaulting law enforcement with a weapon and other charges related to their alleged conduct during the Jan. 6, 2021, breach of the U.S. Capitol.

Their alleged actions and the actions of others disrupted a joint session of the U.S. Congress convened to ascertain and count the electoral votes related to the 2020 presidential election, according to a press release from U.S. Attorney's Office.

Reynold Robert Voisine, 47, Nicholville, and Roger Alyre Voisine, Jr., 48, Canton, are each charged in a criminal complaint filed in the District of Columbia with felony offenses of civil disorder; assaulting, resisting, or impeding certain officers with a deadly or dangerous weapon; entering and remaining in a restricted building or grounds with a deadly or dangerous weapon; disorderly and disruptive conduct in a restricted building or grounds with a deadly or dangerous weapon; and engaging in physical violence in a restricted building or grounds with a deadly or dangerous weapon, the release said.

In addition to the felonies, the two brothers are also charged with misdemeanor offenses of disorderly conduct in a Capitol building, impeding passage through the Capitol grounds or buildings, and act of physical violence in the Capitol grounds or buildings.

The FBI arrested the two men Thursday in Plattsburgh and they will make their initial appearance in the Northern District of New York.

According to court documents, on Jan. 6, 2021, the Voisine brothers, attended former President Trump's rally in Washington, D.C., before marching toward the Capitol building and eventually arriving on the West Front of the Capitol grounds. Roger Voisine, distinguishable by a GoPro mounted on a stick, a tripod tucked in his jacket,

and a camouflage-patterned backpack, donned a paintball mask as he approached the Lower West Plaza. Reynold Voisine, also present in the area, was seen wearing a paintball mask on his head during the riot.

By the afternoon, the situation on Capitol grounds had escalated, and it is alleged that both brothers played active roles in the day's violence. At approximately 3:20 p.m., Reynold Voisine was seen among the crowd as rioters viciously assaulted an officer, dragging the officer from the Lower West Terrace Tunnel and into a mob of rioters. As the attacks continued throughout the day, Reynold remained in the vicinity, using a handheld radio to communicate while the mob assaulted officers inside the Tunnel. The Tunnel was the site of some of the most violent attacks against law enforcement that day.

By 4:25 p.m., Reynold Voisine made his way to the mouth of the Tunnel, where rioters were launching a variety of weapons at the police, including a crutch, a hockey stick, a baton, and multiple poles. It is alleged that Reynold participated in these attacks against officers, first by throwing a crutch at the officers and then by hurling a blue pole that struck police officers. After throwing the pole, he threw

the crutch again, which ricocheted off another rioter and hit the officers. Later, Reynold used a stolen riot shield to ram into the police line.

Around the same time, it is alleged that Roger Voisine was also engaged in direct assaults on police. Court documents say that Roger threw a length of pipe at the officers, pushed into their shields alongside other rioters, and attempted to drag one officer into the crowd. It is further alleged that Roger continued his violent actions by throwing a black rod at the police, hitting one officer's shield, and later throwing three shoes at various officers. At one point, Roger picked up a wooden table leg with protruding nails, swung it twice at officers, and then aggressively threw it at another officer.

In addition to these physical assaults, Roger allegedly used a spotlight to shine directly into the eyes of police officers, further hindering their ability to defend themselves against the mob. Throughout the chaos, Roger remained at the front lines of the mob, holding his GoPro in a manner that suggested he was documenting the event.

This case is being prosecuted by the U.S. Attorney's Office for the District of Columbia and the Department of Justice National Security Division's Counterterrorism Section.

Massena Bitcoin mining plant to invest in expansion at former Alcoa East plant

MASSENA — Coinmint, the parent company of North Country Colocation Services (NCCS) has entered into a strategic partnership with NYDIG for NCCS' bitcoin mining operation at the former Alcoa East plant.

Officials with both companies say they plan to significantly increase the number of employees in the North Country over the next several years as part of the agreement.

The expansion project has been under discussion for years, and the strategic capital from NYDIG reflects their commitment to both NCCS and Northern New York for investment and job growth, officials said.

The local bitcoin mining operation currently employs about 85 full-time workers, split between the former Alcoa East facility and a smaller operation in Plattsburgh, NY.

Officers of NYDIG and NCCS announced the transaction during a special employee recognition and town hall event at the Massena facility on October 16th.

NYDIG is a New York based, ver-

tically integrated financial services and infrastructure firm dedicated solely to Bitcoin, officials said.

"This is a very exciting and transformative day for this company. For the past three years we've been working tirelessly towards a goal of ensuring the security of everyone's job here. This transaction, and resulting expansion project gives us the necessary, long-term stability and security of this company," NCCS CEO David Fogel said.

"We have been looking for an outside company, a capital partner, strategic partner, in order to execute on our expansion project. I'm thrilled to announce that we have found such a partner, and we just recently closed on a transaction with a company that many of you know well. They're one of our biggest customers. They're our best customer in terms of industry knowledge and intelligence, hard work. We're thrilled to announce today that we're partnering for our future with NYDIG," Fogel told employees.

Operations at NCCS will continue as-is after the strategic investment into Coinmint, with the focus on growth and expansion over the coming years.

According to Fogel, the partnership with NYDIG will strengthen Coinmint's financial and competitive positioning, while also protecting workers in Massena and the North Country.

The investment from NYDIG will allow NCCS to further its expansion project, which NCCS has been investing material capital in for over three years, Fogel said.

The partnership on the project has been on hold as Massena Town Board members weighed final regulations for data mining and crypto operations in the town for the last several months. Town officials adopted the final regulations during their board meeting last month.

"This investment reinforces our commitment to the Northern

NY community. By expanding the NCCS operation, we aim to create more jobs and focus on long-term stability and growth for employees and their families," Fogel told North Country This Week.

Fogel commented that NCCS, one of St. Lawrence County's largest taxpayers, will continue to invest and act as an active benefactor of Massena and the North Country community institutions and events. To date, NCCS has assisted the Massena Fire Department, Massena First Responders, Massena Central School District, Rockin' The River festivals and numerous other charitable events and organizations.

NCCS currently hosts 54,000 miners, essentially computer servers that continually mine for Bitcoin, over four former smelting lines.

Fogel said the plan is to continue to expand operations to possibly utilize all six of the site's former smelting lines, each roughly the length of five football fields.

He said the facility is currently using 166 megawatts of its 435-megawatt approved amount, leaving significant room for the expansion project. NCCS draws electricity from the nearby Moses-Saunders dam.

One of the keys to the project would be utilizing more efficient machines, along with a rack system that would allow for more miners to be stored in the facility, as opposed to the shipping containers that are currently used in some cases.

Company officers say the rack systems are much easier to work with, allowing technicians to more easily install and maintain the miners.

The facility would also see a number of other upgrades, including to the electrical system, cranes and three unused lines. For these upgrades and the overall expansion project, NCCS intends to use as many local and regional suppliers as possible.

Potsdam village board deals with unpaid tax bills, surplus vehicles, retirement

POTSDAM — The village board of trustees recently passed resolutions to forward unpaid tax bills to the county, moved several village vehicles to the surplus list and approved a retirement.

The board met Oct. 21 and approved the measures at their regular meeting.

Trustees and the mayor passed a resolution authorizing the Village Tax Collector to sign the Village of Potsdam Tax Roll of Unpaid Taxed for the 2024-2025 period, in the amount of \$258,869.77, plus interest and penalties in the amount of \$18,120.92, for a total

of \$276,990.69. The unpaid taxes will then be turned over to the St. Lawrence County Treasurer, who in turn will make the village whole on its levy demands, and then pursue the unpaid village taxes from the county level.

In another resolution, the board approved the sale of surplus vehicles. On the list were a 1999 Ford Ranger, 1996 Ford F-350, 2005 Dodge Dakota, 2006 International Dump Truck and a 1996 Ford F-350 with dual rear tires. The vehicles will presumably be sold at a municipal auction or for scrap.

Finally, the village accepted "with regret" the resignation of DPW Motor Equipment Operator Jacob Stone, effective Oct. 15.

POTSDAM — A three-year-old company expected to soon be shredding five tons of paper a day was named "Business of the Year" Oct. 23 by the St. Lawrence County Chamber of Commerce.

Ivan and Marie Klobucar, owners of Summit Shred Lab, received the award during the chamber's annual dinner at the Stables at Windy Point. In addition to secure shredding of sensitive documents, the firm provides self-storage facilities as well as fingerprinting and ID services.

Curran Renewable Energy of Massena was presented the "Producer of the Year Award" and Hosmer's Marina of Ogdensburg received the "Customer Service Excellence Award."

"The Klobucars' approach to doing business is top-notch," said chamber Secretary Amanda Hitterman, in presenting the award. She noted "their professionalism, perseverance, hard work, extensive knowledge, clear and timely communications, attention to detail and commitment to the community."

The Klobucars first fell in love with the North Country about a dozen years ago while motorcycling through the area from Canada. They bought a small cabin in the area, visited intermittently, then bought commercial property at 6950 NYS Hwy. 56 near Unionville during the pandemic.

They first offered self-storage units. Then, the company began shredding documents following state and federal document destruction regulations, serving health care organizations, municipalities, lawyers, hotels, residents cleaning out their homes and small businesses.

"This award reaffirms our belief that dedication and hard work in pursuing a dream leads to success and recognition such as this prestigious award," said Ivan Klobucar.

He noted a sign in his office says, "Together We Can Do Great Things," and thanked those who helped get the business off the ground. from shredding one ton of paper a day to five tons a day, he said.

Curran Renewable Energy began operations in 1976 with a used logging truck and a few chainsaws, and today employs 85 people, noted chamber Treasurer Craig Chevalier. He presented the "Producer of the Year Award," which recognizes companies that create and sell locally sourced or value-added products.

Today, the family-owned and operated group of companies is involved in the forest harvesting industry, producing premium wood products like wood fuel pellets, BBQ pellets, and cedar mulch.

Curran Pres. Kelli Curran Ramsey credited the firm's loggers, truckers, mechanics and manufacturers. They help Curran "make a meaningful impact in our community," she said.

Benny Fairchild, second vice-president of the chamber, presented the "Customer Service Excellence Award" to Hosmer's Marina for extraordinary service to their customers.

The business, which recently expanded with the addition of Sweet Emilie's coffee shop, treats each customer "in a way that will want them to come back" and is a "shining example" for residents, newcomers and visitors alike, he said.

Owner Bill Homer said he and his wife, Maureen, love the North Country. "We try very hard to make it an enjoyable place to live and visit

and that mantra rubs off on our 40 employees."

He continued, "We know it takes a whole team to win a customer service award and we have the best team out there, all of our employees are celebrating this honor."

Earlier, chamber Executive Director Ben Dixon noted the "tremendous organizational change" that has been underway since the Jan. 1 merger of the Massena, Ogdensburg and Canton chambers of commerce with the county chamber.

The chamber staff is laying the foundation for a sustainable and impactful chamber but still has a long way to go, he said.

Accomplishments this year have included distributing 10,000 visitor guides, promotion of county fishing and tourism, higher occupancy rates at lodging establishments, high levels of social media viewership, and promotion of the county at trade shows in Canada and New York.

POTSDAM — The Village of Potsdam has officially been certified as a Pro-Housing Community by the New York State Division of Housing and Community Renewal. As a certified Pro-Housing Community, the Village is now eligible to apply for various discretionary funding programs with up to \$650 million in funding available.

"The Village of Potsdam is committed to a ground-up approach to increase the availability of housing in our community and across the state. It's going to take collective effort, hard work and ingenuity—but I believe we have what it takes to spark incremental small-scale development on a local level and bring together major projects at the same time, with the promise to

revitalize our community through smart growth," said Mayor Alexandra Jacobs Wilke.

The Village passed a resolution adopting the Pro-Housing Communities pledge on April 1, 2024, and has since gathered data on the municipality's existing zoning map and regulations, as well as its residential housing renovation and construction permit requests for recent years, in order to qualify for the program.

The Mayor and village staff will meet with the Planning Board and Zoning Board of Appeals to discuss next steps that the municipality can take to reduce red tape and encourage community renewal. The Village received its letter of certification on Sept. 26.

- Dr. Lawreen M. (Heller) Connors passed away on October 20th at Brigham and Women's Hospital in Boston after a courageous battle with cancer.

Lawreen began what would be a lengthy career in higher education at Boston College, where she earned her BS in Math and Chemistry.

From there she went on to Tufts University to attain an MS in Chemistry, and continued her career at Boston University. While working at BU, she met and married her husband, Michael Connors, to whom she was devoted for the next forty-three years.

She was able to deftly balance her love of family with her dedication to science, completing her Doctorate Degree in Biochemistry concurrently with the birth of their first child.

To her, family was always most important; she spent nine years as a stay-at-home mom, dedicating herself to the development of her three children.

A woman of strong lifelong Catholic faith, she found joy in volunteering at several parishes around Woburn – and additional joy in the discovery of her Jewish roots later in life.

She loved to explore and travel,

and would often build summer work conferences into entire two week road trips with her family.

On weekends you could find her walking around Horn Pond, visiting with her grandchildren, going on long bike rides with her husband, or watching sports – but only after starting her morning with a cappuccino and a few hours of classical music.

Lawreen was a professor of Pathology and Biochemistry in the Chobanian and Avedesian School of Medicine at Boston University.

She was a valued member of the Amyloidosis Center. Over a career of more than 40 years of research on amyloid proteins and amyloidosis diseases, she made countless discoveries on amyloid protein structure along with related molecular and cell biology basic science.

In addition, she developed clinical assays for amyloid proteins that supported care of patients with amyloidosis and became worldwide standards.

Her scientific publications on the many types of amyloid proteins and amyloidosis diseases number in the hundreds.

Lawreen directed the Gerry Amyloidosis Laboratory in the Amyloidosis Center overseeing the research of students, fellows, and technicians.

She was internationally recognized for her work and served sev-

eral officer positions in the International Society of Amyloidosis.

In addition, she was a capable peer reviewer for academic journals, and served on the Editorial Board of the journal "Amyloid".

Countless numbers of Masters and Doctoral students of Medicine, Biochemistry, and Pathology will remember her fondly for her superb training and mentorship.

Her greatest passion was teaching students, and she always supported them with encouragement and generous opportunities for advancement. She was known to have "an open-door policy" and students regularly stopped in for Lawreen to look over their research.

Her love of teaching was not limited to her time at the Amyloidosis Center, either; she also carved out time to teach pre-calculus to students at Bunker Hill Community College. Lawreen retired from BU in 2022 as Emeritus Professor, Pathology & Laboratory Medicine.

Dr. Lawreen Connors will be greatly missed by family, friends, colleagues, collaborators, former students, and the amyloidosis research world.

SUNY Potsdam raises \$5.2 million from dedicated donors

POTSDAM -- SUNY Potsdam raised more than \$5.2 million in new gifts and pledges in the 2023-24 fiscal year, the college reports.

Alumni giving increased by 82 percent from July 1, 2023 to June 30, 2024, showing SUNY Potsdam graduates' strong commitment to their alma mater, the college said in a press release.

"It's amazing to see our alumni and friends show their support for a place that we hold so dear. Our donors know the transformational impact that SUNY Potsdam is able to provide for our students and how that support ripples out into their futures, into our community, and into the world beyond. Every gift, no matter the size, has a transformation impact for Potsdam and for our students," said Potsdam College Foundation President Amy Kellogg '99.

Overall, among the outright gifts received in 2023-24, donors provided more than \$1.27 million in support of academic programs, to support learning experiences which ensure academic success and innovation, the college said.

Scholarships were the second highest giving priority among donors, receiving \$898,231 in gifts to fill gaps in financial aid for deserving students.

MURDER...

Dr. LaPoint said it was his determination that Durham suffered "sharp force trauma" or multiple wounds to his neck that occurred from a cutting or slicing motion, as opposed to a stabbing motion.

Dr. LaPoint said the wound was so deep and "quite forceful" to the point it severed the tongue from the hyoid bone and left a "distinct groove" on the front part of the third cervical vertebra.

Dr. Michael Sikirica testified on Oct. 23 regarding the autopsy he performed on Freeman shortly after his death.

Dr. Sikirica confirmed in court that Freeman died from a significant knife wound in his back that shattered his tenth rib on the right side of his back, piercing his liver and nicking his eighth rib in the front of his abdomen.

Dr. Sikirica also detailed a number of other injuries to Freeman, including defensive wounds to his hands and multiple cuts to the left, right and center of Freeman's neck.

First on scene

Leroy Tharrett Jr. and his son Jeffrey were the first to find Durham on the morning of Feb. 11, 2023 after being asked to check on him by a family member who noticed his vehicle was still in the Eastside Cemetery around 8:15 a.m. that morning.

Tharrett Jr. said he would often see Ronald Durham and his white Dodge Ram pickup truck in the cemetery where Durham's wife was buried.

A distant relation through marriage, Tharrett Jr. said he knew Durham "almost all my life."

Around 7 a.m. they all met at the home before Tharrett Jr. went to White's Hardware across town to pick up supplies for the day.

Jeffrey Tharrett also confirmed the timeline and details during his testimony.

Both Tharrett Jr. and his son said they then walked across the street at around 8:10 or 8:15 to check on Durham, where Jeffrey Tharrett discovered Durham deceased next to the driver side door of his truck.

He said the driver side window was rolled down and the truck was "facing the other way" compared to how it was normally orientated.

Police take the stand

Multiple New York State troopers and a Cortland City police officer also took the stand to provide testimony.

Mark Tyler, Trooper Megan Berwald and Cortland City Patrolman Austin Fisk also took the stand over multiple days, each providing their recollection of the Durham murder scene and an encounter with Smith in Cortland when his pickup truck was placed in a police impound.

The State Police all testified that they were called to the murder scene just after 8:15 a.m. on Feb. 11, eventually securing the scene, compiling evidence and interviewing potential witnesses.

In the case of Berwald, her K-9 was deployed at the scene upon arrival. She eventually utilized a drone to capture footage of the scene as snow began to melt with the heat of the sun intensifying around midday.

Terpstra testified that Smith did in fact have a relationship with Durham, noting he claimed he "went home to assist his roommate with fixing, I think, a water pipe, doing some sort of home repair" on the morning of the trial.

She then detailed how Smith claimed to have been in South Colton for work shortly afterward.

One of the first on scene, Tyler detailed how he began taking photos of the scene and searched the vehicle for a murder weapon, finding none.

Tyler said he then began documenting the scene while wearing rubber gloves "so as not to contaminate the scene or any evidence."

He commented that he only entered Durham's truck to begin photographing the interior, during which time he did find some blood in the cab of the truck, including on the glove box.

When asked by Barrett if there was a "spray" of blood, Tyler said there was not.

Based on photos provided by the prosecution, which were taken by Tyler and Berwald, Durham's body could be seen next to the driver side

door of his truck, laying in a huge pool of blood that stretched seven to eight feet.

Boots also came into play during Tyler and Berwald's testimony as both confirmed police had photo evidence of multiple boot prints around the body of Durham. That led Tyler to a local store in Gouverneur that sold a Georgia Boot Company boot that had a tread pattern matching one of the prints near the body.

Motion for mistrial denied

Defense attorney Brian Barrett's motion for a mistrial in the Adam Smith murder trial was denied today, Oct. 28, after the District Attorney's Office attempted to submit video evidence stemming from a Feb. 11, 2023 traffic stop.

Barrett objected to dash camera footage from a traffic stop in the city of Cortland that involved Cortland City Police Patrolman Austin Fisk.

Fisk testified during the morning session, saying he initiated a traffic stop of Smith while he was in the city of Cortland during the afternoon of Feb. 11, 2023.

Barrett contended that by attempting to introduce the dash camera footage and audio of the stop the prosecution would violate a pre-trial decision by Judge Greg Storie regarding evidence that could be introduced during the case.

But Storie overruled the motion, opting instead to allow the jury to view the video without audio.

District Attorney Gary Pasqua suggested the prosecution did not even need the video to prove their case, saying he would omit the video if necessary.

"If it's going to be some sort of a violation of the court's order, we don't have to put that video in whatsoever," Pasqua said.

He commented that the testimony of Smith being pulled over in Cortland "was always going to come in."

"It's part and parcel to what happened in this case and how his vehicle was stopped, and why it was stopped and how it was impounded. In fact, in the court's pre-trial rulings, the court has already ruled that the statements from the defendant could be used at trial from that traffic stop. The fact that the defendant was stopped, that was already coming into evidence. So, it wasn't a violation of any ruling whatsoever,"

Foul dumping in the Deer River

Since early 2024, North Lawrence and Brasher residents have seen Leptotomitus luctus contamination, a sewage fungus, in the Deer River due to North Country Dairy's processing waste ("North Lawrence and Brasher residents voice concerns over Deer River contamination" North Country Now, 6/6/24). The fungus is smelly and blob-like, posing threats to nearby residents' well water as well as aquatic ecosystems in the river.

Not only is the dairy plant still operating, but its representatives have failed to take responsibility for their actions and clean up Deer River.

Close to the river, some communities could become environmental justice areas, meaning they would be disproportionately burdened by environmental degradation. According to the Department of Environmental Conservation's Potential Environmental Justice Areas (PEJAs) map, the area of

contamination is sandwiched between two PEJAs, where 65% of the communities are minority populations and 30% live below the poverty line.

Deer River, a tributary of St. Regis Falls, has even smaller connected brooks in the affected PEJAs, so the sewage fungus could potentially spread into these marginalized communities.

Kevin J. Ellis, CEO of North Country Dairy, released a well-crafted — but ultimately lackluster — statement (<https://north-lawrencecommunityupdate.com/>) on the issue, leaving out any form of direct action.

Let's hold North Country Dairy accountable for its mess and ensure that no communities, especially those that have been historically underserved, have to deal with further water contamination.

Potsdam grad glides to water ski title

HANNAWA FALLS - A Potsdam Central graduate has honed water skiing skills he learned on Hannawa Pond and turned it into success all around the nation.

Nick Leuthauser of Hannawa Falls won the 55K World Elite Slalom Tour Event (WEST) #8 at Swiss Waterski Resort in Clermont, Fla. earlier this month. 55K WEST is in its fifth year.

"I grew up on the water in Hannawa so the 'lake life' lifestyle is ingrained in my DNA," the Potsdam Central technology teacher said. "I have always enjoyed recreating on the water in and out of water skiing."

He first started waterskiing at age 10 and he said it took him 21 tries to get up.

"But once I was finally successful, I was instantly hooked," Leuthauser said. "I spent the rest of that summer skiing as much as I could and eventually started running the course on one ski by the end of the season."

55K WEST stands for 55kph (34 mph) World Elite Slalom Tour. Skiers in the event are the best 34 mph skiers over the age of 35 in the world. Participation in the event is based on a world rank list from participating in events throughout the year.

At a traditional tournament participants will ski anywhere from one to three attempts or rounds a day. Leuthauser said the 55K WEST

event has a unique format, being a two-day tournament featuring a qualification round for the top 32 skiers.

Those remaining after day one compete head to head on day two. There are two skiers skiing against each other behind different boats.

This isn't the first time Leuthauser has won competitions.

He won a Mens 2 (age 25-35) National Championship in 2013 at West Palm Beach in Florida. He also won two Regional Championships and roughly 12 state championships as well.

"I currently hold the Eastern Regional Men's 2 record and New York State Open Men record," he said.

Leuthauser invests a lot of time in the sport.

In season, he tries to ski once or twice a day depending on weather and his schedule.

"I try to get on the water as early as possible in the spring to build a solid foundation for the warmer months," he said.

The successful skier lives on Hannawa Pond, which is public water with a current.

"So in order to train in Hannawa, we have to ski in the morning before other boats come out and before the current starts from electricity demands during the day," he said.

He also skis at a private site where he has a ski course set up in a reclaimed mining pit.

"That site provides a much better training opportunity to prepare for tournaments since most tournaments are held at private ski lakes," Leuthauser said. "During the off-season I make an effort to keep my fitness level up in order to have a solid foundation of strength and balance to build from throughout the upcoming season."

In slalom skiing the name of the game is to make it around as many consecutive buoys at the shortest rope possible. There are 6 buoys on alternative sides that the skier has to go around while the boat drives straight down the middle.

If you make it around all 6 buoys, then the boat stops at the end of the lake, the rope is shortened and you continue until you fall or miss a buoy.

"It is a sport that is very measurable and always ends in failure," he said.

Waterskiing might be an individual sport, but he said it takes a team to make things happen.

"It takes people who share the same passion to help maintain ski courses, drive the boat, and provide insight and ideas in order to improve. In my opinion, the best part of waterskiing is the lifestyle of being at a lake with a good group of people. Also, the ability to move across something that you can't walk on is always a pretty cool sensation that can get anyone hooked."

"It is what I like to call fun fitness," he said.

Coates said he is enthusiastic about the opportunity to train at "the best facility in the North Country" as he chases Olympic glory.

Coates' is currently on the USA Luge Junior National Team and will be competing in the Junior World Cup this season, the premier division for juniors that has launched a number of athletes' careers including Chris Mazder and Erin Hamlin in recent years.

Both have multiple Olympic medals to their credit.

Coates' first Junior World Cup race of the upcoming season will be December 16th in Winterberg, Germany.
