Smoke shop owner suing Mayor Alleges discrimination based on race

MASSENA -- The Village of Massena and Mayor Greg Paquin are being sued in a federal civil rights case by a member of the St. Regis Mohawk Tribe.

According to court documents filed with the Northern District Court on Jan. 15, 2025, Regina Thompson is alleging that the village and Paquin have unlawfully discriminated against her on the

basis of her race, violating her constitutional rights.

In the complaint, Thompson alleges she has faced harassment with regard to the operation of her business, depriving her of equal protection under the law.

Smoke shop claim

In her claim, Thompson said she opened the Willow Street Smoke Shop in December 2021, a convenience store and tobacco shop located at 54 Willow Street,

in the village of Massena.

The location, which lies within the contested "Square Mile" in the village, historically belongs to the Saint Regis Mohawk Tribe, the suit alleges.

Thompson said during one village board meeting she is duly licensed by the Tribe and not subject to state licensing requirements.

In a recent land settlement

NYPA wants to raise rate by 256%

Legislators say that's too much, push back with resolution

CANTON -- The New York Power Authority is seeking a 256% rate hike that would impact residential customers throughout the North Country with electric bills rising anywhere from \$13 to \$30 per month based on usage.

Legislators passed a resolution during the Operations Committee meeting on Feb. 10 opposing the hike. The vote was thirteen in

favor with two abstentions coming from John Gennett, who cited his employment, and Nicole Terminelli who cited her husband's employment.

A public comment period was opened on Dec. 24, 2024 related to its Notice of Proposed Rulemaking to adjust the Preference Power rates, which directly impacts customers who receive low-cost hydropower from the Niagara and St. Lawrence-FDR power projects.

The 256% rate hike would lead to an increase from \$12.88/megawatt hour to \$33.05/megawatt hour in year four of the five-year NYPA rate increase, county officials said.

Legislator Rita Curran said the proposed increase is "astronomical" and something that working families cannot afford.

She urged residents to comment on the proposed hike in

Ogdensburg has new K9 officer and handler

K9 Reed named to honor late Sgt. Scott Reed

OGDENSBURG -- A new police K9, named to honor the late Ogdensburg Police Sgt. Scott Reed, will join the city department in March.

Andrew Layng will serve as handler for Reed, a Labrador Retriever. The K-9 is being purchased from Bohemian K9, in Brockport and will be trained at a total cost of \$11,080.

Ogdensburg Police Chief Mark Kearns shared the plan at a recent city council meeting and said that the department was pleased to name the new K-9 to honor officer Reed.

The city's K9 unit has been a boon not only for the city police but also for the county as the police K9 is often called to assist other law enforcement agencies.

Kearns said the K9 unit is an important part of the city's police

force and can be used in a variety of ways to support operations including detecting drugs, detecting bombs and helping locate missing people.

Reed is the third K9 to serve on the force.

Outgoing Schuyler is a Belgian Malinois, who worked alongside handler Ryan Polniak.

Schuyler was the second dog to serve on the force and was preceded by Labrador Retriever Kodiak, who served four years in the force alongside handler Mark Kearns, who went on to become Chief of Police.

Layng said becoming the next K9 officer was something he's always wanted to do.

"A lot of kids out there grow up wanting to be like their fathers and I am no different. My father is a retired detective sergeant from our department and since I was a kid I

Still a chance to comment on Liberty Utilities rate hike

MASSENA -- A virtual public hearing will be held on Thursday, Feb. 20 at 12:30 p.m. and 5:30 p.m. to allow Liberty Utilities customers to weigh in on a proposed rate hike.

Liberty Utilities filed for an 11.45% rate increase in November, a move that would generate \$2.17 million in additional revenue for the company, according to the filing.

Liberty Utilities currently provides service to Brasher, Winthrop, Canton, Gouverneur, Heuvelton, Lisbon, Madrid, Massena, Norfolk, North Lawrence, Norwood, Ogdensburg, Potsdam and Waddington in St. Lawrence County. Services are also provided to Beaver Falls, New Bremen, Croghan, Chateaugay and Malone.

According to Liberty Utilities, 14,862 residential, 1,770 commercial, 21 industrial and two cogeneration customers are currently serviced by the company.

Public comment is currently open with the New York State Public Service Commission, who are accepting comments both for and against the rate hike.

"Those wishing to comment on any aspect of this proceeding will have the opportunity to make a statement on the record at the virtual public statement hearings," said Richard Berkley, consumer advocate and director, Office of Consumer Services.

The new rate proposal, if successful, would raise monthly bills by more than \$10 for the average residential heating customers.

The amendment filed by Liberty Utilities in November would result in a 6.12% revenue increase for the rate year running from Nov. 1, 2025 through Oct. 31, 2026.

But the measure would not only increase residential rates but commercial and industrial rates as well.

For commercial customers using 549 therms per month, they would see a 1.9% increase.

Industrial customers using 40,786 therms per month would see a 4%

increase.

In the filing, Liberty Utilities officials say they are focused on delivering "safe, resilient, and reliable service, meeting the needs of customers and advancing the goals of the Climate Leadership and Community Protection Act."

Lawmakers are calling on residents to submit their comments in a timely manner, including county legislators who are encouraging all residents to weigh in.

"Residents of St. Lawrence County, many of whom live upon a fixed income and who are already experiencing great financial burden due to rising costs and record-setting inflation over the past four years, will feel significant financial pressure if the requested rate increase is approved," legislators said.

Village of Massena Mayor Greg Paquin said he hopes residents use the opportunity to speak up and voice their concerns. "I encourage all residents using natural gas to make their opinion known through the public comment period," he said.



Troopers investigate fatal structure fire in Rossie

ROSSIE – State police are investigating a fatal structure fire that occurred early Feb. 8 on County Route 3.

At approximately 2:30 a.m., troopers responded to reports of a fully engulfed residence, officers said. Local fire departments arrived on the scene and successfully extinguished the blaze before entering the structure, where they discovered a deceased individual inside.

New York State fire investigators and the St. Lawrence County

coroner were reportedly present at the scene. The coroner ordered the removal of the deceased. An autopsy is scheduled for Feb. 11. Forensic Pathologist Dr. Scott LaPoint will examine to determine the individual's identity and establish the cause and manner of death.

The investigation remains ongoing. State police were assisted at the scene by personnel from New York State Fire, as well as fire departments from Oxbow, Brier Hill, Hammond, and Gouverneur.

O'burg firefighters respond quickly to Washington St. fire

OGDENSBURG – An early morning structure fire was quelled within an hour by Ogdensburg Professional Firefighters on Thursday.

The fire ignited in a home on the 1000 block of Washington Street just before 4 a.m.

Ogdensburg's Captain Irvine and Shift 1 crews responded with Engine 3 and Quint 1, and arrived on scene within two minutes.

Crews determined that the fire that started in the home had spread into the walls, and utilized aggressive interior attacks to knock down the bulk of the fire in short order.

Crews worked for just under an hour in temperatures hovering around 10 degrees, and were back in service at 4:54 a.m.

Ogdensburg Police Department assisted with traffic control.

Search underway for next Nightengale principal

MASSENA -- The search is on as Massena Central School officials seek the next Nightengale Elementary School principal following the resignation of Amy Wells, effective June 30.

The board of education accepted Wells' resignation during the December meeting as she plans to transition into the role of director of special education for the district.

She will assume the post on July 1.

According to Superintendent Ron Burke, current administrators in the district were polled to gauge interest for the position, however no one indicated a desire to fill the void.

"That's always a good sign that people are happy where they are," he said.

With the internal request complete, officials say they are now searching externally for a replacement at the school.

Those who apply are required to have an active School Building Leadership certification and a minimum of three years of teaching experience.

According to the posting, desired qualifications include experience in administration and supervision comparable to an elementary school.

Letters of interest, along with a completed application and certificate that shows an active School Building Leadership certification, three letters of recommendation and transcripts are due to the district office by Monday, Feb. 10.

The principal's position is not the only one the district is hoping to fill this year, with a number of vacancies in special education roles at Jefferson Elementary School and Madison Elementary School, along with a fifth grade teacher at Madison Elementary School, a math Academic Intervention Services teaching assistant at Madison Elementary School, along with science and social studies positions at the high school.

Other positions open include long-term health services staff members, speech and language pathologist, elementary art teacher, bus drivers and an English Language Learner teacher position.

Burke previously said that filling such roles has become increasingly difficult in recent years, due in large part to a smaller pool of applicants to draw from.

He said the district has done a great job of filling those roles despite the workforce shortage and is confident the district will once again be able to this year.

Semiconductor funding

CANTON — State and federal officials are working to build a "semiconductor highway" through New York, utilizing millions in federal funds. In December, Senator Chuck Schumer announced a \$32 million investment in Corning's Canton facility, which will add 130 new jobs. The project will generate about 175 construction jobs. Schumer said this funding agreement with the U.S. Department of Commerce would produce specialized glass critical for the semiconductor industry.

Indictments handed down by County Grand Jury

CANTON – A Madrid man who allegedly broke into a City of Ogdensburg residence with the intent to commit a crime then brandished a knife when police arrived was indicted on numerous charges Thursday, Feb. 6, by a St. Lawrence County grand jury.

Stanley Greer, 59, of 44 County Route 31, was indicted on two counts of second-degree attempted burglary, menacing a police officer, two counts of menacing, and two counts of criminal possession of a weapon.

It is alleged that on Nov. 6, Greer unlawfully entered a building and placed a police officer in danger by displaying a knife in the course of the officer performing his duties.

In other grand jury action:

Andrew Dale, 30, of 32 Howard St., Gouverneur, was indicted for second-degree strangulation and second-degree harassment. It is alleged that on Sept. 15 in the Town of Fowler, Dale applied pressure on the throat or neck of a person causing physical injury. The harassment charge stems from Dale allegedly striking, shoving or kicking that person.

Dustin Browning, 39 of 5 Isabel St., Massena, was indicted for third-degree burglary and third-degree grand larceny. Court documents report that on or about Aug. 1 in the Village of Massena, Browning unlawfully entered a building and stole property exceeding \$3,000 in value. It was also noted that Browning was convicted on a Class D felony charge of third-degree burglary on July 12, 2012 in St. Lawrence County Supreme Court and if convicted is subject to being sentenced as a second felony offender.

Tabitha New, 36, of 15 Johnson St., Gouverneur, was indicted for

second-degree attempted assault, third-degree assault, second-degree menacing, and two counts of endangering the welfare of a child. It is alleged that on Aug. 9 in the Town of Gouverneur, she attempted to cause injury to a person by means of a deadly weapon or instrument. It is also noted that New acted in a manner likely to be injurious to a child less than 17 years old.

Kody Larock, 28, an inmate in the St. Lawrence County Correctional Facility was indicted for fourth-degree grand larceny and two counts of second-degree robbery. It is alleged that on or about Nov. 9 in the Town of Potsdam, Larock did forcibly steal property exceeding \$1,000 in value aided by another person while displaying what appeared to be a firearm.

Jesse Premo, 31, of Saranac Lake, was indicted for second-degree stalking, third-degree criminal mischief, fourth-degree criminal possession of a weapon, one count each of first and second-degree criminal contempt and four counts of endangering the welfare of a child. It is alleged that on or about Aug. 20 in the Town of Potsdam, Premo damaged property of another person exceeding \$250 in value while displaying what appeared to be a firearm. It is also alleged Premo was in possession of an imitation pistol or undetectable knife. Premo also acted in a dangerous manner toward a child less than 17 years old.

Devon Delee, 29, and Lisia Noel, 27, both of Syracuse, were indicted on two counts of third-degree criminal possession of a controlled substance. It is alleged they were in possession of a half ounce or more of a narcotic drug with the intent to sell on Aug. 1 in the Town of Morristown.

Library of Congress honored Gendebien's request to limit access to controversial interview, but now he's asked them to repost it

The Library of Congress has removed online access to a 2013 TAUNY interview that was used as ammunition by Republicans to criticize NY-21 Congressional District hopeful Blake Gendebien, but it will be made available again soon.

A spokesperson at the Library of Congress said Tuesday that online access was removed at the request of Gendebien, but said it can be obtained onsite in the American Folklife Center's reading room.

However, on Wednesday, the Library of Congress said that Gendebien has since requested that the audio interview be made available again and said they are working to make that happen as quickly as possible.

The interview, which included a harsh depiction of the North Country workforce, fueled Republican press statements criticizing Gendebien for comments he made about corrections officers and the local labor force.

North Country This Week became aware of the interview's restricted access after a link in an earlier story which referenced the piece was no longer working.

That prompted an inquiry to the Library of Congress to determine why it had been removed.

"In this case, the subject of the interview requested that it be taken down from our site. We are typically generous in honoring these requests since they are personal narratives, however we keep the descriptive information online and make the collection accessible onsite in our reading room. That is what we've done in this case," he said.

North Country This Week reached out to Gendebien regarding the situation and though they did not delve into details as to why the request was made, campaign officials provided the following statement on his behalf.

"This is what Albany and politicians do, they take statements out of context and launch deceiving attacks in an effort to fool voters. While my comments are readily available online, I will make the recording available again so DC and Albany party bosses can continue living in the past," Gendebien said in the prepared statement.

"While they are dwelling on decades-old comments I'm focused on delivering a better future for the North Country -- fixing our broken immigration system and lowering prices for hardworking families."

The decision to restrict access appears to be in conflict with the spirit of the Library's existing policies, if not the technical policies.

"The Library's Collections Policy Statements define in detail the scope of materials that can be added to its collections. That scope is intentionally broad and deep as befits the nation's library. Thus, there are items in the collections that some will find objectionable or may challenge. For example, authors or publishers may request that particular materials be withdrawn from the collections. To meet its mission, though, the Library must include such materials in the Library's collections. Barring exceptional legal or ethical circumstances, any requests to remove within-scope items on such grounds will be declined. A decision may, however, be made to restrict access to the materials. Requests for removal should be directed to the Collection Development Officer, who will coordinate as necessary with other Library stakeholders, including the Office of the General Counsel (OGC)," the policy says.

North Country This Week has sought further clarity on the policy from the Library of Congress officials who did not directly respond to the question.

The interview in question gives a candid description of rural farm life and was part of a larger series that included similar interviews with dozens of North Country farmers.

In the interview Gendebien said corrections officers "don't have much self-worth," and that Hispanic workers are better workers than local kids because they "don't have practical independence and an ability to think and

the knowledge these guys do."

He also said that the local workforce is lacking and that those that are available come with baggage like domestic abuse issues, drinking problems and custody battles.

The interview was used to fuel political attacks by GOP Chair Ed Cox and others, but Gendebien remained unfazed by their comments and said he wore the attacks as a badge of honor.

In an early interview Gendebien said that while he agrees he could have worded things better the reality is the interview with TAUNY was given by a tired farmer and a frustrated business owner, not a politician.

"I'm not a politician, I was a tired farmer and I spoke plainly," he said.

Gendebien didn't shy away from responding to specifics regarding the interview either. He said his comments about correction's officers could have been worded better and that his intention was to convey that the job is difficult and taxing and that many of the officers take on second jobs doing things that are more enjoyable and fulfilling.

"My point is they bring a lot of value to the North Country," he said.

Gendebien said many corrections officers are his friends and neighbors and that the idea he holds them in ill regard is simply off base.

"The issues that I'm really tired of are rich D.C. show horses prancing around with 15 year old interviews rather than talking about the real issues," he said.

Similarly he said his comments regarding the workforce were really about the difficulty in finding a solid workforce.

"Obviously I don't think every employee available in the north country has domestic problems and an alcohol problem," he said.

"Talk to anyone in the North Country that is self-employed...They all know how hard it is to find a quality workforce," he said.

He said the decision by Republicans to use a decade-old interview as political ammunition shows they are scared he could flip the District blue.

"It means this is going to be a race and I can win and I can represent this entire district better than anyone else ever has," he said. "I'm going to win this race. I'm laser focused on the issues and they are digging up 15 years old interviews that nobody cares about. What people care about is what's going to make their lives better and I will genuinely work for everyone in the district to make that happen."

Although Republicans haven't yet rallied behind a candidate to run against Gendebien, Executive Director of Super PAC Save American Freedom Alex DeGrasse criticized Gendebien for the removal request and issued the following statement on the situation.

"Far Left NY-21 Democrat candidate Blake Gendebien knows that his anti-American worker and anti-American family, pro-illegal amnesty positions including admitting to bailing out a criminal from ICE detention for \$10,000 makes him unelectable, which is why he desperately asked the Library of Congress to scrub his disastrous, career-ending public interview from their website. Blake is a coward and went as far as having the Library of Congress engage in censorship to hide his true beliefs from the voters of NY-21. Shameful."

Village of Massena selling surplus fire rescue truck, ambulance

Both vehicles out of service after purchases

MASSENA -- Village of Massena officials have signed off on the sale of an ambulance and heavy rescue crash truck, allowing for the vehicles to be transferred to other departments while netting the village a big chunk of money.

According to fire department Foreman Aaron Hardy, the department's 2010 International rescue truck has been sold to the Northfield Fire Department for \$160,000.

He said it was the right time to sell the vehicle, which was declared as surplus inventory, to make a fair amount of money back on the vehicle.

"We're very fortunate that this offer actually meets the needs of this department out of Massachusetts," he said.

Hardy said members of the Northfield Fire Department were happy with the vehicle size, noting that the size of the station's doors dictated what vehicles could be purchased.

He said members of the Northfield Fire Department visited Massena to measure the truck and take it for a test drive. He said they were "very pleased" with the condition of the truck and said it would fit their needs well.

Hardy informed village officials that all equipment from the truck has already been moved to another vehicle in the fleet, including extrication equipment.

Trustee Ken McGowan said he felt the sale was the right move, commenting that "making a few bucks on it while it still works" was

a great idea.

He also touched on the equipment that formerly outfitted the vehicle, saying the extrication equipment is now at the fire station and "redundant."

Fire officials took delivery of new battery powered extrication equipment last year, a move that has made servicing the community far easier, Hardy and McGowan both said.

Hardy previously said the new equipment is much faster to deploy and easier to maneuver for fire crews, allowing them to get into tighter areas and to work more efficiently.

In other action, village trustees also signed off on declaring a 2014 Chevrolet Duramax-Diesel 4500 ambulance as surplus property, allowing the village to sell the vehicle.

Mayor Greg Paquin informed trustees that the department is now phasing out the "last of the old guard" by offloading the vehicle, allowing the village to make a few dollars while switching to a three ambulance rotation.

Hardy previously said the ambulance in question had been "in and out of service several times" and was out of commission for weeks in 2024. At one point, he said the ambulance was in the shop more often than it was in service.

He also commented that with the sale of the ambulance, fewer resources will have to be expended to outfit the vehicles.

The 2014 ambulance will now be sold to Flynn Emergency Services for \$5,000.

State expands 'Red Flag Laws' to make courts notify state database of filings

Legislature considering more gun control bills

State lawmakers have taken action to strengthen the state's Extreme Risk Protection Order law, also known as a "Red Flag Law" designed to keep firearms out of the hands of those who are a threat to themselves or others.

Governor Kathy Hochul said new legislation she signed into law that would require courts to notify the statewide registry of orders of protection and warrants when a judge issues an ERPO.

The law builds on legislation signed by Hochul in 2022 shortly after she assumed office.

It specifically revoked an individual's right to own firearms if a temporary ERPO was issued by a court after being reported by people of designated professions.

The 2022 legislation adds more professions to the existing list of reporters who are eligible to file for an ERPO, including health care, mental health and school officials.

Prior to the new legislation, police officers, district attorneys, family or household members, as well as school administrators,

teachers, guidance counselors, school psychologists, school nurses and coaches.

Family or household members under the law include people who are legally married or divorced, people with children in common, including adopted children, people related by marriage including in-laws, people related by blood like brothers, parents or cousins, unrelated people who live or have lived together for periods of time, as well as unrelated people in or were in an intimate relationship like same-sex couples and teens who are dating.

Critics of the laws say the ambiguity of the language allows for law enforcement to remove firearms from an individual's home without due process, violating their 14th Amendment rights.

While an ERPO is meant to stop an individual from purchasing a firearm through a licensed dealer, critics also say the measures do not stop such individuals from purchasing illegal firearms.

Others argue that ERPOs save lives by allowing law enforcement to take immediate action when a potential threat has been reported.

Ogdensburg Airport adds Orlando flight

OGDENSBURG— Breeze Airways will pilot its first direct flight from Ogdensburg to Orlando this Thursday, Feb. 13.

The flight will take off at 11:55 a.m., and marks the beginning of the airline's twice-weekly service to the Orlando International airport.

Flights to Orlando will initially be offered each Thursday and Sunday until April 27.

Ogdensburg Airport Manager Charlie Garrelts said he was "excited to have direct to Florida flights back at OGS."

"These flights will work to increase the quality of life for our residents by giving them more options to fly from Ogdensburg," he added.

Ogdensburg Airport also offers daily direct flights to

Washington-Dulles International Airport.

Breeze was awarded a federal subsidy in 2024 to provide daily flights to Washington D.C. which are beginning to ramp up as time goes on. However their appeal is likely being hindered by the fact that the airline has not yet secured interline agreements with other airlines, which has made connecting flights difficult.

At a recent meeting Ogdensburg Bridge and Port Authority Officials said they were hopeful the Canadian draw for Florida flights would also be a boon for bridge traffic.

In other airport news, Garrelts said he's to secure a state grant that could bring deicing equipment to the airport which could help bring additional flights to the city airport.

SLC legislators oppose DEC plan to end Walleye stocking program

Chairman says volunteers are “ready to roll” and keep program alive

CANTON — Legislator David Forsythe is calling out the Department of Environmental Conservation over their decision to end a successful 40-year walleye stocking program that has proven crucial to increasing and stabilizing the population throughout the county.

The program operated for roughly 40 years thanks to the St. Lawrence Valley Sportsman’s Club and the DEC who worked together to stock walleye in the Oswegatchie River.

In December, the DEC reported in a recent press release that because of that program, the walleye population has remained stable at higher levels for years now, in Lake Ontario and the St. Lawrence River.

Forsythe called into question the DEC’s decision during the Feb. 10 Operations Committee meeting, noting he felt it was a short sighted decision.

“It really wasn’t what I wanted to hear. What I garnished from the conversation was that it was not convenient for them. It’s not a very good allocation of their resources, it’s the only one they do in the state. There is no monetary contribution on their part...I just think it’s unacceptable,” Forsythe said.

Forsythe said he would like to see the program continue.

“We have put a tremendous amount of time and resources into our fisheries and promoting fishing on the St. Lawrence River,” he said.

Forsythe said he was tired of seeing the county “receive crumbs” from the state and DEC.

“We want some meat behind this,” he said.

Forsythe said he has sought assistance from state senators and assembly members, all of whom were supportive of continuing the program.

He said the volunteers who have operated the program for the last 40 years are also onboard and have a “renewed energy” about the program.

“They’ve seen a resurgence in their efforts,” he said.

Forsythe commented that the number of volunteers has increased in recent years, giving him hope that northern pike and smallmouth bass may also be an

option in the coming years.

Interest increased to the point that a former hatchery in Lisbon, dormant for many years, has been restarted. Funding will be the only hangup but Forsythe said the volunteers are “ready to roll.”

“It always comes down to funding and resources,” Forsythe said.

He was also critical of DEC efforts to repopulate sturgeon in the St. Lawrence, a fish that he said cannot be fished by sportsmen and women.

Legislator Rita Curran noted that the sturgeon population was also stable and did not require intervention as walleye have for the last 40 years.

Forsythe took a moment to call into question DEC plans to potentially do away with a pheasant stocking program as well, something that has proven successful and popular among hunters throughout the county.

“I think we just have to say enough is enough, we’re tired of the crumbs,” he said.

In reference to the DEC presentation on Feb. 3, Legislator Harry Smithers questioned what a stable population looked like.

“Did they ever give us an answer on that? What is the definition of a stable population?” he said.

Forsythe agreed with Smithers’ assessment that DEC officials gave “shaky information” at best, commenting that the number is “science based now” but no set formula or calculation was given on Feb. 3.

“Stable is all science based,” he said.

Forsythe was critical of the choice to not involve Region 6 representatives, sportsmen and women, clubs or members of the restocking program to weigh in on the choice to end the program.

Legislator Nicole Terminelli also pointed to a lack of information from many DEC studies in recent years, commenting that the numbers presented are not necessarily true to the population of certain fisheries.

In the end, the resolution opposing the discontinuation of the stocking program passed unanimously.

Copies will also be sent to the DEC, as well as Senators Dan Stec and Mark Walczyk, along with Assemblyman Ken Blankenbush and Scott Gray.

Canadian Blackhawk helicopters to patrol northern border to stop illegal crossings

AKWESASNE -- North Country residents may soon see and hear Blackhawk helicopters patrolling near the border after Royal Canadian Mounted Police secured two additional helicopters for surveillance efforts.

According to a press release from the RCMP, the Blackhawks will “bolster surveillance and response capabilities” during operations to patrol, detect and respond to both north and southbound threats at the U.S.-Canada border.

Officials say the helicopters will be used to prevent illegal crossings of people, goods and drugs.

The Blackhawks will complement the RCMP’s existing fleet of nine helicopters, six of which provide border surveillance and support with cameras capable of thermal imaging, and another capable of hoisting operations.

“The addition of Black Hawks greatly increases the RCMP’s detection and response capabilities, offering rapid deployment and providing coverage when and where needed in between ports of entry, in line with the RCMP’s mandate,” RCMP officials said.

The Blackhawks will be deployed daily based on operational needs.

Though RCMP officials declined to release details on where the Blackhawks will be based or where they will be deployed, Akwesasne Mohawk Police say helicopter patrols may be seen in the area, including along the St. Lawrence River.

According to AMPS, the heli-

copters will coordinate with law enforcement agencies, including AMPS patrol units when operating in the Akwesasne area.

“The helicopters will be based in Ottawa and will patrol the Ontario, Quebec and New Brunswick borders. Their presence does not indicate a specific threat but is part of broader border security efforts,” AMPS said in a statement.

According to AMPS, the helicopters may be seen operating at low altitudes when necessary, though efforts will be made to minimize noise disruptions.

“The RCMP has integrated these helicopters into its strategy alongside drones and surveillance towers for enhanced monitoring and are committed to local law enforcement partnerships,” AMPS said.

“AMPS remains committed to responding appropriately within our jurisdiction and ensuring community safety. If you have any questions or concerns, please reach out and we will work to address them,” they continued.

The news comes just over two weeks after Canada announced a \$1.3 billion investment to bolster security at the border and to strengthen the country’s immigration system following pressure from the Trump administration.

The funds include \$667.5 million for the RCMP, \$355.4 for the Canada Border Services Agency, \$180 million over six years for the Communications Security Establishment, \$77.7 million for Health Canada and \$20 million over five years for Public Safety Canada.

In an executive order issued on

Feb. 3, Pres. Donald Trump said Canada had failed “to arrest, seize, detain, or otherwise intercept drug trafficking organizations, other drug and human traffickers, criminals at large, and illicit drugs constitutes an unusual and extraordinary threat, which has its source in substantial part outside the United States, to the national security, foreign policy, and economy of the United States.”

An executive order from Feb. 1, titled “Imposing Duties to Address the Situation at Our Northern Border” detailed how the government of Canada had taken immediate steps “designed to alleviate the illegal migration and illicit drug crisis through cooperative actions.”

The order noted that further time was needed to assess whether the steps “constitute sufficient action to alleviate the crisis and resolve the unusual and extraordinary threat beyond our northern border.”

Trump announced shortly after the Feb. 3 executive order that he would pause the expected 25% tariffs on Canadian goods entering the U.S., as well as the 10% tariff on Canadian Energy products. The order states the tariffs would be paused and not take effect until March 4, 2025 at 12:01 a.m. eastern time.

Trump also recently announced a 25% import tax on all steel and aluminum products coming from Canada, which will take effect on March 12.

That gives both sides a month to negotiate to avert the tariffs, which could prove detrimental to both sides of the border.

Voter deadline soon for June primary


You may not find primary elections a very romantic topic, but in New York, Valentine's Day and primaries are closely associated.

The next round of primary elections in New York doesn't happen until June 24, but the increasing number of voters who are not affiliated with a particular party only have until February 14 to take steps that will enable them to cast a primary vote four months from now.

Some unaffiliated voters (those who recently moved into the state, for example) may not be aware that NY has closed primaries, meaning that only members of a candidate's political party can vote to determine that party's nominee in the General Election.

Only four parties currently qualify for ballot lines in New York State: the Democratic, Conservative, Republican, and Working Families Parties. By not affiliating with one of those parties, voters in effect partially disenfranchise themselves. It is through the primary elections that voters choose the candidates

Massena housing options limited for visiting anglers

MASSENA -- Anglers who attend tournaments in Massena hope to see more housing options within and closer to Massena, according to a survey conducted by grant writer Linda McQuinn.

McQuinn updated town board members of her findings during the board's January meeting, noting that many anglers stay outside of Massena due to limited options.

"What we have found is that many travel from much further away than just the neighboring towns. For some, it comes down to long term stays. For others, it comes down to space for their family," she said.

But overall, McQuinn said anglers generally do not have enough options in the Massena area.

She said it is something she and sport fishing promoter Don Meissner hope to see change in the coming years as more tournaments come to the area.

McQuinn said she was able to compile a great deal of information from anglers in both 2022 and 2024, with just one angler failing to complete the survey last year.

"It was truly remarkable to see 287 responses," she said.

Those surveys, which were part of the Toyota Series tournament hosted by Major League Fishing, will play a crucial role moving forward, she said.

Other interesting tidbits from the survey include the origin of most anglers. In total, 218 were from the United States, while 28 were international residents in 2024.

A total of 41 were from New York.

McQuinn also broke the figures down further to show the growth in participation from certain states.

Texas, New Jersey and Maryland saw the most growth, she said.

"We broke it down in terms of the top 10 non-New York states. So, you can see that we have a lot of anglers coming from Pennsylvania, Texas, Virginia, New Jersey, Maryland, Ohio, Alabama, North Carolina, Tennessee and Indiana," McQuinn said.

Anglers also said they were staying longer, with thirty saying they stayed more than two weeks. That's up from 26 in 2022.

A total of 104 anglers stayed for more than a week, up slightly from 103 in 2022.

McQuinn said that trend is encouraging because it could mean

new anglers are coming to the area to practice before the tournaments, to compete and then stay after as well.

That means a greater economic impact for the region, she said.

One of the more telling aspects of the survey included lodging, with more anglers opting to use campsites. That figure rose from 43 to 54 in 2024.

Hotel use declined slightly, down to 107 from 115 in 2022.

Airbnb saw a significant increase, from 79 to 100 anglers between 2022 and 2024.

"We've speculated that perhaps they might start out in a hotel, and then they decide this is too expensive and will shift slightly and go to an Airbnb, or they might decide that a campground is what they want do," McQuinn said.

St. Lawrence County Chamber Director Ben Dixon was also in attendance at the meeting, commenting that the county has seen a "significant increase in Airbnb options" in recent years.

He credited events such as the Major League Fishing tournaments as a major catalyst for the expansion.

While numbers of anglers are up, so are revenues, McQuinn said.

McQuinn said total revenue rose from \$429,430 total in 2022 to \$618,145 in 2024.

Anglers from New York alone accounted for \$82,000 in 2024, she said.

She said those figures do not account for support staff who help put on the events not, nor does it account for families as McQuinn and Meissner did not interact with any of the families who have spent money in the area as visitors to come watch the events.

This is simply the anecdotal reports from the anglers, but it does coincide with what we've seen from Major League Fishing. They've reported that at their events, we can see anywhere from \$1.2 to \$1.5 million. So, that's really very, very good for communities like our town," McQuinn said.

McQuinn said 2025 will be a banner year for Massena, with multiple tournaments planned throughout the summer season.

Three Major League Fishing tournaments will be hosted by the town, including the Phoenix Bass Fishing League- Northeast Division No. 2 on July 12, the Tackle Warehouse Invitational- Stop No. 6 from July 25-27 and the Toyota Series Northern Division No. 2 from Aug. 14-16.

Greenhouse planned in Massena but roadblocks remain for final approval

MASSENA -- A greenhouse in the town of Massena has received a preliminary approval from the St. Lawrence County Planning Board but with a handful of conditions.

The 453,000-plus-square-foot facility will cover roughly 10 acres and is expected to supply fresh produce to the northeast with crops like lettuce.

Confluent Energies Inc. has proposed the project, which will be located in an industrial zone as part of a lease from Arconic.

County officials say the company is leasing 79 acres total from Arconic, with the project expected to be completed in two phases.

Confluent is expected to employ around 42 employees for phase one and around 141 employees for all phases, though the planning board only reviewed phase 1 recently.

Further review will be required when Confluent intends to begin on phase two, officials said.

As part of the agreement with Arconic, Confluent is expected to lease space for accounting, customer service and sales, with a new building to be constructed.

That building will be the greenhouse, which Confluent said is not required to go through code review since it is considered an agricultural building.

But planning board members disagreed with that assessment, arguing such structures can be subject to code review.

County officials said the structure should be subject to the building code in its entirety due to not meeting the definition of an agricultural building.

But Beardley Architects + Engineers representative John MacArther informed the county that discussions with Town Code

Enforcement Officer Patrick O'Brien ran contrary to that belief, with O'Brien agreeing the greenhouse portion was considered agricultural.

Under that belief, the growing portions of the head house, the irrigation room, germination and transplanting areas were also considered agricultural areas, he said.

MacArther said other areas, such as the boiler room, storage and processing areas were considered industrial occupancy, requiring a review under the building code.

One aspect of the project that the county Planning Board requested be remedied was greenhouse glow from the grow lights, officials said.

That needs to be remedied before moving forward.

Another aspect that Confluent Energies is seeking a change for is the requirement for parking spaces, 756 to be exact.

That's due to town code requirement but Confluent argues that 39 spaces would be sufficient given the size of the operation.

That change will likely require an area variance.

In the end, the county Planning Office recommended approval with three conditions, including lighting on the property to be down-cast, dark sky compliant and a lighting plan to address "greenhouse

glow" should be submitted.

County officials also suggested coordinating with the town Highway Department regarding a curb for road access. A wastewater management plan was also suggested after Planning Board members raised concerns about wastewater management.

Officials with Confluent said the three waste streams associated with the project would enter Arconic's wastewater treatment plant and be processed through the facility.

Confluent officials said the report, which was presented to the county Planning Board for wastewater management, has also been submitted to Arconic for review.

Board member Kenneth Bellor said he has reviewed the report with Arconic officials, noting that they were "very surprised with the detail of the project" and that the location manager and environmental superintendent were "not aware of the project detail."

He said leadership was "totally caught by surprise."

In response, Bellor said it was strongly suggested Confluent leadership meet with Arconic officials to review the project in detail, in particular from a project management standpoint.

"Arconic is the critical path on this project," he said.

agreement, the "Square Mile" was not included as a portion of tribal territory that could be reclaimed by the tribe, however thousands of acres in the towns of Brasher, Massena, Fort Covington and Bombay were included.

Thompson's store, which includes a drive-thru, received a site plan review by the St. Lawrence County Planning Board on Aug. 11, 2022, who approved the plan on the condition that the drive-thru be redesigned to exit onto Woodlawn Ave. instead of Willow Street.

Thompson alleges in her claim that the County Planning Board also recommended the Village of Massena Planning Board take into account the parcel is located within the "Square Mile," which could impact land use regulations.

Thompson also alleges the County Planning Board recommended combining her three parcels into one "to accommodate future expansions."

Court documents state the Village Planning Board then took action and approved the site plan during the Aug. 15, 2022 meeting, under the condition the parcels be

combined into one and a fence be erected around the business and drive through.

In her claim, Thompson alleges no other businesses in the village have been required to combine their parcels to receive approval from the Village Planning Board.

Claims cited

Thompson also cited numerous instances during which Paquin and former Mayor Jim Hidy addressed concerns over illegal shops and unlicensed operations in the village.

One such meeting was the Aug. 15, 2023 village board meeting, during which Hidy commented "We didn't think the natives were gonna come in but that situation has not been resolved yet."

Code Enforcement Officer Aaron Hardy also addressed the situation multiple times, stating that each location had a fire inspection and went through site plan reviews that allowed them to operate a business in those spaces.

As far as proper licensing and taxation, those matters fall to the state, village officials said on multiple occasions.

Multiple attempts by NCTW to reach the state Department of Taxation have gone unanswered.

Court documents cite two other occasions during which North Country This Week reported on comments made by Hidy and Paquin during public meetings, including one instance when Paquin commented "the Massena Square Mile does not exist. It never has and is not an obstacle for the State of New York to come here and work with us."

Blockade of drive-thru?

Thompson alleges that between Oct. 2023 and Jan. 2024, the village of Massena took direct action to "blockade" her drive-thru with concrete barriers.

Photos included with court documents show multiple barriers behind the building and along the adjacent sidewalk, a measure that prevented Thompson from "orienting and operating her drive-thru in the manner recommended by the County Planning Board."

Court documents also cite a change to a village code to prohibit parking on the south side of Willow Street, running between Somerset Ave. and Woodlawn Ave.

That motion was approved unanimously by the board.

Thompson alleges the new code affects only one block, the one in which her business is located.

Going a step further, Thompson alleges Paquin's comments during the Jan. 2024 village board meeting shows bias as he spoke specifically about Thompson's shop.

Paquin had questioned why the Planning Boards had allowed Thompson to move forward with her drive-thru, "indicating that the parking restriction was imposed specifically to target the parking available" around Thompson's shop, court documents state.

Barricades to remain

Court documents also allege Paquin commented during a public meeting that the concrete barricades would remain until Thompson installed a fence around the drive-thru.

Documents also claim Paquin commented that the village "interceded and acted" when Thompson failed to install a fence in a timely manner.

The lawsuit alleges no other businesses on Willow St. are required to surround their business with a fence.

Combination unnecessary

Court documents state Thompson spoke with Britney Rushlow, assessor for the Town of Massena, who informed Thompson she was unsure why Thompson's parcels would be required to be combined, noting that many other businesses operate on uncombined parcels.

According to the claim, Thompson alleges Rushlow suggested Thompson confirm the requirement with the village due to the potential additional expenses incurred by obtaining a new deed.

Discrimination inferred

Thompson also alleges in her suit that her business has been subjected to increased police activity and a higher than normal police presence.

She also claims she is being discriminated against due to being a Native American member of the St. Regis Mohawk Tribe, operating with a tribal license.

Thompson claims she has had to bear additional expenses and delays due to "arbitrary conditions imposed on Plaintiff and her shop by the Village Planning Board," though she does not go into further

details regarding the claim.

She alleges she has also suffered emotional distress and harm as a result of the alleged discriminatory harassment, obstruction and uncertainty as related to her shop.

Claims for relief

Thompson is seeking the removal of all barricades around her business, the elimination of parking restrictions on Willow St., a financial judgement against Paquin and the village in an amount to be determined at trial, a financial judgement for her lost business, punitive damages against Paquin and the payment of attorney's fees incurred by the lawsuit.

The village is represented by Attorney Matt McArdle, who will likely defend Paquin as well, though he is being sued personally and not within his official capacity as mayor.

knew I wanted to be a police officer because of that. I've also had a love for dogs since I was young and I can't recall many memories that my home has been without several dogs at once," he said. "When I was in high school and started to think seriously about getting into law enforcement I knew right away that I wanted to be involved with our K9 program. It checked a lot of boxes for me. I'm now in my seventh year with our Department and have had some opportunities to assist K9 Reed and my predecessors Sgt. Polniak and K9 Schuyler during their work. That perspective helped confirm my aspirations to become a handler."

He said the decision to name the officer after Sgt. Reed was made by the chief and supported by the department as a way to honor someone who was important to the department.

"I believe the decision to name K9 Reed after Sgt. Reed was made by Chief Kearns. Chief Kearns and

many of our senior officers had close personal relationships with Sgt. Reed. We are always looking for a way to honor his memory."

Layng said he hopes it will make Reed's family proud.

Layng said police K9's are a cornerstone to the police department. He said they can make a difference in finding missing children, locating evidence needed to prosecute crimes or aid in apprehending wanted persons.

"K-9 units are an important resource for any type of interdiction, in most instances they are the key to drug seizures," he said.

Reed is a year and half old male black lab and will have a certification in AWDA narcotics detection and AWDA tracking soon.

"K9 Reed and myself are set to finish training and begin work with patrols after March 7 of this year."

Public comment period on rate hike about to end

hopes of putting an end to the proposition.

"I understand we've had inflation but the last thing I think we should do is a 256% increase in the cost of power when people are trying to feed their children, keep the lights on and pay their taxes and do everything else they're trying to do. I have not seen any of the employees that I work around get a 256% raise," she said.

Curran said she doesn't know how families "can carry this" and afford to pay for the increase.

"I will not support this (rate hike)," she said.

Legislator Harry Smithers questioned what rationale or justification NYPA claimed to justify the rate hike but Curran said to the best of her knowledge there was none.

"There are comments online that you can see. Basically, they just want an increase," she said.

Curran said she wants to learn more about the request and to "see everyone's books" before the proposal was weighed by state officials.

Legislator David Forsythe commented that the proposal was covered during a recent meeting of the St. Lawrence River Valley Redevelopment Agency meeting he attended.

He said Massena Electric Superintendent Andrew McMahon gave a presentation during the meeting, noting the proposed rate hike and how it would impact North Country residents.

IN total, Preference Power Rates apply to hydroelectric sales to customers in 47 municipal electric systems, four rural electric cooperatives, three investor-owned utilities, the Tuscarora Nation, two transportation authorities, customers in neighboring states and host communities.

"Even if it's a 100% increase it's still too much," Forsythe said.

"Hopefully they'll reconsider this because it's astronomical."

The 60-day public comment period ends Feb. 24.

All written comments on the rate proposal must be filed with NYPA's Corporate Secretary by emailing secretaryoffice@nypa.gov.

In addition to the filing comments, NYPA held two public forums, one in Niagara and a second in Albany.

All submissions received during the public comment period, including statements received during the public forums, will be considered before a final rate recommendation will be presented to the NYPA Board of Trustees at its July 2025 meeting.

Central to this commitment is our multidisciplinary approach, achieved through close collaboration with the REW Cancer Center providers and Dr. Ali Gharagozloo from the Claxton Campus Radiology Department.

Additionally, we are excited to welcome back Dr. Alka Srivastava, who brings medical oncology and hematology expertise. Her dedication further strengthens our promise to provide outstanding cancer care for patients across the North Country.

We welcomed board-certified nephrologist Dr. Timi Akins to serve patients at Carthage Area Hospital (CAH) and Claxton Campus, extending the Dr. Ravinder N. Agarwal Renal Center's advanced services to Jefferson and Lewis Counties.

Additionally, Low-Dose Lung Cancer Screenings — led by board-certified pulmonologist Dr. Francis Lee and powered by AI technology — have been expanded to CAH, facilitating earlier detection and improving patient outcomes.

Registration is open for the workshop "Vegetable Production: Garlic and Brassicas", organized by Cornell Cooperative Extension of St. Lawrence County and the Eastern New York Commercial Horticulture Program (ENYCHP).

This opportunity is available for new and established farms of all skill levels.

The workshop is being held on Tuesday, March 11th, 9:30am-4:00pm at the Extension Learning Farm in Canton. The morning session is led by Crystal Stewart-Courtens of the ENYCHP.

This portion includes tips for growing great garlic from seed to post-harvest, advice for managing the invasive leek moth, and a discussion with a panel of experienced garlic growers.

The Brassica (cole) crop portion in the afternoon is led by Elisabeth Hodgdon of the ENYCHP. Brassica crops include cabbage, broccoli, kale, cauliflower and more.

The afternoon topics include pest and disease management, crop rotation, varieties, and planting dates.




Think it's too early? Think again. Graduation season can busy, planning ahead essential to secure venues, vendors

Graduation is an accomplishment so significant that many families commemorate grads' hard work with a party.

park.

Planning early can ensure such parties are just what parents and students are hoping for.




