## More than 2,000 corrections officers fired, blacklisted from government jobs

North Country reps say governor's order is hypocritical

Gov. Kathy Hochul has issued an executive order that will bar more than 2,000 corrections officers who were fired for striking Tuesday from working in state or local government in the future.

In the order Hochul said the state is committed to ensuring individuals appointed to state service uphold the law and their oath to public office.

"Individuals participating in illegal strikes have willfully violated the Taylor Law and an

order of the Supreme Court of the State of New York by engaging in

misconduct that undermines the public trust, demonstrates disregard for the law, disrupts public services, and is inconsistent with suitability for public service roles," her order says.

According to the order the state will investigate to determine which officers were involved in the strikes and all state agencies will need to determine if any applicants for jobs were former officers and if they were involved in strikes as part of the background checks.

## Weaver steps down from City Council due to residency requirement

OGDENSBURG -- Ogdensburg City Councilor Michael Weaver has resigned from city council.

Weaver's decision came as he will no longer be a city resident.

On Monday City Council accepted the resignation and set a special meeting for April 7 at 6 p.m. where they hope to fill the council.

Before that can happen the vacancy committee will solicit nominations for candidates willing to fill the role and present three potential candidates to council.

Mayor Michael Tooley offered kind words for Weaver, whom he said was a dedicated councilor.

Deputy Mayor Dan Skamperle said it was a pleasure working with Weaver and said he doesn't have to be a city councilor to stay

active in the community.

Councilor Michael Powers noted that being a councilor can be a thankless job and said he appreciated his willingness to take on the challenge.

Councilors Jennifer Stevenson, Donna Trimm and Storm Cilley said they were sorry to see him leave.

Weaver has served on the city council since January of 2024. It was his first term.

## Alcoa CEO says aluminum tariffs could cost jobs

As many as 100,000 jobs could be impacted if things go bad

MASSENA -- Alcoa CEO Bill Oplinger has told media outlets that tariffs proposed by President Donald Trump on multiple occasions could cost the company 20,000 U.S. aluminum industry jobs, along with an additional 80,000 jobs in sectors that support it.

Oplinger made the comments in a webcast recently, noting the Pittsburgh-based Alcoa would be hit heavily if the tariffs did go into effect.

Though Trump proposed tariffs when he first entered office in January, tariffs have been delayed at the eleventh hour multiple times.

Most recently, Ontario Premier Doug Ford announced on March

11 the province would immediately implement a 25% tariff on all electric exports to the U.S.

That measure would have impacted 1.5 million Americans, including many in New York. In response, Trump issued a 50% tariff on all Canadian aluminum and steel imports.

But shortly thereafter both sides backed down, bringing the two countries back from the brink.

Trump has said on multiple occasions he would impose a flat 25% tariff on aluminum imports "without exceptions or exemptions" in a move that he said would bolster U.S. production of metals used to manufacture vehicles, cans and various other products.

## Learn Ayurvedic gardening

While not an expert, Linda has been interested in Ayurveda for decades and has recently delved deeper into it.

With 20 years of teaching experience in English and Communications, Linda is always eager to share what she's been learning in an approachable, accessible manner.

Although Ayurveda is a comprehensive practice that includes exercise, meditation, sleeping, breathing, and a full range of dietary topics, this presentation will focus on dietary principles applied spe-

cifically to vegetables and garden planning.

This presentation is not intended to offer religious or medical advice.

## Facing murder charge in roommate death

CANTON -- An Ogdensburg man accused of killing his former roommate last April in Rensselaer Falls is facing a second-degree murder charge following an indictment Thursday, March 6, by a St. Lawrence County grand jury.

John Free III, 51, who is currently an inmate at the St. Lawrence County Correctional Facility, was also indicted on first-degree manslaughter, first-degree assault, and third-degree grand larceny.

County court documents report that between April 5 and April 12 Free caused the death of John Barr, 58, of

Rensselaer Falls.

Barr was found dead on May 16 and is alleged to have been struck in the head with blunt objects by Free.

The grand larceny indictment stems from Free stealing property in excess of \$3,000.

Free is a former Ivy Ridge employee and before the body was discovered, he was interviewed about his time and actions as an employee at Ivy Ridge. WWNY-TV also interviewed him in an hour-long program.

Free is being represented by attorney Bradford Riendeau.

# Massena Central proposed budget would have no tax levy increase, officials say

Four buses included in current plan, foundation aid likely to increase

MASSENA — When voters in the Massena Central School district head to the polls on May 20 they will likely see a budget with no tax levy increase, according to district officials.

District officials say the budget could have included a 4.27% increase under the property tax cap, however they opted against that with the budget as it currently sits.

Superintendent Ron Burke said the figure would be allowable under state law but noted the Finance Committee is "aiming for zero or as close to zero as we can possibly get."

That figure will be aided by a proposed \$1.98 million increase in foundation aid for the district, which would come to \$37.8 million under Governor Kathy Hochul's proposed budget.

That figure is based on a long established formula, officials said.

But aid increases wouldn't stop there, as the district would also see a \$255,228 increase for universal pre-kindergarten, \$254,866 for Board of Cooperative Educational Services, \$61,694 for private excess cost, \$59 for hardware and technology, along with \$300,548 for transportation.

While those figures would increase, other areas of aid would decrease, including \$136,124 for high cost excess cost, \$1,304 for software, library and textbooks, as well as \$1.02 million for building aid.

Total aid would top out at \$50.2 million, officials said.

But Burke reiterated that those figures are not set in stone as the state budget has yet to be passed.

"If you look at our building aid ratio, it looks like it's decreasing by \$1 million. I typically don't get too worried about that because that means we're paying off bonds or a project's been completely paid. But, we know that wasn't the case. In fact, that's probably going to end up being a plus \$1 million," he said.

Burke said expenditures under the draft budget would increase by \$2.3 million. That's in contrast to using the current budget and "moving it forward with no changes," he said.

"We'd be looking at a \$986,000 increase, which is a 1.4% increase," he said.

He said an additional component of the budget includes the strategic budget process, "which is where the administrative team gets together and we talk about what it is that we think we need or want additional for the next year."

## 'Adopt a Senior' at Massena in full swing

MASSENA -- Community members can adopt a senior from the class of 2025, a tradition that began with the class of 2020 who were unable to have a normal school experience due to the pandemic.

School officials say the "Adopt a Senior" program will provide gift baskets filled with each student's favorite items as a way to recognize the senior for their accomplishments.

Baskets will be delivered between March 24 and April 4, officials said.

The program is one of the first steps in recognizing students before their planned June 27 graduation. The event will take place at 8:30 p.m., however a rain date has been set for June 28, if necessary.

A reception is also planned for sometime in May or June, which will include a LifeTrack survey for outgoing students.

The survey is intended to track students' progress as they prepare to enter college or the workforce, with surveys conducted prior to graduation, 18 months after graduation and five years after graduation, according to a board resolution.


The survey is currently open for outgoing seniors, with an expected

## Outpouring of interest 'very exciting to see' Massena sport fishing promoter says sports shows huge draw for tourists

MASSENA — Sport fishing continues to be a big tourism draw to the North Country, especially in Massena where multiple professional tournaments have been held for the last few years.

Sport fishing director Don Meissner said the outpouring of support has "just been wonderful," noting that the numerous sports shows he and grant writer Linda McQuinn attend continue to raise the bar.

"We meet so many people and have so many new faces coming to these shows, seeking us out to see what it is all about," he said.

Meissner told North Country This Week that the shows he and McQuinn have attended since the fishing season wrapped up in 2024 "have been spectacular."

"They've been better than we expected, which says a lot. There has been so much interest in Massena and what it has to offer," he said.

Meissner commented that anglers and tourists alike continue to ask about the sights they can see when they visit, locations to stay and businesses they should visit.

He and McQuinn take numerous materials to promote the area and businesses, usually coming home empty handed.

"We have handed out hundreds of fliers, visitors guides, promotion products and materials. We rarely have anything left," he said.

Meissner said the first show of the season, held in Marlborough, Massachusetts, was a home run.

Now with two shows left, he said the final push is on to bring awareness to Massena.

"We have been working closely with a number of businesses in this town to help us for a presentation for people that are going to these sports shows, to understand what they have," Meissner said.

He said working with PBS has also been a huge boost

to efforts, with numerous videos shot over the last few months to promote tourist attractions such as the Nicandri Nature Center and St. Lawrence Seaway Visitor Center.

"Those videos are a big hit, we're very excited for everyone to see them," he said.

He also praised efforts by Highway Superintendent Dylan Casselman who he said has been a huge help in coming up with new ideas to attract more people to Massena.

Part of that plan involves Boutique Air, the Essential Air Service Provider operating at the Massena International Airport.

Meissner said officials with Boutique have sent numerous items for the sporting shows and tournaments. With air service playing a big role, Meissner said it opens up Massena to a whole new audience.

"At the last sports show we had a number of people, I can't tell you the number, but more than a handful of people that came in and they said, 'Oh, we had no idea you had an airport. If we could fly there in an hour and fly back,'" Meissner said.

Boutique has provided bags for shows, along with special travel rates for flights between Boston Logan Airport and Massena, a move that has increased fliers and attendance at shows, Meissner said.

Meissner said the collaboration with Boutique has been "a real highlight of the show," leading other, local businesses to begin advertising and sending materials.

He said in the end the goal is to drive as many people to the booth as possible, allowing he and McQuinn to speak with potential tourists who may come to the area.

"Once they come into the booth, they have a million questions and that's really encouraging to see. There is a big interest in the North Country and Massena in particular. We have, I think, the best smallmouth bass fishery in the world and word is getting out," he said.

## Vaping continues to be problem at school

MASSENA -- Vaping is a continuing problem at Massena Central School, something officials appear poised to tackle in the next capital project.

According to student ex-officio Isabel Beard, who is a student liaison to the board of education, students have raised concerns regarding vaping in bathrooms with more than one toilet.

She said vaping has been a consistent issue in larger bathrooms, leading some students to feel they appear associated with vaping despite not participating.

Board member Robert LeBlanc posed the question to Beard following her report to the board, asking for her input.

LeBlanc said he was aware of the ongoing issue and as the chair of the district's Facilities Committee was seeking solutions.

"When I asked Isabel for more details about the problematic corner bathrooms, I knew about the problems. I just wanted to know what

she was feeling about it and just make sure that there's no confusion because we know about the problem," he said.

School officials, including Superintendent Ron Burke, addressed the concerns students have raised regarding the corner bathrooms referred to as "gang-style" bathrooms due to having more than one toilet.

"What we're hearing from our students, as Isabel said, is because there's so much vaping that goes on, there's guilt by association. Especially if you're a student athlete, that becomes a real major issue," Burke said.

He said the concern extends to the entire student body, with many with a clean record saying they do not want to appear that they are vaping simply for using a bathroom where someone may be.

Burke said district officials hope to convert one boy's and one girl's bathroom into individualized restrooms, as opposed to the gang-style bathrooms, in order to provide more options for students.

He said that project would likely

be part of the next capital project, which voters will see on May 20.

As for the next capital project, Burke said the price tag currently sits at \$79.9 million, with the district expected to receive building aid to cover 97% of the project.

"I always want to put that caution out, though, that just because we have a 97% building aid ratio, that doesn't mean that's what we're actually going to get. There will be certain aspects of the project that are not going to be aidable," Burke said.

The project would require the district to utilize \$7 million from the capital reserve fund, something that would ensure no impact to taxpayers, he said.

The projects included would cover HVAC repairs and replacements for boilers, along with a steam pipe running to the high school, as well as new cooling units in certain areas of each school, roof replacements, ceiling replacements, new lighting, exterior toilets near grass athletic fields, as well as renovations to the girl's locker room and pool renovations.

## Grand jury hands down indictments for kidnapping, drug possession, strangulation

CANTON — A St. Lawrence County grand jury indicted a Rensselaer Falls man Thursday, March 4, on a kidnapping charge.

John Dobbs, 53, is accused of abducting a person and injuring a person by means of a deadly weapon on Feb. 27 in the Town of Morristown. He was indicted for second-degree kidnapping and second-degree assault.

In other grand jury action:

Christopher McGregor, 43 of 13 Bishop Ave., Massena, and Nancy

Perry, 39, of 221 Kingsley Road, Massena, were each indicted for first-degree criminal possession of a controlled substance, second-degree criminal possession of a controlled substance, and two counts of third-degree criminal possession of a controlled substance.

A traffic stop in the Village of Canton on Sept. 1 netted a street value of approximately \$180,000 of crystal methamphetamine and crack cocaine. The drugs seized were 47.6 ounces of crystal methamphetamine

and 40.6 ounces of crack/cocaine, according to Canton police.

Joseph Clement, 32, of 7854 Marshy Road, Harrisville, was indicted for second-degree strangulation, first-degree criminal contempt, and second-degree criminal mischief.

It is alleged Clement applied pressure to the throat or neck of an individual at which time violating an order of protection issued Oct. 13 in Town of Fowler Court. Clement is also accused of damaging property in an amount exceeding \$1,500.

# Strangulation, meth possession, burglary indictments handed down by grand jury

CANTON – A St. Lawrence County grand jury recently indicted a Potsdam man for allegedly choking and restraining an individual in the Town of Potsdam.

David F. Phillips, 44, of 5543 State Highway 56, was indicted on a felony count of second-degree strangulation, first-degree unlawful imprisonment, and fourth-degree criminal mischief.

It is alleged that on Feb. 11 Phillips applied pressure on the throat or neck of a person and prevented that person from communicating a request for emergency assistance.

In other grand jury action:

Courtney Barber, 22, an inmate in the St. Lawrence County Correctional Facility, and Donald Dobbs III, 27 of 1607 Jay St., Ogdensburg, were each charged with felony counts of second-degree criminal possession of a

controlled substance, felony counts of third-degree criminal possession of a controlled substance, two counts of criminal possession of a weapon, and seventh-degree criminal possession of a controlled substance. Dobbs was also indicted for second-degree obstructing governmental administration.

According to county court documents, Barber and Dobbs unlawfully possessed a stimulant weighing more than 10 grams on Aug. 30 in the City of Ogdensburg. They also possessed substances containing methamphetamine weighing more than one-eighth ounce with the intent to sell.

They were also found to be in possession of an electronic stun gun. Dobbs was also indicted for allegedly attempting to prevent a public servant from performing an official function

by means of intimidation, physical force or interference.

Jose Melendez, 37, an inmate in the St. Lawrence County Correctional Facility, was indicted on three counts of second-degree strangulation, a felony, third-degree assault, and second-degree unlawful imprisonment stemming from three alleged incidents in the Town of Colton.

It is alleged Melendez applied pressure to the throat or neck of an individual causing physical injury on July 10, Aug. 10 and Oct. 22.

Allyssa Moore, 29, an inmate in the St. Lawrence County Correctional Facility, was indicted for third-degree burglary and petit larceny. It is alleged Moore unlawfully entered a building on July 29 in the City of Ogdensburg with the intent to commit a crime and did steal property.

## Grant awarded to restore Old Town Hall

WADDINGTON – The Town Board of Waddington has been awarded a grant for more than \$5,500 for restoration of the Old Town Hall.

The Northern New York Community Foundation will make \$5,680 available to the town from the Rock Charitable Fund to assist the town in commissioning Crawford and Stearns, Architects and Preservation Planners, Syracuse New York, to conduct an analysis and review of the Old Town Hall in Waddington and prepare a

Building Conditions Assessment Report outlining their findings.

The Old Town Hall in Waddington was erected in 1884 and is an important local landmark of recognized architectural and historical significance and is listed on the National Register of Historic Places. This assessment report will focus on highlighting concerns related to the toll that time and severe north country winters have taken on the exterior stone, masonry, wooden windows,

and wooden trim of the building. The town then intends to use this report as supporting documentation for pursuing future grant applications that will hopefully assist the town in funding repairs to the building to restore it to its original glory.

### Firings in Washington a tragedy

I have little tolerance for waste, and less for fraudulent activities in the workplace. Today we are faced with a President and his DOGE "special government employee," Elon Musk, who claims they are committed to reducing waste and fraud in government agencies.

"No New York State agency shall hire or appoint any individual who was previously employed by the Department of Corrections and Community Supervision and thereafter separated from such employment in connection with such individuals participation with the illegal and unlawful strike," the order says.

She further states that the prohibition includes state positions and any civil service positions.

In addition, Hochul is barring local governments from appointing, transferring or promoting any individuals involved in the strike and suspending home rule legislations from stopping local governments from making their own determinations regarding hiring former officers who participated in the strikes.

Assemblyman Scott Gray said the executive order was "an egregious suspension of civil service laws and municipal home rule," a measure that undermines "long-standing legal protections for public employees."

"The executive order is in stark contrast to the Clean Slate legislation that allows criminal records to be sealed in order for convicted felons to gain employment—how is that for contrast?" he wrote.

Senator Mark Walczyk also called out the governor for the disaster emergency executive order, saying she is punishing officers for standing up against failed policies.

"Madam Governor, practice what you preach! Who is fighting for our correction officers' families? Your actions are fighting against them, making it nearly impossible for these brave individuals to provide for their families you swore to fight for. Depriving correctional officers of job opportunities and stripping their families of health insurance is the exact opposite of your promise," Walczyk said.

The harsh order followed news

from a press conference Monday evening, where DOCCS Commissioner Daniel F. Martuscello said the state would uphold several aspects of an agreement hashed out with the union on March 6, despite a failure to meet the 85% "return to work" threshold.

"After 22 days of an illegal strike, the governor and I are happy to report, it has now ended," he said.

"Officers and sergeants who did not have pre approved medical leave and did not return by this morning's 6:45 a.m. deadline have been terminated effective immediately," he said.

Hoping to limit the fallout and ensure safe staffing numbers could be met, Assemblyman Scott Gray issued a letter to Martuscello asking him for a 48-hour extension for officers to return to work, but that appears to have fallen on deaf ears.

Although there will be no disciplinary actions from DOCCS or the Union, penalties for violating the Taylor Law will remain in place, he said.

Despite firing more than 2,000, Martuscello told corrections officers they've been heard, but corrections officers who spoke to North Country This Week, who are now off work are unconvinced.

The strikes began three weeks ago on the heels of reports that several corrections officers were exposed to fentanyl and had to be treated with Narcan. Not long after corrections officers began to call for safer working conditions and a repeal of the HALT act, which limits the use of segregated confinement.

Corrections officers said the HALT act has created a dangerous environment for them and inmates alike.

Over the past three weeks several officers were hashed out between the union and state, but because the strike was not sanctioned by the union, NYS COPBA failed to deliver on its end of the signed agreements several times.

In the latest agreement the state offered a financial incentive for those who returned to work Sunday

and allowed a Monday deadline without the extra incentive.

The deal included a 90 day hold on the rehabilitative programming required for inmates by the HALT Act, and allows for additional inmate segregation when staffing levels are low.

The deal also includes a reversal of a policy that would have made 70% staffing levels the new 100% and include better inspections and screenings for mail and the use of body scanners on anyone who enters the facility.

A major sticking point in the negotiations appeared to center around health care.

Under the deal those who returned to work allowed officers to pay for COBRA health care to compensate for the lack of coverage that occurred when the state stripped striking officers of their healthcare benefits.

The state said it intended to follow through on those initiatives despite failing to meet the threshold, but offered no room for resolution for the more than 2,000 corrections officers who did not return to work.

Martuscello said that termination letters were already issued and that the campaign to hire corrections officers would begin soon.

In the meantime, he said National Guard members will continue to supplement the workforce.

In return the union agreed to withdraw a lawsuit it initiated regarding healthcare benefits.

Those striking over the past few weeks have seen a huge outpouring of community support with local restaurants providing food to the picketers.

The strikes have caused a major disruption in the prison system and led to the deployment of the National Guard to supplement under-staffed prisons.

During the strikes there were multiple prisons that lost control of inmates which led to the deployments of Corrections Emergency Response Teams to secure the facilities.

**ALCOA...**  
But Alcoa officials are not as optimistic, saying the tariffs would have a significant impact on American jobs.

"This is bad for the aluminum industry in the U.S. It's bad for American workers," Oplinger said.

Oplinger also said the tariffs would be enough to spur U.S. firms to hire more workers and boost production, something Oplinger said would not drive the company to produce more aluminum.

Oplinger said the tariffs alone would not be enough to tempt Alcoa into restarting some of its shuttered U.S. facilities.

"It's very hard to make an investment decision, even on something like a restart, without knowing how long the tariffs will last," Oplinger said during the webcast.

Part of the concern stems from downstream jobs, also called indirect jobs, and the impact tariffs could have.

For every Canadian aluminum production job impact, 13 American indirect jobs could be impacted, officials said.

That would mean significant economic consequences in the U.S.

Alcoa officials said they are making "real time decisions based on the information available," commenting the "deeply integrated supply chain from Canada into the United States" is a top concern at the moment.

The cost to tool up and produce more aluminum is also an issue, Alcoa officials said.

Alcoa officials said any tariffs would have "an immediate impact on pricing and supply," in turn affecting costs for consumers.

In the case of aluminum goods, like soda cans, those costs would be passed directly to the customer.

Alcoa officials have signaled support for supporting and growing manufacturing domestically, just not at the expense of the consumer.

Alcoa in particular have said they hope to continue to support growth efforts, bringing more good paying manufacturing jobs to the U.S.

But to make a large investment that would be billions of dollars while not seeing a return on investment for 10 to 15 years is difficult.

Alcoa officials have said it was their belief that competitively priced energy is the way to foster growth, including job creation.

In many cases, such operations have been established in areas with the most affordable power available given the creation of primary aluminum is a very energy intensive business, Alcoa officials said.

One bright spot to come from the bleak webcast was that Alcoa would consider boosting U.S. output if it had a cheap supply of power, something Massena has in spades.

Alcoa currently operates a plant in Massena, the oldest continually operating smelter in the world.

"Built in 1902, Massena Operations has a rich history of dedicated employees producing high-quality aluminum for the transportation, construction, defense and food industries. The plant has provided for families, served as a strategic partner to defense and aerospace industries and helped humankind explore the surface of the moon," Alcoa said on their website.

Another key issue hitting the sector right now is a supply issue, with primary aluminum in short supply for the current demand.

Alcoa officials have said replacement materials will play a key role in that, noting the demand curve has shown that a gap in the market exists. Companies from Europe, the Middle East, Asia and Canada as well typically fill that void, however tariffs could greatly impact that supply.

An economic impact study conducted prior to the 120th anniversary of the facility showed that the site's approximately 450 employees make a significant impact statewide in New York, with direct, indirect and induced effects contributing to more than \$150 million in payroll earnings, according to Alcoa.

But with the threat of tariffs looming and talk of lost jobs coming to the forefront, many are left to wonder what facilities would be impacted first.

According to documents obtained by North Country This Week, St. Lawrence County exports \$267 million in goods to Canada annually, \$75 million of which is aluminum. That represents the largest share of exports, followed closely by nonferrous metal products, which represents \$64 million.

Iron, steel and ferroalloys make up \$49 million, while metal ores account for \$24 million and pulp, paperboard and mill products round out the top-5 with \$16 million.

St. Lawrence County also exports \$35 million in services to Canada annually, with transport making up \$20 million.

As for goods exports by industry, minerals and metals account for \$221 million total, or 83% of all exports from the county.

Those figures have steadily risen since 2017, when total exports came in at \$170, eventually rising to \$301 million in 2022.

A total of 700 individuals are employed at the 19 Canadian-owned businesses operating in St. Lawrence County, with an additional 1,450 jobs that depend on goods and services exports to Canada.

Among the top Canadian-owned businesses operating in St. Lawrence County include Braebon Medical Corporation, Brookfield Properties, Canarm Ltd., Hewitt Environmental, JSI Telecom, Jmpower Aggregates, Liberty Utilities, Lower Gravelle Assoc., Marimac-Massena and Massena Terminal Railroad.



# DEC reports that 657 bears were harvested in the Northern Zone last fall

The New York State Department of Environmental Conservation (DEC) reports that 657 bears were taken in the Northern Zone during last hunting season.

Of those, 632 were taken in regular season, 15 with a bow and one was harvested by a youth hunter. DEC did not specify how many were taken in St. Lawrence County specifically.

In total, hunters in New York harvested a reported 1,685 bears during the 2024 hunting seasons. The 2024 bear harvest was 24 percent higher than 2023 and approximately 13 percent higher than the five- and 10-year averages.

"New York's healthy bear population continues to provide excellent hunting opportunities," said DEC Division of Fish and Wildlife Director Jacqueline Lendum. "Data collected and voluntarily submitted by hunters, taxidermists, and meat processors through the Black Bear Management Cooperator Program allows DEC to monitor trends to ensure the bear population remains robust and hunting traditions continue for the long term."

Wildlife Management Units (WMUs) within the Catskills and western Adirondacks continued to produce the highest bear harvest densities. In WMUs 3C, 3K, 3M, 4P, 4R, 4W, 4Z, 6C, 6H, and 8Y hunters harvested more than 10 bears per 100 square miles, with hunters taking more than 14 bears per 100 square miles in WMUs 3C and 6C.

Long-term trends in bear harvest density suggest that bear populations have stabilized in both the Northern and Southern Zones

following population expansions that contributed to peak bear harvest densities throughout the early 2000s.

Widespread drought conditions likely contributed to the elevated bear harvest during the 2024 seasons. During periods of drought,

natural food sources for bears can become scarce and bears may travel farther in search of food or congregate around available food sources. This can increase the likelihood that hunters will encounter bears.

Black bear harvest data are gathered from two main sources:

harvest reports required of all successful bear hunters and the physical examination of bears by DEC staff, cooperating taxidermists, and meat processors. Harvest estimates are made by cross-referencing these two data sources and determining the rate at which hunters report

their bear harvests in each zone. In fall 2025, DEC will send a commemorative 2024 Black Bear Management Coordinator Patch and a letter confirming each bear's age to all hunters who reported their bear harvest and submitted a tooth for age analysis.



### EVs emit more carbon dioxide during production

Consumers increasingly are turning to electric vehicles (EVs) because of their perceived benefits to the environment and additional perks.

The United States Environmental Protection Agency says EVs typically have smaller carbon footprints than gasoline cars, even when accounting for the electricity used for charging. In addition, EVs can be more efficient in regard to energy use.

However, it is important to note that mining the materials that are used in the batteries required for EVs can make the EV manufacturing process more energy-intensive than making internal combustion energy vehicles (ICE), according to Earth.org.

The Intergovernmental Panel on Climate Change says EVs and hybrid cars emit more carbon dioxide than traditional cars during production. The additional environmental cost of transporting these batteries also results in a higher carbon footprint than ICE vehicles.

However, the EPA points out that the greenhouse gas emissions associated with an EV over its lifetime are typically lower than those from an ICE vehicle, even when accounting for manufacturing.

## Clean vehicle interiors can improve your driving experience

A number of factors are involved in keeping a vehicle functioning and looking good.

Ensuring a vehicle interior is clean and tidy is easily overlooked, but such efforts can improve the driving experience.

Drivers who want their cars and trucks to look their best should not forget their vehicle interiors. Drivers unsure where to start can spruce up their vehicle interiors in the following ways.

### Remove any trash

Wrappers, receipts, empty water bottles, and other items can quickly pile up inside a car, especially for drivers who have young children. Routinely go through the vehicle to gather and remove debris.

### Vacuum the interior

Start off with a can of compressed air and blow out dust and any other dirt that has accumulated in tight crevices. Then use a high-powered vacuum to conduct a thorough cleaning. Pay attention to the seams of car seats, door handles, armrests, floor mats (and under them), underneath child safety seats, and the trunk or cargo area. If you don't have a vacuum with a lot of suction, utilize one at a do-it-yourself car wash location.

### Scrub the floor mats

Drivers with rubber mats can remove them and make a mild cleaning solution of a few drops of dish soap and warm water. Use a soft-

bristled brush to clean the mats. Upholstered mats can be shampooed using a carpet cleaner. Then rinse and hang to dry. All mats should be completely dry before being returned to the vehicle.

### Clean the upholstery

Seats can get dirty and dingy over time. For cloth vehicle seats, use a proper spray or foam upholstery cleaner. All-purpose cleaner can work on vinyl seats, but leather seats require a special leather soap and conditioner. Avoid products with silicone, which can stain your clothes and may make interior surfaces too slippery.

### Address glass surfaces

Turn your attention to the windshield, windows and mirrors. You can use a store-bought glass cleaner on these surfaces and a lint-free cloth. Avoid products containing ammonia, which may damage tinting on windows.

### Consider lingering odors

If the interior of the car has an odor, the cabin air filter may need to be changed, or there may be water entering the vehicle somewhere and creating a musty smell. Seek out any problems and address. A car air freshener can further improve the interior smell.

A thorough deep cleaning can be done at least once a month to keep a vehicle's interior fresh and clean.

However, keeping up with interior cleaning and maintenance by do-

ing small jobs regularly will reduce the need for routine deep cleaning.

## Various warning signs can indicate bad brakes

Each component of a vehicle performs an important function that ensures the car runs safely and soundly. A working brake system is vital to vehicle safety, so any issues affecting the brakes merit attention. Fortunately, there are various warning signs that indicate to vehicle owners it is time to replace brakes.

• Grinding sound: A deep grinding metal sound indicates that brakes are wearing down. Brake pads typically come equipped with tiny metal ridges on the bottom of the pads to alert the driver that the pads have worn down. Continuing to drive like this will put metal on metal, which can damage the rotors.

• Squealing sound: Some brake pads have built-in wear indicators. A driver may notice a squealing, screeching or whining noise when the brakes are engaged, says Bridgestone. Grinding or squealing often indicates that the brakes need to be replaced.

• Pulling to one side: When braking, drivers might notice the car pulling over to one side. This indicates brake pads are unevenly worn out, causing the car to pull to one side when braking.

• Visible wear and tear: A visual inspection of the brakes can give drivers an idea of their condition. If the pads are less than a quarter-inch thick, it is time to have them inspected or replaced.

• Brake pedal vibration: When brakes are working properly, the vehicle will smoothly slow to a stop. If the brakes are worn out or if the rotors are damaged, the break

pedal can vibrate and the car may even buck as it comes to a stop. This means the brakes and possibly the rotors will need to be changed.





BE IT ENACTED, by the Legislature of the County of St. Lawrence as follows:

**SECTION 1. LEGISLATIVE PURPOSE**

It is the desire of the St. Lawrence County Legislature, in its continuing efforts to upgrade and evolve the administration of St. Lawrence County government, to create the position of human Resources Director, pursuant to County Law § 400 to provide consistent application of a myriad of human resources elements.

**SECTION 2. DIRECTOR OF HUMAN RESOURCES**  
A. Department Head and Appointment. The Department of Human Resources shall be headed by and under the supervision of, the Director of Human Resources, who shall be appointed by the St. Lawrence County

Legislature for a term of the board.

B. Term. The term of the Director of Human Resources shall be four years.

C. Powers and Duties. The powers and duties of the Director of Human Resources is as follows:

1) Appoint, supervise, discipline and remove all employees of the Department of Human Resources, in accordance with applicable job classifications assign and reassign powers and duties to such employees, have charge and control of all employees of said Department of Human Resources; all in accordance with sound management principles, New York Civil Service Law, policies and/or directives of the County Legislature, and other administrative policies and procedures.

2) Provide management-level oversight to all human resources and personnel functions of the County.

3) Provide advice and counsel to the County Legislature and County Administrator on staffing needs and associated costs for optimal County operations.

4) Support County department/office heads on recruitment strategy and execution, hiring, onboarding and performance management of department hires.

5) Support the County Legislature, County Administrator, and County department/office leadership on formulation of labor relations strategy, contract negotiations and contract administration for collective bargaining units.

6) Evaluate County employee and administrative policies and procedures for compliance with state and federal regulations and County directives, and recommend updates as needed.

7) Administer compensation management for County non-union personnel.

8) Ensure a strong workplace culture for County employees.

9) Administer and coordinate the employee benefits and protection programs such as Health Insurance, Dental Insurance, Vision Insurance, Pension Plan, Deferred Compensation, Life Insurance, COBRA, flexible benefits, etc.

10) Acts as the Affirmative Action/Equal Employment Opportunity Officer on behalf of County government.

11) Have such other powers and perform such other duties as may now or hereafter be conferred or imposed upon him/her by resolution of the County Legislature or applicable law.

D. Minimum Qualifications. The Director of Human Resources shall meet or exceed the following qualifications:

1) Graduation from a regionally accredited or New York State registered college or university with a Bachelors degree and five (5) years of experience in human resource administration in a union environment two (2) years of which must have been in a supervisory or administrative capacity, OR

2) Graduation from a regionally accredited or New York State registered university with an Associates degree in Business Administration, Human Resources or related field and seven (7) years of experience in human resource administration in a union environment two (2) years of which must have been in a supervisory or administrative capacity

3) An equivalent combination of training and experience as defined by the limits of (a), (b), and (c) above

**SECTION 3. TRANSITION PROVISIONS**

Nothing herein shall be construed to impair in any manner the lawful administration of the New York Civil Service Law in St. Lawrence County.

**SECTION 4. REPEAL OF PRIOR ENACTMENTS**  
Any other prior enactments of the County Legislature, to the extent that they contradict the terms of this Local Law herein, are hereby repealed.

**SECTION 5. SEPARABILITY**

If any clause, sentence, paragraph, section or part of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been rendered.

**SECTION 6. EFFECTIVE DATE**

This Local Law shall take effect upon filing with the Secretary of State.




