Massena battling blighted properties

Abandoned properties targeted for safety

MASSENA -- Another abandoned property is causing issues in Massena, this time for the town code enforcement officer.

Code Enforcement Officer Patrick O'Brien updated town board members of issues with a property on North Raquette Road, which has been abandoned "for some time."

During the May board meeting, O'Brien told board members the property had received six different complaints in recent weeks.

But upon investigation, he was unable to immediately track down the owner.

Remnants of previous tenants were also left behind, including a yard full of garbage.

The issues were even larger than that, however, as the location did not have a real septic system, O'Brien said.

"As I was doing the inspection of that property, I also discovered that their septic system is literally just a PVC pipe coming out of the basement and into the ground, not even out into the ground, but on top of the ground. So, we're addressing that currently," he said.

At the Docks says hotel still on menu

Apartment project now priority due to grant

OGDENSBURG -- Owners of At the Docks LLC said a \$3.5 million grant from the state will help bring apartments to the city's waterfront, but that won't derail plans to bring a Wyndham Hotel to the area.

On Monday the At The Docks said they were grateful to city and state officials who helped secure a Restore NY grant.

"We're incredibly honored and excited to be chosen for this amazing grant award, which will play a big role in helping us move forward with the development of Ogdensburg's waterfront—a project that means so much to our city's future," a public statement from the company said.

Citizen Advocates faces lawsuit

Woman says she was fired for whistleblowing

OGDENSBURG -- A self-proclaimed whistleblower whose employment was terminated by Citizen Advocates for alleged HIPAA violations is now suing the non-profit organization for wrongful termination.

According to court documents obtained by North Country This Week, Brandi Lamay is taking legal action against Citizen Advocates, her employer from October 2021 through Nov. 10, 2023 for firing her for accessing patients' charts. In the filing, she says the termination was actually retaliatory after she raised concerns regarding improper activities by employees of the organization.

In the complaint, Lamay alleges in her role as an addiction counselor and Licensed Practical Nurse (LPN), she saw multiple patients who claimed therapy sessions listed on charts were never conducted.

The first complaint occurred around April or May 2022, when one patient said they had not gone through Credentialed Alcoholism and Substance Abuse Counselors therapy sessions "in several months."

Lamay alleges over the following months she spoke to several other patients, whom she was directly involved in the care of, with each stating they too had not received treatments listed on their respective medical charts.

She also claims the patients' medical records were not "accurately documenting decisions made by patients concerning treatment options."

Lamay said "many patients" complained they were not regularly receiving therapy or counseling sessions at the frequency their charts claimed, with some charts also "indicating in correction decisions that have been made by the respective patients

SLC Chamber brings back ambassador program in Massena

Director announces series of events, sponsors sought

MASSENA -- The St. Lawrence County Chamber of Commerce is relaunching an ambassadors program in Massena, welcoming businesses and officials to the community.

Dixon said the Chamber has a number of events planned for the summer as well, including the Dairy Festival, slated to run June 6 and 7.

To celebrate the occasion, Dairy Princess Isabella Perretta and alternate Dairy Princess Danica Dishaw.

Other ambassadors include alternate Dairy Princess Myrah Bullock, and promoters Grace MacDonald, Bella Dalton, Kathryn Fitzgerald, Ava Fitzgerald, Melanie Gilbert, Rose Smith, Norah MacDonald, Kenzie Phillips and Bailey Phillips.

Perretta and Dishaw both addressed the legislature, highlighting the key role dairy plays in healthy and active lifestyles.

Perretta said she and the dairy ambassadors have attended numerous events, including high school athletics and college hockey games to promote chocolate milk through the chocolate milk refuel program, highlighting the benefits of rehydrating and recovering with choco-

late milk after athletic events.

Perretta said she and ambassadors continue to work with families and athletes across the county through numerous events each year, while also highlighting the role of dairy farms in the region.

"We want to help share the message of nutrition, sustainability and hard working farmers behind every glass of milk," she said.

According to county officials, the U.S. Department of Agriculture (USDA) and Department of Health and Human Services released the Dietary Guidelines for Americans, which aimed to reinforce the importance of consuming three daily servings of dairy food like milk, yogurt and cheese.

Former scout leader convicted of child sex assault may appeal to Supreme Court

CANTON -- A former attorney and Boy Scout troop leader convicted of sexually assaulting a child during a Boy Scout camping trip in 2014 may take his appeal to the U.S. Supreme Court.

Michael Kelsey, who was convicted of sexual assault in 2016, is attempting to appeal his conviction in St. Lawrence County Court, striking at the very constitutionality of the court's decision.

Kelsey has long sought to overturn his conviction in 2016, which in turn would have allowed him to also have his name removed from the state sex offender registry.

He previously sought in forma pauperis status, which would have allowed for court filing fees to be waived.

But Kelsey argued the court gave "no advance notice" to the dismissal of his appeal, writing he only sought pauperis status and not a decision of his appeal in his previous filing.

"The Court's 2/20/25 dismissal should be set aside to allow argument on the appeal of the District Court's July 2024 granting of a motion to dismiss," Kelsey wrote in his filing.

Now, Kelsey may bring the matter to the U.S. Supreme Court, though the clock is ticking.

Kelsey has 60 days from the issuance of the 2nd Circuit's mandate to bring his appeal to the high court, though no indication has been made if he will do so.

Kelsey, who was also a Dutchess County legislator at the time of the initial allegations, was convicted of first-degree sexual abuse, first-degree attempted sexual abuse, forcible touching and two counts of endangering the welfare of a child in 2016.

Kelsey was attempting to strike at the constitutionality of his sex offender status, in particular the Corrections

Law that required him to be registered.

Kelsey was sentenced to an aggregate prison term of seven years to be followed by 10 years of post release supervision following his conviction.

The punishment issued in 2016 was then held up on an appeal, according to court documents.

Kelsey was released from prison in May 2022 but prior to his release, a risk assessment instrument was submitted by the Board of Examiners of Sex Offenders that classified him as a risk level two sex offender with a sexually violent offender designation.

Kelsey tried to reargue the designation but was denied "based on a failure to provide notice of motion to the People," according to court documents.

He also sought to require the St. Lawrence County District Attorney to destroy all copies of pre-sentence reports. Mary Rain was the district attorney during Kelsey's initial conviction.

Kelsey also sought monetary damages, punitive damages and \$10,000 for attorney's fees. Kelsey is representing himself in all court actions.

In other court actions, Kelsey sued County Court Judge Felix Catena, who presided over his trial, Kim Nethaway, the stenographer who transcribed the trial and former Chief Judge of the Court of Appeals Janet DiFiore, claiming that "various alleged deficiencies in the proceedings deprived him of due process and negativity impacted the appeal of his ensuing conviction."

Those actions were dismissed in State Supreme Court since Nethaway was not properly served notice and Catena was entitled to judicial immunity.

Christopher Sherman and Catena were both included in the dismissal issued by the Second Circuit on Feb. 20.

County officials long held that the county should be dismissed from any legal actions involving Kelsey, which was affirmed by the courts.

Schumer concerned with border traffic drop

Canadian border crossings have dropped 290,000 across all New York Ports of Entry last month, which equates to a 22% decrease, according to Senator Chuck Schumer.

In a release, Schumer said tariffs imposed by President Donald Trump have led to a "nose dive" in entries, which in turn is hurting the North Country economy as summer tourism efforts ramp up.

In St. Lawrence County, the Ogdensburg Port of Entry decreased from 43,945 crossing in April 2024 to just 31,857 crossings in April 2025. That represents a 27.51% decrease. In Massena, the Seaway Bridge was a much smaller decrease, down from 209,524 in April 2024 to 205,518 crossings in April 2025, a 1.91% decrease.

"Burning bridges and ruining

relationships with our closest ally and key trading partner, Canada, right when summer tourism season is arriving, is about as destructive as it gets. Upstate NY is on the frontlines of Trump's destructive tariff war, and this shocking new data shows our tourism economy is paying the price from Buffalo to Ogdensburg," said Schumer.

According to new data from CBP, Upstate NY & Canada saw approximately 1,017,500 border crossings in April, compared to 1,307,381 during the same month in 2024, a nearly 22% decrease across road and bridge crossings frequented by tourists, federal officials said. In response, Schumer has called upon House Republicans to "stand up for their constituents and Main Street small businesses - like hotels, restaurants and shops - and take up the resolution which has already passed the Senate to end this reckless, ill-conceived and harmful trade war with

Canada."

"This should be a bright red alarm for NY House Republicans who have stayed silent as Trump's reckless trade war has wreaked havoc in their districts. To add insult to injury, he makes absurd declarations on annexing our neighbors to the north, which only depresses travel to the U.S. and the purchase of American products," Schumer said.

According to a recent North Country Chamber of Commerce survey, 66% of businesses are already experiencing a dip in Canadian bookings, the statement said. Canada is the top source of international visitors to the U.S., with 20.4 million visits in 2024, generating \$20.5 billion in spending and supporting 140,000 American jobs, they continued. Schumer said if there were even a 10% reduction in Canadian travel, it could mean as much as \$2 billion in lost spending and 14,000 job losses across America.

Local dairy farms to get state taxpayer cash for modernization projects

Four St. Lawrence County farms are to be awarded part of about \$3.3 million in state grants to modernize their farm operations, announced the governor's office.

J&J Farms of Ogdensburg, River Breeze Dairy LLC in Chase Mills, Royal J. Acres LLC in Ogdensburg, and Stauffer Farms LLC in North Lawrence are among 15 North County farms the state says will receive grants.

The North Country farm awards are part of nearly \$21.6 million awarded to 103 farms across the state through the Dairy Modernization Grant Program to support New York's dairy industry, the press release from the governor's office said.

The state claims the funding, first announced in the Governor's 2024 State of the State address, will help New York's dairy farm-

ers and dairy cooperatives invest in new equipment, expand storage capacity, and strengthen their operations, particularly as they face extreme weather events, providing a critical boost to New York's dairy industry.

The state awarded eligible applicants for projects to expand on-farm milk storage capacity, and improve the transportation and storage of milk.

"New York's dairy industry is critical to the agricultural and economic health of our state," said New York State Farm Bureau President David Fisher, a Madrid farm owner. "The Dairy Modernization Grant Program is not only a significant step in improving operations for farmers across New York, but also in making a commitment to agricultural sustainability."

SLC legislature celebrates centenarian during June 2 meeting

CANTON -- Eloise June (Finley) Kroeger, a lifelong North Country resident, is celebrating a milestone birthday as she turns 100-years-old.

St. Lawrence County officials celebrated the occasion Monday at the full board meeting, with County Historian Nancy LaFaver detailing Kroeger's life.

Born June 3, 1925 to Arthur and Edith Edna (Beals) Finley, Eloise attended the Marshville/Heacher one-room schoolhouse in the hamlet of Marshville, near Hermon, until eighth grade.

Later attending high school in Hermon, Kroeger was the valedictorian of her class, though no yearbook exists, nor was prom held for her class due to WWII.

"She remembers having fun socially by going to square dances, she especially remembers a member of the band who had a crush on her and wrote a song for her to the tune of the Yellow Rose of Texas, the first stanza was, "There's a little girl in Marshville," LaFaver said.

Following graduation, Eloise went to live with her grandparents in Massena, working for Alcoa during the war. She would go to the facility each day with telegrams from customers who were looking for their shipments "as everything was always shipped late because the war orders were sent first," LaFaver said.

Enrolling in the Cadets Nursing Program for the US Department of Health in 1945, which ran through the state hospital in Ogdensburg, Eloise studied at the hospital during her first and third years, while spending year two conducting hands-on training in general nursing at the Morrisania Hospital in the Bronx. She graduated in 1947, once again as the valedictorian of her class.

With the war ending and the Cadet Nursing program coming to a close, Eloise later began working for the state hospital in Ogdensburg, eventually moving up to be the Supervisor of the Center East Building, LaFaver said.

She continued working there for 33 more years, retiring in 1983.

While working at the state hospital, Eloise met her future

husband William who was working in the kitchen after returning from his service as a pilot and navigator in the Naval Air Corp.

Despite asking Eloise to go on a date on multiple occasions, she refused each time until a friend of William's convinced Eloise he did not have a steady girlfriend, LaFaver said.

After marrying, the young couple moved into a house in Vets Village in Ogdensburg, which was government housing for WWII veterans returning home from the war.

They eventually settled on Hamilton Street, where they raised their seven children; William Arthur, Michael John, Gerald (Jerry), Margaret Louise, Ann Elizabeth, Kevin John, and Karen Sue.

"While working and raising their children, Eloise enjoyed belonging to clubs such as the Writers Club, North of Upstate, and doing things with her husband, who was a member of the Elks Club of Ogdensburg, and the American Legion in Lisbon. Eloise also enjoyed gardening, flowers, writing poetry, knitting, and spending time with family at their camp on the St. Lawrence River," LaFaver said.

The ever "spunky, strong-willed, intuitive and direct" Eloise now has nine grandchildren and six great-grandchildren.

Known to have a "heart bigger than the county she lives in," Eloise has been described as an honest woman with integrity, trustworthiness and strong work ethic that has made her a "role model, exhibiting strong moral character," LaFaver said.

In later life Eloise had one goal, to outlive the Queen of England, LaFaver said.

"Which she has. She states that the secret to a long life is to keep breathing and refuse to die," she continued.

Eloise has said her next goal and dream is to see her family all find happiness.

A neighbor of Chairman David Forsythe's wife when she was a child, the chairman offered his congratulations to Eloise and her family during the meeting.

"I simply want to say congratulations. This is a huge honor and I can't think of a better family to recognize this way," Forsythe said.

Troopers report that Foti was charged following investigation of a motor vehicle accident, which revealed that Foti

was allegedly driving while his ability was impaired by drugs.

Foti was found to possess cocaine and several containers with pills that were controlled substances, State Police say.

Foti was processed at the Ogdensburg State Police station, arraigned in Lisbon Town Court, and released.

Charged with menacing with knife

BRASHER— A Massena female who allegedly threatened a victim with a knife during a domestic incident was arrested by State Police.

Trisha M. Stevens, 41, was charged June 2 with one count each second-degree menacing and third-degree criminal trespass following an alleged domestic incident in the Brasher, during which a verbal argument reportedly escalated to physical threats.

As of the meeting, O'Brien said he was still working through who actually owned the property.

He said ensuring the records with the county are up to date is the first hurdle. Then finding an address to contact the owner would be next.

"Once we figure out who owns it, it's actually finding them because address information is pretty sketchy," he said.

O'Brien said he would continue to work with the county to identify the owner and further address the issues with the property.

In other news, O'Brien said a new issue arose with the former St. Lawrence Centre Mall, with lighting complaints reaching the office.

The location, now an industrial complex, has been dealing effectively with a myriad of code violations, O'Brien said.

"We received complaints that the mall lighting was ineffective for safety and too bright. We mention nuisance light in the code, as does the state, but there's really no definition," O'Brien said.

Despite having a light meter to determine the brightness of the lights, O'Brien said there is nothing specifically in state or local code.

O'Brien said he has reached out to the owners of the complex, who

were very receptive, and requested a contractor come back to the location to angle the lights down to address the issues in the meantime.

The change comes after O'Brien cited the complex for not having sufficient exterior lighting or parking lights. He said the structure is "pretty well lit up now."

concerning treatment options. In some cases, allegedly falsified charts showed a patient turned

down inpatient rehab when they, court documents state.

According to court documents, Lamay took the growing number of concerns to Clinic Manager Cynthia Mosher on or around Oct. 16, 2023 to detail the "numerous discrepancies she had discovered between what patients were telling her about their treatments and experiences, and what their respective medical records claimed about the treatments they were supposedly receiving."

Mosher then directed Lamay to bring the issue to the Human Resources Department, court documents state.

Lamay claims she contacted HR representative Bernadette Moore about the complaints on Oct. 23, 2023, not receiving a response.

Documents state on Oct. 24 Lamay spoke with Mosher again to follow up about her report to HR, to which Mosher allegedly said HR and upper management opted to "just re-train them" when referring to the counselors who made the entries at issue.

Lamay claims that based on the lack of response by HR and brief interaction with Mosher that no investigation would occur and no corrections would be made in good faith.

That in turn led Lamay to report her findings to the New York State Justice Center for the Protection of People with Special Needs, filing a report on Oct. 25, 2023 to raise concerns about Citizen Advocates practices, according to documents.

But that report to the Justice Center led to Citizen Advocates to "look for grounds to terminate" Lamay, the claim states.

Around the time of the report, Lamay said she received a text message from the Nursing team lead and her direct supervisor, Brittany Shorrette, informing Lamay that leadership with Citizen Advocates were "asking me to review your attendance and list of any call outs, late arrivals, etc" to establish ground for discipline and/or termination.

On or around Nov. 10, 2023, roughly two weeks after submitting complaints, Lamay was issued a "written warning" from Citizen Advocates, citing attendance and performance concerns, documents state.

Court documents state the warning, which was received Nov. 10, 2023, was backdated to August 22, 2023.

On Nov. 22, 2023 Lamay received a text message from Director of Nursing Jessica Foster, advising her "to not report to work for her 7 a.m. shift, but to instead come in at 9 a.m.," documents state. It was at this time Lamay knew her employment would be terminated, she claims.

During a telephone call with Jamie Tavineur, the Director of Nursing, Lamay was informed she was being terminated for HIPAA violations, documents state.

According to the complaint, Lamay was informed she "went in the charts...above and beyond in the

charts" when referring to patients' medical records Lamay reviewed in connection with bringing the internal and external complaints.

A written notice of termination was received Nov. 22, 2023, citing "a second HIPAA violation" but not further grounds for termination, according to the complaint.

Following the termination notice, Lamay said a complaint was filed against her by Citizen Advocates for "professional misconduct with the New York State Education Department," for which she received written notice from NYSED dated Feb. 27, 2024, advising her that it was investigating claims against her of professional misconduct.

Lamay alleges the complaint filed with NYSED was "based on its allegations that Plaintiff (Lamay) had committed HIPAA violations by reviewing patients' medical charts" in connection with the internal and external complaints files.

On May 1, 2024, NYSED informed Lamay she was cleared of any wrongdoing following their investigation and that the file was to be closed on the matter, according to the complaint.

Lamay alleges it was upon information and belief that Citizen Advocates did not file a report with any other state or federal agency, such as the U.S. Department of Health and Human Services or the Office of Civil Rights regarding the alleged HIPAA violations.

She also claims she did not commit any HIPAA violations in connection with reviewing her patients' medical charts and filing the complaints associated.

Due to this, Lamay alleges misconduct and false pre-textual reasons to establish grounds for termination, according to the complaint.

Lamay alleges the actions of Citizen Advocates are in direct retaliation for her actions in filing the complaints, a direct violation of New York State Labor laws and whistleblower protections.

As part of her complaint, Lamay is seeking a payment for all recoverable damages, including an injunction to "restrain continued violations" of multiple sections of state law, along with all available front pay, compensation for lost wages, benefits and other remuneration, payment of reasonable costs, disbursements and attorney's fees, along with "payment of a civil penalty in an amount not to exceed \$10,000 and/or all available punitive damages, if the violation is willful, malicious or wanton."

In February 2025 St. Lawrence County officials selected Citizen Advocates to replace Reachout for comprehensive crisis intervention and response services for the county.

Reachout, a Potsdam based firm that served the North Country since 1977, officially shuttered on Dec. 31, 2024 citing a lack of funding.

The organization has offered emergency mental health counseling to those in need with both paid staff and volunteers managing the phone hotlines.

In their place, Citizen Advocates were approved to receive \$150,000 in Opioid Settlement Funds to cover start-up costs in the county.

The comprehensive service plan will include a 24/7 mobile crisis response service where licensed and certified staff able to practice in New York State will provide intervention services.

Along with the crisis hotline, Citizen Advocates will also have an electronic health record and the ability to bill Medicaid Managed Care for both telephonic and mobile responses, an appropriate level of crisis follow-up services, and provide the current community provider, if indicated, documentation of the crisis contact the following day, officials said.





NOTICE OF SUBMISSION OF WATER QUALITY CERTIFICATION REQUEST

This notice announces that Rich Road Solar Energy Center, LLC (“the Applicant”), a wholly owned subsidiary of EDF Renewables Development, Inc. (“EDF”) filed a Joint Application for a Wetlands Permit, which included a request for a Water Quality Certification (WQC), with the U.S. Army Corps of Engineers (USACE) (collectively the “Joint Application”). The Joint Application will be filed with the New York State Office of Renewable Energy Siting and Transmission (ORES) on or about June 13, 2025. The Joint Application relates to the construction of the proposed 240-megawatt (MW) major solar electric generating facility along with a 20 MW battery energy storage system, to be located in the Town of Canton, St. Lawrence County, New York (“the Project”).

On September 24, 2024, the Applicant was issued a Siting Permit under Article VIII of the Public Service Law from ORES (Matter No. 22-02969). The Joint Application that is the subject of this notice covers the permits/approvals required to construct and/or operate the Project under the Clean Water Act 404 and for WQC from ORES under Clean Water Act 401 and 6 NYCRR Part 608. No public comment period is required for the Joint Application at this time.

The Joint Application includes, among other things: a description of the Project, including details on Project components, Project design, Project construction, and related information; an analysis of the environmental setting of the Project; results from analyses conducted to assess potential impacts to aquatic resources, streams and jurisdictional waters from construction and operation of the Project; proposed measures to minimize environmental impacts; and reasonable alternatives. The pending USACE application also addresses compliance with the Endangered Species Act and the Historic Preservation Act.

The Project’s environmental impacts are more fully described in the record before ORES under Article VIII; as relevant to the request for Water Quality Certification and USACE Application under review, the Joint Application for Permit will include detailed descriptions of impacts to wetlands and waterbodies, both temporary and permanent, as it relates to jurisdictional resources. In general, the project is anticipated to result in less than 0.5 acres of permanent federal wetland impacts and de minimus impacts to federally regulated streams resulting from the installation of permanent culverts for facility access roads. Additional temporary wetland impacts and permanent forest conversion impacts will be described in further detail in the Joint Application for Permit. 

Arthur John Quackenbush III, 77

Canton

Lawrence University and moved to Canton in 1987 to work in various administrative and athletic roles at

Canton Central Schools, where he remained for the duration of his career.

For most of those years, until his retirement in 2008, he was principal of J.M. McKenny Middle School. He was also a tireless and dedicated referee, coach, umpire,

and sideline official at countless sporting events for Canton teams, around St. Lawrence County, and across the region, including coaching his children's teams.

He was happiest with a whistle around his neck, surrounded by kids.

Art was a devoted and selfless member of the North Country community for 40 years.

A constant presence and gentle giant at school, he was known for wearing a tie that flapped in the breeze and a high-visibility neon baseball cap while directing bus traffic at dismissal; for rounding up winter coats, clothes, food, quarters for snacks, and other necessities for students in need; and for roaming the cafeteria at lunch to exact a "principal tax" on students (and his own kids) with lunchbox treats.

He once allowed his students to suspend him completely from a wall using only pieces of duct tape to encourage them to read.

Art was known for his use of singular adages known as "Art-isms," including, "Be careful what you wish for!" and, "So it goes..."

A quietly competitive golfer, he played every possible minute at courses across the North Country and beyond and was a fixture at Oliver D. Appleton Golf Course at St. Lawrence University.

In recent years, he befriended a kindergarten class at St. Catherine's (formerly St. Mary's) School and stopped for daily visits at the classroom window during walks with his golden retriever, Ginger.

He was a wonderful, fun-loving, dependable, generous, and easy-going friend to his fellow educators, referees, neighbors, golfers, and former students.

He also gave over 25 years of service to the Massena Volunteer Fire Department, where he proudly served as Fire Chief from 1995 to 1996.


Dick married his first wife, Verna Blais (Richardson), with whom he shared 23 years of marriage and raised six sons.



Man credits learning to parachute jump for saving his life

CANTON – The arrival of spring means we’re all spending more time outside and in some instances that involves climbing on ladders, using dangerous tools or even possibly using dangerous tools while climbing on ladders.

It was while trimming a tree when Craig Ballard, of Madrid took a fall that could have cost him his life. He said a limb from the tree he was cutting fell and inadvertently kicked the ladder out from under him.

“I went down while holding the chainsaw,” he said. “I was fortunate enough that I had my wits about me and enough to do what I needed to do to still be here.”

He attributes knowing what to do in that situation to something he learned while sport parachute jumping.

“I was able to position my body

and fall in a way that helped minimize the damage,” he said. “I really think that helped save my life.”

Even though he was able to ditch the chainsaw, Mr. Ballard did not escape uninjured. He broke both of his legs, as well as his left arm. The accident led to a lengthy hospital stay prior to another long stay at United Helpers Rehabilitation and Senior Care, where he was admitted into the rehabilitation unit.

“They certainly know what they’re doing,” he said referring to the therapy staff at United Helpers in Canton. “They were able to take a pretty big problem and make it a little more manageable.”

Mr. Ballard, who spent almost 45 years as a member of the Madrid Volunteer Rescue Squad, and another 13 years as a volunteer firefighter in Madrid, said he is not used to being the one on the

receiving end of assistance.

“I’m thankful for everyone who helped me out along the way. The first responders who came to the scene, the nurses and the doctors at the hospital, and the nurses and therapy staff here who have helped me get as close to where I would like to be as they could,” he said.

Mr. Ballard’s stay at United Helpers was 100 days, the most his insurance would cover. “While I do wish, I could have stayed a bit longer, I am certainly in a better spot now than I was when I got here.”

When Mr. Ballard arrived in Canton, he wasn’t going anywhere unless it was in his wheelchair. By the time he was discharged this past winter, Mr. Ballard was using a walker.

Warning signs for cataracts

Cataracts are a common and treatable vision problem. Access to cataract treatment is limited in various countries.


In fact, a 2021 study published in the journal *Lancet Global Health* found that 94 million people ages 50 and over have vision impairment or blindness that could be corrected through access to cataract surgery.

Surgery might not even be considered if people are not first aware of the symptoms of cataracts, which can manifest in various ways.

- **Blurry vision:** The American Academy of Ophthalmology notes that blurriness may be associated with an assortment of vision problems, including cataracts. Blurry vision makes it difficult to see clearly or sharply, and cataracts are characterized by cloudiness that affects the natural lens of the eye. The blurriness associated with cataracts is the result of a breakdown of proteins in the lens of the affected eye.
- **Seeing double:** Double vision

also is symptomatic of various vision issues, including cataracts. The AAO notes that when a person is seeing double, he or she may be seeing two, often overlapping, images of a single object.

- **Sensitivity to light:** The AAO notes a need to shield eyes from light to prevent eye pain could indicate a sensitivity to light that is characteristic of cataracts. This sensitivity may be especially noticeable when confronted by headlights at night.
- **Difficulty seeing at night:** The AAO reports that this symptom is often characterized by difficulty seeing in dark conditions that can make it harder to adjust to seeing when going from a well-lit space into darkness. That adjustment also may take longer in people experiencing cataracts. Some people may not be able to see at all in dimly lit conditions.
- **Seeing faded colors:** Bright colors that appear faded or yellow is another symptom of cataracts.

How to make your mental health matter

Mental health is now discussed more openly than it once was. Mental illness or issues that affected mental health used to be stigmatized, and many people suffered in silence and might not have gotten the help they needed.

The National Institute of Mental Health reports more than one in five adults in the United States lives with a mental illness. Mental illnesses include many different conditions that may vary in degree of severity, from very mild to severe.

The NIMH notes self-care plays a significant role in maintaining mental health and supporting recovery. People can safeguard their mental health in many ways.

- Spend time in nature. Nature can have a calming effect on people. Going for a walk can help tame stress and break patterns of negative thinking. In Japan, the concept of forest bathing is said to improve mental health. Forest bathing involves spending time in a forest or another green area experiencing the different sounds, sights and smells that nature offers.

- Set boundaries. B2B Reviews says 12 percent of U.S. workers were fully remote in August 2023. Estimates suggest that number may have increased to around 14 percent by 2025. Working from home can make it more challenging to set firm divisions on time spent working and for home life.

Establishing boundaries means not being available 24/7 for calls or emails and not feeling guilty about taking time away from work.

- Get regular exercise. Just 30 minutes of exercise each day can get feel-good endorphins flowing through the body to boost mood and bodily health.

- Get more sleep. Adults generally need between seven and nine hours of sleep for optimal health and reaching deep sleep phases, says the Mental Health Foundation. Creating consistent sleep routines can help improve sleep.

- Try relaxing activities. Relaxing activities can include reading, listening to music, meditation, or low-stress crafts and hobbies.

- Socialize with others. Socialization provides opportunities to see others and talk about anything you want to get off your chest. People feeling stress or anxiety might think they are alone. But having conversations with others can illustrate that these are common problems and there are solutions. Sometimes just talking about an issue can help you overcome it.

- Use your vacation time. Too many people are not using enough of their deserved and accrued time off. A survey from the financial services company Sorbet found that 62 percent of Americans don't use all of their paid time off. Failure to take time off is a recipe for burnout.

Meeting your dairy needs

Drinking milk is a common way to meet daily dairy needs for a healthy diet. Milk provides 13 essential nutrients, including vitamin D and calcium, which help build strong bones and reduce the risk of osteoporosis. It also contains vitamins A and B, potassium, and protein, which support overall health, including strong teeth and a healthy immune system.

According to the USDA, dairy intake recommendations vary based on age, gender, and other factors.

Generally, children need 1 to 2.5 cups of dairy per day, while adults benefit from about 3 cups. One cup equals 8 ounces. Health experts recommend choosing nonfat or low-fat options to reduce saturated fat, which can raise cholesterol and increase heart disease risk.

If drinking milk isn't appealing, it can be added to smoothies or recipes. Cheese and yogurt also count—8 ounces of yogurt or 1.5 ounces of hard cheese equals one cup of milk. Lactose-free options are available.




