Four Corners area improving, still wary of COVID increase

While Seward County's COVID-19 case numbers have plateaued, Laura McDougall of Four Corners Health Department said that's better than seeing them go back up.

"We are still at a significant level of community transmission," she said during the Four Corners briefing Jan. 7. "It's still more than we want."

Over the previous seven days, Seward County reported 63 new cases, down from its height of over 100, she said.

The district is distributing the COVID-19 vaccine to the seven health care facilities in the district, McDougall said. That includes Memorial Health Care Systems in Seward.

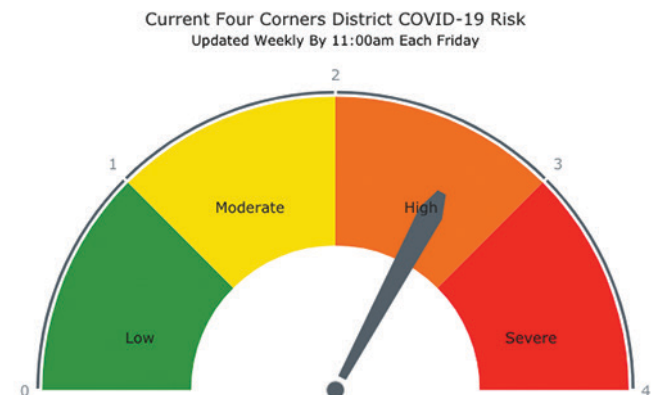
Four Corners received 1,300 doses of the Moderna vaccine to share among the four counties.

"As soon as we get it, it's out the door and in arms," McDougall said.

Phase 1A is health care workers and priority groups, she said. The hope was to finish the first round of that phase of vaccinations within the next week.

It takes a couple weeks for the vaccine to start to kick in, she said. At that point, a person has 50-60% protection. The second dose is given 21-28 days after the first dose. The second dose boosts immunization to 95%.

"We still recommend masks and social distancing," McDougall



said.

If a person has already had COVID-19, they wouldn't need a vaccine for at least three months, she said. If someone has used the new infusion treatment, they should wait at least 90 days before being vaccinated.

Once Phase 1A is done, Phase 1B steps up. Those are people age 75 and older. McDougall estimated at least 3,000 people within the district in this tier.

"We have a lot of vaccinating to do," she said.

Those in the second tier will be contacted by their healthcare provider to schedule a vaccine, McDougall said.

Dr. Josh Fields, superintendent of Seward Public Schools, said they have surveyed their staff and found about 72% want a vaccine when it's available.

Mallory Gibreal of Memorial Health Care Systems said they've been getting a lot of calls about the vaccine.

Roger Reamer, CEO of MHCS, said they're trying not to waste doses. Once a dose is open, it's only good for about six hours, he said.

MHCS hosted a vaccination clinic Jan. 6 and gave 350 doses, he said.

Testing numbers have leveled off, with the hospital testing about 50 a week and Test Nebraska doing about 100 tests a week.

A new treatment, monochromal antibody infusion, is also available now. MHCS has two week's worth of treatments that are managed through the University of Nebraska Medical Center and the state of Nebraska.

The process takes about two and a half hours. On Dec. 7, MHCS received its first allotment and treated 45 people, Reamer said.

During the sector reports, David Kumm of Concordia University said students were to come back over the weekend. CU plans to continue with its protocols.

"We will play it conservative for January," he said.

The university plans to follow its traditional schedule with its regular breaks.

"No breaks was really hard on everyone," he said.

Sixpence hosts diaper drive

According to the National Diaper Bank, one in every three families in the United States can't afford enough diapers to keep their children both clean and healthy as they grow, and that was before the coronavirus pandemic.

Not enough diapers mean babies can sit in dirty diapers for much longer than needed as some parents choose to provide either food or diapers for their children.

Katie Langner and Morgan Kozisek of ESU 6's Sixpence are looking to change that for Seward County and its surrounding communities with their "52 Weeks of Diapers" campaign happening throughout 2021.

Sixpence is a nonprofit with the goal of providing help and services to parents of children ages 0-3.

"We've been thinking of this for a while, but with COVID, we've really seen the need of these families," Langner said.

“We’ve seen things being taken away and parents really struggling.”
So for 52 straight weeks, a diaper pantry established by Sixpence will take place.
For a week, local businesses in Seward, Milford and Utica can host a diaper collection at their location. At week’s end, Langner and Kozisek will collect the donations and distribute the diapers to families once a month, or as needed.
So far, six local businesses including ESU 6, Seward Public Schools and Awe Salon have signed up to host.
Community members can get involved by bringing in packages or wipes or donating money for the Sixpence group to buy supplies.
The duo will send out a notice on Seward Community Chat on what business is hosting the diaper drive week by week.
Sixpence’s goal by year’s end is 75,000, and they will be keeping track of how much is gathered at each business that hosts.
For those who are interested in receiving diapers and supplies, the Sixpence group asks an appointment be made by calling or texting Langner at (402) 641-4998 or Kozisek at (402) 587-1454.
This is open to anyone in Seward or its surrounding areas. Appointments for picking up diapers will begin Feb. 1.
Sixpence hopes to continue a diaper drive collection in October, Diaper Awareness Month, to stock for families who may be in need in the future.
“Diapers and wipes are expensive, and we just don’t want kids to suffer,” Kozisek said. “We want to do more, do better for the community.”

BVCA launches telehealth program

Blue Valley Community Action Partnership now offers free access to telehealth services in Seward, Butler, Fillmore, Gage, Jefferson, Polk, Saline, Thayer and York counties.
This new program is funded by the CARES Act and was created to address some of the more pressing issues created by the Covid-19 pandemic. A survey BVCA circulated to clients and the general public in 2020 indicated many people in BVCA’s service area could not utilize remote medical or mental healthcare due to a lack of technology and/or internet access.
BVCA’s telehealth program will loan clients a Chromebook or tablet for the purpose of online medical appointments. If the client does not have internet access at home, BVCA will provide a private, comfortable space at one of its facilities. Each Family and Community Services office now has a station with a laptop and scanner clients can use, as well as an internet connection. Clients will still be billed by their healthcare providers, but there is no cost to rent or use BVCA’s equipment.
BVCA’s survey also indicated the pandemic contributed to a stark increase of feelings of depression and hopelessness. The organization will work with partner agencies to provide mental telehealth services at reduced or no cost to the client.

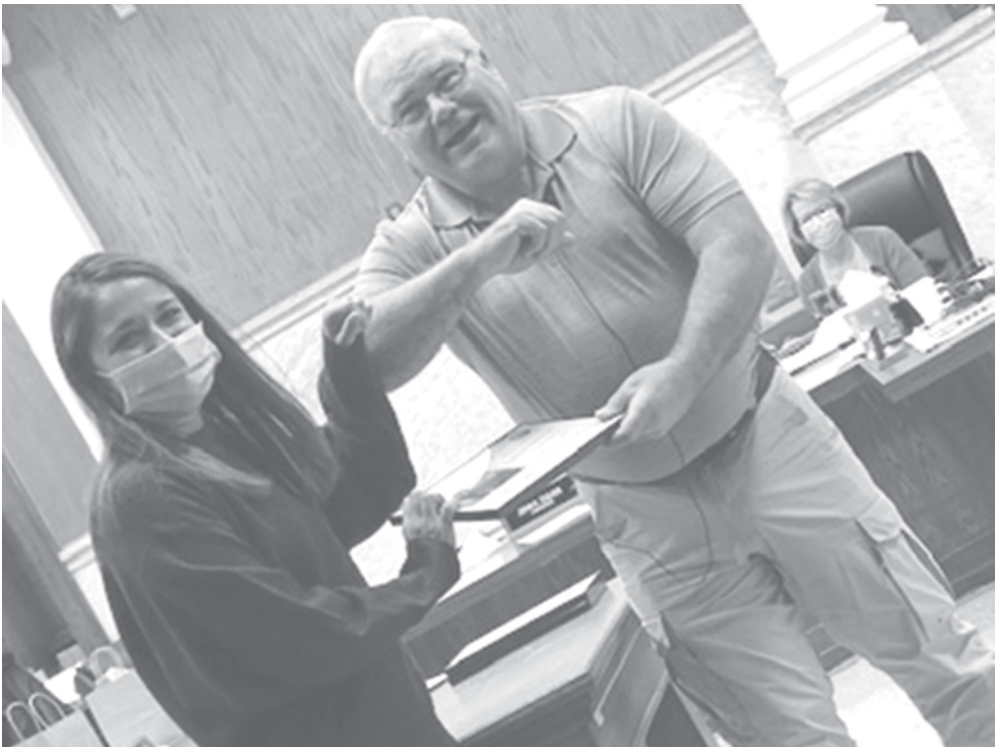

Severity hits close to home

This week I have to steer away from my lighthearted columns, which I write purposefully.

They help break up the seriousness of things going on in the world and I write them with that intent.

I know that everyone is tired of reading the word COVID everywhere you look, trust me, I am too. But, this week, I feel I need to share.

I was not unaware of the seriousness of COVID, but the severity only really hit me after I said the words, "my family really hasn't been majorly affected by COVID." I should have knocked on wood because not even two hours after uttering those words I got a call that completely changed my view on COVID and made it that much more real.

"Your dad has a major blood clot in his leg and smaller ones in his lungs," my mother told me over a phone call while I was at work.

This diagnosis came after he was diagnosed with COVID-19 earlier this year and pneumonia a few months later.

He would be put on blood thinners for the next six months, my mom told me.

Exactly one week later I got another message while I was working.

"Hey kid. Sounds like we are going to Norfolk with your dad. He's got fluid in his right lung and some bleeding that they want to drain," my mom's message read.

We are lucky this was all caught in time

but doesn't make it any easier. We were told if we would have waited even a day longer we may not have gotten the same outcome.

Fortunately, I was able to sneak away from Crete to go see him last week, but when I walked in I was face-to-face with something I never thought I would see – my dad in pain.

Let me put this in perspective. My dad is the kind of man who can almost cut his finger off chopping wood, duct tape it together and keep working. He dealt with severe knee pain for years while he was working laying flooring. He was even back to carrying in wood the day after he was diagnosed with pneumonia (against what we told him to do - rest). This man avoids the doctor like the plague, no pun intended.

It wasn't until I was sitting with him after he got his second chest tube put in that it really hit me, and I think that is how a lot of people are. They know it's bad but it hasn't impacted them close enough to really understand.

While he is doing better now, there was always the chance he

wouldn't and that's incredibly scary. And to know COVID was the thing that landed him in the hospital makes it even more real.

COVID is more than losing smell and taste. It affects people differently, but for some it really takes a toll, sometimes even a life. It's not just COVID and done, sometimes it causes a ball to roll of medical complications.

COVID doesn't just impact that singular person. It impacts the wife who takes off work to stay in the hospital. It impacts the son who has to take care of the house while the parents are gone. It impacts the daughter who has to take off work to help her brother. It impacts the employers who are missing those employees.

I won't be naïve enough to think everyone who reads this will now take extra precautions because of this column, but I hope it shares the message that this is real and important.

Please continue to wear your mask and listen to the medical staff who are seeing this each and every day.

Anyway, all of this is to say that this year's goal is to not compare myself to others reading habits or be hard on myself for goals not met.

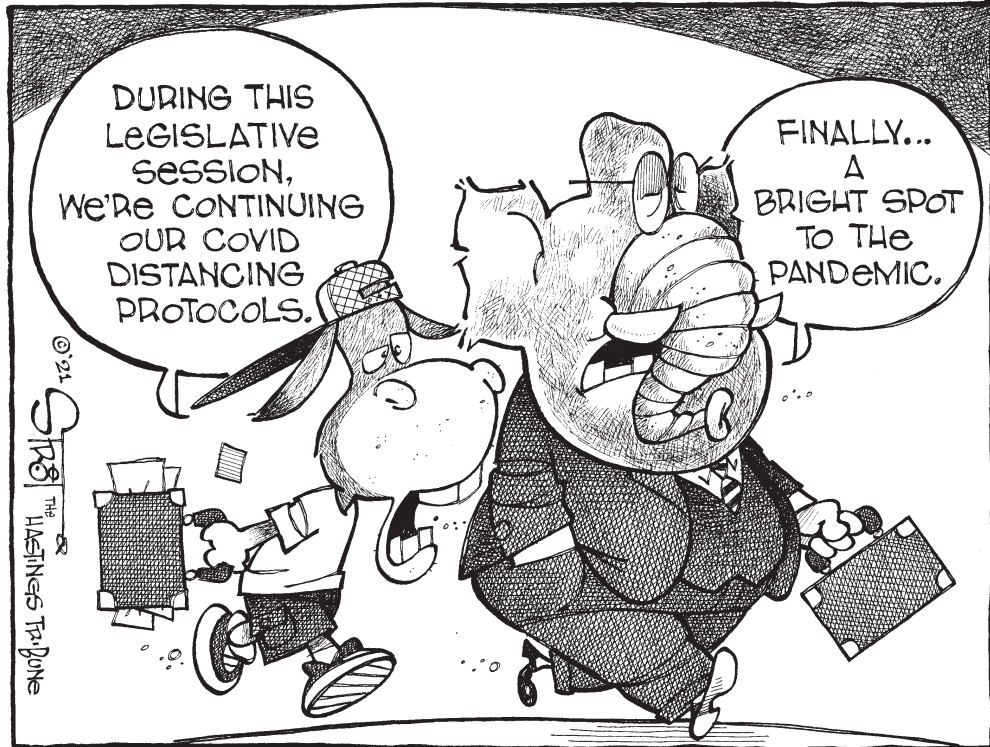
At this point, I think we all need a break and realize we aren't invincible, and things may no longer be expected of us that perhaps once were.

Milford goes 7-2 in duals; senior hits 150

After the five-day moratorium, the Milford wrestlers came back to practice but couldn't wrestle a competition until Jan. 8 when they were at the Wilber-Clatonia Duals.

MHS finished the day 5-0 and saw senior Konner Schluckebier hit the 150-win milestone.

The Eagles wrestled conference foe Wilber-Clatonia in the first dual and set the tone with a 45-27 win.

"Dual tournaments

are fun but you have to be ready to go right away. You may have your toughest match of the night right away unlike an individual tournament where you work your way to the finals match," Coach Joe Schluckebier said.

The dual against the Wolverines was the first time Milford had beaten WCHS in a dual in recent memory, the coach said.

Milford beat Wakefield 69-6 and edged Logan View 40-34. Coach Schluckebier said the

dual was tied going into the last match. Carter Springer pinned his opponent to give the Eagles the 40-34 win.

Milford also beat Bishop Neumann 61-10 and Norfolk Catholic 69-0.

The tournament win was the fourth of the season for Milford, setting a new school record.

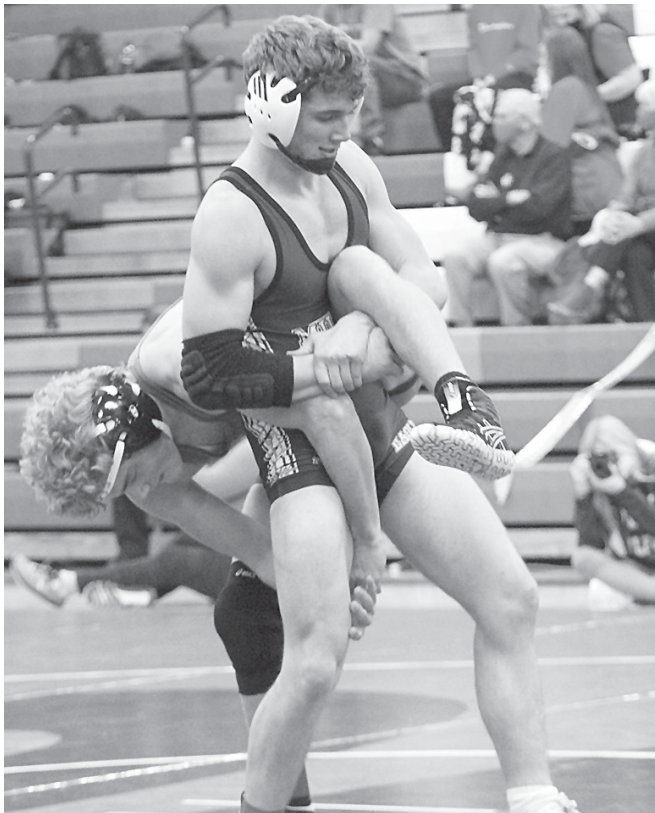
The Eagles got up Saturday morning and hit the road to David City Aquinas for another dual tournament.

Milford drew Aquinas, the defending state dual champions, in the first round and lost 42-27. MHS came back to beat Conestoga 67-6 and Blair, ranked No. 3 in Class B, 45-29. In the third-place dual, Milford ran out of steam against David City and lost 45-31.

"We need to work on finishing the job, but it doesn't take away from the previous eight duals where we really performed better than I would have predicted," Coach Schluckebier said. "We beat teams ranked B#3, C#4, C#9 and C#10 and beat multiple individually ranked opponents."

The Eagles will close their dual season Thursday, Jan. 14, in a triangular at York with YHS and Cross County-Osceola. The team is scheduled to wrestle at Arlington Saturday, Jan. 16.
