Emergency Sensory Kits Donation to Sauk Rapids Police Department-Mayor Hunstiger introduced Assistant Chief of Police, Brent Bukowski, and Police Officer, Masen Barton, who discussed how the sensory kits that were donated to the Sauk Rapids Police Department from Rinke Noonan work. The kits are intended to enhance the ability to serve those with autism in the time of a crisis.

Officer Barton and Assistant Police Chief Bukowski explained that it is their goal to have a sensory kit in each of the police department's marked squad cars. Bukowski pointed out that the Sauk Rapids Police Department also requires more training in responding to calls involving individuals with autism than what is mandated through new police re-

Officer Barton shared a personal experience that he recently had in responding to a situation involving a person who had autism and was non-verbal. He said that following this experience, he brainstormed and researched ways in which to better equip officers in responding to these types of situations. Officer Barton noted that he wanted to be able to have more tools available to not only help officers, but he also wanted to better help people with autism or who are non-verbal when they are in a high stress/emergency situation. He explained that he was able to find the sensory kits that Rinke Noonan helped the department to purchase on the Bit of Grace website

Nelson explained that the new Southside Lift Station has been a huge time saver for the utilities department with the need to pull pumps going from five times a week to once a year.

Vision Next 2040 Comprehensive Plan Open House Todd Schultz stated that the City of Sauk Rapids will be holding an open house on December 19th from 4:00pm to 6:00pm to answer questions related to the new Comprehensive Plan entitled "Vision Next 2040 Comprehensive Plan". The open house will take place at the Sauk Rapids Government Center.

Schultz stated that the meeting has been advertised in the Sauk Rapids Herald and posted appropriately. Partners and townships have also been invited.

C. 220 2nd Ave North Property

Todd Schultz advised the City Council that the EDA officially purchased the home at 220 2nd Ave North, which is near Rock Creek Coffee. This home will be demolished once the previous owners move out.

A. Thank You-Councilperson Sauer extended a thank you to the city staff, organizers, and volunteers of the Jingle & Mingle event this past weekend. He stated that although the weather wasn't ideal, the participants appeared to appreciate and enjoy the planned events.
