## PUBLIC NOTICES


Re: Notice of Benton Solar, LLC's Filing of a Route Permit Application and a Joint Site Permit Application with the Minnesota Public Utilities Commission (MPUC Docket Numbers: IP7115/GS-23-423; IP7115/ESS-24-283; IP7115/TL-23-425).

On September 24, 2024, Benton Solar, LLC ("Benton Solar") filed both a Route Permit Application and a Joint Site Permit Application (collectively, "Applications") with the Minnesota Public Utilities Commission ("Commission") to construct and operate a 100-megawatt ("MW") alternating current ("AC") nameplate capacity solar energy conversion facility, a 100-MW AC battery energy storage system, and an approximately 0.5-mile 115 kilovolt ("kV") high-voltage transmission line that will interconnect the solar facility and battery to the electric grid in Benton County ("Project"). This notice provides information on the Project and the siting process, as well as how to register your name with the Commission on the Project contact list, which will ensure that you receive future notices about the Project.

**Project Description** 

Benton Solar proposes to construct the Project in Minden Township, Benton County, Minnesota. The Project site encompasses an approximately 951.4-acre area and is located entirely on privately owned land for which Benton Solar has secured control through voluntary agreements. Of that larger site, approximately 631.9 acres are planned to be used for solar panels and racking, inverters, security fencing, a substation, electrical collection and communication lines, stormwater basins, laydown areas, access roads, weather stations, and the battery energy storage system. Benton Solar also proposes to construct an approximately 0.5-mile-long 115 kV transmission line to deliver energy from the Project to the electric grid via Great River Energy's ("GRE") Benton County Substation. The Project route, as depicted on the accompanying map, is approximately 48.3 acres and the Project right-of-way is approximately 6.2 acres.

The accompanying map outlines the location of the proposed Project.
