AN ORDINANCE ESTABLISHING CHARGES FOR FIRE AND EMERGENCY RESPONSE SERVICES

The Board of Supervisors of Langola Township, Benton County, Minnesota ordains:

Section 1: Purposes and Intent

This ordinance is adopted for the purpose of authorizing Langola Township (the "Town") to charge for Fire and Emergency Services as authorized by Minn. Statutes §§ 366.011 and 366.012.

Section 2: Definitions

1. "Fire and Emergency Services" means any deployment of firefighting personnel, emergency medical personnel and/ or equipment to extinguish a fire or perform any preventative measure to protect equipment, life, or property in an area threatened by fire, or to provide fire suppression, rescue, extrication, medical, and any other services related to fire and rescue as may occasionally occur.

2. "Service Charge" means the charge imposed by the Town for receiving Fire and Emergency Services.

3. "Fire Protection Contract" means a contract between the Town and another jurisdiction which provides Fire and Emergency Services.

Section 3: Parties Affected

Persons or entities that utilize Fire and Emergency Services within the Town, regardless of residence.

Section 4: Rates 1. Residents of the Town who receive Fire and Emergency Services will be billed 100% of the amount charged to the Town by the Fire and Emergency Services provider pursuant to the Fire Protection Contract. In the event the charges must be sent to collections or certified to the resident's property taxes because of non-payment, the resident will forfeit the resident discount previously applied to the invoice. Interest will be applied to the original amount of the invoice prior to discount.

2. Non-residents of the Town who receive Fire and Emergency Services will be billed 100% of the amount charged to the Town by the Fire and Emergency Services provider pursuant to the Fire Protection Contract.

Section 5: Fire and Emergency Service Charges in

<u>General</u>

1. The Collection of Fire and Emergency Service response charges shall be pursuant to Minnesota Statute § 366.011 and any other applicable statute. Collection of unpaid service charges shall be as authorized in Minnesota Statute § 366.012 and any other applicable statute.

2. Parties requesting Fire and Emergency Services, parties receiving Fire and Emergency services, and owners of property upon which Fire and Emergency Services are performed may be billed directly by the Town if such Fire and Emergency Services are provided pursuant to the Fire Pro-tection Contract. If Fire Department personnel deem a fire or other emergency exists, even if the parties did not request services, the parties will be charged and billed.

3. When a particular service rendered by the Fire and Emergency Services provider directly benefits more than one

Environmental Review – Public Notice

The City of Sauk Rapids is requesting public comments on the potential environmental impact of the construction of the PFAS TP Upgraded and New Wells.

The City of Sauk Rapids is proposing the addition of a common well house, two new wells, upsizing/improvement of approximately 750 LF of raw watermain, and Water Treatment Plant (WTP) capacity increase to reduce PFAS levels present in the water treatment system.

A common well house is proposed to be added to provide preliminary treatment for existing Wells No. 6 and 7, as well as the proposed Wells No. 8 and 9. This new well house, a 30-ft by 30-ft concrete masonry building, will be equipped to house flow meters, SCADA controls, electrical control equipment, and chemical storage and injection systems.

Proposed wells No. 8 and 9 will be situated in the same city owned area as Wells No. 6 and 7 and will be outfitted with submersible pumps and pitless units, with site piping connecting them to the new proposed well house. This work is essential to provide the additional flow needed to serve the City without requiring PFAS treatment.

The watermain along River Avenue, which links the wellfield to the Water Treatment Plant (WTP), needs to be enlarged from 10-inch to 16-inch to handle the increased flow from Wells No. 8 and 9. The upgrades will also include installation of 4 hydrants for flushing points on the raw watermain. This project will be conducted within the current watermain easement.

The improvements at the WTP are confined to the existing footprint of the building. These enhancements include the removal and replacement of four existing flow meters, the addition of a ladder to the filter cells, the replacement of four valve actuators, the relocation of two backwash valves, and the replacement of the potassium permanganate feed system with liquid sodium permanganate system.

The City intends to finance the project with a low interest loan from the Minnesota Public Facilities Authority's drinking water revolving fund. To receive this loan, an environmental review must be conducted in accordance with the National Environmental Policy Act of 1969.

person or property, the owner of each property so benefited, and each person or entity so benefited (where the property protection only is not involved) shall be liable for the payment of a proportionate share of the full charge for such service as outlined herein.

4. All parties will be billed whether the Fire and Emergency Servies are covered by insurance. Any billable amount of the service charge not covered by a parties' insurance remains a debt of the party billed for such Fire and Emergency services

5. Parties receiving an invoice for Fire and Emergency Services will have 30 days to pay. If the invoice is not paid within that period, the invoice will be considered delinquent, and interest will accrue at a rate of 1.5% per month.

6. If the Fire and Emergency Service charge remains unpaid for 30 days after the notice of delinquency is sent, the Town Board may, in addition to any remedies available under Minnesota law, on or before November 15 of each year, certify the unpaid Fire and Emergency Services charge to the County Auditor of the county in which the delinquent party owns real property for collection with property taxes levied against the property pursuant to Minnesota Statutes §§ 366.011 and 366.012. The County Auditor shall be responsible for remitting to the Town all charges and service charges collected on behalf of the Town. The Town must give the property owner written notice of its intent to certify the unpaid service charge to the Auditor by October 15. The service charge shall be subject to the same penalties, interest, and other conditions provided for the collection of property taxes.

7. The parties receiving the service shall be liable for all collection costs incurred by the Township including, but not limited to, administrative costs, attorneys' fees, recording fees, and court costs.

8. Any party aggrieved by a charge authorized in this ordinance may appeal the charge as follows:

a. Within the period for which a bill is payable, the party shall file a written request with the Town Clerk setting forth specific reasons why the charge is improper.

b. The Clerk shall notify the aggrieved party, in writing, of the time, place, and date the Town Board will hold a hearing on the issue.

c. The Town Board may grant relief on appeal if it finds proof to satisf

d. The Town Board may extend the time for payment for at law or otherwise to recover FROM a reasonable period.

Section 6: Application to Collections to Budget

All Fire and Emergency Services charges collected will be Town funds and used to offset the expenses of the Town in contracting for Fire and Emergency Services.

Section 7: Effective Date

This Ordinance shall become effective and enforceable upon its publication in the Town's official newspaper.

Section 8: Severability

If any portion of this Ordinance is found unconstitutional or otherwise invalid by a court of proper jurisdiction, all remaining provisions shall remain in effect and shall not be affected by the ruling on the invalid section.

Motion by Johnson and seconded by Heinen to approve the amended agenda. Motion carried unanimously.

There was no one present from the public to speak under Open Forum.

Motion by Gapinski and seconded by Johnson to approve Consent Agenda items 1 -8: 1) approve the Regular Meeting Minutes of December 17, 2024 and authorize the Chair to sign; 2) approve the Memorandum of Agreement with Law Labor Enforcement Labor Services, Inc. representing Detenion Officers and Dispatchers in the Sheriff's Office to implement the 2024-2026 Class and Comp Maintenance Program Recommendations. Year 1 and authorize the Chair to sign; 3) accept and file the County Administrator's Report; approve the contract for outside Labor Attorney Services and authorize the Chair to sign; 5) approve the 2025 contract for the purchase of guardianship/conservatorship services for: Resource Training and Solutions and authorize the Chair to sign; 6) approve the Joint Powers Agreement with Local Govrnment Units for the enforcement and regulation of Cannabis and authorize the Chair to sign; 7) approve the appointments to the Board of Adjustment and Planning Commission; 8) approve an alternative method to disseminate bids and Requests for Proposals and authorize the Chair to sign. Motion carried unanimously

Next, Auditor-Treasurer Christine Scherbing requested to re-designate Auditor-Treasurer the authority to designate depository banks and to designate depository banks for Benton County funds. Motion by Gapinski and seconded by Johnson to re-designate Auditor-Treasurer the authority to designate depository banks and to designate depository banks for Ben-County funds. Motion carried unanimously.

Next, County Administrator Montgomery Headley explained that the draft listing of the 2025 County Board meetng dates and times reflects the traditional meeting dates of the 'first and third" Tuesday of each month at 9:00 AM; with the exception of the December 2, 2025 meeting commencing at 6:00 PM for the "Truth in Taxation Meeting". Following discussion, Johnson/Heinen to set the 2025 County Board meeting dates and times: "first and third" Tuesday of each month at 9:00 AM with the exception of the first meeting in December which will be on Tuesday, December 2, 2025 at 6:00 PM (to combine with the Truth in Taxation Meeting). Motion carried unanimously

Next, Headley requested the County Board to designate the official newspapers for Benton County for 2025. We have received bids from Star Publication to publish official County notices in both the Sauk Rapids Herald and Benton County news. Star Publications cites a 30% discount for publishing n both newspapers. Publication rates will increase 2.5% in 025. Examples of notices published include County Board minutes, notices of public hearings, the delinquent tax listing, annual financial statements, the summary budget statement,

and County ordinances. Motion by Johnson and seconded by Benoit to designate the Benton County News and Sauk Rapids Herald as the official newspapers of Benton County for 2025. Motion carried unanimously.

Next, Headley requested the County Board to set the 2025 per diem rate for Boards and Commissions. The County Board's past practice has been to set the per diem paid to members of Boards and Commissions at the first meeting in January. Boards and Commissions affected by this action include the Park Commission, Planning Commission, Board of Adjustment, Solid Waste Advisory Committee and the Extension Committee. The current per diem paid to members of Boards and Commissions is \$70 per meeting. The requested action sets the per diem at the same \$70 rate established for County Board members for 2025. Motion by Gapinski and seconded by Benoit to set the 2025 per diem rate at \$70 per meeting for Boards and Commissions. Motion carried unanimously.

Next, Headley requested the County Board to consider the appointments to Career Solutions. Due to the departure of Commissioner Schlangen from the County Board and the Career Solutions Board, a new appointment is needed. Such appointment will allow Benton County to have two representatives to the Career Solutions Board for its first meeting in January (and help to avoid any potential lack of quorum issues.). The Career Solutions Joint Powers Agreement requires the appointment of two Board members from each County. Motion by Gapinski and seconded by Johnson to appoint Benoit to the Career Solutions Board. Motion carried unanimously.

Next, Headley requested the County Board to consider the State of Minnesota Safe and Secure Courthouse Grant Agreement. Benton County was awarded a \$21,350 "Safe and Secure Courthouse" grant from the Minnesota Judicial Branch to install bullet-resistant glass in Court Administration. The grant will cover half the project cost. The balance can be provided by the County's Capital Improvement Plan (CIP) fund balance. Motion by Heinen and seconded by Benoit to approve the State of Minnesota Safe and Secure Courthouse Grant Agreement. Motion carried unanimously

Next, Headley requested the County Board to adopt the County Board Policy Manual. A County Board Policy Manual was first created and adopted in January 2023. It was subsequently revised in May 2024 to include provisions for remote attendance at County Board meetings. Headley requests Board review and approval of the Policy Manual for 2025. Motion by Johnson and seconded by Heinen to adopt the County Board Policy Manual. Motion carried unanimously.

Next, Headley requested to schedule closed sessions for Department Head annual performance evaluations. There was a consensus to schedule the Department Head annual performance evaluations at a later date.

Next, Social Services Supervisor Nikki Knowles requested the County Board to consider the contract for Projects for Assistance in Transition from Homeless (PATH). Through the Community Adult Mental Health Initiative (CAMHI) the four-county area (Benton, Stearns, Sherburne and Wright) applied for the PATH grant through the Department of Human Services. The initiative was selected to receive the grant. The purpose of the PATH grant will be to service persons with serious mental illness (SMI) or co- occurring SMI and substance use disorder to access needed housing, treatment and supportive services and income support. A portion of the grant is to be utilized for Direct Assistance for client and administrative cost.

Staff Salary and Benefits - \$160,941

Direct Access - \$32,185

Administration - \$32,950

The contract is dated August 18, 2024 through June 30, 2025. Motion by Heinen and seconded by Johnson to approve the PATH grant. Motion carried unanimously.

Next, County Engineer Chris Byrd requested the County Board to consider the Letter of Support to Sauk Rapids for Transportation Alternatives (TA) and Active Transportation (AT) grant application. This topic was discussed during the December 17, 2024 Board meeting. Subsequent conversations with the City of Sauk Rapids have revealed an understanding on the part of Sauk Rapids that the County will not be responsible for relocation of a trail if it will conflict with future expansion of CSAH 1. It was also noted that the trail to the south of Osauka Rd is within the county right-of-way and a

new trail to the north will need to connect at the same pedestri an crossing, thus requiring a letter of support from the County This will also require a signed Resolution supporting the Ac tive Transportation Grant Agreement. Motion by Gapinski and seconded by Heinen to approve the Letters of Support for the TA and AT grant application, and the supporting Resolution. Motion carried unanimously.

Next, Byrd requested the County Board to consider the Resolution of Support for TA grant application to partially fund the construction of a shared use path along CR 55 in the City of Rice. If successful, the grant would cover 80% of the construction costs, which are estimated at \$372,025. The gran would not cover engineering or construction inspection costs The grant funds would be available in fiscal year 2029. Byrd added that the City of Rice adopted a Resolution supporting this project at their January 6th meeting. Motion by Gapinski and seconded by Johnson to adopt the Resolution of Support for Transportation Alternatives grant application. Motion car ried unanimously.

Next, Byrd shared information regarding the Xcel Ener gy Appropriation Estimate. On Tuesday, December 31, 2024 Byrd received the relocation and appropriation estimate via email from Xcel Energy. The estimate provided a detailed cost estimate to remove a wooden transmission line pole that will conflict with the roundabout construction at CSAH 1 and CSAH 29. The elimination of this one wood pole requires two steel poles on concrete foundations. Xcel is requesting that payment of 80% of this estimate be made before advancing to the next step. They will give credit for the \$134,000 the County already paid. The total estimate has increased by \$62,251 since June of 2024. The total cost of the project is estimated at \$997,208. Xcel Energy Project Managers Cody Holmes and Josh Tomlinson (virtual) were present to answer questions. They acknowledged that one major factor holding this project up has been waiting for the construction materials to arrive. The project was also prolonged due to trying to find alternative ways to reduce the cost. Xcel has ordered the product and is trying to expedite the project as soon as possible. Xcel also addressed that the increase of \$62,251 is due to acquiring ease ments for the project. Another setback is that Benton Counv cannot advertise for bids for the road construction proje that Byrd was hoping to have completed during the summe months of 2025 to avoid burdens to traffic when school ends, begins. Benton County cannot advertise for bids until we have the pole materials from Xcel. Gapinski stated that we do not want to put the County at more risk, but this is going to be a phased project, and the only party not losing money is Xcel. Holmes stated that they cannot guarantee a completion date of this project. Motion by Gapinski and seconded by Heinen to approve the Xcel Appropriation Estimate and authorize the County Engineer to sign. Motion carried unanimously.

The Regular County Board meeting was recessed at 10:27 AM to conduct a Human Services Board Meeting and a Com munity Health Board Meeting.

The Regular Board meeting reconvened at 10:57 AM.

Next, Board members continued to report on recent meet ings they attended on behalf of Benton County

Under Comments by Commissioners, Headley noted that he received an email from Bollig Engineering stating that the City of Gilman received a Letter of Conditions from the USDA approving their infrastructure project.
