Sac County considers jail replacement options

BY AMBER MOHRMANN The Sac County Board of Supervisors are exploring the possibility of building a new jail. Sheriff Ken McClure said the county has begun "preliminary discussions" on renovating the jail in the courthouse basement, transporting inmates to another facility or building a new jail. The county's existing jail, built in 1973, is in need of safety and security upgrades, staff members reported to a report from the state jail inspector and a grand jury.

McClure has considered, but declined against asking the public to approve or build a new jail. The county jail with inmates open in 2022, that primarily to the outdated nature of the jail that was nearing 90 years old. Group asks school board to holster its gun program

Cite expense, liability, bad feelings

BY TOM CULLEN A coalition of Cherokee School District residents has demanded the suspension of a policy that will allow up to 45 staff members to carry firearms on school grounds.

A four-page letter sent to the school board on Monday accused the board and Sup. Kim Langrath of "unwarranted questions, lack of transparency and funding discrepancies" when it passed the policy in November. Langrath and board President Jeff Thomas declined to comment on the coalition's four-page letter because it was received in the public comment period of Monday's school board meeting.

Langrath noted the board can discuss anything that isn't specifically listed on the agenda, the coalition claims to have requested a special discussion with the board, but were denied because the board couldn't arrange for its attorney to sit in on the meeting.

"As taxpayers, parents and community members, we urge the board to immediately suspend any expenditures associated with training teachers as armed professionals," the letter reads. "In this time, we ask that you invest in policies and practices that truly make our schools safer for everyone."

One after the other, coalition members outlined their complaints from the policy, believed to be the most extensive school training plan in the state in terms of staff. The district is expected to increase up to 45 — or a third of its staff — carrying firearms on school grounds.

"That amount of people with firearms will no doubt create unmitigated financial stress for the district, the coalition believes it believes will be a tremendous increase in liability and expensive training regimen. The group claimed Co. Kim Reynolds' \$100 million school...
