Azle ISD unveils unofficial accountability rating

AZLE — Texas Academic Performance Reports (TAPRs) have been released for 2023 and Azle ISD is standing strong. TAPR is an important tool for school districts to determine how their students fare academically. The metric measures STAAR-based student achievement, school progress from year to year

School officials speak on student achievements, effects of COVID

and equity between different demographics enrolled at each campus. It is used by the Texas Education Agency and the federal government to help identify which schools need guided improvement and which can be trusted to

self-assess.

In years past, TAPR has been used to generate an accountability rating for each district. Prior to launch, TEA unveiled a new formula for the 2023 accountability ratings that many districts wor-

ried would negatively impact their scores. These districts then filed a lawsuit against TEA in protest of the new formula. The release of 2023 accountability ratings is currently pending on judicial review. Using the new formula, Azle ISD has calculated its own unofficial score based on the recently released TAPRs. Using this formula, the district should score an 85 or a B on the 2023 accountability

ratings. Azle ISD also scored an 85 in 2022. Districts were not rated in 2021 or 2020. Azle ISD received an 88 for 2019.

AISD Director of Secondary Curriculum and Federal Programs Jordan Thiem said that while the district does not hold accountability ratings as its "north star," he is proud that the hard work and progress of the district and its students has been reflect-

ed in its unofficial score.

"Commissioner Morath has let it be known that the new accountability system has raised the bar on expectations and has therefore raised the bar on many of the metrics," Thiem said in an email to the Tri-County Reporter. "The numbers that we have seen for our district with internal data should

Bond or bust

SPRINGTOWN — Longtime Springtown school board member Tootie Hall provoked the Springtown City Council to chuckle when she gave a brief update on the school district's quest for a winning bond election.

Hall represented the school board at the Jan. 25 meeting in honor of Mayor Greg Hood's proclamation of School Board Recognition Month. While she had their attention, Hall addressed SISD's inability to pass a bond election, saying the school board is evaluating the district's situation and how to proceed. She ended her remarks by

saying, "There will be another bond, so start saving your quarters," which summoned the hum of laughter from council members.

Not much seems to have changed since Springtown Independent School District's last failed bond election in November, the fourth installment in a series of ballot proposals rejected by voters. From the perspective of school district leaders, campuses still need relief from overcrowding caused by enrollment growth, but some voters are still wary of

approving any measure that would increase their property tax bills.

Hall said she made her comment to the council because she doesn't see another way forward other than to keep asking voters to approve a bond proposal, though the proposition may need to be split up into pieces.

"We're still grasping for straws," Hall said. "I mean, we are out of room."

The question isn't whether the school board can call another bond election, but rather, what will it take for voters to approve it?


Since December, The Tri-County Reporter has sought to find out why SISD's bond proposals have failed not once but four times in a row. To answer this question, the Reporter interviewed multiple people — including SISD Superintendent Shane Strickland, school board members, bond supporters and opponents — and requested data on local property taxes and results of school bond elections in the state.

To best convey its findings, the Reporter has broken this story into parts. Part one of this series will examine the history of Springtown's bond election efforts.

In May 2021, SISD had its first of four failed bond elections. The school board called for a \$38.5 million bond election to build a new elementary school, add classrooms at the middle and intermediate schools and expand the high school's welding shop, ac-

Results of 2023 school bond elections in Texas



Tarrant County — Residents in Tarrant County have the chance to elect a new sheriff this year.

Sheriff Bill Waybourn, who currently holds the office, is seeking re-election. He faces challengers Indya

Murray and Patrick Moses, both Democrats. The primary election in March will allow voters to select a candidate to represent each party. Primary Election Day is March 5 and early voting runs Tuesday, Feb. 20 to Friday, March 1.

reflect the idea that we are improving... We try to make a difference to every child every day. In terms of accountability, that means we are focusing on making sure that every student grows academically by a full year or more and that we continue to give multiple options to our secondary students to be college or career ready."

Thiem also broke down student STAAR test scores to show where Azle ISD's strong suits and weaker points lie in a Jan. 22 Azle ISD board of trustees meeting. Last year, the district showed gains in performance levels for all subjects, demonstrated by 80% and 51% of students achieving at least the "approaches" and "meets" markers. The district had more students in this category than both the state and regional averages. The district slightly lagged behind in the "masters" category at 19%, with the state at 20%. One of Azle's best subjects is 10th grade U.S. history, with 97% of students falling under "approaches", 77% under "meets" and 41% "masters." The state average for each respective category was 94%, 70% and 38%. Fifth grade STAAR scores and high school English were two more high points for Azle students, while math scores were their lowest.

"The gains are one indicator of success and as a district we couldn't be more proud of the work that students and teachers have done to make those results happen," Thiem said. "The gains we see from TEA data need to be celebrated and acknowledged but are a small piece of the puzzle. We have so many things to celebrate in Azle that aren't measured or acknowledged by TEA in accountability."

STAAR data also showed that 2023's third graders lagged behind the high-achieving fourth grade classes one year ahead of them. Thiem said this year is significant because it is the first where the district has seen the scores of students who started kindergarten while under COVID lockdowns.

"There are reports from multiple sources regarding the learning loss and setbacks in achievement due to COVID," Thiem said. "TEA even notes this inside of the reasoning and justifica-

tion for a change inside of accountability. Most of the data, even TEA's data, shows us that we have returned to where we were pre-COVID but not where we would have been if we continued growth trends... Our teachers and campus administrators have worked incredibly hard to make sure that COVID learning gaps do not hold our students back."

While Azle High School seniors may also be lagging behind in college-level course enrollment, they outperform the state and region in graduating with technical credentials and labor market experience. Azle ISD scored 43.4% and 38.1%, respectively, in career and college readiness compared to the state's 33.5%, and 52.9%. College readiness is largely based on whether students earned college credit through advanced placement, OnRamps, dual credit classes or met Texas Success Initiative criteria for the SAT and ACT, among other academic achievements. Career readiness is based on the number of students enrolled in work programs or who have earned industry certifications. The district also has a 95.8% four-year graduation rate compared to 89.7% from the state and 89.5% from the region.

"I think it's a testament that we have a plan for students and that we support them in being at school and succeeding in school," Thiem said. "In the state's eyes they are


looking at percentages and not counts. There is a large trend happening in education of students leaving public education in different ways that does not count as a drop out. In Azle we have multiple options to meet students where they are so that dropping out is not their only option, things like Hornet Academy."

Thiem also presented Azle ISD's Results Driven Accountability scores. Results Driven Accountability is a TEA metric used to improve results and be responsive to the needs of students who fall under the following categories: Bilingual Education, English as a Second Language, and Emergent Bilingual (BE/ESL/EB), Other Special Populations (OSP) and Special Education (SPED). Azle ISD met requirements for all three categories, earning the highest score of Determination Level 1.

"That's a big deal," Thiem said. "It means we're not just moving on; we're not just disregarding these kids. It means every single one of these kids we're trying to provide an equitable education for, and they're not being treated differently because of who they are or what they are."


Achieving this score means Azle ISD is allowed to self-monitor its instruction in these categories instead of being assigned additional state-guided improvement plans.

up with the most chips was declared the "winner." We would play blackjack, craps, and roulette. It was a lot of fun, and come to think of it, it was probably a good way to learn arithmetic as we figured the odds on a craps table and the payout on roulette. We guys had a lot of fun and as I recall, the competition was very intense.

In the mid '60s, there was no internet or cable television. There was no ESPN or internet to learn the outcome of a sporting event. The newspaper was the best source, and it was always at least half a day behind. Sporting events were rarely available for viewing via television, and

so when a contest was on, it was something my dad and I would watch together. During the mid-'60s, the Big 8 basketball schools played their games on Saturday afternoon or evening, and one of the games would be rebroadcast on local television on Sunday.

Watching those games was one of the highlights of the week for a couple of reasons. I loved basketball and it was cool to simply see major college players perform. Perhaps even more importantly, it was a time when my dad and I could be together and interact. He would ask me which players I liked best and why, talk about the coaches and their strategies, and point

things out about the game I did not yet understand. Mom would make us lunch, and we would eat in the living room which is something we were ordinarily not allowed to do. It was a special time.

Before the start of one game, Dad looked at me and asked if I wanted to bet. As I recall, Kansas was playing Missouri. He asked me which team I liked, and I told him Missouri. He responded by telling me he would take the Kansas team, plus he would give me six points. He explained this meant Kansas not only had to win the game, but they also had to win by more than 6 points. I felt like I was stealing money from my very own father! There was no way Kansas would win, much less win by more than the allotted points.

We watched the game, and it was a good contest with the score rocking back and forth. I was nervous as the game came down to the wire,

praying Missouri could hold on, but in the last minute Kansas exploded and blew the game open. When a Kansas player hit a shot with about five seconds left, they went ahead by seven, and I had lost the bet. I was crestfallen and could not believe I had the bet "won" the whole game only to lose in the last few seconds. My dad, in a good-natured way, kidded me about losing the wager and all I could do was take it.

After a couple of minutes of cajoling, dad told me to go and get the sports page out of the newspaper. I ran and got it, handed it to him, and he showed me the results from the games played the night before. There it was: Kansas beat Missouri by seven points. I did not know the game we had bet on had already been played and Dad knew the result before we wagered!

At first, I thought "what the heck was going on here? Did

my own father cheat when he made the bet with me?" I had never, ever, seen my dad do something dishonest or unfair, and I simply could not believe what had happened. I was bumfuzzled!

Before I could speak, dad looked at me and said, "Son, I know you have been gambling with the neighborhood kids for fun, and that is OK. What I want you to know is there are a thousand different ways to cheat in gambling and in life, so do not ever take another man's bet. If, out of the clear blue sky, he wants to make a wager with you, he knows something you do not know."

Pretty sage advice, whether when gambling or in life itself.

The Tri-County Reporter asked the candidates vying for the precinct seat in the Republican primary to tell us about themselves and their goals. Check out their responses below:



Jason "Scott" Bedford

Name: Jason "Scott" Bedford
Position: Tarrant County Constable Pct 4
Occupation: Constable
Education: I graduated from the police academy as salutatorian of my class at the age of 30. At the age of 48, I attended Charis Bible College and graduated two years later at the age of 50 with an associate degree in biblical studies.
Community Involvement: I currently lead weekly devotional services and teach identity theft prevention to seniors at various senior liv-

ing facilities around Tarrant County. I also work with charitable organizations that assist families in need.

Why are you running: I am seeking re-election for the office to continue building on the implementations from when I was first elected as Constable. I have been in law enforcement for 23-plus years and served as a firefighter and EMT. I have served as constable for the past two years. During that time, I marked all patrol units, outfitted deputies with uniforms and lifesaving body armor while making it mandatory to wear while on duty. I have created a mandatory school visibility program which requires patrol deputies to work school zones daily, physically walk through a school weekly, and be in and around schools by completing their daily paperwork in school parking lots when feasible. I am now utilizing Tarrant County's reporting system for offense reports which are also directly filed from my office and utilizing the CRIS program for accidents. A review of daily activity reports revealed most deputies were only work-

ing an average of four total hours per day. The extra time allowed me to implement additional tasks for deputies to better serve our community. I have an extensive history as an instructor and understand the importance of being properly trained. I have increased the frequency of training in high liability areas such as use of force, firearms and civil process requirements. As a supervisor at previous agencies, I was responsible for assisting in creating new policies and procedures to better guide and protect our citizens and officers alike. With this experience, I am now implementing state recognized policies and procedures.

Goals: I have implemented specialized training for all deputies. I have doubled minimum training hours in specialized training such as school shooting response, taser and advanced handgun tactics and I will be introducing emergency medical care into our training in hopes to better serve our deputies and citizens. We will continue to provide the new services I implemented upon being elected in 2022.

Education: Boswell High School / 1980, 2-1/2 years college from TCC, Stephen F. Austin, Tarleton State, TCU. Master Peace Officer, police instructor, police firearms instructor.
Community Involvement: Serve on the executive committee of Windy Ryon Memorial Roping, a non-profit which provides scholarships for area youth. Member of Northwest Tarrant Lions Club and the Tarrant County Junior Livestock Show Buying Group, which raises money to buy area youth agricultural projects each year.

Family: I have been married to my wife Jill for 32 years. Jill is a retired schoolteacher from Eagle Mountain Saginaw ISD. We are proud parents of two adult sons ages 29 and 31, who both live and work in Precinct 4. We are active in our community and are members of Christ Chapel Bible Church.

Why are you running: I am running for Constable to bring honesty, integrity and duty back to the office. The Precinct 4 Constable's office is broken right now. The current leadership comes to work only a couple days a month and is not completing the basic duties that are required of the job. I want to correct the mismanagement that has taken place for almost two years and bring the constable's office back to where it was previously, a well-respected and highly efficient office. The people of Tarrant County deserve better than what they are getting now from their constable.

Goals: Public safety has always been and will always be the most important goal when I am your constable. When I was first elected to the office in 2016, I increased the training to all sworn personnel. This helped make them more efficient deputies on the street. As political discussions about education in Texas seem increasingly common, Parker County residents will have a chance to vote for the person they want to represent them in those conversations at the state level.

State Board of Education District 11 representative Patricia "Pat" Hardy is up for re-election this year, but she has challengers, both a fellow Republican and a Democrat. District 11 includes all of Parker, Hood and Somervell counties, part of Tarrant and Johnson counties and just a smidge of Dallas County.

The State Board of Education decides on curriculum standards, instructional materials and graduation requirements, among other tasks, according to the Texas Education Agency's website.

The primary election in March will allow voters to select a candidate to represent the Republican party and a candidate to represent the Democratic party. The primary winners in both parties will go head-to-head in the November general election.

Primary Election Day is March 5, and early voting runs from Tuesday, Feb. 20 to Friday, March 1.

Name: Brandon Hall
Occupation: Pastor

Education: I started school at Springtown Elementary in the same building where my grandfather attended high school. I later transitioned to home schooling through the end of high school. I earned a bachelor's degree in pastoral theology from Hyles-Anderson College.

Community involvement: I currently serve as the pastor of a local church in Springtown and I have also worked as a full-time youth pastor. I have been heavily involved in the conservative and pro-life movement, including attending the 2022 Republican Party of Texas State Convention as a delegate and serving as a presiding election judge in Parker County.

Family: My family has lived in the Parker County area since the 1800s, making me a fifth-generation resident of Parker County and a seventh-generation Texan. I was raised in a blue-collar household where my father

worked in the oil and gas industry. Strong work ethic was instilled in me from a young age. My wife Ashley and I met while in high school, attended college together, and we have been married for three years. Ashley has a degree in education and has taught first grade at a private Christian school.

Why are you running for a place on the State Board of Education, and what experience are you bringing to the position: My passion for seeing students thrive began while working in youth ministry. While in Bible college, I led ministry outreach and mentorship programs for at-risk youth in inner-city Chicago. Working with mostly single-parent families, I helped to enroll and raise tuition funds for 14 kids to attend Christian school. Transitioning from failing schools full of drugs, gangs and violence and being placed in an uplifting environment was a life-changing experience for many of the students. In addition to my ministry experience, I have worked professionally on campaigns to elect conservative leaders including Gov. Abbott and President Trump. I also served as a staff member in the U.S. Congress where I had the opportunity to learn public service and assembled and led advisory committees on border, immigration and agriculture policy for former Rep. Yvette Harrell who was ranked one of the top conservatives in Congress.

Texas schools must be equipped with curriculum that promotes unbiased learning. I am committed to dismantling Critical Race Theory and Diversity, Equity and Inclusion. Our schools need to get back to the foundational principles of education, rooted in conservative values, to reclaim academic rigor and integrity and to provide students with a strong launching pad for their futures. The left is relentless in attempting to indoctrinate our children with woke ideology and your State Board of Education member must be just as relentless as the first line of defense protecting the innocence of students and upholding the rights of parents. I will be that solid conservative fighter that parents can count on to have their back every single time!

What goals do you have that you feel will help serve residents, students and school staff in District 11: One of my top goals will be to see Texas find or develop an alternative standardized test to the STAAR testing system that puts unnecessary stress on students and teachers and wastes valuable classroom time "teaching to the test." I will advocate for the legislature to remove the STAAR test and replace it with a test that measures student aptitude according to grade level

standards based on what the students have already been learning. The STAAR test has varied too far from the course criteria and it's time for it to go.

Obscene books such as the title "Gender Queer" showing up in North Texas school libraries is a deeply concerning trend. The fact that these books ever showed up in schools in the first place speaks to a complacency that has plagued the State Board of Education. Eradicating obscene materials from Texas schools is a matter (of) urgency and will be my first priority on the State Board of Education.

Education: I hold a master's degree in secondary education and history from the University of North Texas and a bachelor of arts degree in social studies from Howard Payne University.

Community involvement: Serving on the SBOE is an unpaid position which requires many hours of work throughout the year. For 10 years, I volunteered with Kids Hope, where I mentored students one-on-one at Clarke Elementary in Fort Worth. For 25 years, I ran the state finals for the National Geographic Geography Bee and judged numerous local, area and regional spelling bees affiliated with the Scripps National Spelling Bee. I am a member of Travis Avenue Baptist Church, and I received the Baptist Educators Serving Texans (B.E.S.T.) award in 2022.

Family: My family has always been my rock; parents, siblings, nieces, nephews, godsons, and goddaughter.

Why are you running for a place on the State Board of Education, and what experience are you bringing to the position: I believe in community service. There is no salary for serving on the SBOE, but the immense privilege to serve the students, educators and taxpayers of District 11 is a duty I do not take lightly. My entire career has centered around education, so I serve because education is my passion. I am a strong supporter of the public education system and want Texas public schools to be successful for all students. We have a duty to ensure students become responsible citizens, living their lives to the fullest and making meaningful contributions to their community and beyond. My priorities on the board include revising the social studies TEKS (which will be reviewed in 2025), keeping CRT, DEI, and similar "woke"

policies out of our schools, strengthening the Permanent School Fund, and continuing to advocate for local control.

With 22 years of experience serving District 11 of the SBOE, 30 years as a high school history and geography teacher, and five years as a social studies coordinator, I have devoted my life to Texas public education. My experience as an SBOE board member has trained me on how best to get things done in Austin, and the 18 years I have served on the Permanent School Fund (PFS) Committee has given me intimate knowledge of how best to lead the PFS with conservative fiscal responsibility, allowing us to annually give billions to public schools and in doing so reduce the tax burden on local taxpayers. With over three decades of experience as an educator, I empathize with the challenges our schools face, making me a powerful advocate for teachers, parents, and students.

What goals do you have that you feel will help serve residents, students, and school staff in District 11: My top priority for this term will be updating the social studies Texas Essential Knowledge and Skills (TEKS). TEKS for each subject are updated every ten years. It is vital that we produce quality standards when the social studies TEKS come up for review in 2025. As a high school world history and world geography teacher for 30 years, I have hands-on classroom experience that will help inform my decisions on what content is appropriate and engaging to students depending on their grade levels. Social studies is one of the four core foundation courses of study in the state standards, and it needs to be factual, balanced, respectful and appreciative of our history and culture.

I will continue to oppose CRT, DEI, and other "woke" policies from being pushed on our students. Similarly, in my continued efforts to protect young children, I will ensure that reading materials are age-appropriate and not hypersexualized. Schools should be places of development and learning, not indoctrination.

Supporting true to my priority of supporting Texas taxpayers, I will continue to strengthen the Texas Permanent School Fund (PFS), the largest state education endowment in the nation. Through wise management, the PFS has grown to over \$55 billion in assets. The PFS backs local ISD bonds by providing a AAA rating, thereby lowering interest rates and ultimately decreasing the tax burden on local taxpayers. I have spent 18 years guiding the PFS committee with fiscal conservatism, and if reelected I will continue to do so.

My final major priority is advocating for local control. District 11 spans six counties and encompasses urban and rural school districts which have different needs and values. The SBOE makes macro policy decisions affecting the entire state, but I believe that some issues are best left up to local stakeholders.

Name: Rayna Glasser
Occupation: High school math teacher, department chair, and senior class sponsor

Education: I am a single mom who raised my son while putting myself through college. I earned an Associate of Arts degree through Tarrant County College before transferring to Texas Woman's University where I earned a Bachelor of Science degree in mathematics. Two years ago, I completed (my) Master of Education in teacher leadership with an emphasis on curriculum and instruction at Lamar University. I am currently working on my principal certification through Lamar.

Community involvement: I have served as an election judge in Tarrant County elections for the past several years. I recruited students to work as student poll workers, many of whom have gone on to college and continue to work the elections. I took a group of seniors to Langston University this past fall for a college visit. Several of our students received scholarships as a result of this visit. I oversee the "Adopt a Wildcat" Facebook group where I actively recruit to pair our students with a mentor after graduation. I am always looking for ways to help the community I serve.

Family: I am a single mom of a 21-year-old son. He graduated from Castleberry High School in 2021. He played football, basketball and baseball and I never missed a game. My younger sister and I were raised by a single mom. She taught us to be strong and to chase our dreams. My sister lives in North Texas and my mom lives across the street from me.

Why are you running for a place on the State Board of Education, and what experience are you bringing to the position: As a classroom teacher and parent, I see first-hand the challenges our students face every day and COVID directly impacted our students who are still trying to recover from the impact of the pandemic. According to NWEA (Northwest Evaluation Association), a K-12 assessment and research organization that tracks data through MAP (Measures of Academic Performance) testing, the data shows we are still dealing with the fallout.

We test students at the beginning of the year, the middle of the year and the end of the year. The latest numbers estimate that most students would need, on average, an

additional 4.5 months of mathematics and 4.1 months of reading to recover in these two subjects. Yet, as educators, we just went back to teaching the curriculum we always taught before the pandemic and acted like nothing changed.

We have to do better for our kids; for their future. They deserve an education, and we aren't doing an adequate job getting our kids back on track.

School and district leaders are doing the best they can with the limited resources and staff they have. We have a teacher shortage right now because teachers are being asked to do more and more with less and less.

We have to take care of our teachers so they can take care of our kids. That starts with setting realistic standards and a comprehensive curriculum that moves students forward while providing opportunities for students to close their learning gaps.

What goals do you have that you feel will help serve residents, students and school staff in District 11: My primary goal would be setting curriculum standards and ensuring our students are prepared for the global workforce upon graduation.

I would assist (in) reviewing and adopting instructional materials. I would push for curriculum that is rigorous and relevant and ensure that the curriculum keeps our kids moving forward while also addressing the learning gaps so many of our kids face post-pandemic. I think SBOE should review and approve a comprehensive list of approved instructional materials for districts and/or schools to choose from. Our district is very diverse. It represents rural and urban constituents. It represents wealthy and poor constituents. It represents White, African American, Hispanic, Asian and other constituents. Each demographic is uniquely different and there is no "one size fits all" curriculum that is going to engage every student. I think it is important to have approved resources, but I think we need to allow districts and schools to choose what is going to best meet the needs of their students. I would also advocate to remove the STAAR test as a graduation requirement. While I feel like testing is necessary and beneficial for the data it can provide, I feel the way testing is utilized currently is unfair to our students. Students can fail STAAR in fifth grade and get promoted to sixth grade. Students can fail STAAR in eighth grade and get promoted to ninth grade. If students fail STAAR in ninth grade, they can continue to take the test until they graduate. However, if they have continually failed since elementary school, it is unlikely they will pass in high school because they never understood the foundational concepts necessary to build their knowledge. I would propose changes to this system that will ensure all our kids (get) an equitable education regardless of their demographics.



Get to know primary candidates running for District 60 state representative

STAFF REPORTS

The race for District 60 state representative will be on the ballot during the March primary elections.

Mike Olcott is again running against incumbent state Rep. Glenn Rogers. Previously, Rogers and Olcott had the highest number of votes in the 2022 primary election, and Rogers narrowly won the seat in the following runoff election.

Because there is no Democrat candidate in this race, whoever wins in the Republican primary in March will triumph by default in the November general election.

State representatives speak for their districts in the Texas House of Representatives, which meets every two years (or in special sessions called by the governor) to vote on potential new laws that will affect residents in their districts as well as the whole state.

District 60 includes Parker County as well as Palo Pinto and Stephens counties.

Primary Election Day is March 5 and early voting runs from Tuesday, Feb. 20 to Friday, March 1.

The Tri-County Reporter asked the candidates vying for the District 60 state representative seat in the Republican primary to tell us about themselves and their goals. Check out their responses below:

Name: Mike Olcott
Occupation: Retired Biochemist

Education: After earning a B.S. in biology from Rhodes College in Memphis, Tennessee, and a Ph.D. in biochemistry from the University of Kentucky in Lexington, I worked as a post-doctoral research scientist at Stockholm University in Sweden and OSU.

Community involvement: I co-founded Parker County Conservatives in 2015. The primary mission of this organization is to educate, motivate and activate conservative Republicans in Parker County. I also served as a Republican precinct chair from 2014-2021.

Family: I have been married to my beautiful wife since 2001.

Why are you running for District 60 state representative, and what experience are you bringing to the position: A fifth generation Texan, I grew up with the conservative values that make Texas the Texas we love. Unfortunately, those values have been under assault for

quite some time. Sadly, too many community and political leaders have been cowering to political correctness and woke cancel culture allowing the genuine true heart of Texas to rapidly erode. Occupation: Veterinarian and Rancher

Education: I graduated from Graham High School. My BS and Doctor of Veterinary Medicine degrees were completed at Texas A&M University. A post-graduate degree was obtained at Kansas State University. I was a tenured associate professor at North Carolina State University. I am board certified with the American Board of Veterinary Practitioners in beef cattle practice. In 2020, I was recognized as an Outstanding Alumnus by the Texas A&M College of Veterinary Medicine. I have been an invited speaker for numerous veterinary and cattle industry events across the U.S. and have authored over 40 peer-reviewed publications.

Community involvement: My "community" has encompassed local, state and national involvement. Mandy and I are active in our Aleo church and Sunday school class. I serve as a lay reader and was chair of our Pastor/Parish committee. While in practice, I was president of the Palo Pinto County Farm Bureau, president of the West Cross Timbers Veterinary Association, director of the Texas VMA, member of the Graford School Board, member of the tax appraisal advisory board and VP of the Palo Pinto County Livestock Association. Recently, I served on the executive committee and as president of the American Association of Bovine Practitioners.

Family: I have four living children, three daughters and a son, and five grandchildren. My oldest daughter, Meg, is an MD and infectious disease specialist. My daughter,

Ginny, is an attorney, dealing mostly with education issues. My son, Ben, graduated from Texas A&M with a degree in genetics and is in technical sales. My youngest daughter, Leah, is a sophomore at Tarleton State University, majoring in physics and math. My wife, Mandy, is also a veterinarian. We live on our ranch south of Graford on land settled by my family 125 years ago.

Why are you running for District 60 state representative, and what experience are you bringing to the position: I am currently in my second term serving as state representative for House District 60. I am running to be a strong voice for my local district and rural Texas. Due to redistricting, this is my first term to represent Parker County, now 80% of my district. We lived in Aleo from 2000-2019, and two of my children attended Aleo public schools. While much of Parker County is now more suburban, residents still cherish rural conservative values and rally around their local schools. Parker County is one of the fastest growing counties in the nation, and we need experienced leadership in the Texas House to address the unique challenges that accompany growth. I serve on the House Natural Resources Committee, which oversees water entities such as the Texas Water Development Board and TCEQ. My team has toured every water facility in the district and are well equipped to tackle water availability issues. My conservative record includes passing Constitutional Carry, banning abortions in Texas, passing the largest property tax relief bill in state history, and funding the border to the tune of \$6.6 billion in this session to continue building the wall and put more boots on the ground. What goals do you have that you feel will help serve residents in District 60: The border crisis has made every town in Texas a "border town." In the absence of federal leadership, I will continue to strongly support Gov. Abbott's mission to secure our border and resist the invasion. Our citizens and our communities are being harmed by fentanyl and other drugs that continually cross the southern border. My goal is to stop that threat. Texas should do whatever possible to end the Biden Border Crisis. Enforcement of current laws is a critical first step.

I want to continue lowering property taxes. We passed the largest property tax cut in history this past legislative session. This is a great start, saving the average Texas homeowner \$1300, but we can and will do more.

My team and I are ready to work toward immediate and long-term solutions for our region's water shortage. Beginning in March, we will hold Town Halls across the district focused on providing factual information about the looming water crisis and to entertain ideas and potential solutions prior to the 89th legislative session in 2025. I will continue to actively participate in the Hydrology 2050 group to continue seeking ways to address the long and short-term water needs. We owe it to future generations to prepare now for future water demands.

I will continue protecting our great local schools. In District 60, we are blessed to have outstanding public and private schools that provide our students with a balanced education. Our schools are the heart of our communities; Friday Night Lights, band performances, FFA activities, and many other school events are irreplaceable. According to an April 15, 2021, edition of The Springtown Epigraph. About 60% of Parker County voters in the Springtown school district rejected this proposal, which would have raised tax rates by almost 12 cents.

The Epigraph also reported that SISD's enrollment was 3,674 in January 2021, which at the time was the highest January enrollment since 2007. Now the district's enrollment numbers are more than 4,000.

"Across the district, we are already planning to add teachers at every elementary grade level as we prepare for next year," former SISD Superintendent Mike Kelley said in the May 6, 2021, edition of the Epigraph.

In the fall of 2021, SISD put the same proposal out for a vote again, except this time the cost of the projects ballooned to \$41.5 million. However, a successful bond election would have only increased the tax rate by about a half-cent compared to the previous year.

Again, the bond proposal failed to pass, this time by about 51% in Parker County and 54% in Wise County.

After failing at the polls twice in a year, the school board opted to not call for elections in 2022. Instead, the district hosted multiple meetings to educate locals on the district's needs and get feedback to form a new plan. From there, the district found support for building a new middle school and reconfiguring the district's campuses instead of constructing a new elementary school.

In February 2023, the board decided to call for an election to fund the new proposal to

build a new middle school, convert the current middle school into a ninth-grade center and turn the intermediate school into the district's fourth elementary campus. In this plan, there wouldn't be a need for an intermediate school as fifth graders would be taught at the elementary campuses, and sixth graders would go to Springtown Middle School.

The May 2023 bond proposal was estimated to cost \$120.78 million, which was tens of millions of dollars more expensive than the 2021 plans. Building a middle school generally costs more than an elementary school, and district officials would need to buy more land to accommodate the new middle school campus. Without considering the impact of increased property appraisals, the district's tax rate was projected to increase by about 29 cents with a successful bond election.

Although voters failed to pass the May 2023 bond, the election was close in Parker County where the percentage of "no" votes didn't reach 51% of the total ballots cast, and more people in the county voted on the bond than during the previous two elections. With Wise County's results taken into consideration, the bond failed by only 57 votes.

In August 2023, SISD called for another bond election with a proposal almost identical to the one in May. The district hired a new financial adviser and architect, and because of the Texas Legislature's required tax compression, SISD's tax rate would have been about a cent less than the rate for the previous year after a winning bond election.

But SISD still didn't capture the votes it needed to win the

election in November. Instead, SISD voters in Parker and Wise counties definitively told the district "no" at the ballot box. More people in both counties came to the polls (which could be attributed to the constitutional amendments election that was also on the ballot in November) and soundly rejected the bond proposal by about 56% in Parker County and about 60% in Wise County.

"I don't know that people truly see the need, especially those that are not visiting our campuses," SISD Superintendent Shane Strickland said about why the bond hasn't passed. "They don't feel the impact that it has inside the buildings."

The community meetings in 2022 had a decent number of attendees, but leading up to the November 2023 election, the district's informational meetings were sparsely attended.

Strickland theorized that the district may be reaching people who already are bond supporters at meetings when they need to attract opposed or questioning voters. But getting them to show up is harder said than done.

"We had lists of people that we would call in, invite them to these meetings, and a lot of them would say they're going to come and then just never come," he said.

School districts in Poolville, Decatur and Bridgeport also had failing bond elections in November, but Azle ISD — which Strickland pointed out has more businesses and corporations that pay local taxes than Springtown — was able to pass a bond election last fall.

Despite the view on the local level, most 2023 school bond elections in Texas had more in common with Azle than Springtown and other

nearby school districts. Of the 203 school bond elections that took place last year, 150 (74%) passed at least one proposition while 53 (26%) failed, according to the Municipal Advisory Council of Texas. This trend is still consistent when broken down between the May 2023 and the November 2023 bond elections in Texas. The Municipal Advisory Council of Texas reports that 80% of May bond elections were successful while 63% of November bond elections were successful.

Strickland estimated that it's been since 2008 since SISD last passed a bond election. Voters approved the school district's use of \$35 million to build Goshen Creek Elementary School on Pojo Road, Porcupine Stadium, the baseball/softball complex, additional classrooms and a band hall at the high school, classrooms and a restroom at Springtown Middle School and renovations for safety at the intermediate school.

The previous bond proposal in 2005 only received partial favor. Voters approved major improvements at each campus but shot down propositions for a new elementary school and a sports complex. Of course, the voters changed their minds about these proposals in 2008.

"I believe the community has sent a clear message to the students in Springtown that education is important," former Superintendent Andrea Hungerford said in the May 14, 2008, edition of the Epigraph. "All facets of education prepare students as our future leaders."

In that previous Epigraph article, Hungerford talks about wanting to get rid of "unsightly portables," overcrowding at Springtown Elementary School and the

need for more restrooms — all of which have been discussed leading up to SISD's most recent bond elections. The 2008 bond election was reported to have included a tax increase, but the district also had access to state funds to help pay for the debt.

Mike Gilley, a former assistant superintendent and principal for SISD, recalled most of the bonds passing when he worked for the district. He described the 2008 election, specifically, as a great success for the district.

"It was just a great economic time for us and (we) got everything really at a reasonable price," Gilley said. "We kind of got everything we wanted and (were) able to pay for it."

But 2008 prices aren't the same as they are now. Gilley estimated the price of the

stadium, baseball/softball complex, track and added bus barn parking alone was about \$17 million, "and now, \$17 million wouldn't even touch trying to construct the same thing."

Gilley doesn't remember much opposition to the 2008 bond since it was understood that the facilities were inadequate compared to the district's size. He pointed out that most of the district's campuses were constructed before 2001.

"We can add to, glam over (I guess you might say) some things, but there are such things as plumbing, wiring ... space needs, that have to be met and/or overcome," Gilley said.

BOOK REVIEW

Look over here and say "Cheeeeeeeese!"

Let's see those chompers, those pearly-whites. How 'bout a big grin, ear to ear. You've got a full set of gorgeous teeth, why not show them off? Smile — especially if, as in the new book "Big Meg" by Tim Flannery and Emma Flannery, one tooth is as big as a toddler's hand.

Growing up in Victoria, Australia, Tim Flannery enjoyed fossil hunting on both land and just off the coast. It was more than a hobby for him — it was an obsession, a way to make money and to learn about that branch of science. He still recalls a large fossil he found in 1973, the tooth of *Otodus megalodon*, a shark that had gone extinct millions of years ago.


At a possible 101,600 kilograms (around 112 tons), a theoretical 20 meters long (nearly 22 yards or almost 66 feet), and a bite force roughly twice that of a *Tyrannosaurus rex*, the *Otodus megalodon* was no shrinking violet. Informally known as "Meg," it was the largest predator the Earth had ever seen. Ever.

Flannery wasn't the only one who was fascinated by the gigantic predator.

It's thought that ancient societies used megalodon teeth in rituals and as tools. Fossil hunters avidly look for them in known spots. Museums love having Meg's teeth and dealers sell them to private collectors online. Flannery says there are likely millions of teeth not yet discovered, mostly because each Meg had "tooth stacks" and hundreds of razor-sharp, killing-machine teeth in its mouth at any one time.

And yet, despite that humans' evolutionary lineage and Meg's overlapped a bit, our knowledge about the megalodon is really quite limited. Little can be learned from its bones, since Meg had a cartilaginous skeleton and cartilage doesn't fossilize well. We can extrapolate information from any of the 15 species of its cousins that live. And maybe, says Flannery, we'll know firsthand: some people believe that the megalodon still exists...

If you've read this far, it's pretty safe to say that deep, deep inside you lies the heart of a 5-year-old who thinks sharks are the coolest creatures alive. They're the coolest creatures dead, too, as you'll see inside "Big Meg."

It's unfortunate, actually, that most kids are too young to read a book like

this. Authors Tim Flannery and Emma Flannery, a father-daughter team, write in great detail about creatures that can hold a lot of fascination for all ages: longer than an average ranch-style home, Meg didn't live in a vacuum, so the authors include facts about other marine animals, both ancient and current, in their narrative, as a touchstone. This may irritate some readers — it means a lot of subject-bouncing and an overabundance of seemingly-irrelevant, seemingly-superfluous info — but stay with it. The mind-boggling is ultimately worth it.

This is the kind of book that makes you want to drop "Did you know?" at the dinner table tonight. It's a shark-lover's dream read. Share it with a kid, if you can; "Big Meg" will make you both smile.




Who's running for Texas House District 99?

STAFF REPORTS

Residents in Texas House District 99, which includes northwest Tarrant County, have the chance to elect a new representative this year.

Rep. Charlie Geren, who currently holds the office, is seeking re-election. The primary election in March will allow voters to select candidates to represent the Republican Party and Democratic Party. Primary Election Day is March 5 and early voting runs Tuesday, Feb. 20 to Friday, March 1.

The Tri-County Reporter asked all the candidates vying for the district seat in both the Republican and Democratic primary to tell us about themselves and their goals. Check out their responses, listed in order received, below:

Name: Jack Reynolds
Position: Texas House District 99
Occupation: Educator
Education: I was born and raised in Texas and spent most of my life here save for my time in the military. I graduated from high school in New Braunfels in 1986. However, I did not get my undergraduate degree until I was 42 years old, graduating cum laude from Tarleton State University in 2010 with a bachelor's degree in economics and a minor in math. I worked my way through graduate school as a high school math teacher, receiving a master's degree in economics in 2013 and a doctoral degree in educational leadership and policy studies in 2018.

Community Involvement: I have served on Azle's Municipal Development District Board for the last couple of years, and I served a year on my neighborhood's homeowner's association. At various times, I have also coached little league baseball, and I have served as an umpire for a softball league.

Family: I have five brothers — a younger brother with whom I share both my mother and father, three older half-brothers with whom I share a mother, and an older stepbrother who joined the family when I was 12 years old. In 2006, I met my wife, April, and we married the following year. We have a son named Jackson who is 11 years old.

Why are you running: There are several reasons why I chose to get in this race. The proverbial straw that broke the camel's back was the impeachment of (Texas) Attorney General Ken Paxton. While I certainly do not condone the behavior he was accused of, you would be hard pressed to convince me that other politicians in Austin, and certainly in Washington, D.C., do not similarly use their positions to benefit friends and family. If doing favors for friends and engaging in extramarital relations was truly an impeachable offense, we could get rid of a whole bunch of politicians. This kind of hypocrisy I simply cannot stomach. However, this was not the only reason I decided to challenge Charlie Geren.

Beginning in 2020, I became aware of an almost systemic failure in higher education to adhere to Texas Government Code, Chapter 657, Military Employment Preference. As a twice-honorably discharged Army Infantry and Desert Storm veteran, I learned first-hand this was largely being ignored because there is simply no enforcement mechanism. Our veterans deserve more than legisla-

tive virtue signaling from our elected representatives, and my repeated efforts to reach out to our own representative, Charlie Geren, were mostly ignored. The people in District 99 deserve a more responsive representative.

Goals: My first goal will be to put a stop to the landfill being proposed on Silver Creek Road in the south Lake Worth community. The company proposing the landfill relies on a years-old, dormant permit. Such landfill permits cannot simply exist in perpetuity, such that a company can revive it years later after residential communities have sprung up in the area.

It is thanks in large part to Charlie Geren that this problem exists at all. He filed HB 1794 in 2015, which capped the amount that cities and counties could collect from companies that contaminate the environment, removing the disincentive polluters would otherwise face. I am in favor of protecting cities and counties from frivolous lawsuits, but Geren's legislation goes too far.

Not only does this landfill pose a threat to the air quality and water supply, but it will also decimate property values, potentially wiping out equity in people's homes. When I am elected, I will do everything in my power to stop this landfill. I will place a reasonable time restraint on how long such permits can be used before they need to be reviewed for renewal, and I will reinstate fines that act as a disincentive to those that contaminate our residential communities.

I am also eager to roll up my sleeves and work with the governor to resolve a host of issues. For example, we need to secure our border, ensure the integrity of our elections, eliminate property taxes, protect small businesses, improve education, reform school finance, protect state's rights and implement the party's legislative priorities. I will not go to Austin simply to do what I want or what I think is best. I will go to Austin and do what my constituents ask of me constrained only by our Constitution.

Occupation: Rancher/Restaurateur

Education: I grew up in the Fort Worth area and attended high school at Arlington Heights, just as my father and younger brother did. I then went on to spend two years at the Baylor Military School in Chattanooga, Tennessee. After my time there, I went on to attend Southern Methodist University where I am proud to have graduated with a degree in real estate and finance.

Community Involvement: I have been involved in the Northwest Tarrant County community for more than four decades, having spent much of this time involved in the Fort Worth Stock Show. Since the early 1970s, I have had an active role in the steer show and have served many roles on the Fort Worth Stock Show including treasurer and secretary. Currently I serve as vice president of the Southwestern Exposition and Livestock Show. Why are you running: Prior to my time in the legislature, I served for nearly a decade as a Deputy U.S. Marshal, giving me a deep understanding and experience in law enforcement. After my time with the Marshals, I moved into water policy and advocacy, serving in an elected position on the Tarrant Regional Water District board of directors. I was then appointed to the Texas Water Development Board and served as chairman of the Texas Resource Finance Authority for five years. My focus was always on serving the people of Tarrant County, and later the whole of Texas, in an open and fiscally responsible manner. I oversaw a multitude of much-needed wastewater reclamation projects and ensured that Texas would have stable and long-lasting access to groundwater resources. After serving on the board, I transitioned into the Texas Legislature, being elected for my first term in the Texas House in 2000. During my time in the legislature, I have served on a multitude of committees including State Affairs, Energy Resources, Calendars, Redistricting, and Land and Resource Management. I also served as the chairman of the House Administration Committee for over a decade, chairman of the Local and Consent Calendar Committee, and Speaker Pro Tem for the most recent legislative session. I have served the wonderful community of northwest Tarrant County my entire life. I'm proud to be endorsed by the NRA with an A-Rating and I'd be honored with your vote to continue advancing our values in the Texas House.

(Current residential rate \$23.09 – new rate \$23.75/month) The City's contract with CWD allows for an annual market adjustment each February 1st based on increase in fuel costs, landfill costs, and on the percent of increase in the annual Consumer Price Index (CPI) for all DFW Urban Consumers as published by the U.S. Department of Labor, Bureau of Labor Statistics. The new garbage service rates are available on the City's website at www.cityofazle.org or a hard copy is available at City Hall.

NOTICE TO ALL COMMERCIAL AND INDUSTRIAL ACCOUNTS. Beginning February 15, 2024, all commercial and industrial customers will be direct billed by CWD. CWD is sending out letters to all commercial/industrial accounts with details on what to expect.

Azle residents benefit from a variety of waste disposal options - twice a week solid waste, once a week recycle (option to choose either 65 gal cart or 18 gal bin), once a week bulk item collection, once a month bulk brush, and a twice a year "X-treme Green Event" that is held as part of the city-wide clean up.

Get to know primary candidates running for District 30 state senator

Residents in State Senate District 30, which includes north and east portions of Parker County along with parts of multiple other North Texas counties, have the chance to elect a new leader this year.

Sen. Drew Springer, who currently helms District 30, will not seek reelection. The primary election in March will allow voters to select a candidate to represent the Republican party and a candidate to represent the Democratic party. The primary winners from both parties will go head-to-head in the November general election.

State senators represent their districts in the Texas Senate, which meets every two years (or in special sessions called by the governor) to vote on potential new laws that would affect residents in their districts as well as the whole state.

Primary Election Day is March 5 and early voting runs Tuesday, Feb. 20 to Friday, March 1.

The Tri-County Reporter asked all the candidates vying for the District 30 state senate seat in both the Republican and Democratic primaries to tell us about themselves and their goals. Check out their responses:

Community involvement: Police officer for the City of Denton for nine years full time, and nine years as a reserve officer.

Family: I've been married to my wife, Shelly, for 17 years. I have two daughters, Justice, 19, and Liberty, 8.

Why are you running for District 30 state senator and what experience you are bringing to the position: The only thing (I) have done in my life is service to others, whether it be as a police officer, watching over your families at night, or in my current work operating state

that needs to change. **What goals do you have that you feel will help serve residents in District 30:** Support our schools and teachers. Our education system is desperately underfunded and underappreciated. Forty percent of our school staff has been lost in the past two years. With the State of Texas having a massive surplus, supplying additional funding to our schools and our public school teachers must be our very first step.

Medicaid Expansion. We should be accepting the Medicaid Expansion program. There is no reason for us not to be part of a program we already spend our tax money into. As it stands right now, I see some health care providers dropping their Medicaid recipients due to lack of funds. We are also in a situation where some people are poor, "but not poor enough" to qualify for Medicaid — another issue that can be fixed with the MC-expansion, since this program increases the threshold in which people are accepted in.

Mitigate the housing crisis. We have a problem in Texas right now where some massive corporations are buying up several suburban homes meant for families and flipping them into rental homes. It is becoming such a problem that with supply going down, demand increases, which increases prices on homes. This turns our housing situation into something

that seems out of reach for lower income earners, who then decide to rent from those homes instead of buy, which in turn gives these corporations more (funding) to continue to buy more homes — it's a vicious cycle. What we need to do is add an additional tax on corporate entities that own more than 100 homes and send that money into a program that helps low-income first-time home buyers.

Properly staff our prisons, and air condition all of them.

Get to know primary candidates running for Parker County Precinct 1 constable

STAFF REPORTS

Parker County residents in Precinct 1 have a choice to make in March — keep their current constable or elect a new one.

Incumbent Constable Ray Wright will face off against challenger Jason Ingram in the upcoming primary election. Because there is not a Democrat running in this race, whoever wins in the Republican primary in March will triumph by default in the November general election.

Constables serve legal documents like summonses, warrants and judgement enforcement, according to Parker County's website. They may arrest those who violate penal laws or breach the peace in their presence, and they can seize and sell property if ordered by the courts.

Precinct 1 is in the northeast corner of Parker County and includes Springtown, Reno and part of Azle.

Primary Election Day is March 5 and early voting runs from Tuesday, Feb. 20 to Friday, March 1.

The Tri-County Reporter asked the candidates vying for the Parker County Precinct 1 constable seat in the Republican primary to tell us about themselves and their goals. Check out their responses below:

Name: Jason Ingram
Occupation: I am a lieutenant commissioned with Wise County District Office as the bailiff for County Court at Law #2. I am also a part-time patrol officer for the Southwestern Baptist Theological Seminary campus in South Fort Worth.

Education: In 1991, I graduated from Azle High School. Afterward, I attended the police academy at TCC in 1997. I graduated and started a rewarding career in law enforcement. Besides the police academy, I have also taken academies to become an EMT, firefighter, arson investigator, fire investigator, fire inspector, and plans examiner. I have completed over 4000 public safety training and education hours, primar-

ily in law enforcement. I also finished my first AAS degree in criminal justice at TCC in 2017. In striving to do more, I have just completed my second AAS in fire protection technology at Dallas College.

Community involvement: As a deputy fire marshal with the city of Azle, I volunteered at many events, including "National Night Out" at Azle Park, where I got the opportunity to demonstrate to kids and adults the finer points of how to use a fire extinguisher. I was also instrumental in the Church of Azle's acquisition of the church at 836 Northwest Pkwy. With God's direction, meeting with the right people assisted the church of Azle in acquiring the building and land. This was a huge blessing for the city of Azle and the church.

Family: My family is deeply rooted in Parker County. My Granddad Carl Ingram and my uncle Billy Ingram helped start Azle's first VFD in 1951. My uncle, Jerry Ingram, was a reserve Azle police officer for many years. My father, Jack Ingram, was a Fort Worth Police Officer who served over 23 years before retiring due to a head-on car accident while on duty. I have a beautiful wife, Teressa Ingram, and three amazing stepdaughters: Nicole, who works as an RN; Cheyenne, a marine veteran; and April, both of

whom work for the Tarrant County Sheriff's office.

Why are you running for Parker County Precinct 1 constable and what experience are you bringing to the position: I am running to be the next Parker County Constable Precinct #1. Years ago, I set this as a future goal for myself, and just as the date to file approached, I decided that now was the time for me to pursue it. I was counseled by the church leader and other constituents who are deeply rooted in Parker County politics to follow what God had placed on my heart, and they had faith in me that I would be the best person for the job. I firmly believe that you lead from the top, and if you do your best, the ones you lead inherently do the same. We need a change in the same old ways and a new direction. I bring many things to the table to be considered. Many people don't realize that the Constable's office has environmental deputies under its command. My experience as a deputy fire marshal, firefighter, fire inspector, and EMT can play a significant role in the leadership of that division of the constable office. As a master police officer TCOLE instructor and TCOLE firearms instructor, my constable's office will be trained and ready to respond

to any emergency that may arise. While conducting normal business-like civil processes, the constable or his deputies could be that first responder just seconds away from a major life-threatening incident. Being well-trained, easily identified in uniforms, and easily seen in marked patrol units are just a few simple things that could make a world of difference in emergencies. This department could be the one that saves the lives of your loved ones. While this department is running well, I believe there is always room for improvement. If allowed to be your next constable, I will be committed to serving the people who elected me.

What goals do you have that you feel will help serve residents in Precinct 1: The constable office can be led to be a top-notch law enforcement department in our county. My goals are simple but can considerably impact the residents of Parker County Precinct #1. As law enforcement officers, we take an oath to serve and protect. As a start, I will require all our county-owned patrol cars to be marked. This alone can help deter crime while we're in the course of regular duties. This also allows Parker County Precinct #1 residents to flag us down if they need help in an emergency. If you cannot see us, you can't ask for help! This leads to my second goal: uniforms for our department. It is imperative that, as public servants, we wear uniforms so that citizens can easily and quickly identify any of our on-duty personnel. Again, you can't ask for help if you don't see us! Another primary goal is to work with all four law enforcement agencies within PCT 1. This collaboration and clear communication can significantly impact residents, especially during life-threatening emergencies. If one of our local law

enforcement agencies is tied up on an extended call, your constable office can be that stopgap. And with our marked patrol cars and easily identifiable uniforms, we can easily be that much-needed help in your emergency! Time matters when you call 911, and with the shortage of law enforcement officers, the constable's office needs to step up and help anywhere it can; this doesn't mean we're taking over. We're here to assist if the need arises, as most offices would do. We are supposed to be public servants and take the oath as law enforcement officers to serve and protect the public. If elected, I will hold to that oath, and we will be there for the residents of Precinct 1.

Family: I was born and raised in Parker County. I married my high school sweetheart Beverly and together we have two children, six grandchildren, and three great-grandchildren. Being a public servant is something that runs deep in our family. My wife is a retired teaching assistant, my daughter is a nurse and my son is a retired Navy Chief. We proudly carried these traditions on with our grandchildren, one of whom is an assistant district attorney in East Texas, the other is a school teacher.

Why are you running for Parker County Precinct 1 constable and what experience are you bringing to the position: After several years in the field and holding different positions throughout the law enforcement system I felt that this was the best and most fulfilling next move in my career. I am grateful to get to use my knowledge and training from various roles such as patrol deputy, sergeant, lieutenant, captain and chief deputy to give back to the community that raised me. In addition to those positions, I proudly served 12 years in the Texas National Guard and had the privilege of being assigned to commander of the Fugitive Task Force working alongside the US Marshalls. I have also been proudly serving our precinct as Parker County Constable Pct. 1 for the past five years.

What goals do you have that you feel will help serve residents in Precinct 1: My main priority at this moment, in the growing population of our precinct is to ensure that I as well as everyone under my authority is prepared and properly trained thus ensuring that safety and quality of service remain unwavering and ever-changing in our growth.



We Happy Few

A trippy look at an alternative Britain

My opinions on computer gaming and some of my favorite games. I've been playing games on the home computer since the days of the Trash 80. I love indie, open-world, unique, puzzle, and resource games. The cake is a lie.

We Happy Few is set in 1964 Britain, in an alternate timeline in which the nation lost the war with Germany. The citizens take a drug they call Joy that keeps them happy and causes memory loss, which is a bonus for many of these people. They have a lot of memories they'd like to suppress. But the drugs just aren't working as well as they used to.

The developers of the game describe it as "the tale of a plucky bunch of moderately terrible people trying to escape from a lifetime of cheerful denial in the city of Wellington Wells. In this alternative 1960s England, conformity is key. You'll have to fight or blend in with the drug-addled inhabitants, most of whom don't take kindly to people who won't abide by their not-so-normal rules."

Everybody wears a white silicone mask while in town, because it hides any negative expressions. All good citizens must put on their "happy face" to conform to society. Everybody that stays in a city is expected to be a good citizen and take their Joy. Propaganda is broadcast through televisions throughout the city to encourage citizens to take their Joy, with the voice of "Uncle" Jack Worthing. Joy is also in the city water supply.

This game relies a lot on stealth. When you're in the city, people will attack you if you haven't been taking your Joy. Many of these citizens can't tolerate taking Joy anymore because of a bad reaction, so they live outside the city limits in the ruins, haunted by their memories.

The game tells the story of three people trying to escape Wellington Wells. We start with our first protagonist, Arthur Hastings, who works at the Department of Archives, Printing, and Recycling in Wellington Wells. His job is to censor bad news and approve positive stories. He sees an article about him and his brother, and it brings

up bad memories. He's determined to go find what happened to his brother. At this point you have the choice of taking more Joy or choosing to remember. If you take your Joy, it's a pretty short game.

If you don't take your Joy, things get dark in a hurry. Arthur attends the office party and finds his coworkers smacking a pinata. When the Joy wears off, he realizes they're beating a dead rat. (Told you!) As Arthur recoils in horror, one of his coworkers notices he's off his Joy and offers him one. Arthur refuses, his coworkers accuse him of being a Downer and attack him, and he escapes via a service tunnel.

There's a lot of stuff going on in this game. It has the feel of a first-person adventure, with some fighting, some stealth, item collecting and crafting, and quests to discover and solve. Quests mostly test your agility and stealth rather than puzzle-solving abilities.

You need to get across the bridge and escape Wellington Wells, but you'll soon discover it's more complicated than it seems. The town is falling apart. Some of it is just damage from the war that was never repaired. Many of the houses outside the town are ruined. But the systems that keep the town running are also falling apart. Apparently keeping your citizens high on drugs is bad for maintenance. Several of the quests in story mode will be to fix various systems.

At first I played the game very conventionally, going from suggested quest to suggested quest. But when I went exploring to find more ingredients for healing potions, I realized there are lots of mini-quests scattered

throughout Wellington Wells. Each gives you experience points to boost your attributes. There are various combat and stealth attributes that can be acquired when you've gained experience points. You'll pick up recipes to craft items, chemicals and healing items. Some quests are mandatory to finish the game, while others are optional and are there to expand the storyline and give you a chance to earn experience points.

Arthur's mission is to get across the bridge and escape Wellington Wells, but there are two other stories — Sally Boyd and Ollie have their own quests.

I really enjoyed this game. Sure, it's dark, and because I'm not good at stealth, probably a little more violent than it needed to be. If you use your fists only, your battles will end in unconsciousness, not death.

Some of the quests can be blocked off if you make the wrong move, but the solutions are relatively simple. The story is compelling and will keep you playing to find more notes — various pieces of paper you find scattered around in your explorations.

This is a complex game with an extended map and lots of side quests. It also has quite a lot of replayability, because each time a new game is started, it generates a new map.

We Happy Few is rated for mature audiences only due to blood, strong language, suggestive themes, use of drugs and alcohol and violence.

There are three DLCs created for this game — We All Fall Down, We Happy Few — Nick Lightbearer, and They Came From Below.

We Happy Few (2018) is available on SteamOS for \$14.99.
